(57) **CLAIM**

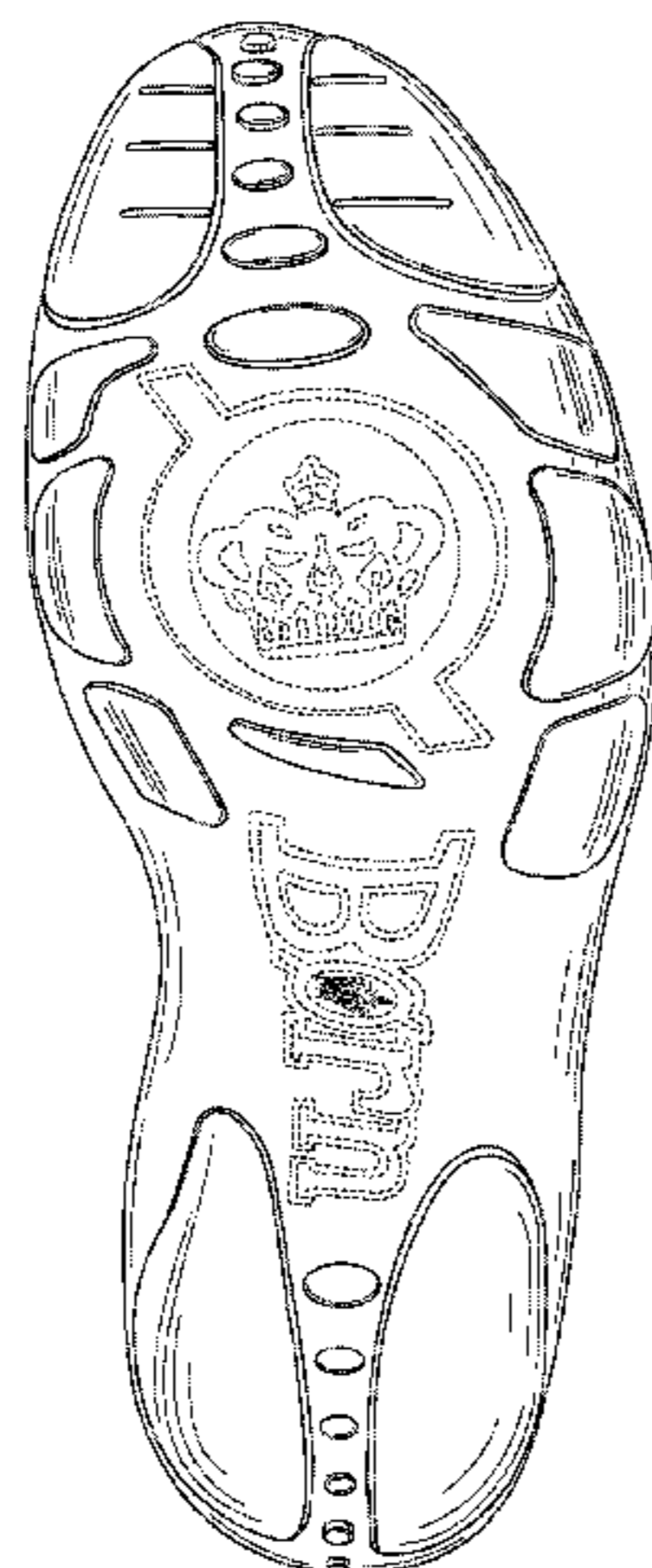
The ornamental design for an outsole for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of an outsole for a shoe showing my new design;
FIG. 2 is a bottom view thereof;
FIG. 3 is a right side view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a front view thereof; and,
FIG. 6 is a rear view thereof.

The outermost broken lines shown in the arch and forefoot areas of the views represent boundaries of the design with the lines themselves and the areas within them forming no part of the claim.

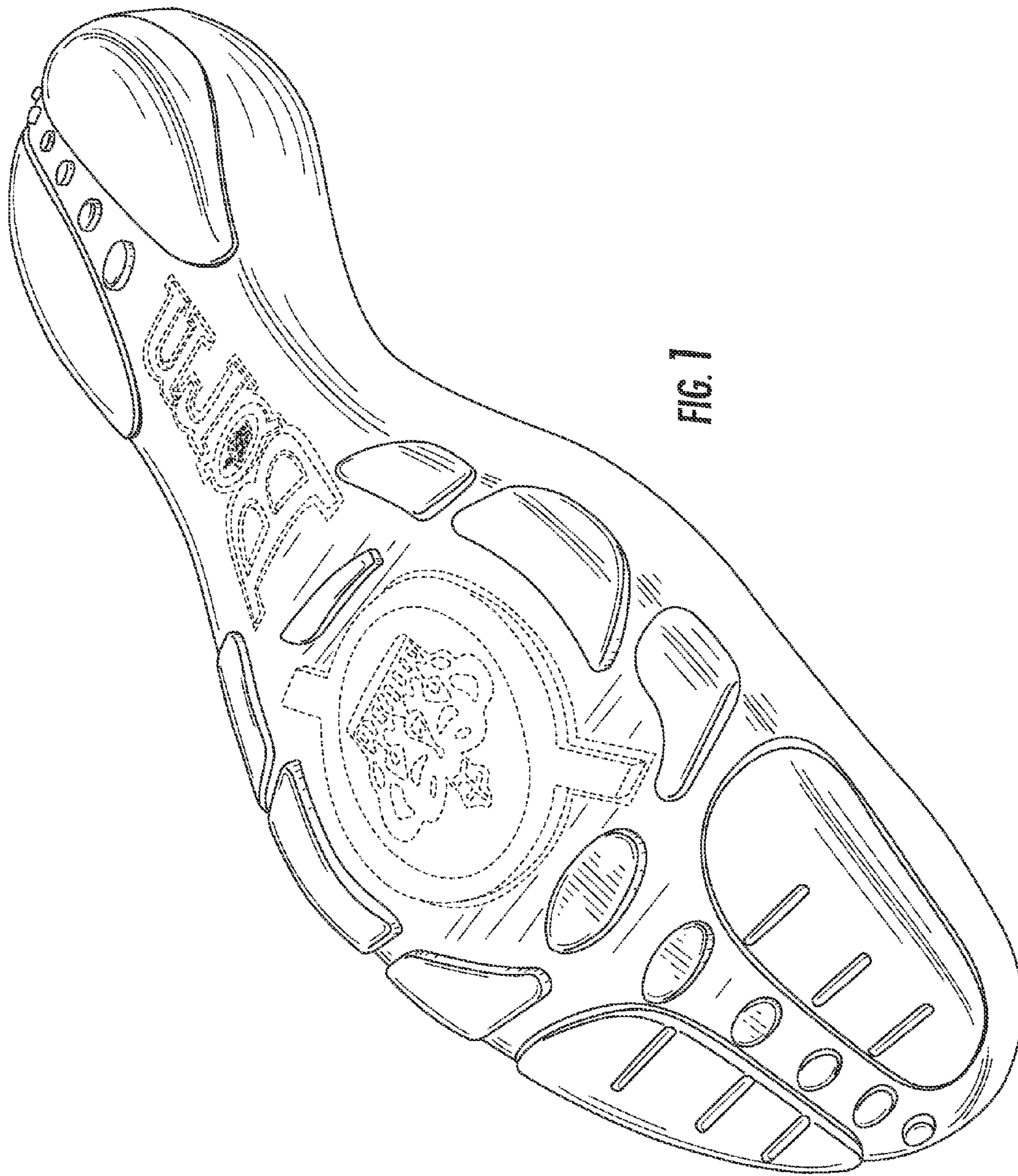

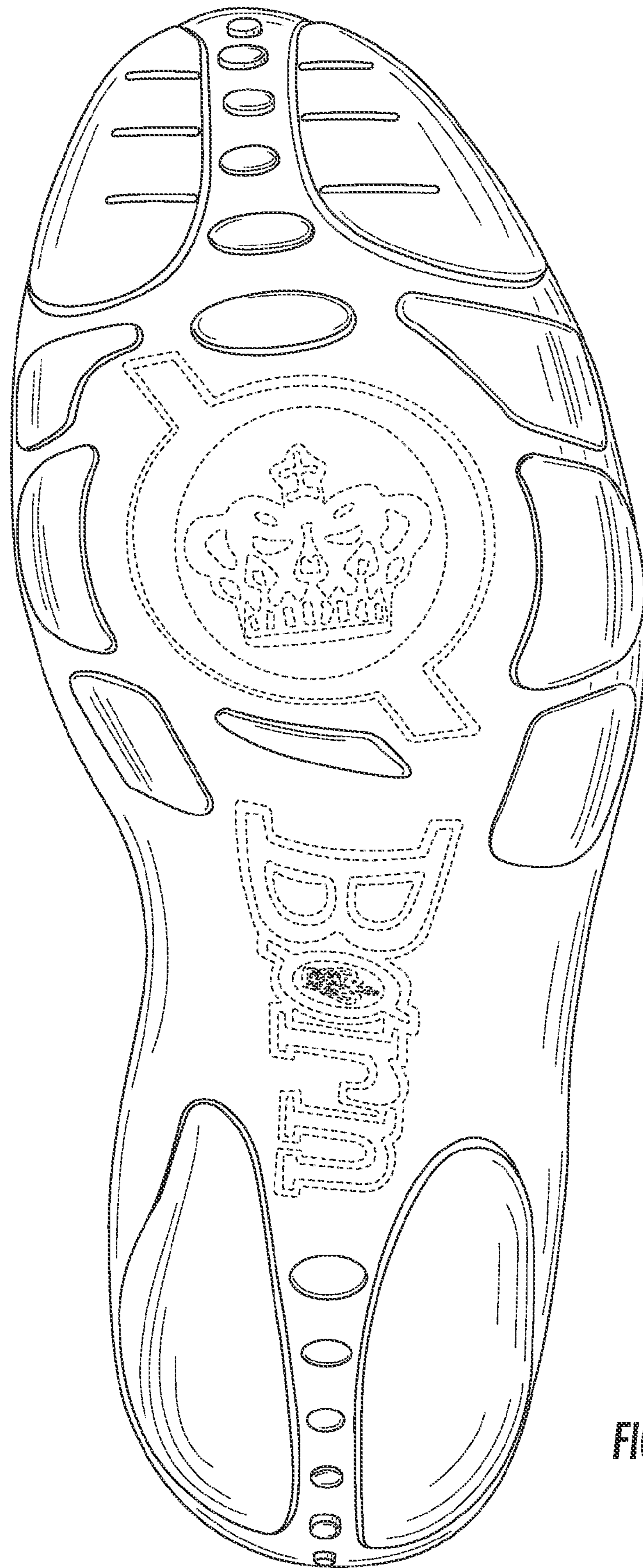

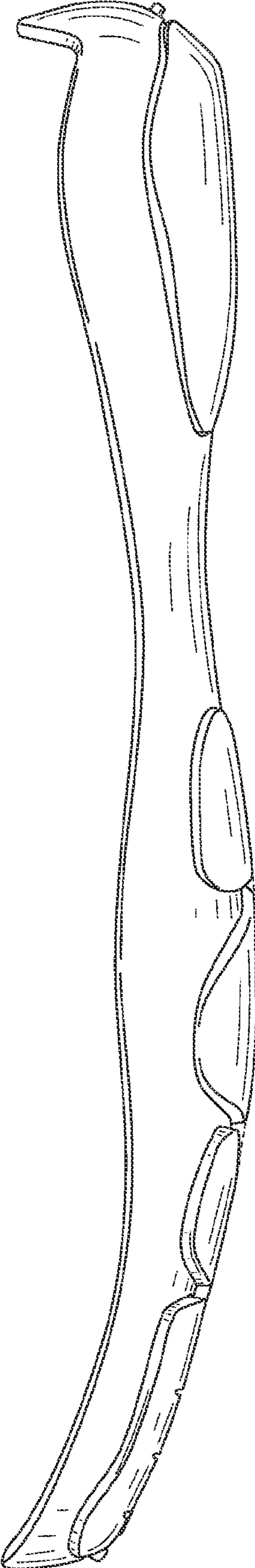

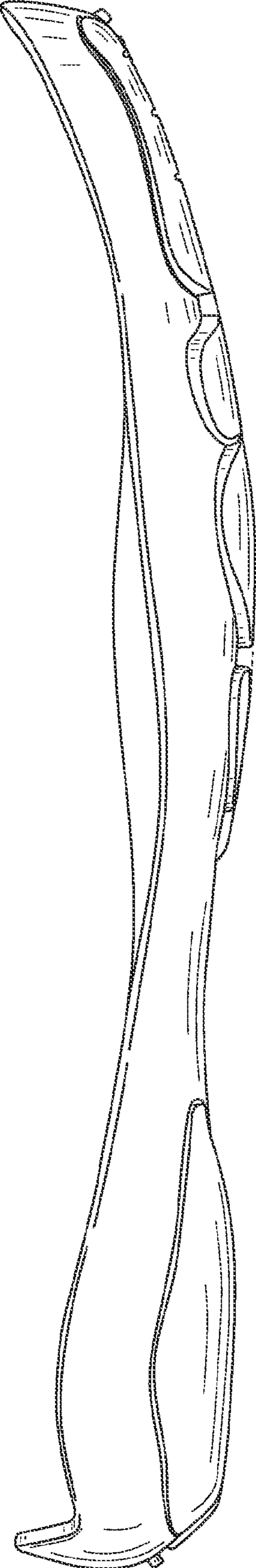

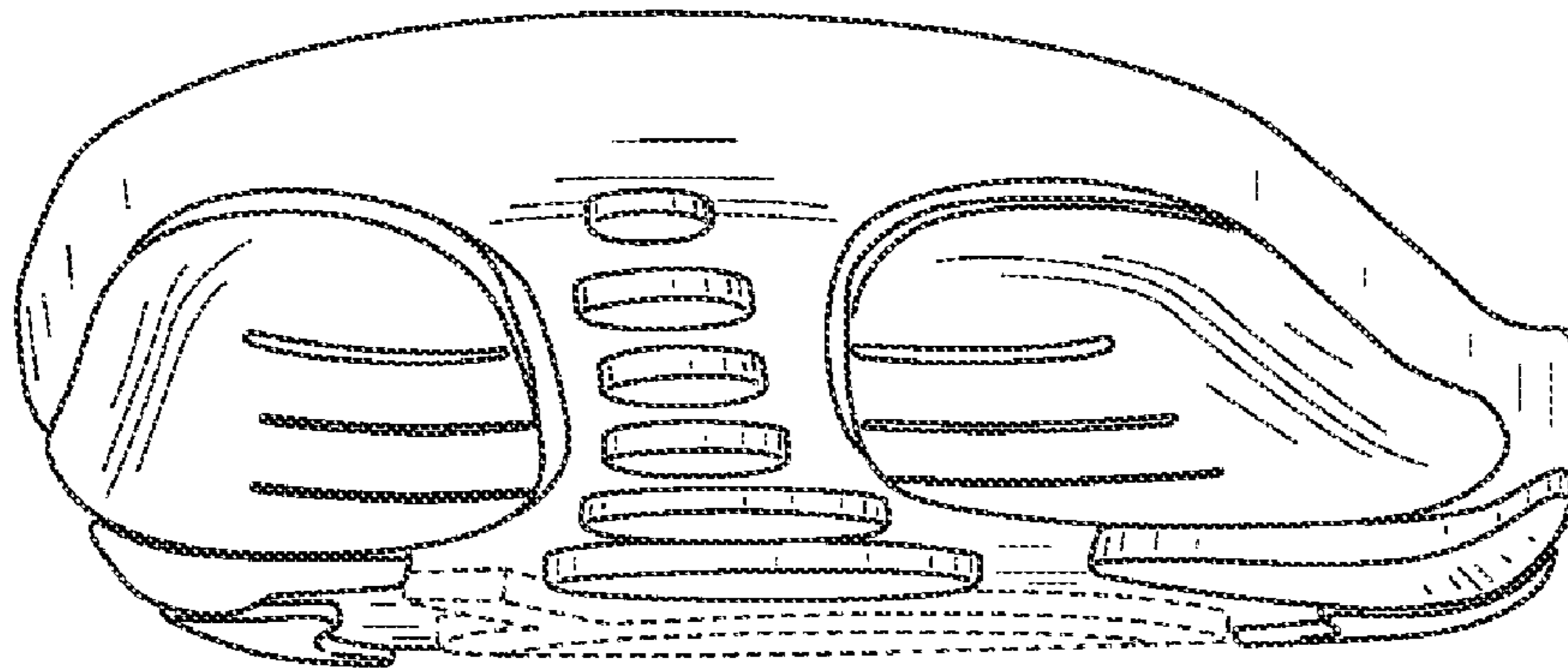

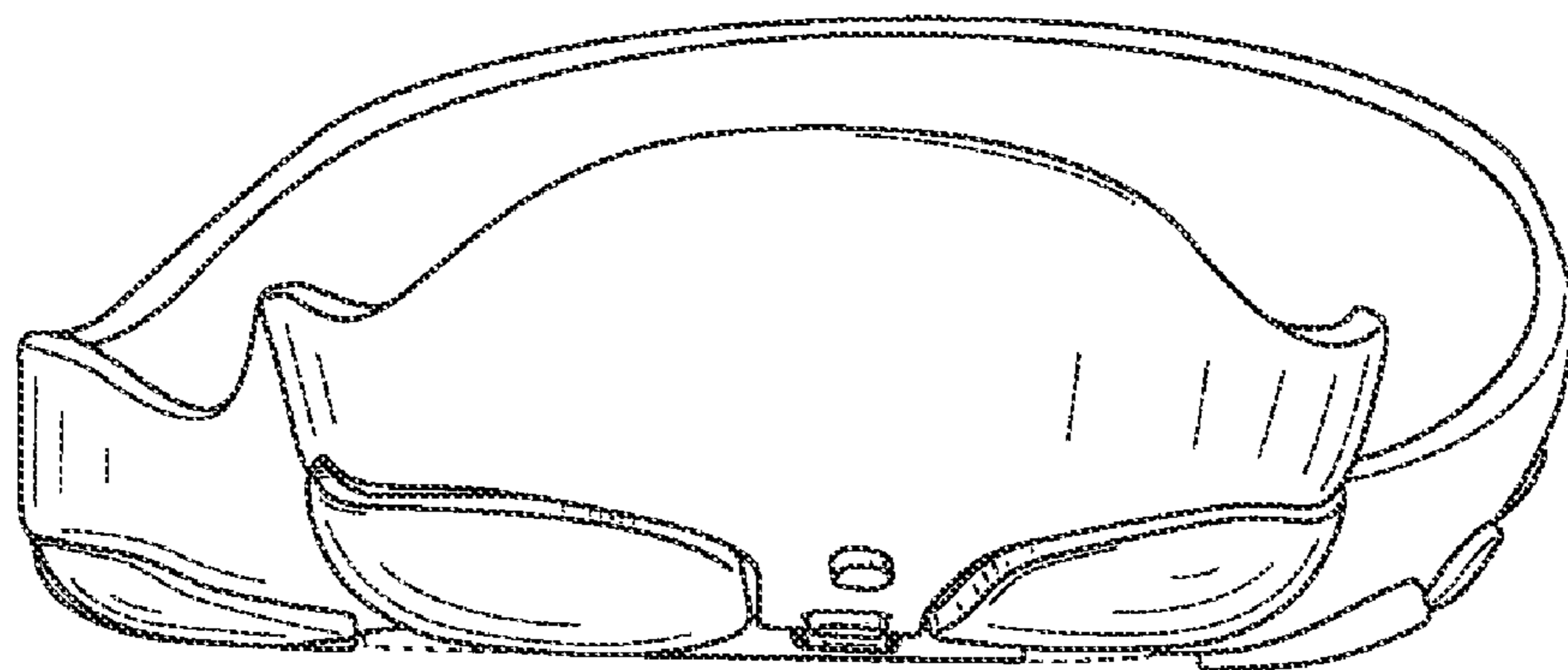
