(57) **CLAIM**

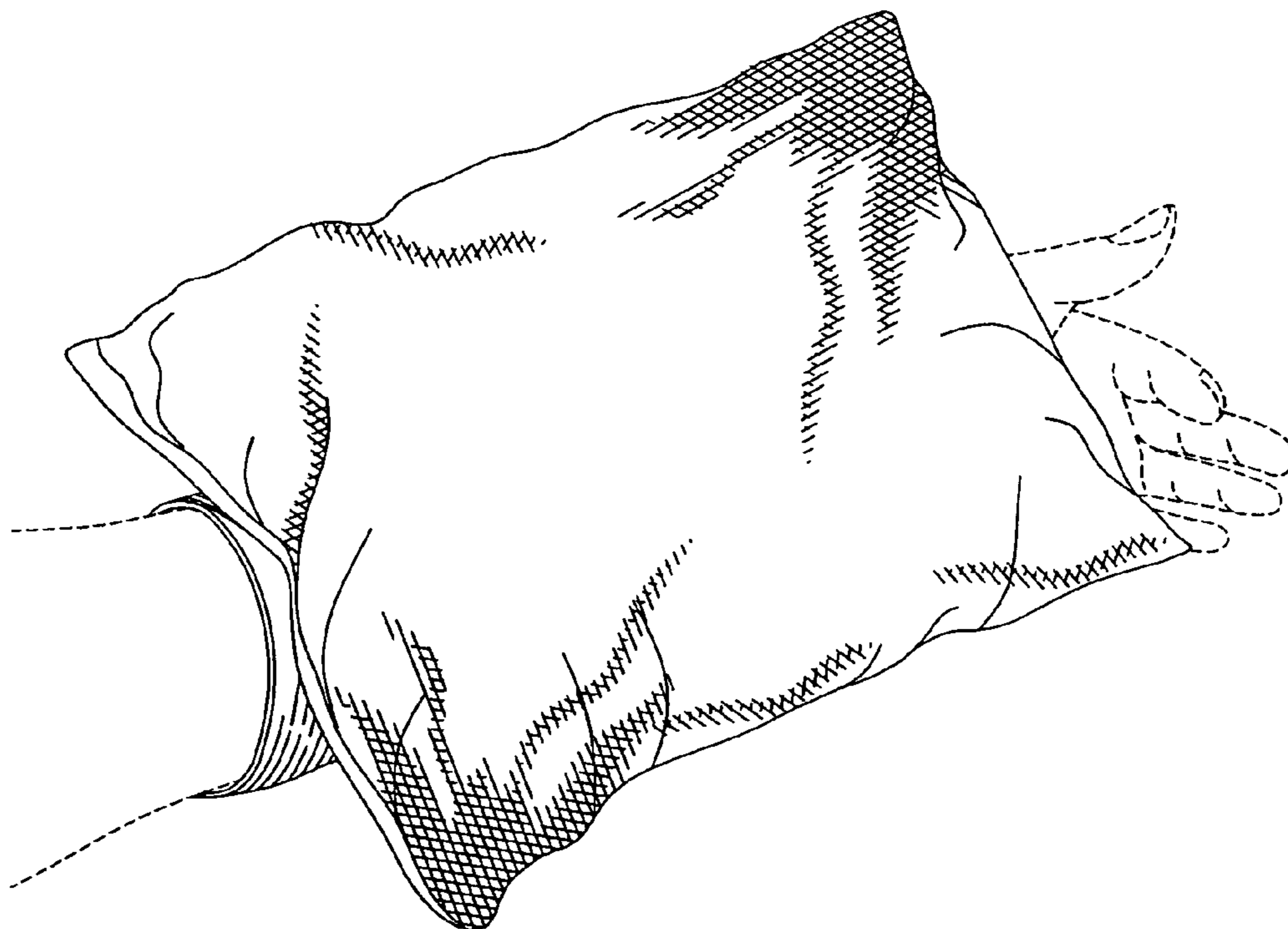
What is claimed is the ornamental design for a nursing pillow, as shown and described.

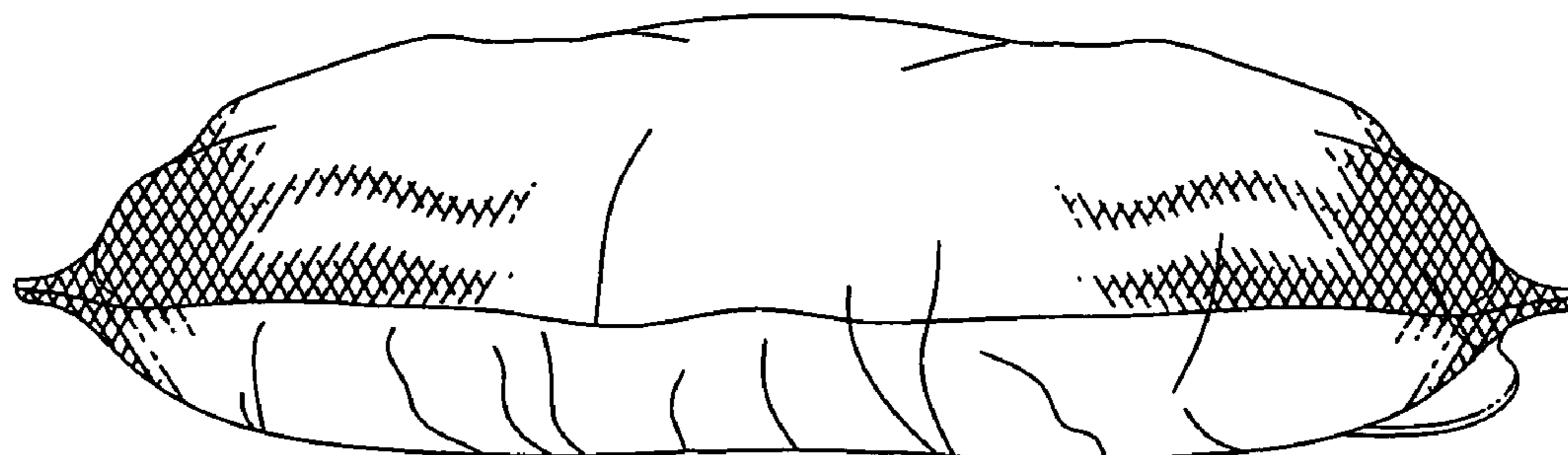
**DESCRIPTION**

FIG. 1 is a front view of a first embodiment of the nursing pillow;  
FIG. 2 is a left side view of the nursing pillow shown in FIG. 1;  
FIG. 3 is a right side view of the nursing pillow shown in FIG. 1;  
FIG. 4 is a top view of the nursing pillow shown in FIG. 1;  
FIG. 5 is a bottom view of the nursing pillow shown in FIG. 1; and,  
FIG. 6 is a perspective view of the nursing pillow shown in FIG. 1, in use attached to an arm.

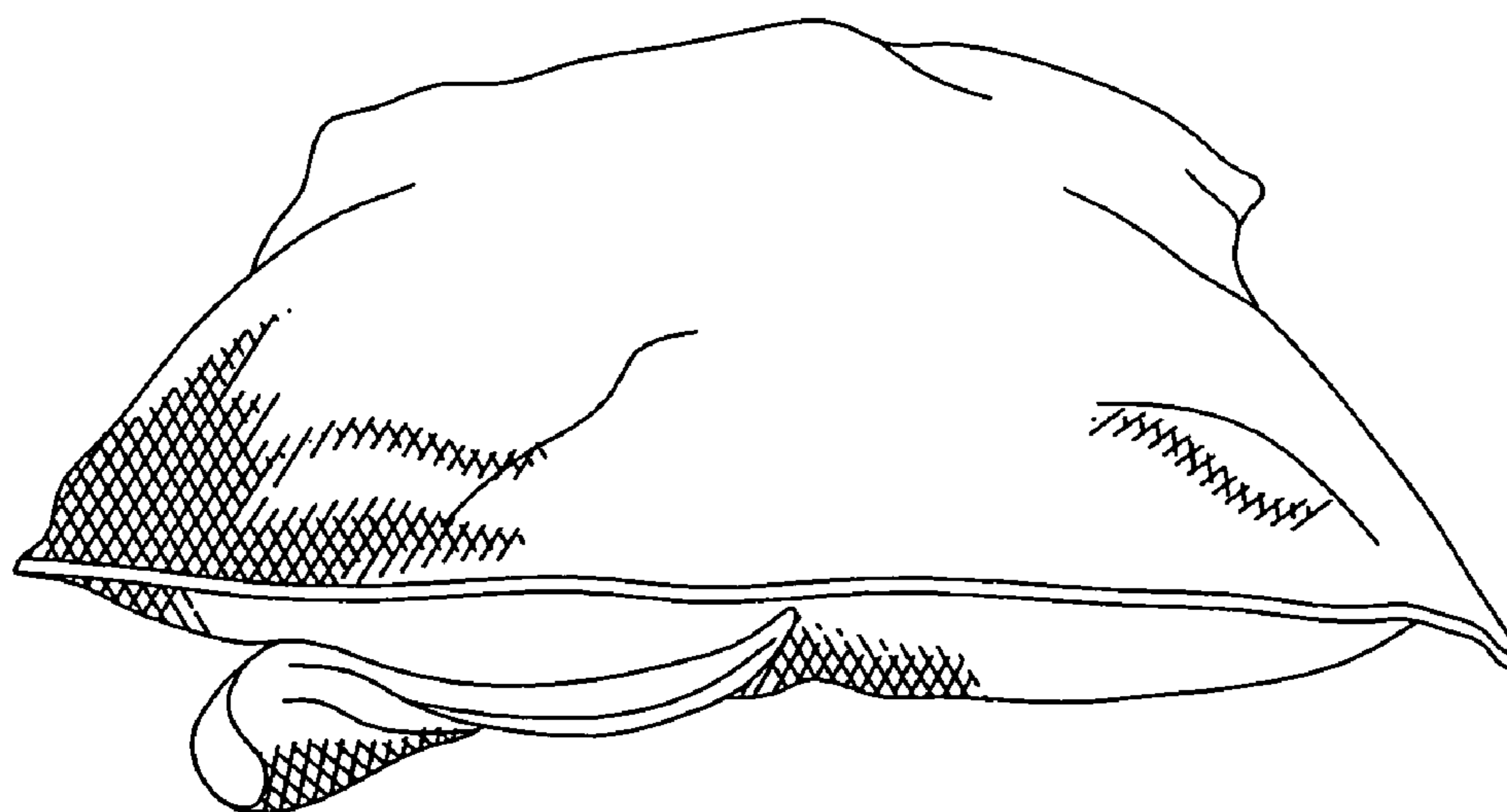
In the drawings, the broken lines illustrate the environmental in which the nursing pillow is used and forms no part of the claimed design.

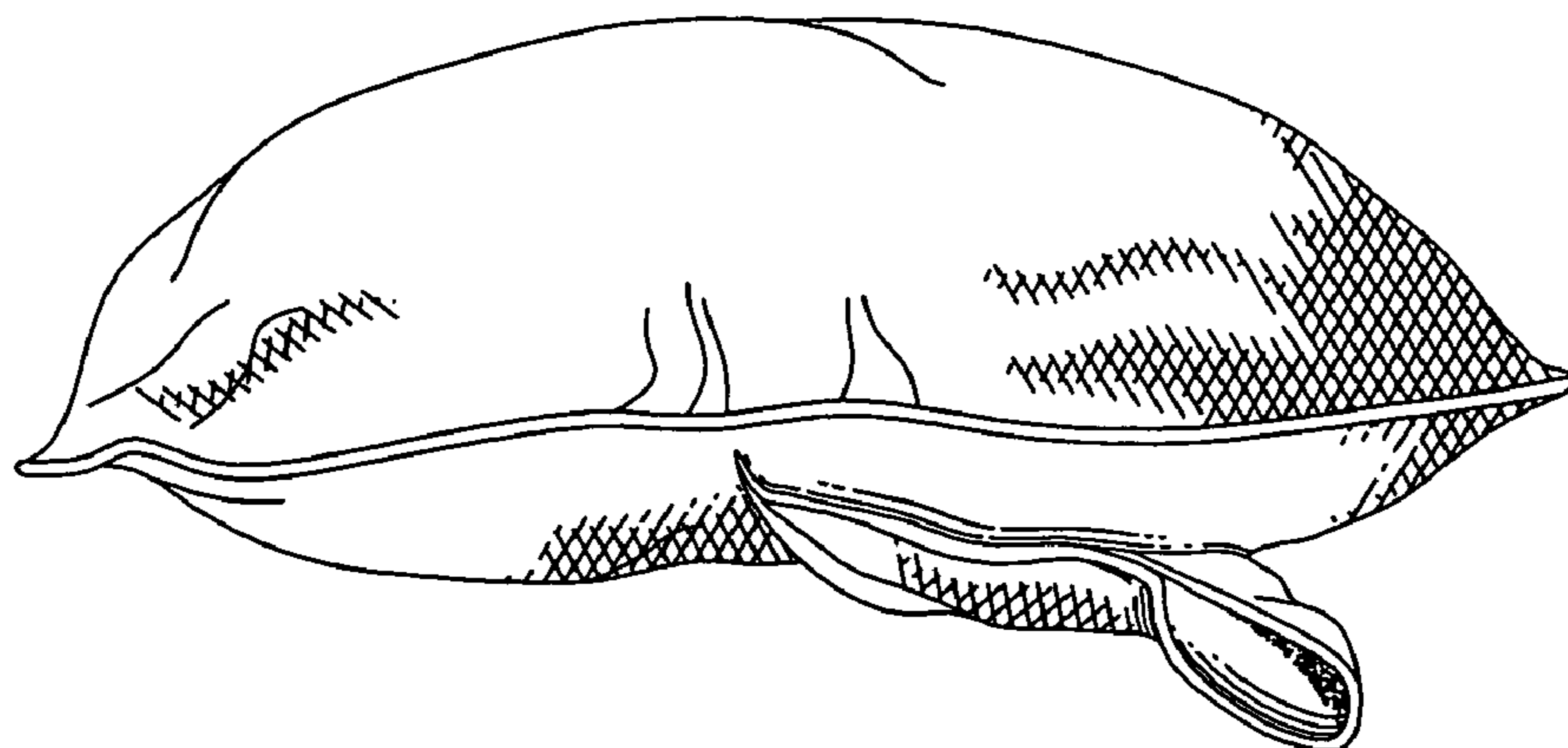




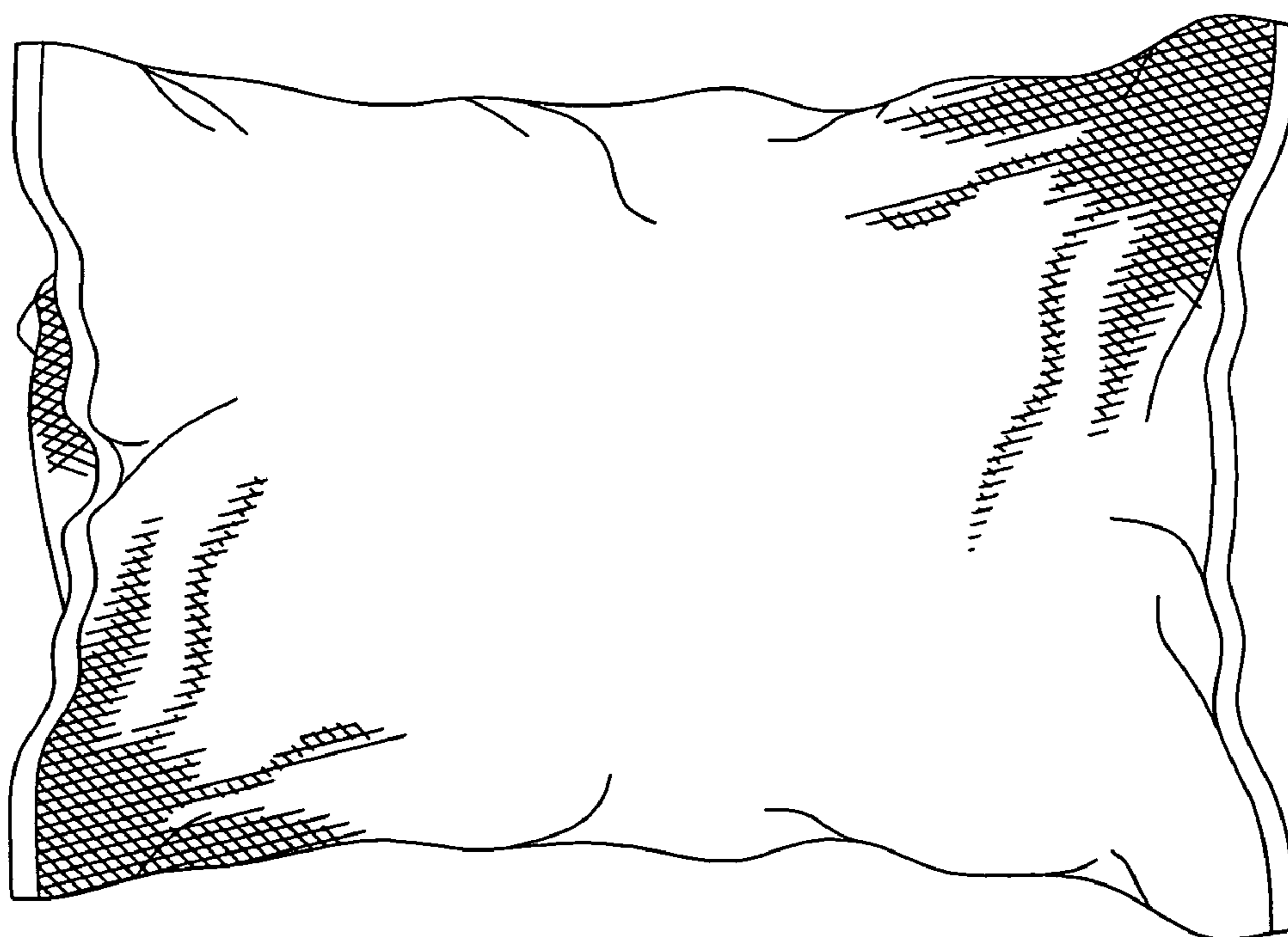

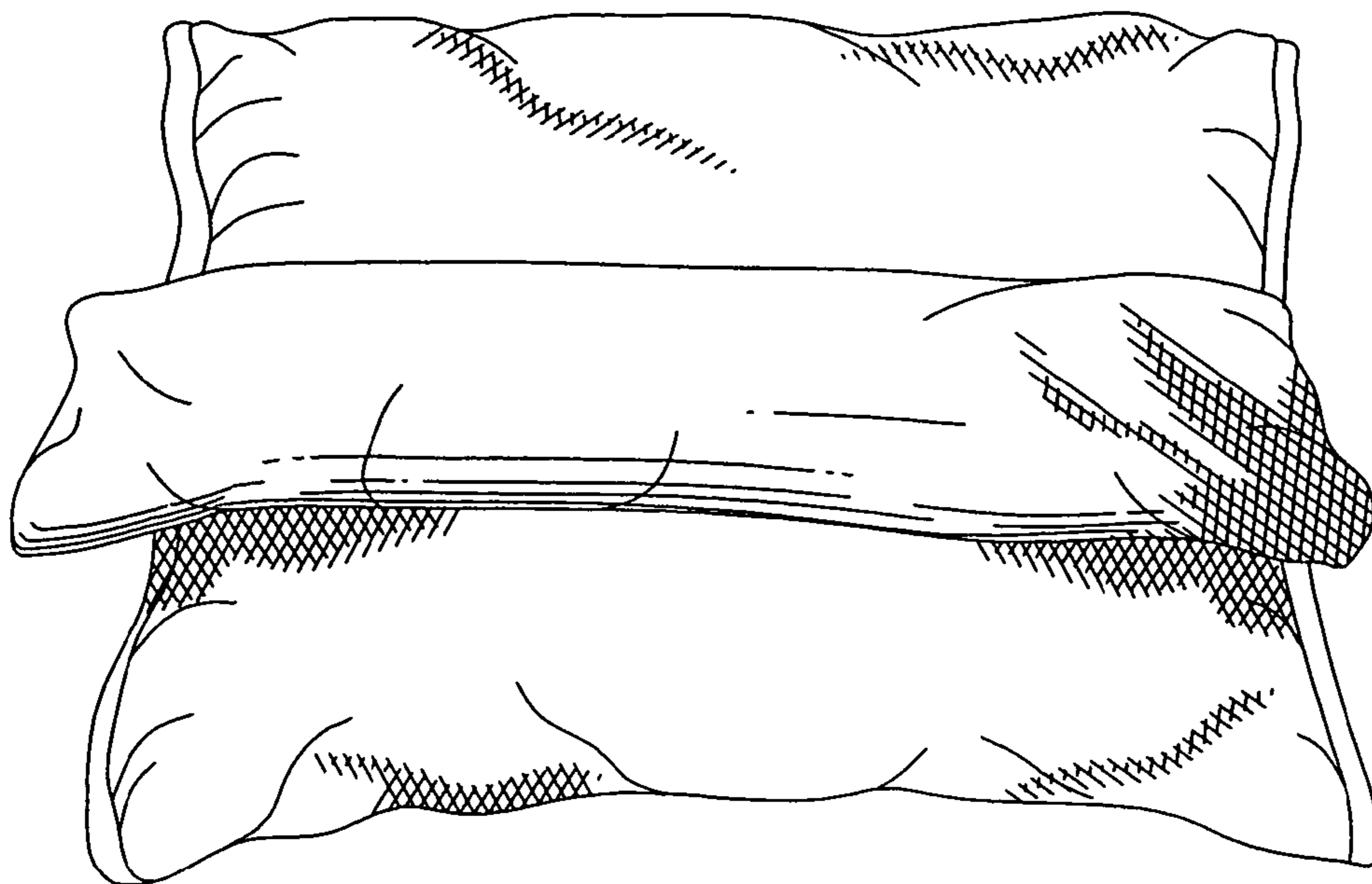

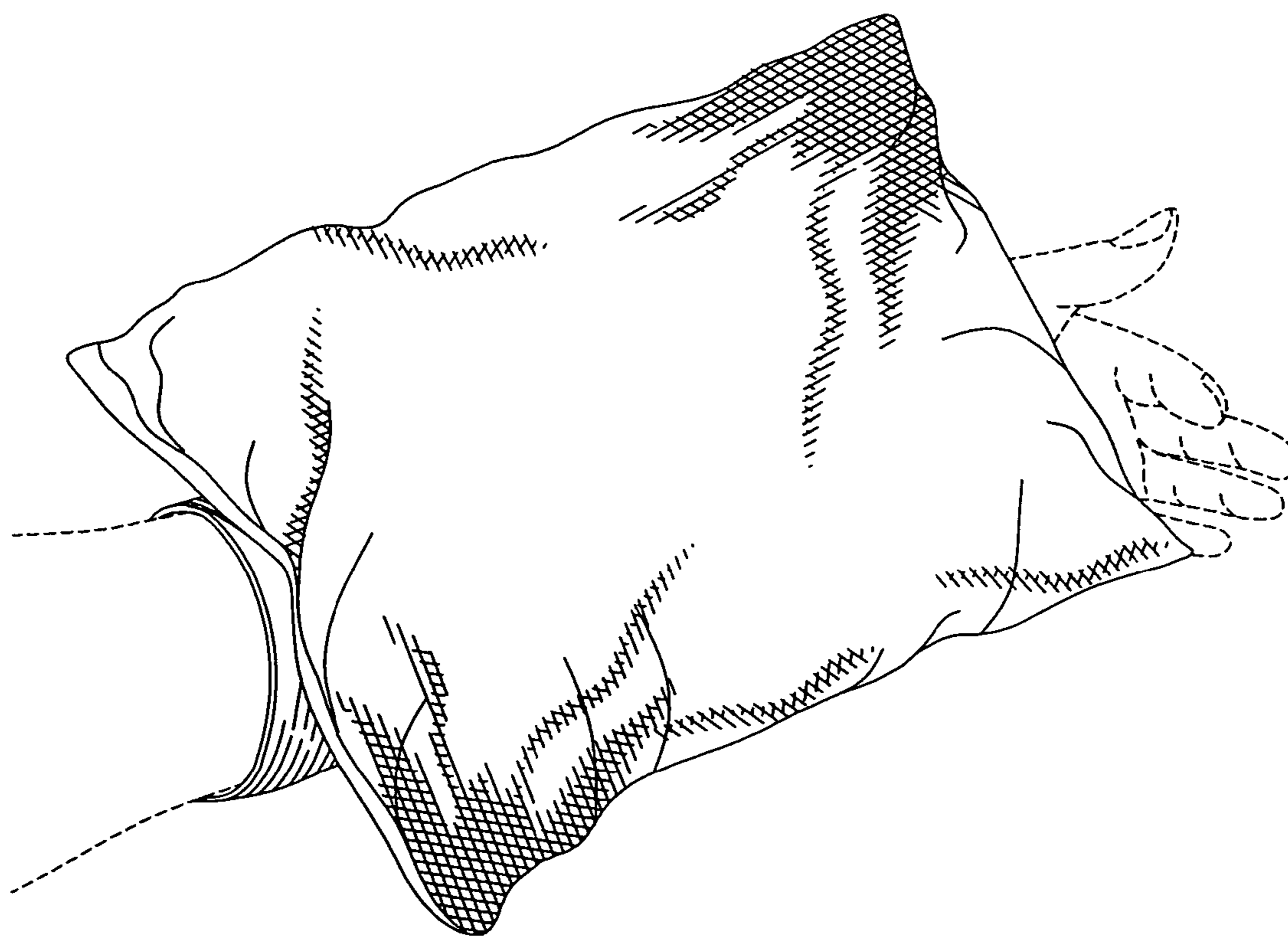
