DESCRIPTION

FIG. 1 is a top front perspective view of a beverage dispenser showing our new design;

FIG. 5 is a left side perspective view thereof in closed position;

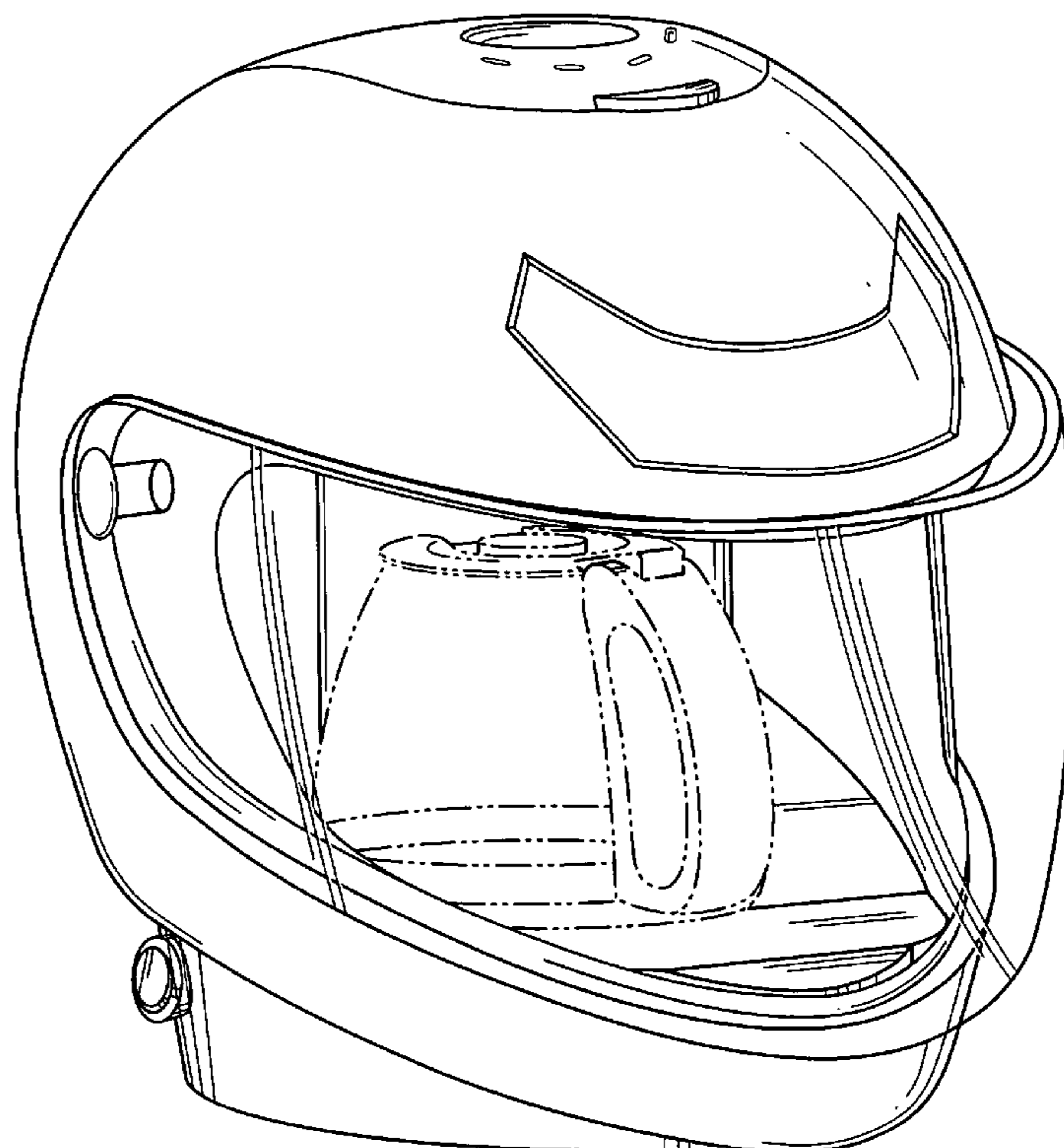
FIG. 6 is a rear view thereof;

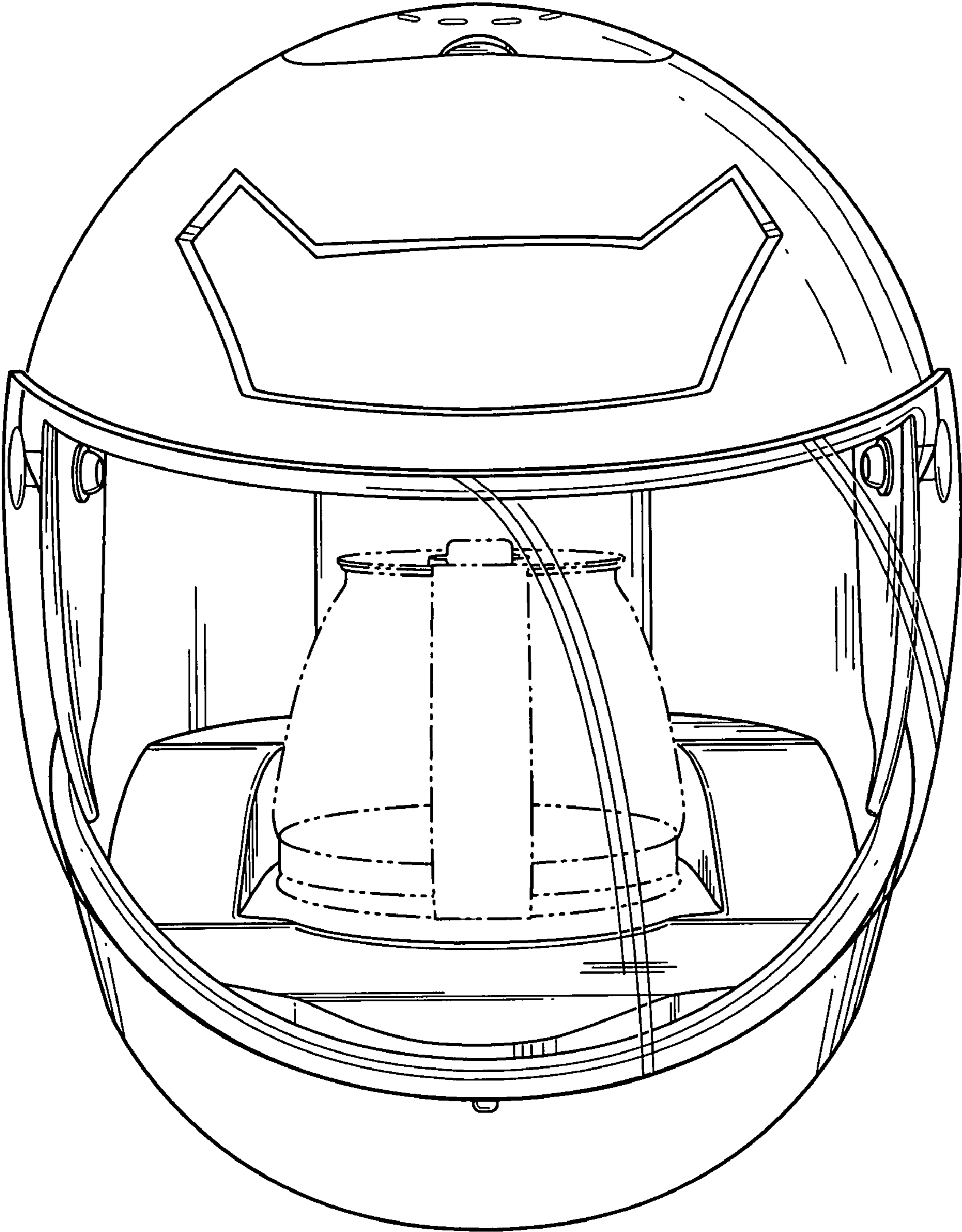

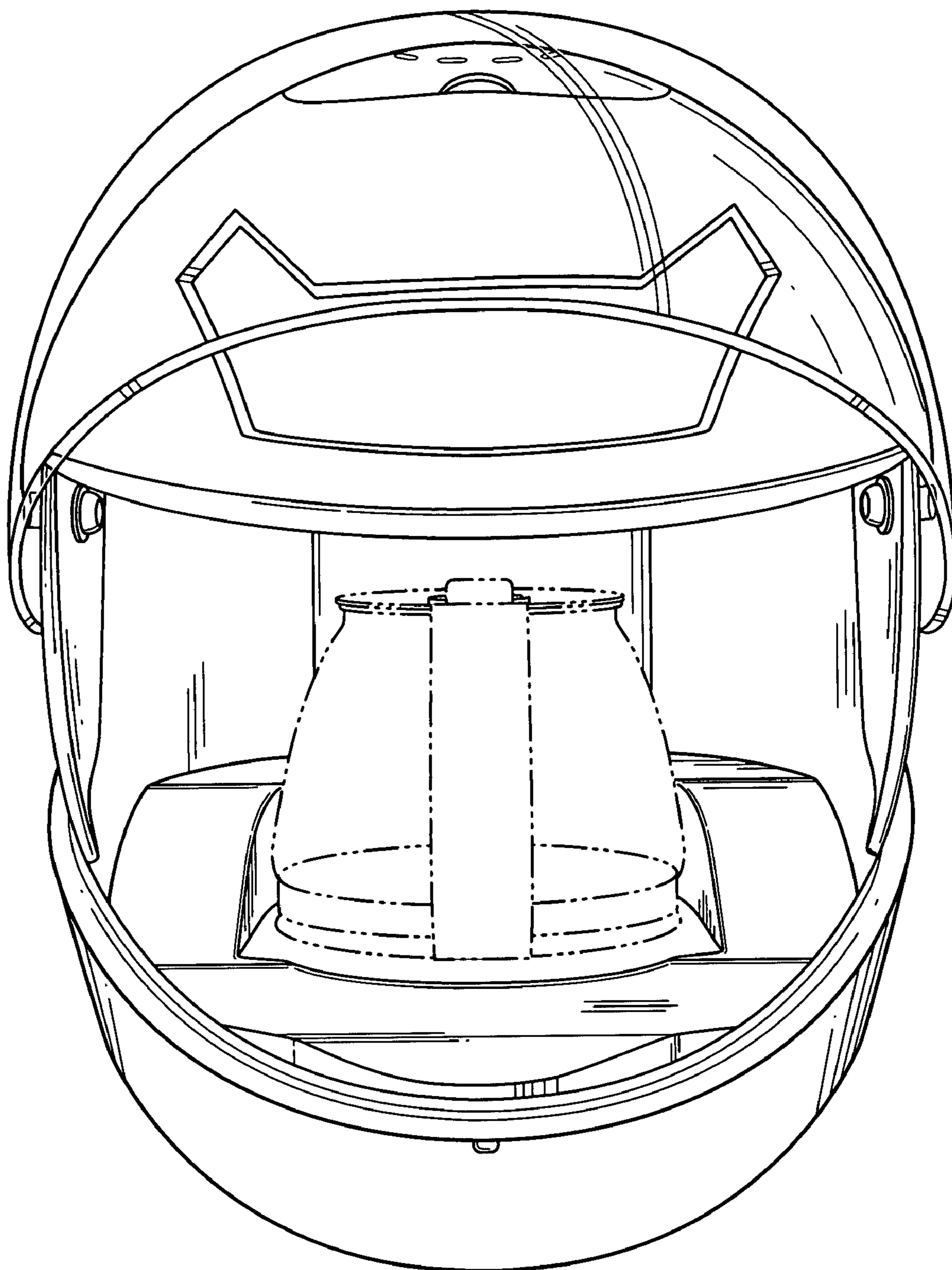

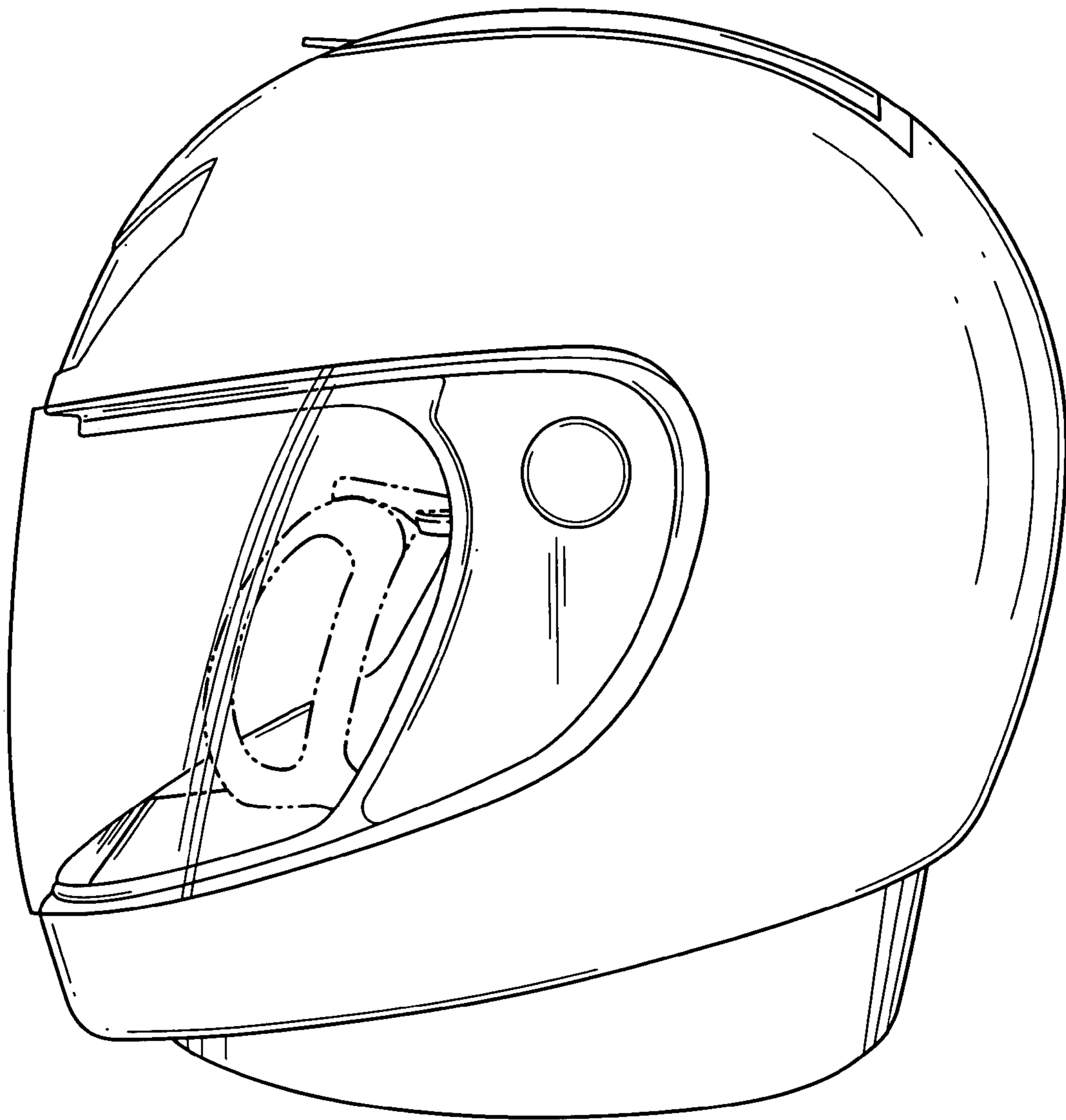

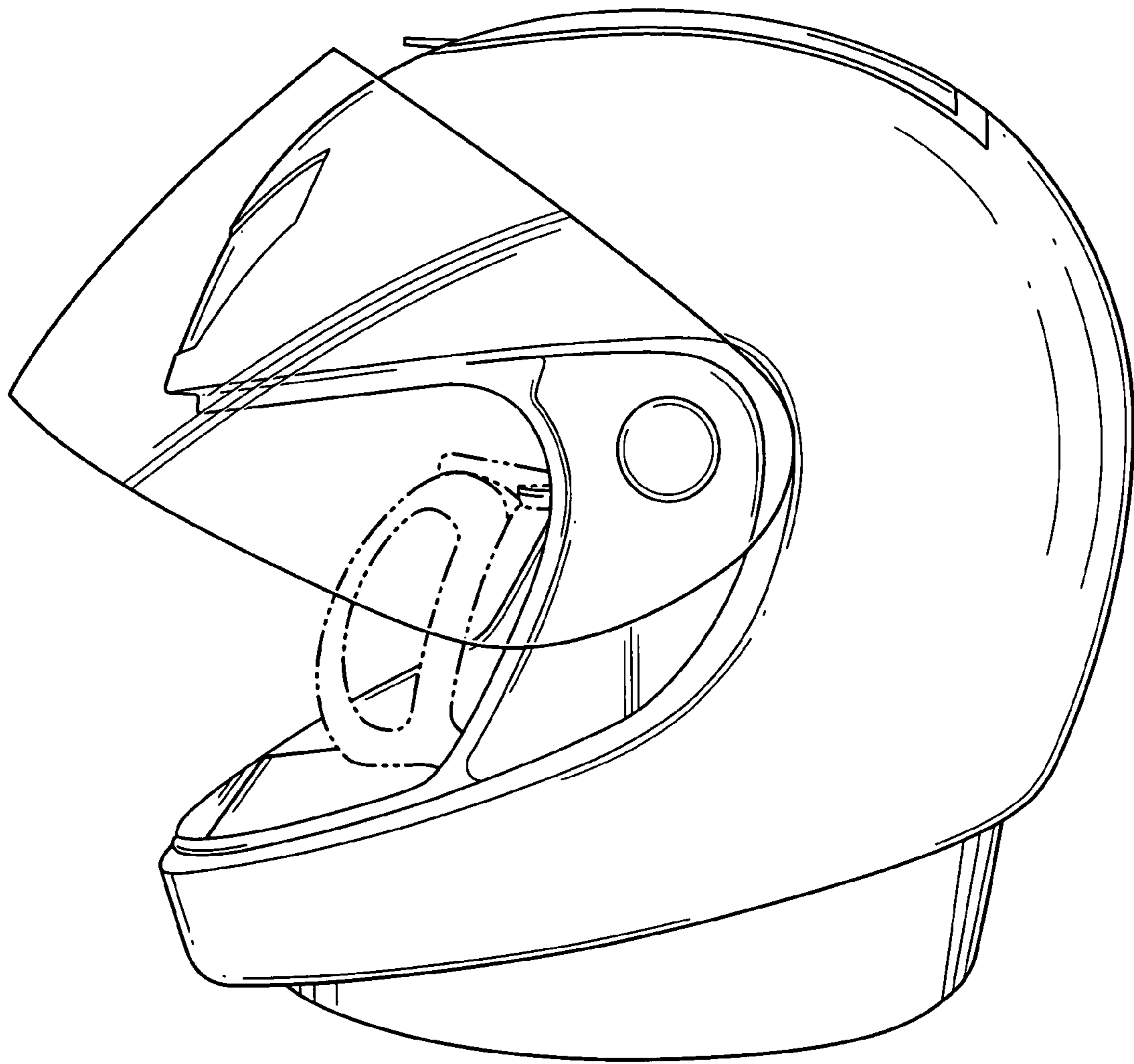

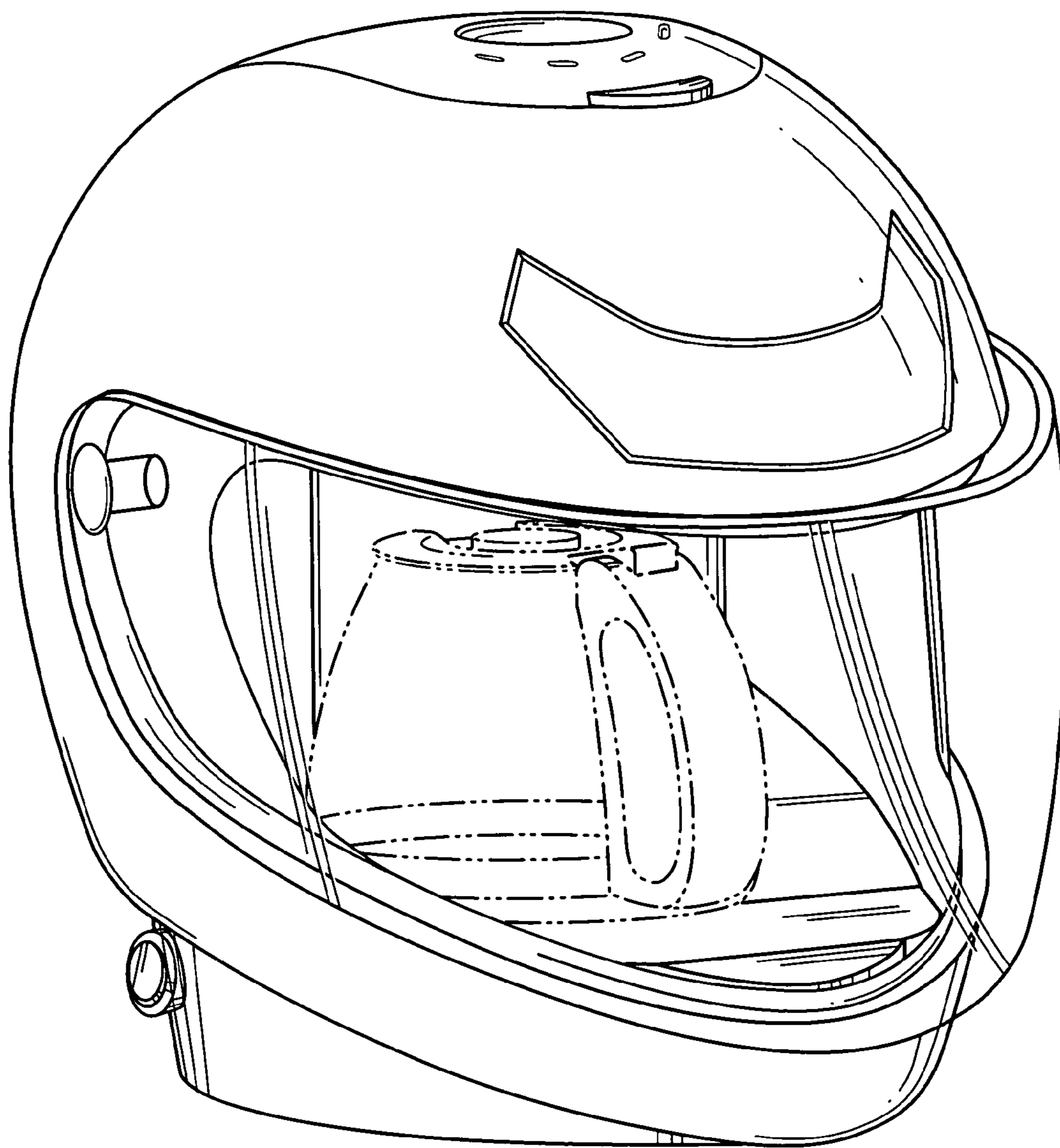

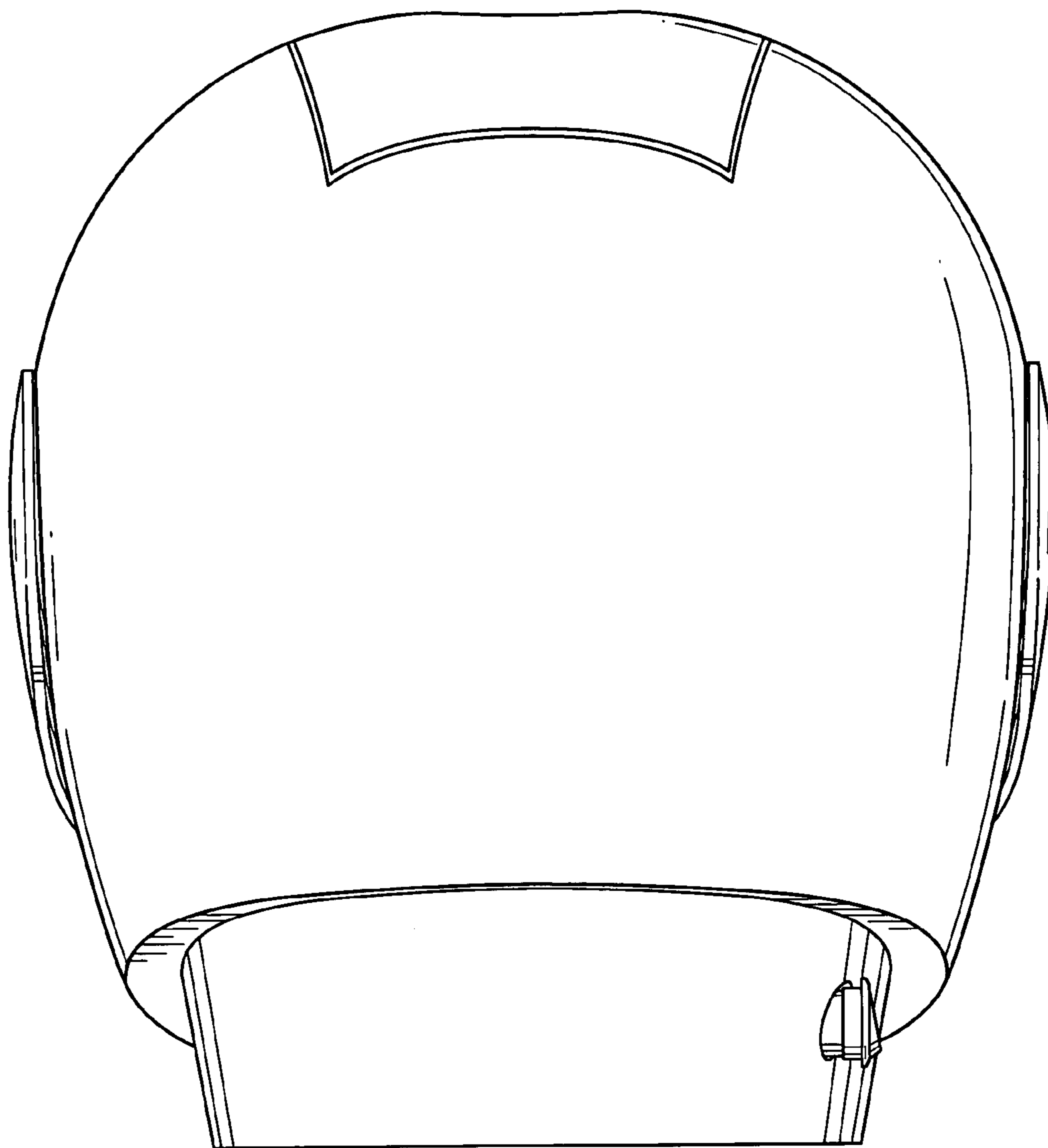

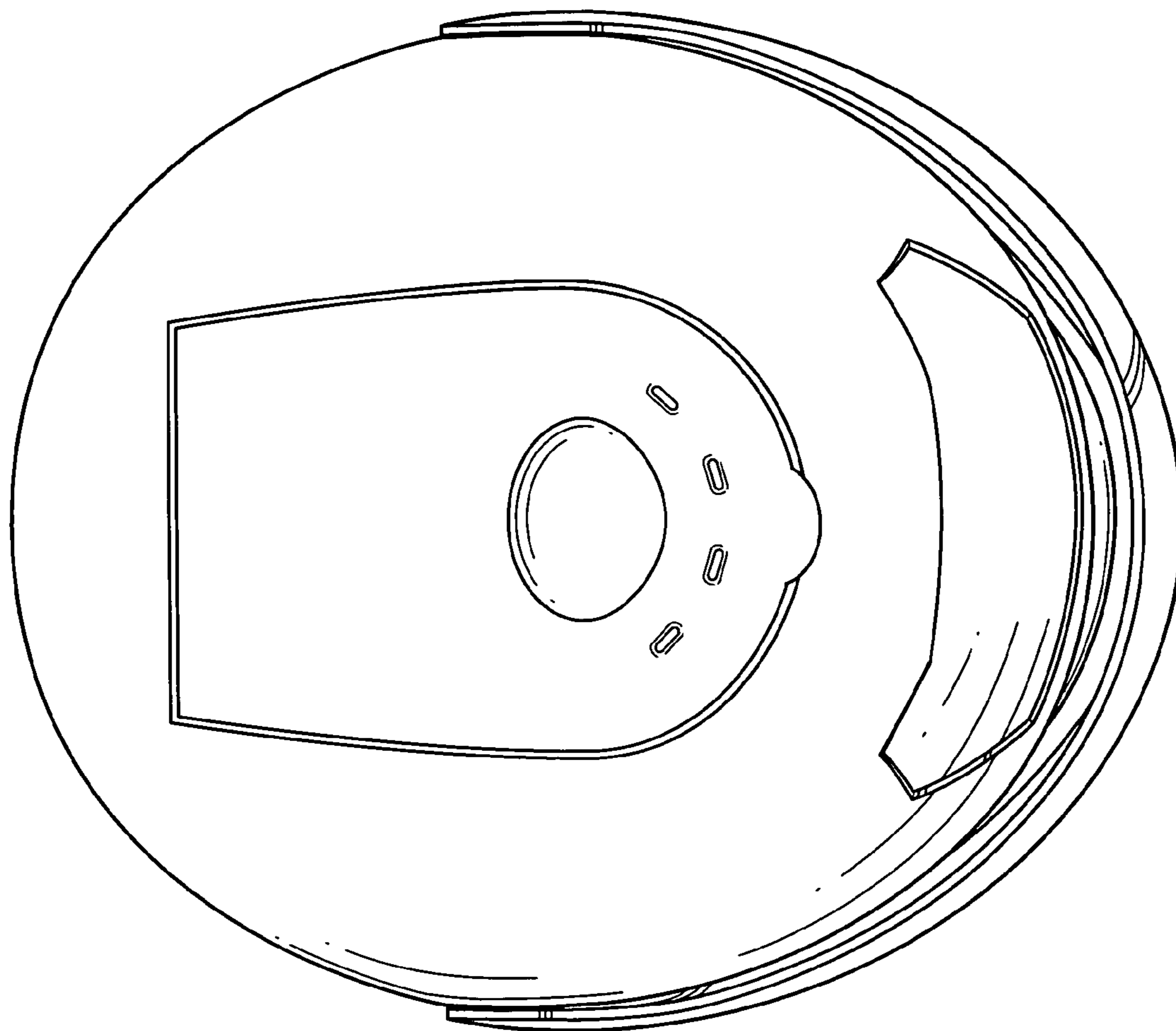
