FIG. 3 is a left view.

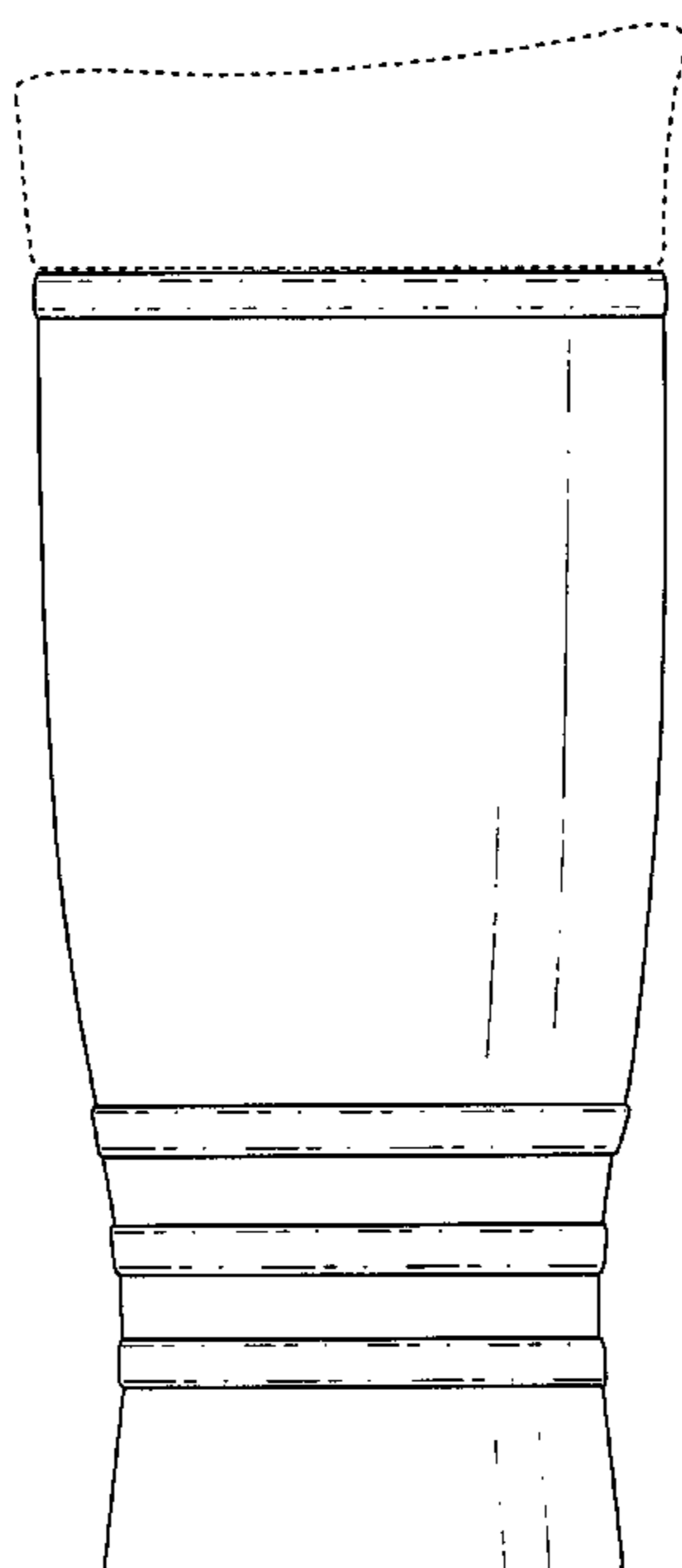
FIG. 4 is a front view.

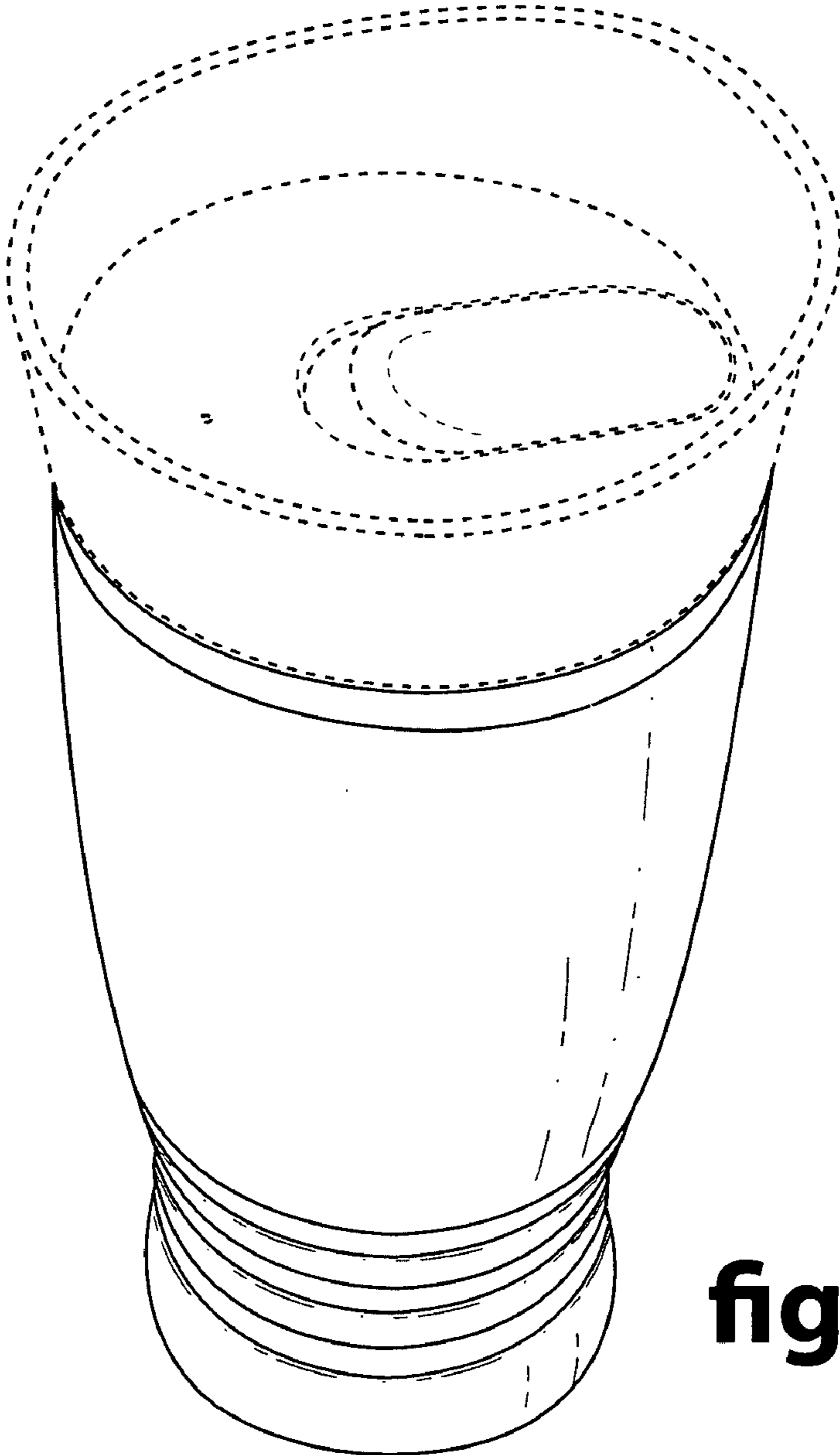
FIG. 5 is a rear view.

FIG. 6 is a bottom view; and,

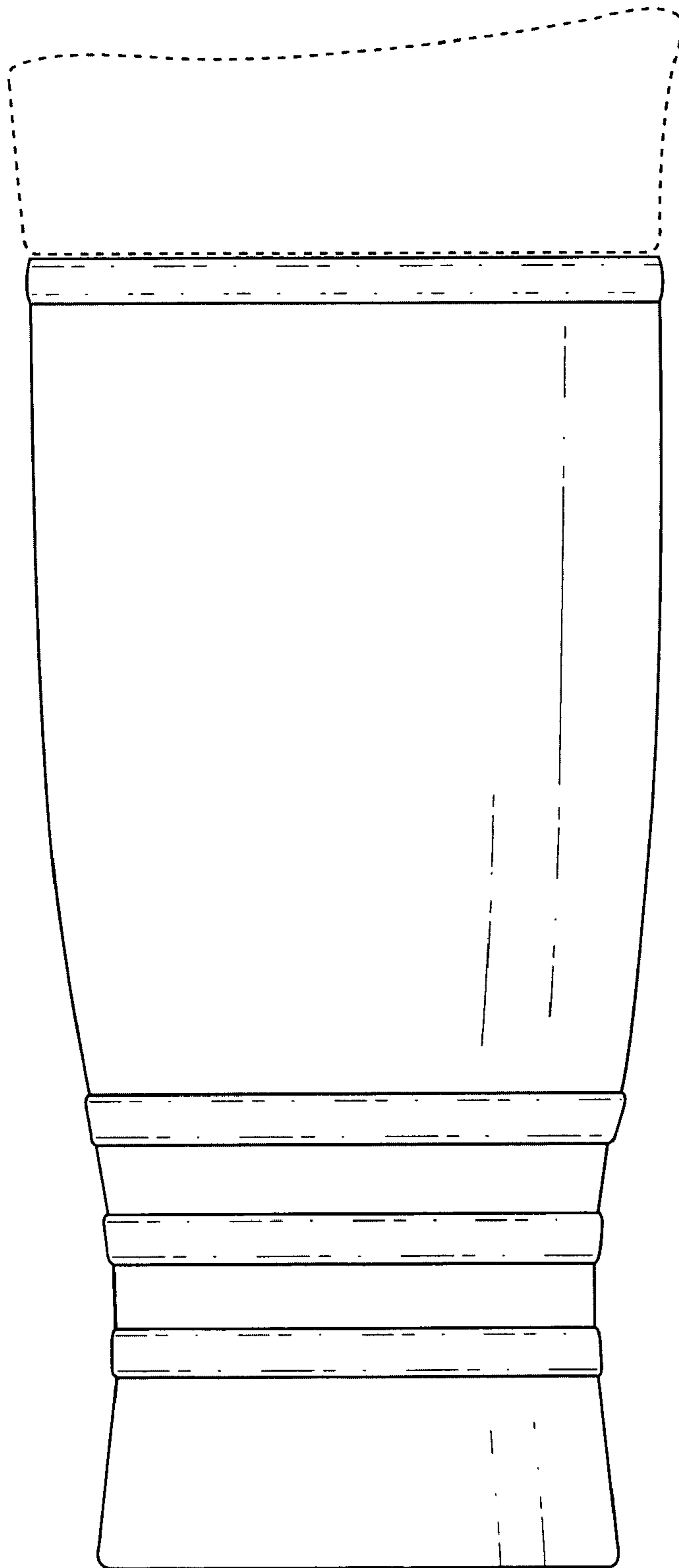

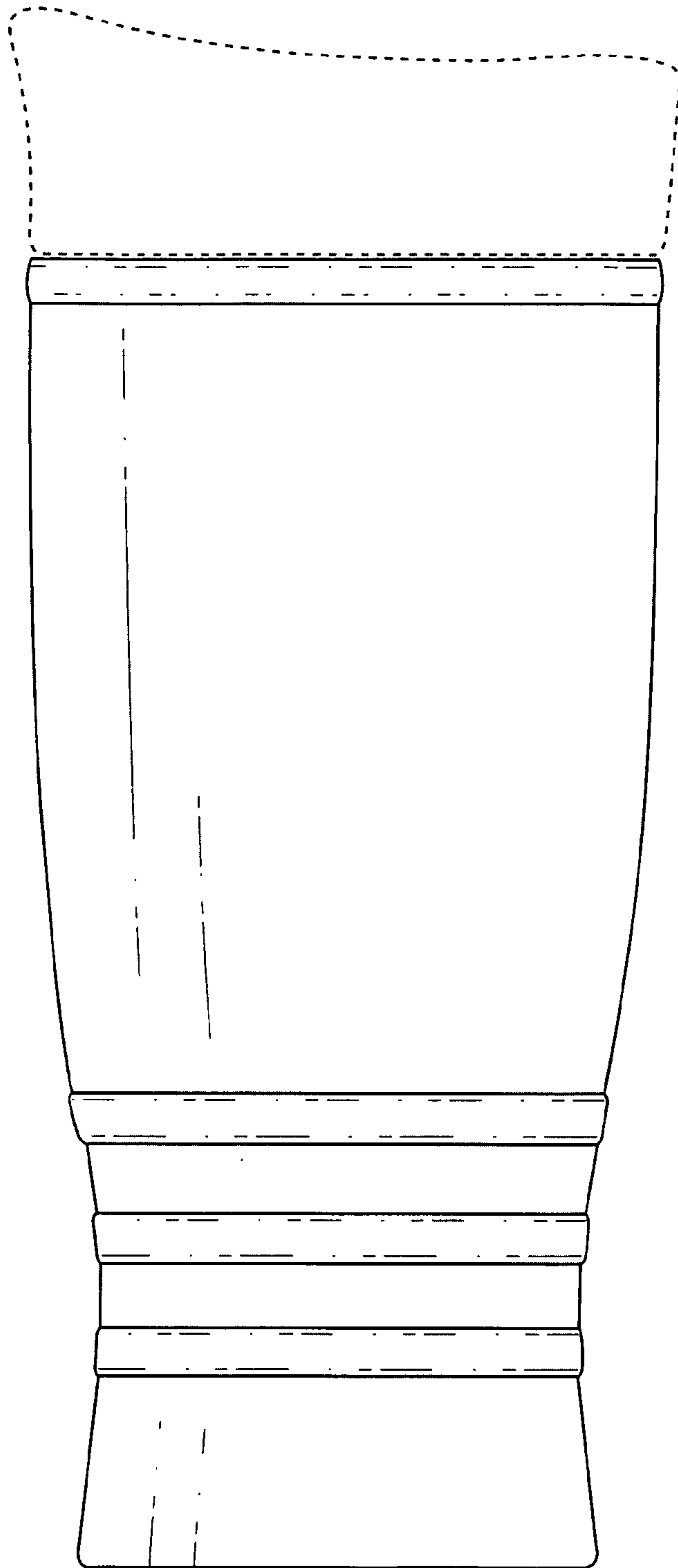




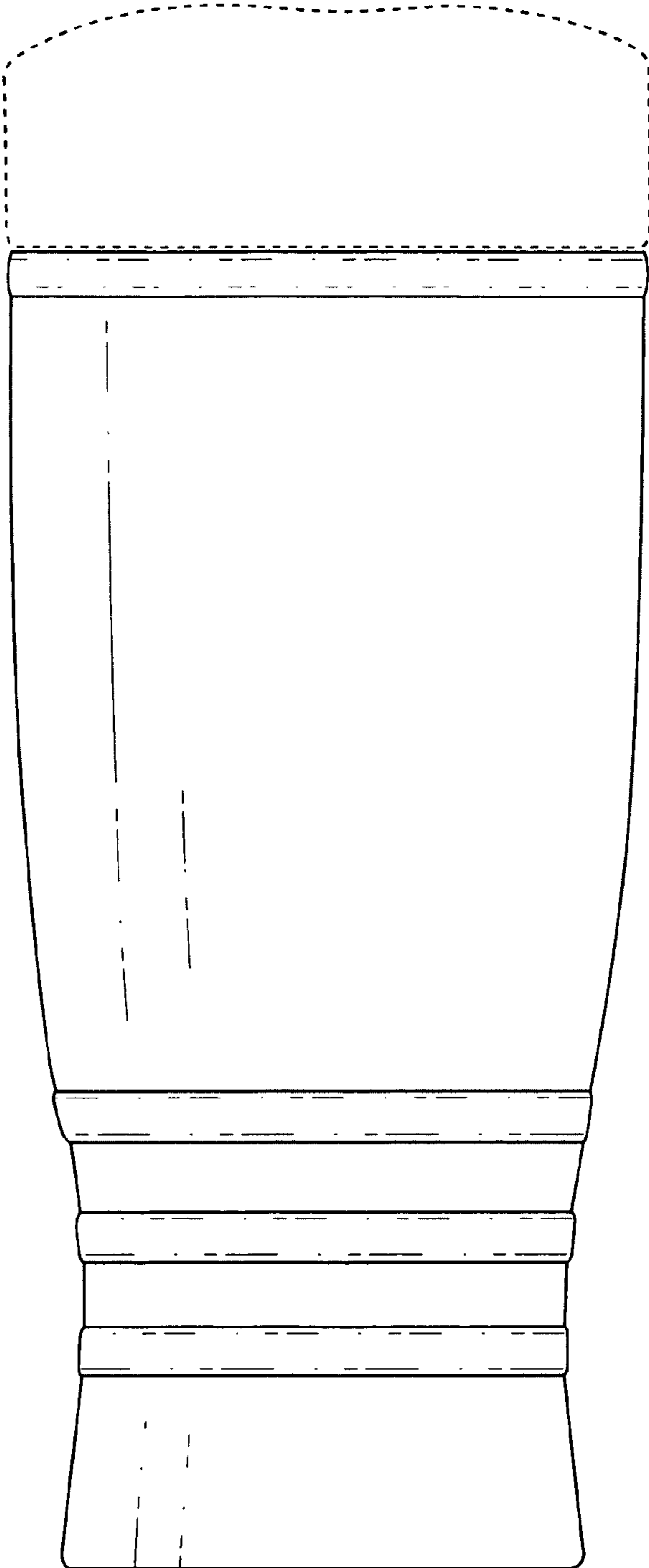

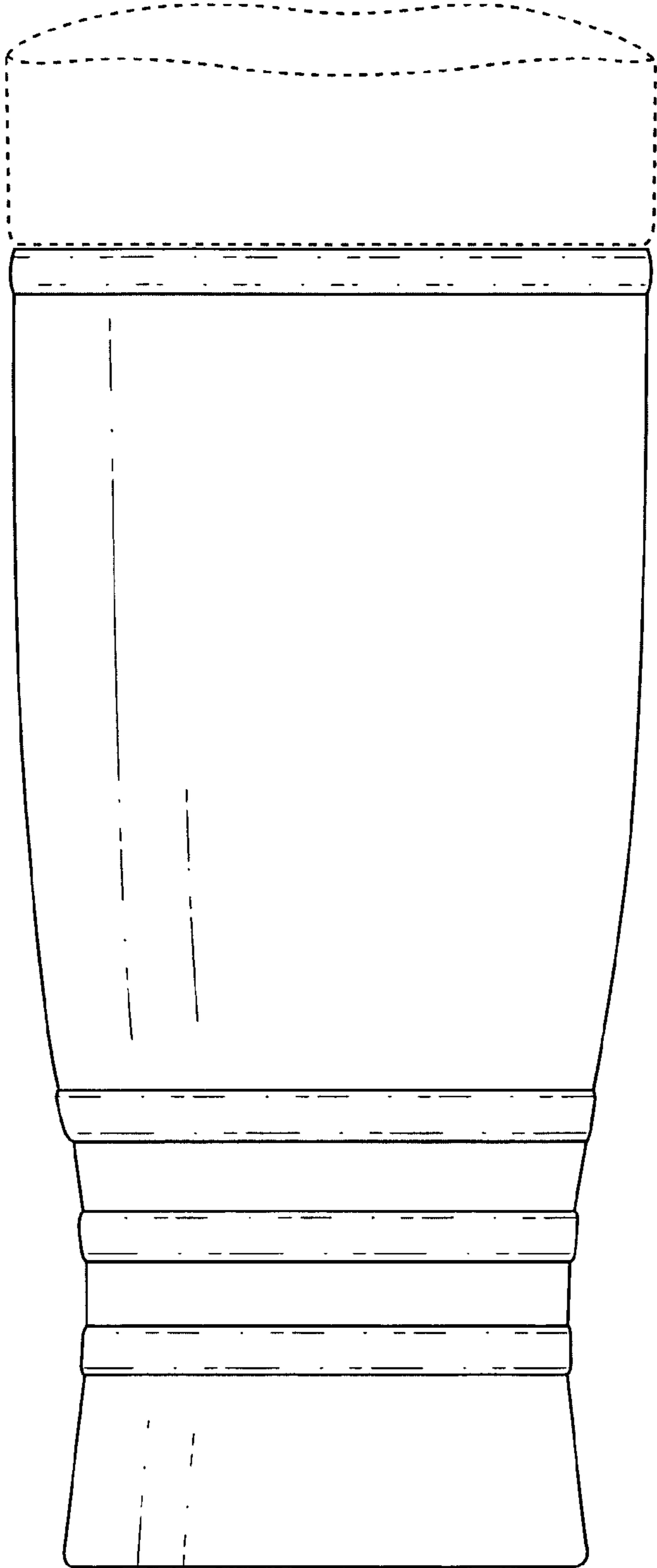

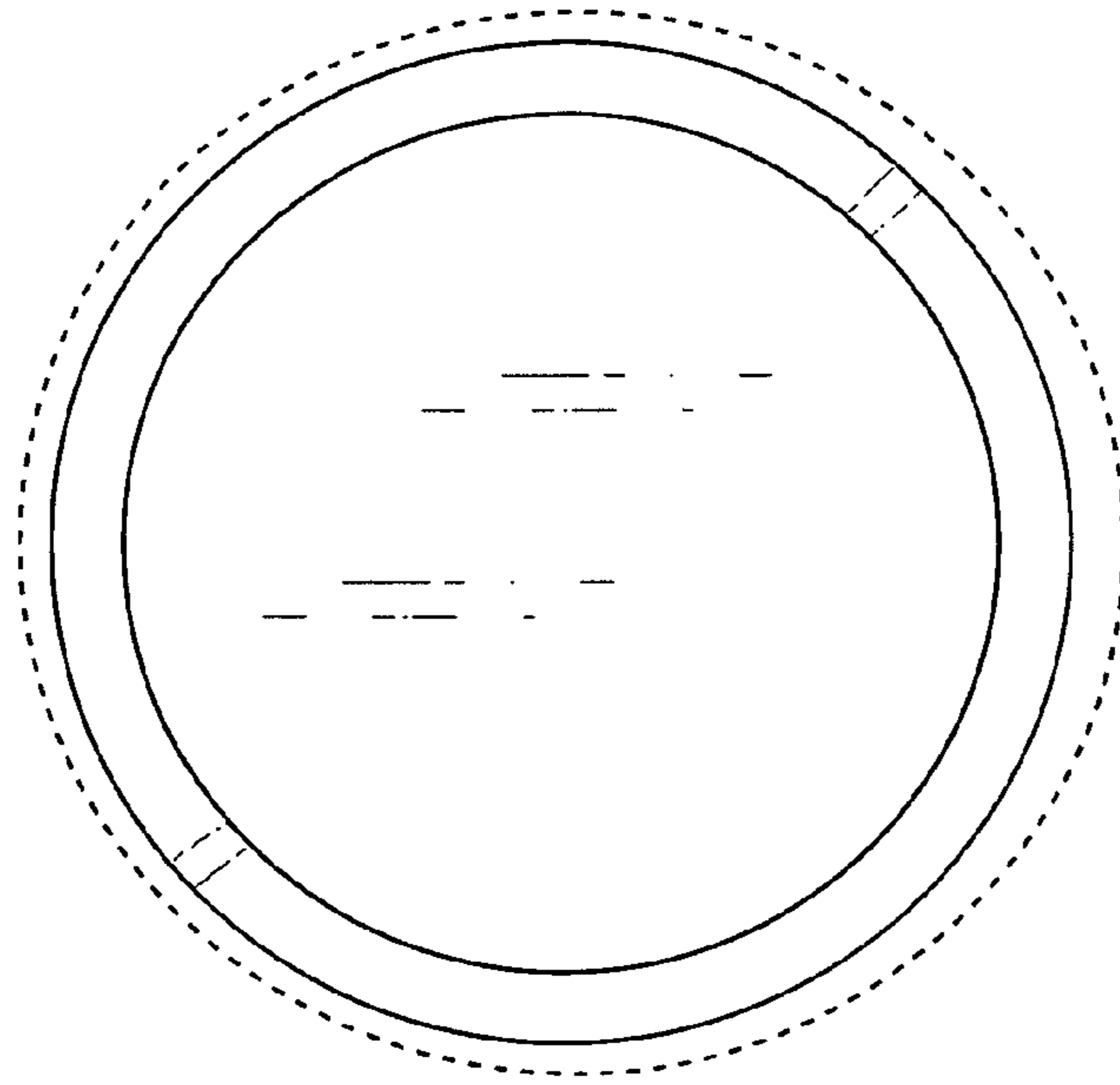

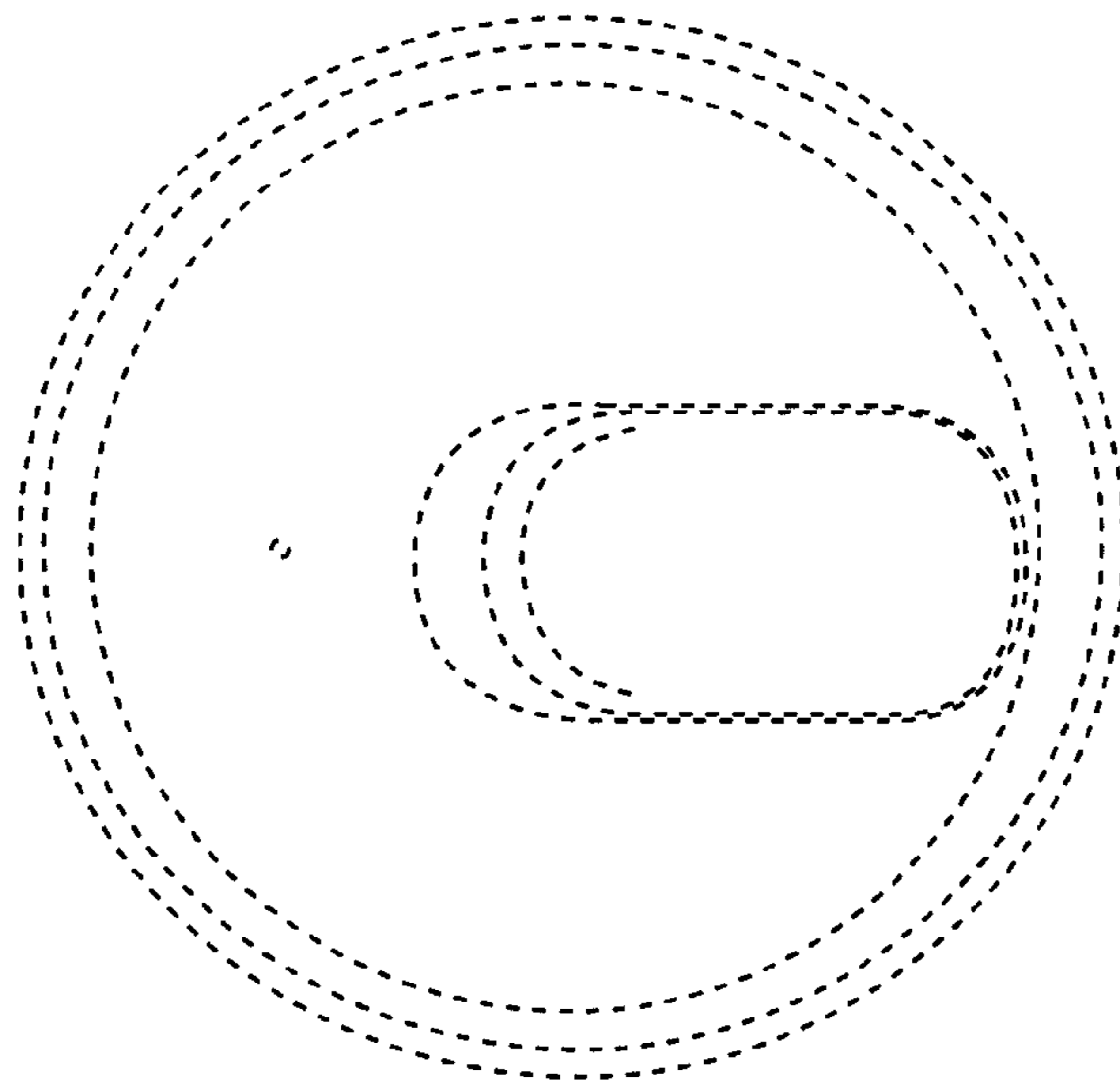
