We claim the ornamental design for a box grater, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a box grater according to the new design;

FIG. 4 is a front view of the box grater shown in FIG. 1;

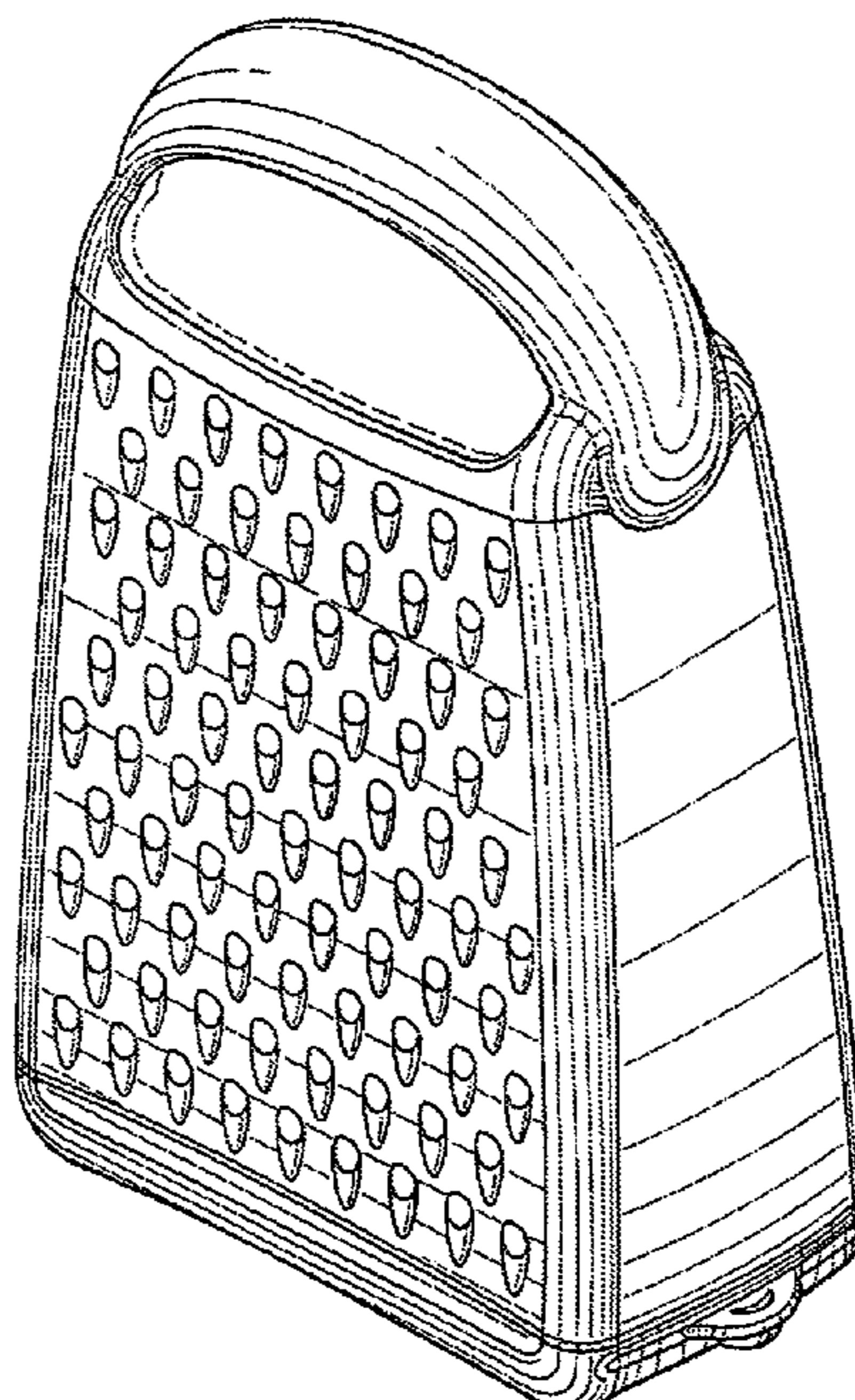
FIG. 5 is a right side view of the box grater shown in FIG. 1;

FIG. 6 is a rear view of the box grater shown in FIG. 1; and,

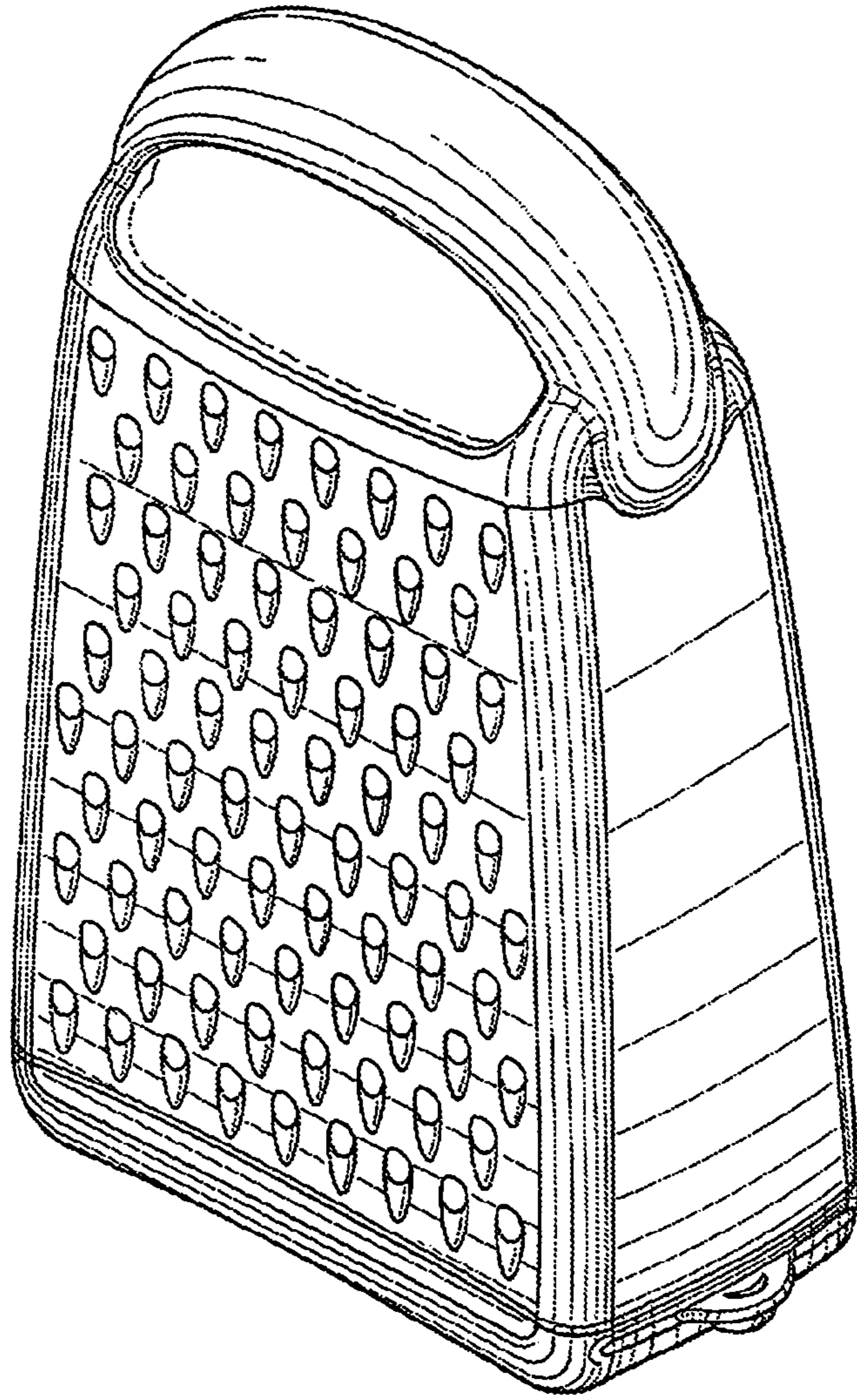
FIG. 7 is a left side view of the box grater shown in FIG. 1.

The broken lines of the interior top portion are for illustrative purposes only and form no part of the claimed design.

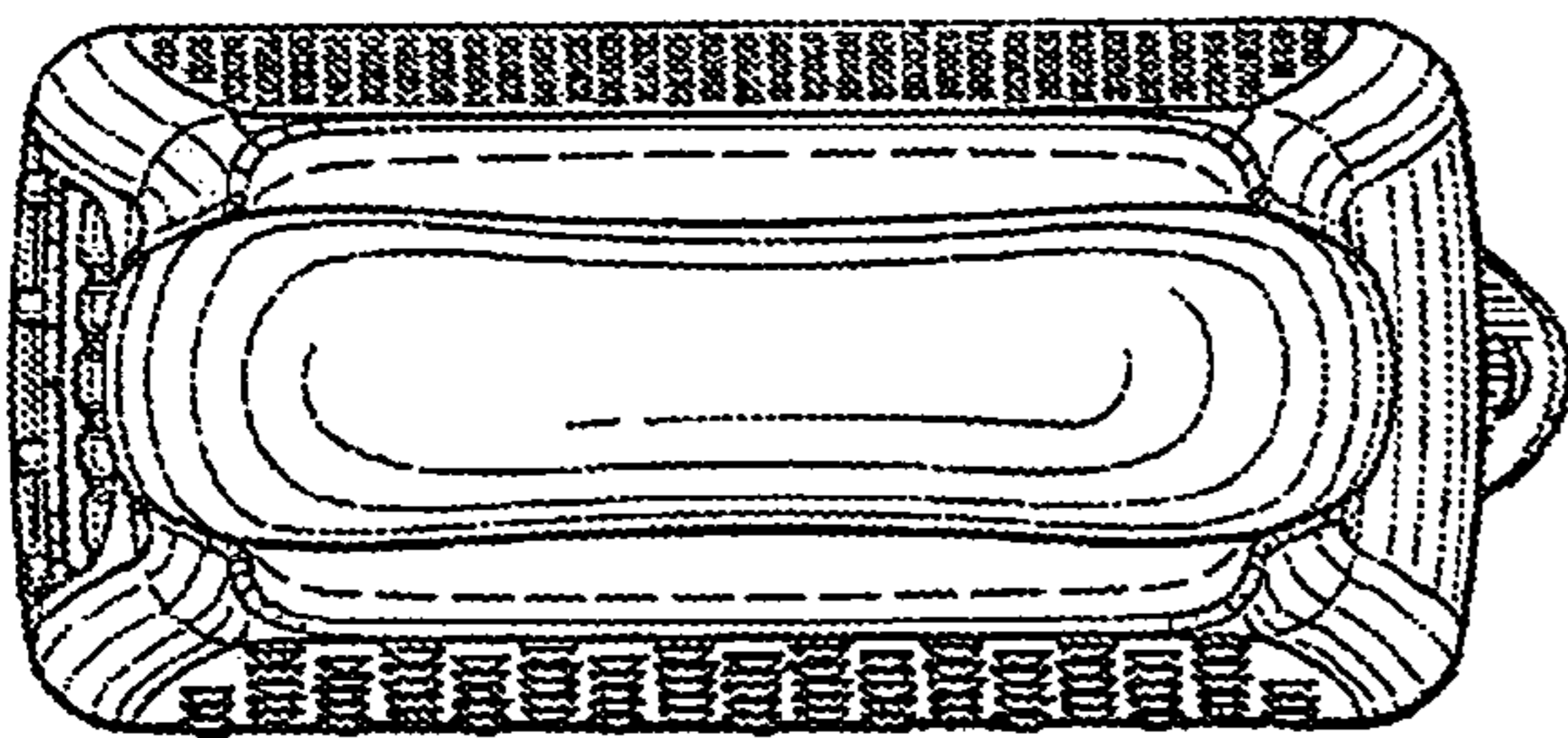

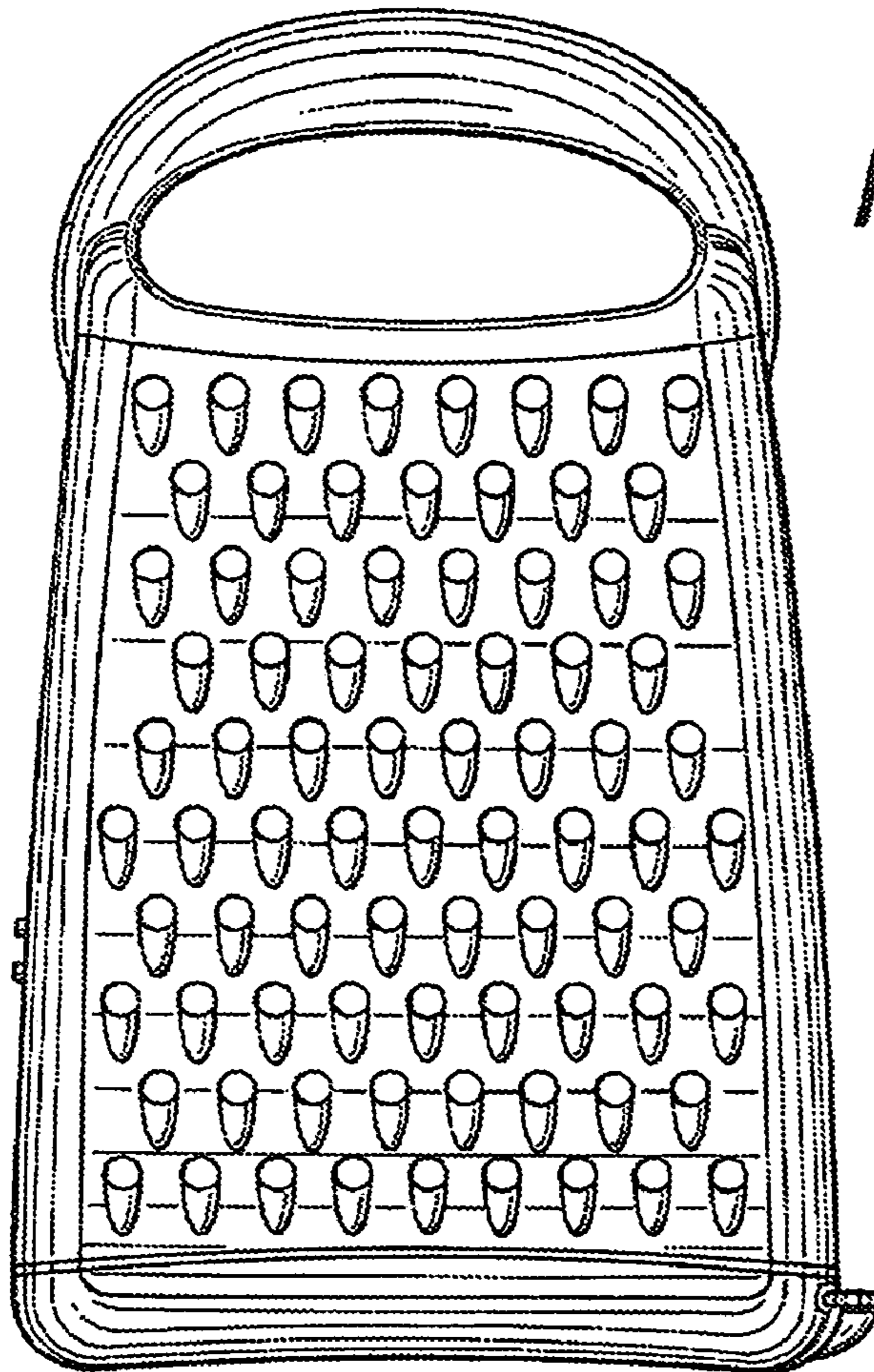
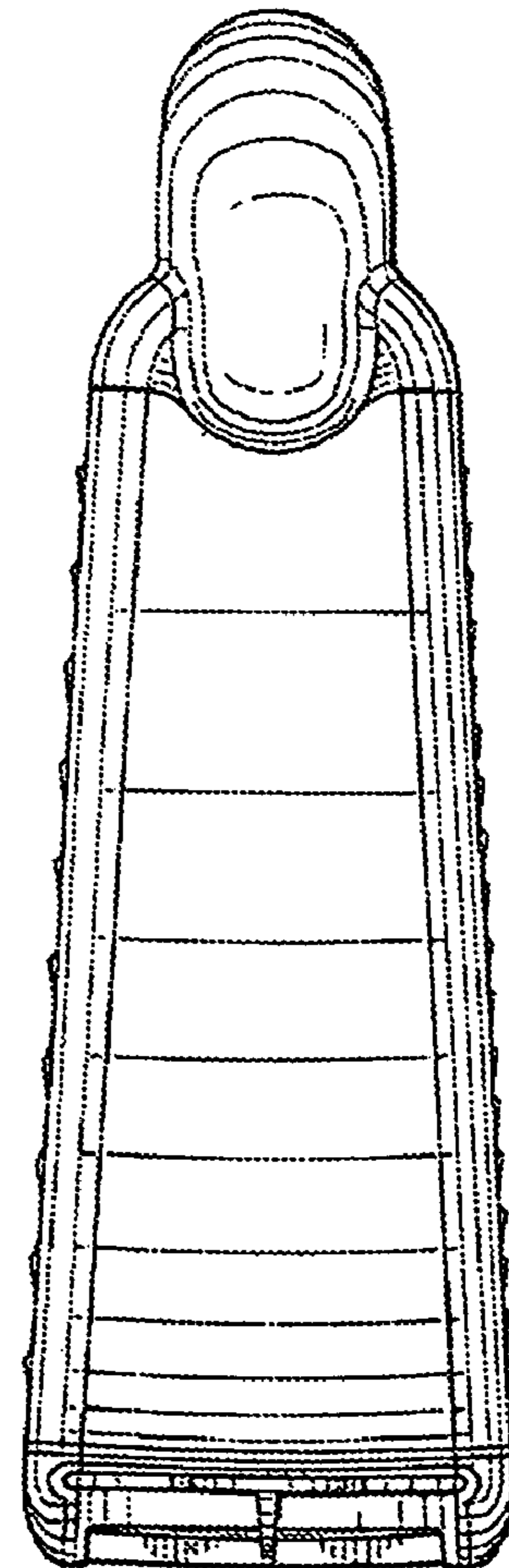

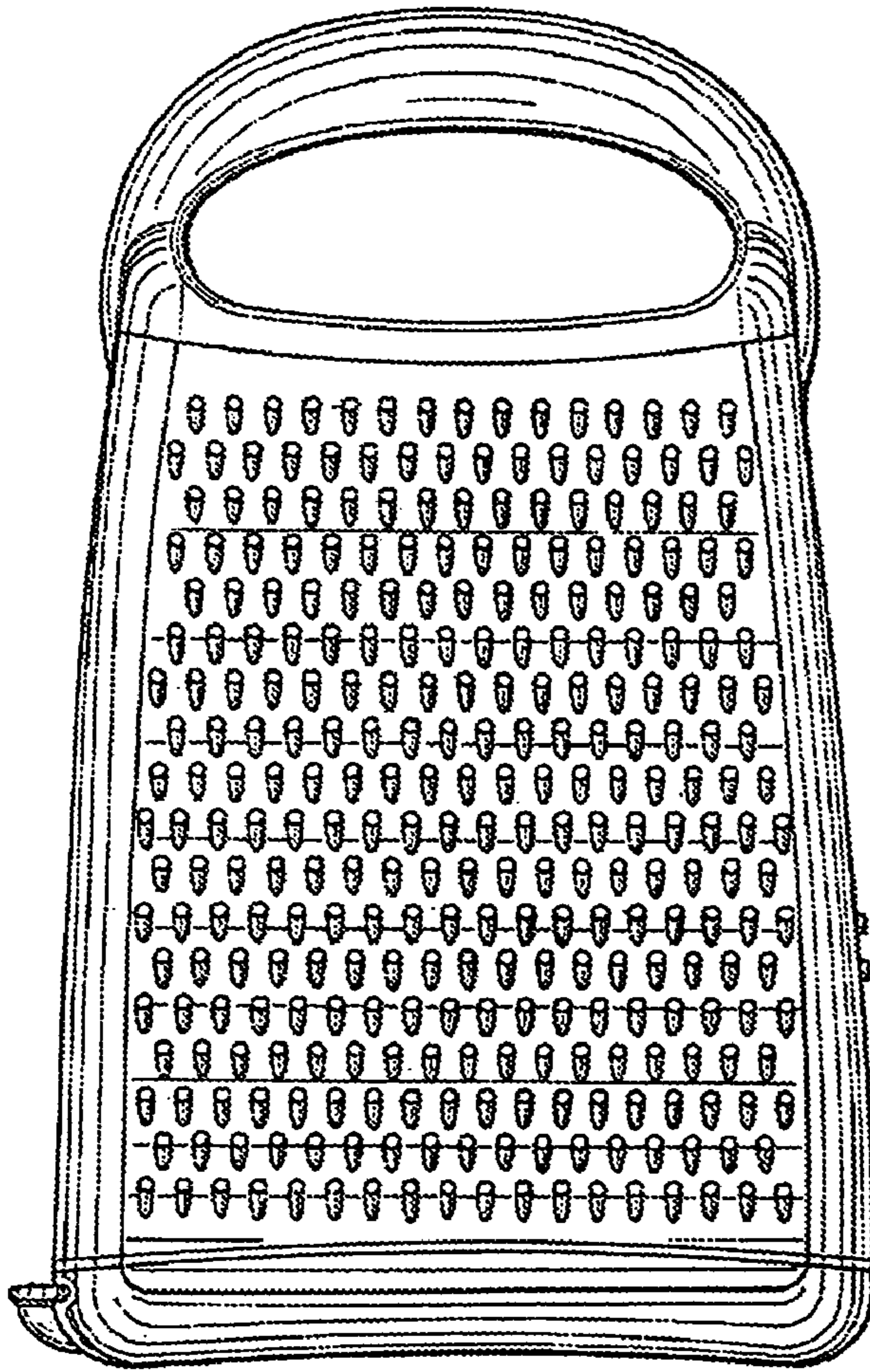
