FIG. 3 depicts a top plan view of the invention of FIG. 1.

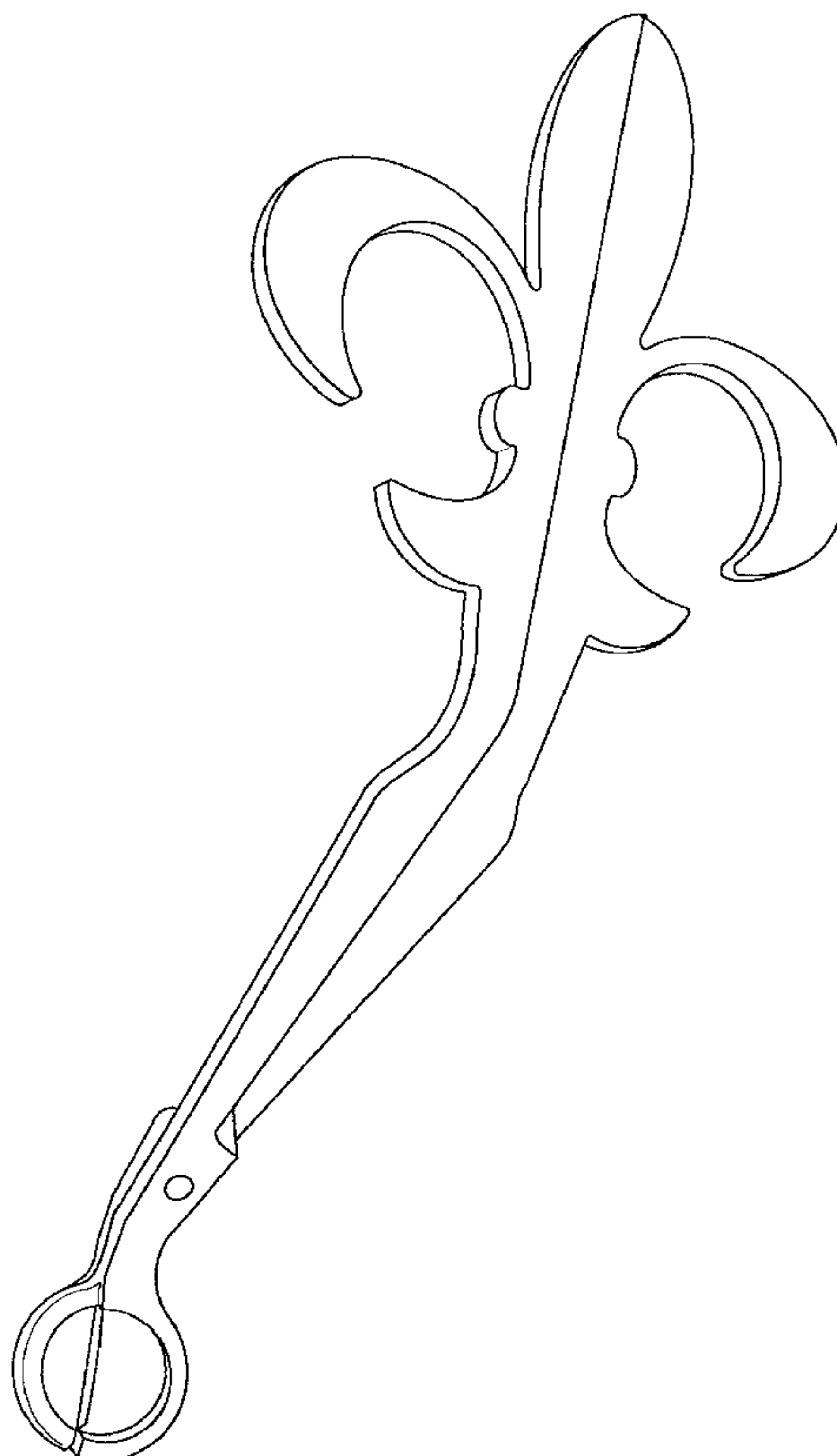
FIG. 4 depicts a bottom plan view of the invention of FIG. 1.

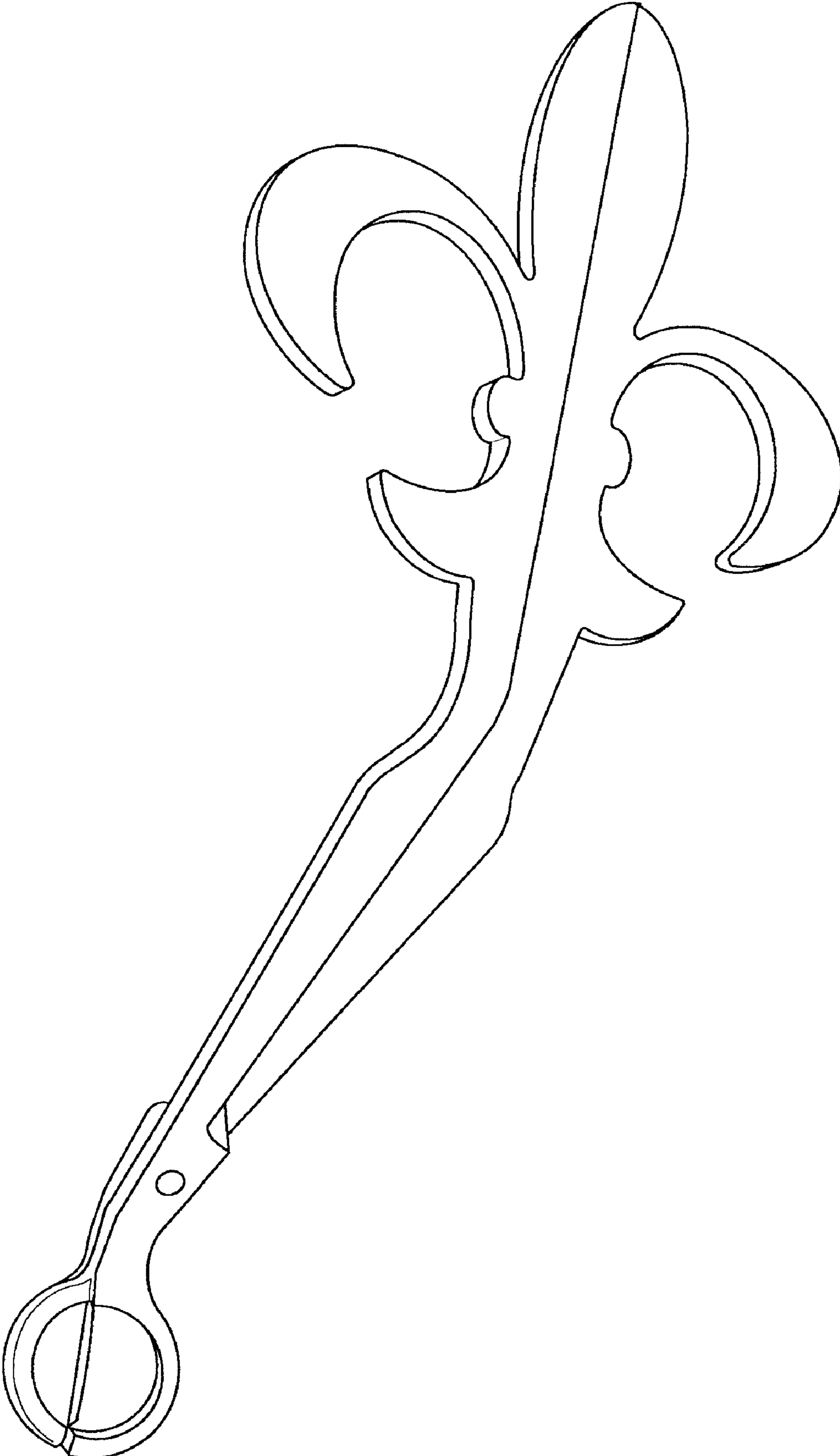

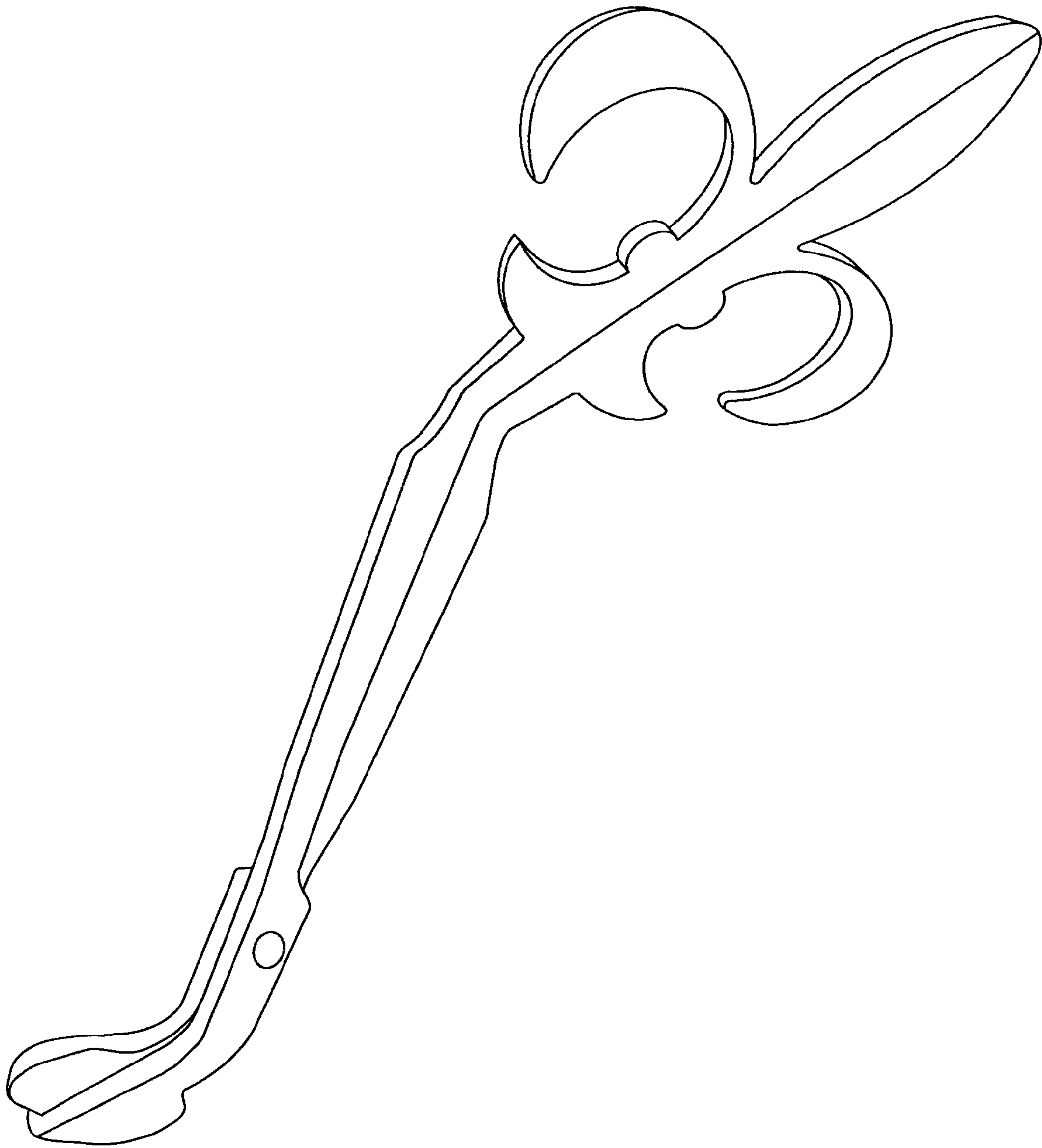

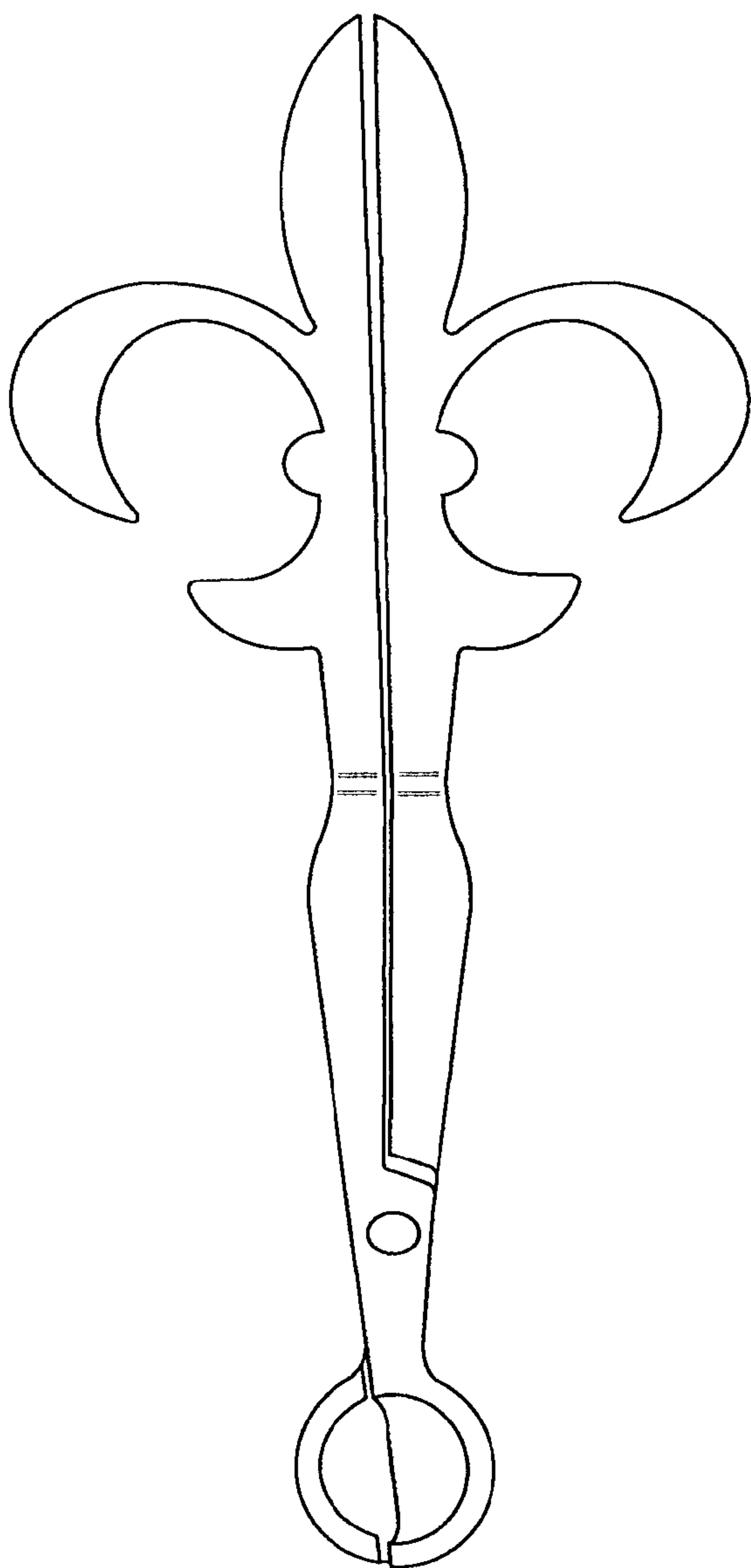

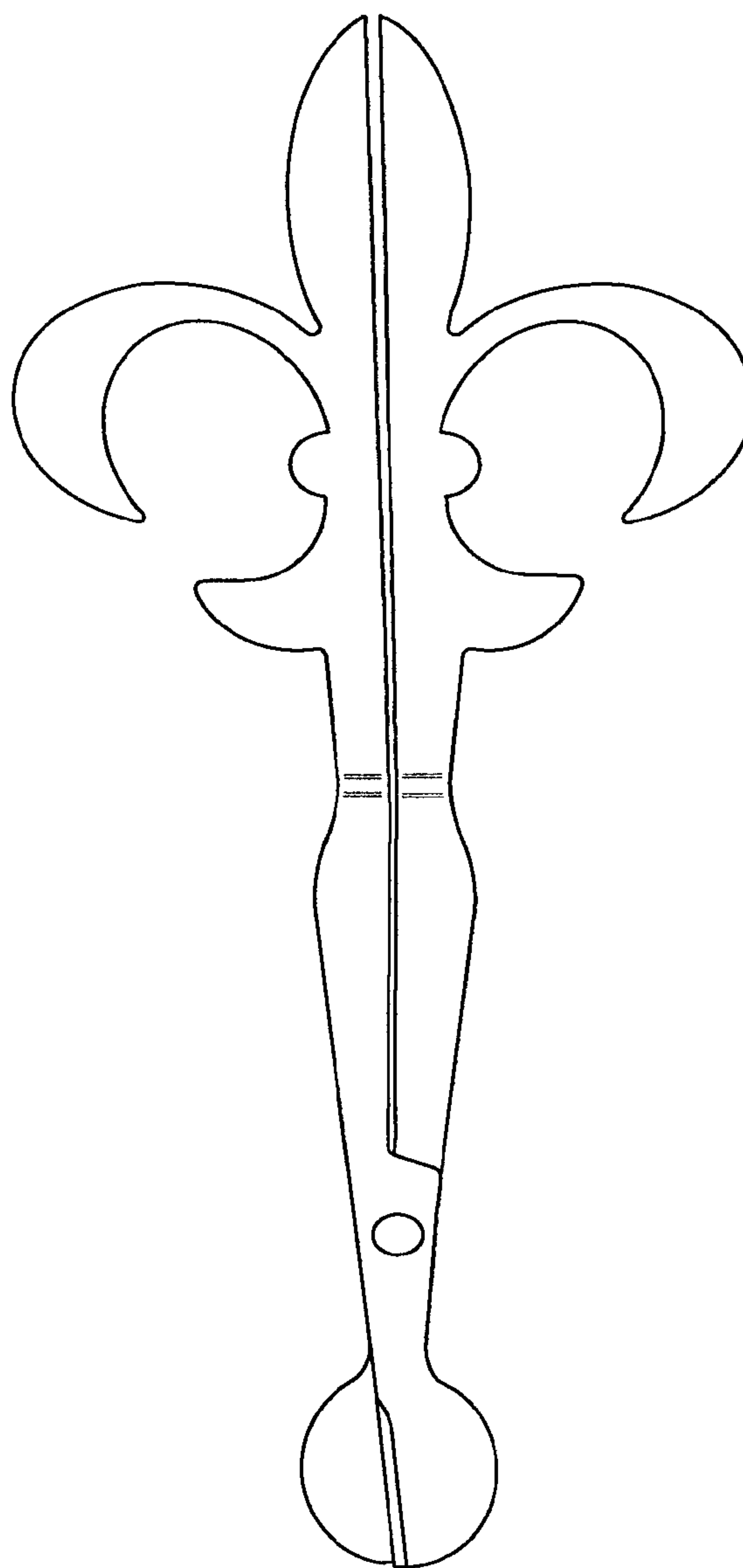

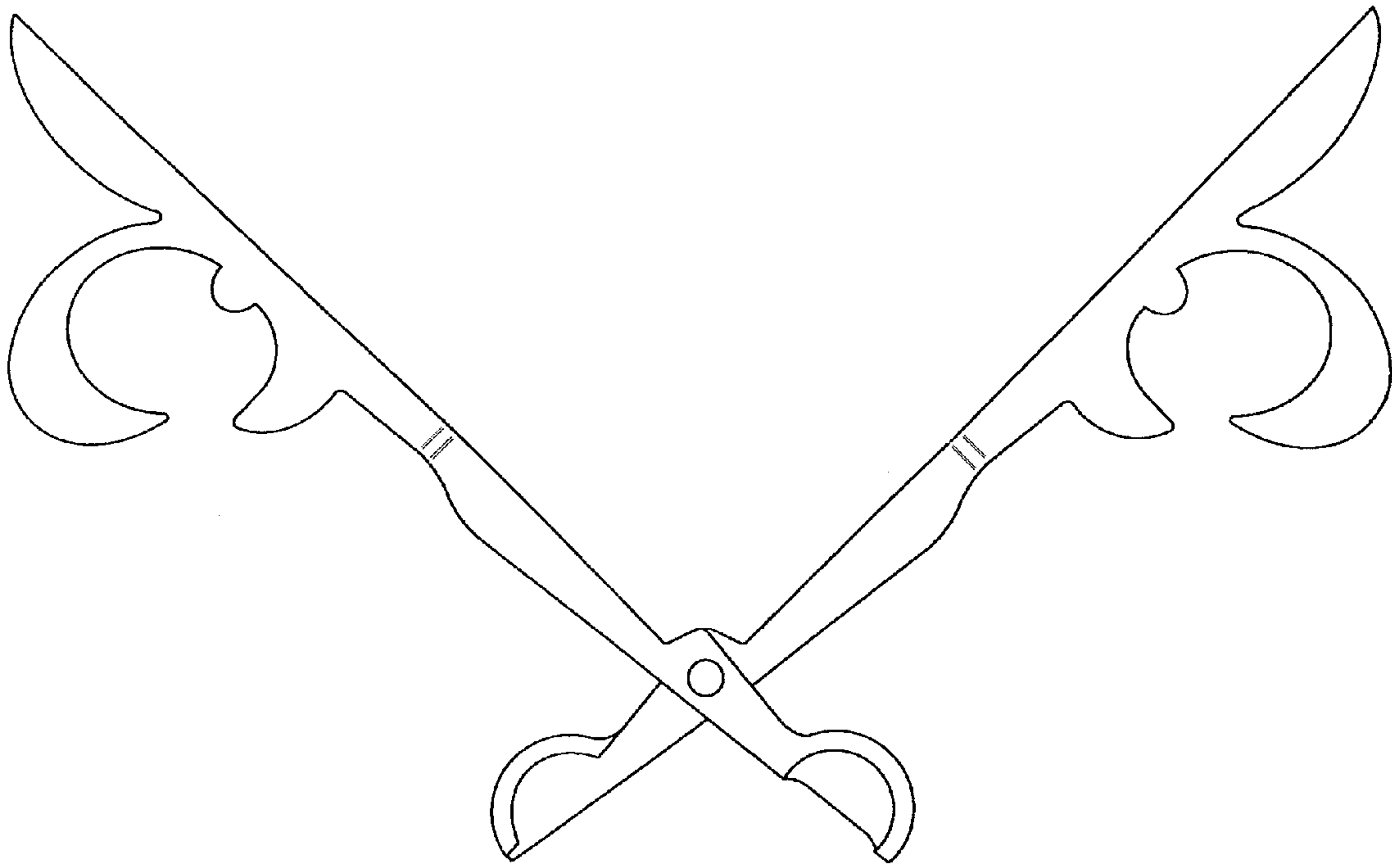

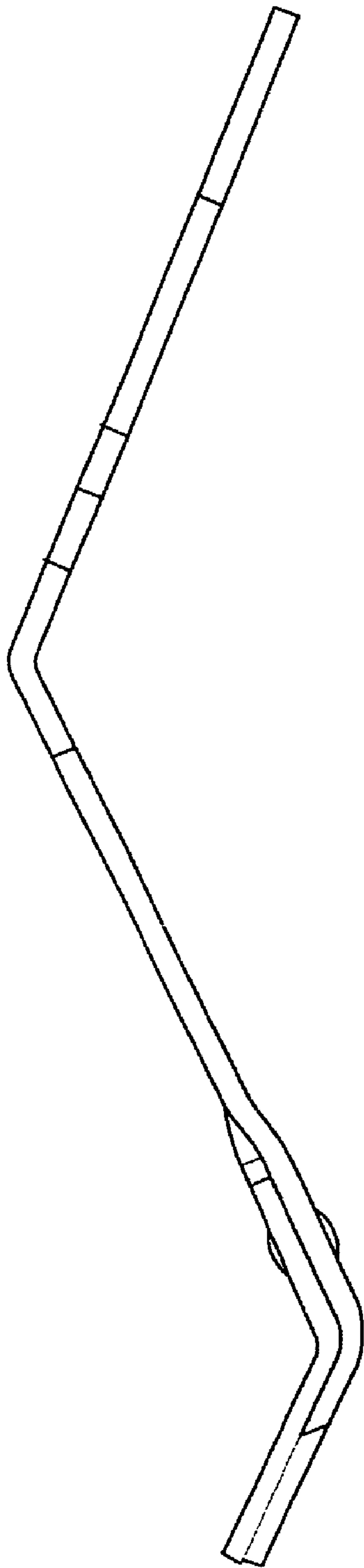

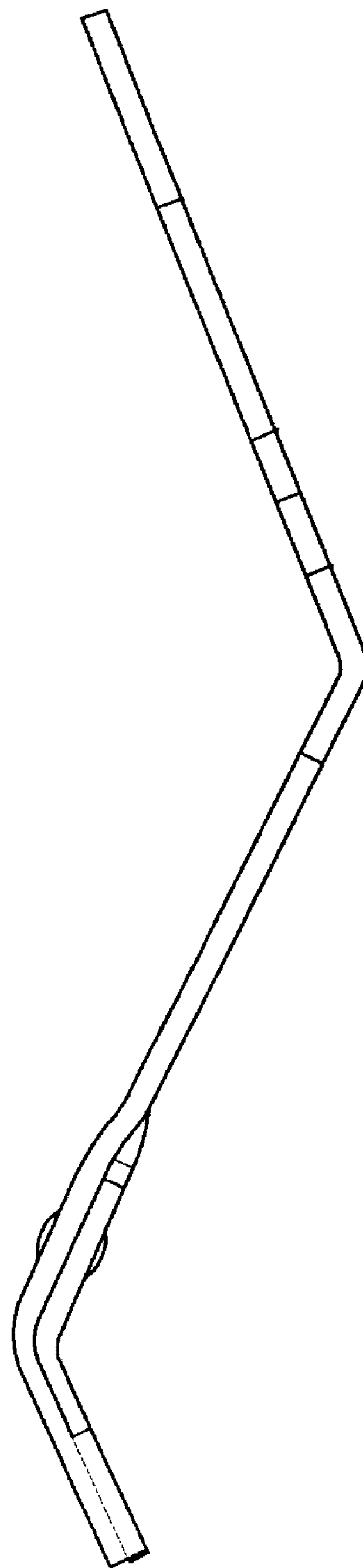
