The ornamental design for a multimedia speaker system, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a multimedia speaker system of the present design;

FIG. 2 is front elevational view of the central component of the multimedia speaker system of the present design, shown separately for clarity of illustration;

FIG. 3 is a rear elevational view of FIG. 2;

FIG. 4 is a left side elevational view of FIG. 2;

FIG. 5 is a right side elevational view of FIG. 2;

FIG. 6 is a top plan view of FIG. 2;

FIG. 7 is a bottom plan view of FIG. 2;

FIG. 8 is a front elevational view of one of the speaker component of the multimedia speaker system, shown separately for clarity of illustration;

FIG. 9 is a rear elevational view of FIG. 8;

FIG. 10 is a left side elevational view of FIG. 8;

FIG. 11 is a right side elevational view of FIG. 8;

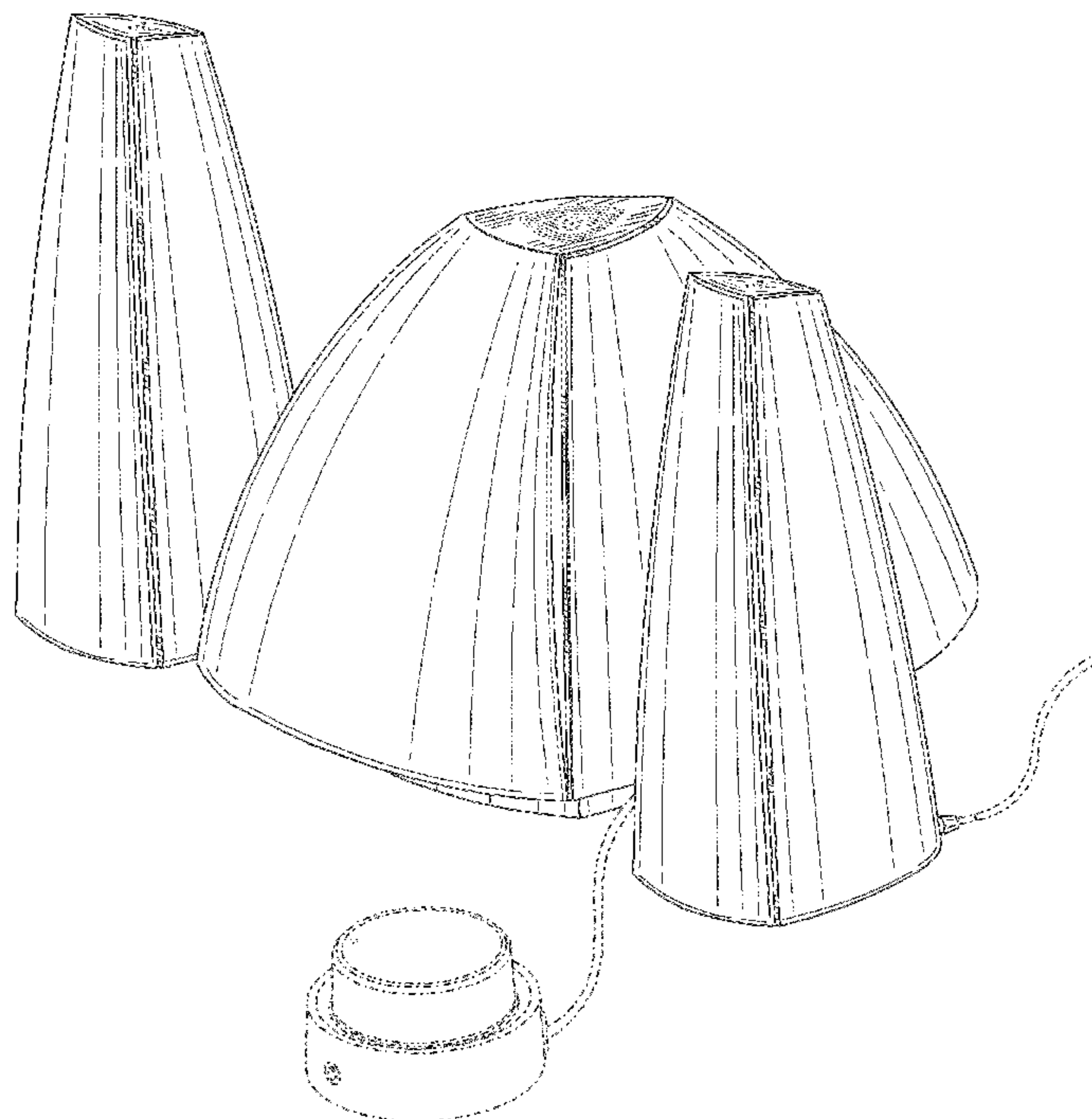
FIG. 12 is top plan view of FIG. 8; and,

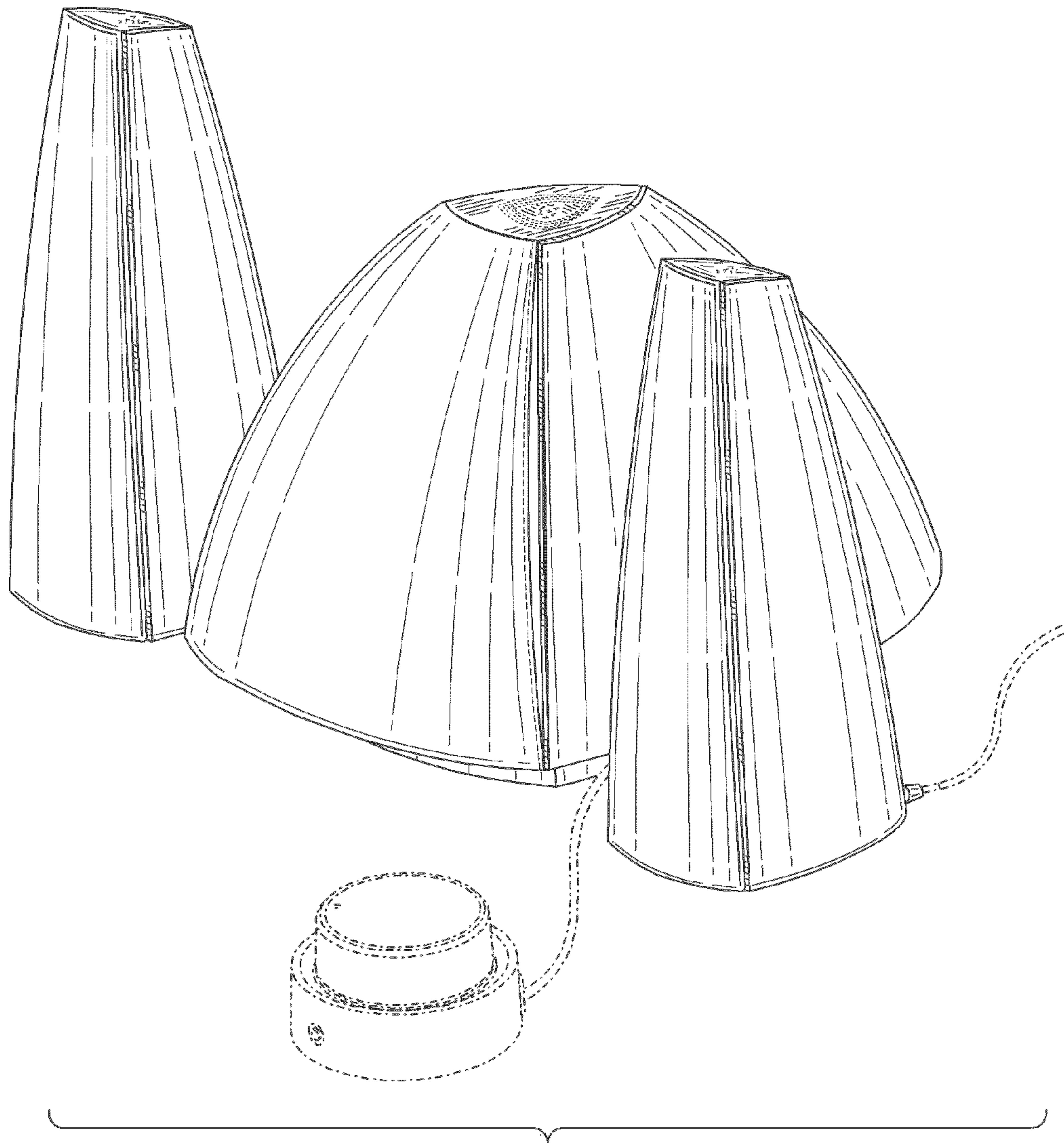

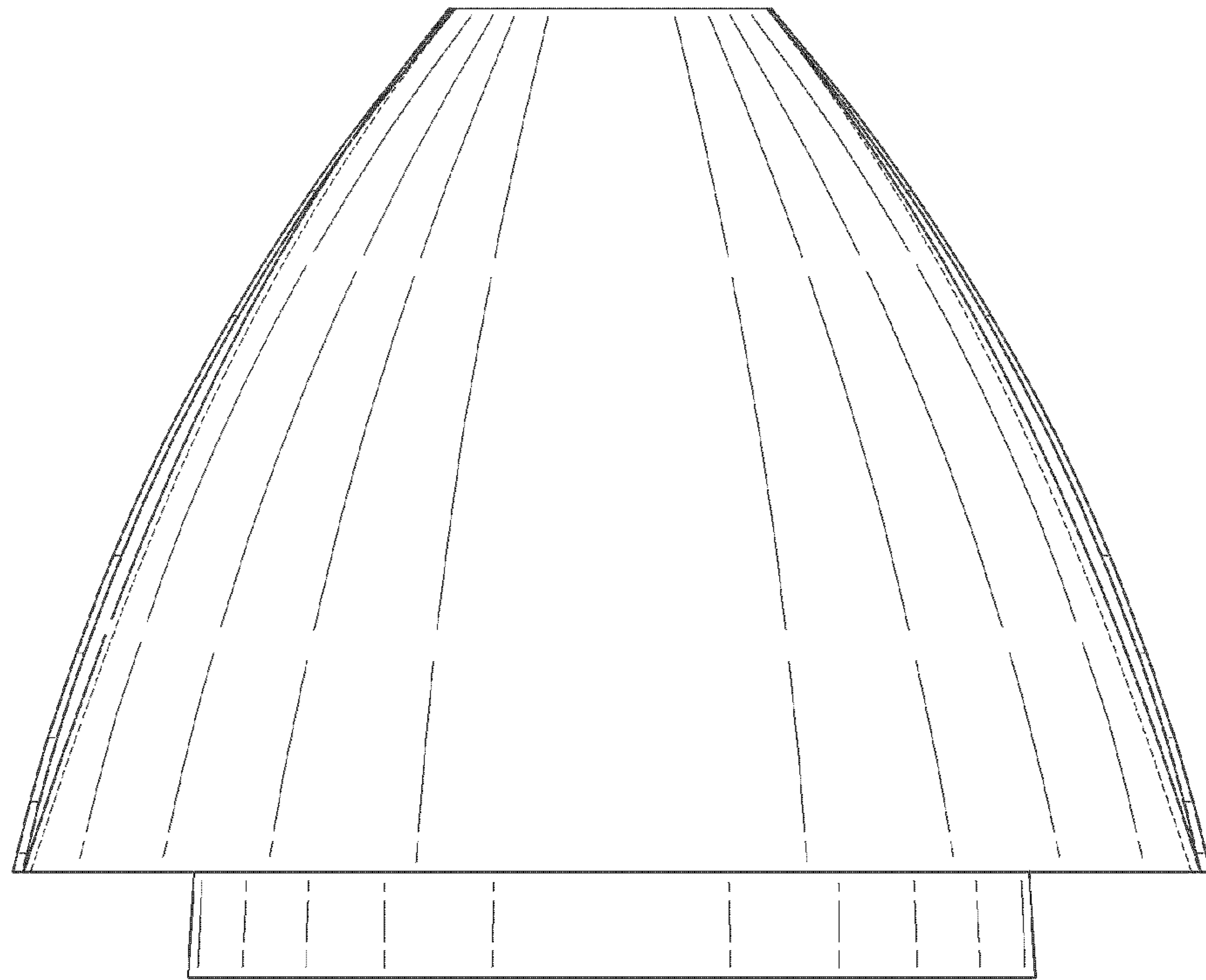

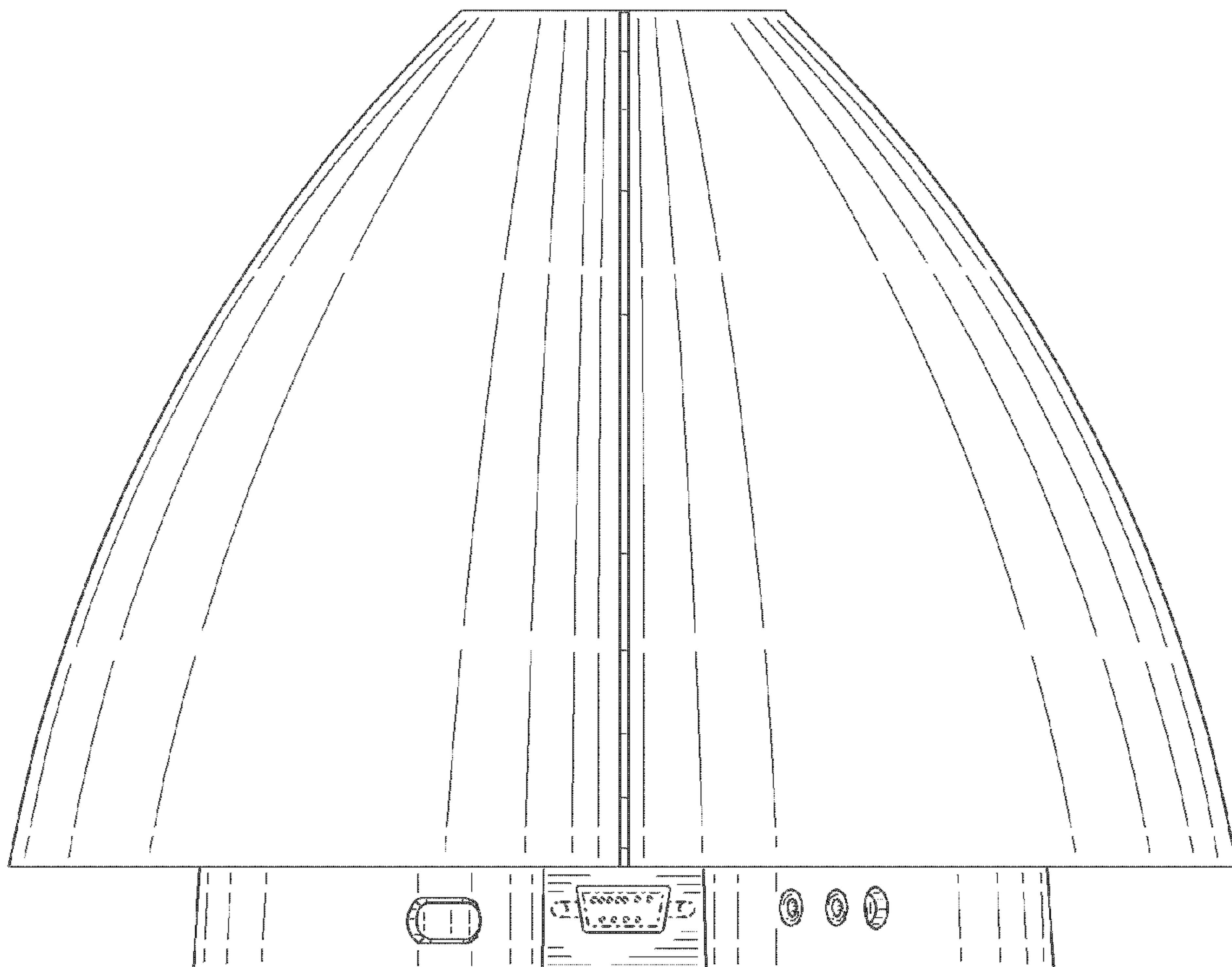

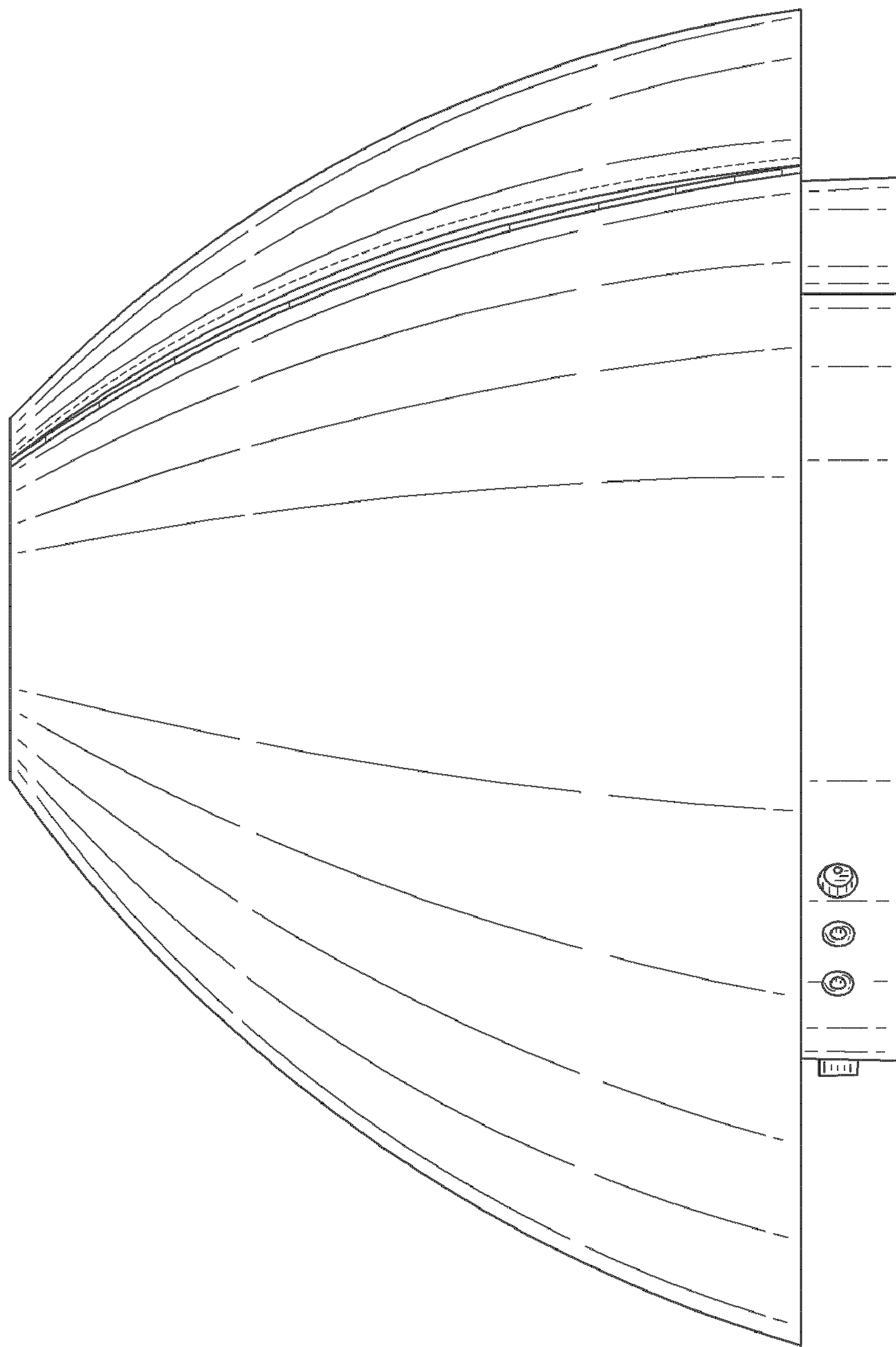

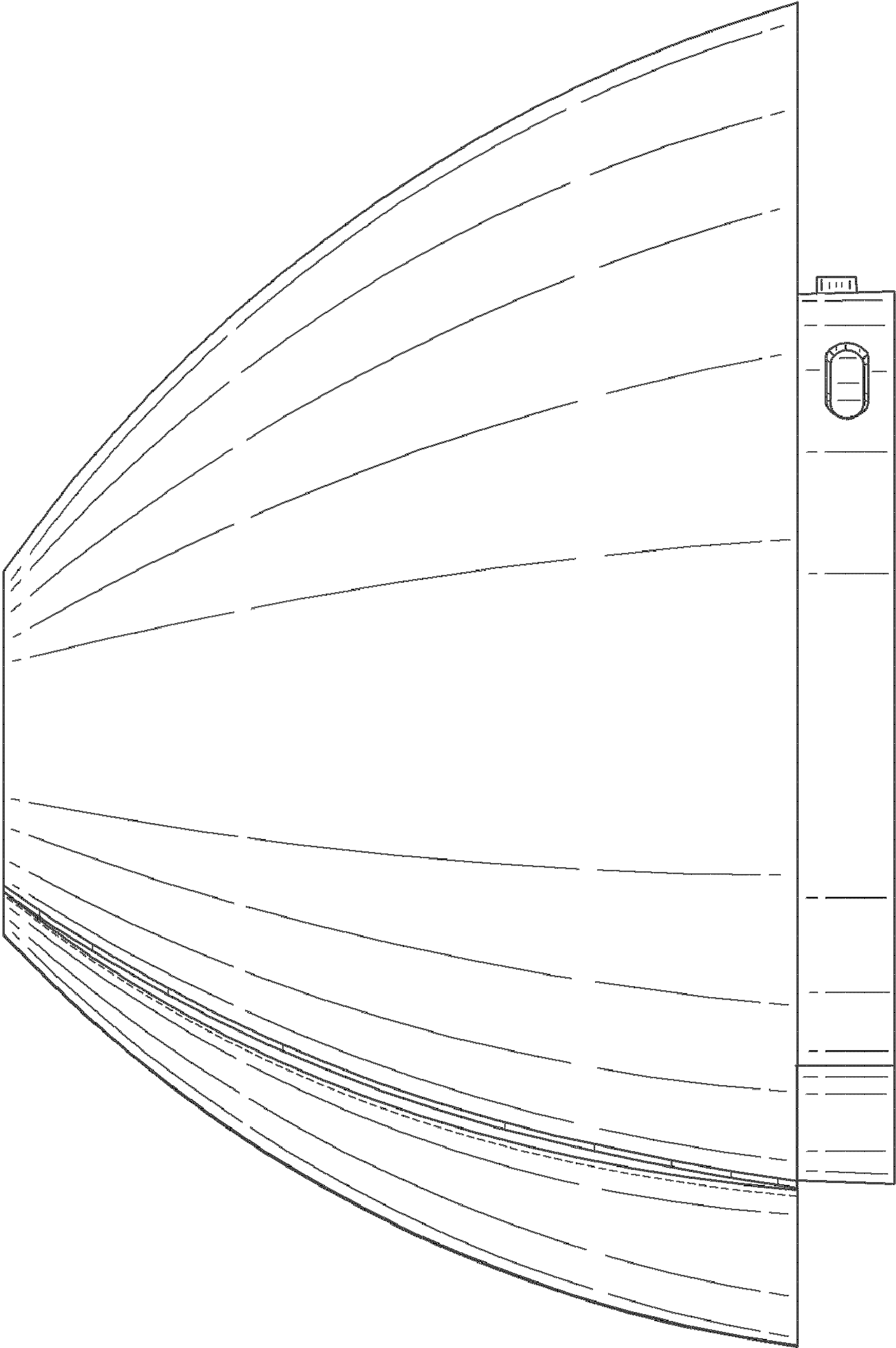

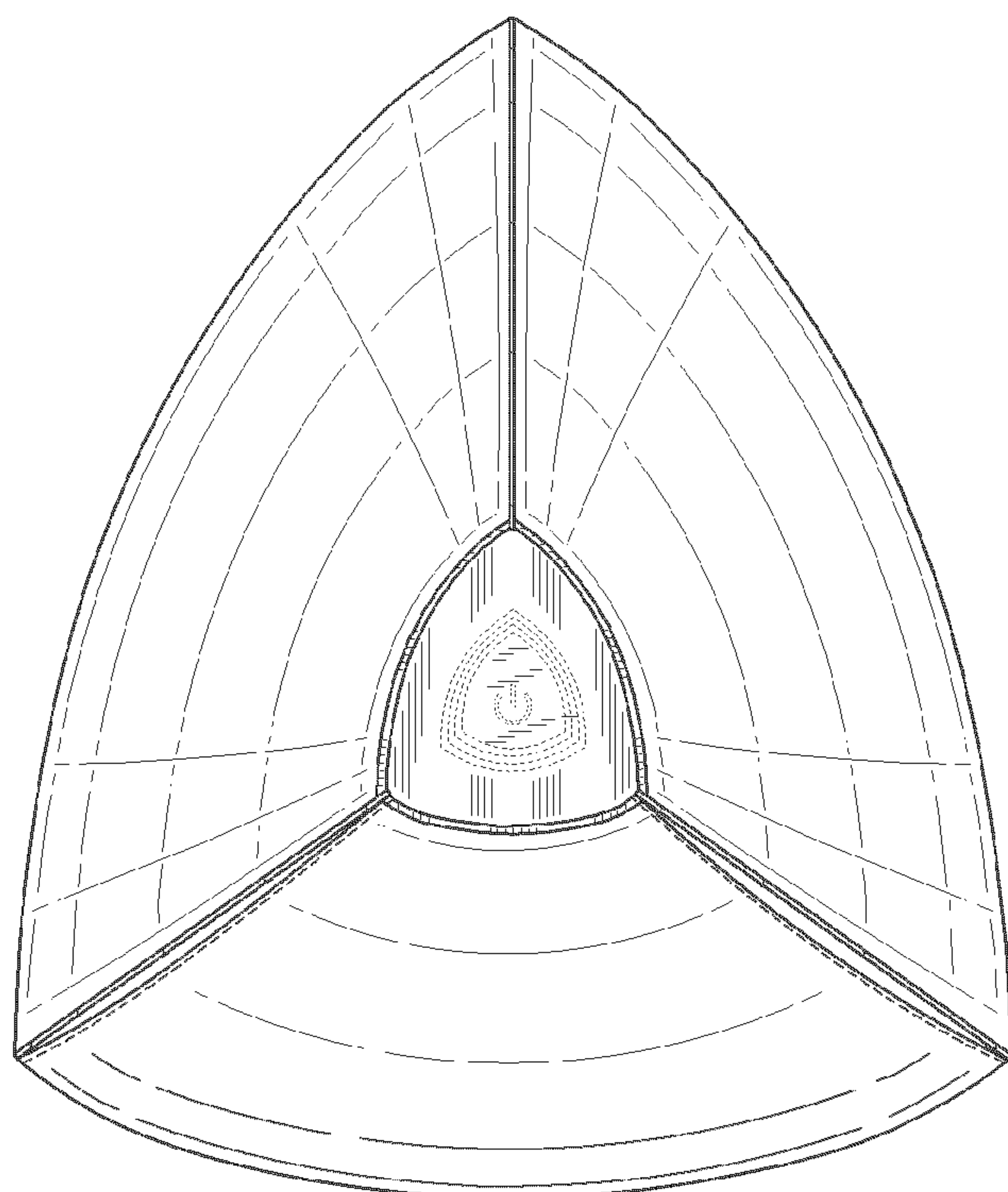

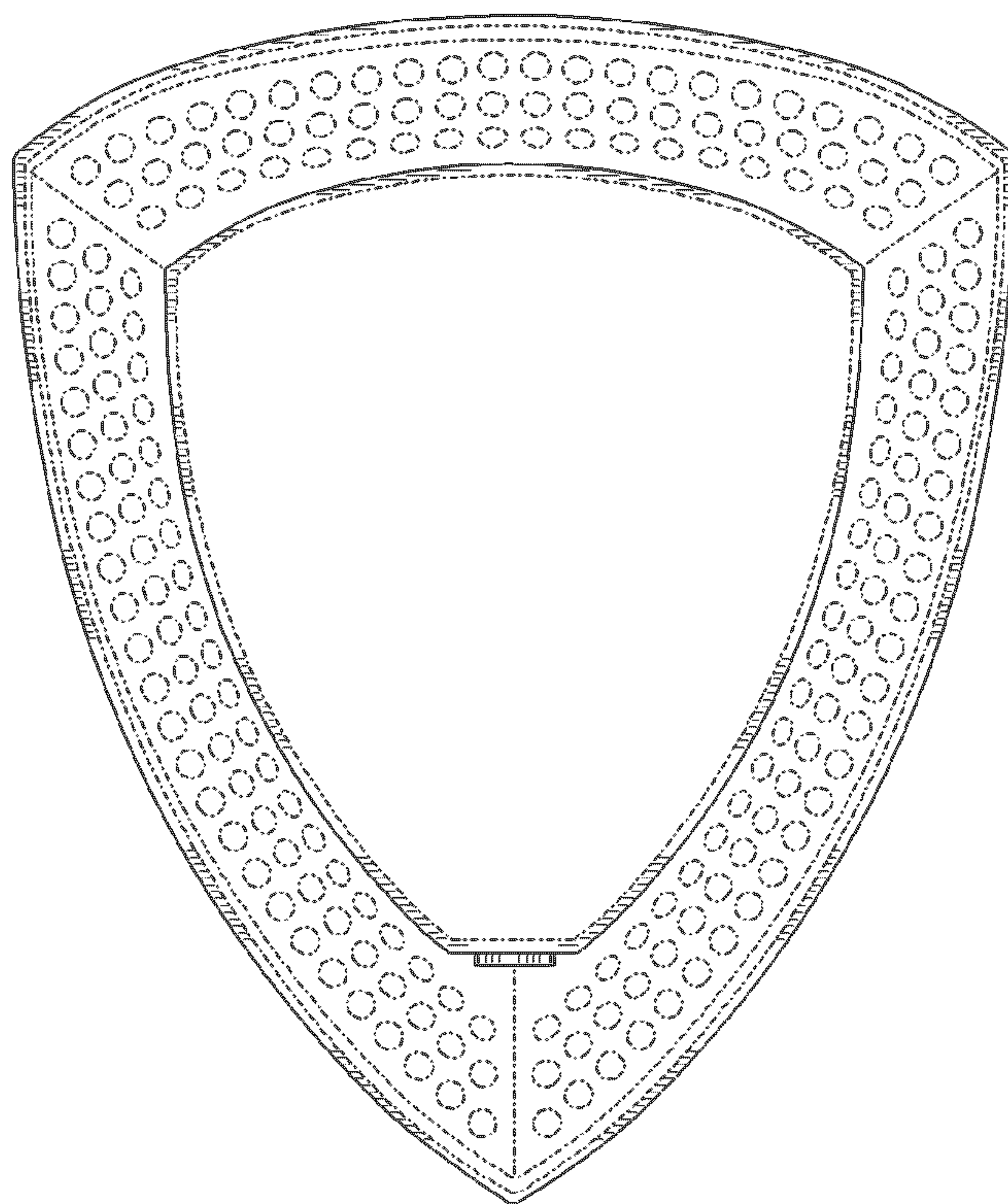

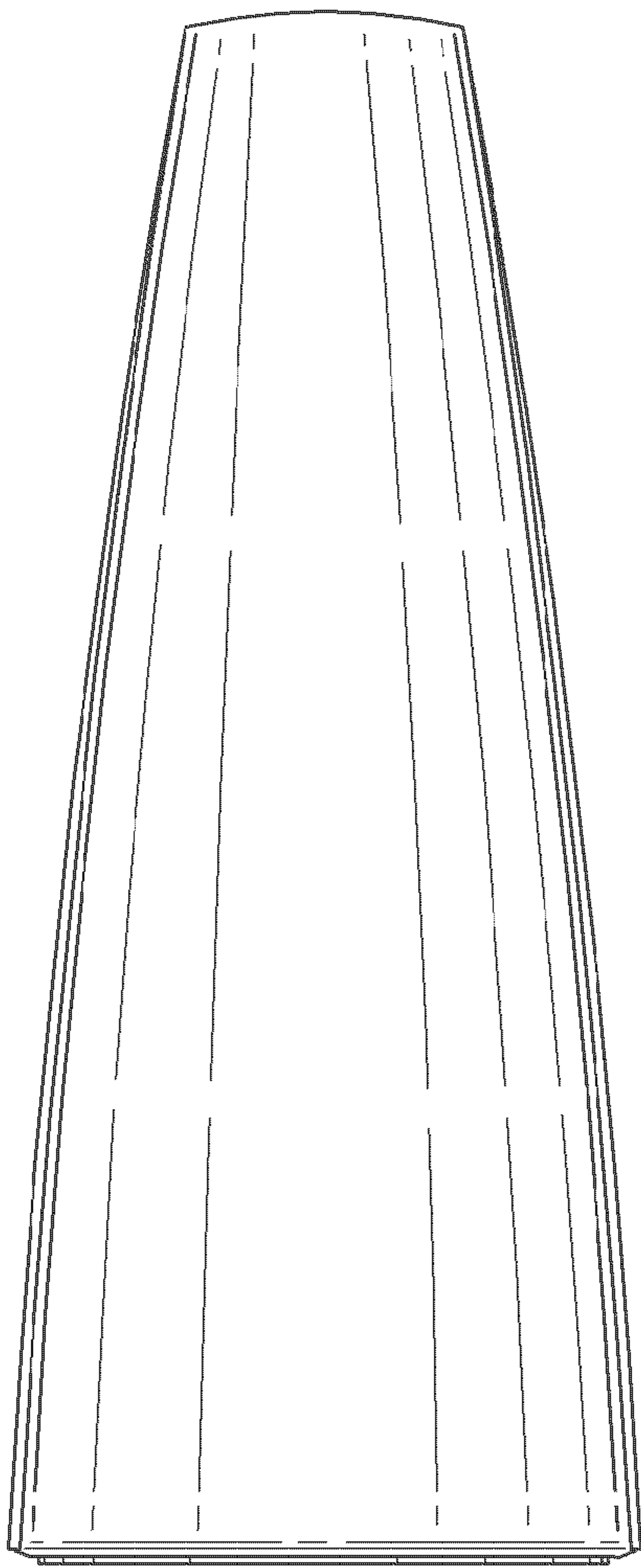

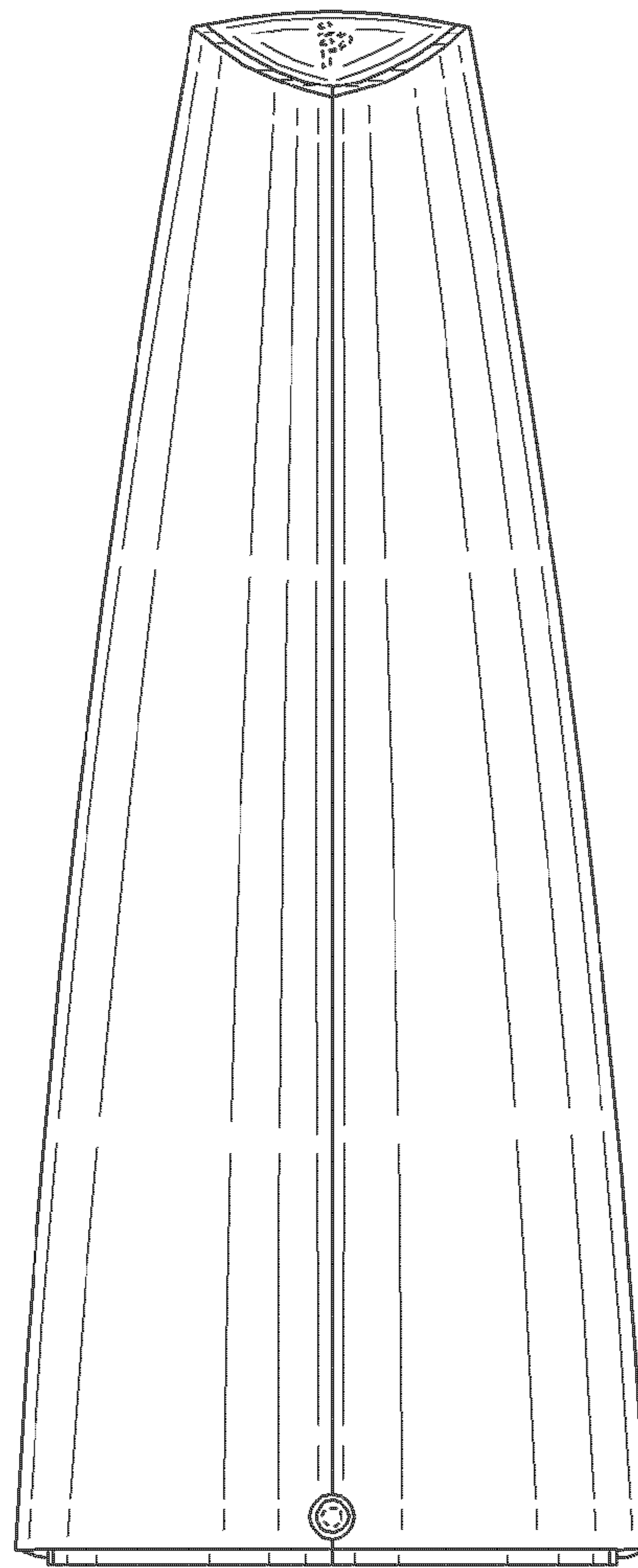

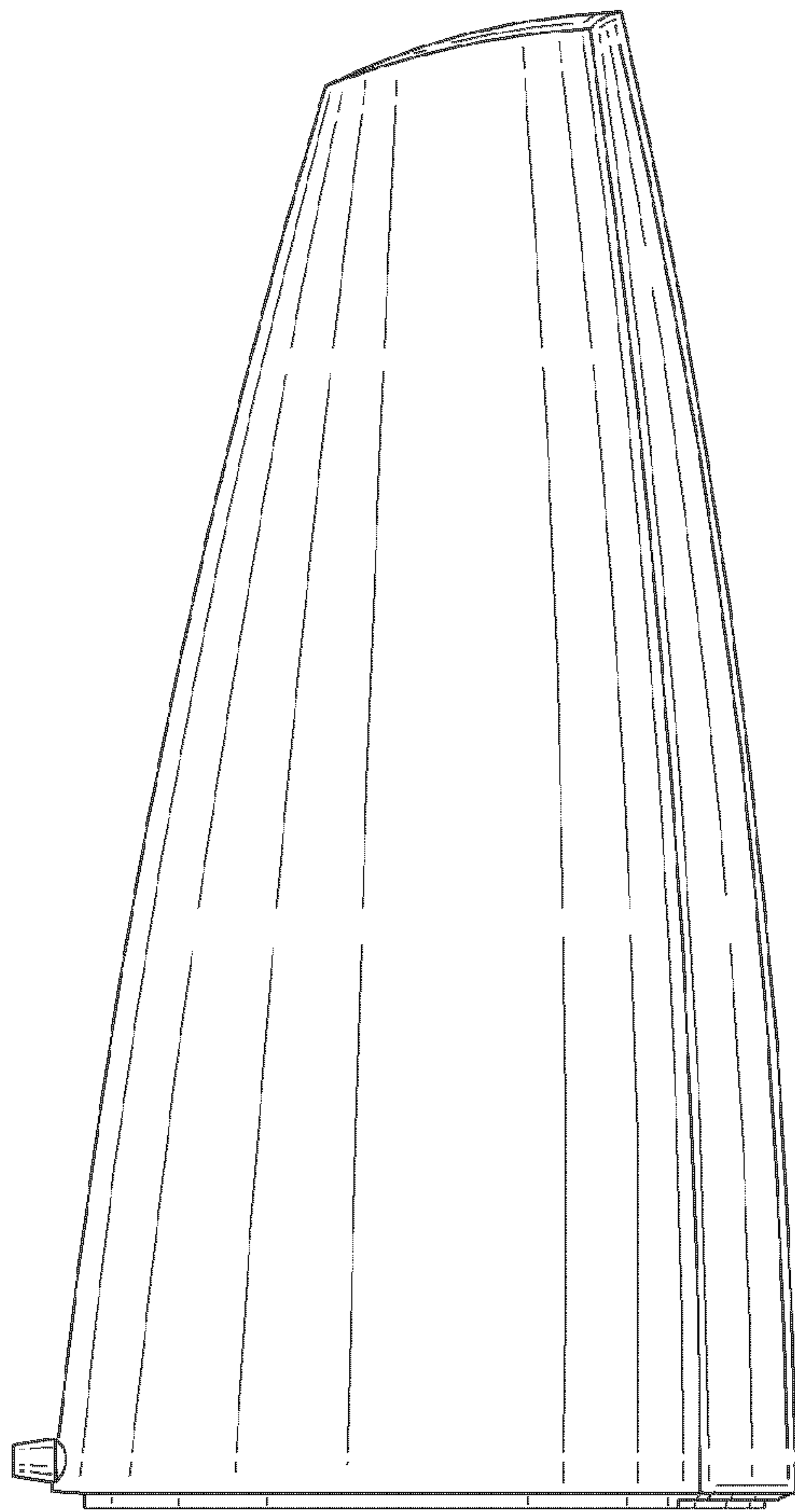

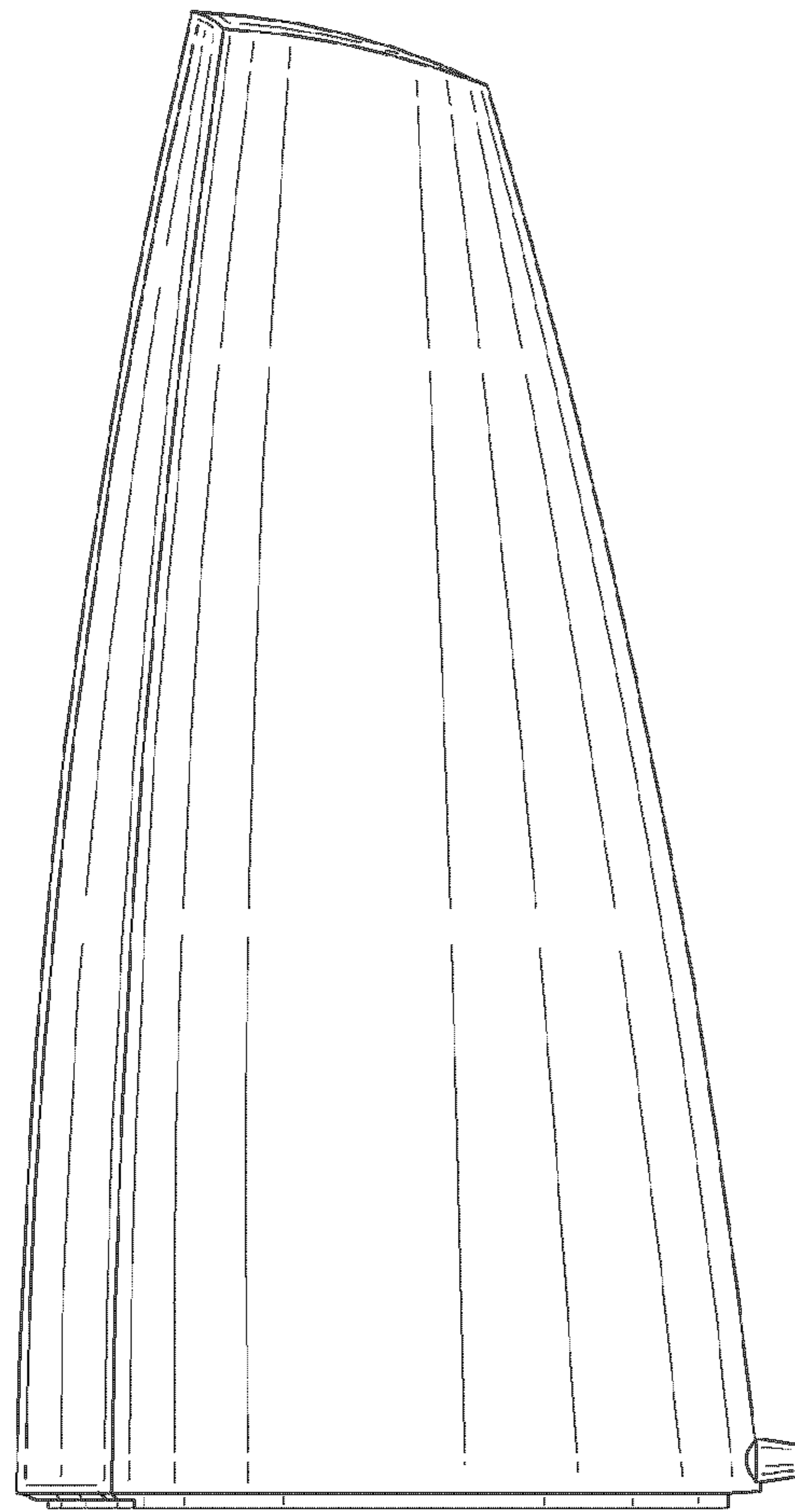

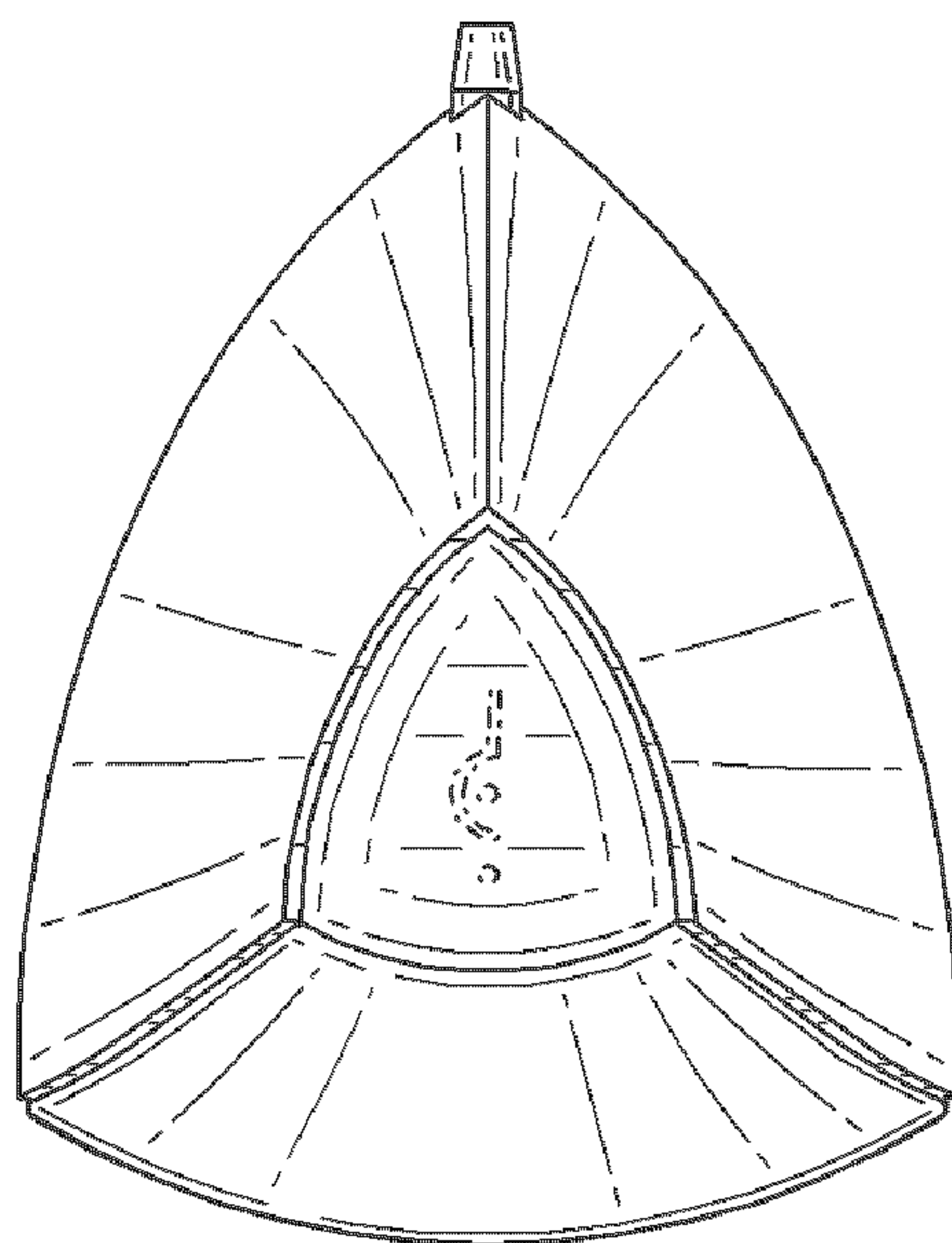

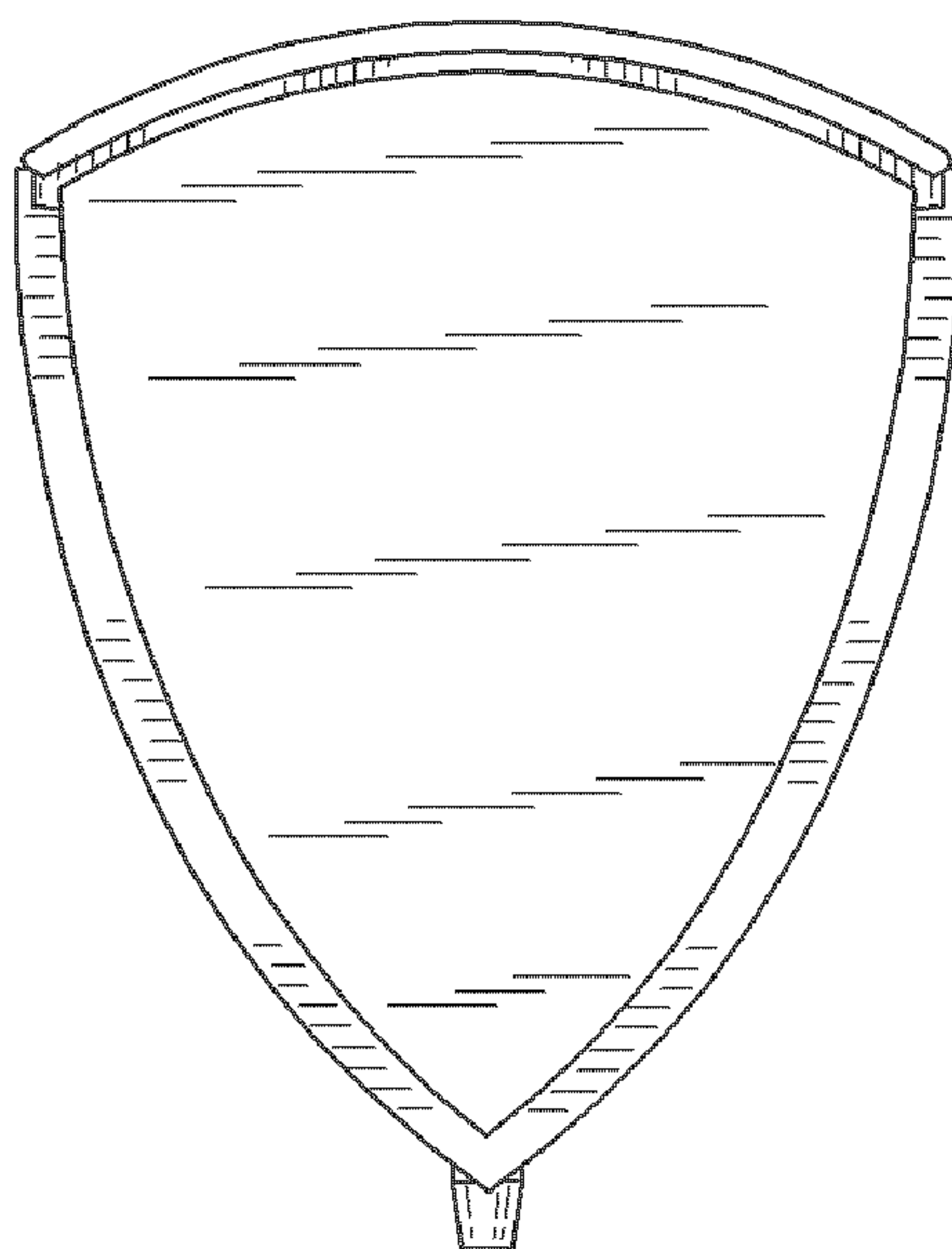
