DESCRIPTION

FIG. 1 is front-top-right perspective view of a base cradle for a communications headset showing our new design;

FIG. 3 is a back view thereof;

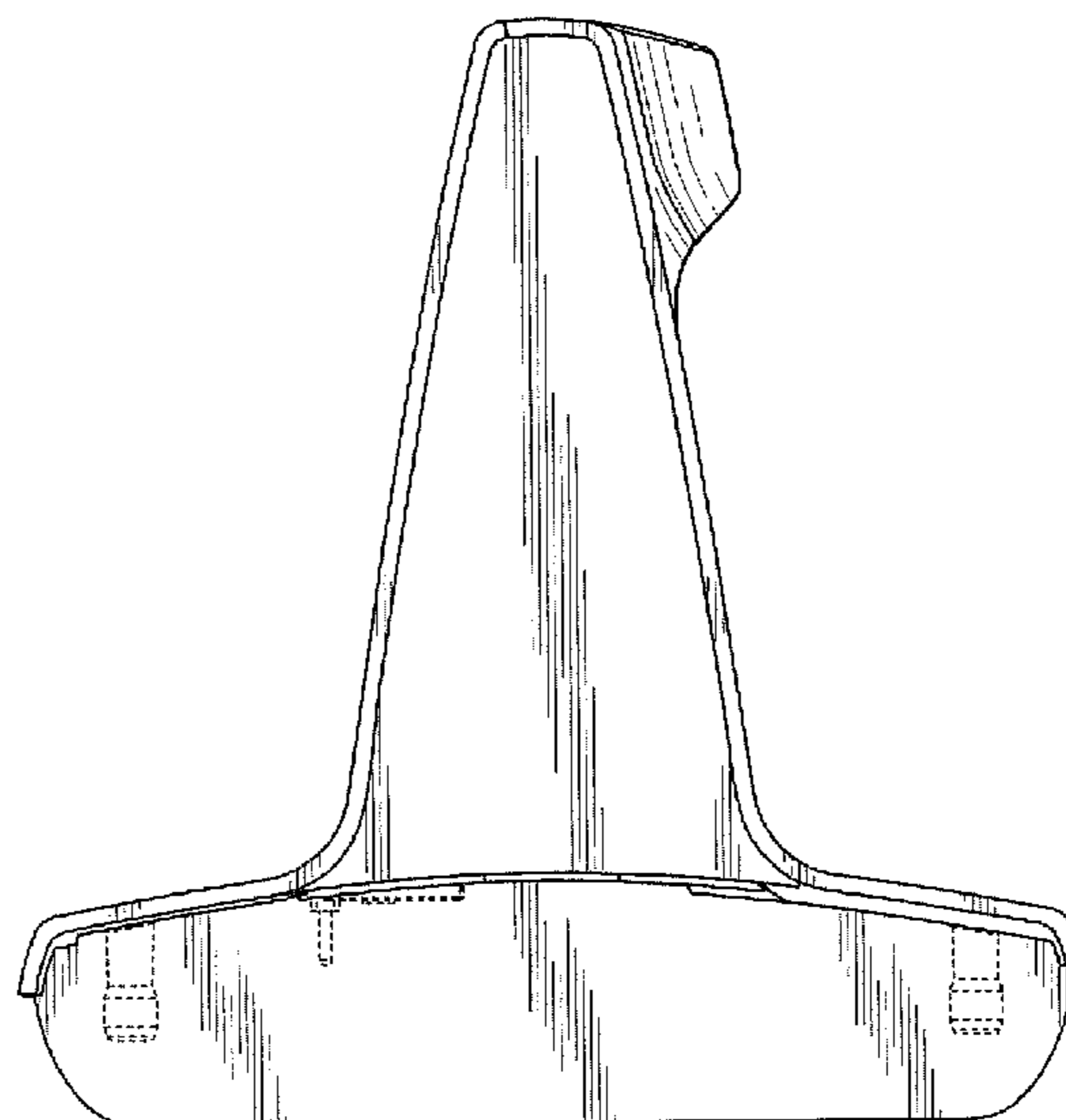
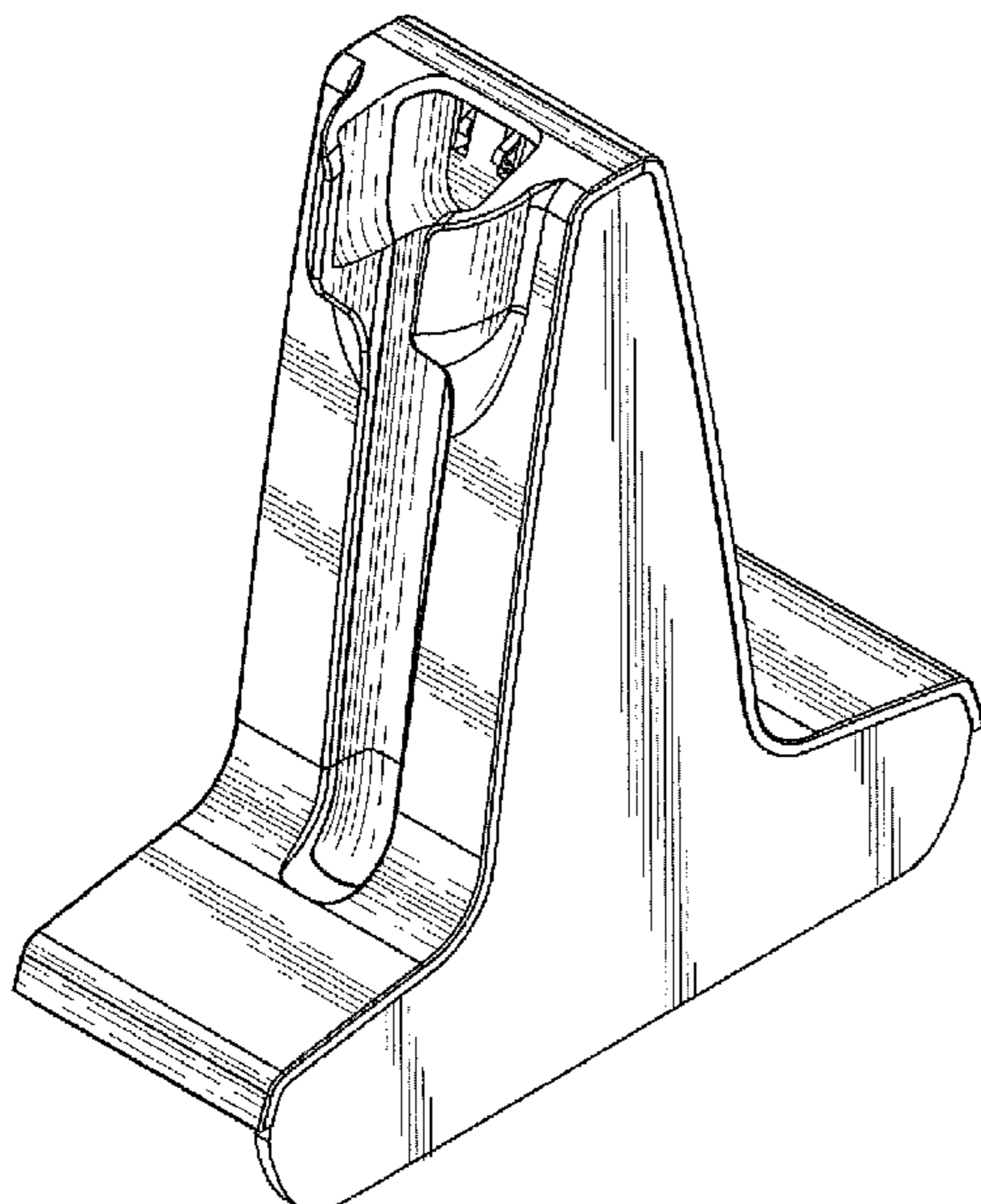
FIG. 4 is a left side view thereof;

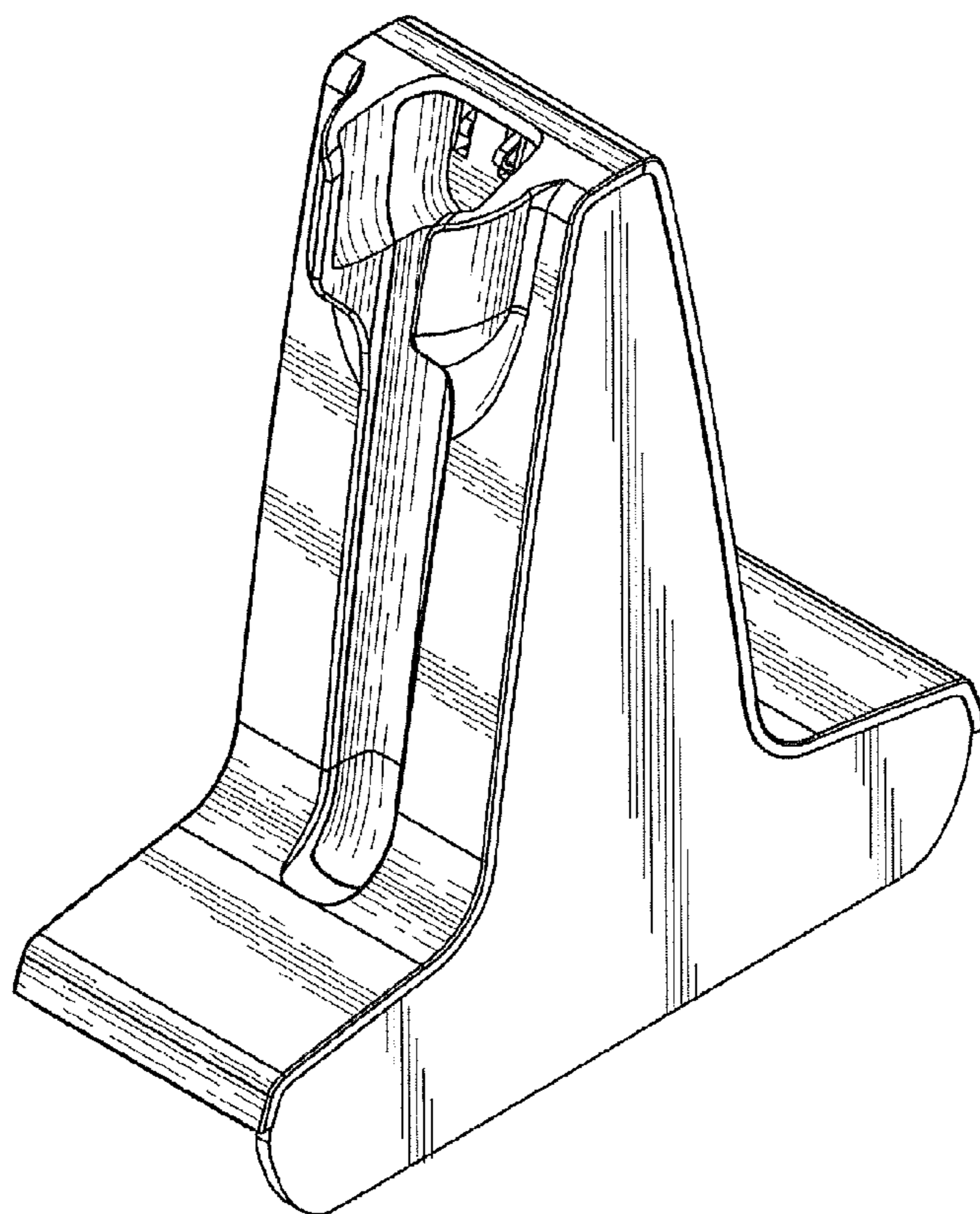

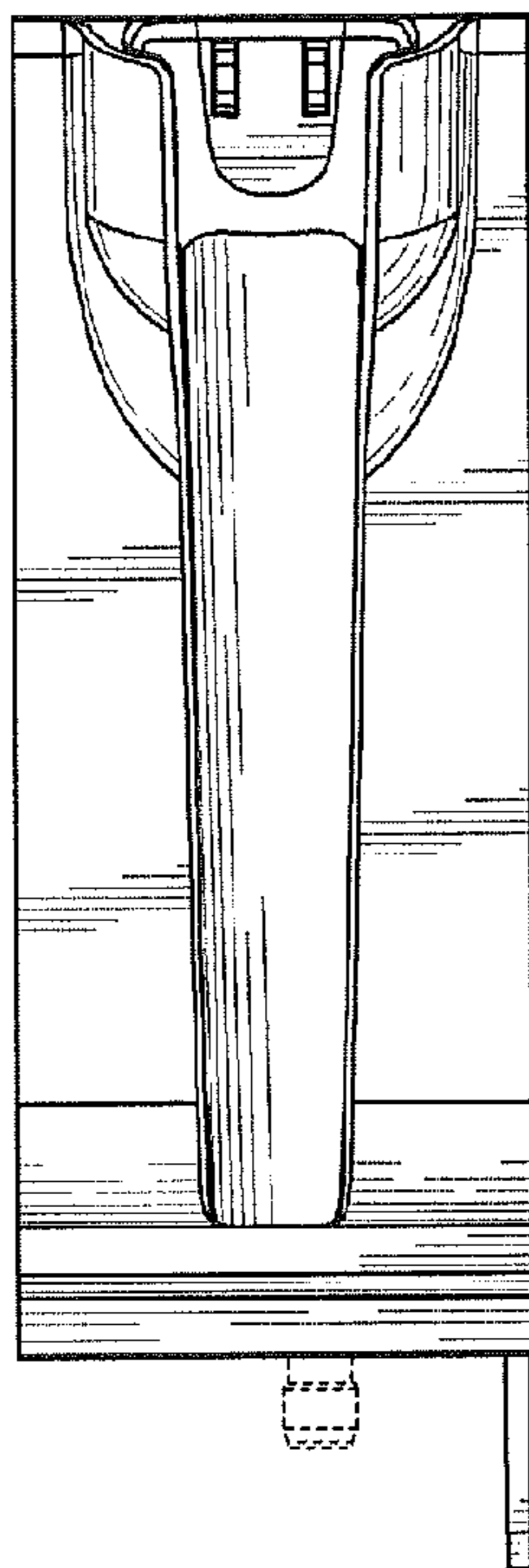

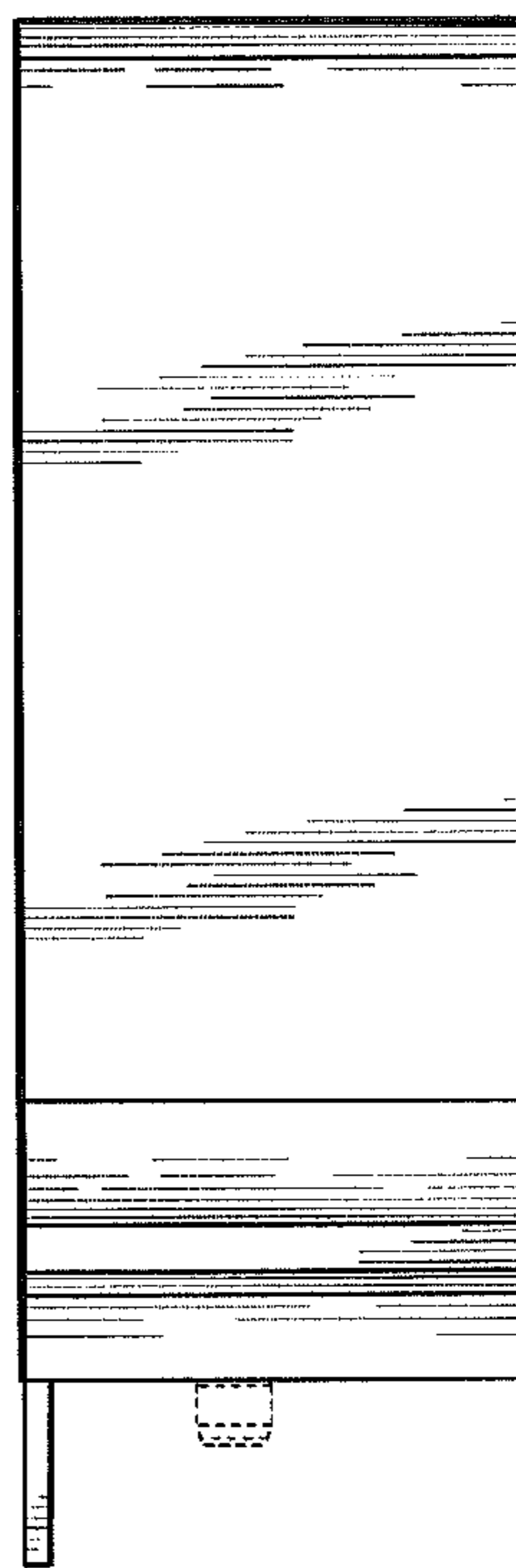

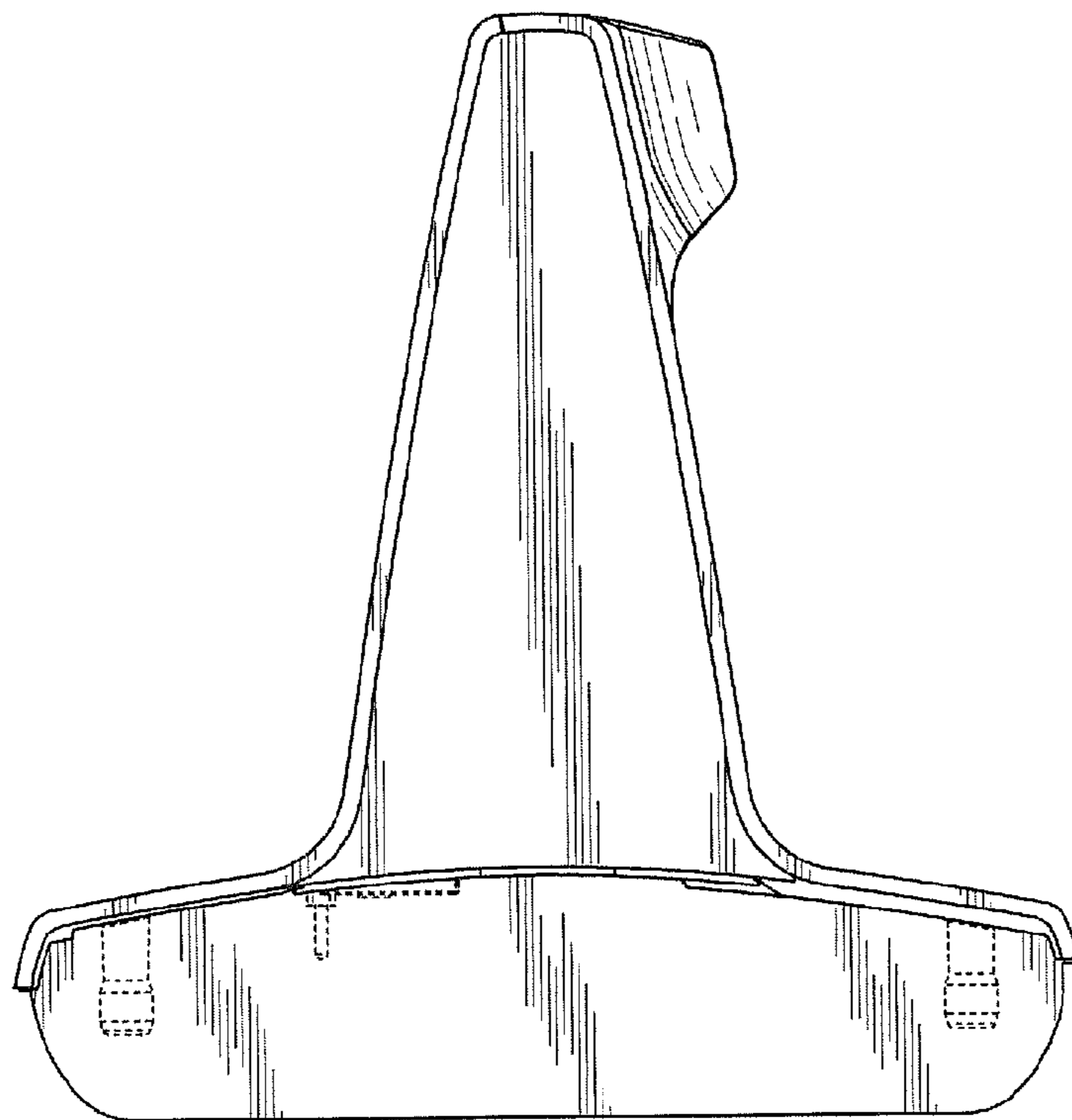

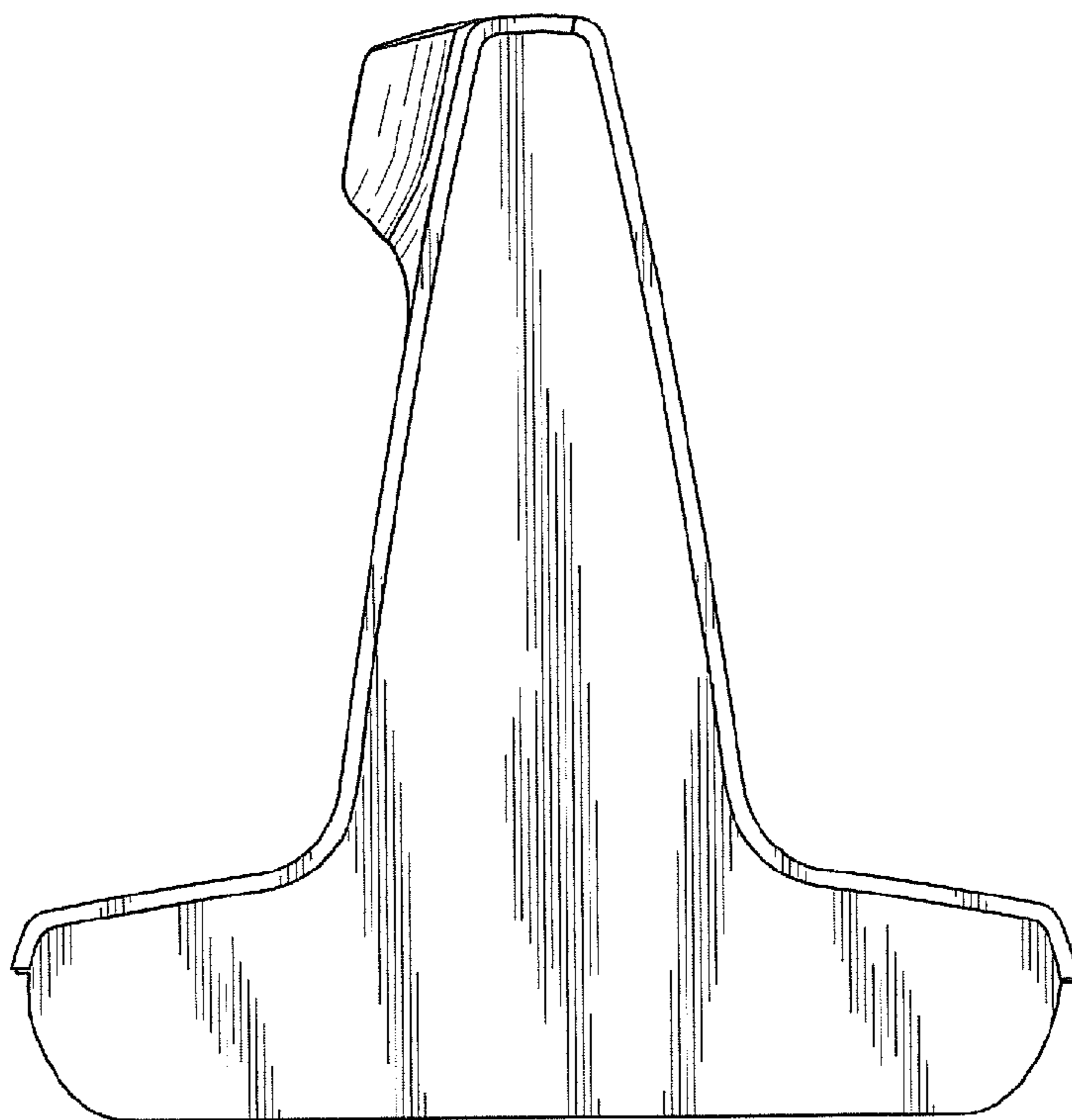

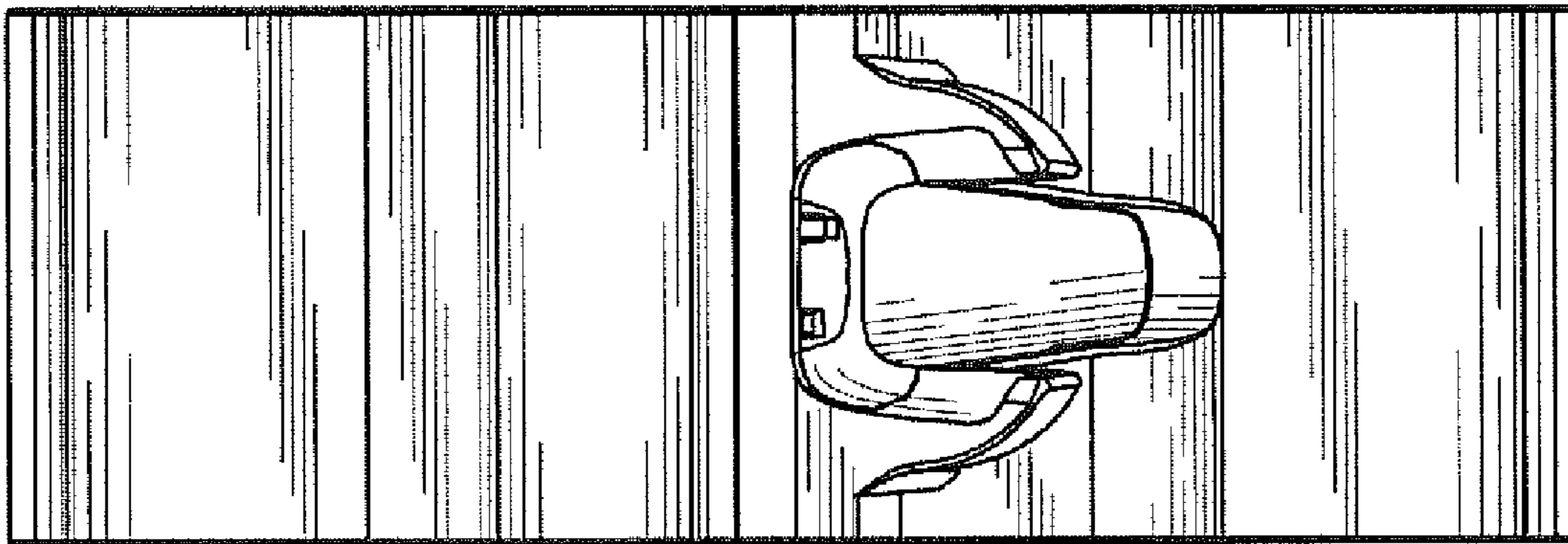
