(57) **CLAIM**

I claim the ornamental design for a blue tooth device for cellular phone, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a blue tooth device for cellular phone showing the new design:

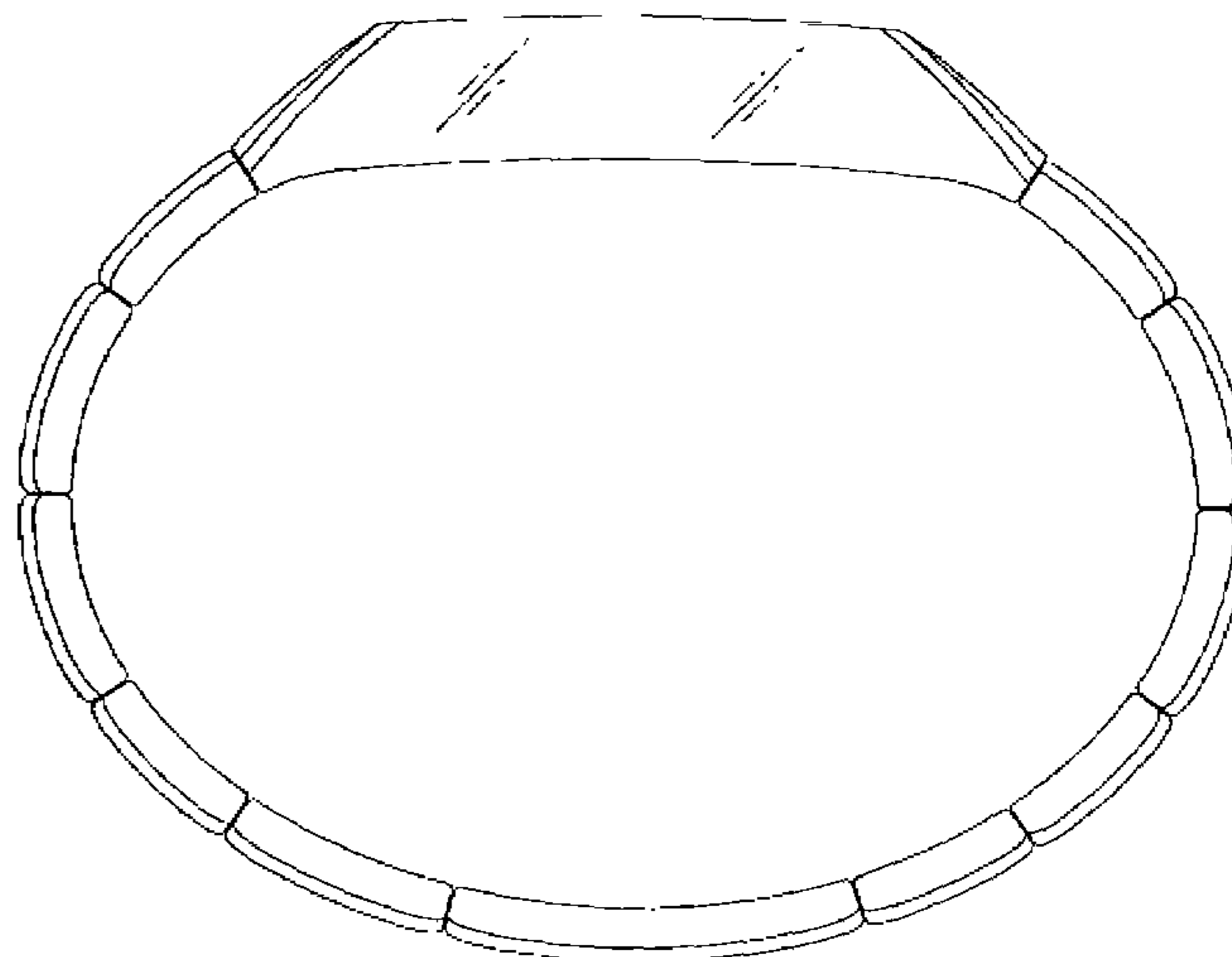
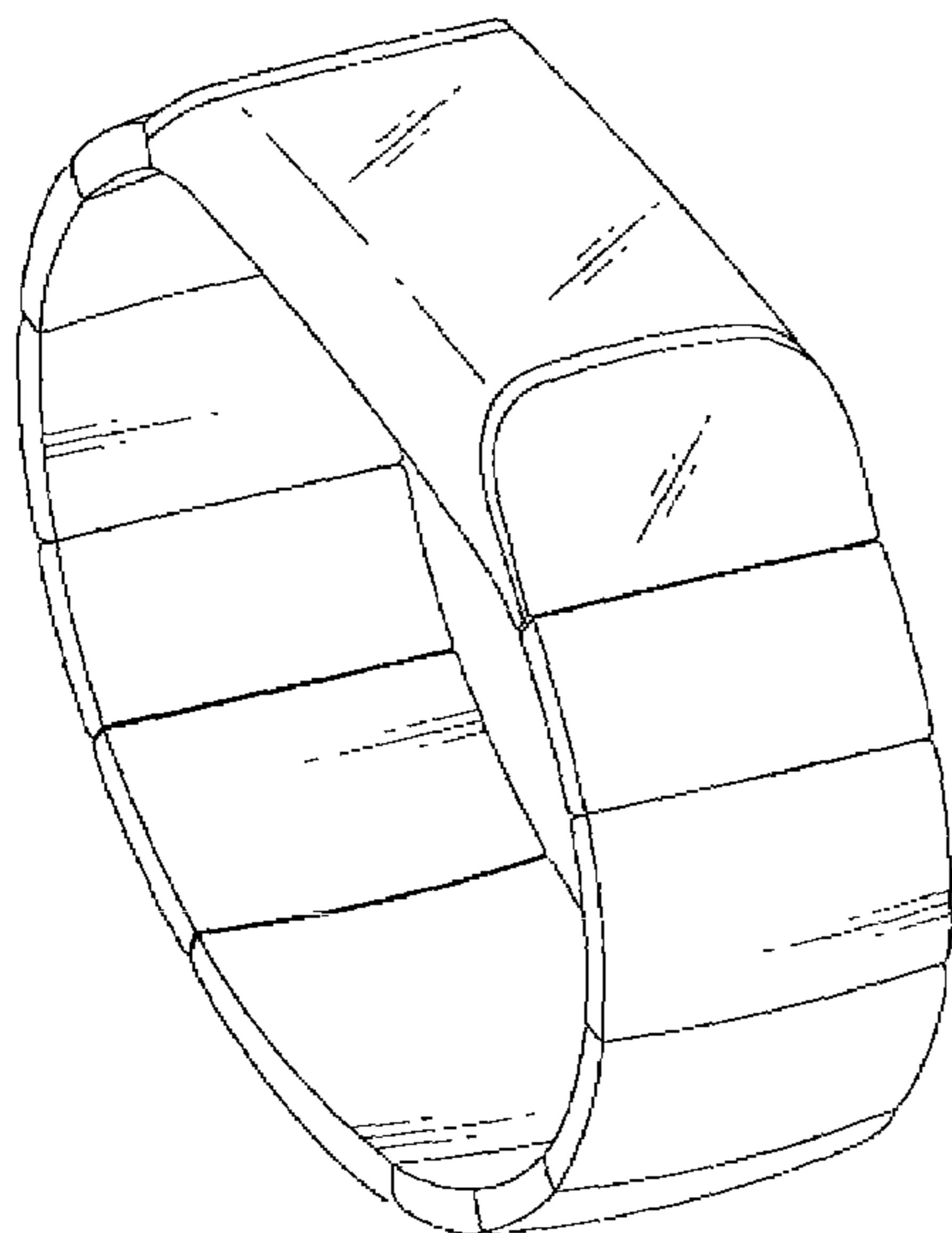

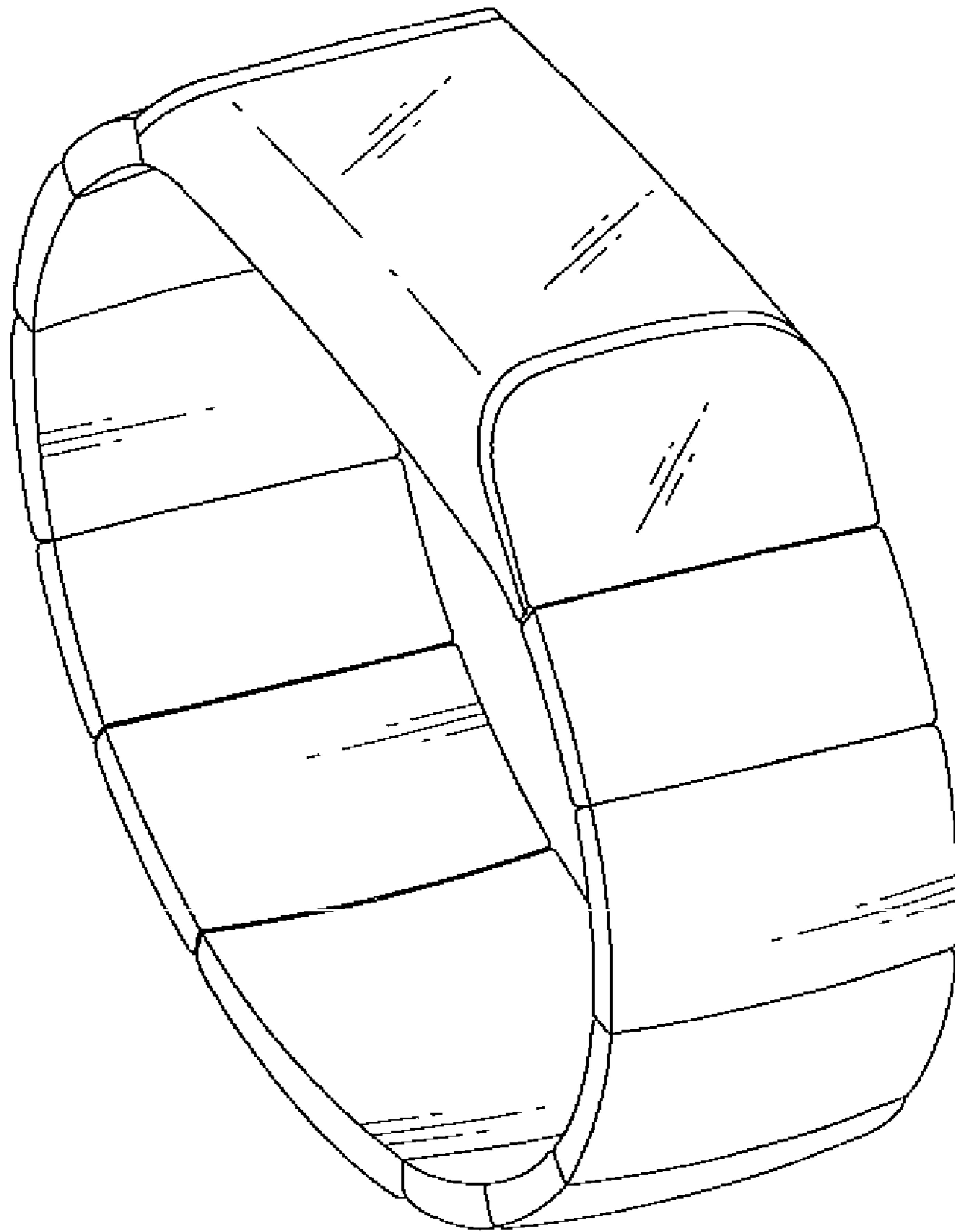

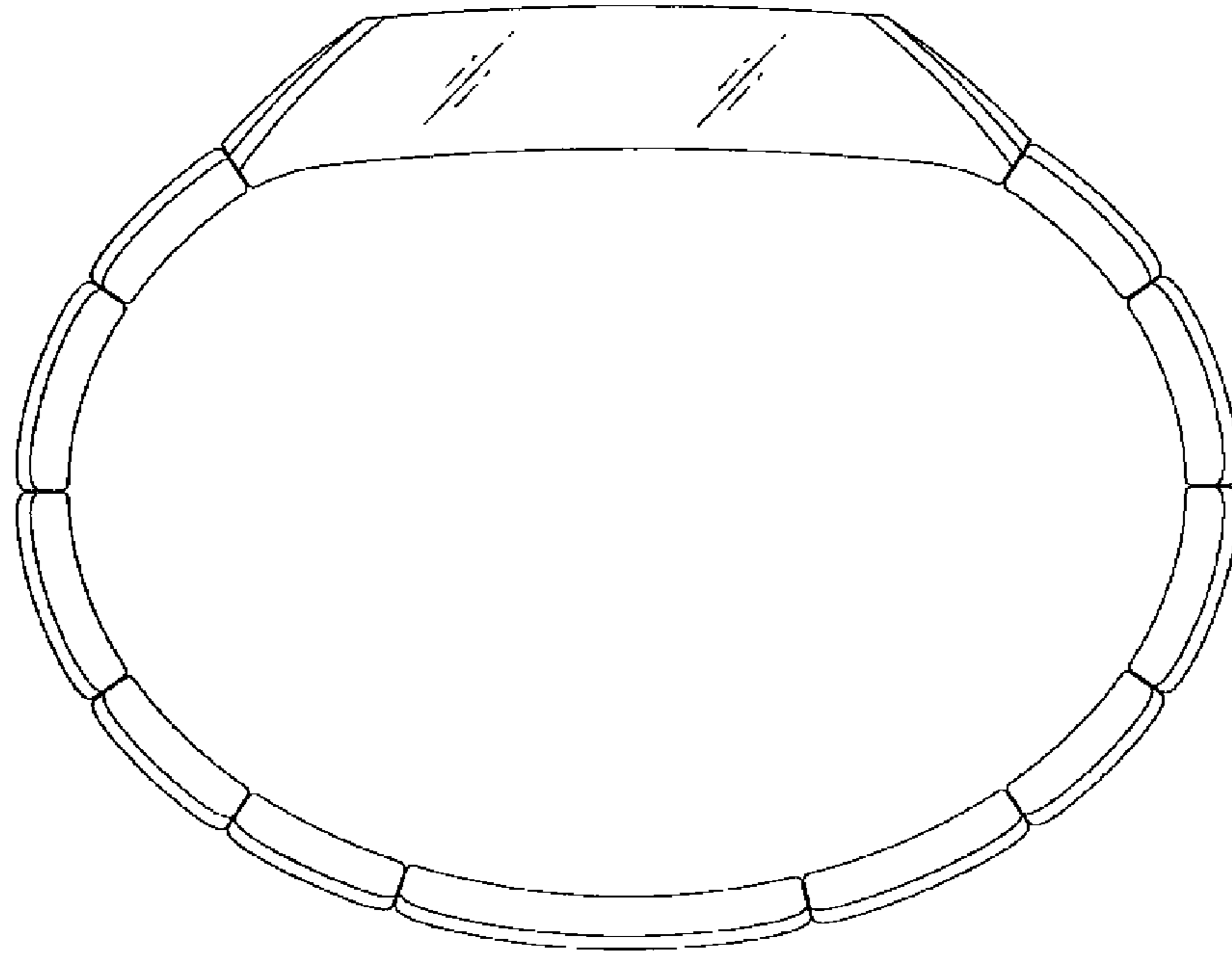

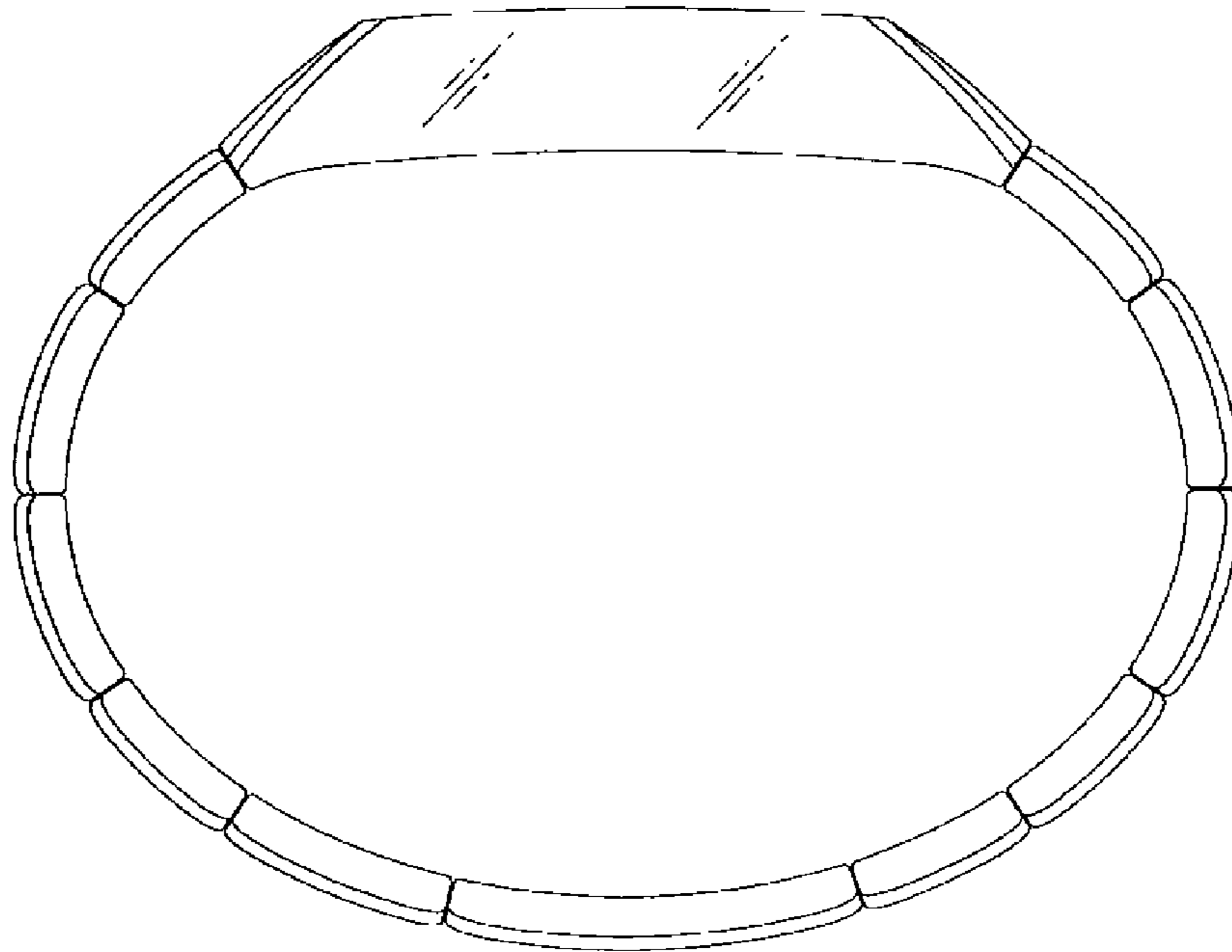

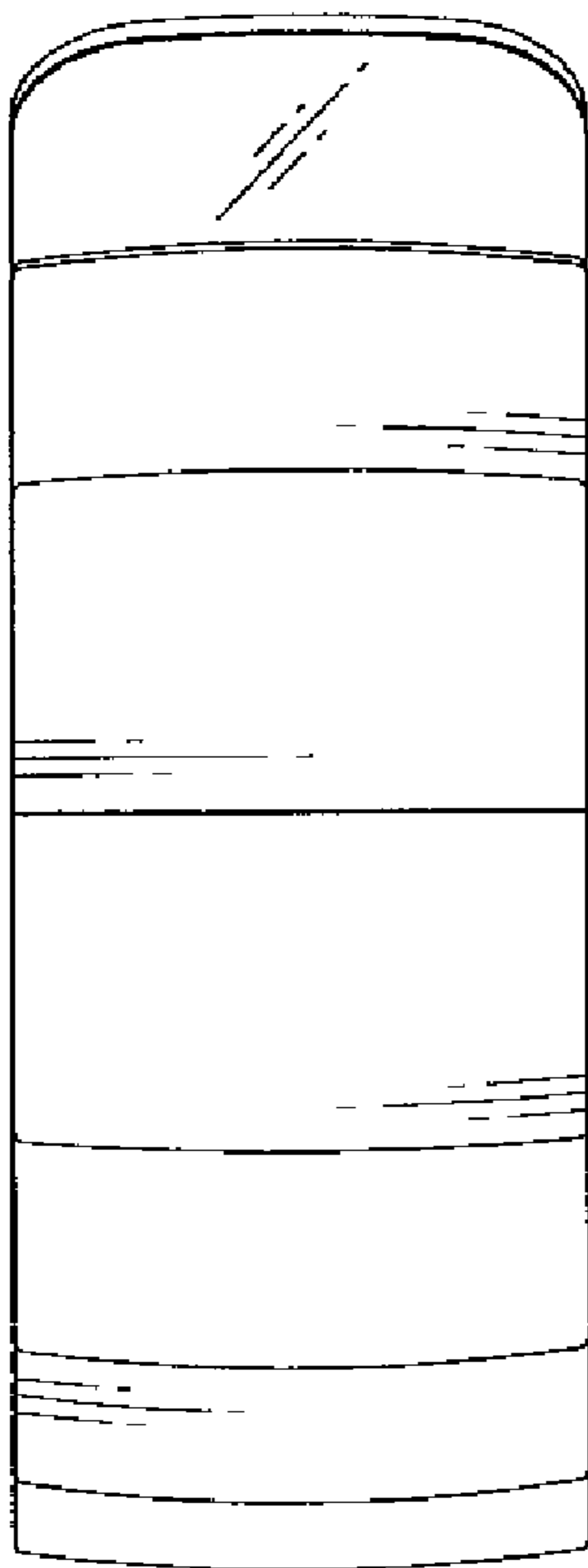

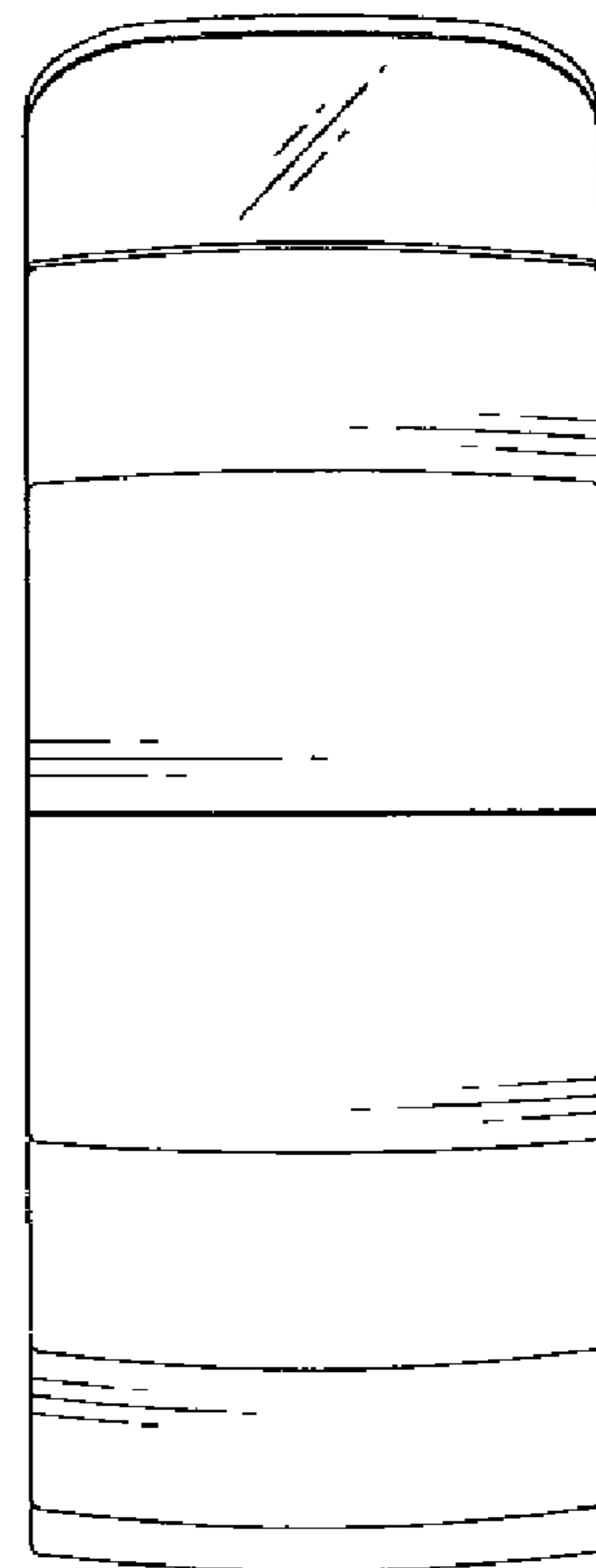

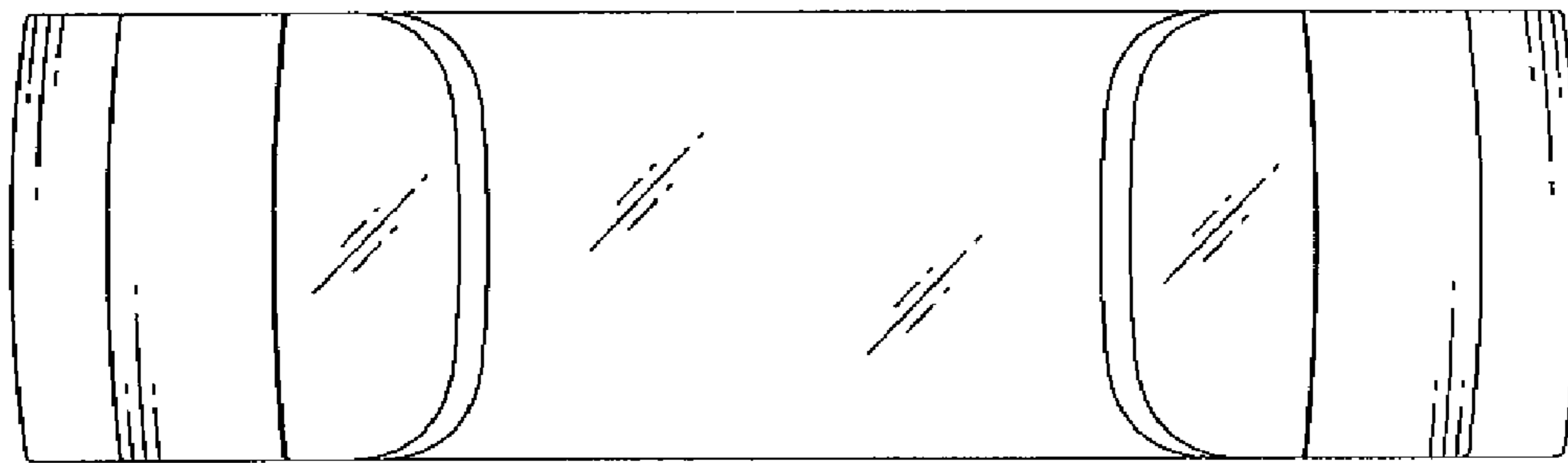
