FIG. 3 is a bottom view of the contoured guitar of FIG. 1.

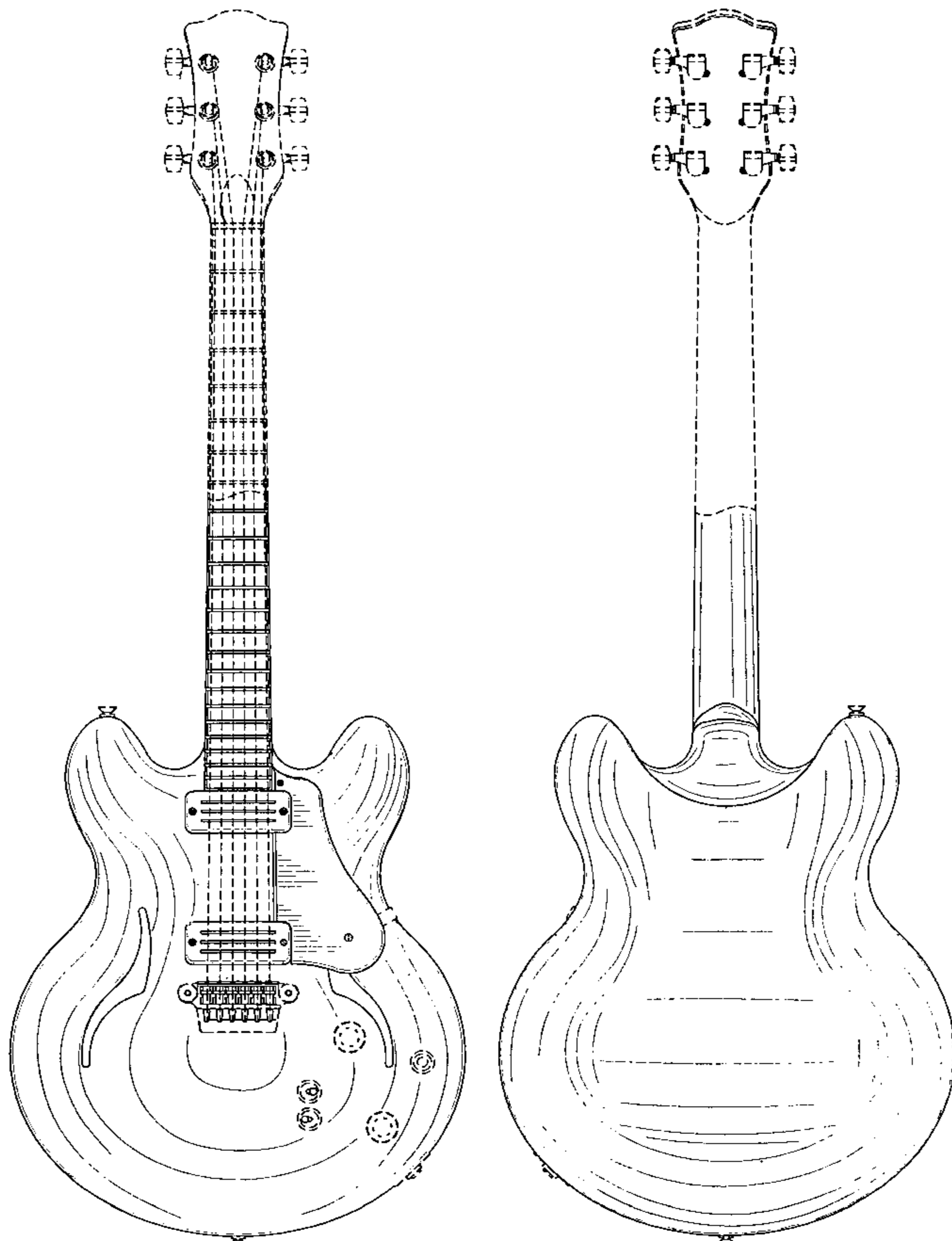
FIG. 4 is a top view of the contoured guitar of FIG. 1.

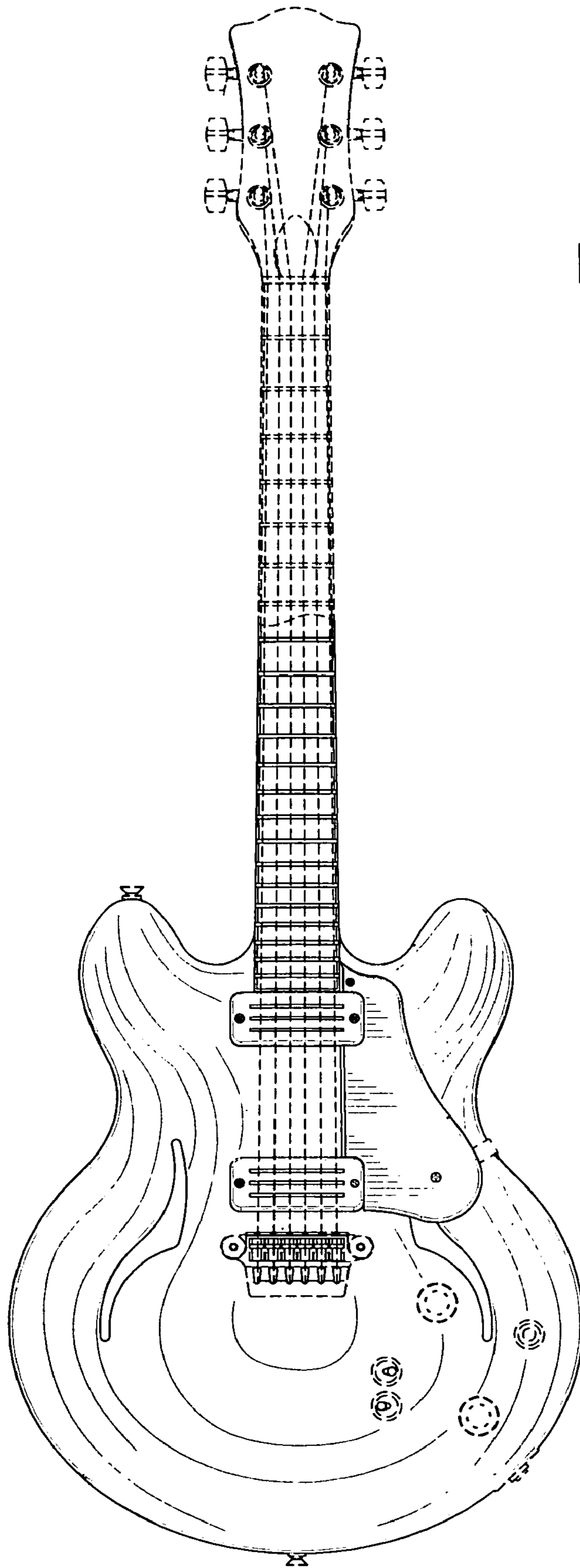

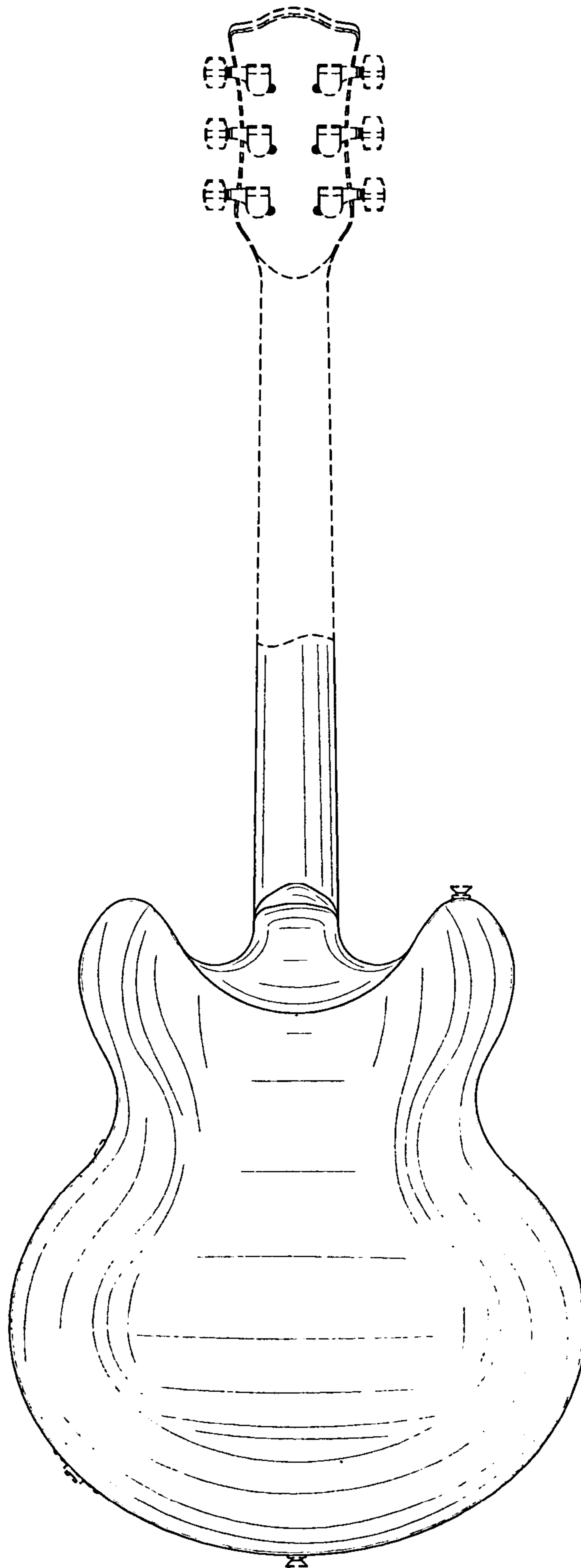

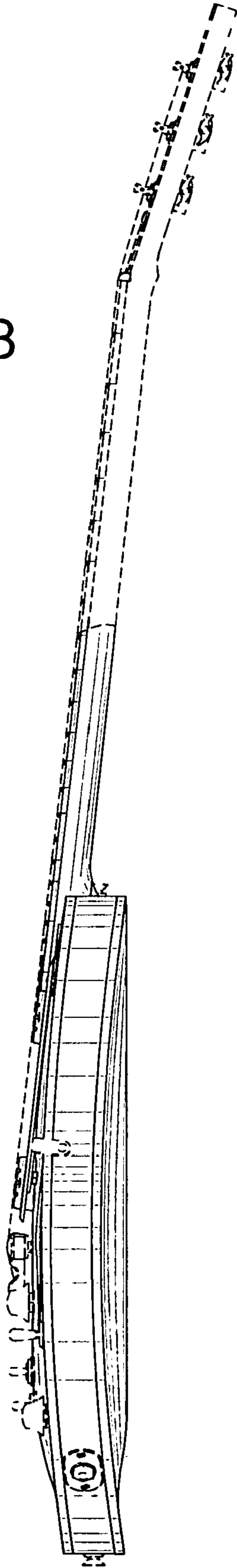
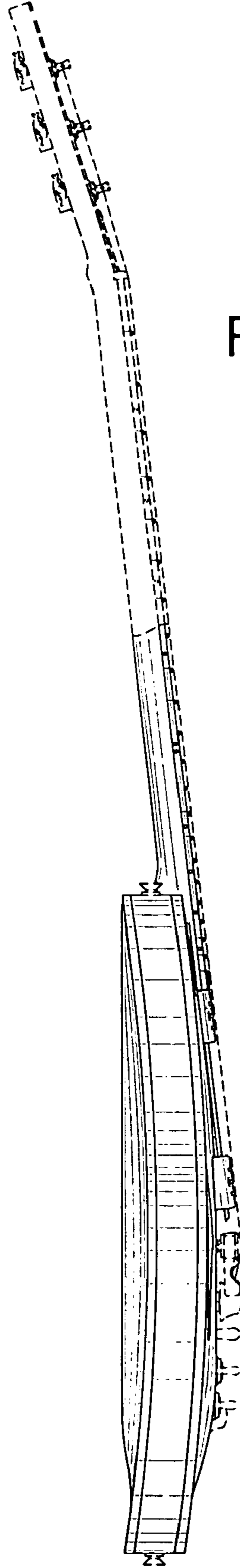

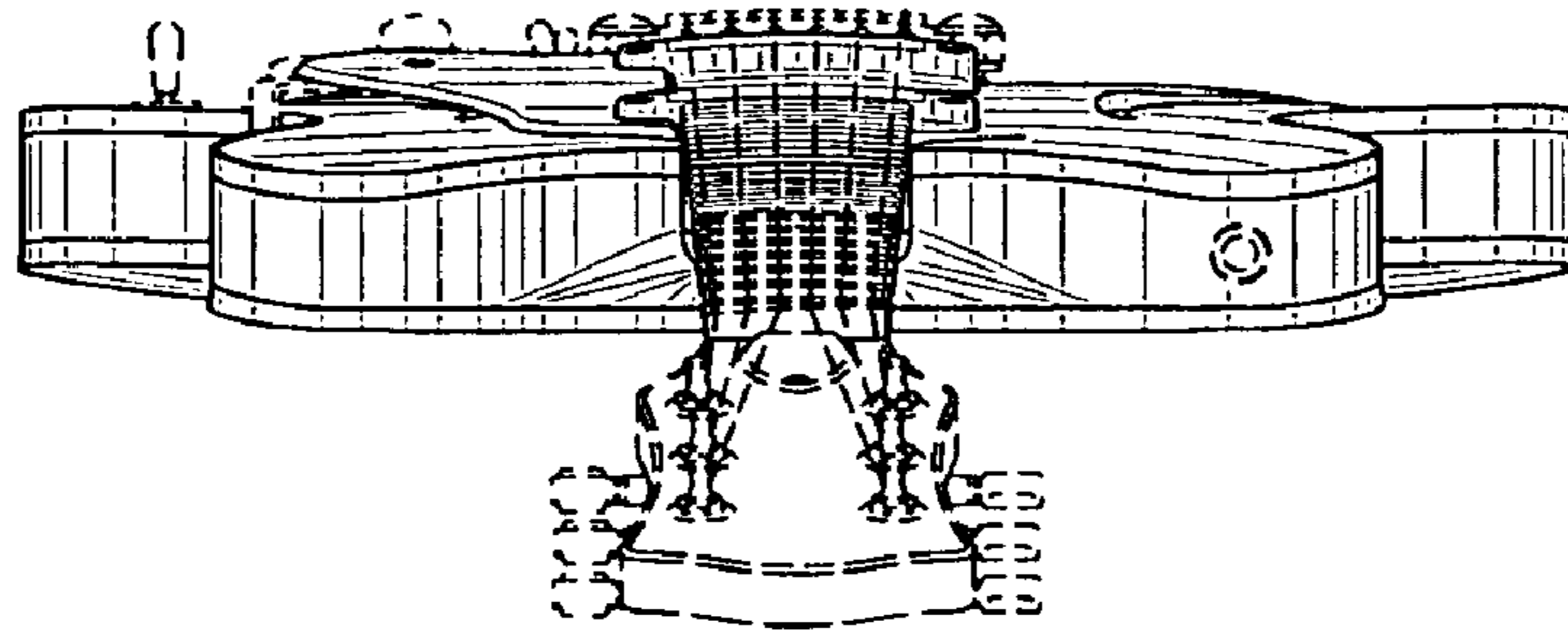

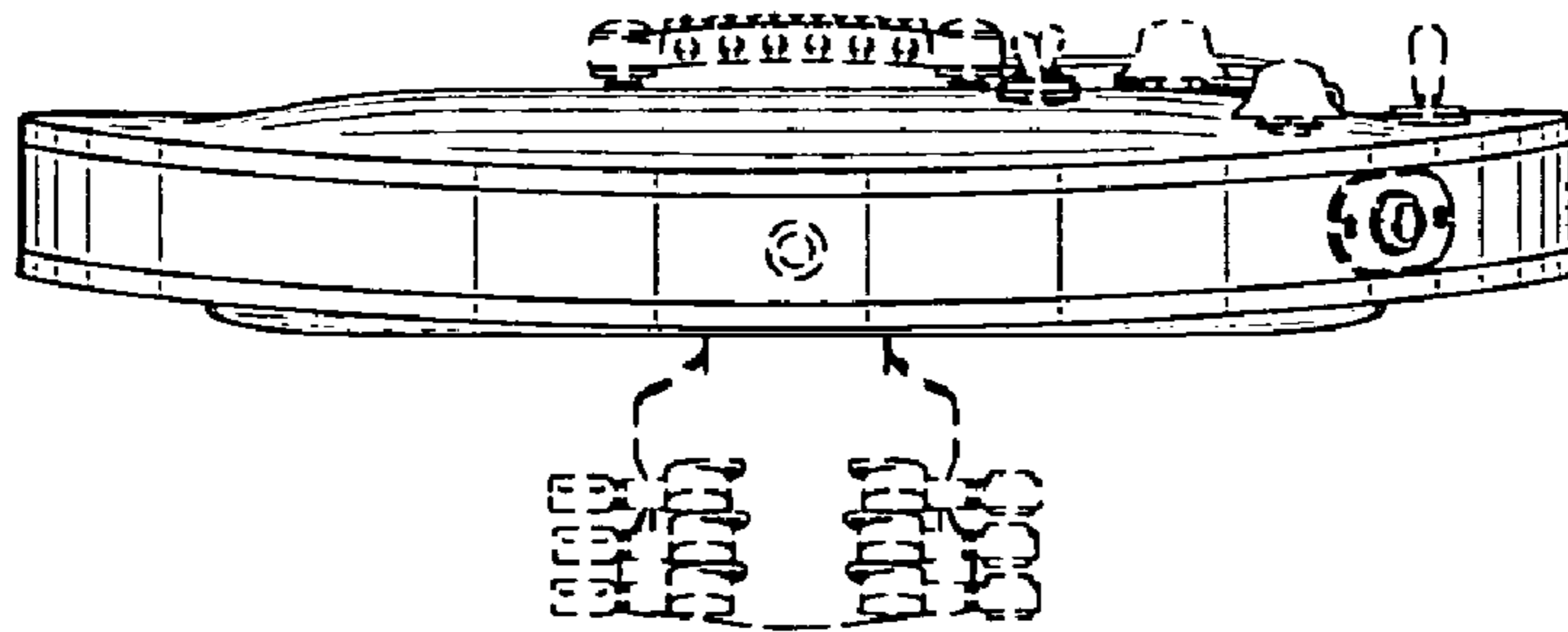
