The ornamental design for toolbox for developmental curriculum, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a toolbox for developmental curriculum showing my new design;

FIG. 2 is a top plan thereof;

FIG. 4 is a right side elevation thereof with the left side elevation being a mirror image;

FIG. 3 is a rear elevation thereof;

FIG. 5 is a front elevation thereof;

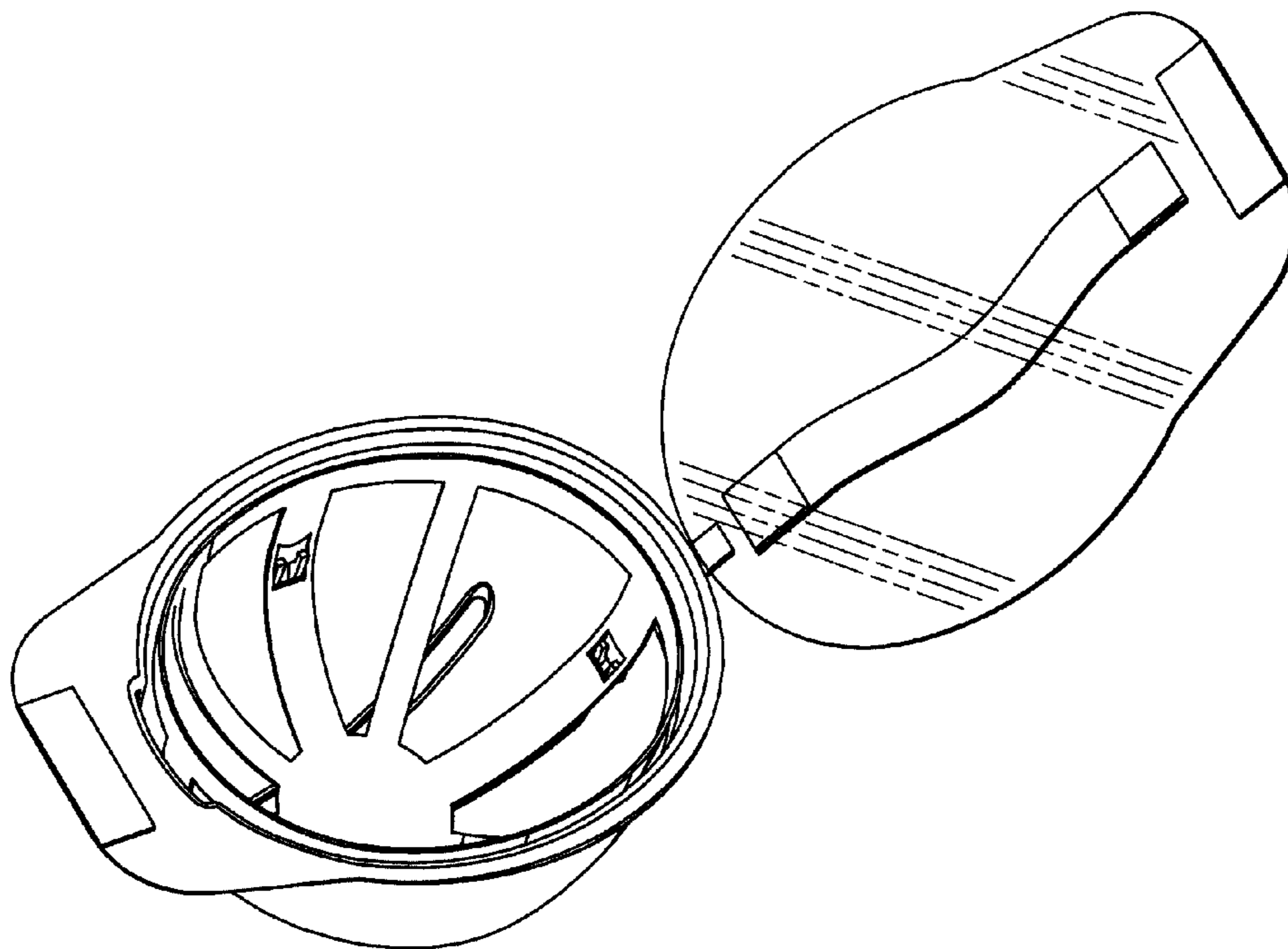
FIG. 6 is a bottom plan view thereof;

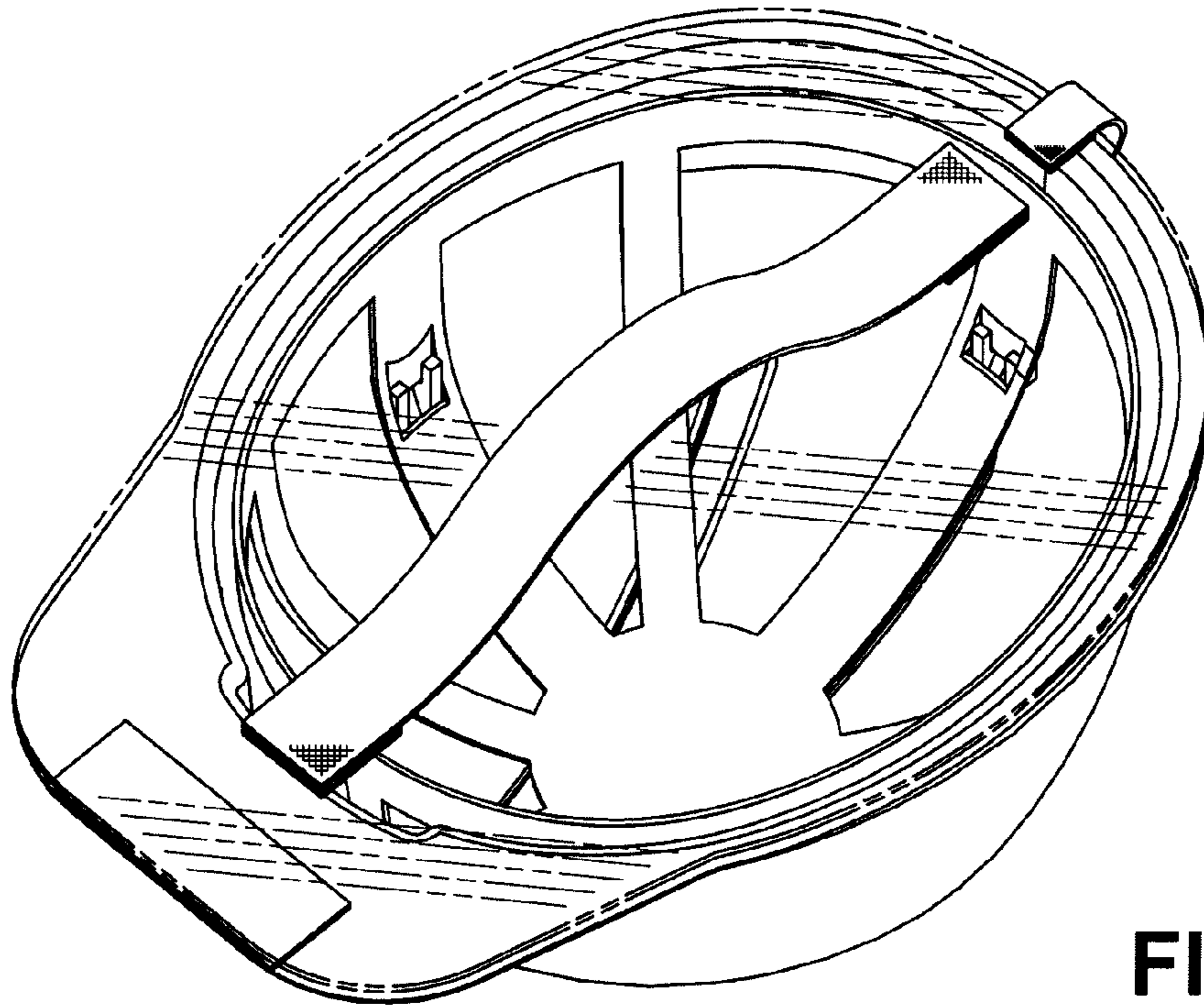

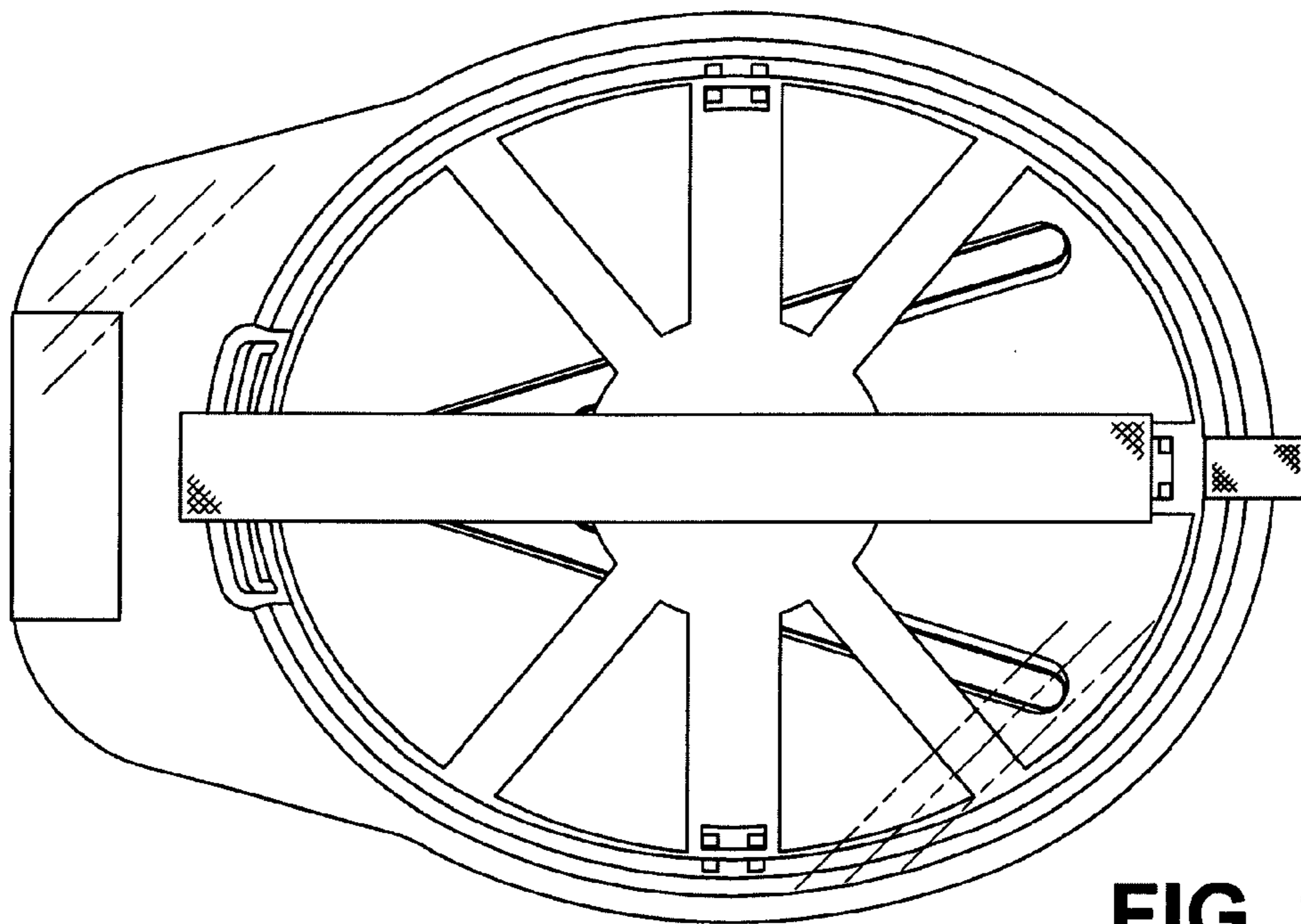

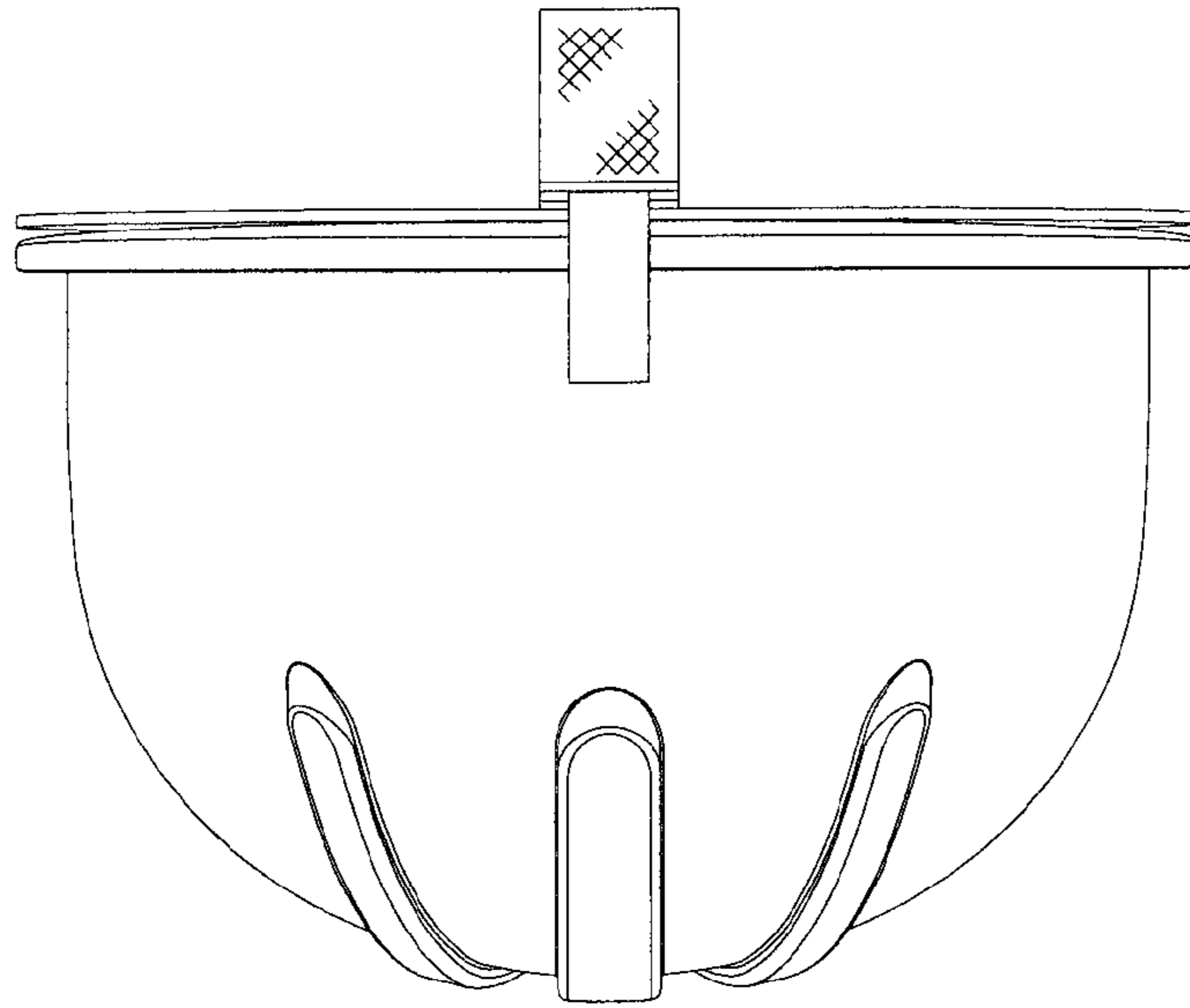

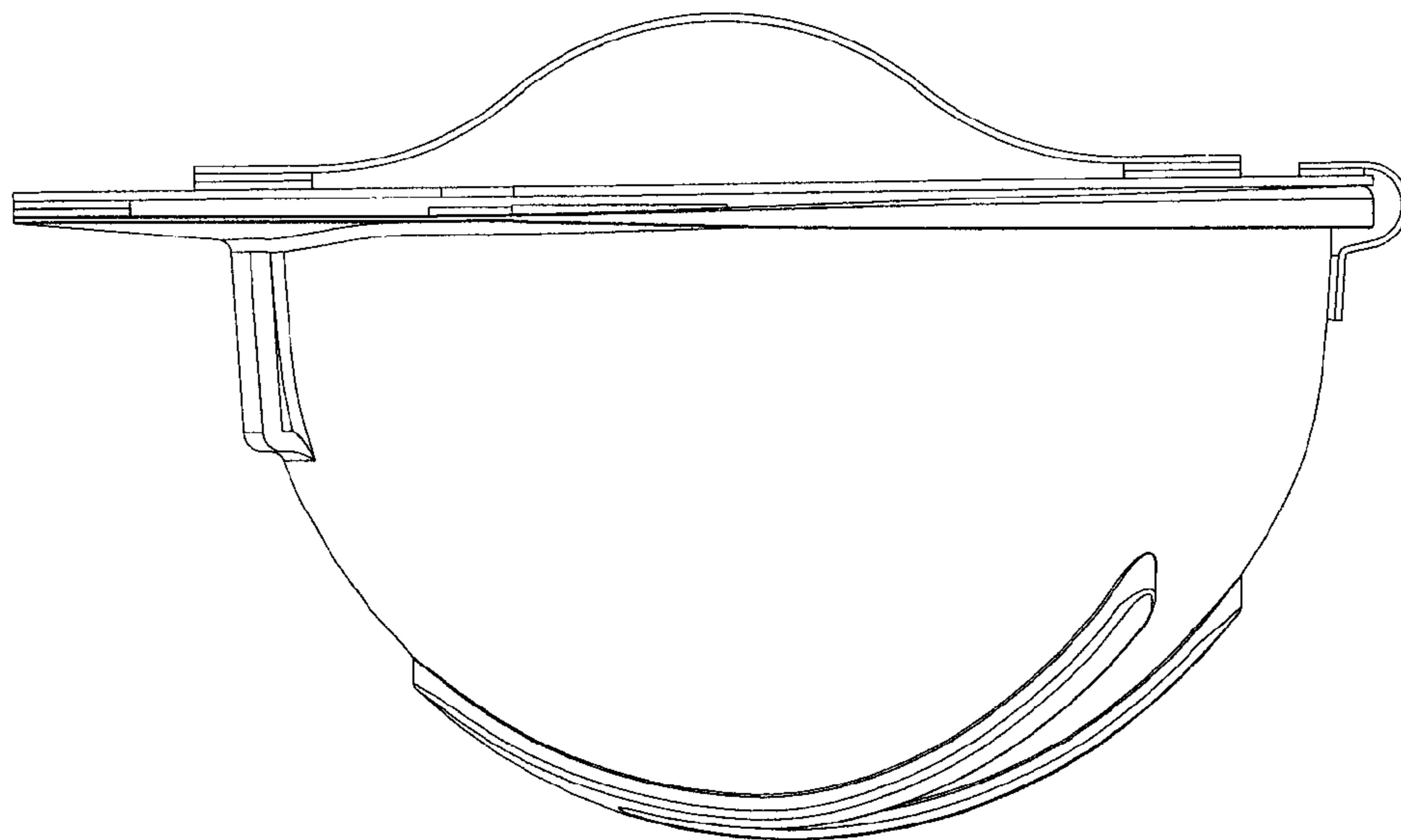

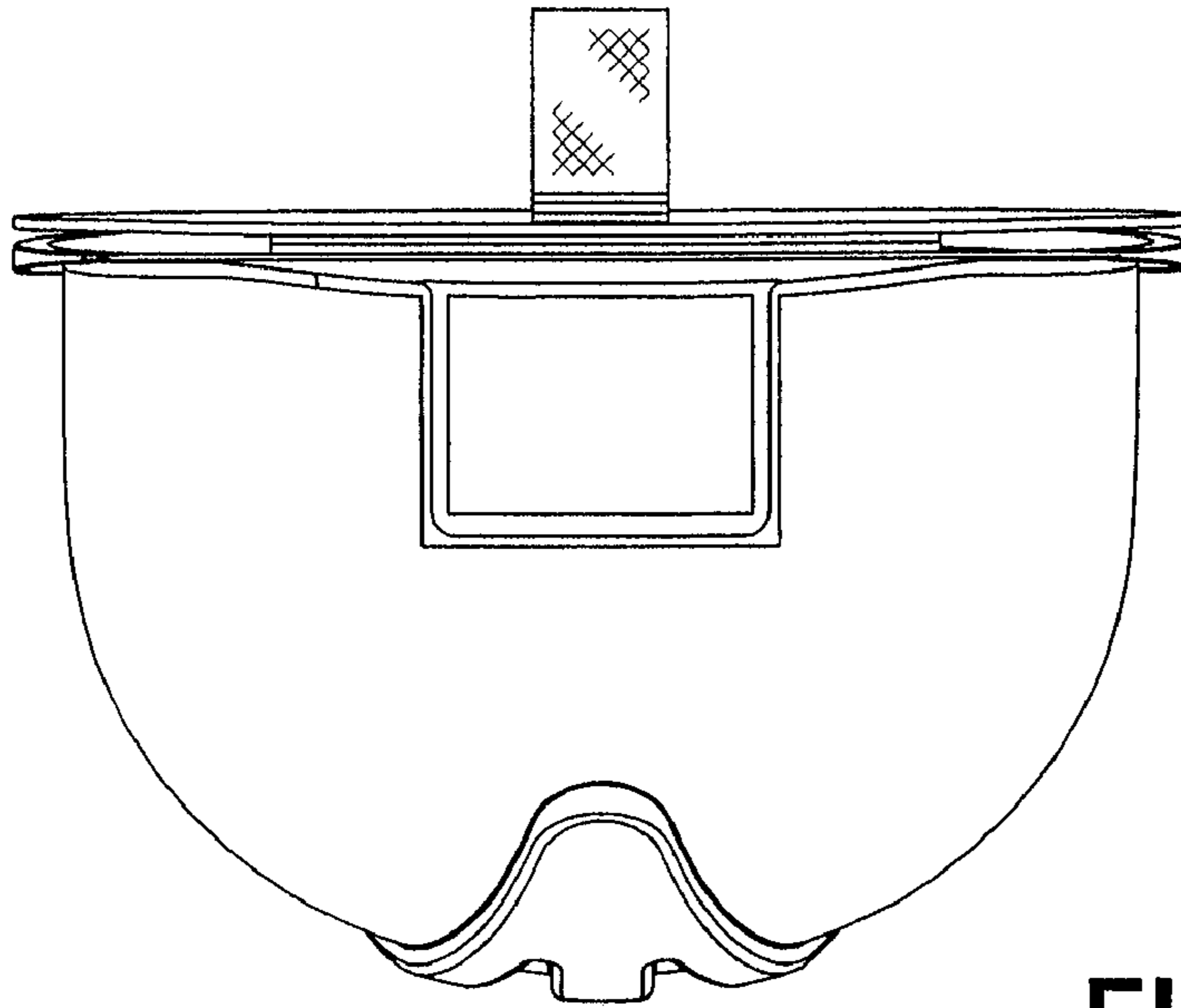

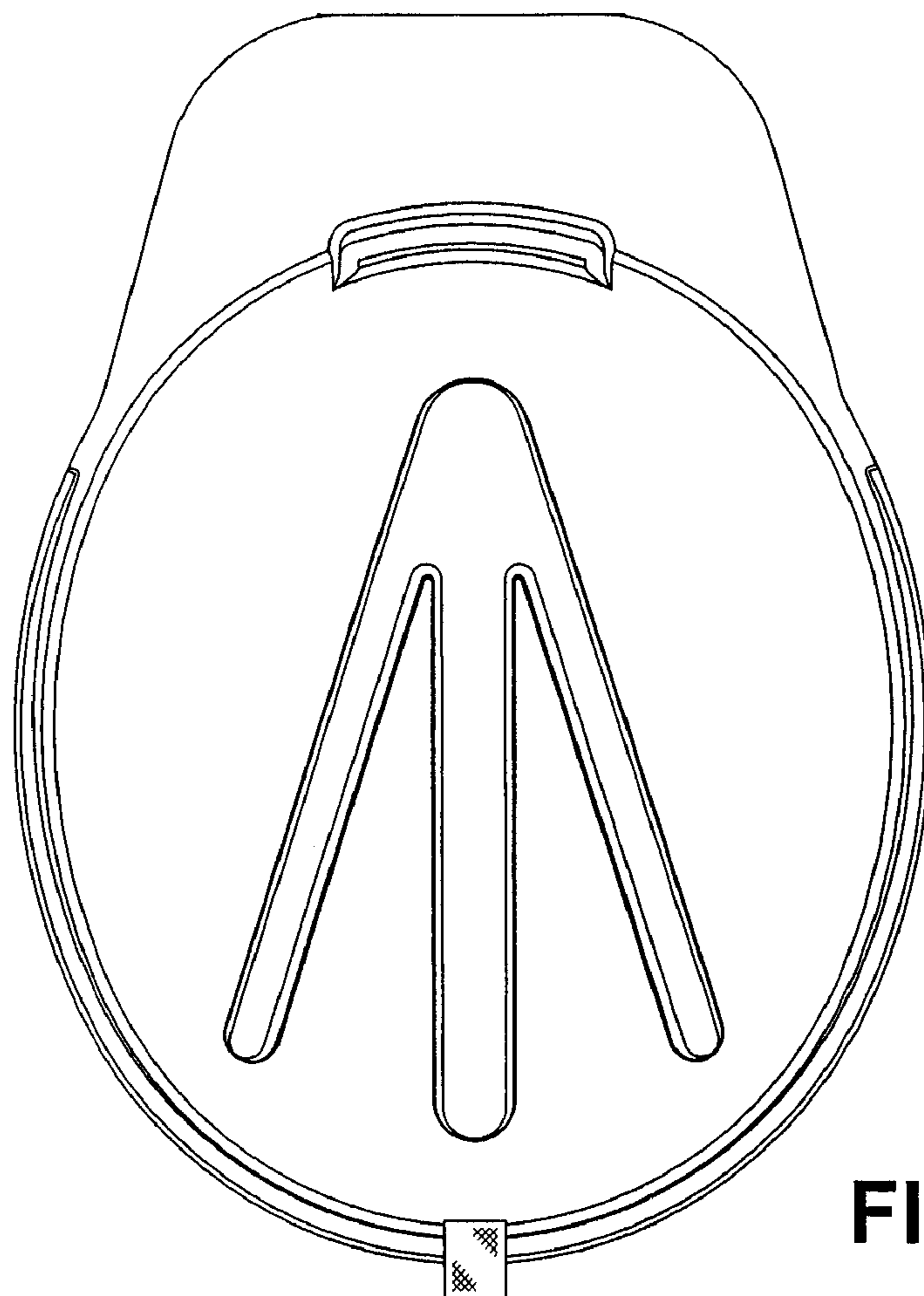

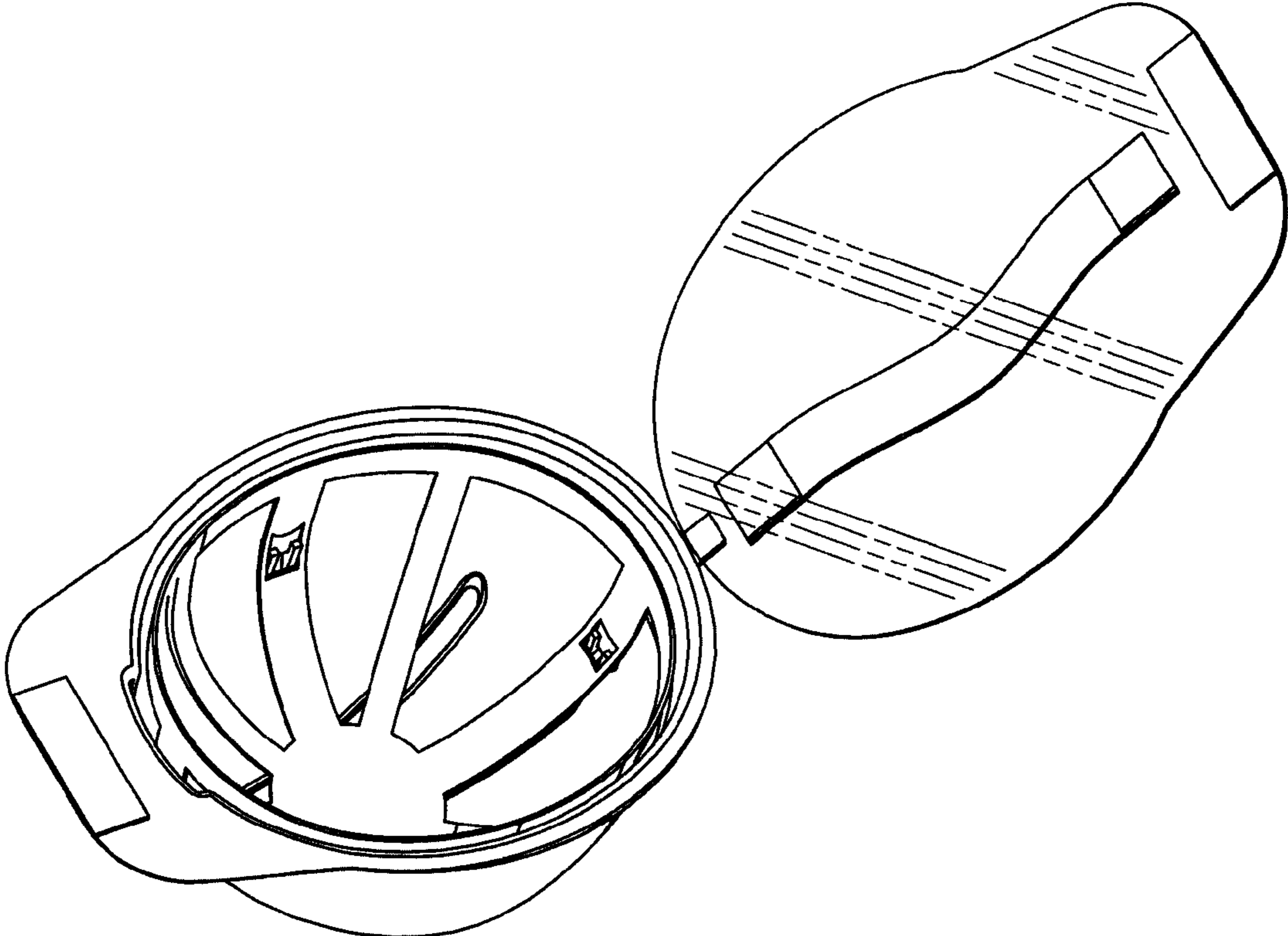

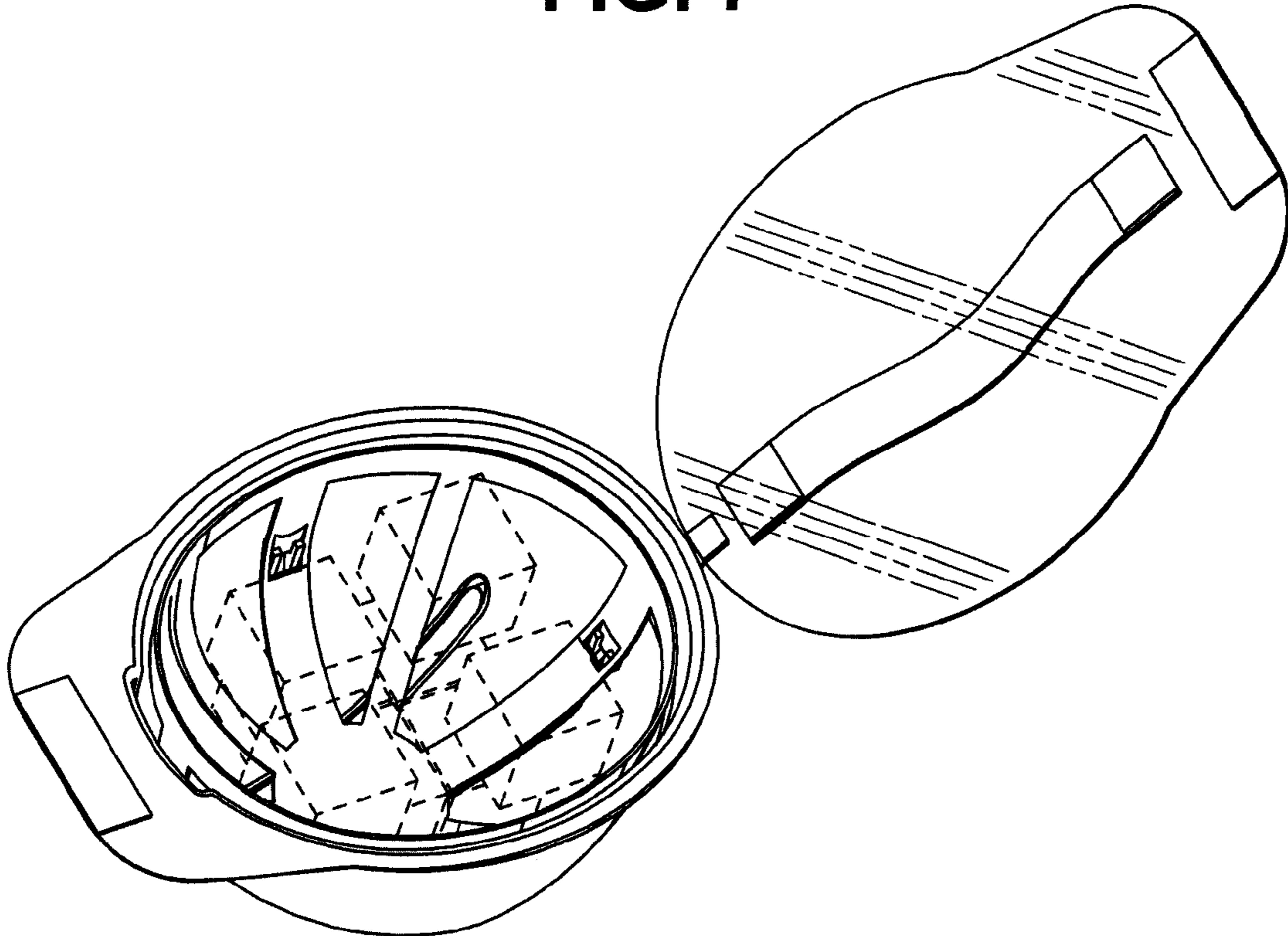
