FIG. 3 is a right side view of the food product of FIG. 1;

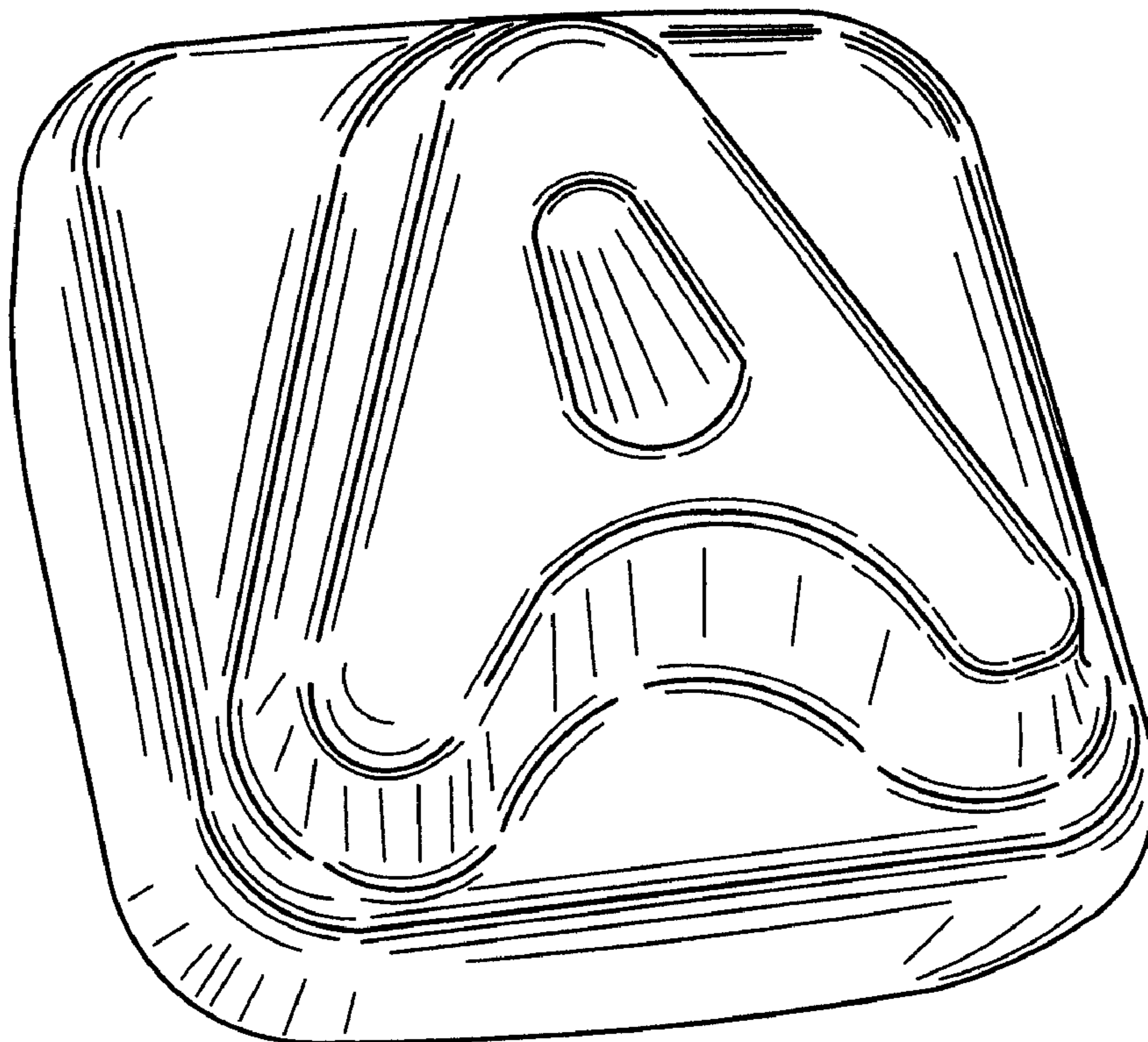
FIG. 4 is a top plan view of the food product of FIG. 1;

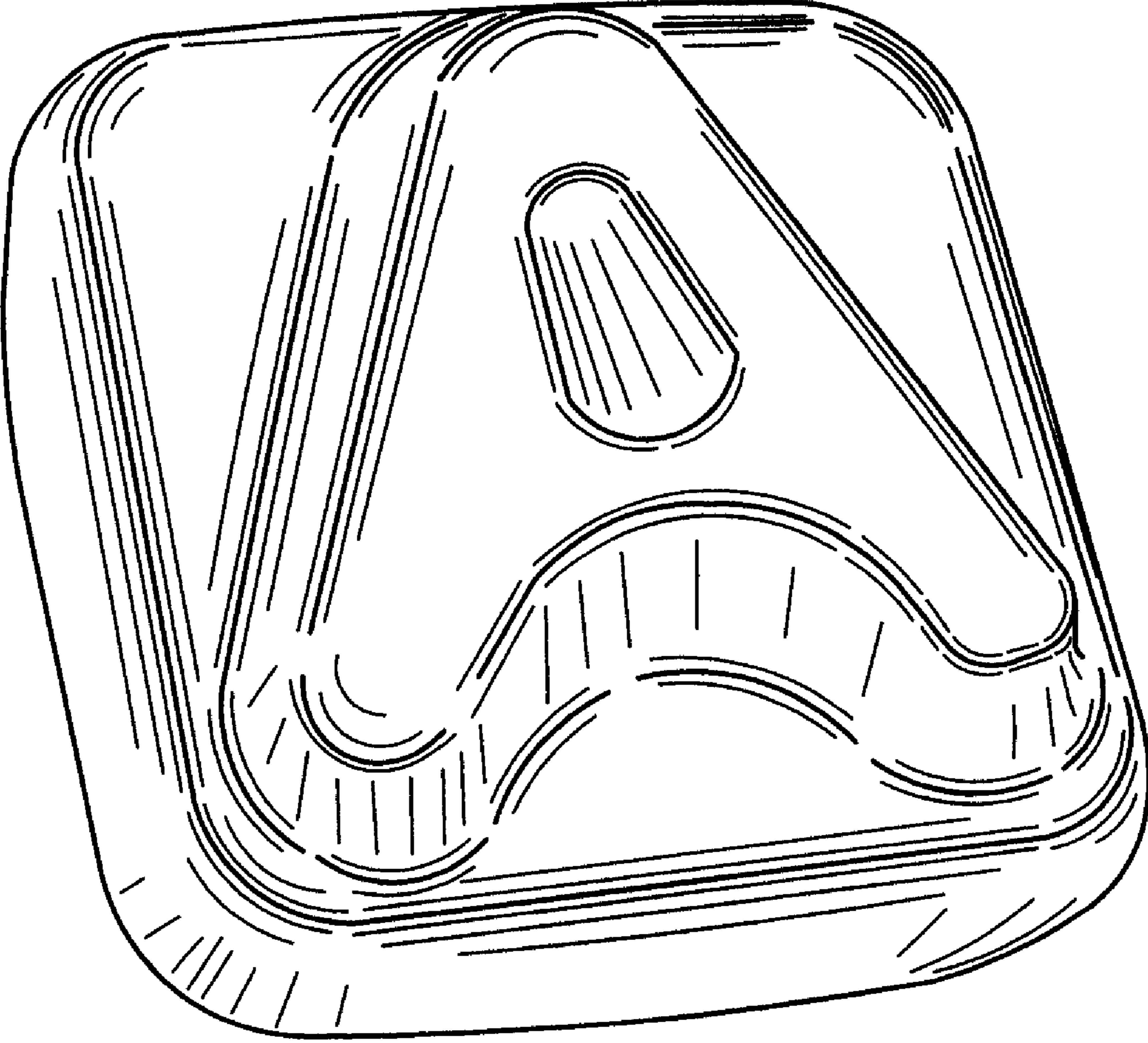
FIG. 5 is a bottom plan view of the food product of FIG. 1;

FIG. 6 is a top end view of the food product of FIG. 1; and,

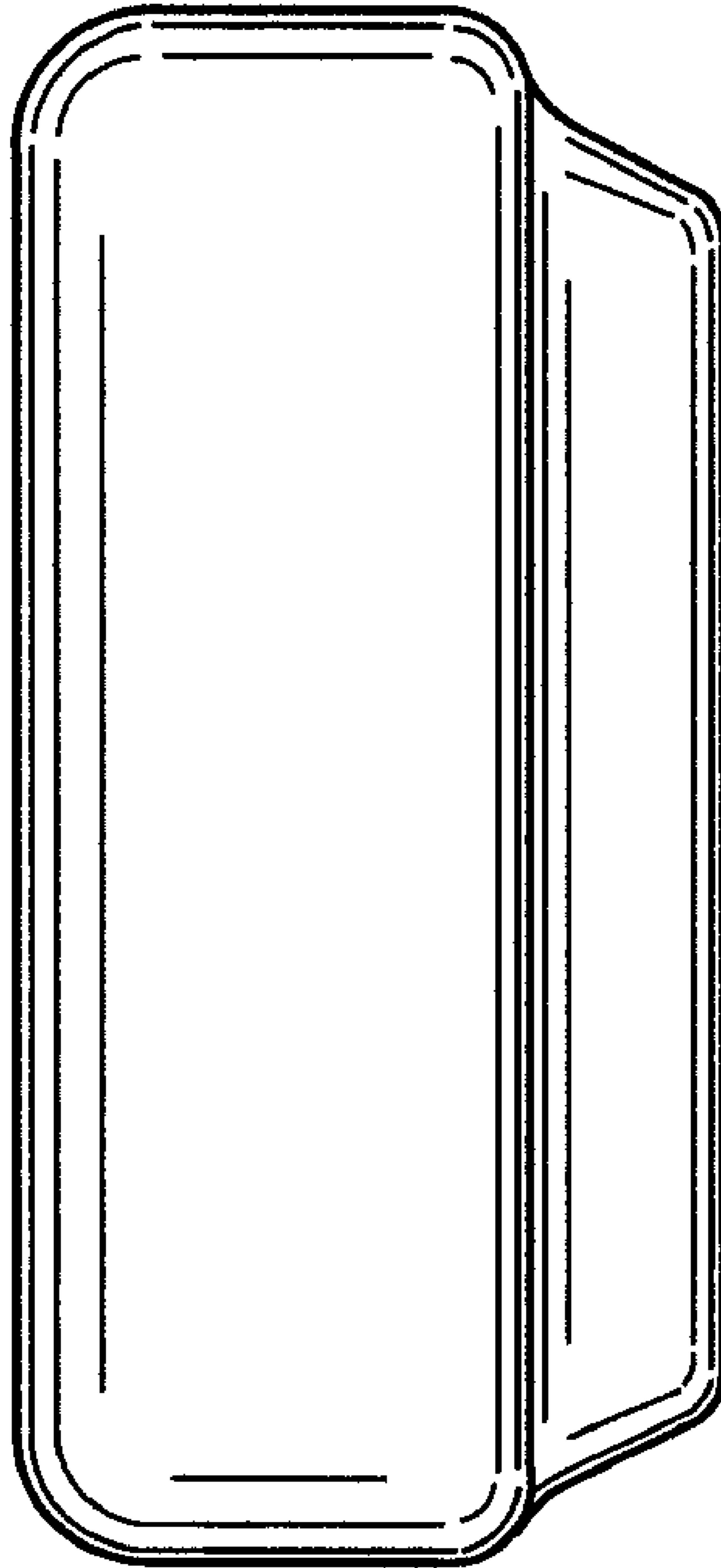
FIG. 7 is a bottom end view of the food product of FIG. 1.

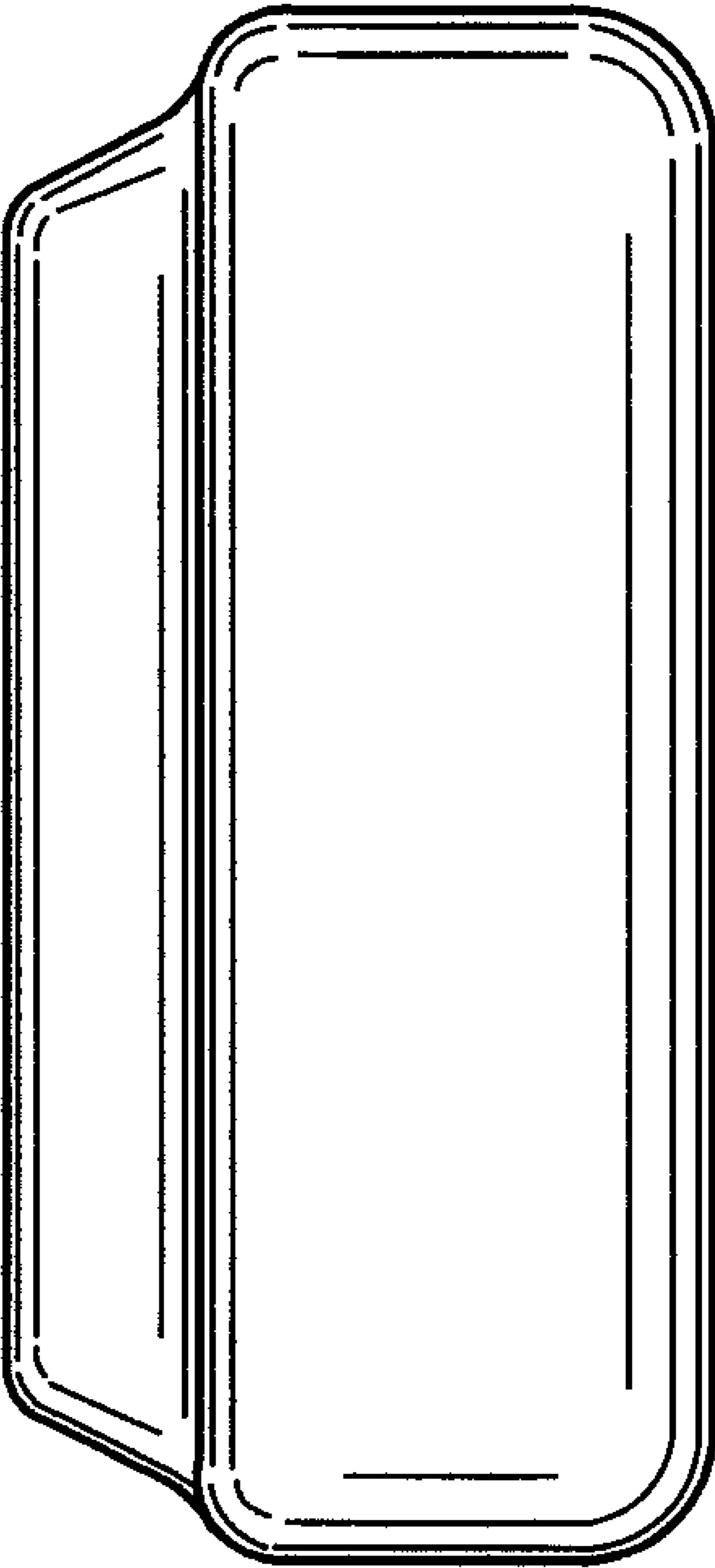




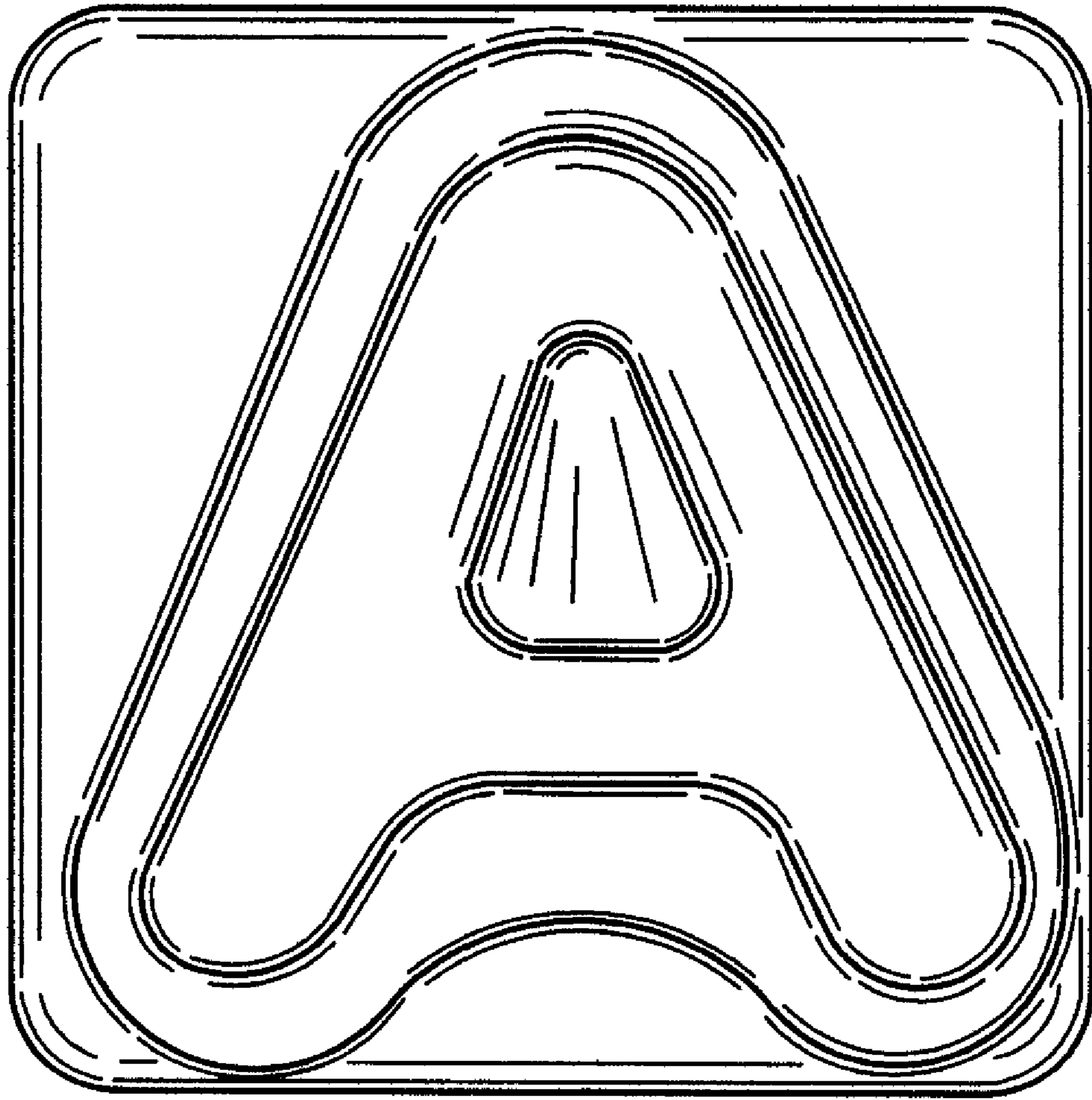

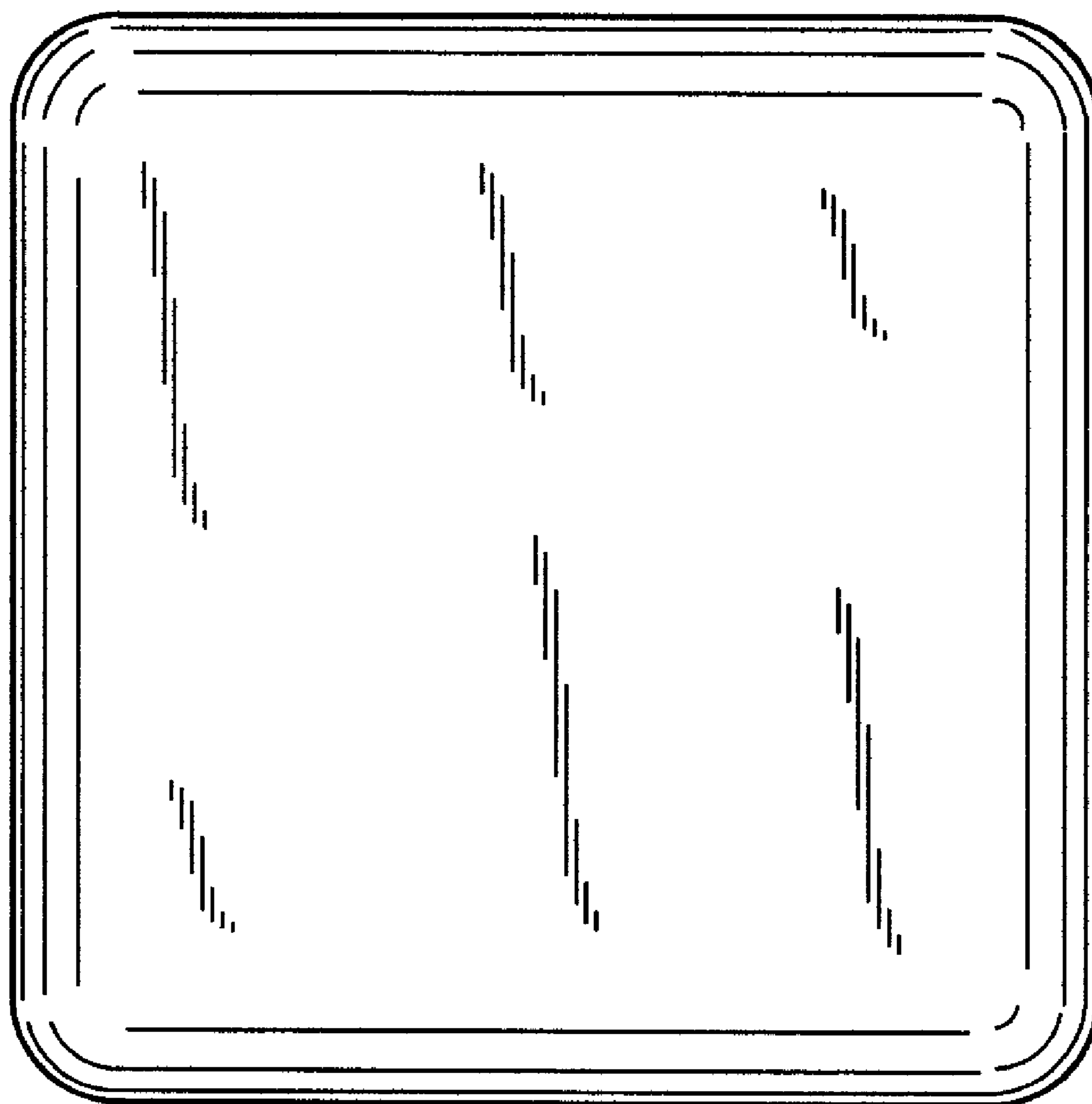

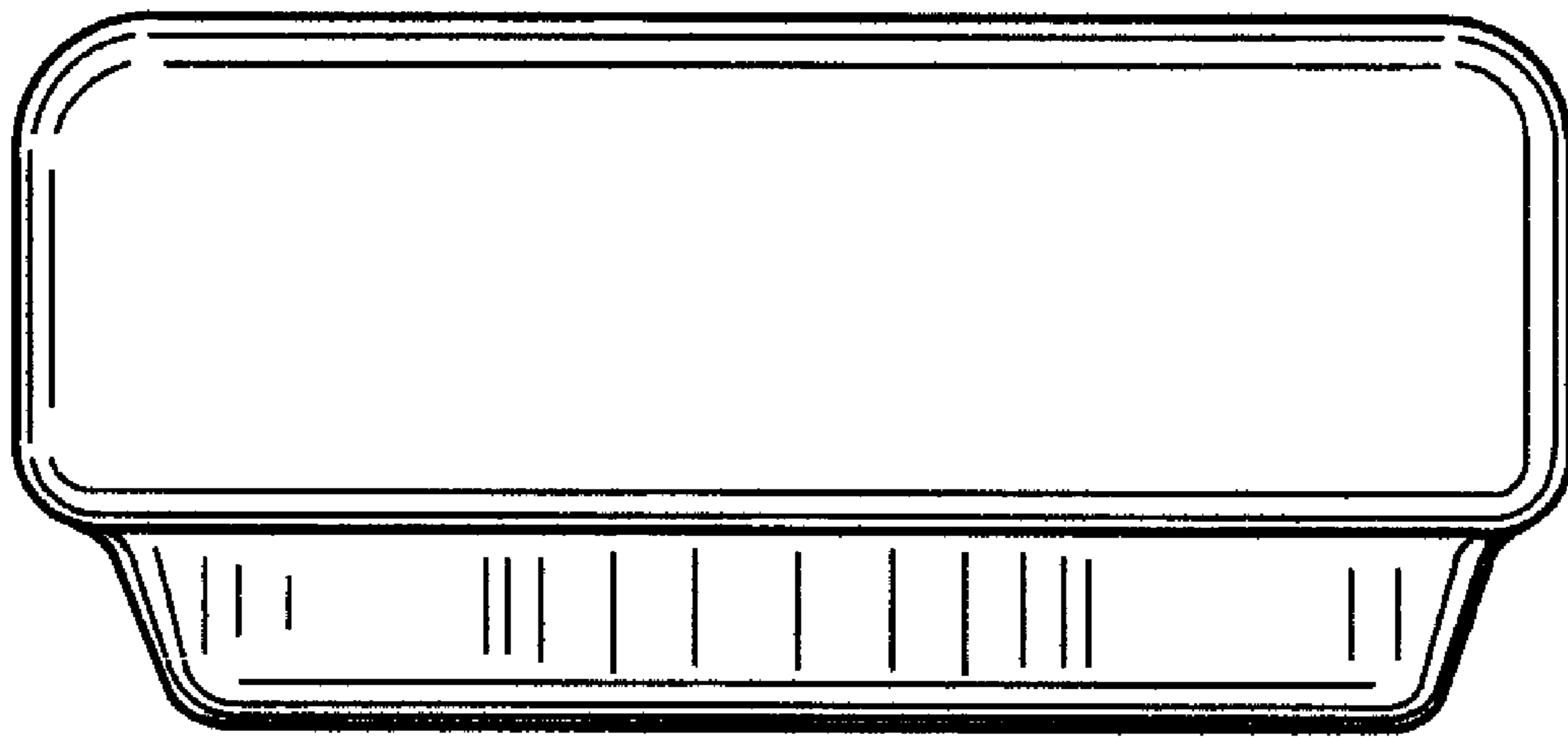

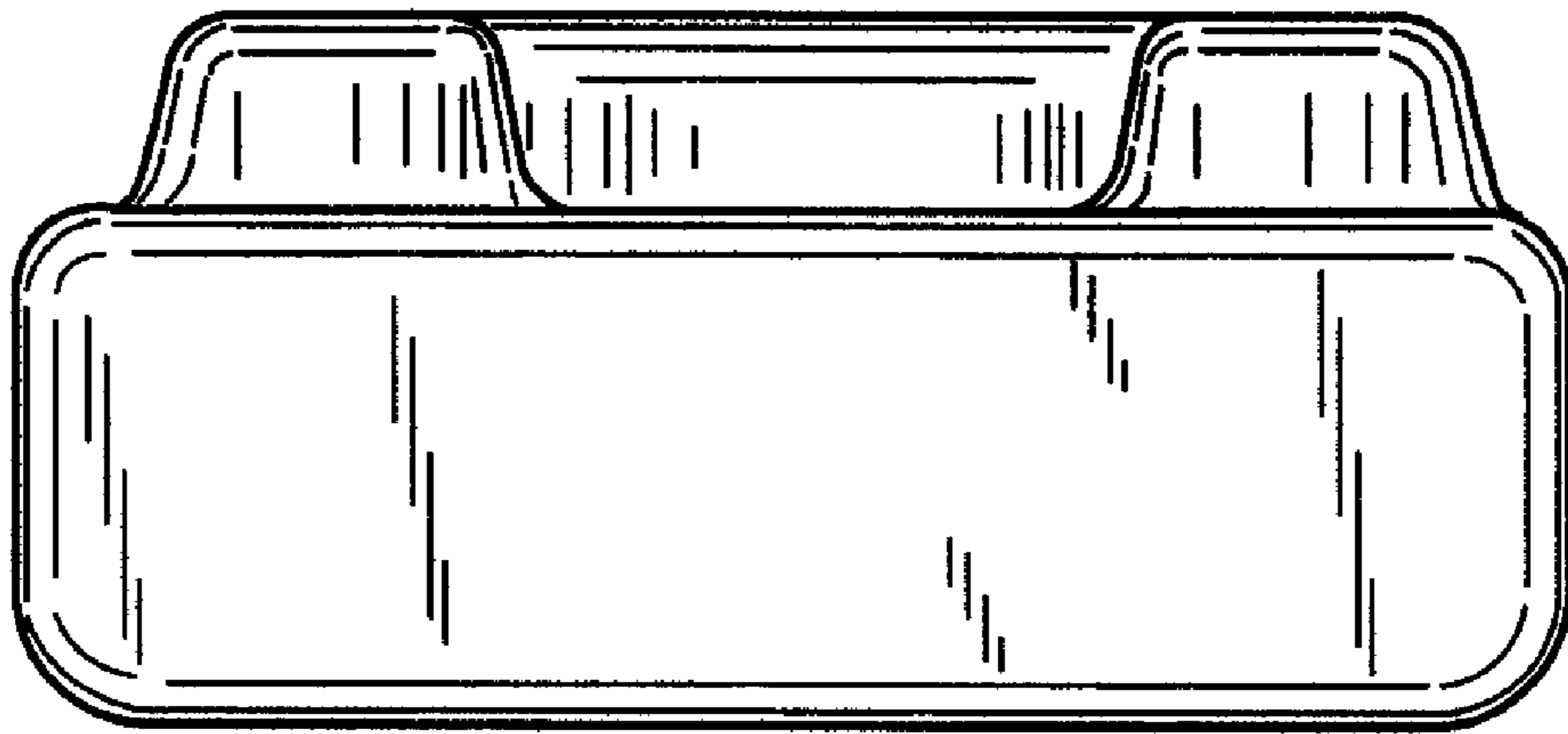
