FIG. 1 is a perspective view of the “cookware top lid handle”, showing my new design;

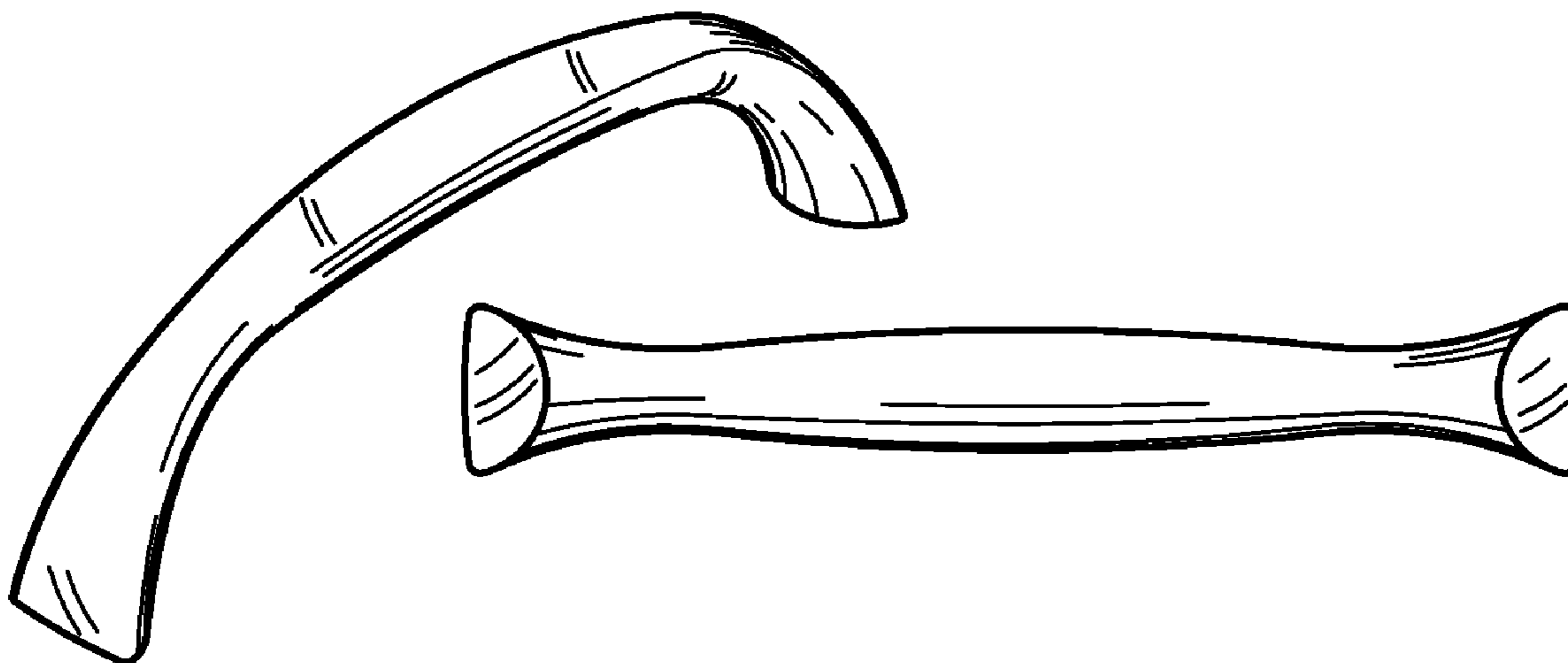
FIG. 2 is a top plan view thereof;

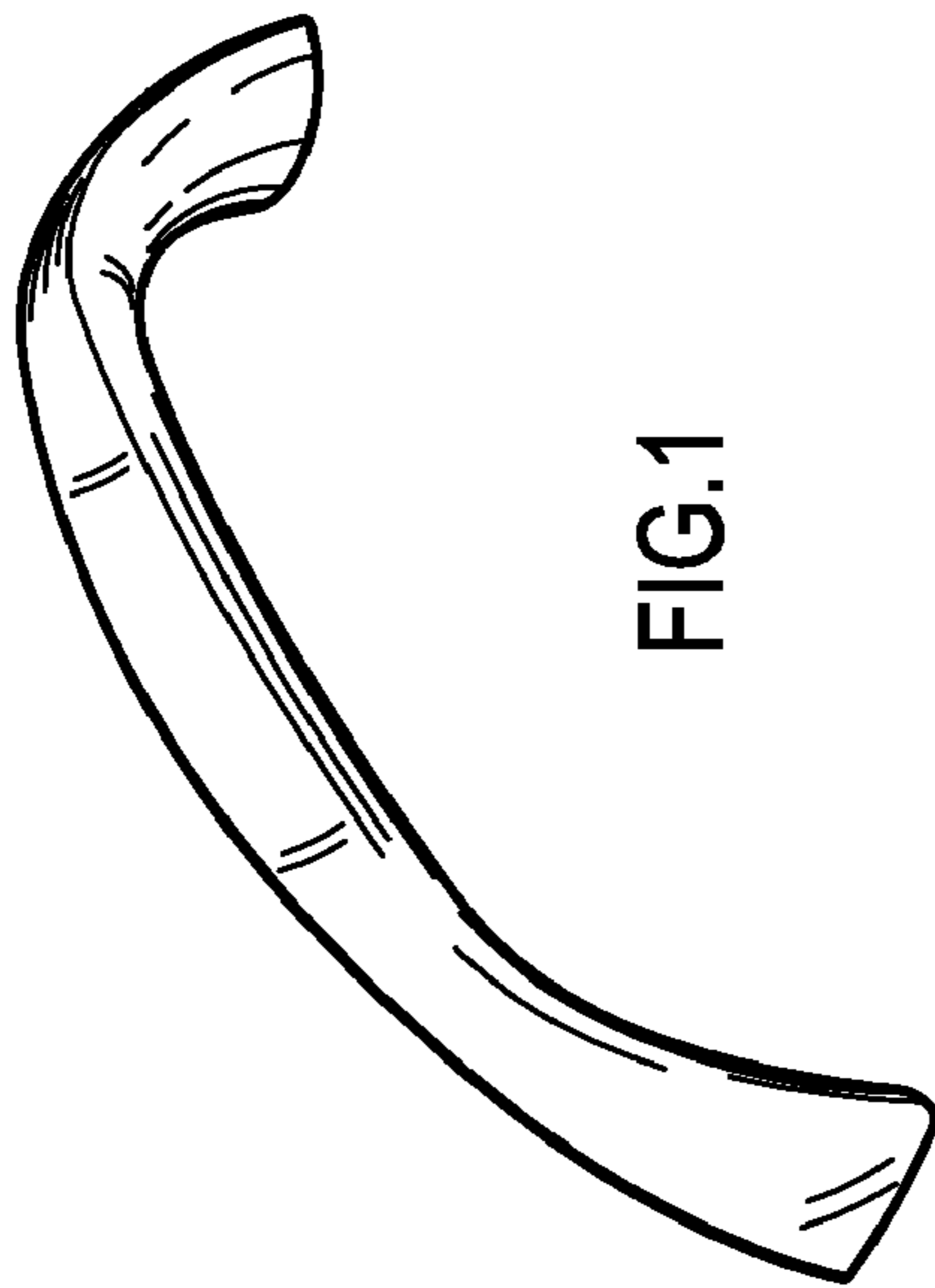

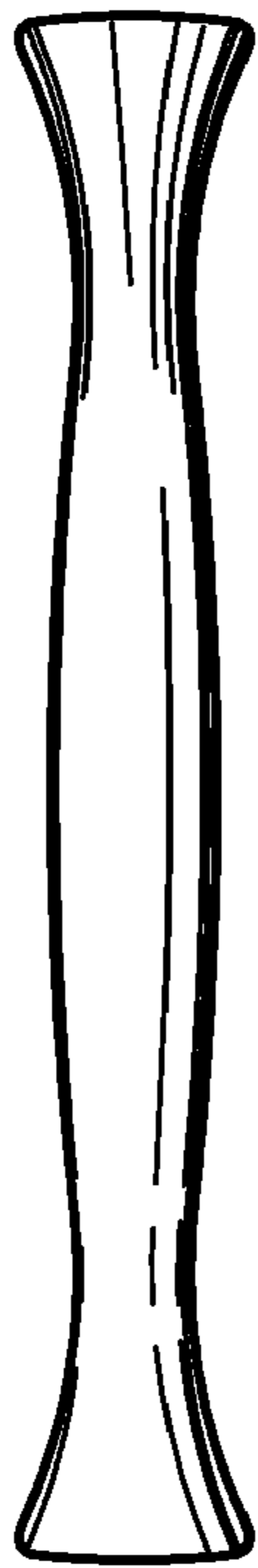

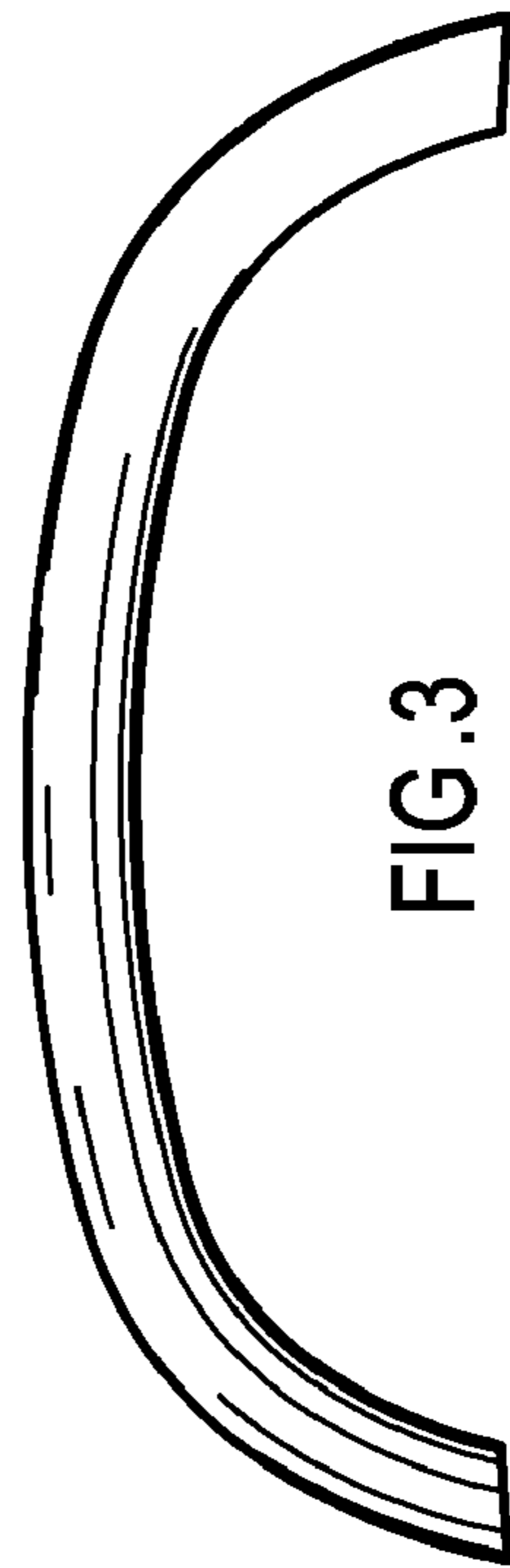
