The ornamental design for a utensil, as shown and described.

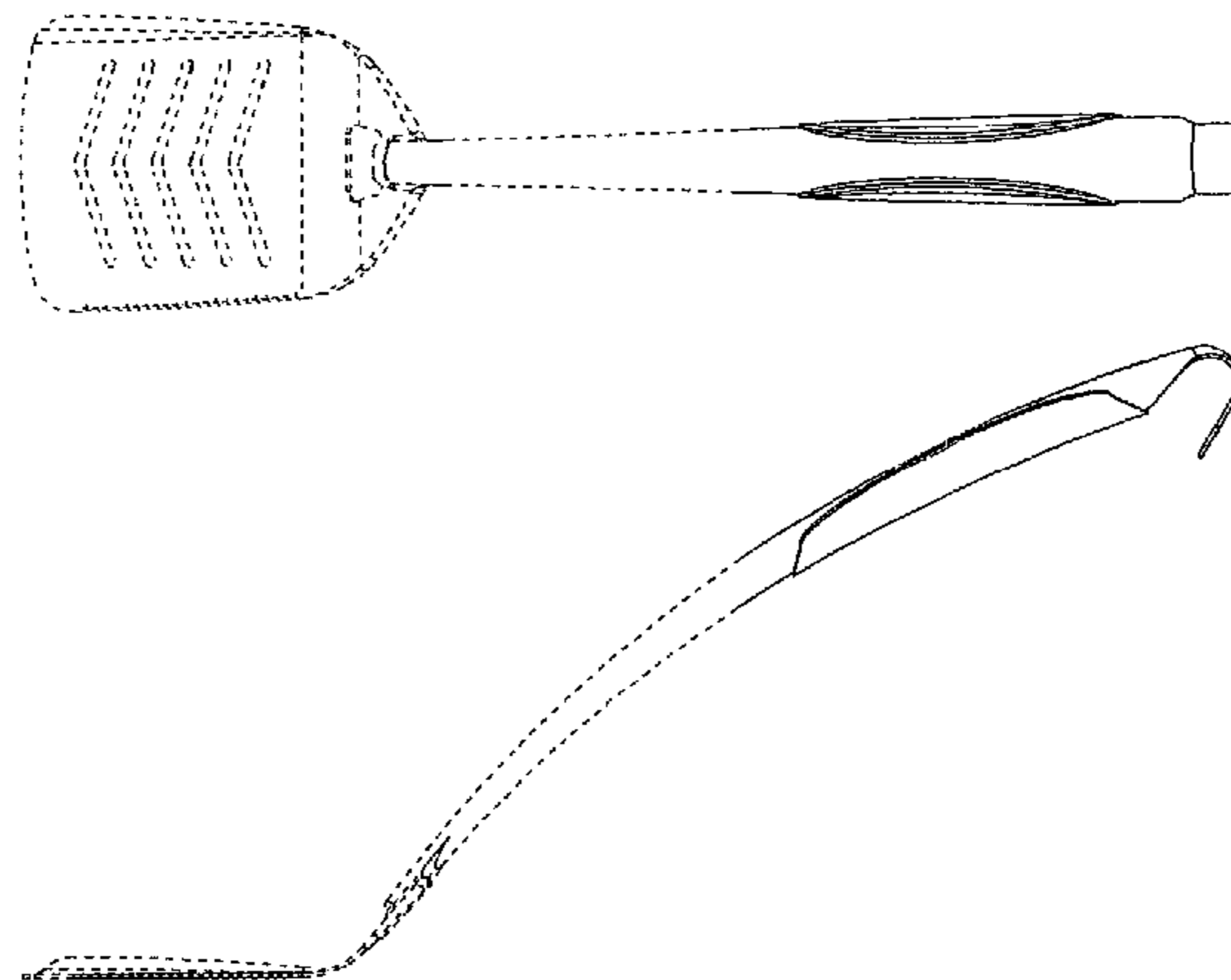
DESCRIPTION

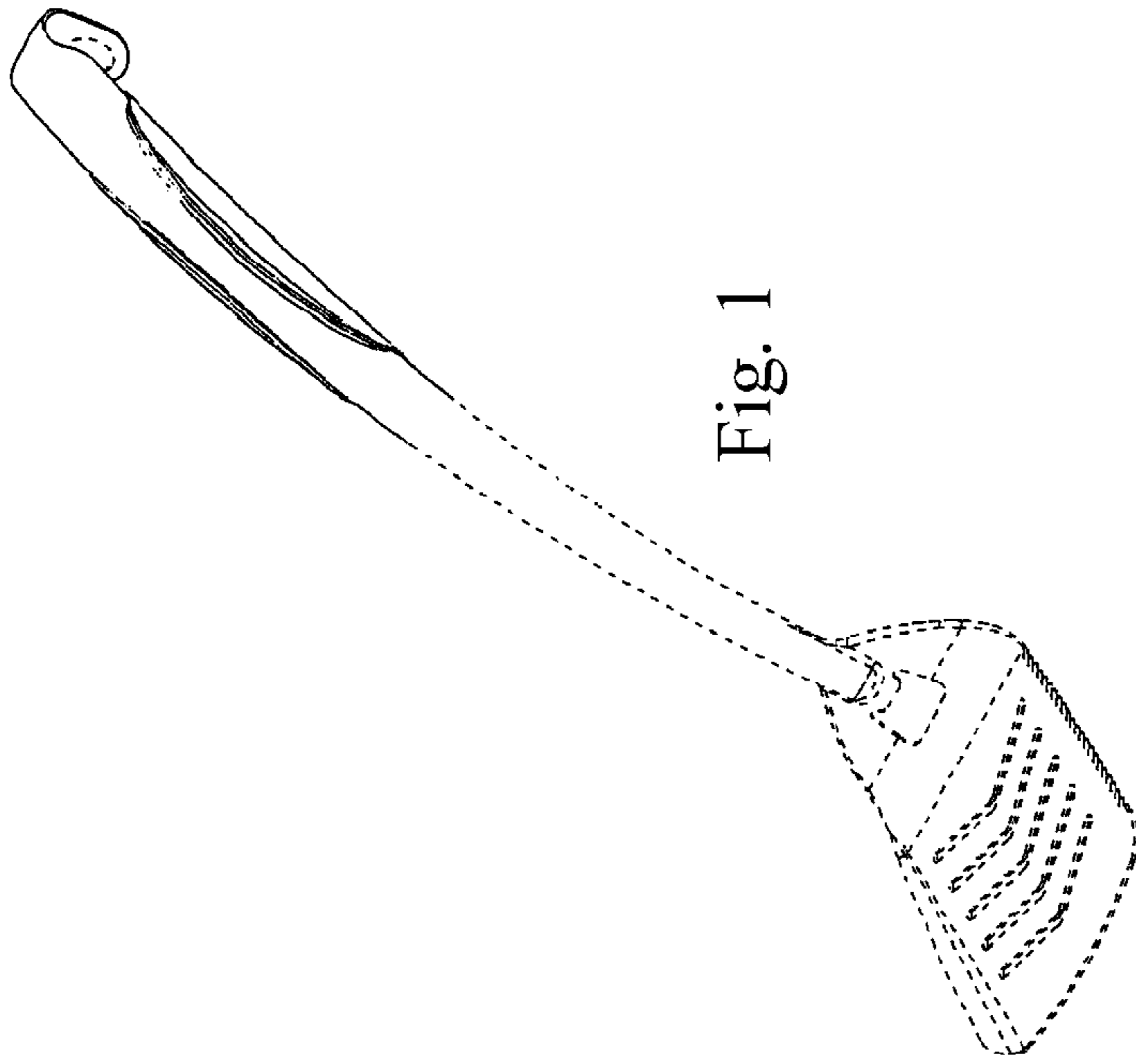

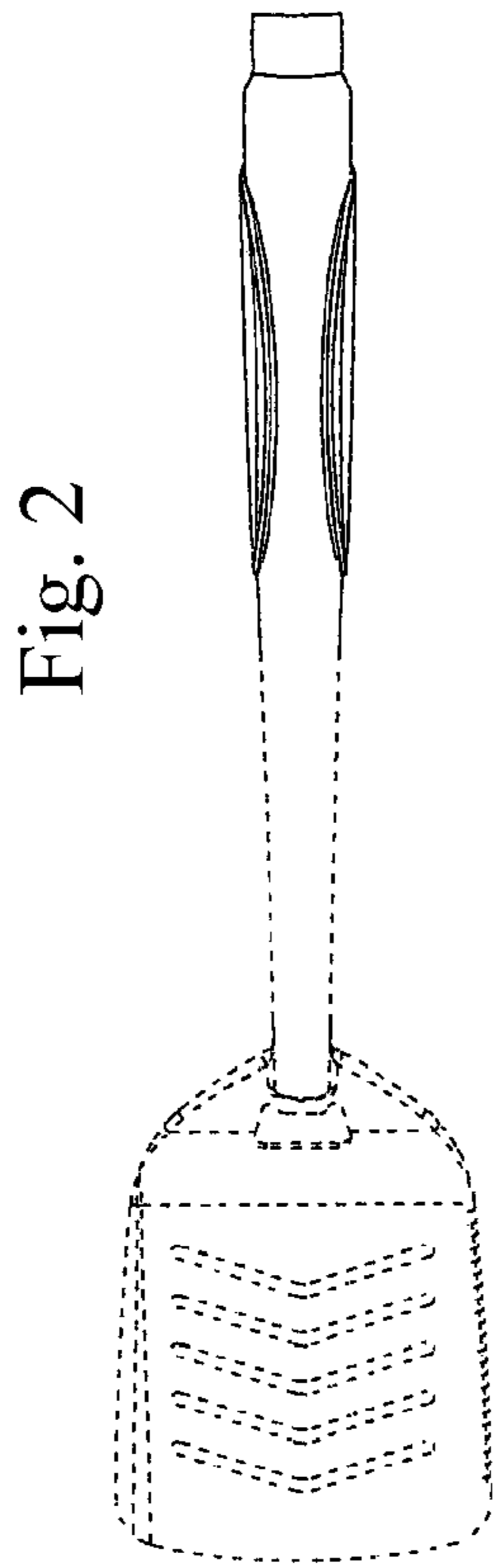

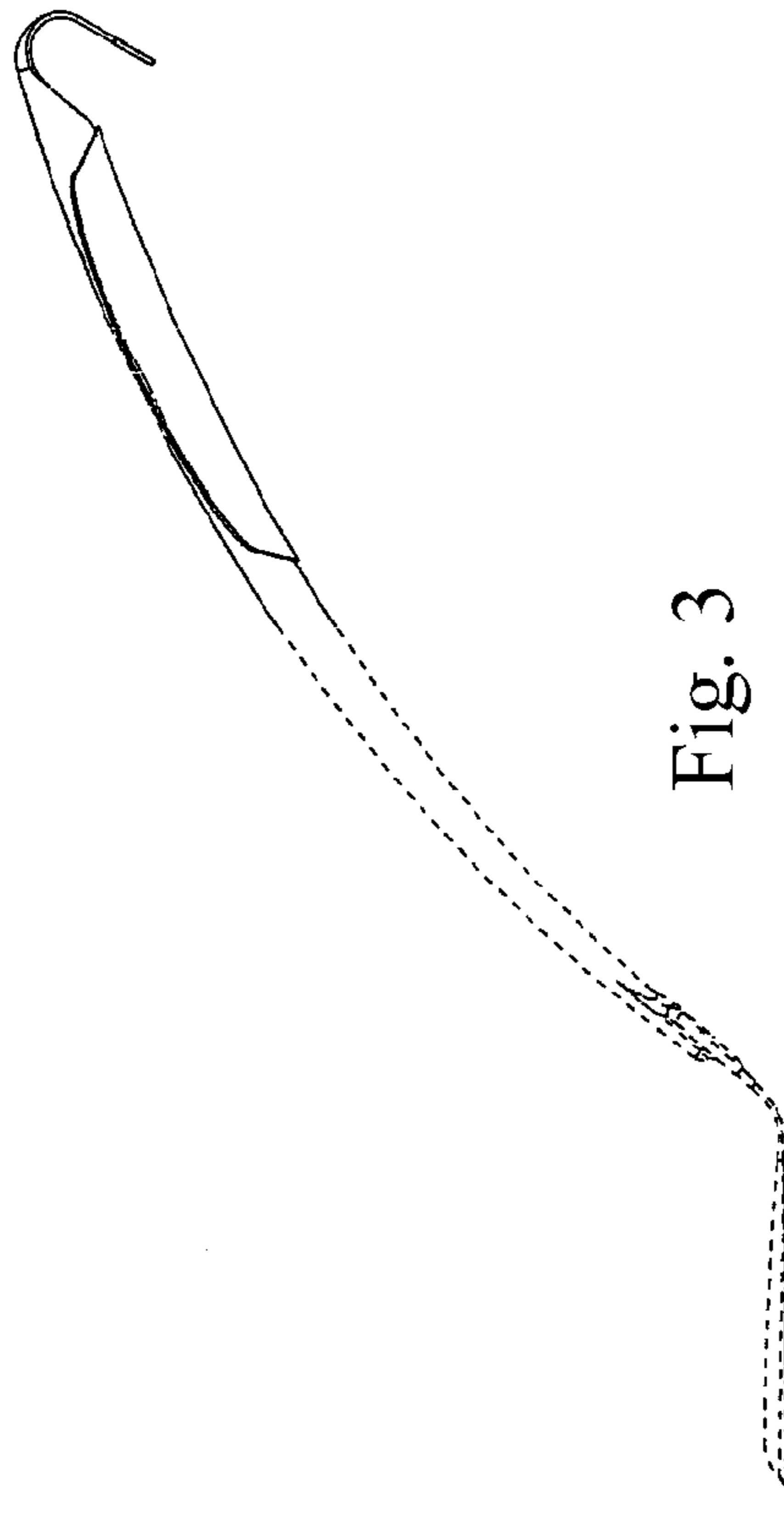
