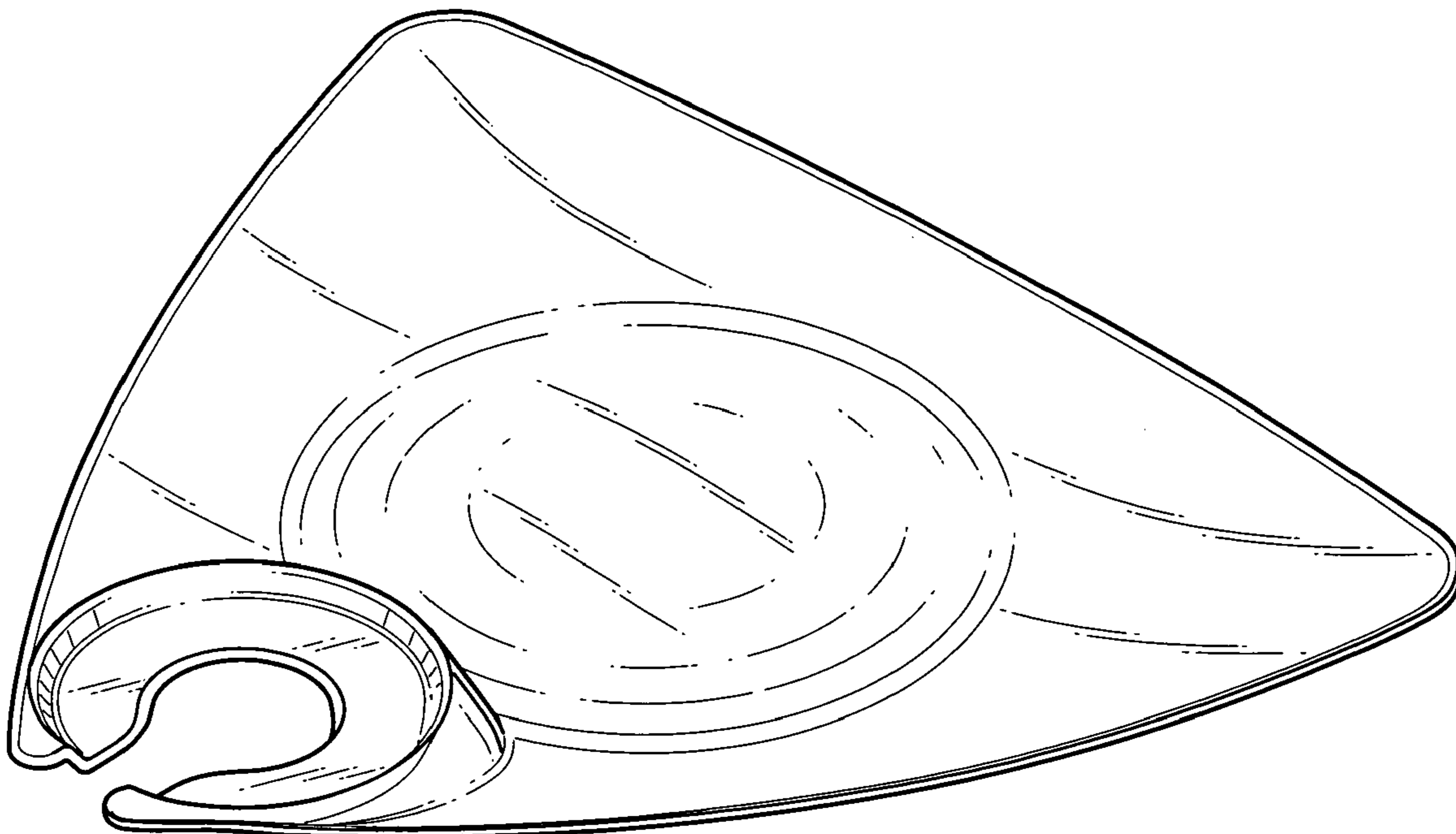
The ornamental design for a compartmented dish, as shown and described.

FIG. 1 is a top perspective view of a compartmented dish showing my new design;  
FIG. 2 is a top plan view thereof;

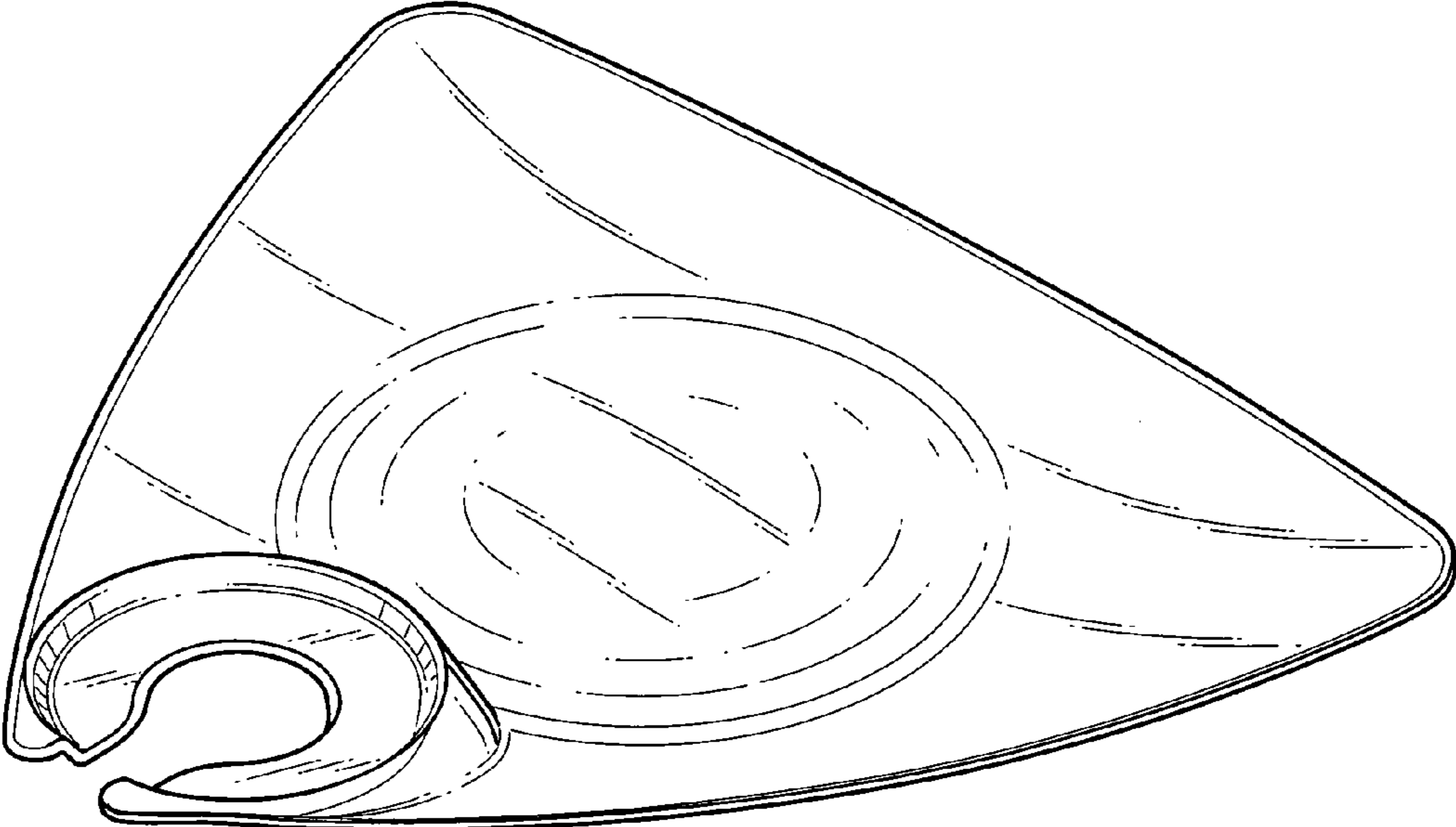

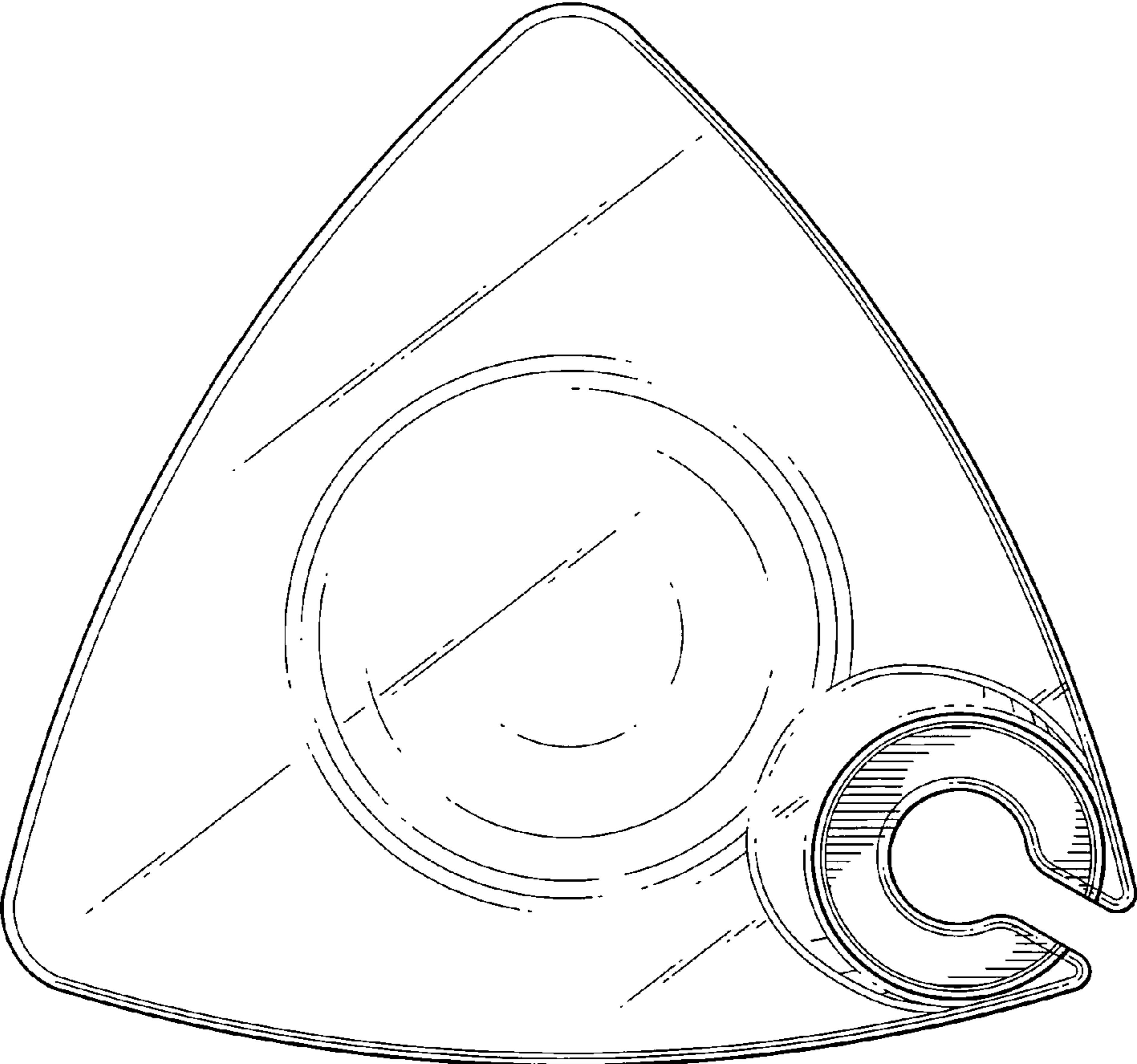

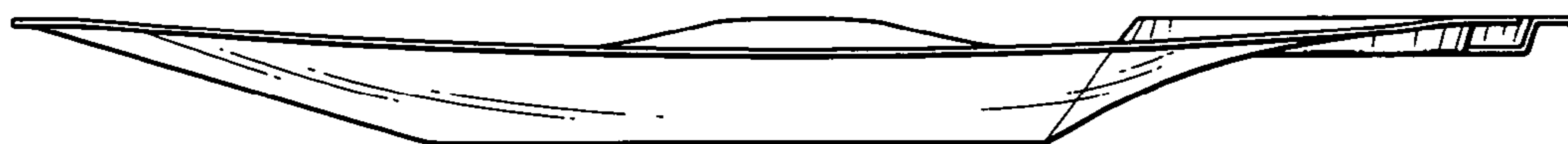

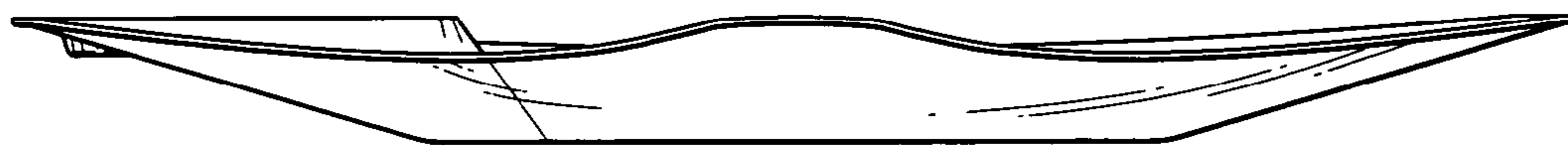

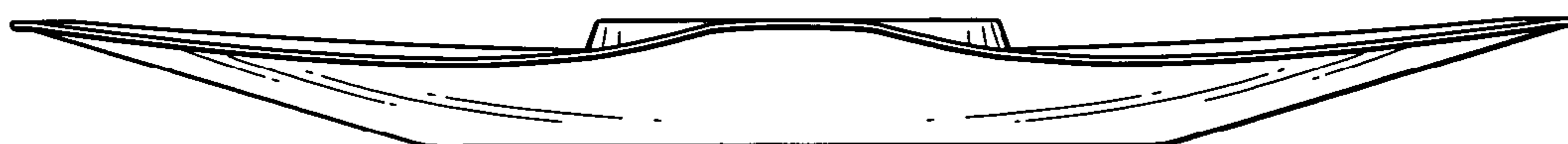
