The ornamental design for a cupcake holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a cupcake holder showing my new design;

FIG. 2 is a side view of the cupcake holder;

FIG. 3 is a side view of the cupcake holder rotated 90 degrees from the view of FIG. 2;

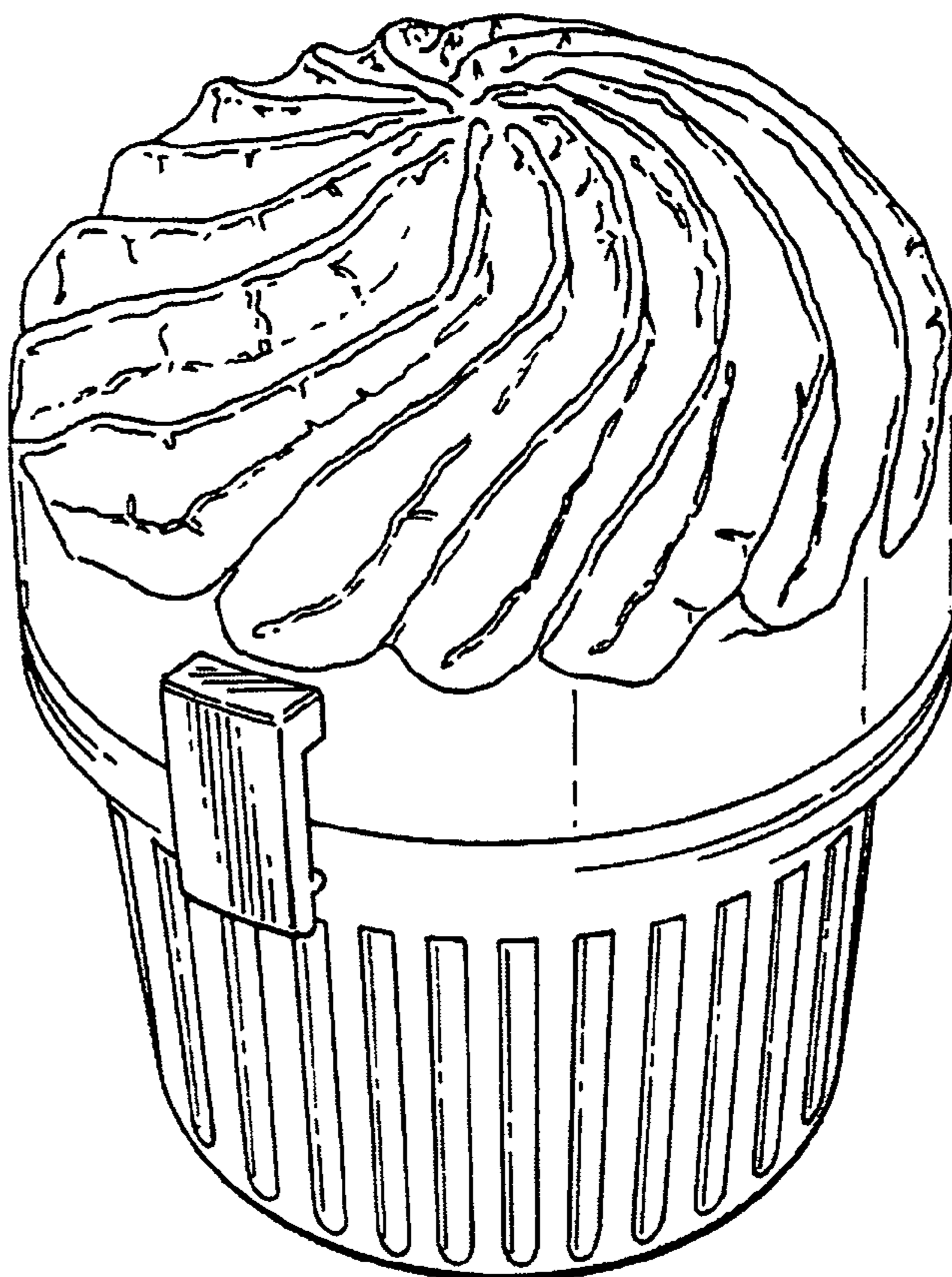
FIG. 4 is a side view of the cupcake holder showing the side opposite of that of FIG. 2;

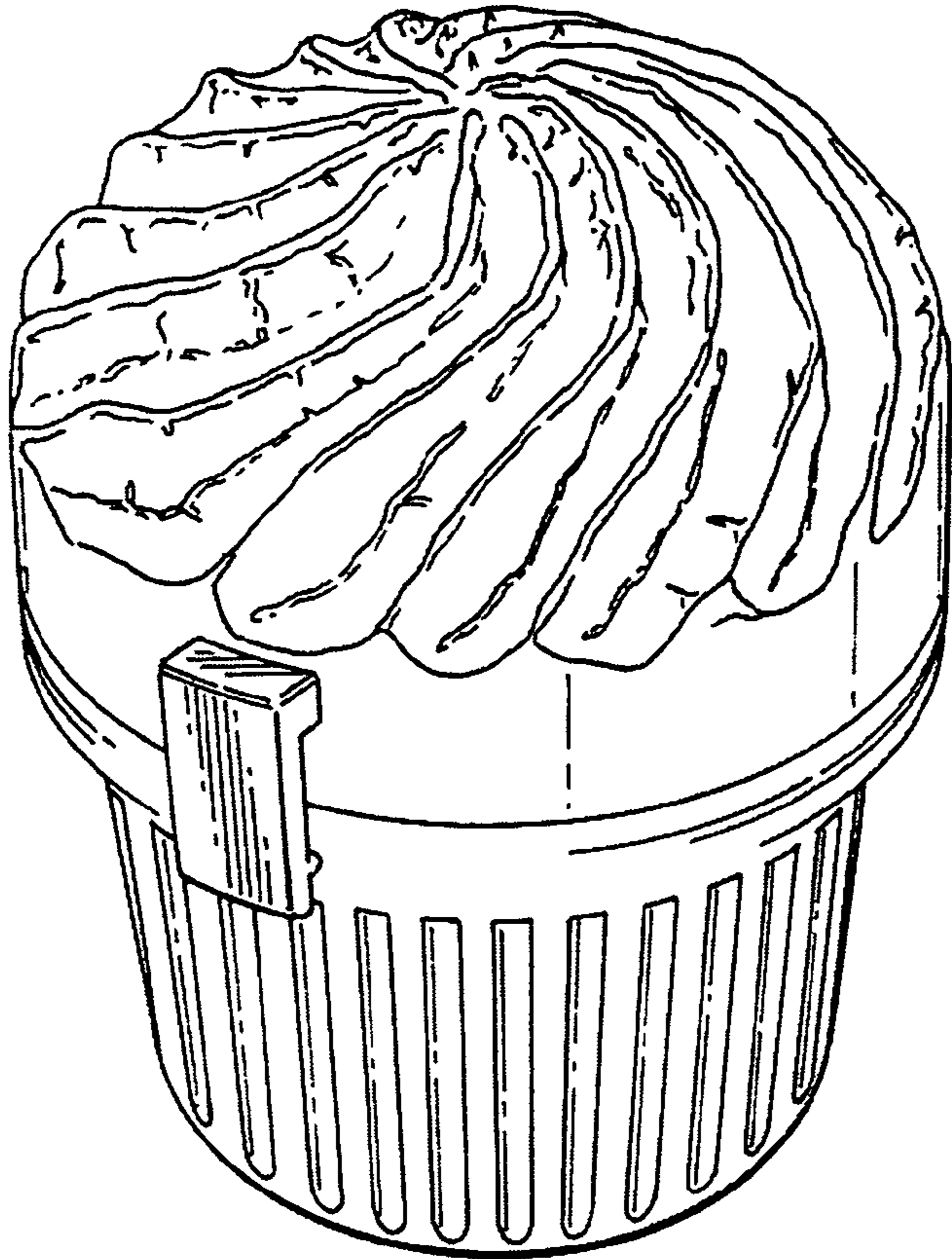

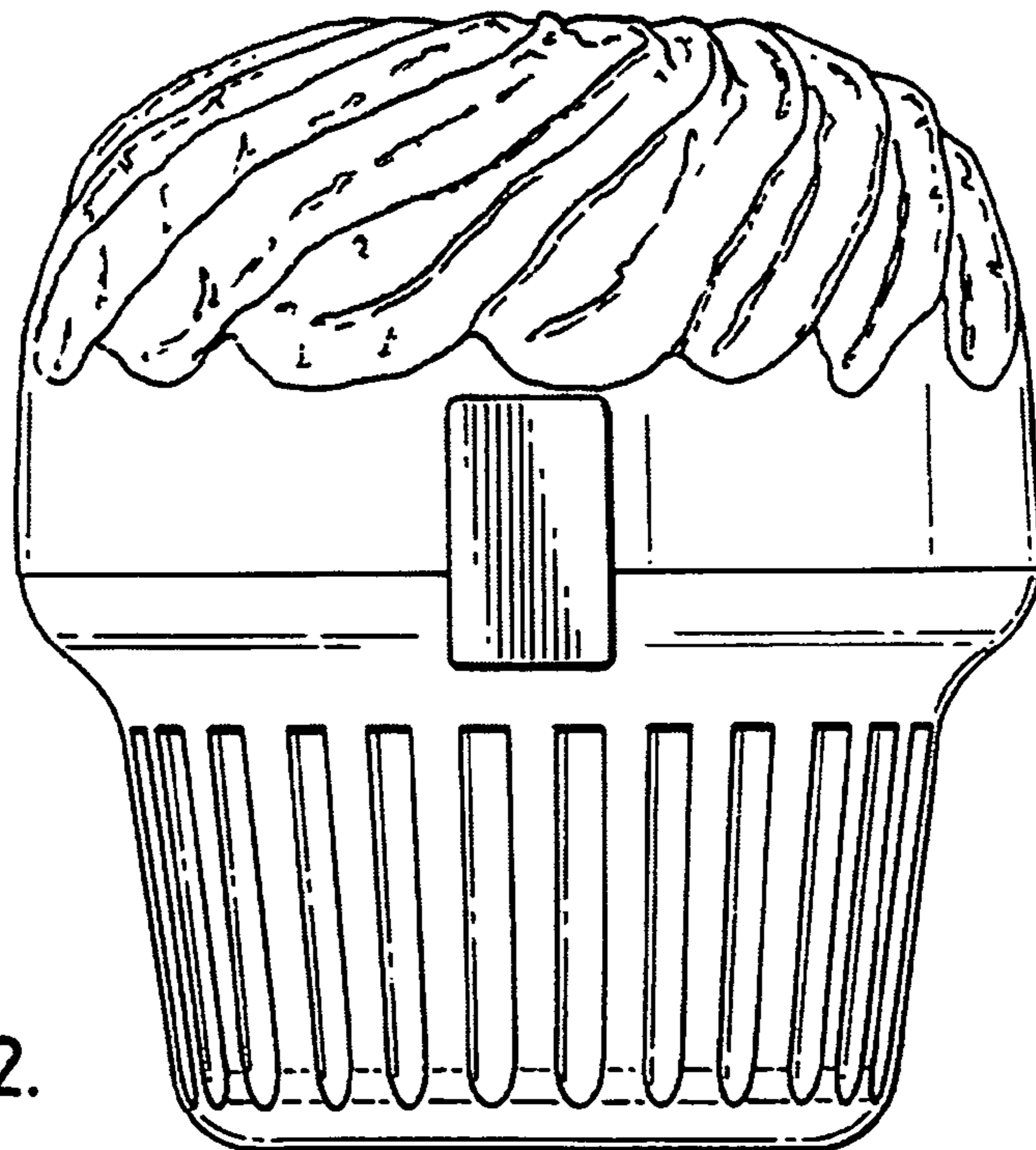

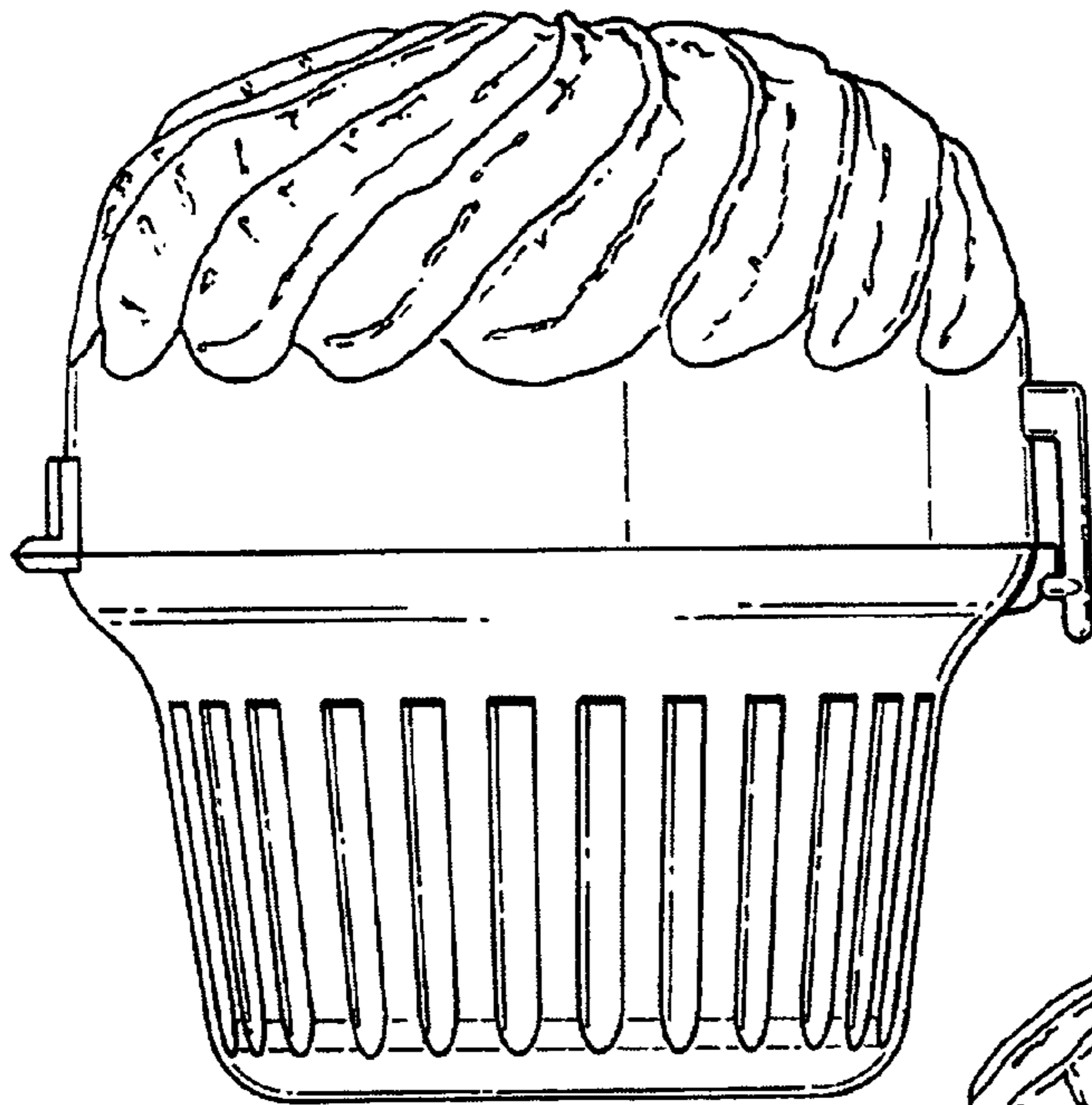

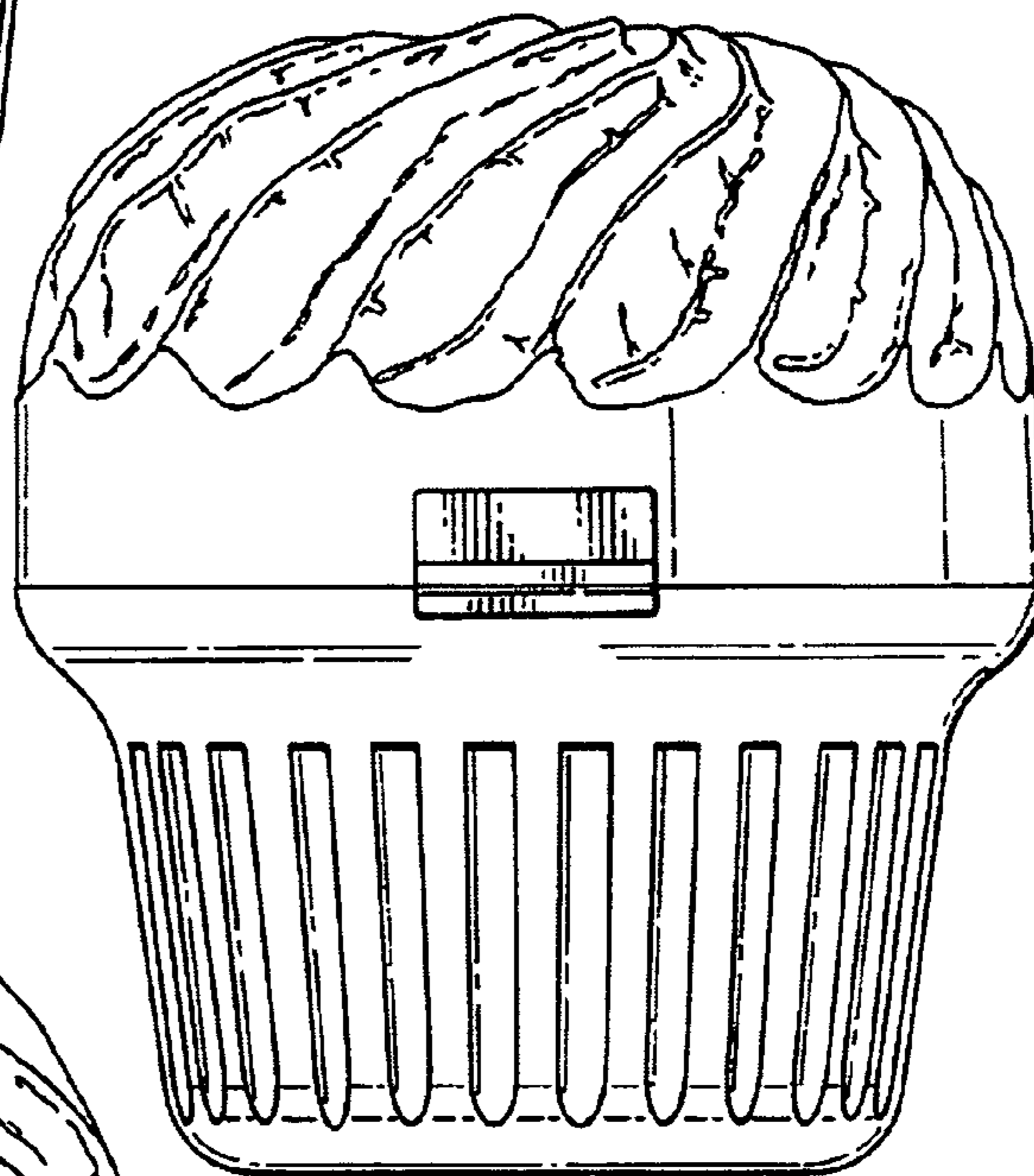

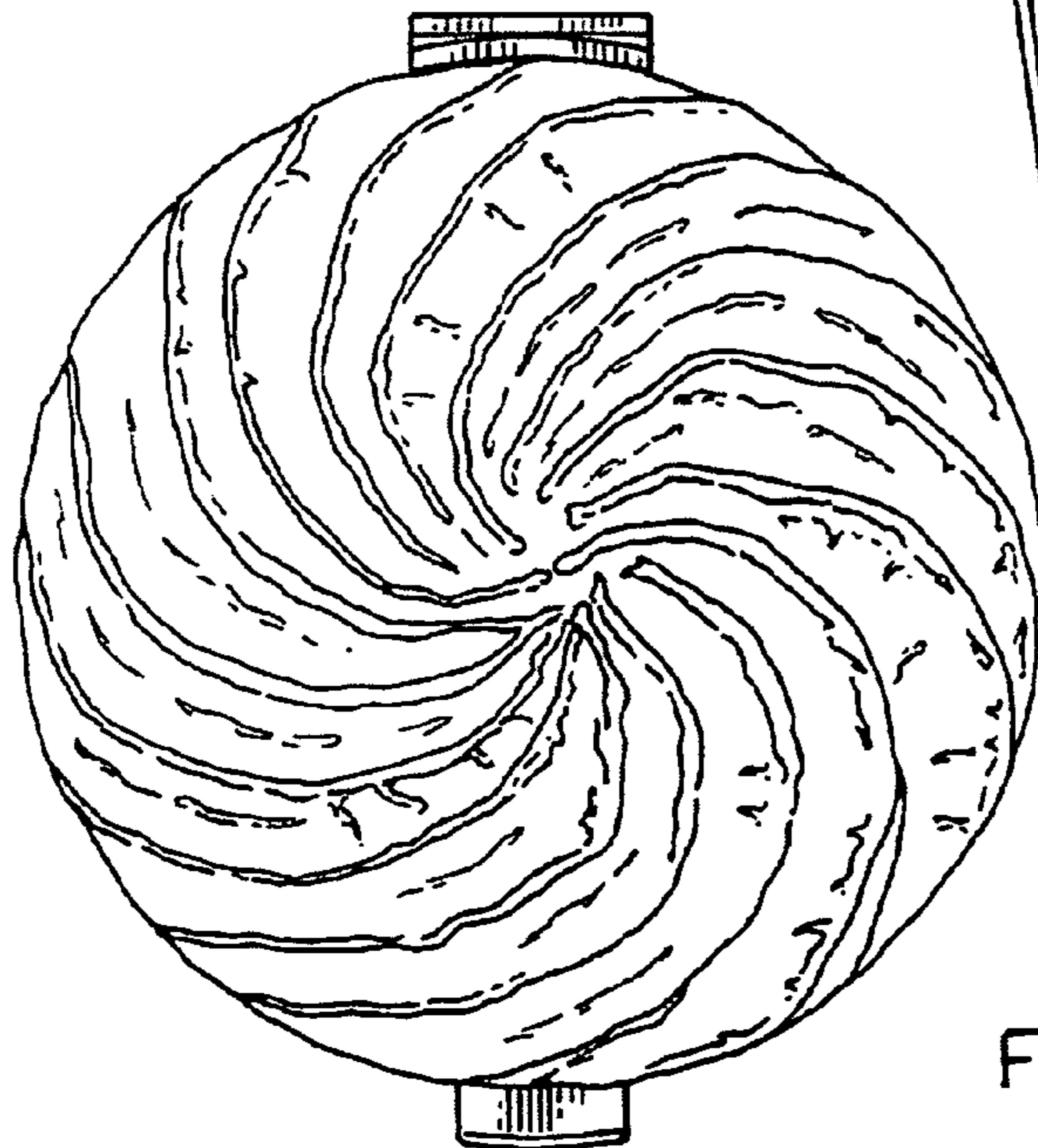

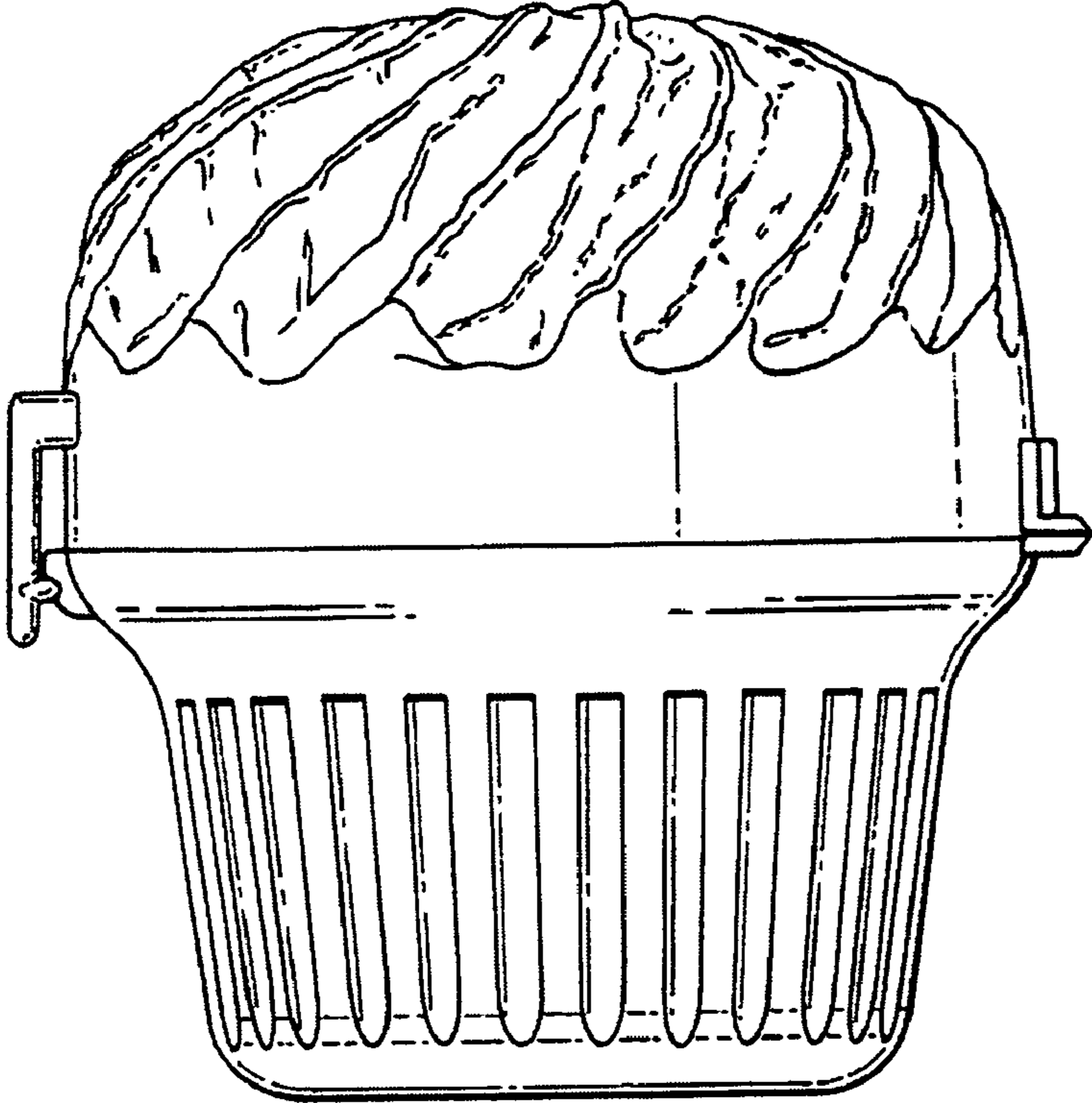

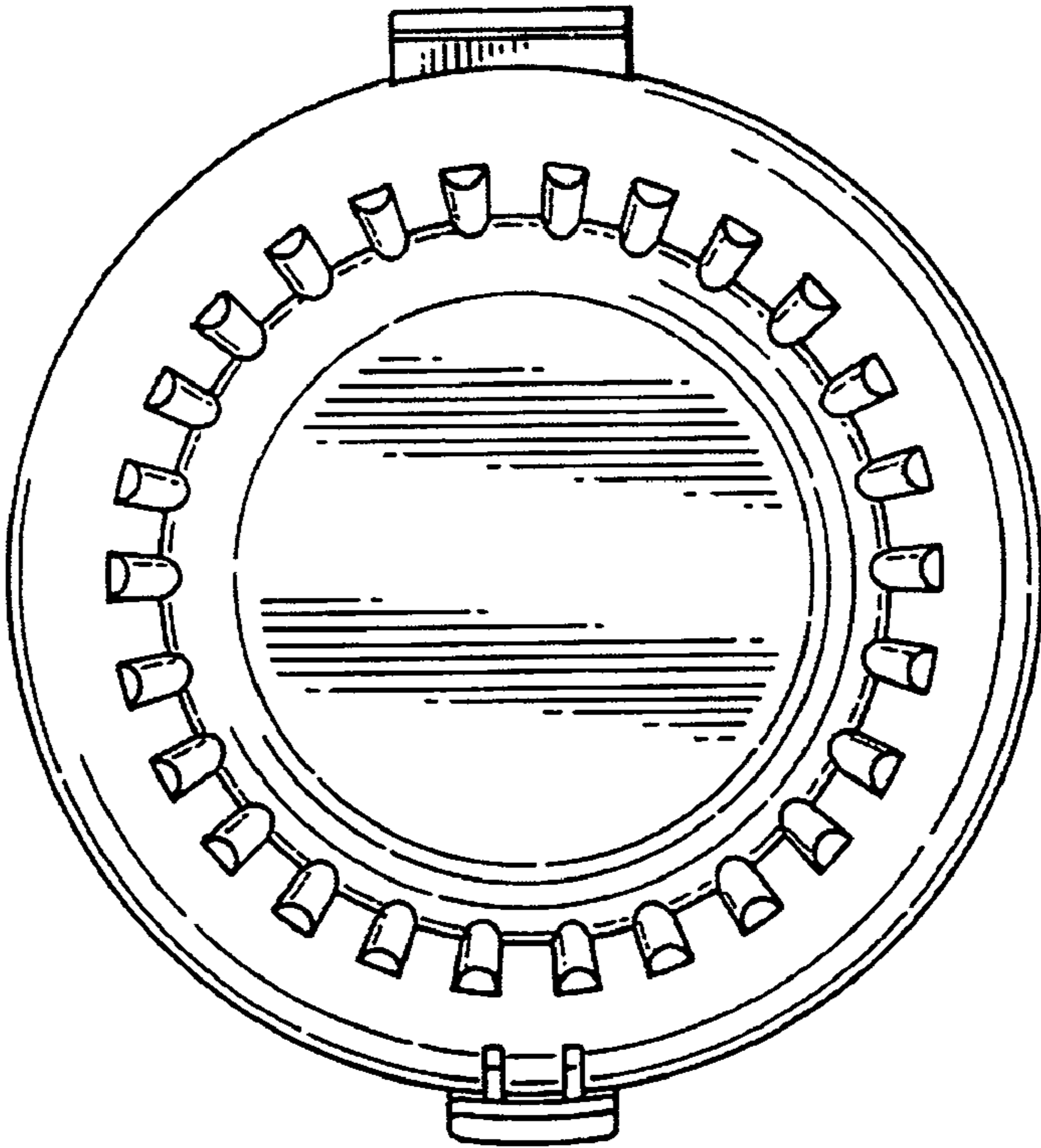
