FIG. 4 is a side view of the design of the present invention;

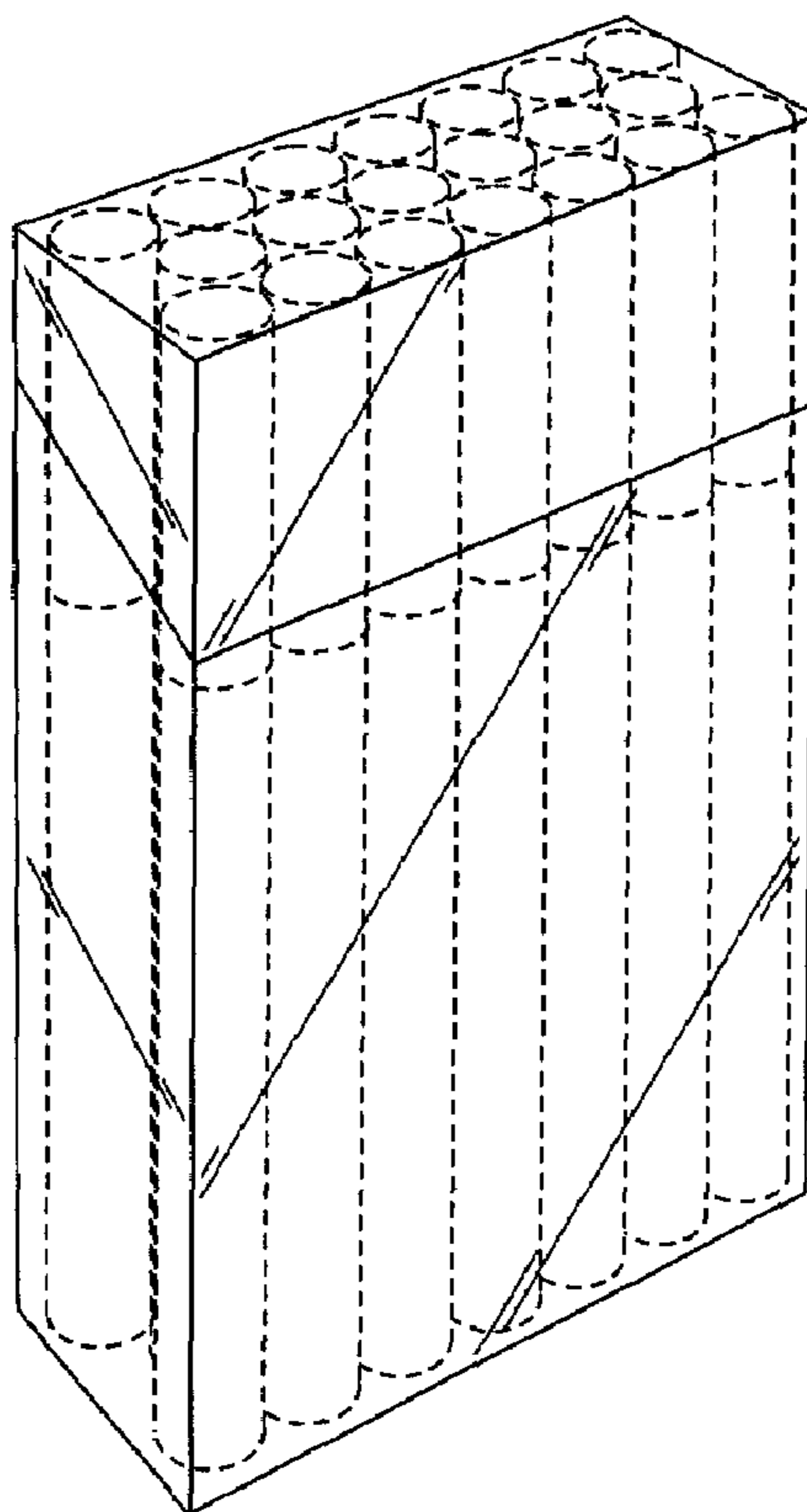
FIG. 5 is a side view of the design of the present invention;

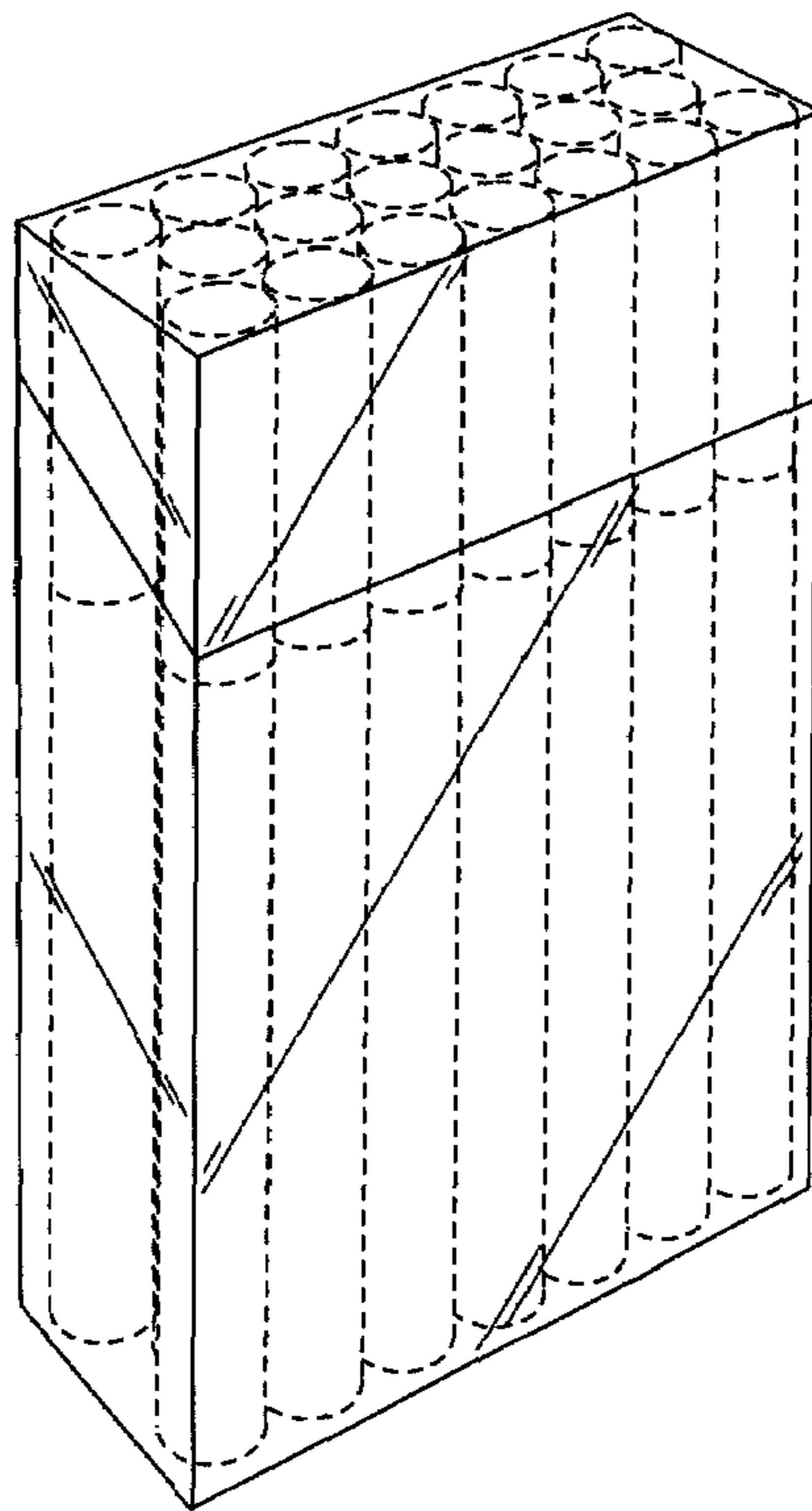

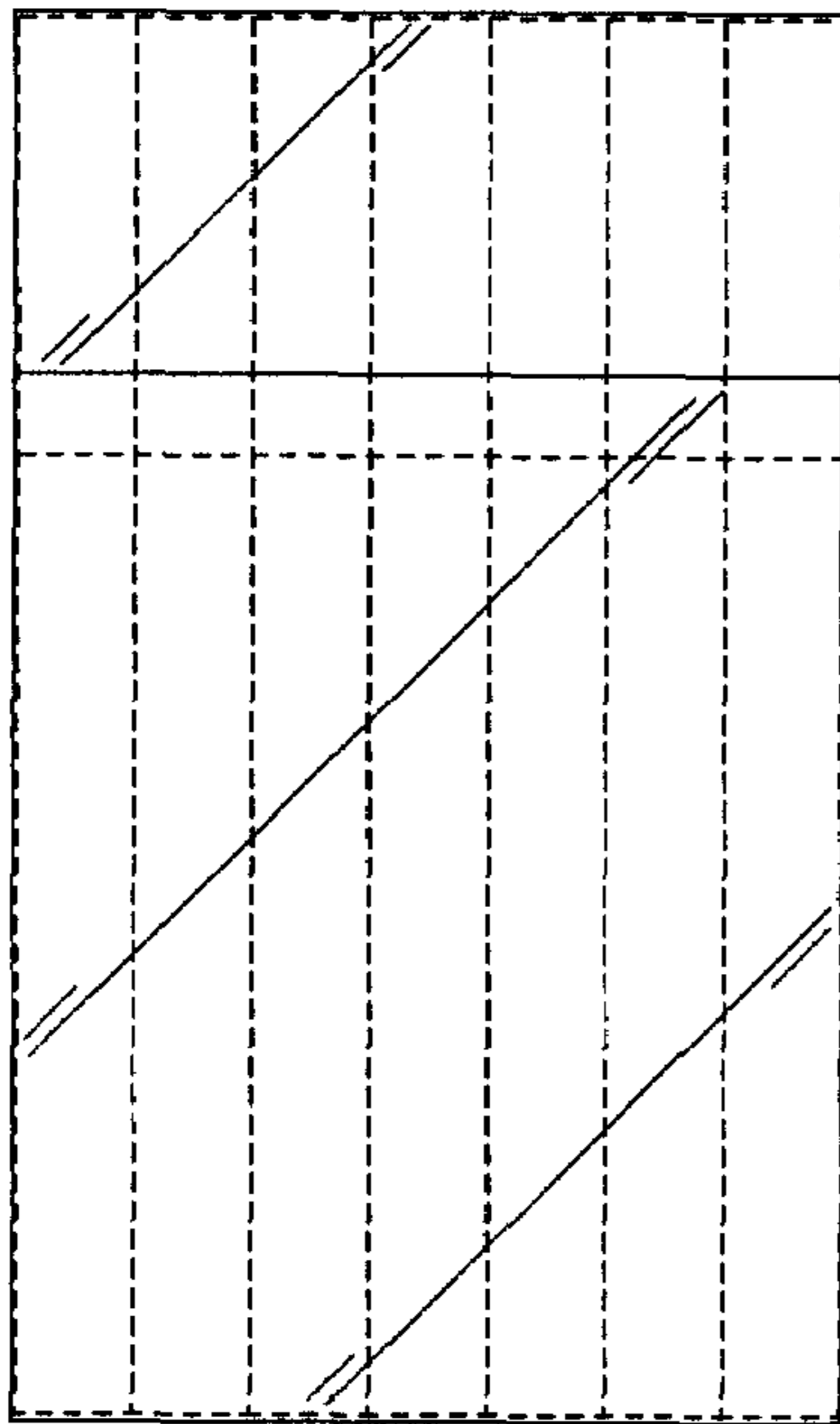

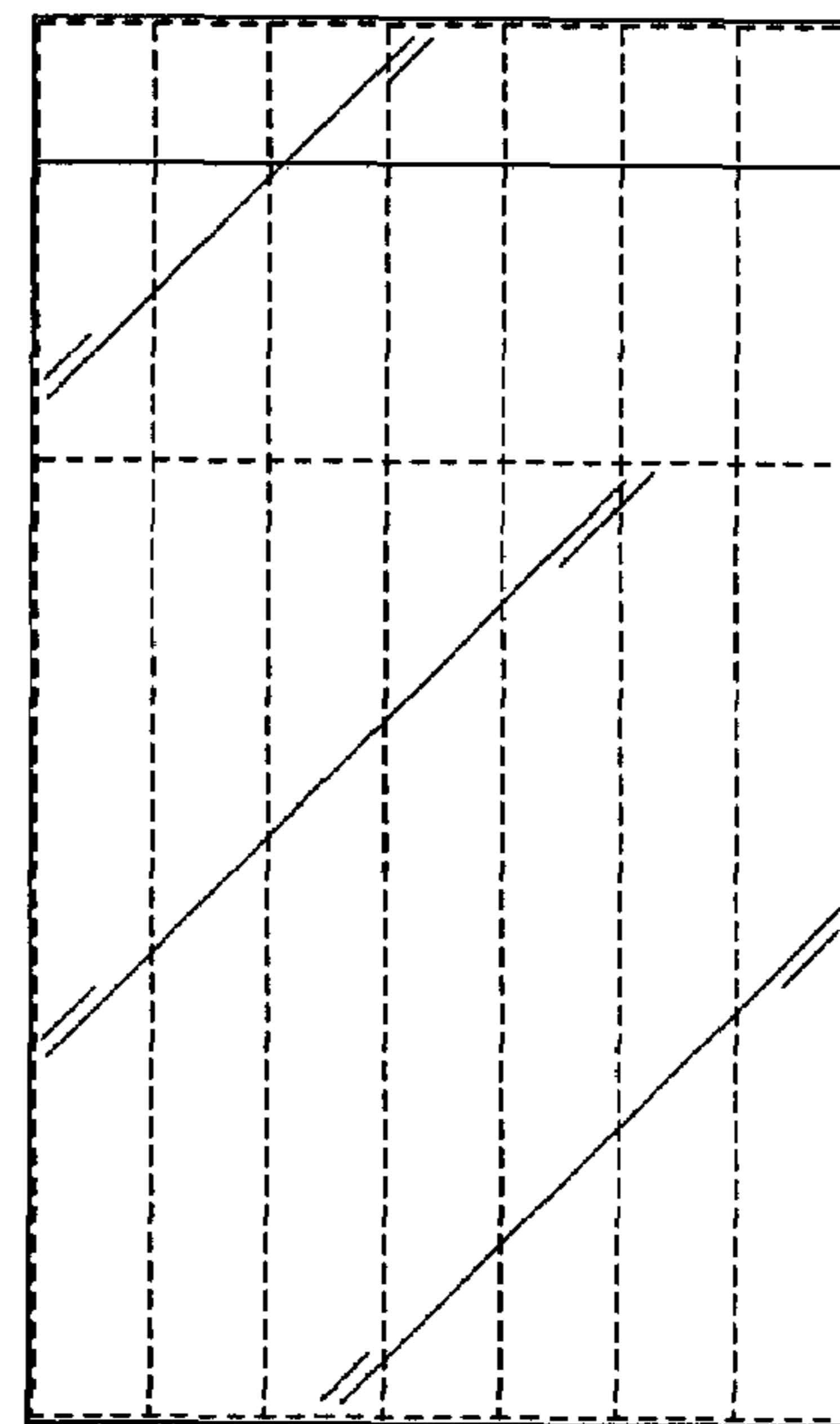

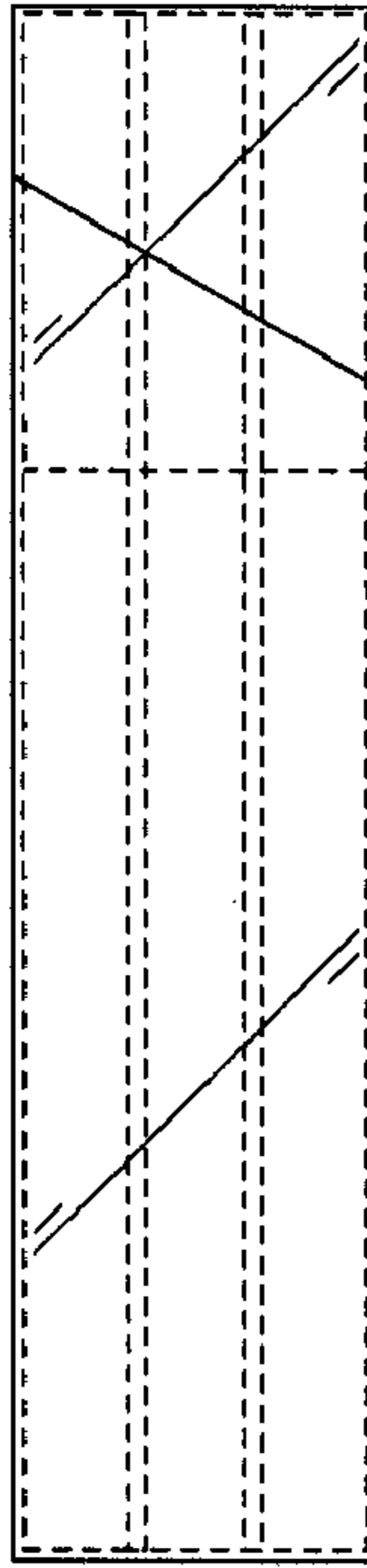

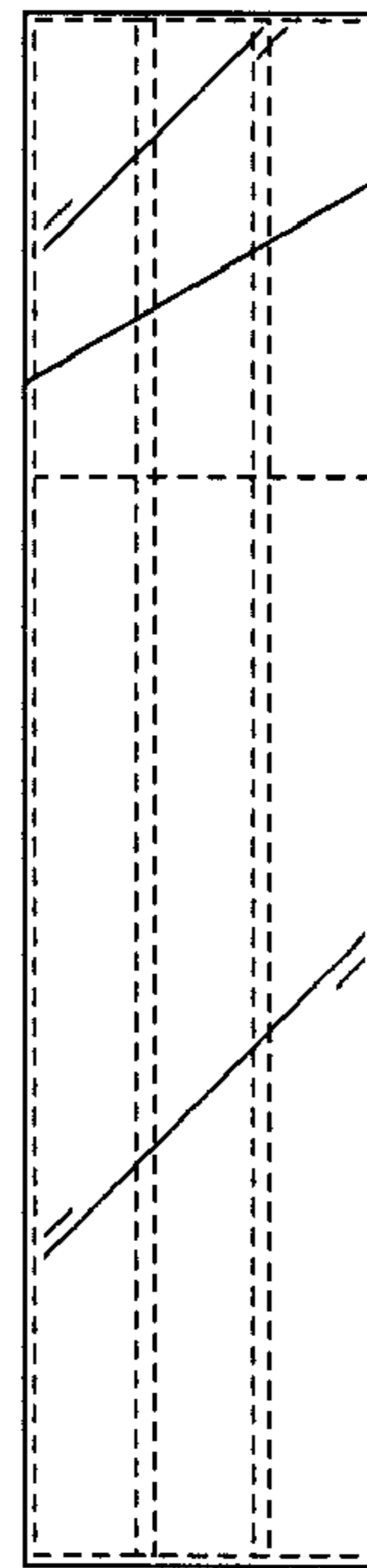

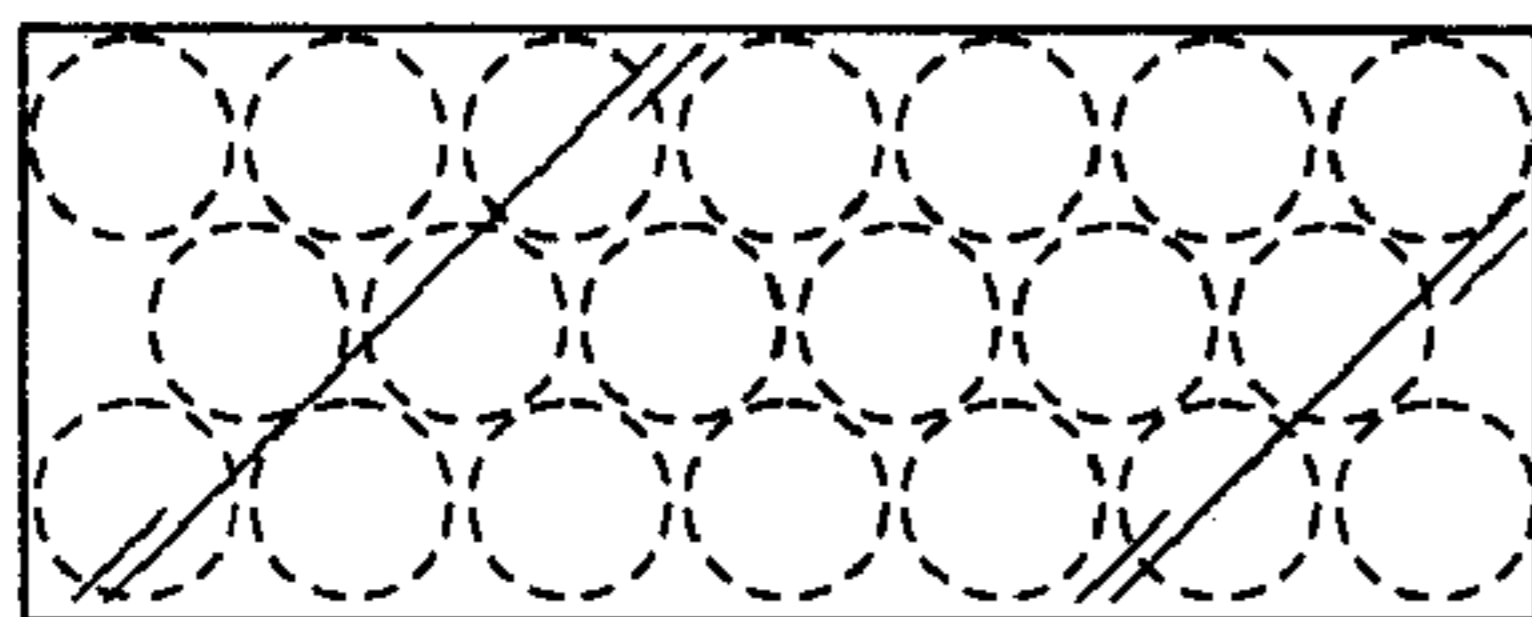

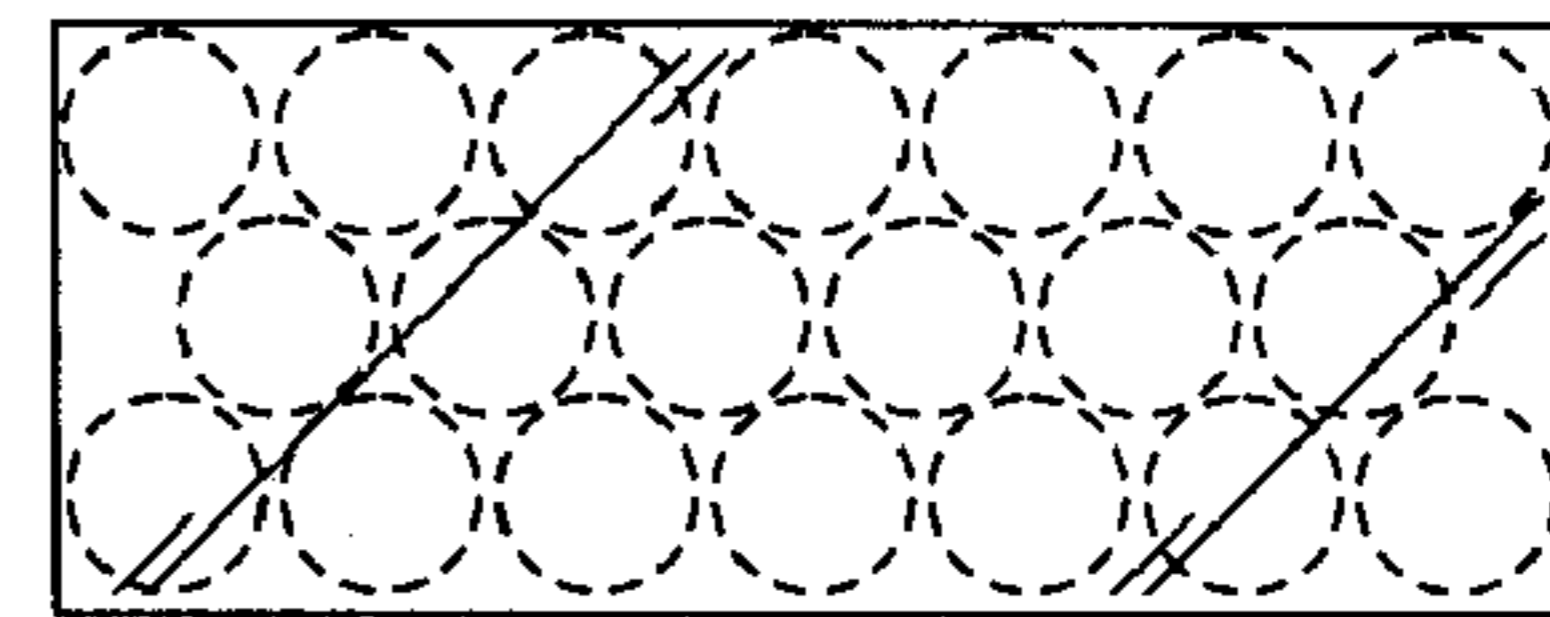
