The ornamental design for a container cover, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a container cover showing our new design.

FIG. 2 is a top plan view of the first embodiment of the container cover of FIG. 1.

FIG. 3 is a bottom plan view of the first embodiment of the container cover of FIG. 1.

FIG. 4 is a left elevation view of the first embodiment of the container cover of FIG. 1.

FIG. 5 is a right elevation view of the first embodiment of the container cover of FIG. 1.

FIG. 6 is a back elevation view of the first embodiment of the container cover of FIG. 1.

FIG. 7 is a front elevation view of the first embodiment of the container cover of FIG. 1.


FIG. 8 is a perspective view of a second embodiment of a container cover.



















