The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the first embodiment of the bottle showing my new design, which is identical in all respects to the second embodiment except for the transparency of the cap;

FIG. 2 is a perspective view showing the second embodiment of my bottle design, the cap being opaque;

FIG. 3 is a front view of the second embodiment;

FIG. 4 is an exploded perspective view of the second embodiment;

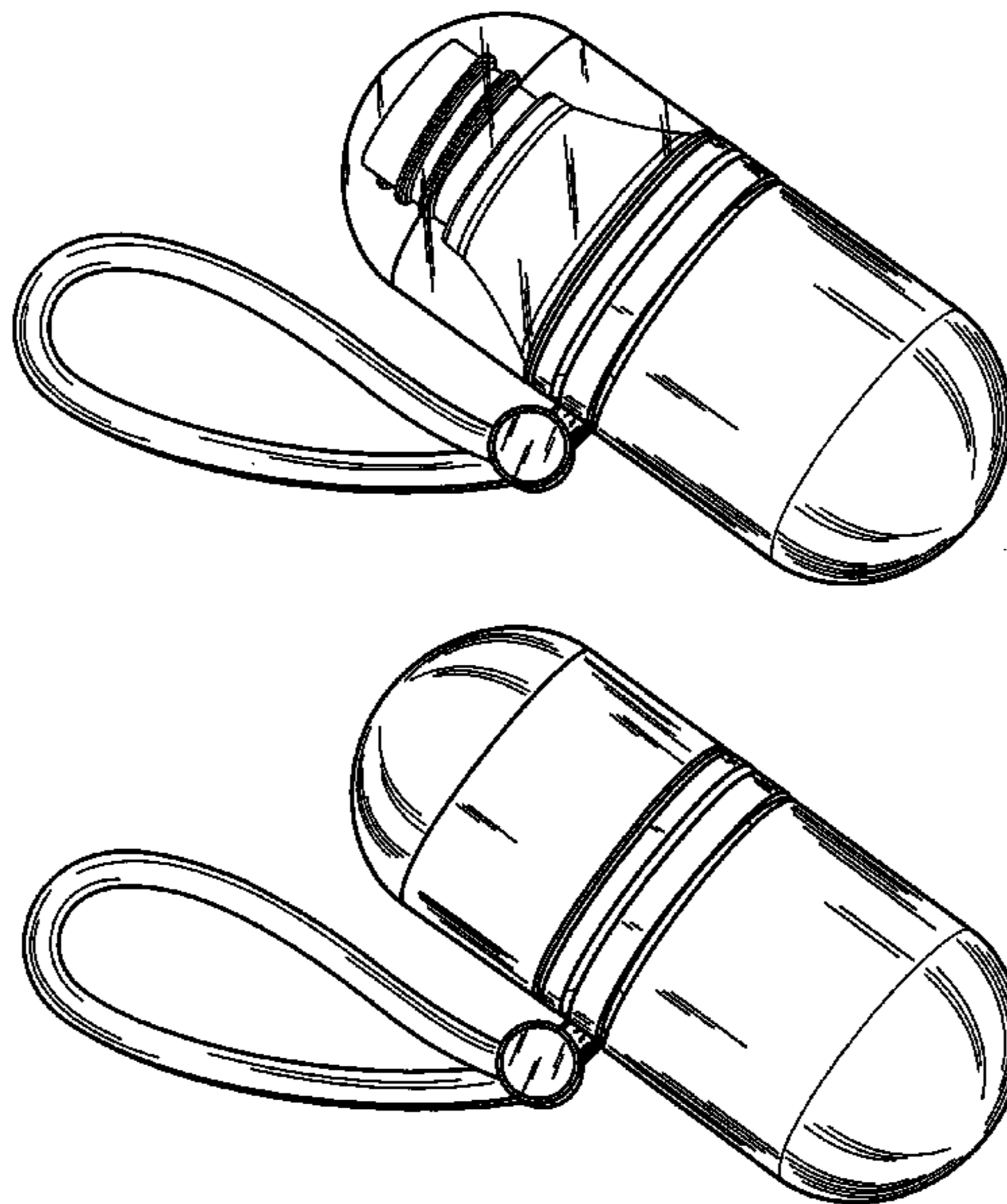
FIG. 5 is a top view of the second embodiment; and,

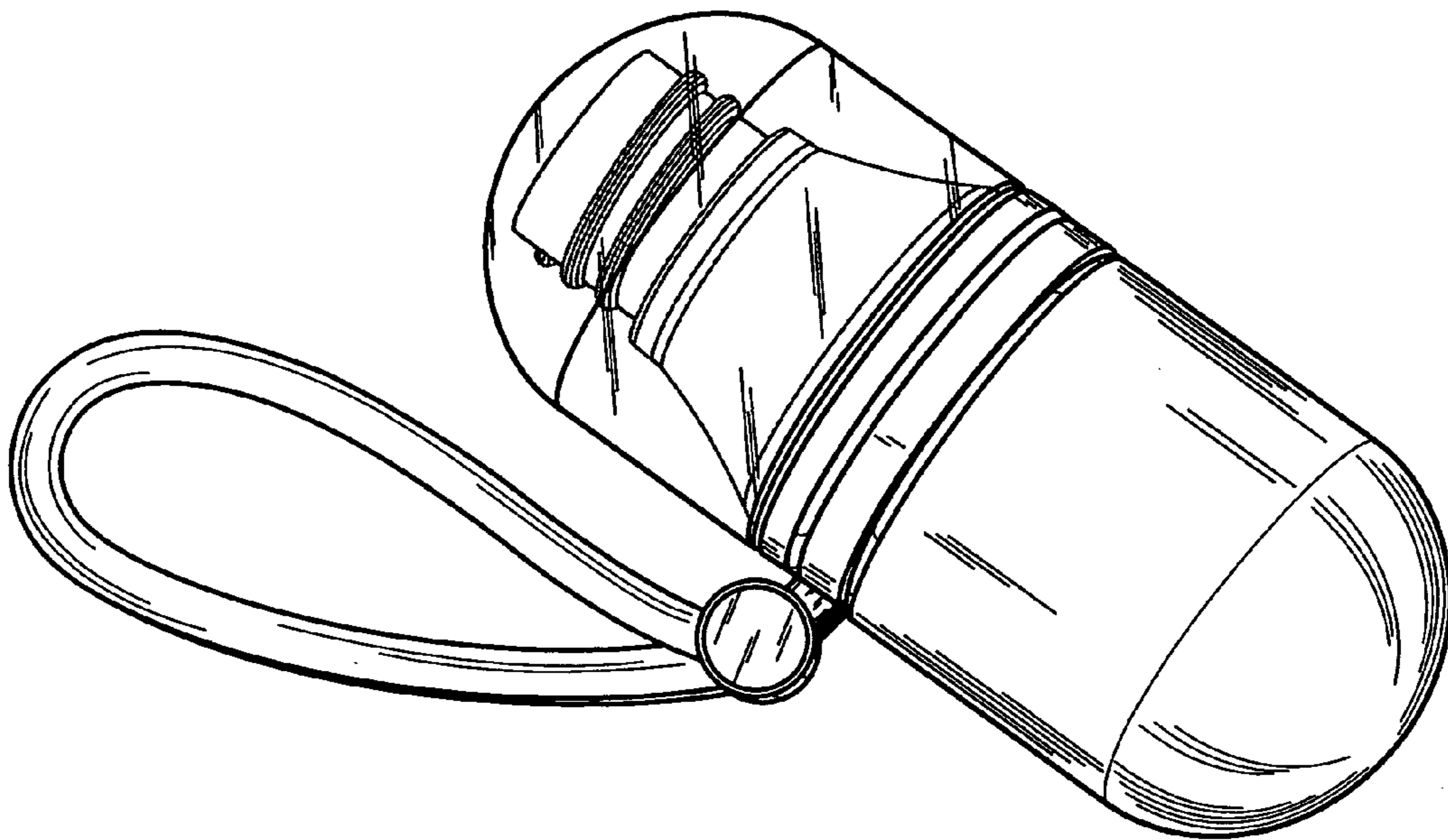

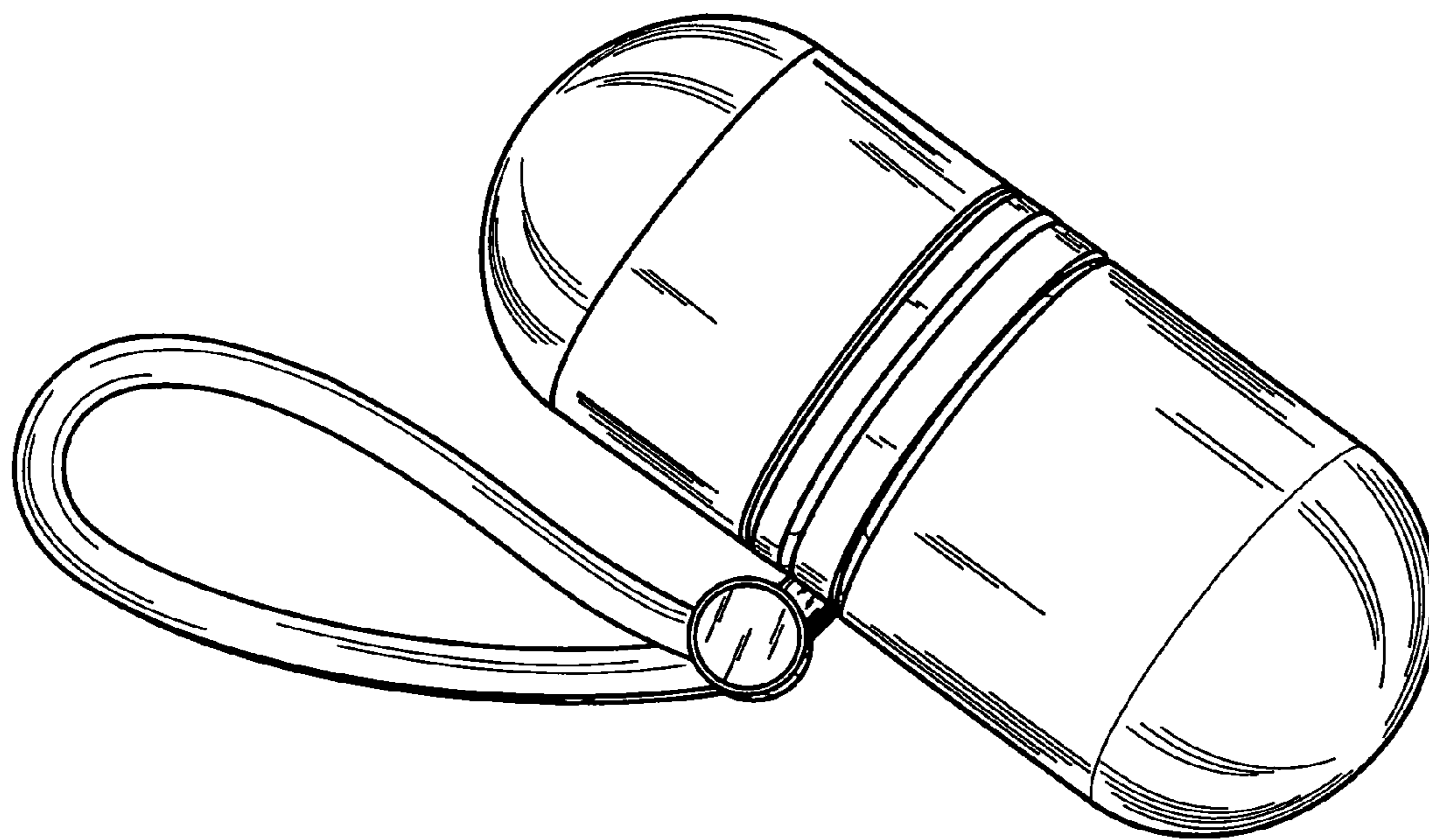

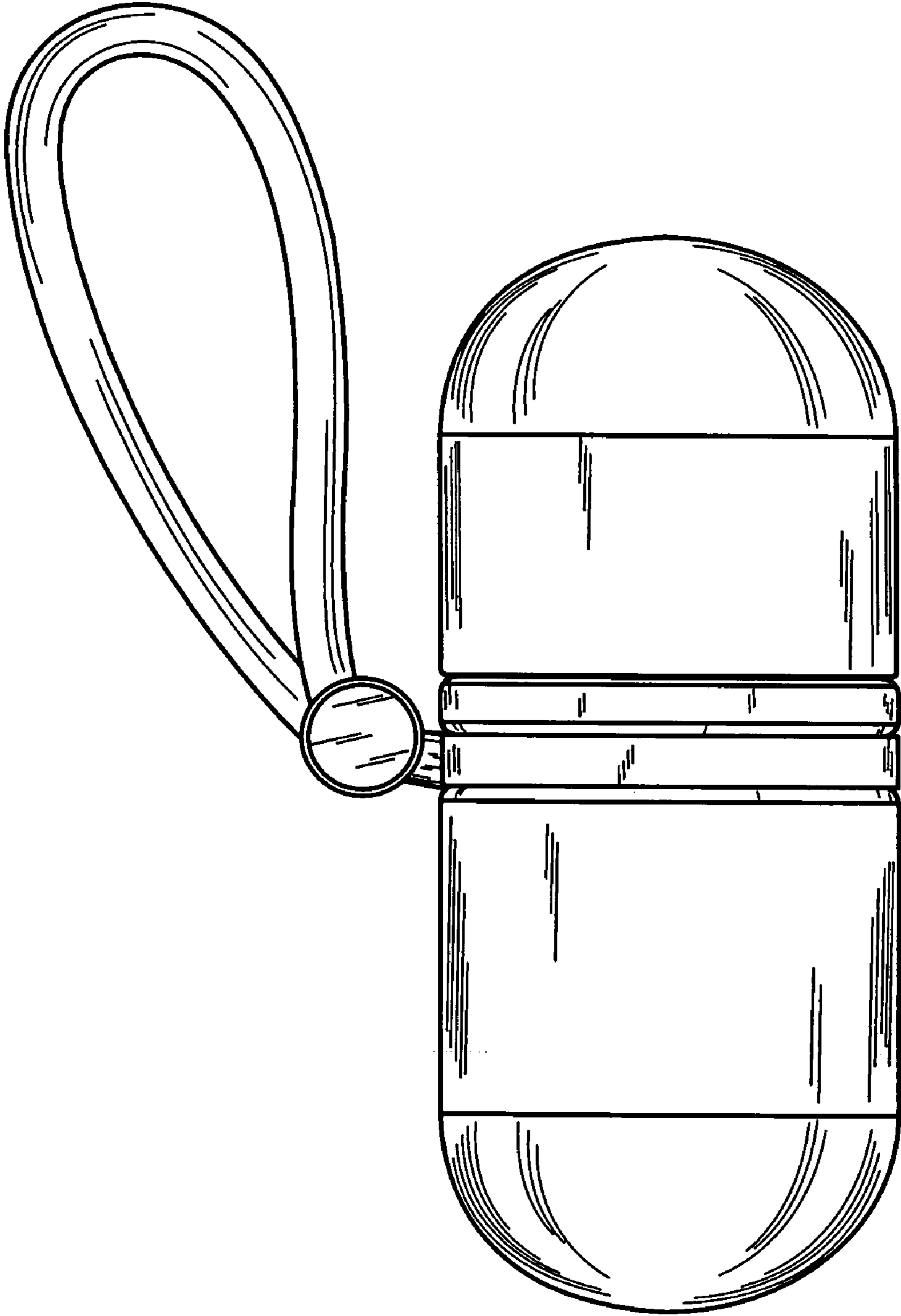

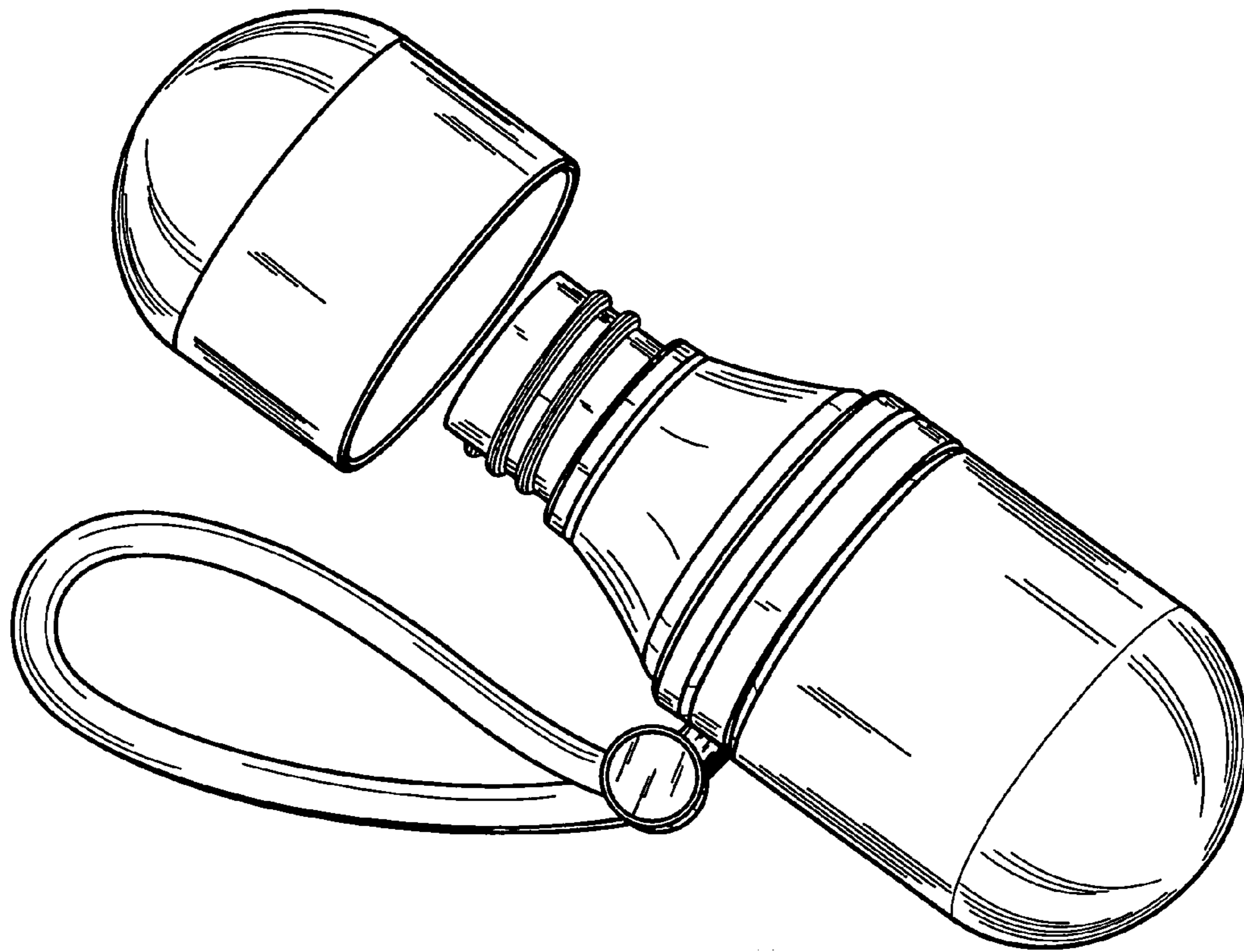

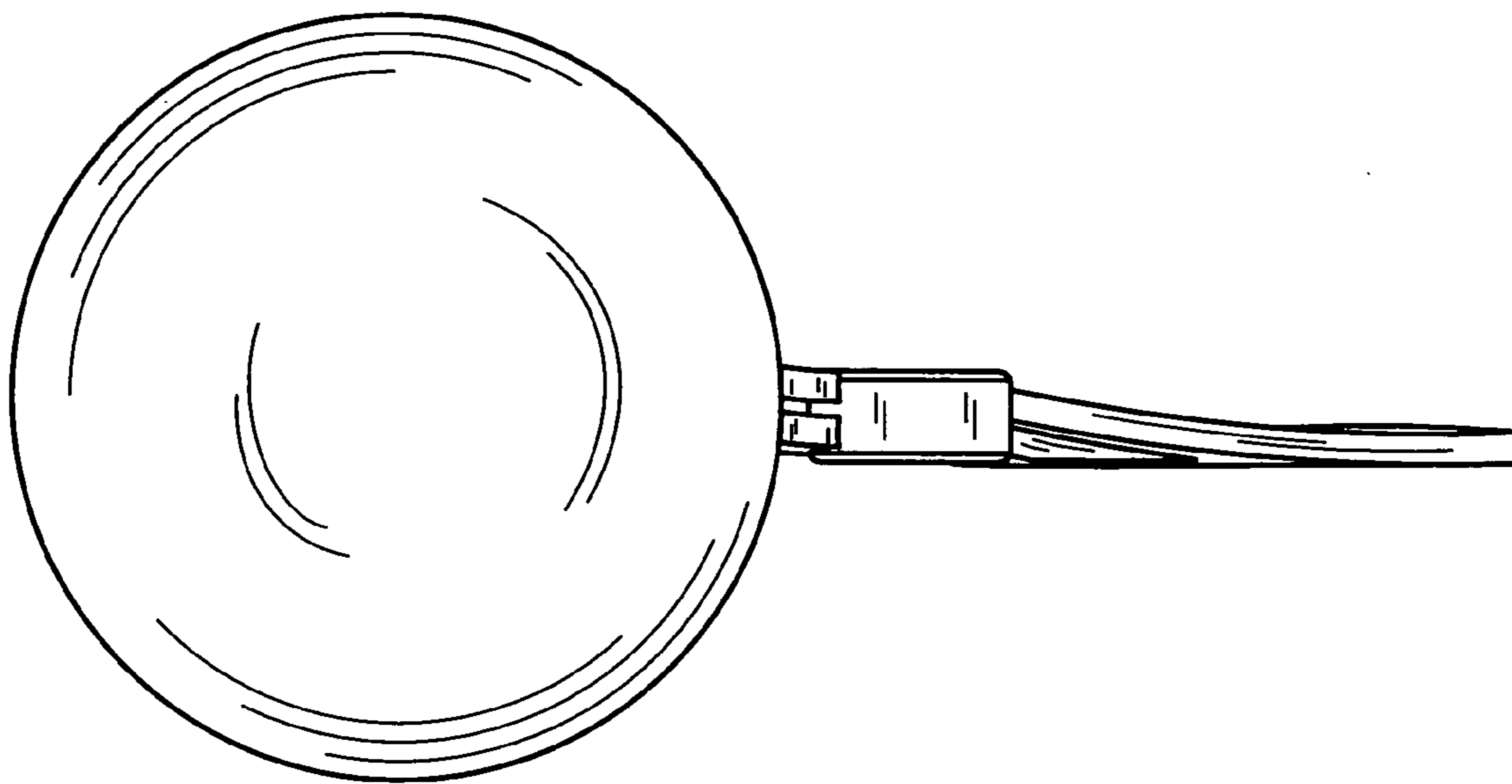

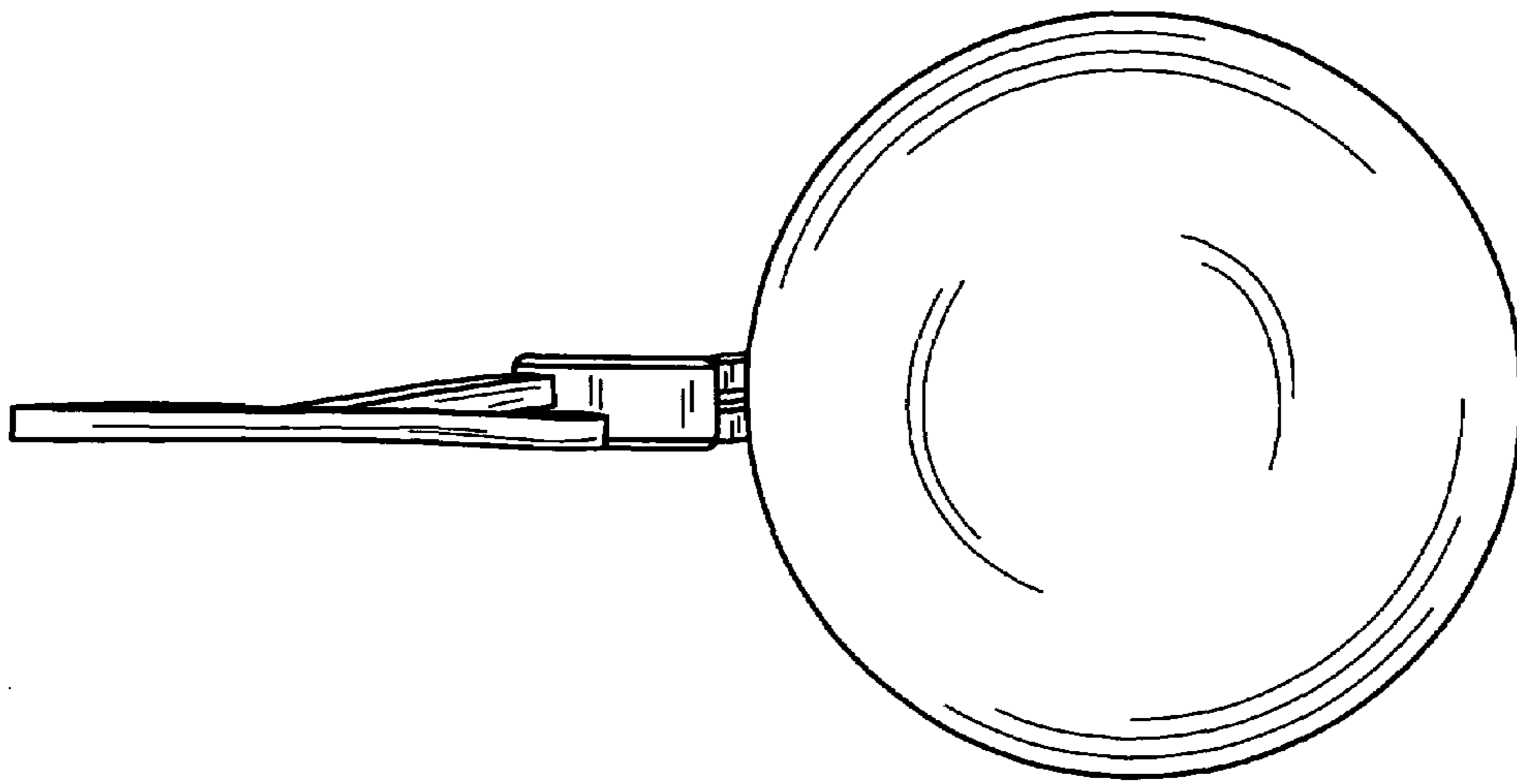
