DESCRIPTION

FIG. 1 is a front elevational view of a front fender for a
motorcycle showing my new design;

FIG. 4 is a right side elevational view thereof;

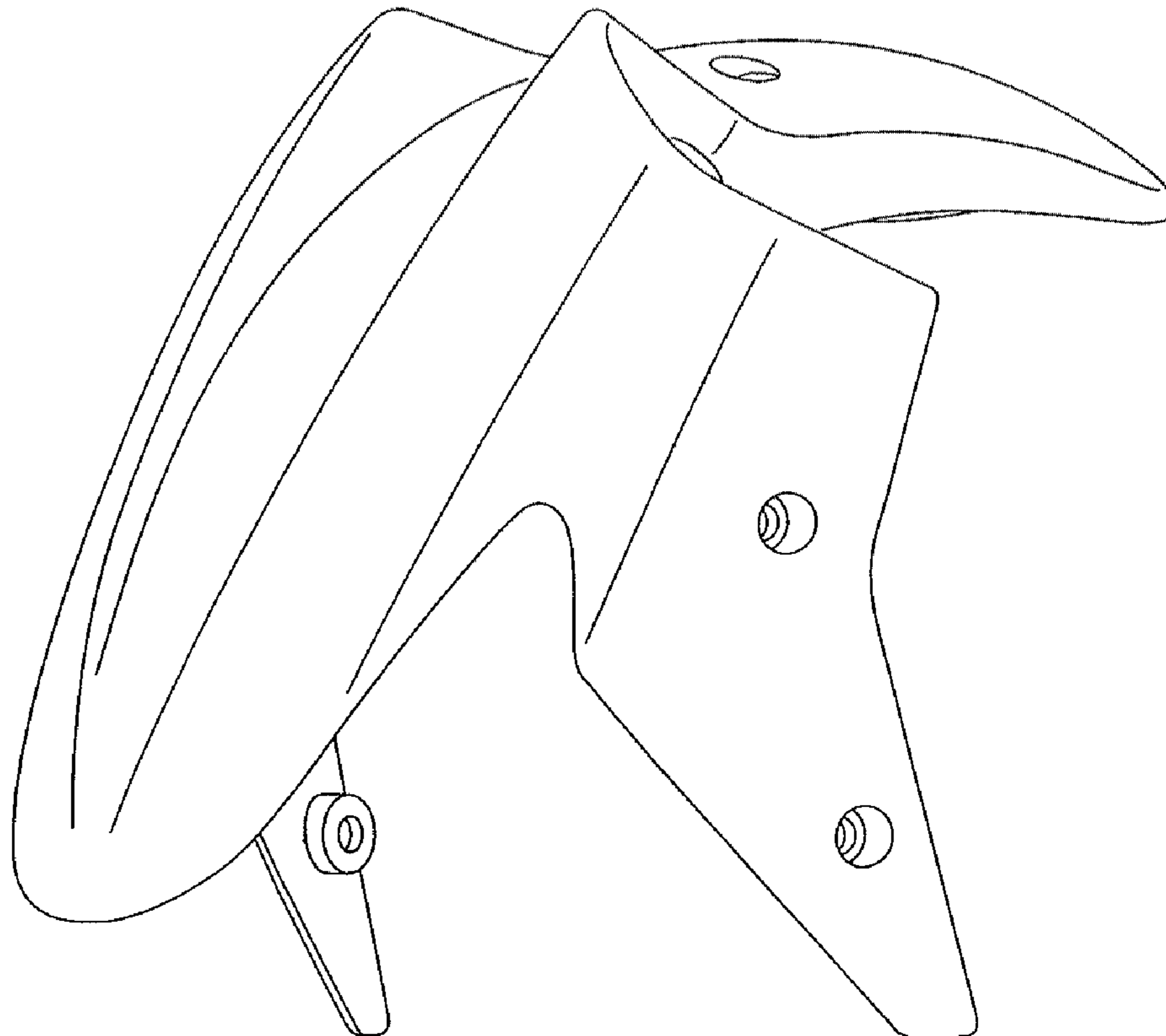

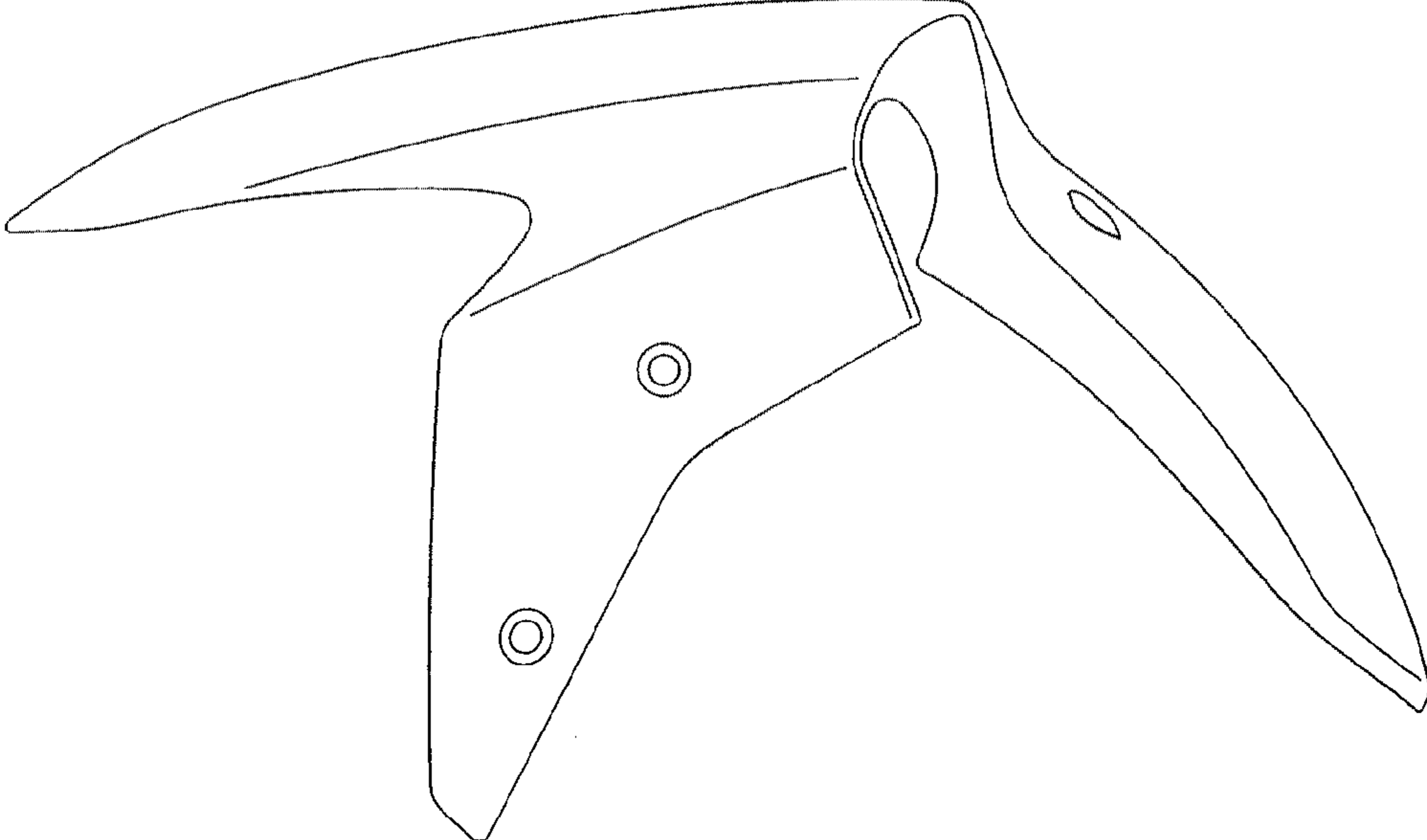

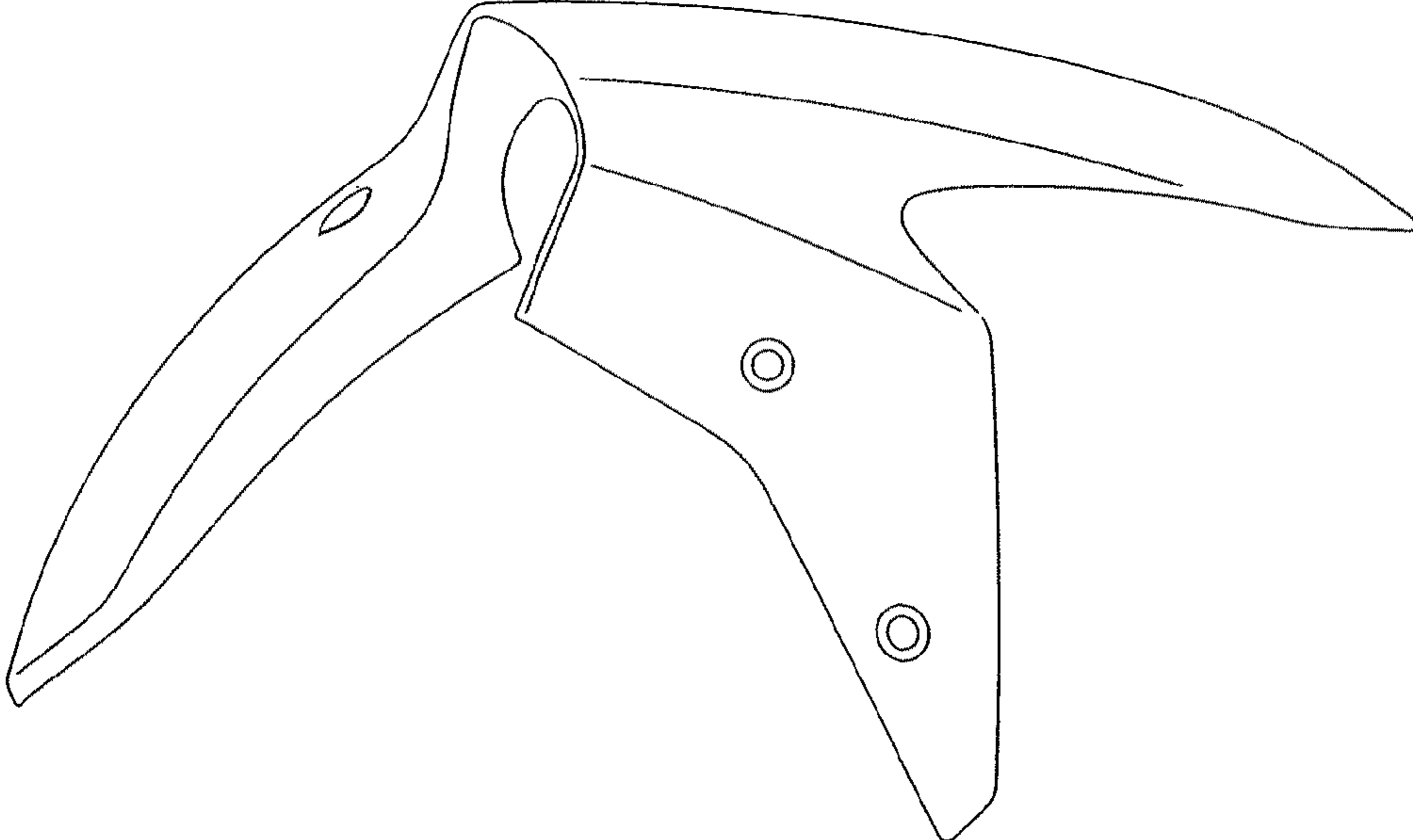

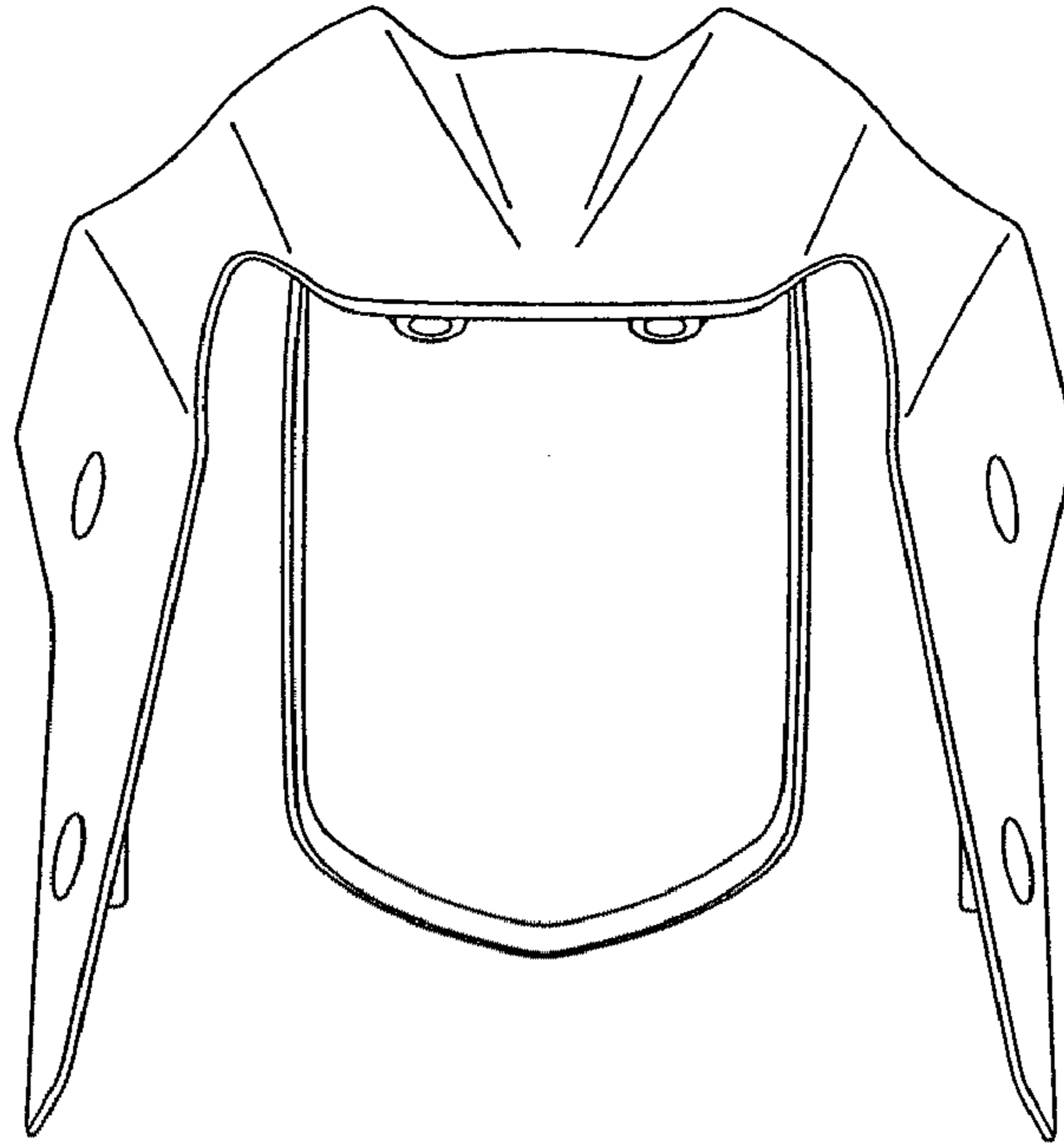

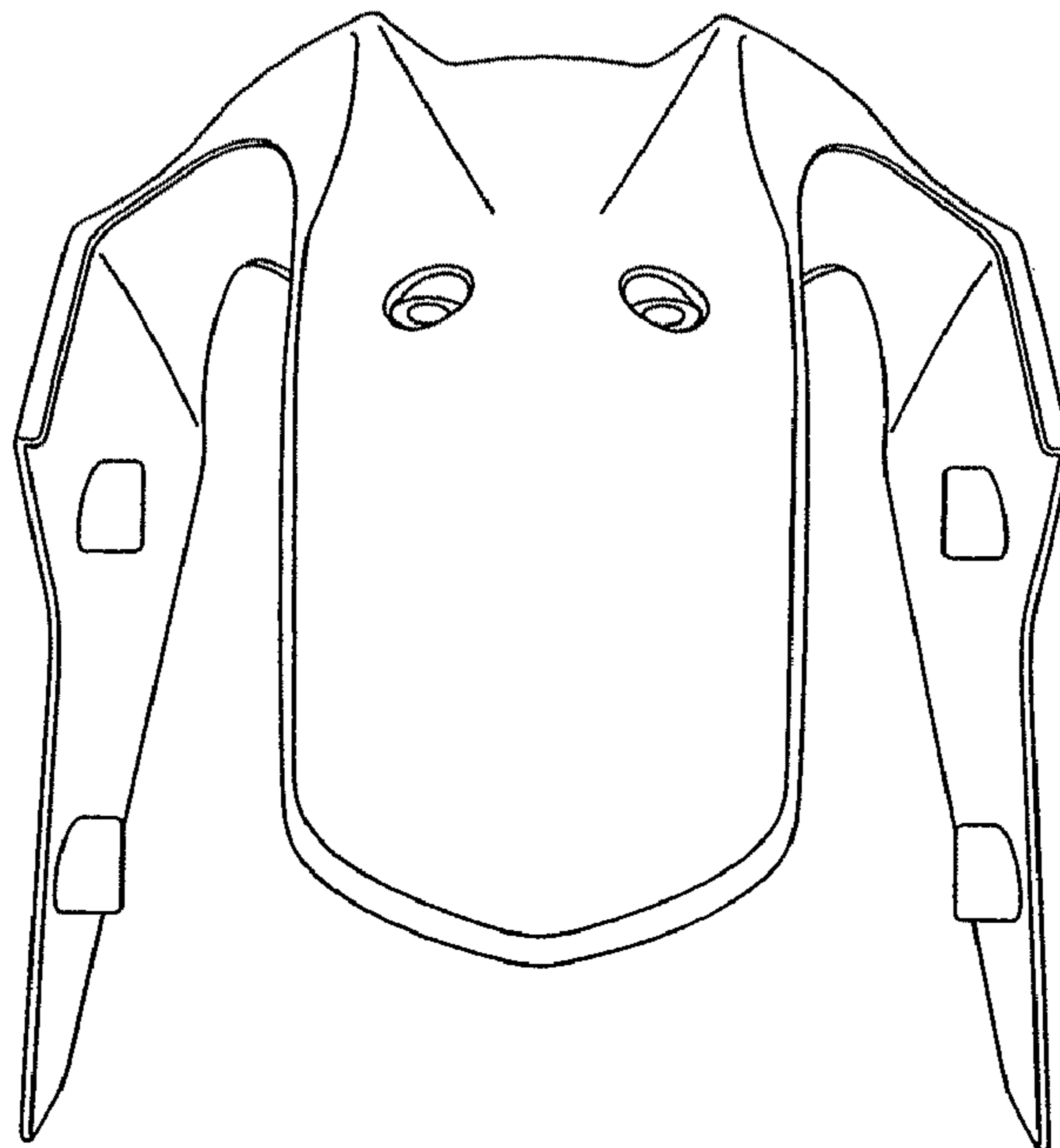

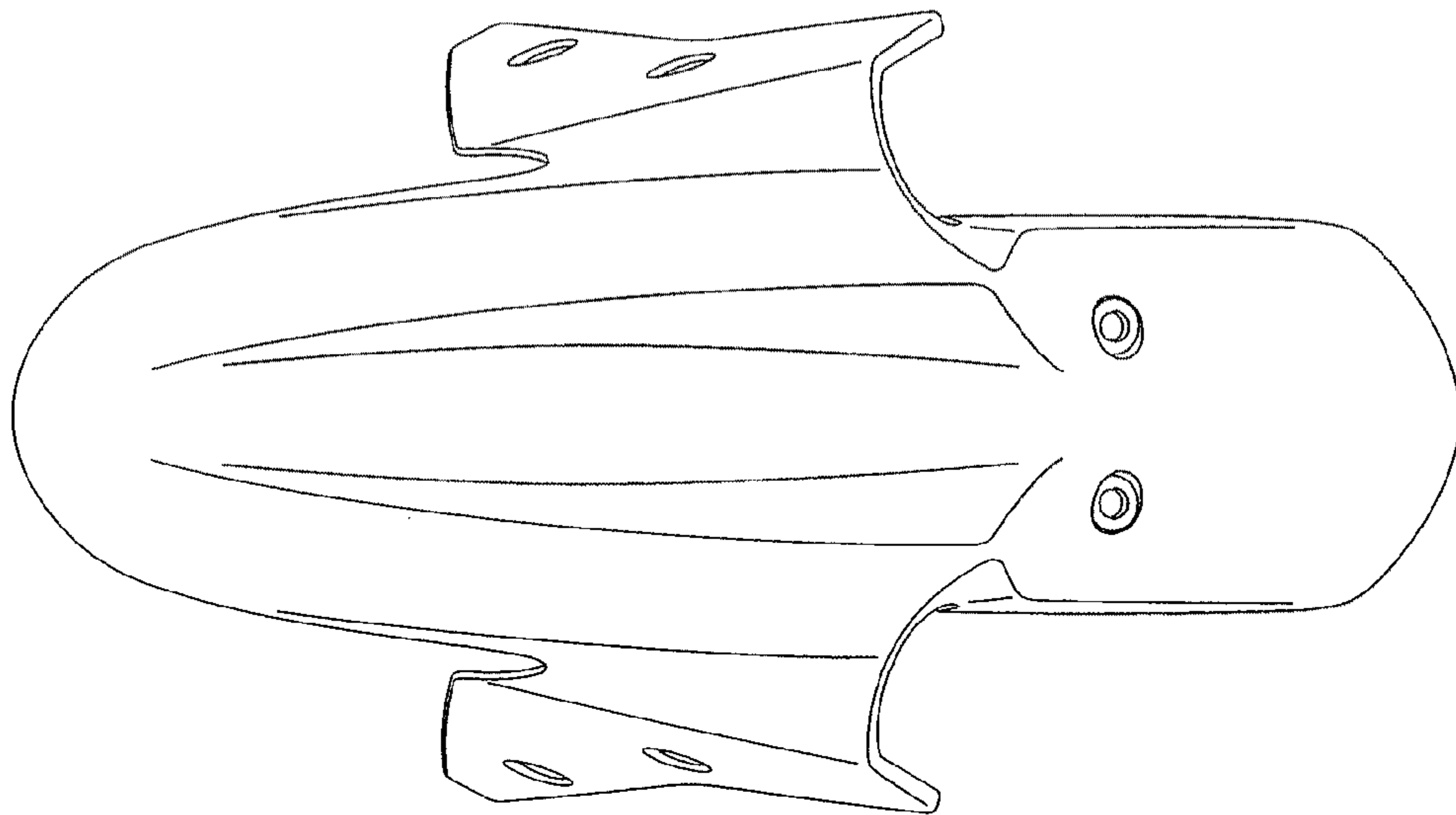

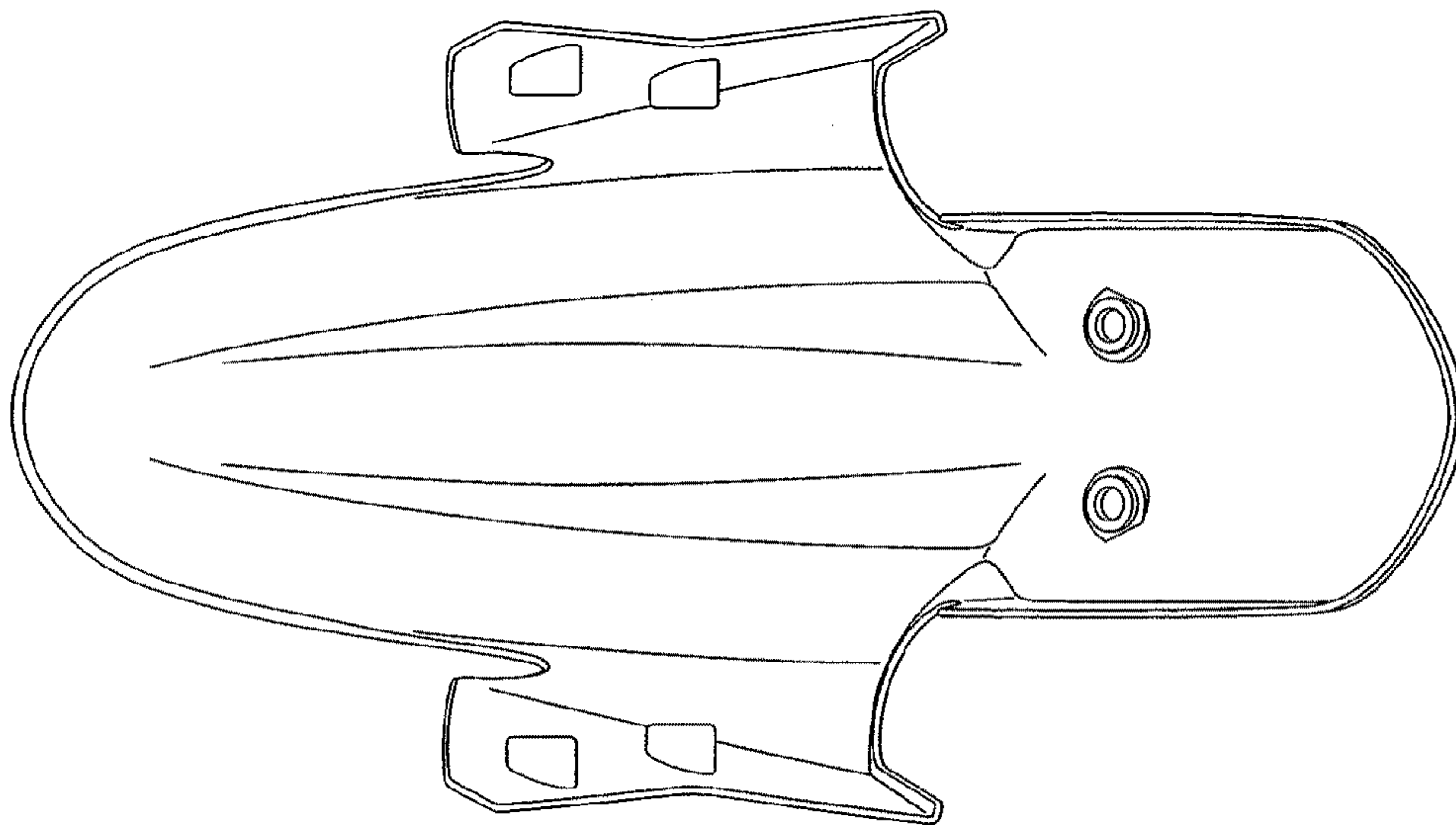

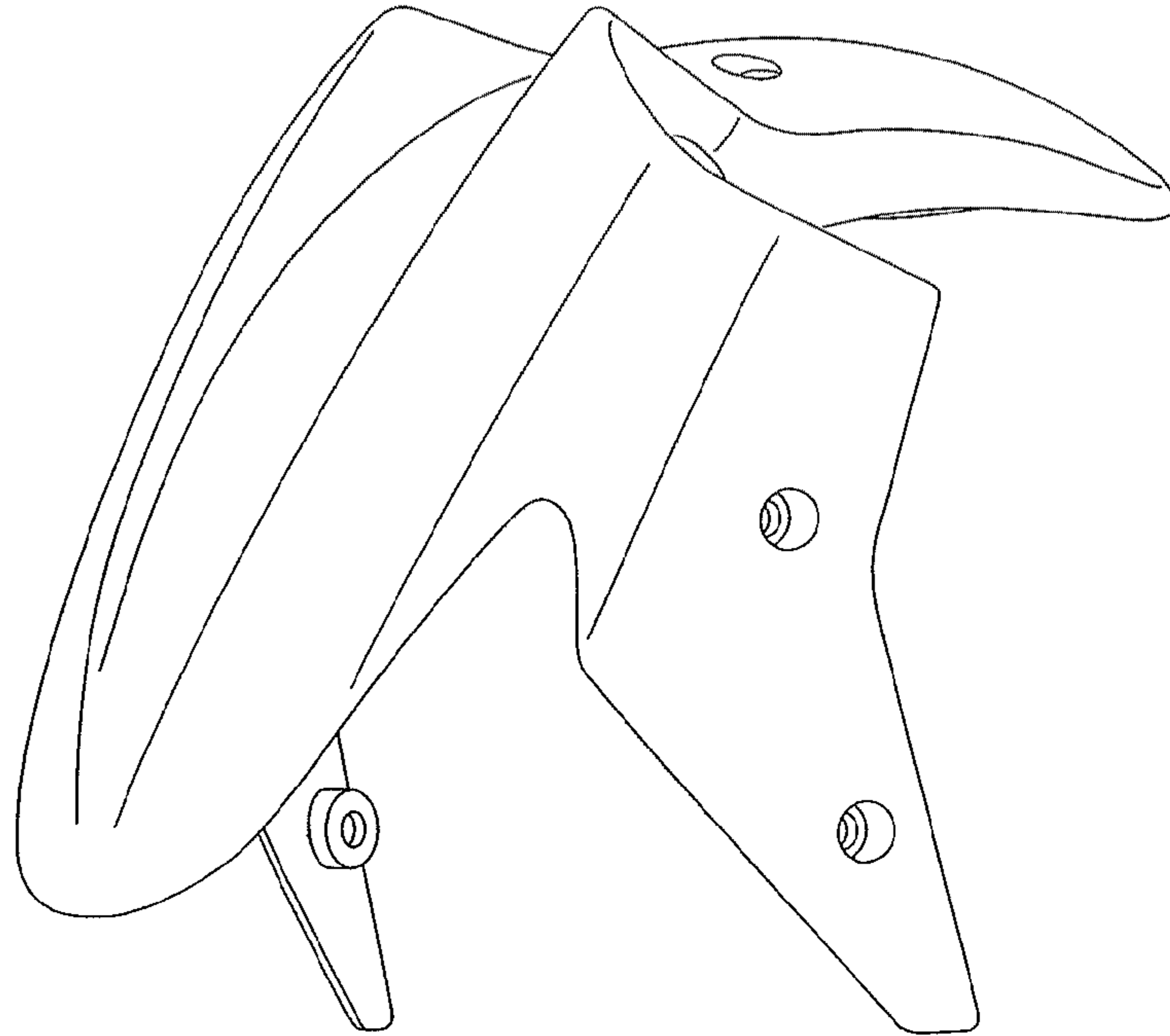
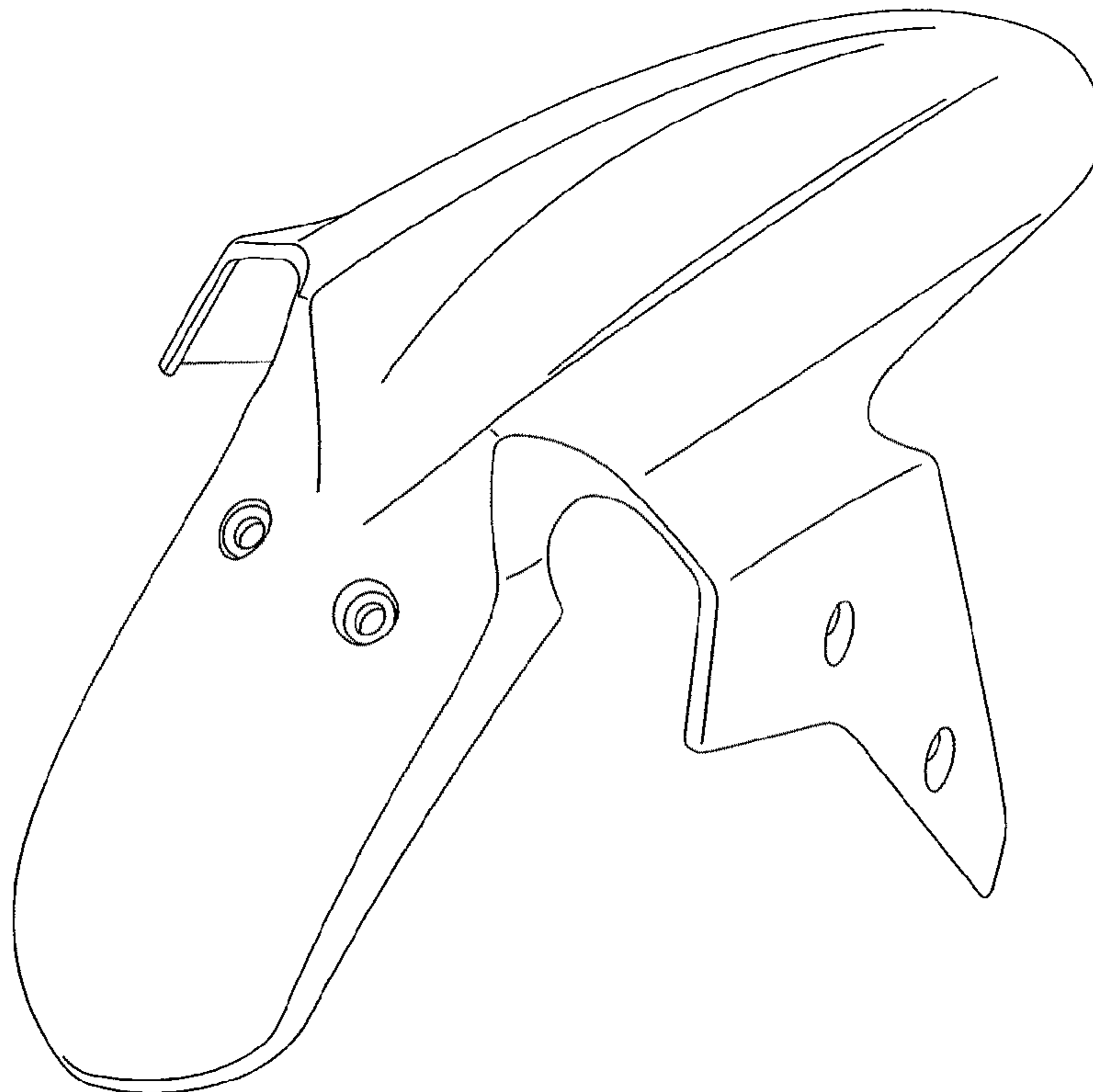
