The ornamental design for a air vent for a vehicle, as shown and described.

DESCRIPTION

This application is related to the following co-pending applications, of the inventor, filed on even date herewith: Application Ser. FIG. 1 is a perspective view of a first embodiment of a air vent for a vehicle according to my novel design; and

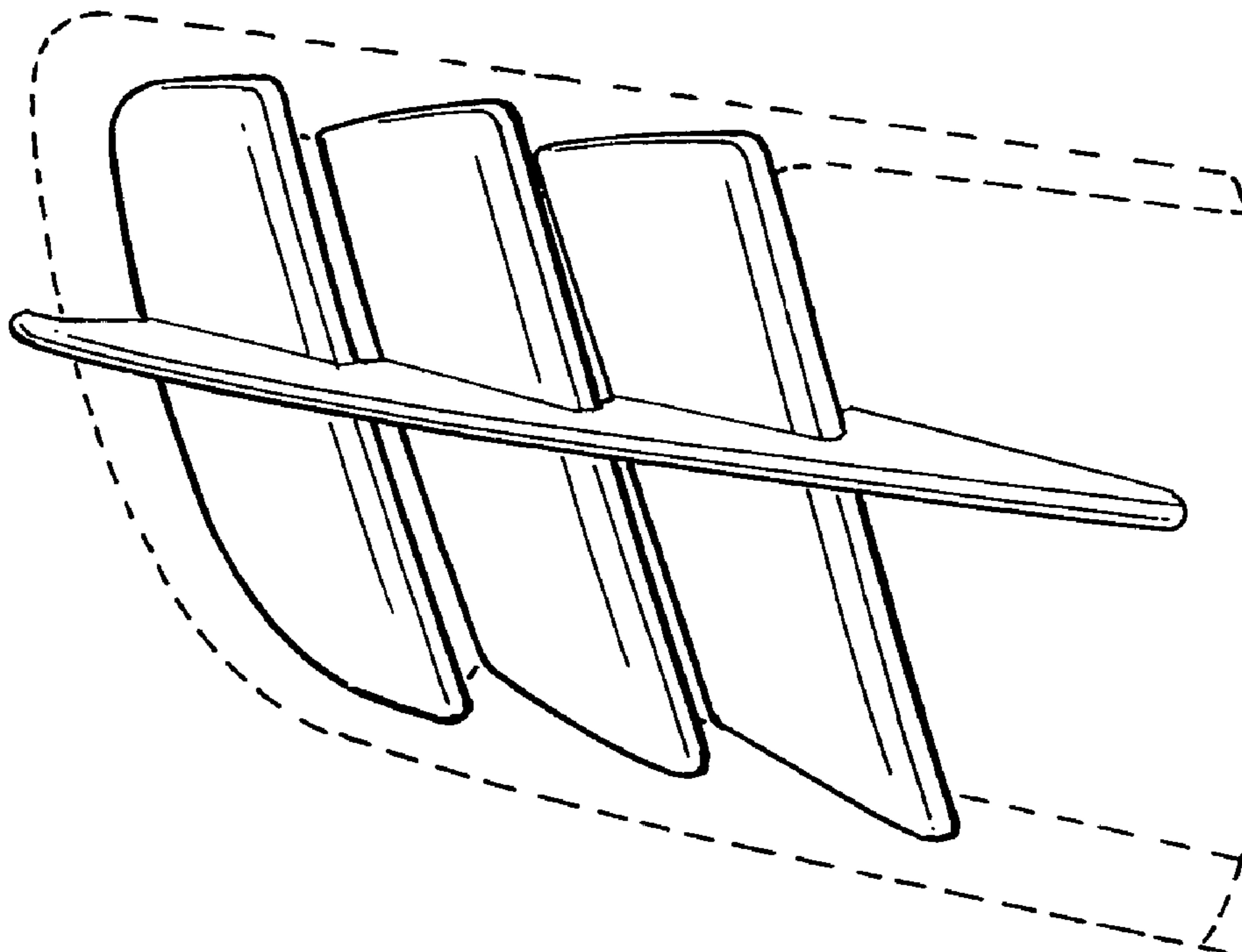
FIG. 2 is a front view thereof.

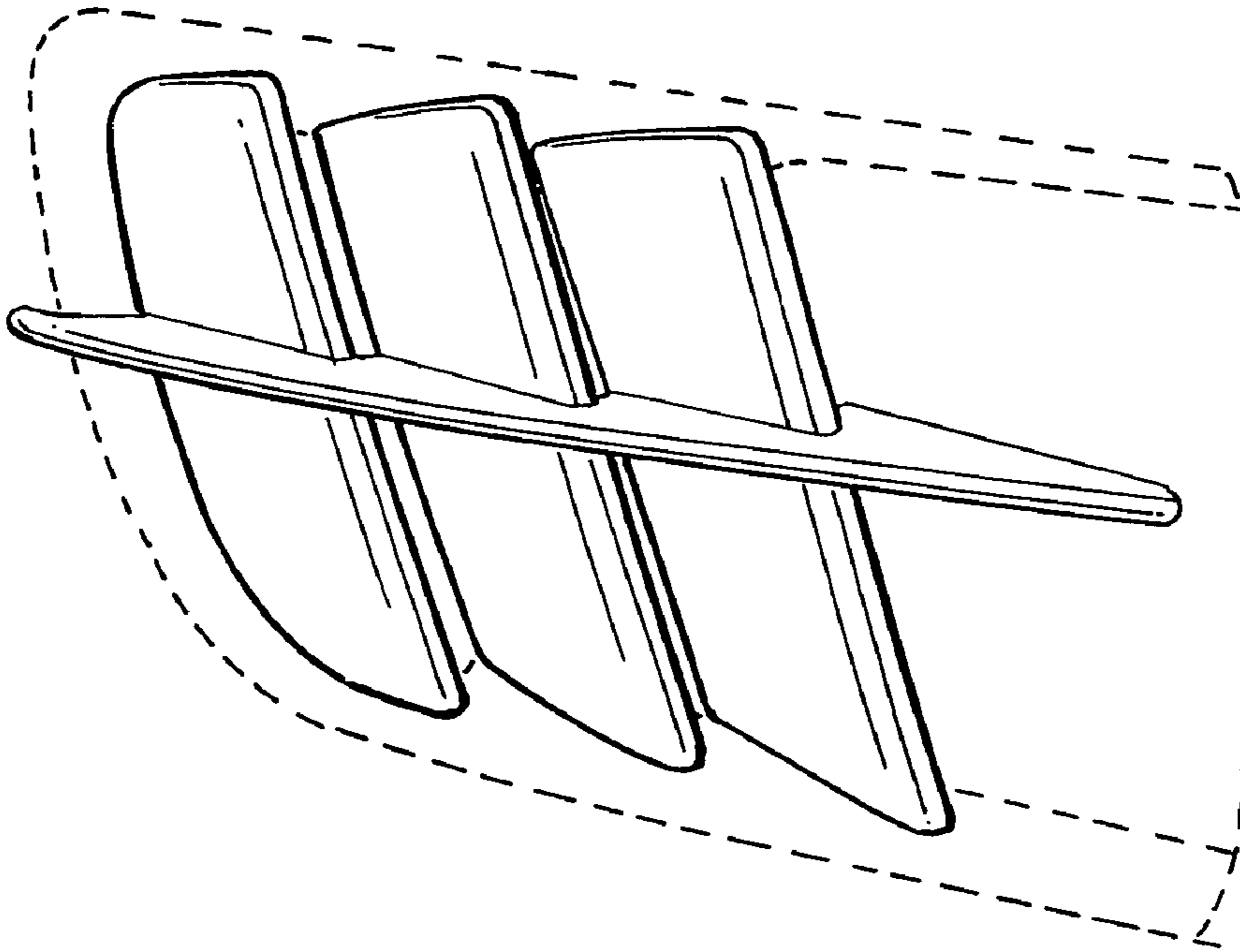

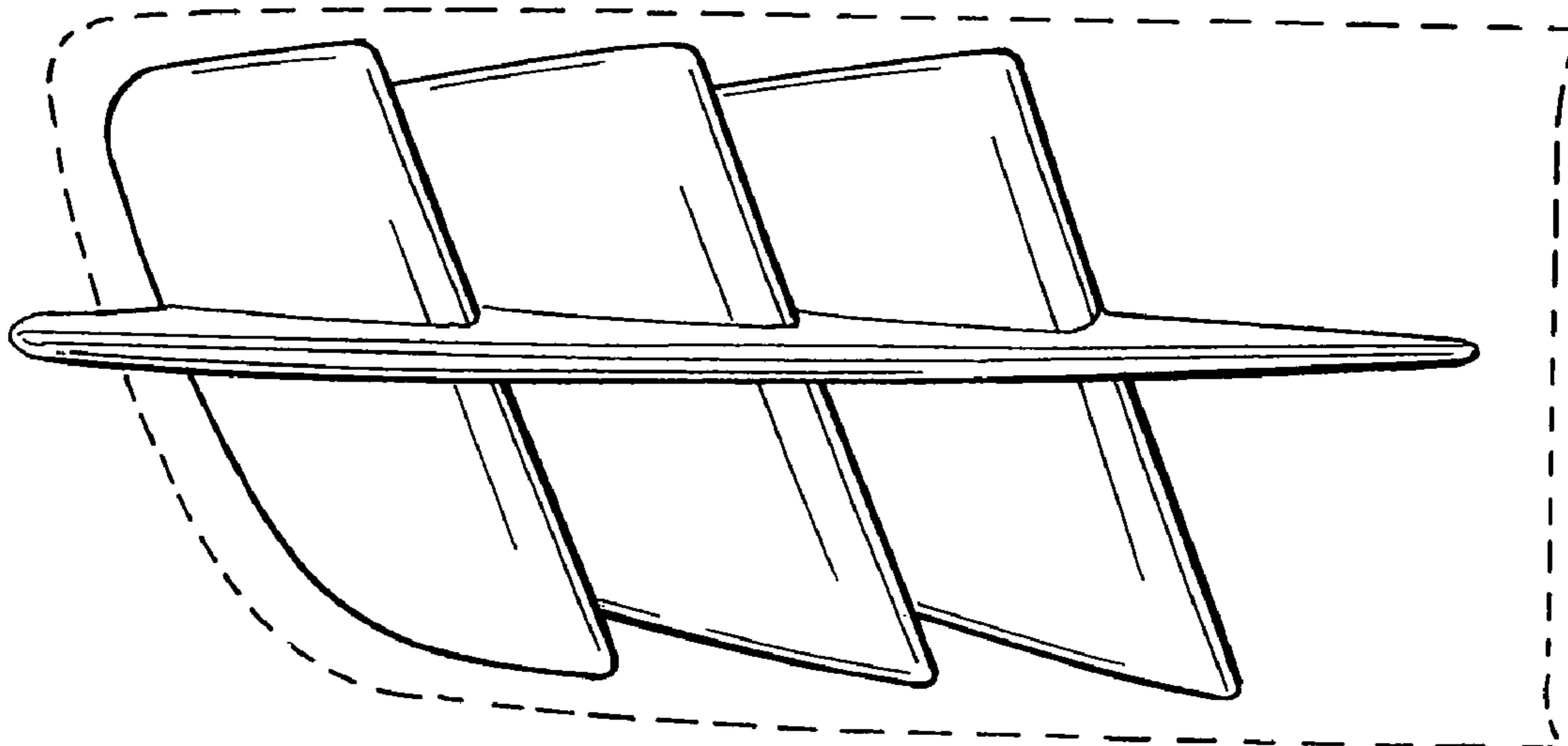

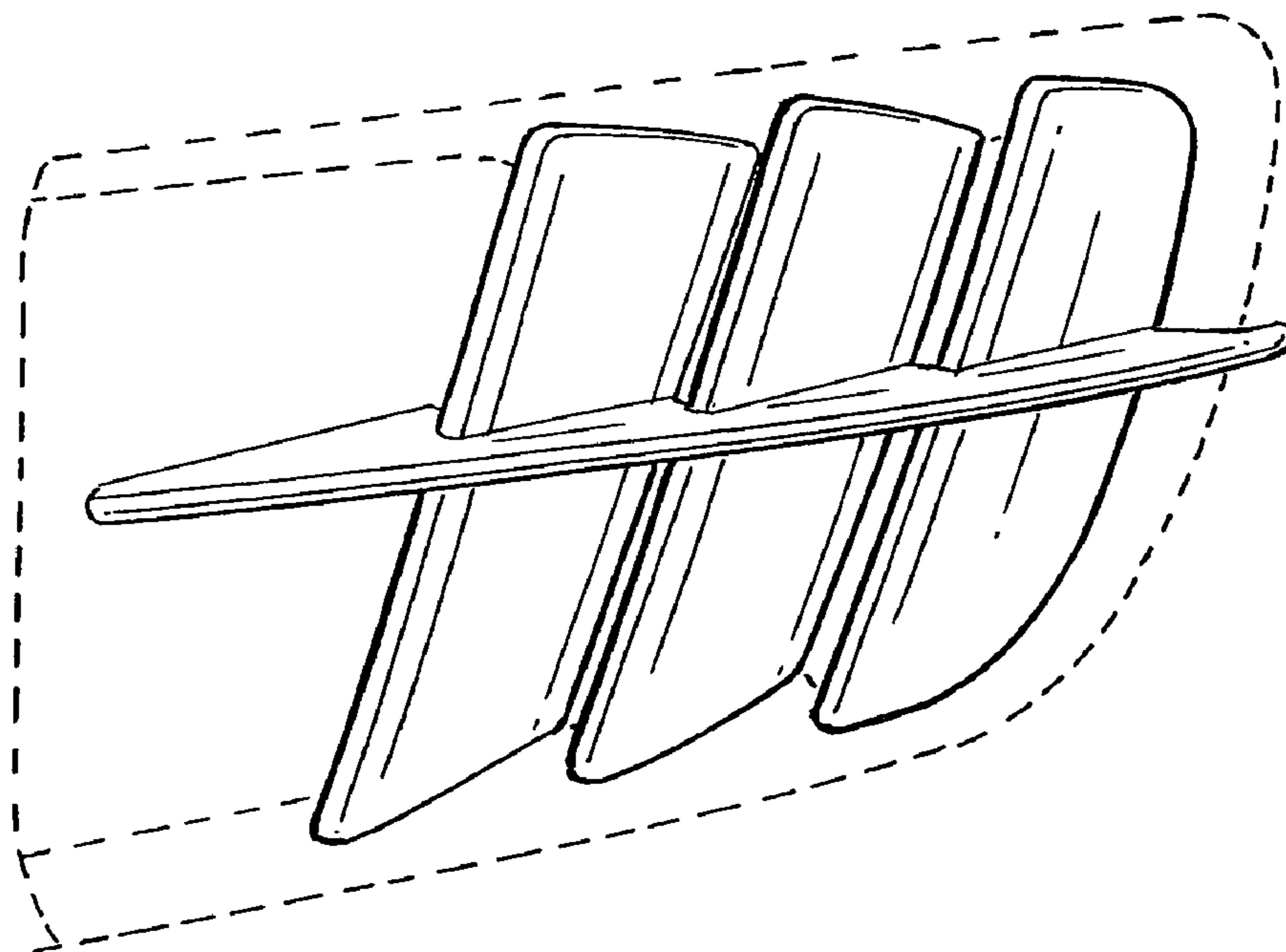

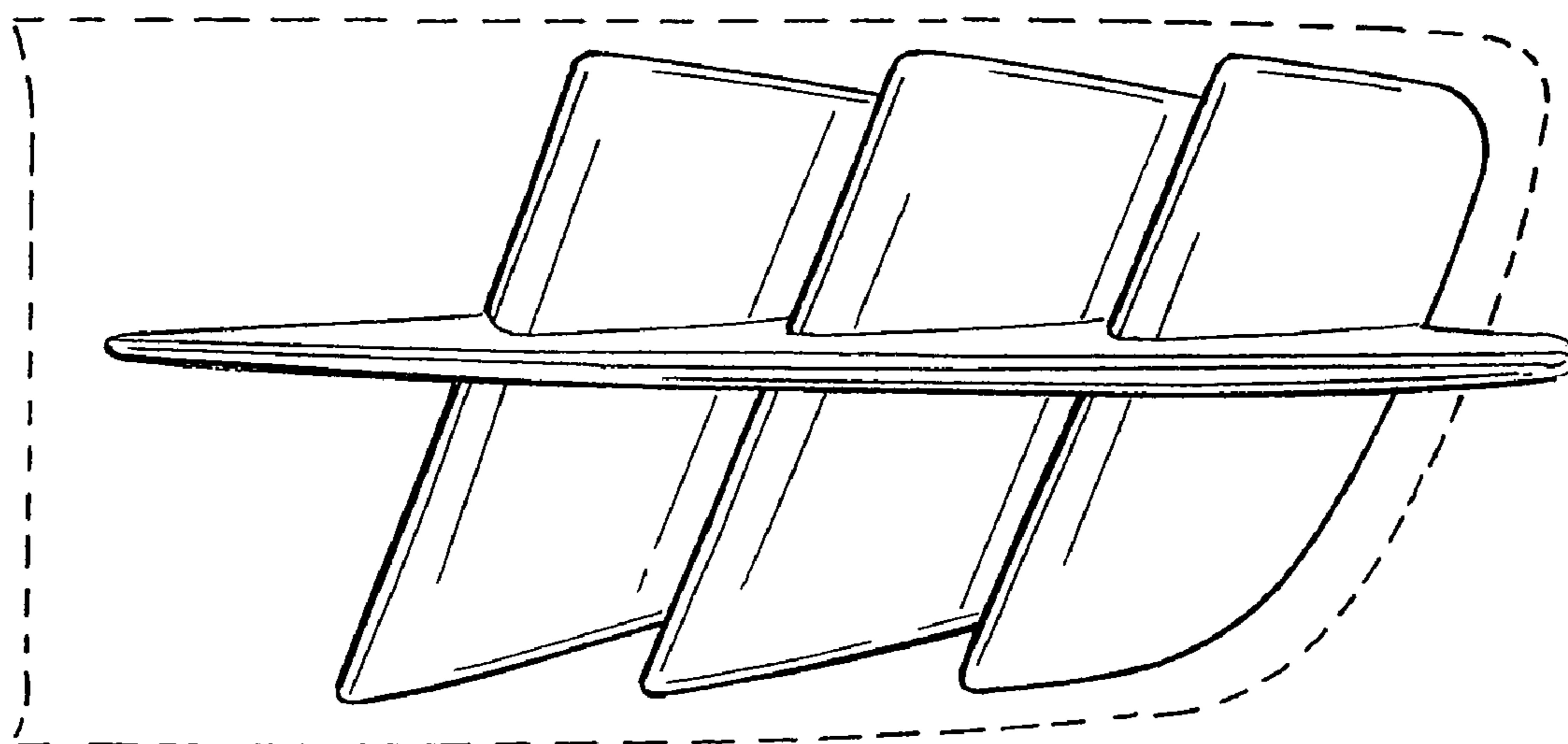
