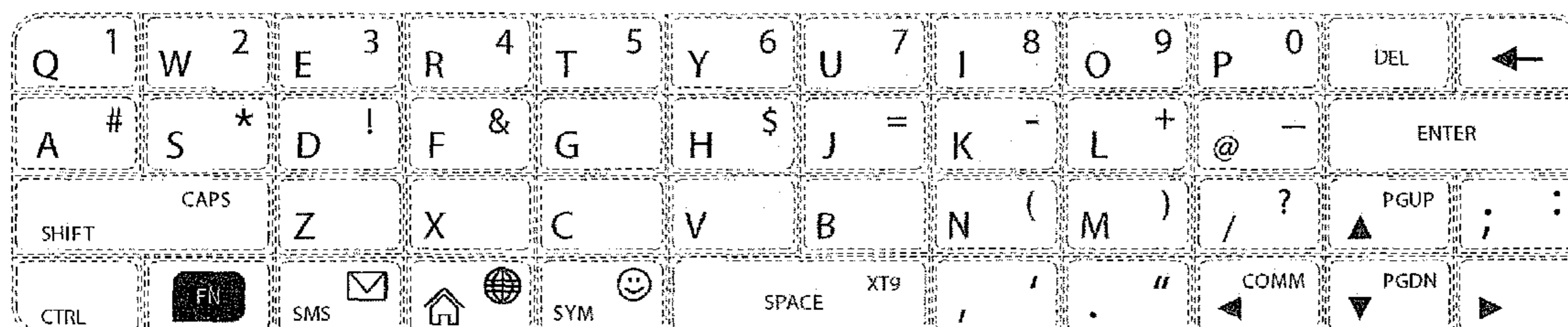
The ornamental design for a keyboard, as shown and described.

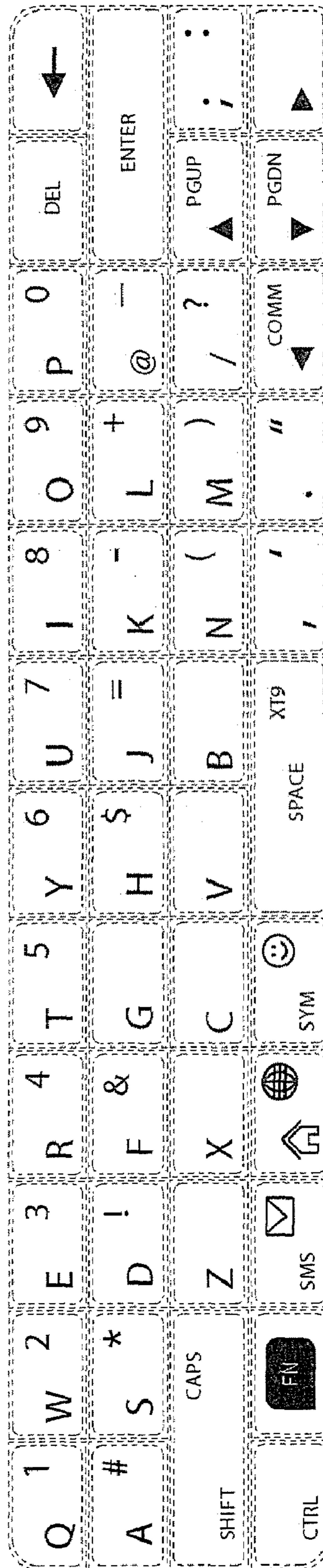
DESCRIPTION
