(57) **CLAIM**

The ornamental design for a video image display for a portable phone, as shown and described.

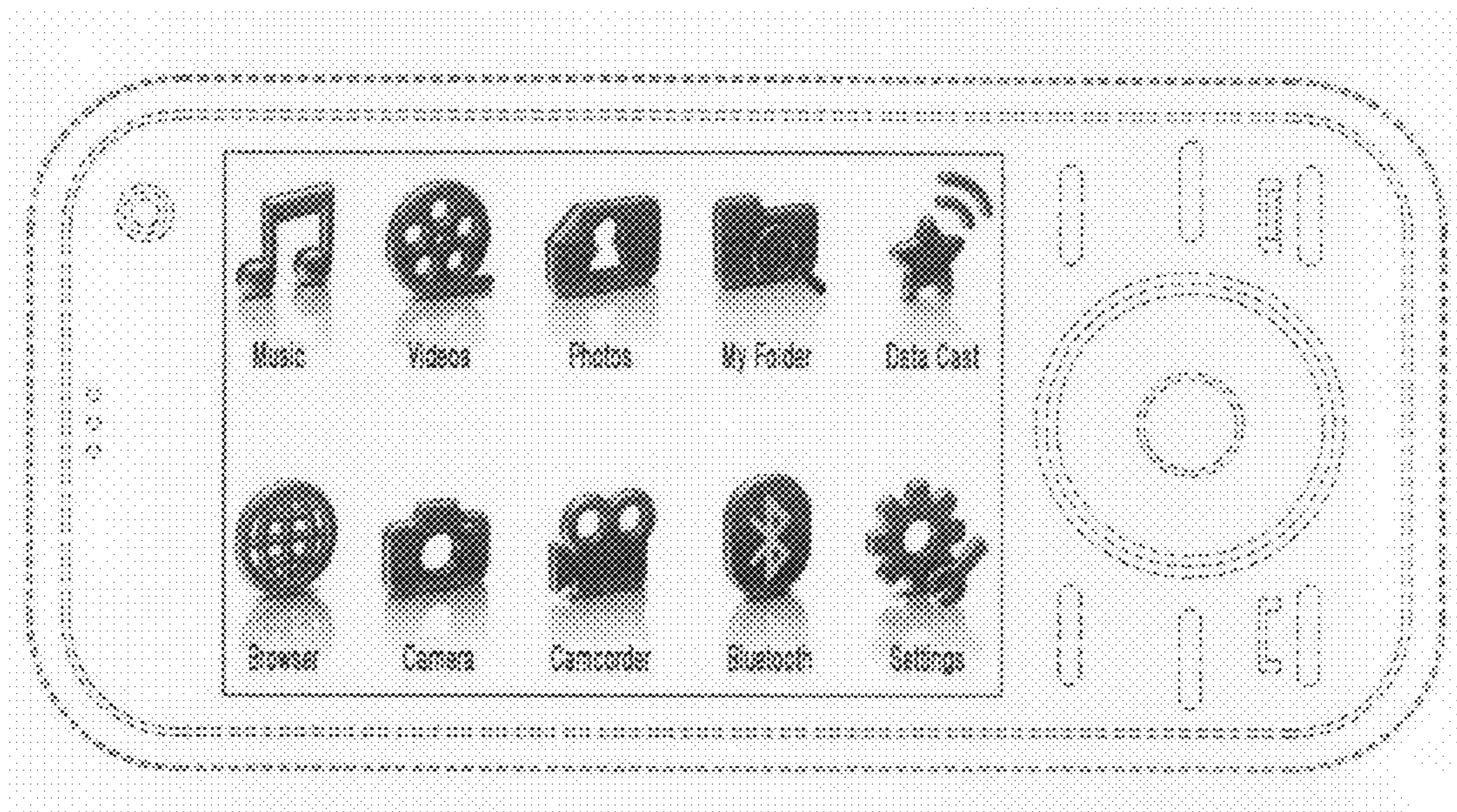

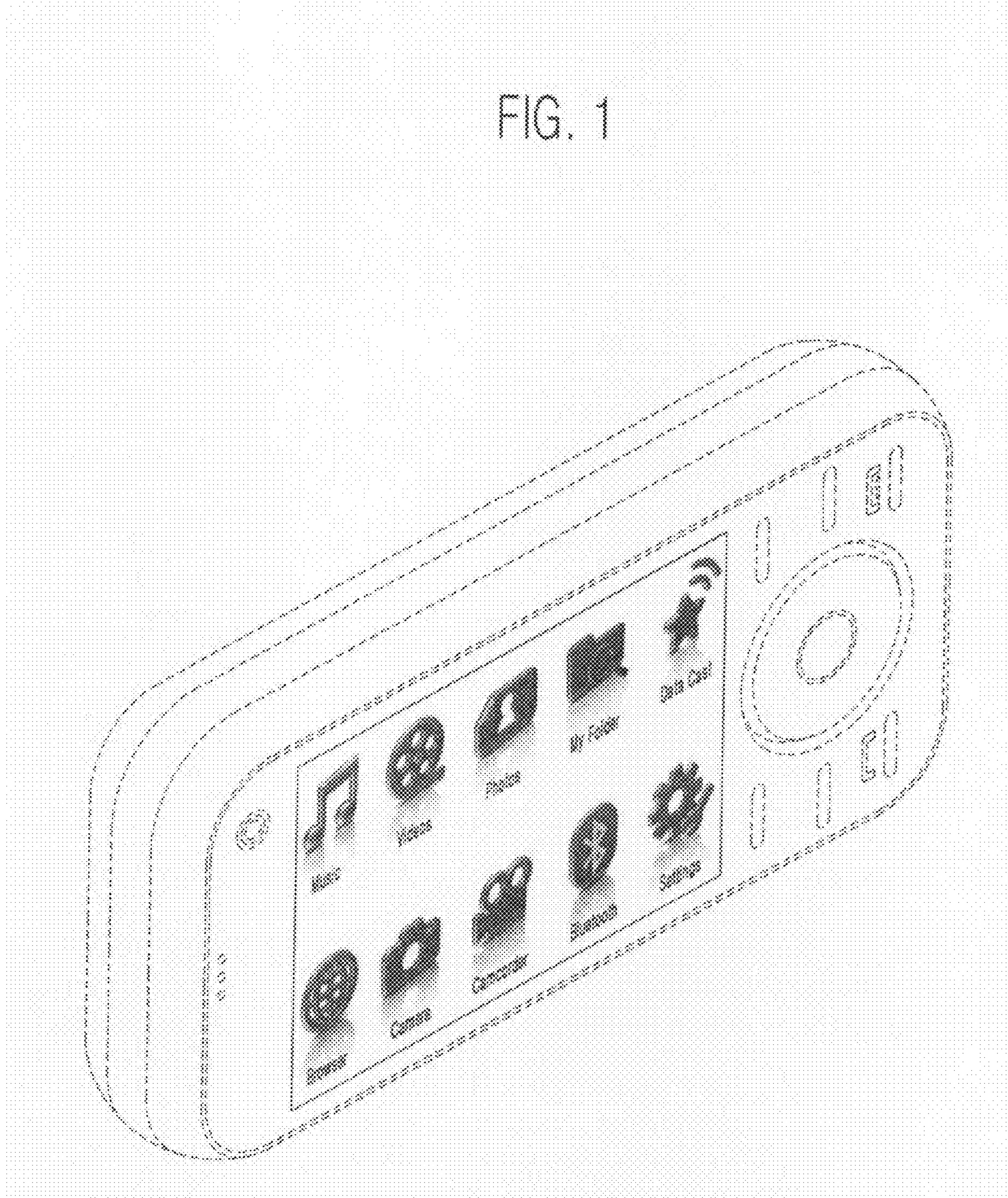
