FIG. 1 is a top plan view of a therapeutic device showing our new design;

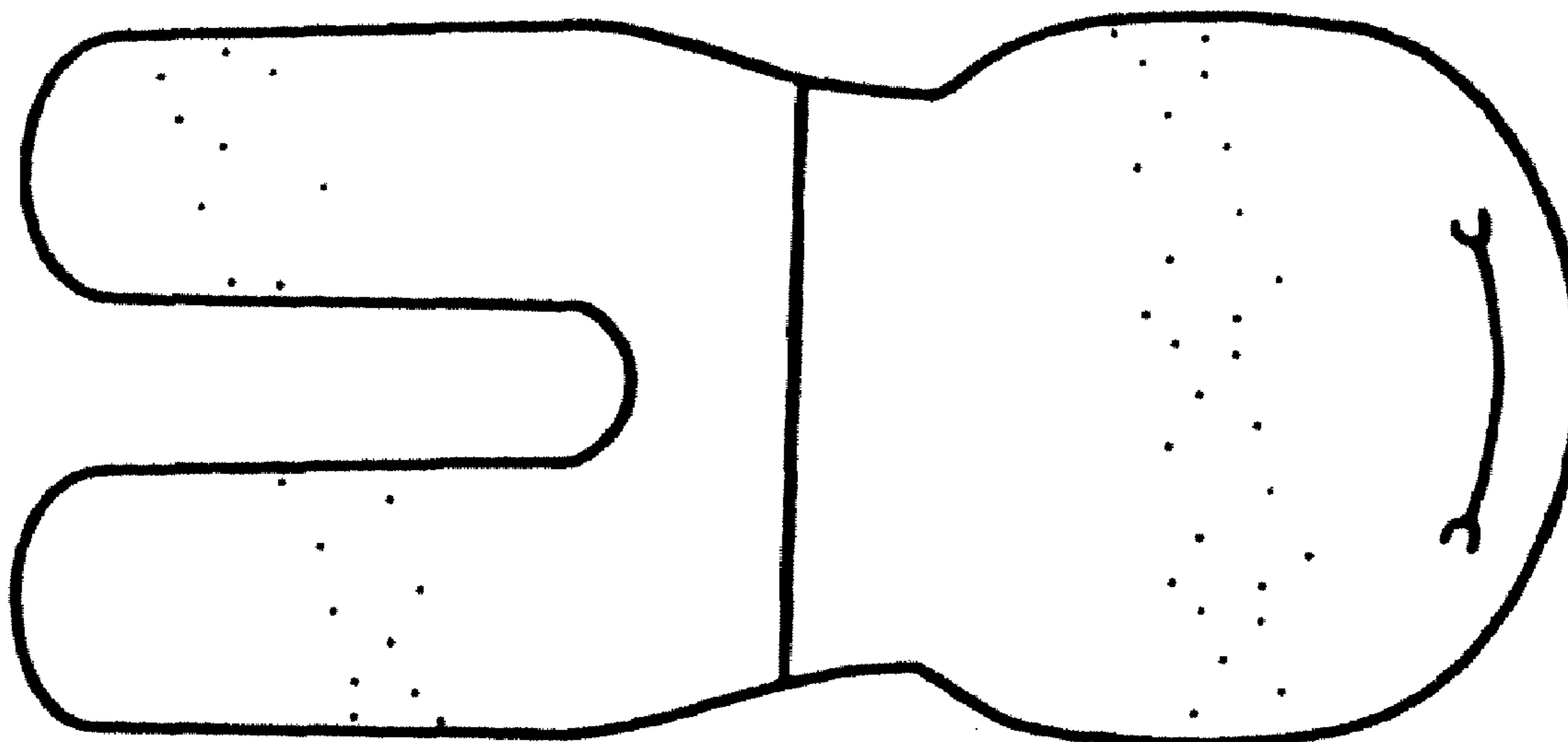
FIG. 2 is a left side elevational view thereof, the right side elevational view being a mirror image;

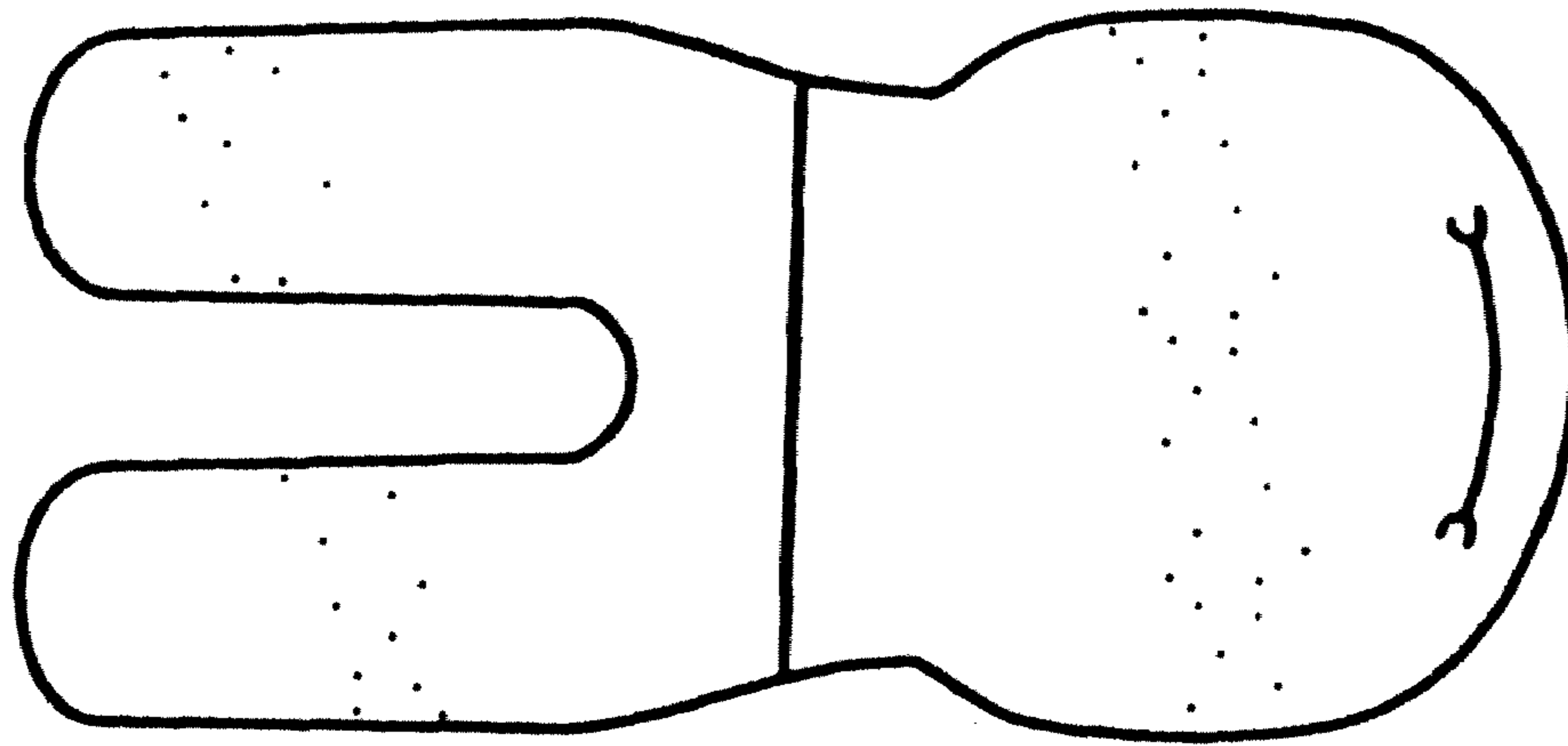

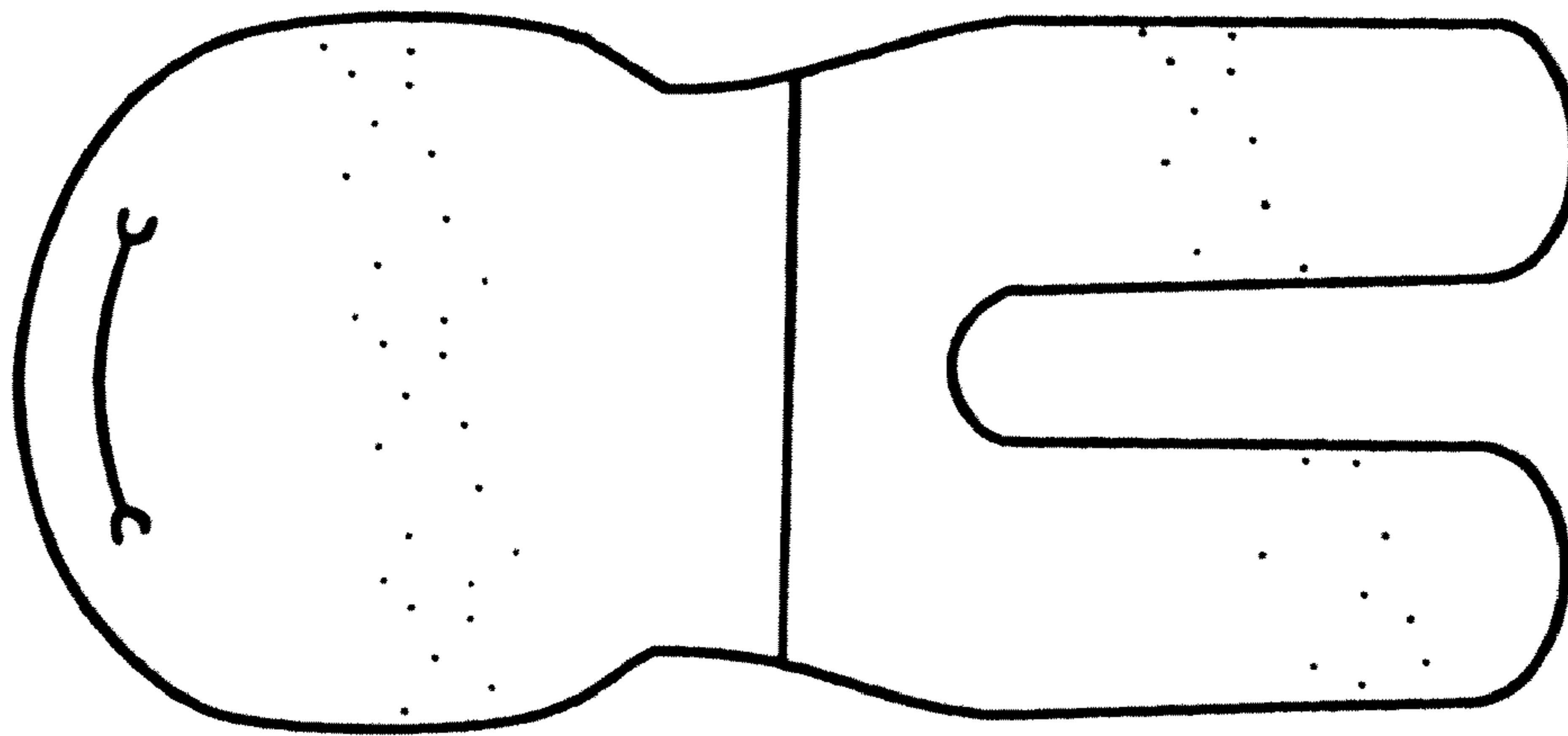
