(57) **CLAIM**

The ornamental design for a synthetic arched baluster, as described and shown.

DESCRIPTION

FIG. 1 is a left upper perspective view of the synthetic arched baluster of the present design;

FIG. 2 is a right lower perspective view of the synthetic arched baluster of FIG. 1;

FIG. 3 is a left side view of the synthetic arched baluster of FIG. 1;

FIG. 4 is a front view of the synthetic arched baluster of FIG. 1;

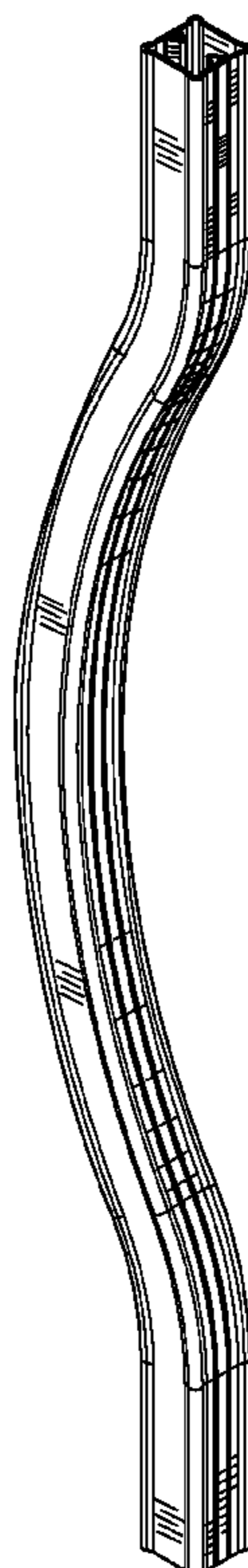
FIG. 5 is a right side view of the synthetic arched baluster of FIG. 1;

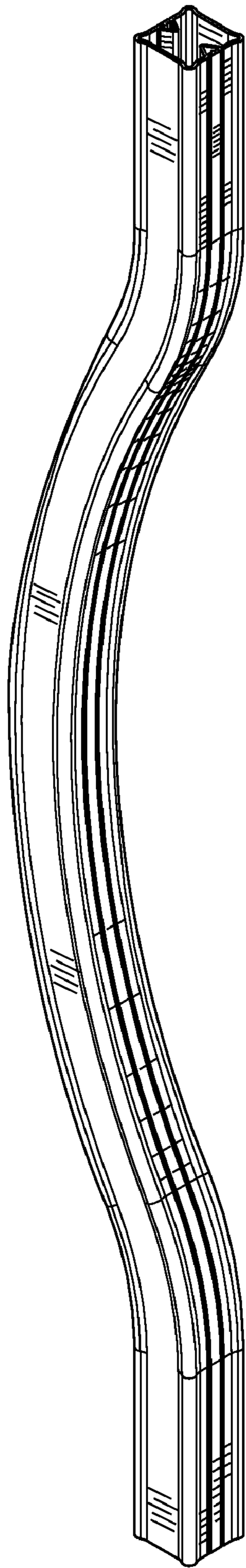

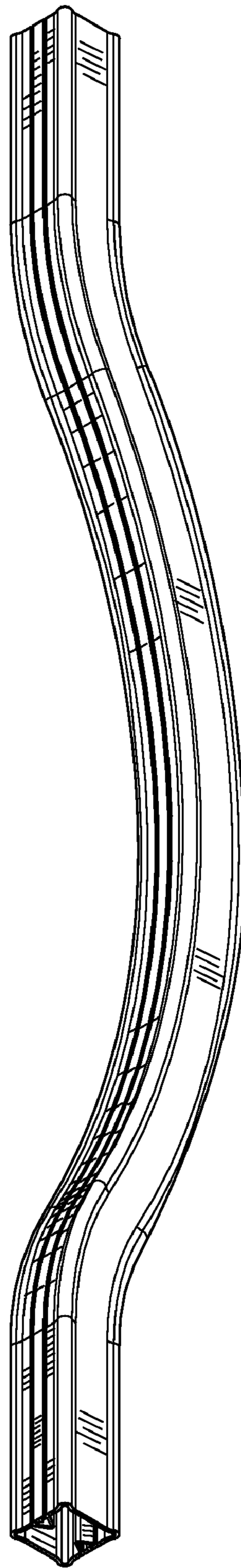

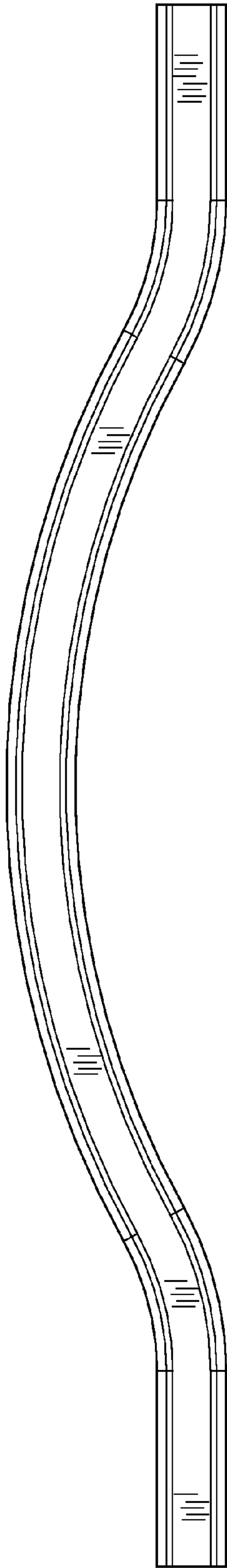

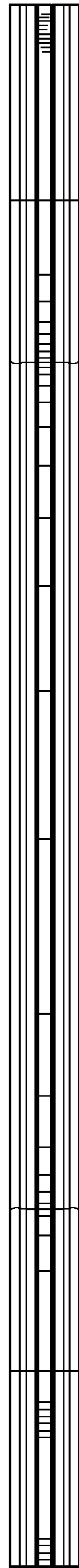

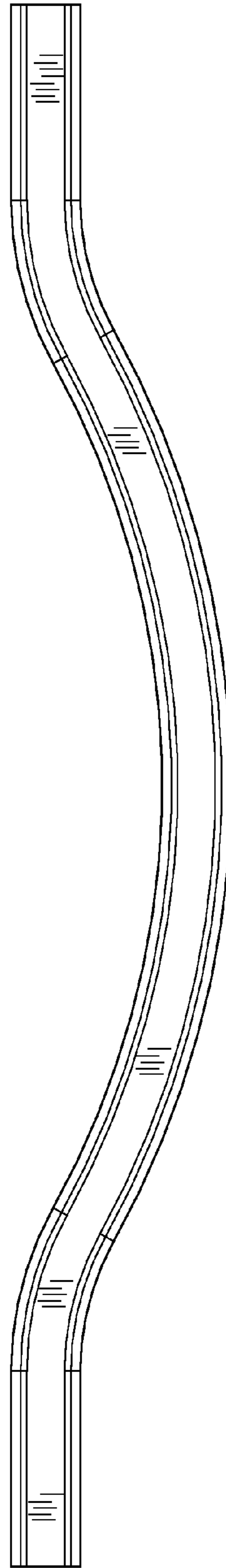

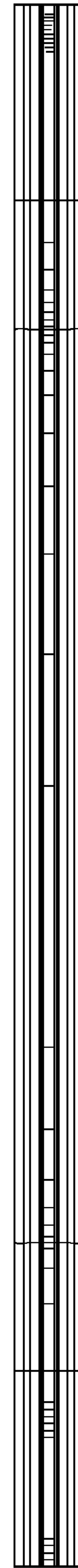

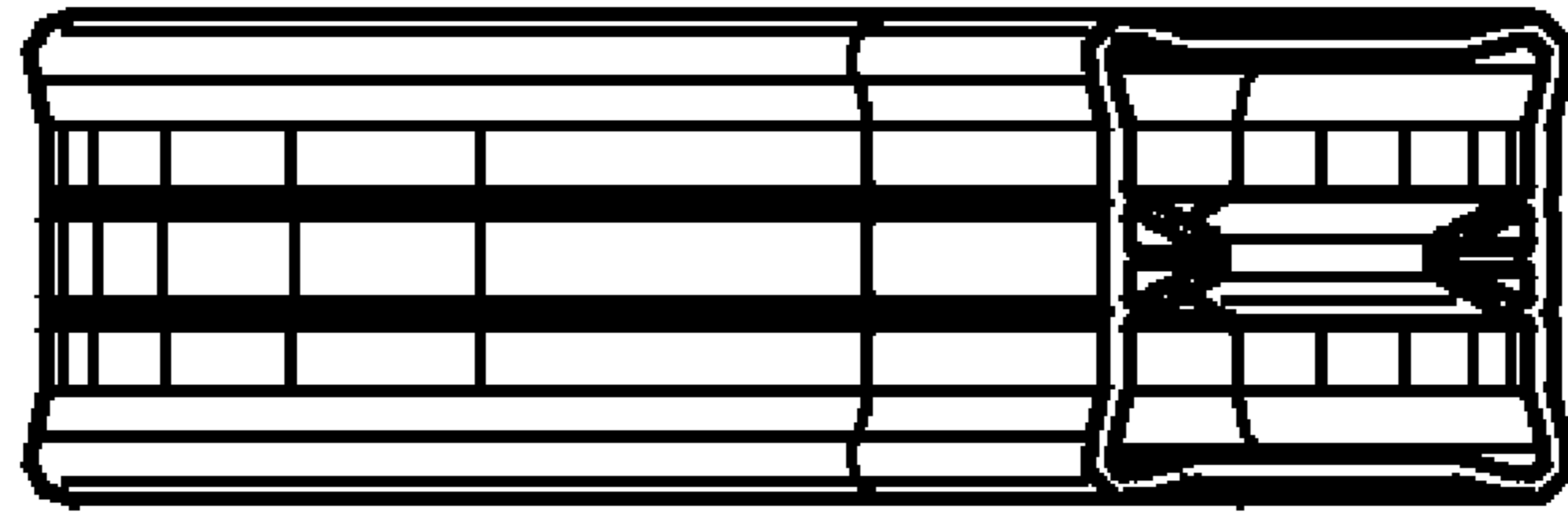

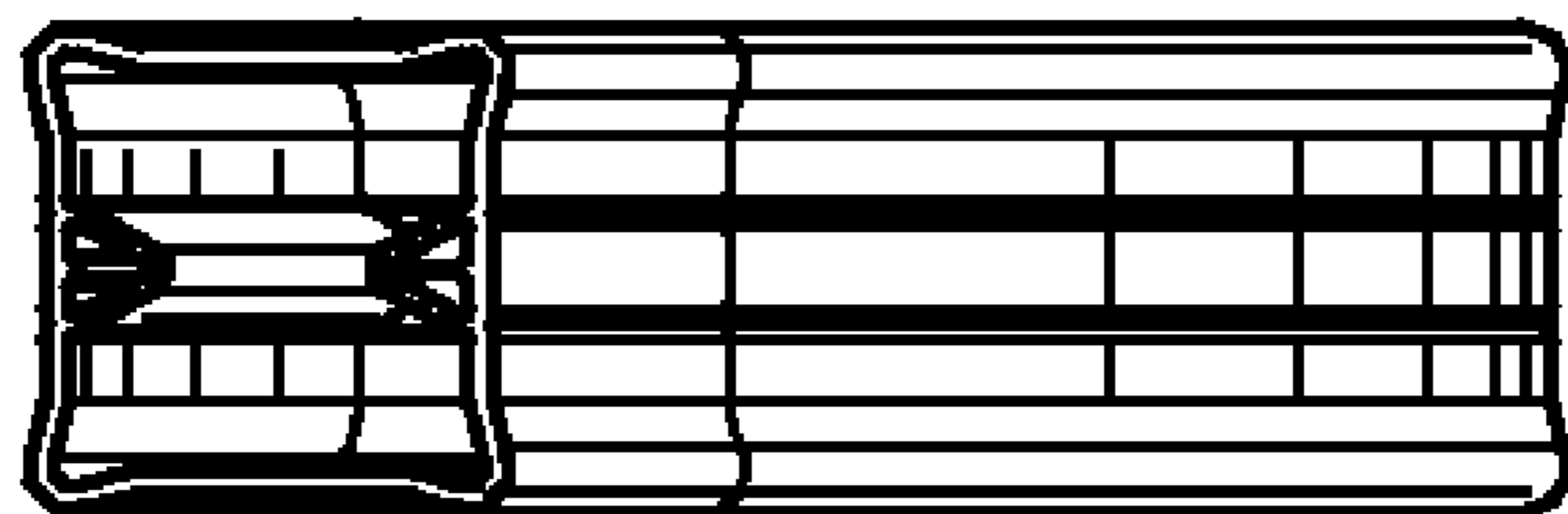
