(57) **CLAIM**

The ornamental designs for a bowling glove, as shown and described.

DESCRIPTION

FIGS. 1-3 show various views of a first exemplary embodiment of a bowling glove.

FIG. 1 is a rear/right/top perspective view of a bowling glove according to the first exemplary embodiment;

FIG. 2 is a rear/top perspective view thereof on a bowler's hand; and

FIG. 3 is a front/top perspective view thereof on a bowler's hand;

FIGS. 4-6 show various views of a second exemplary embodiment of a bowling glove.

FIG. 4 is a rear/right/top perspective view of a bowling glove according to the second exemplary embodiment;

FIG. 5 is a rear/top perspective view thereof on a bowler's hand; and,

FIG. 6 is a front/top perspective view thereof on a bowler's hand.

The broken lines are for illustrative purposes only and form no part of the claimed design.

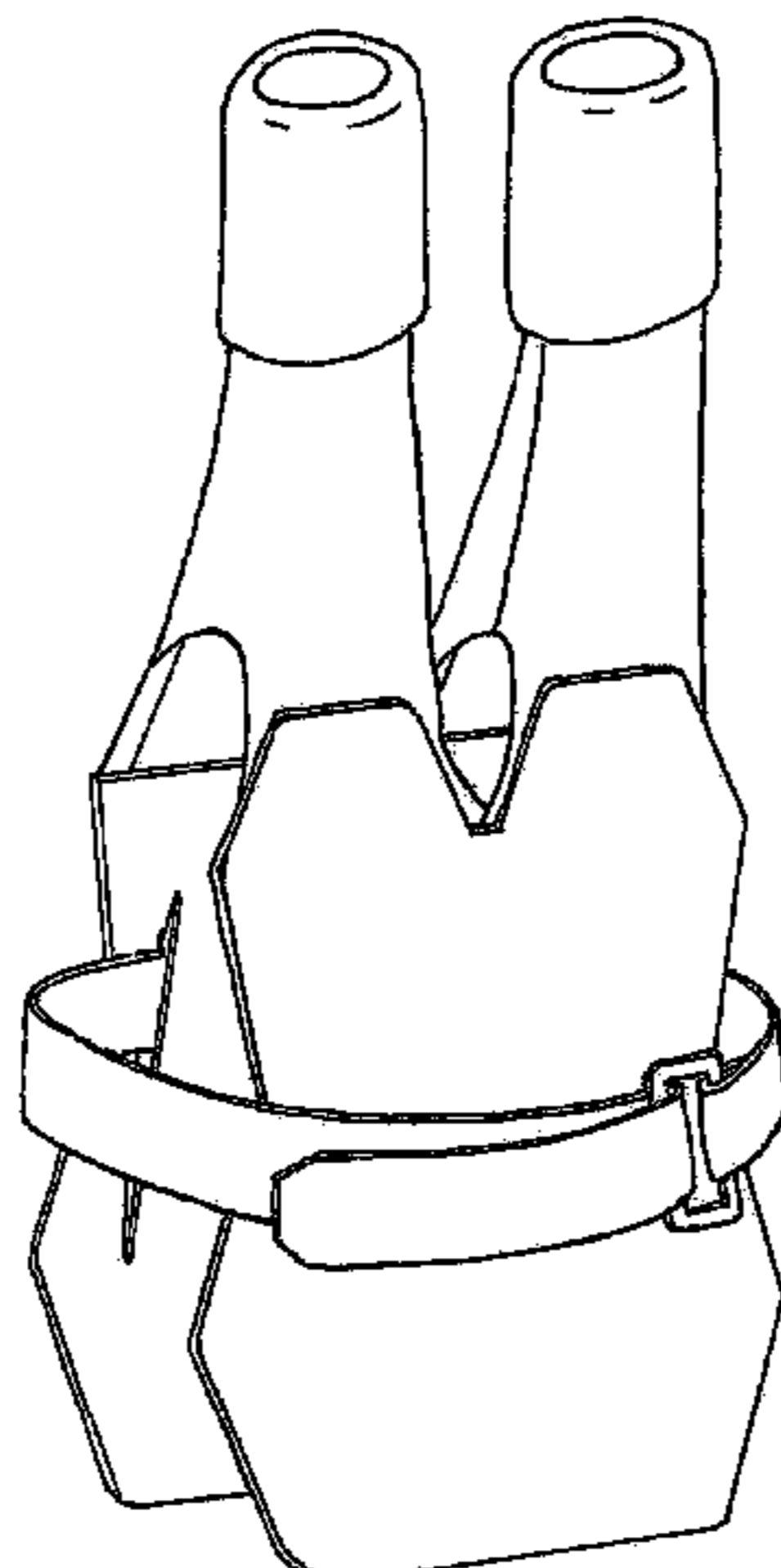

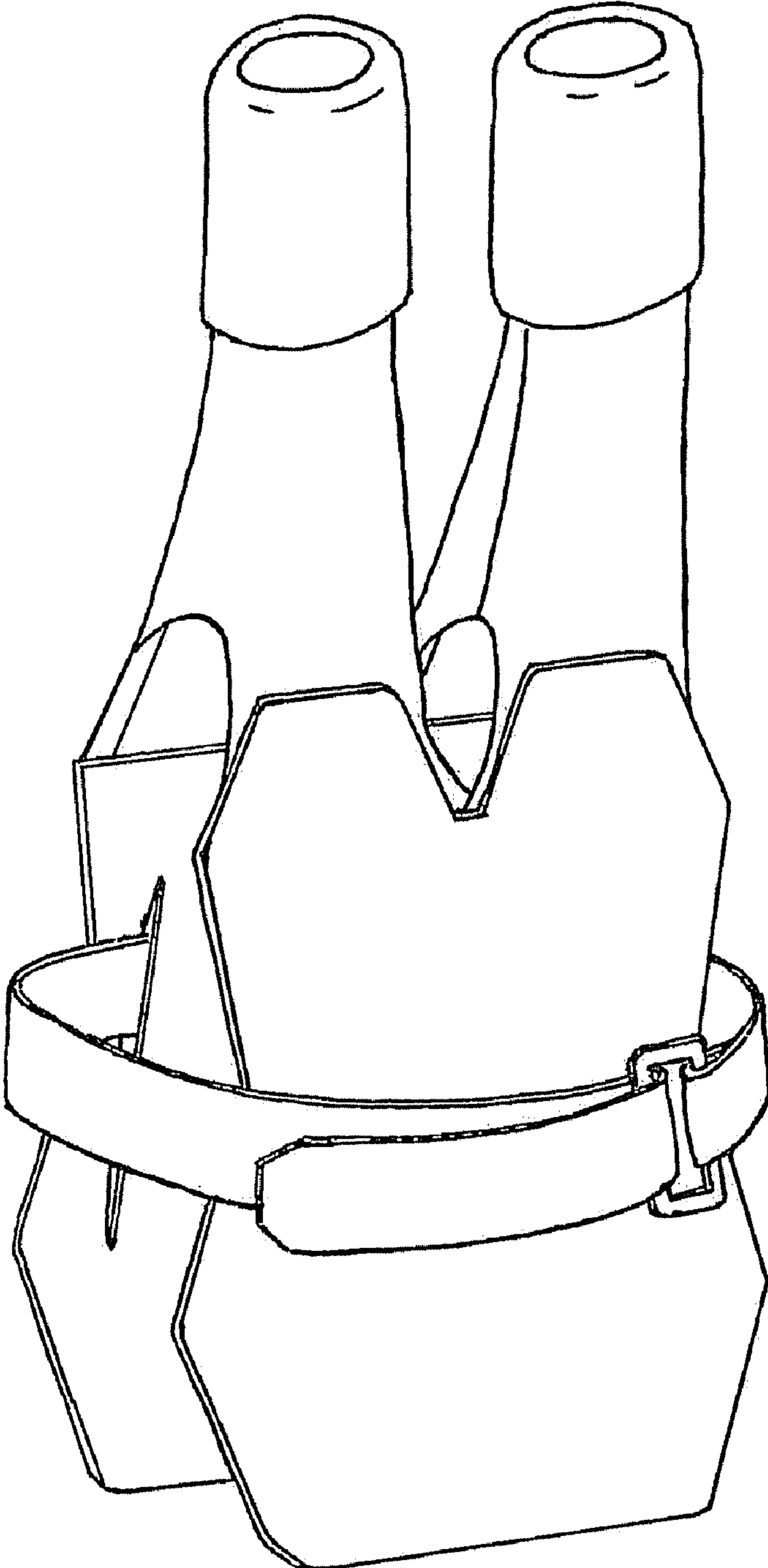

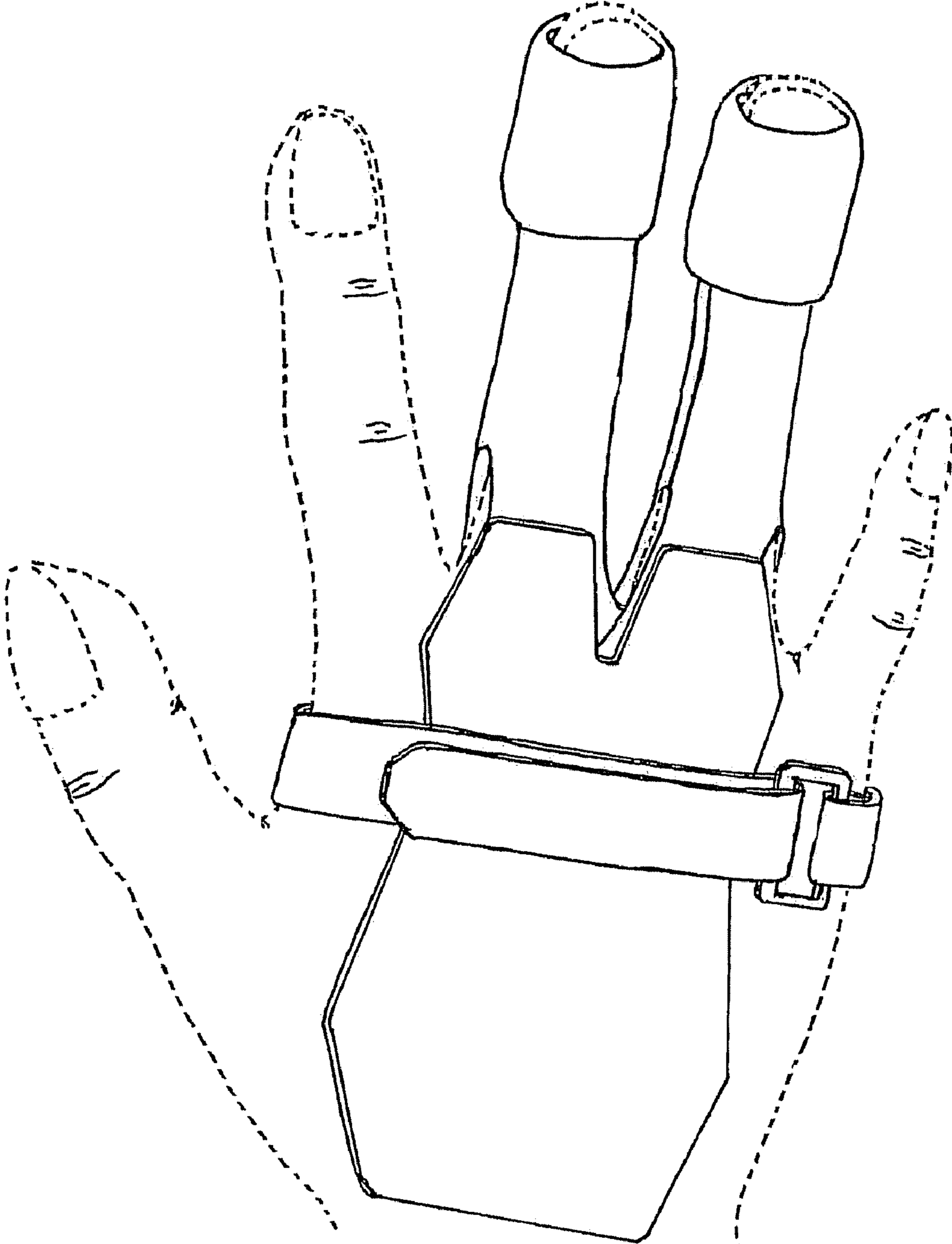

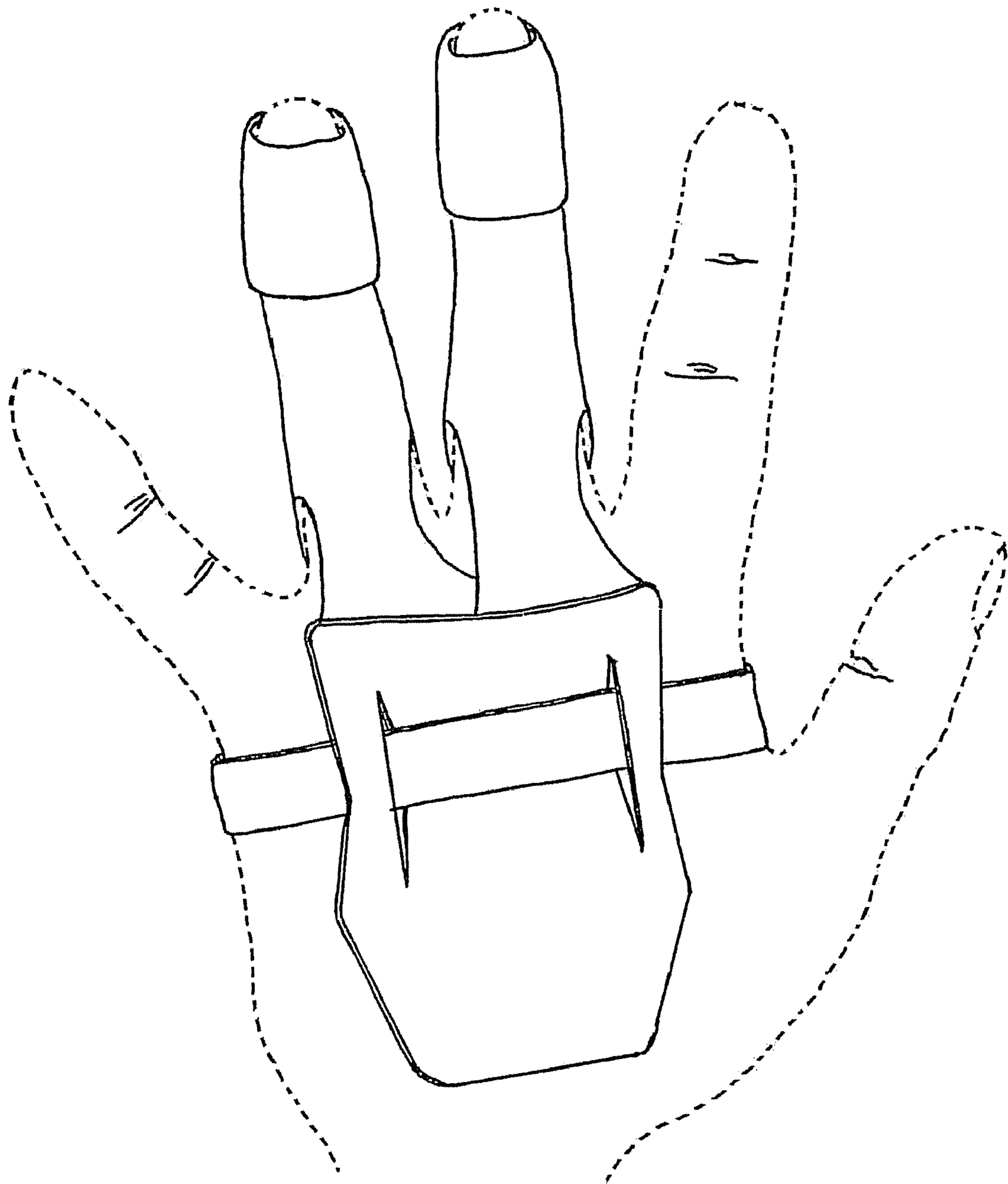

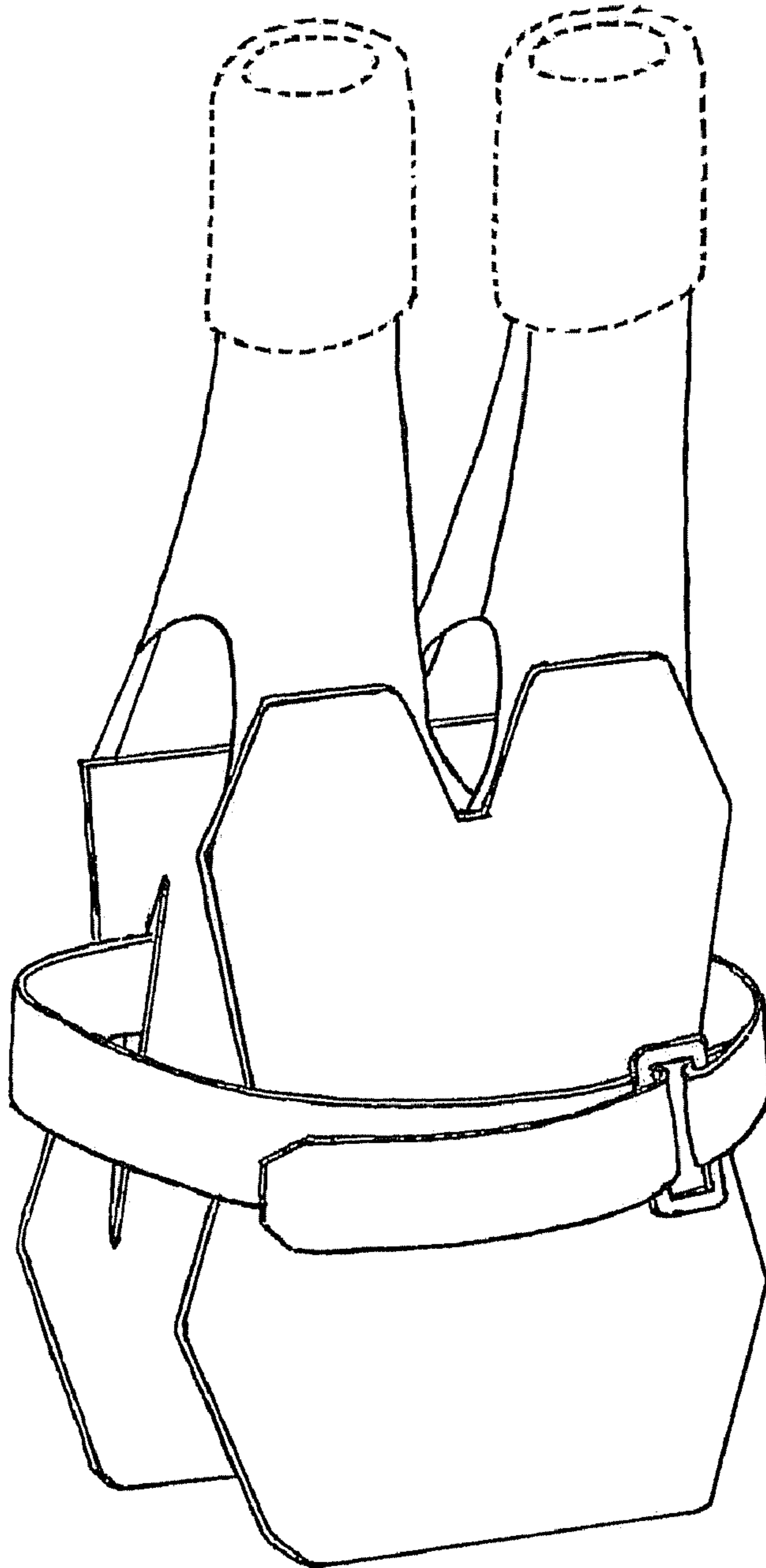

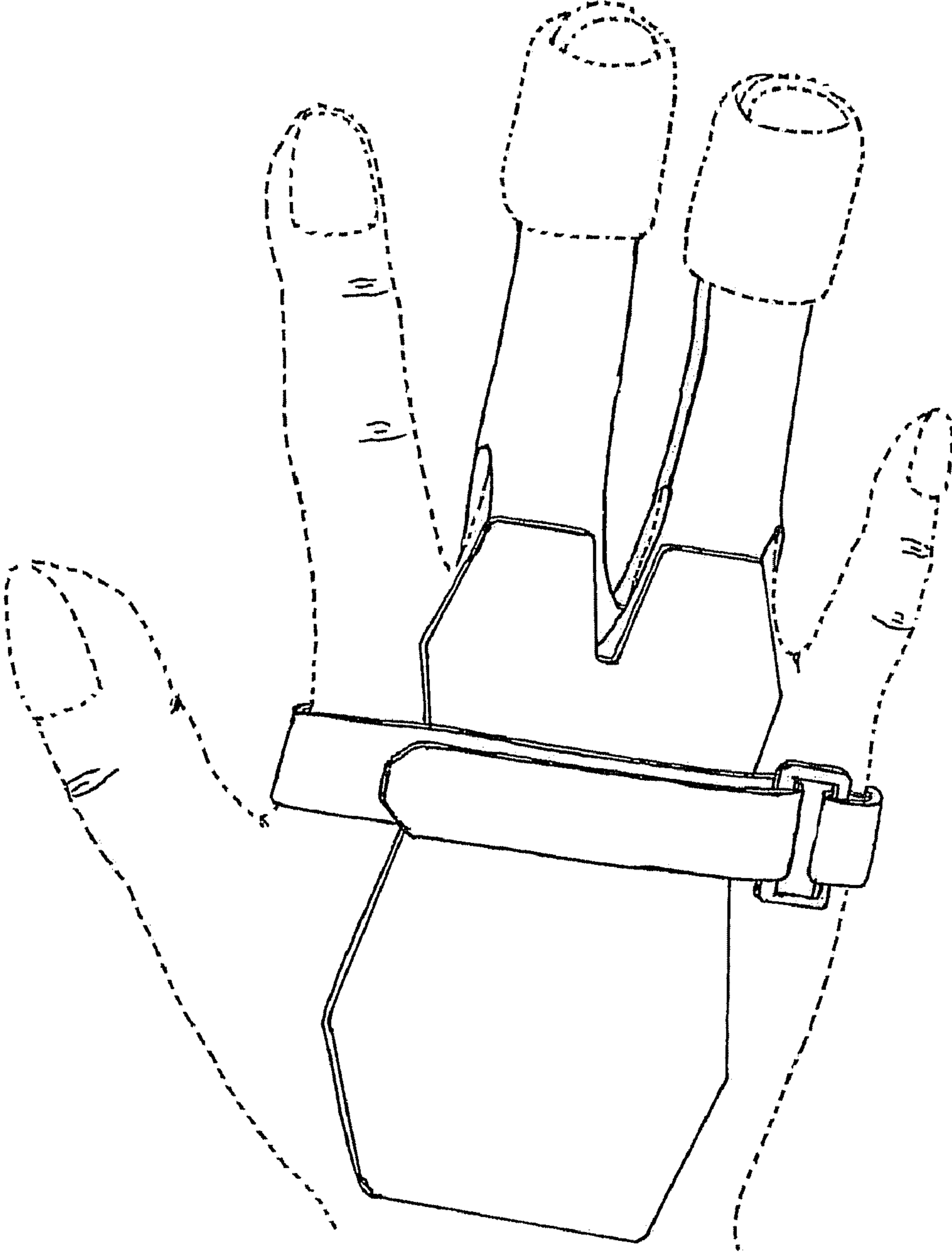
