(57) **CLAIM**

We claim the ornamental design for a food product with linked star design, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a food product with linked star design, according to the present invention;

FIG. 2 is a left side view of the food product with linked star design of FIG. 1;

FIG. 3 is a right side view of the food product with linked star design of FIG. 1;

FIG. 4 is an end view of the food product with linked star design of FIG. 1; and,

FIG. 5 is a bottom plan view of the food product with linked star design of FIG. 1.

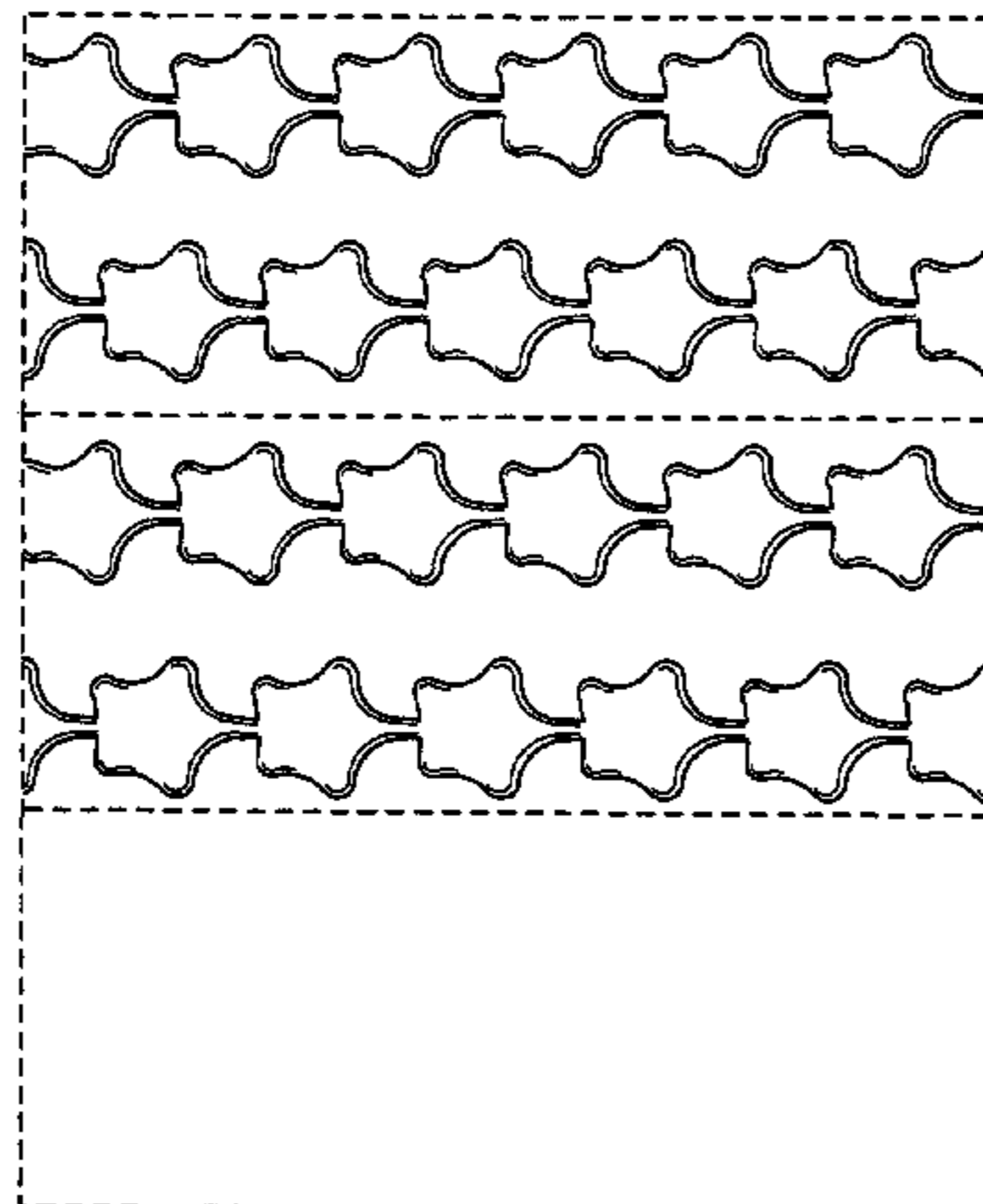
The broken lines on FIGS. 2-4 and the outermost rectangle on FIGS. 1 and 5 represent the boundary of the article and form no part of the claimed design.

The broken lines showing the inner rectangles on FIG. 5 form no part of the claimed design.

The two horizontal broken lines on the interior of FIGS. 1 and 5 represent locations for folding the unclaimed article and form no part of the claimed design.

The broken line showing of the word “INDICIA” depicts environmental subject matter and forms no part of the claimed design.

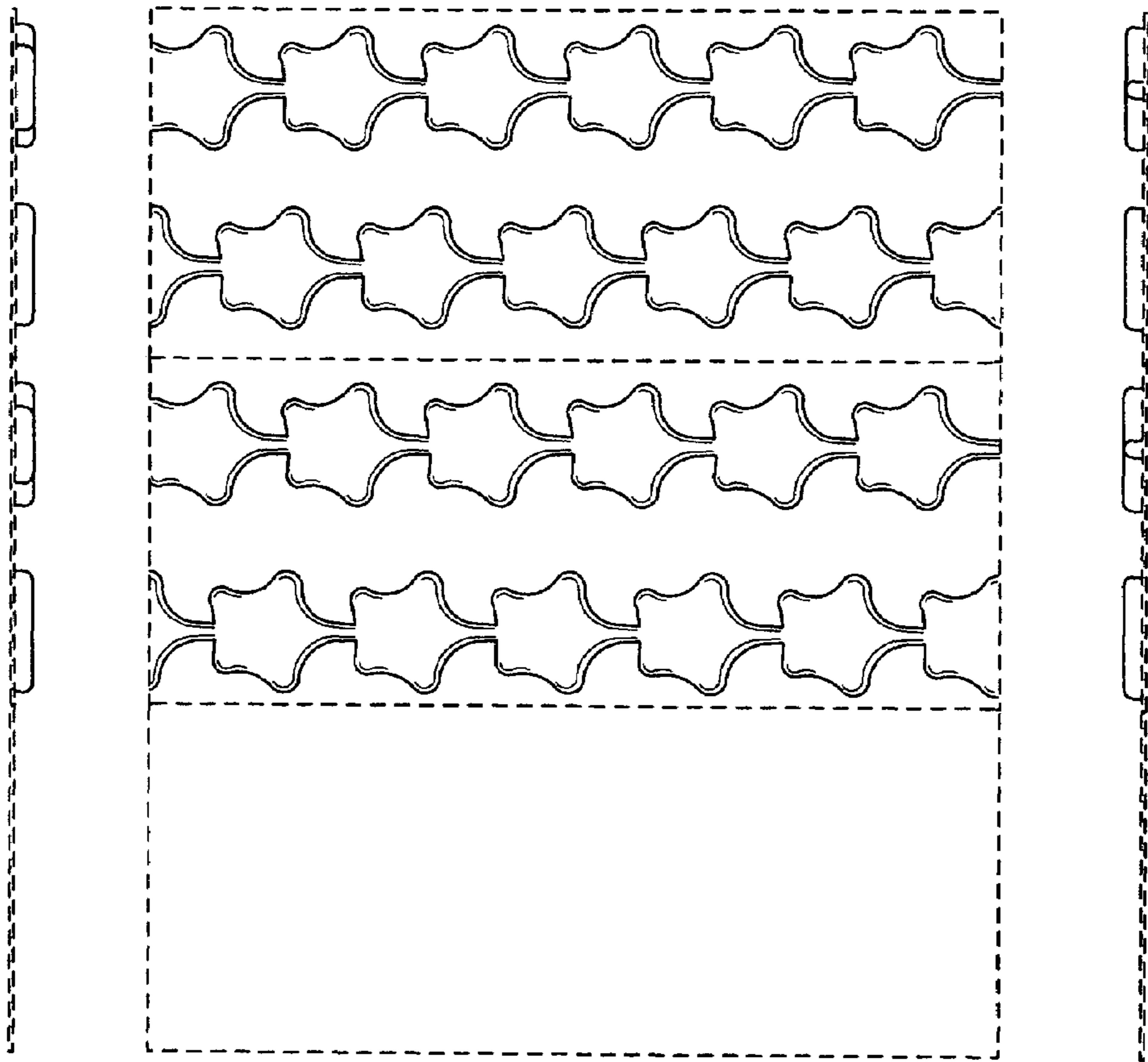

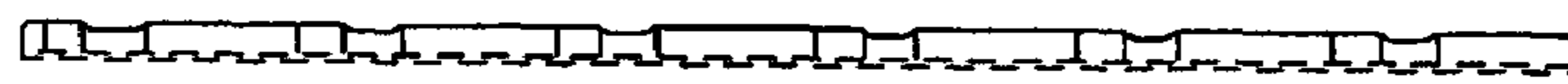
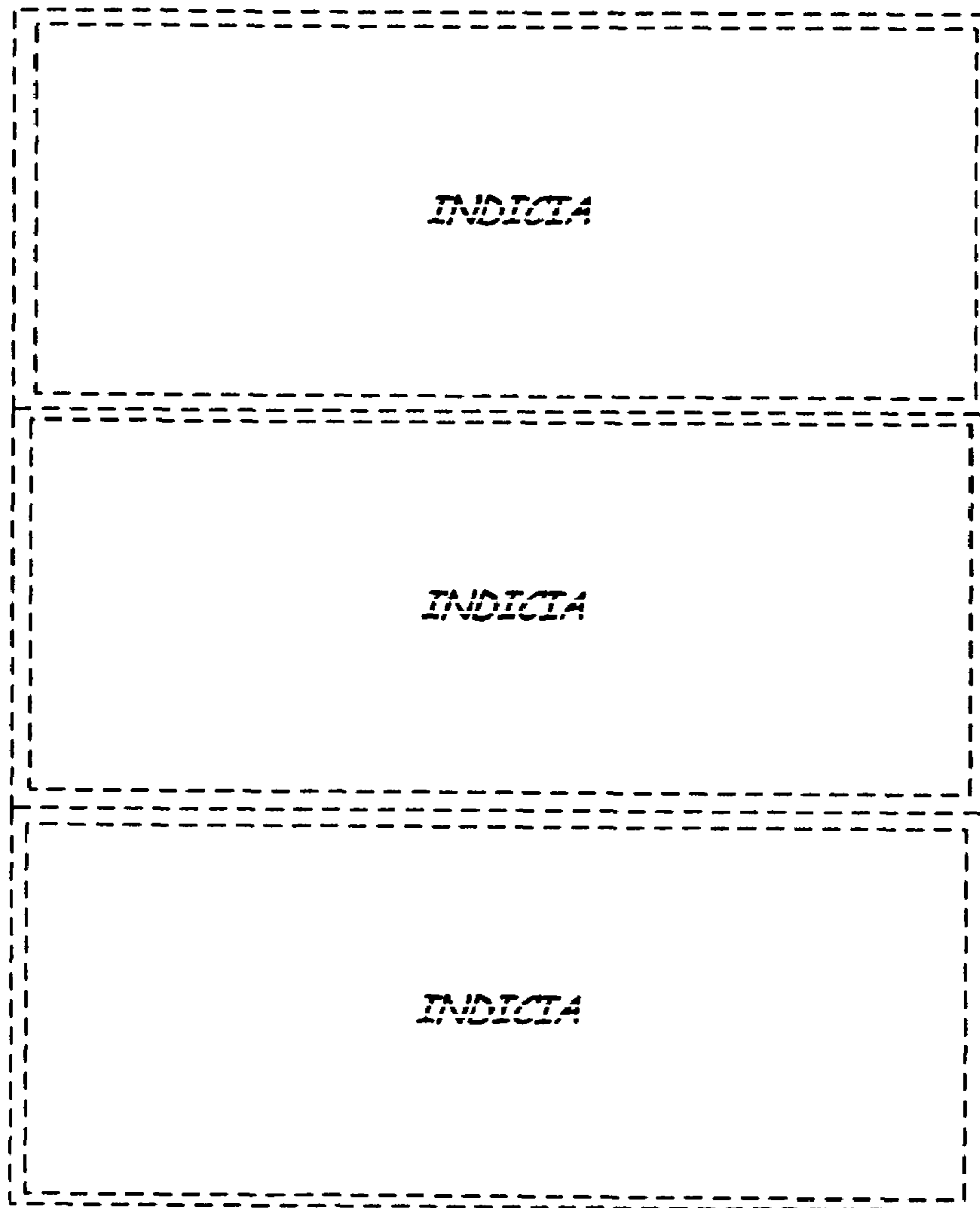
