FIG. 2 is a front view of the sports bra shown in FIG. 1;

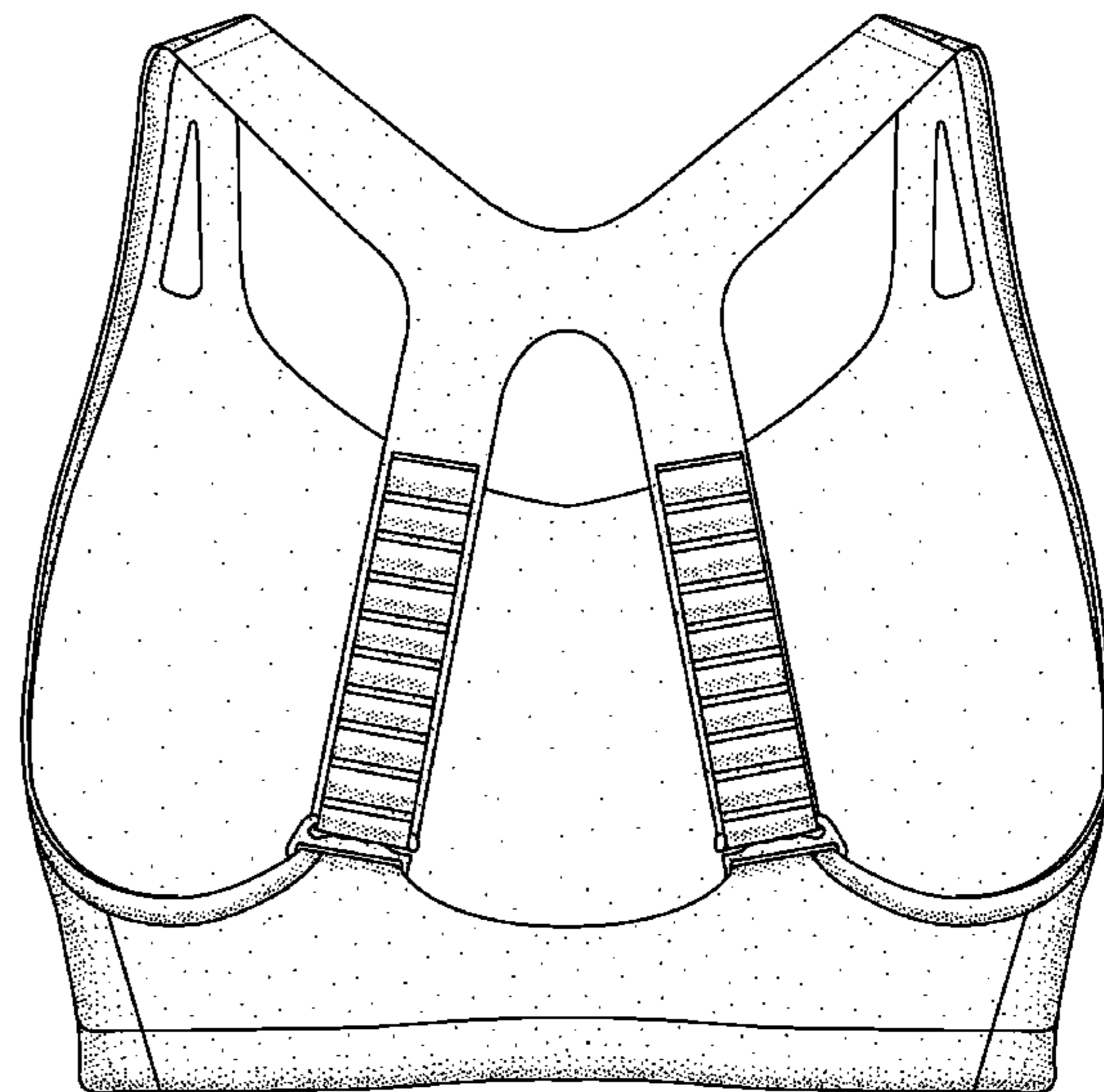
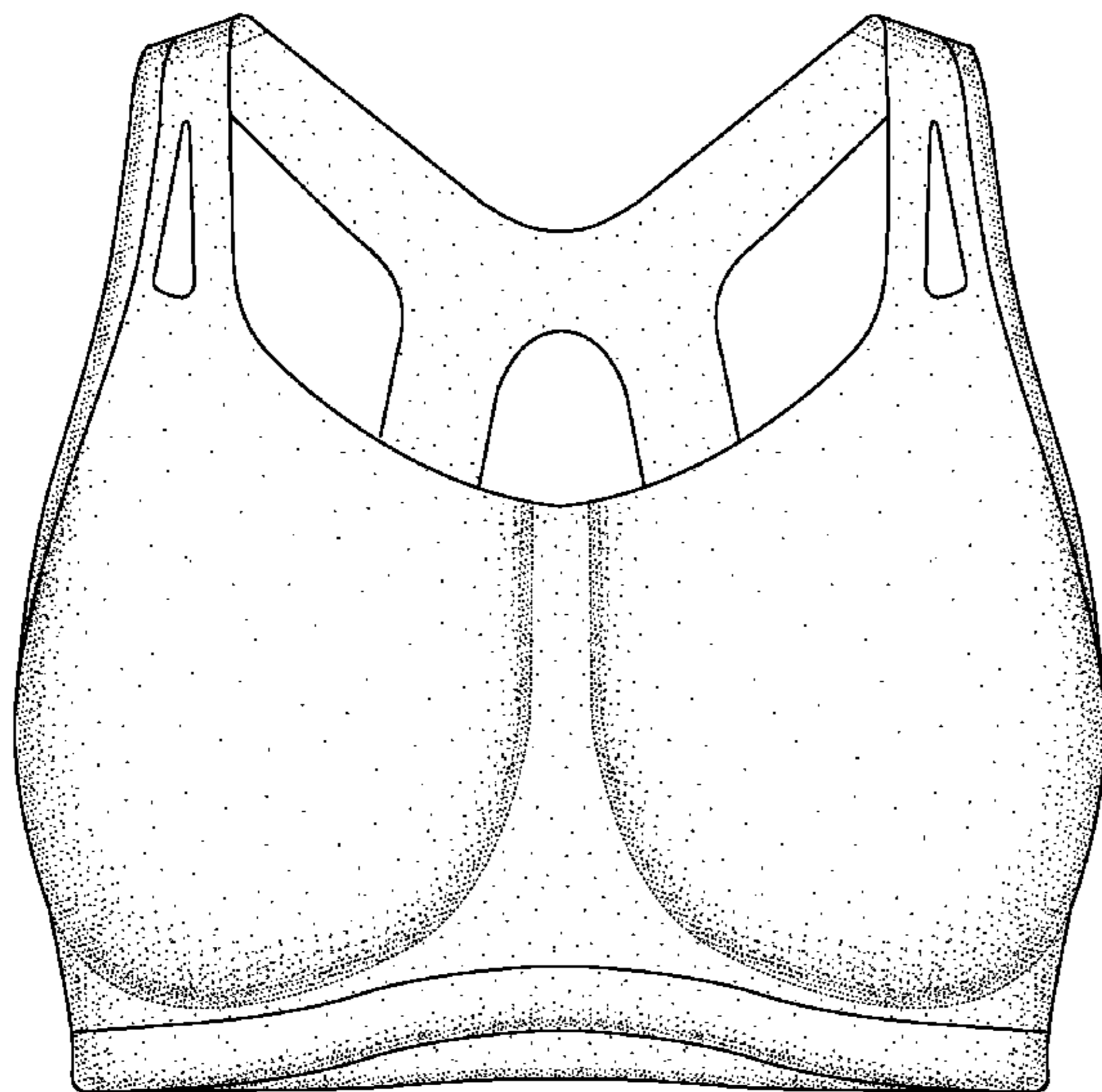
FIG. 3 is a rear view of the sports bra shown in FIG. 1;

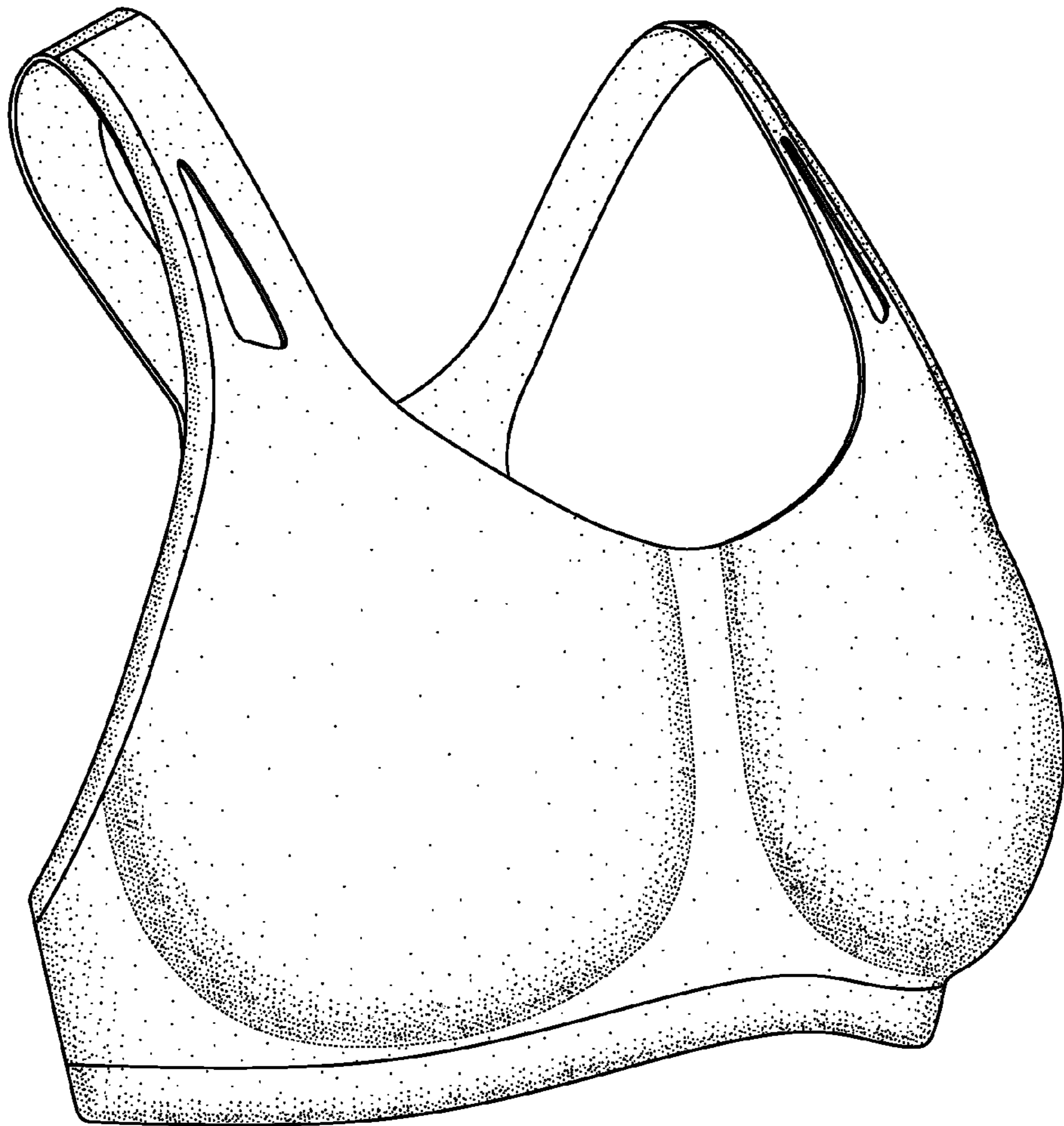
FIG. 4 is a side view of the sports bra shown in FIG. 1;

FIG. 5 is another side view of the sports bra shown in FIG. 1; and,

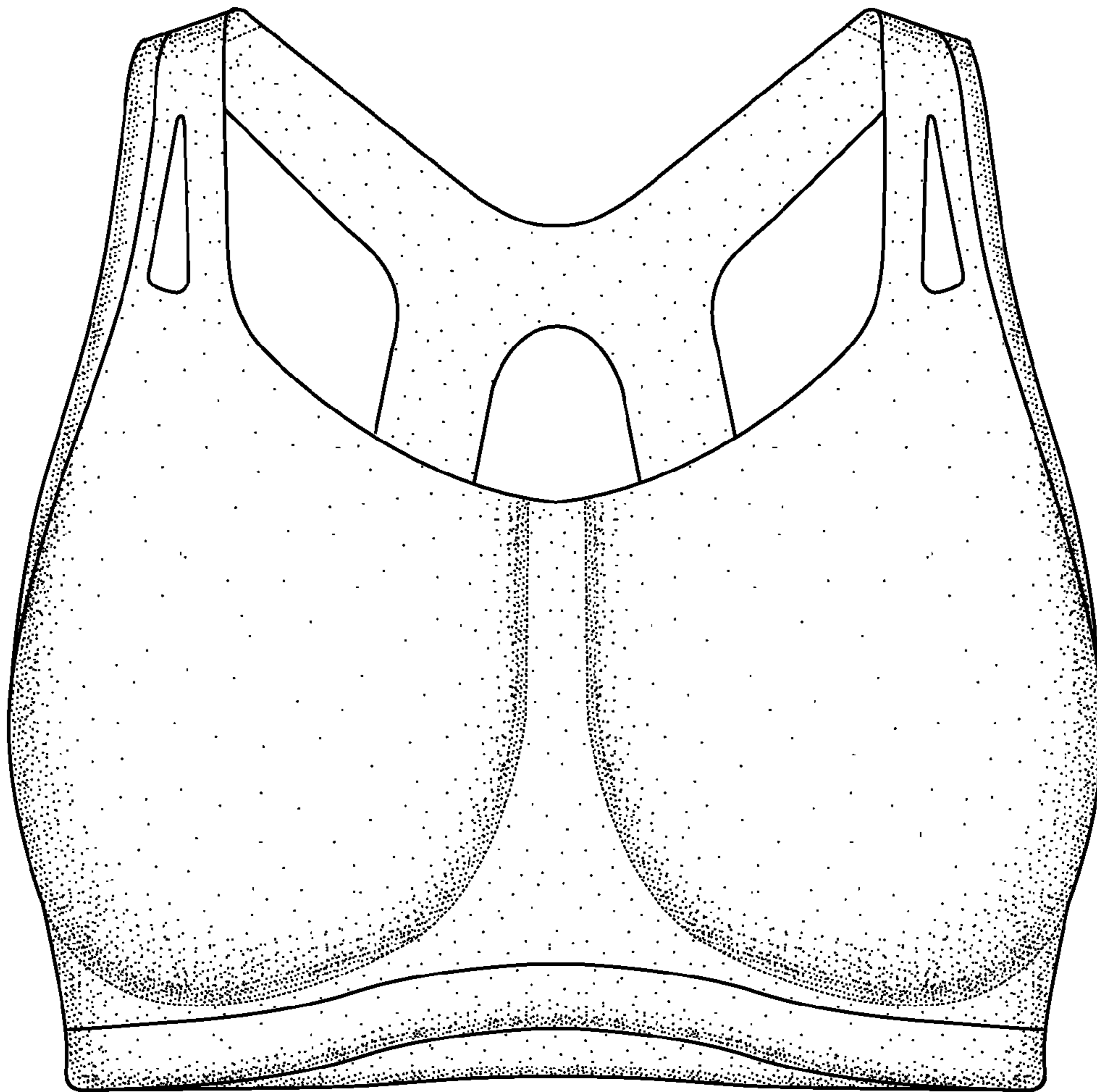
FIG. 6 is a top view of the portion of the sports bra shown in FIG. 1.

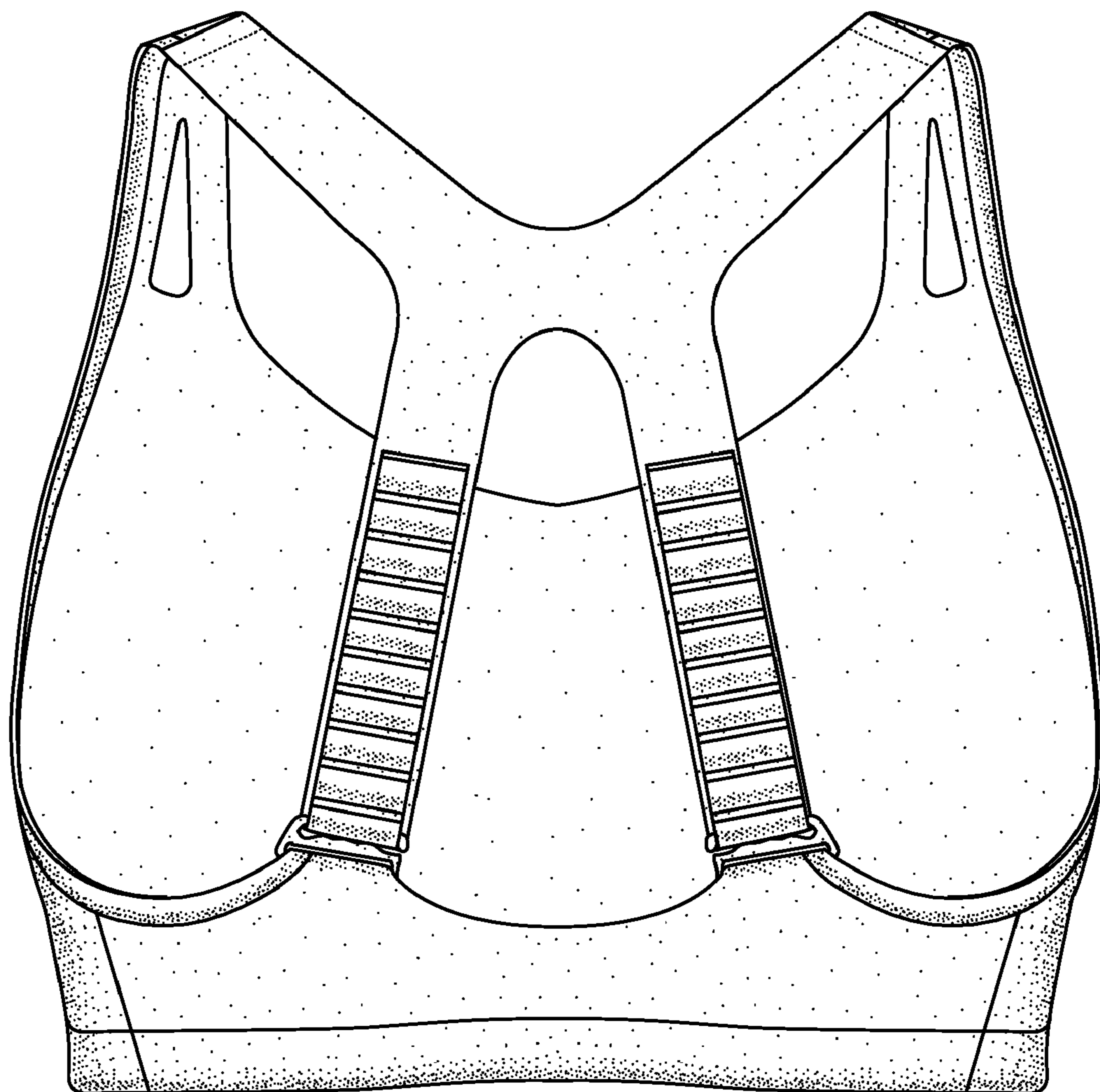

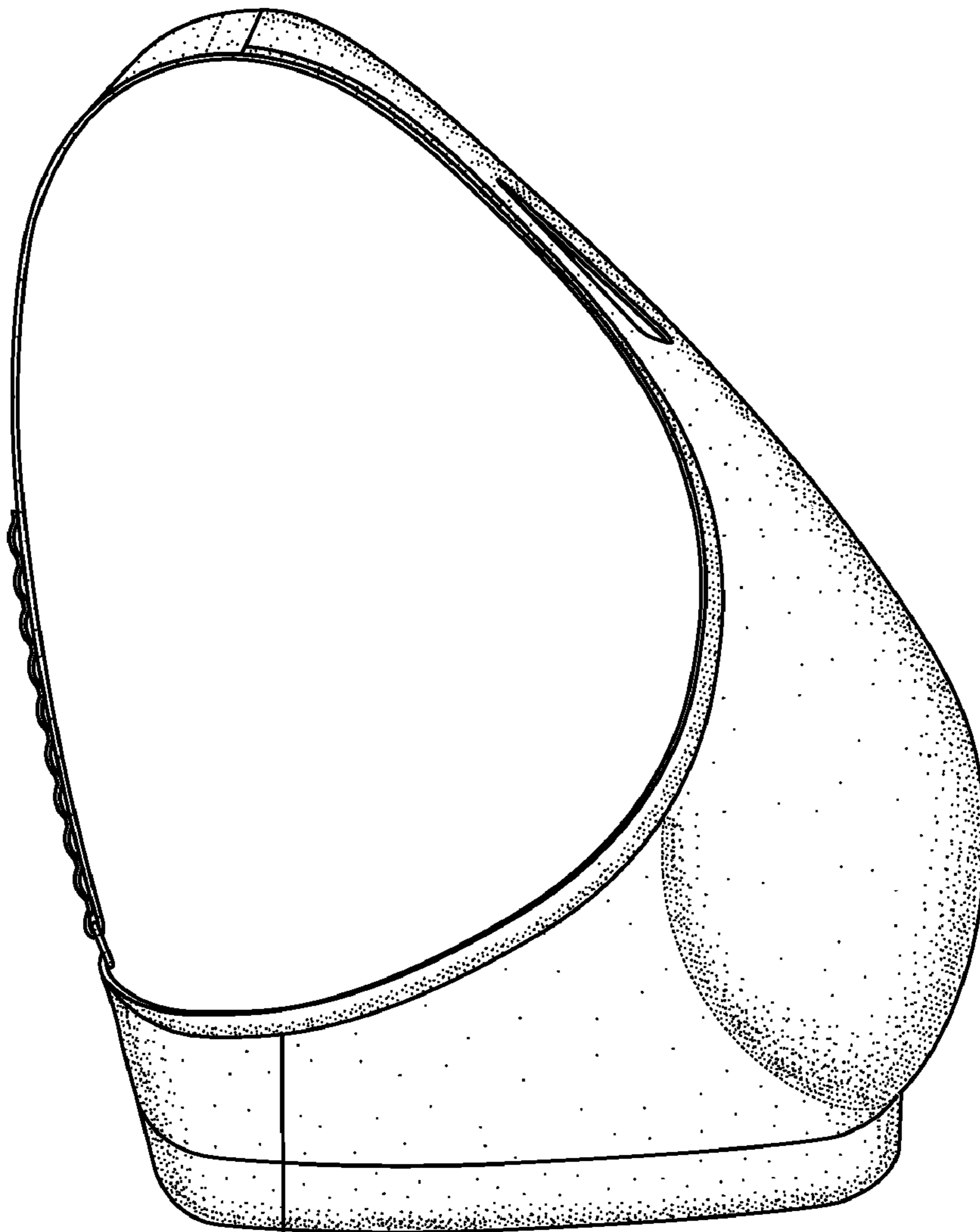

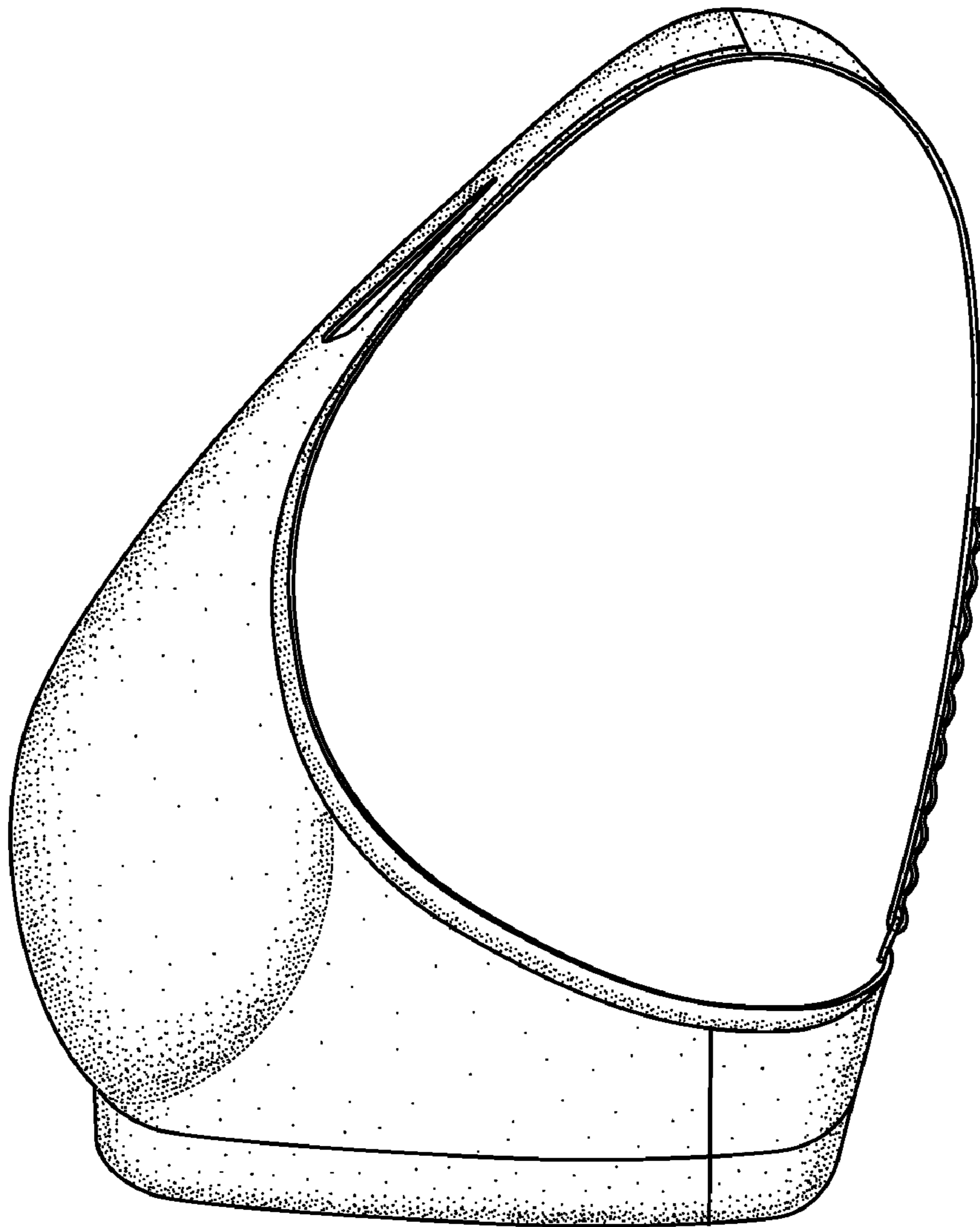




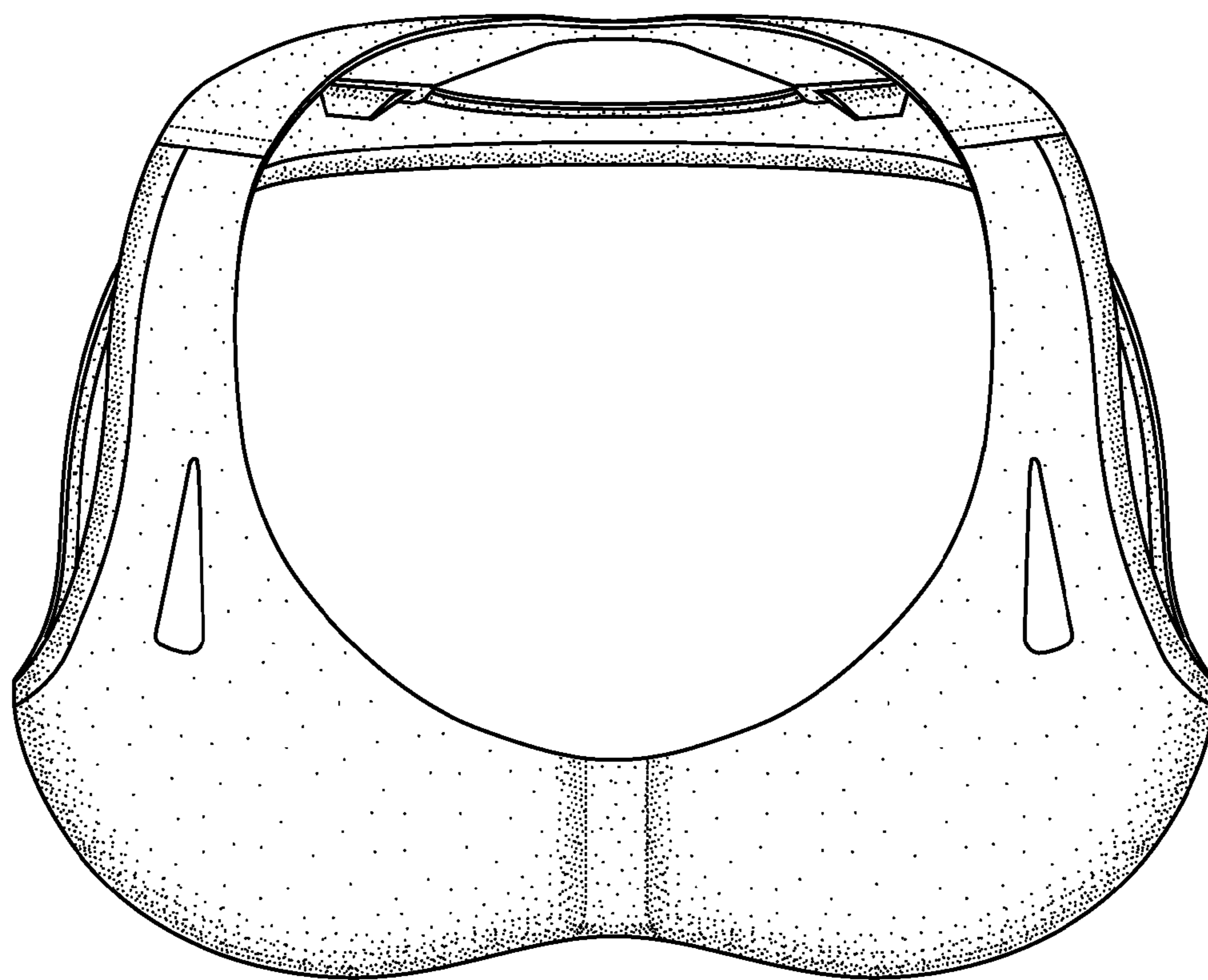
