showing my new design;

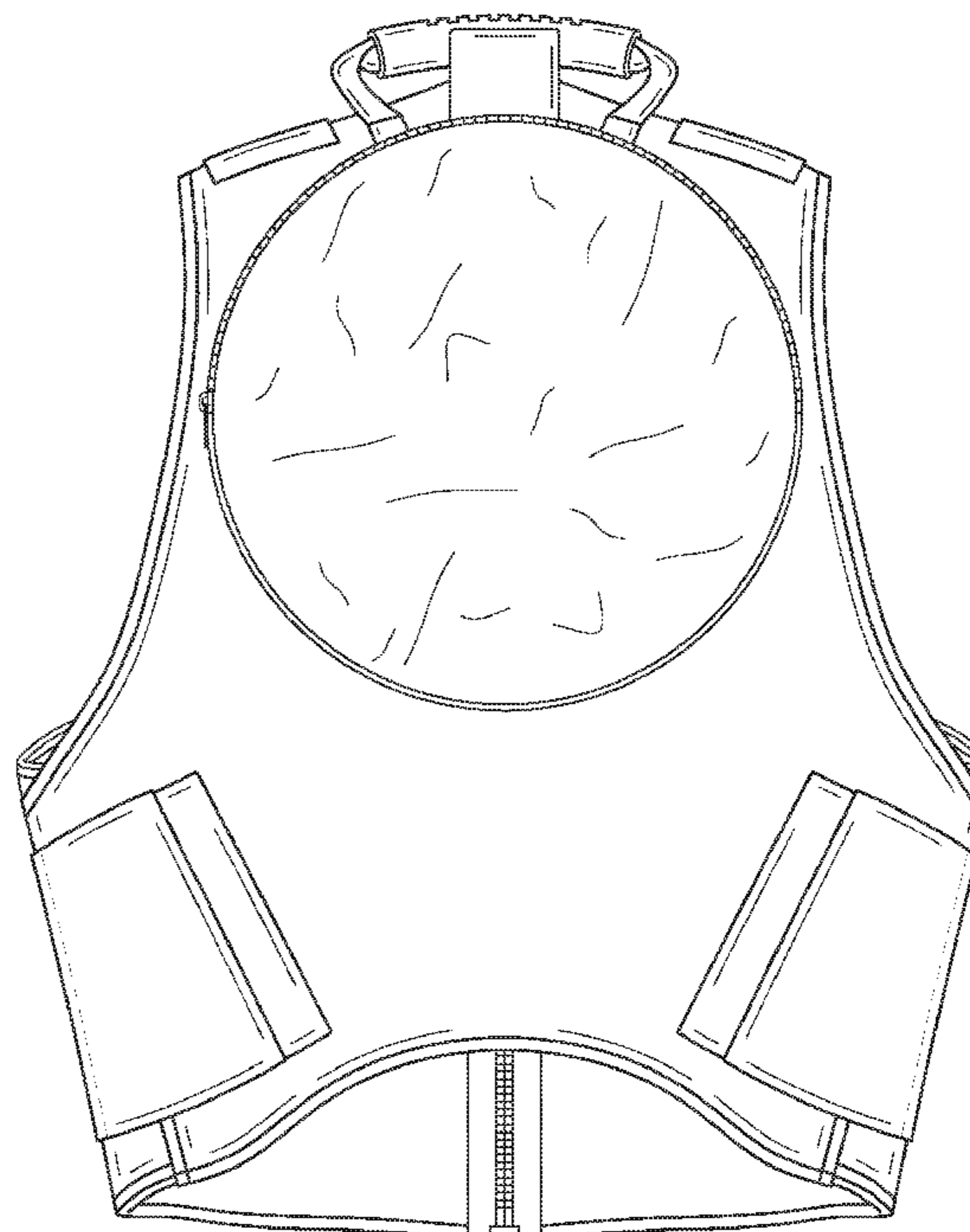
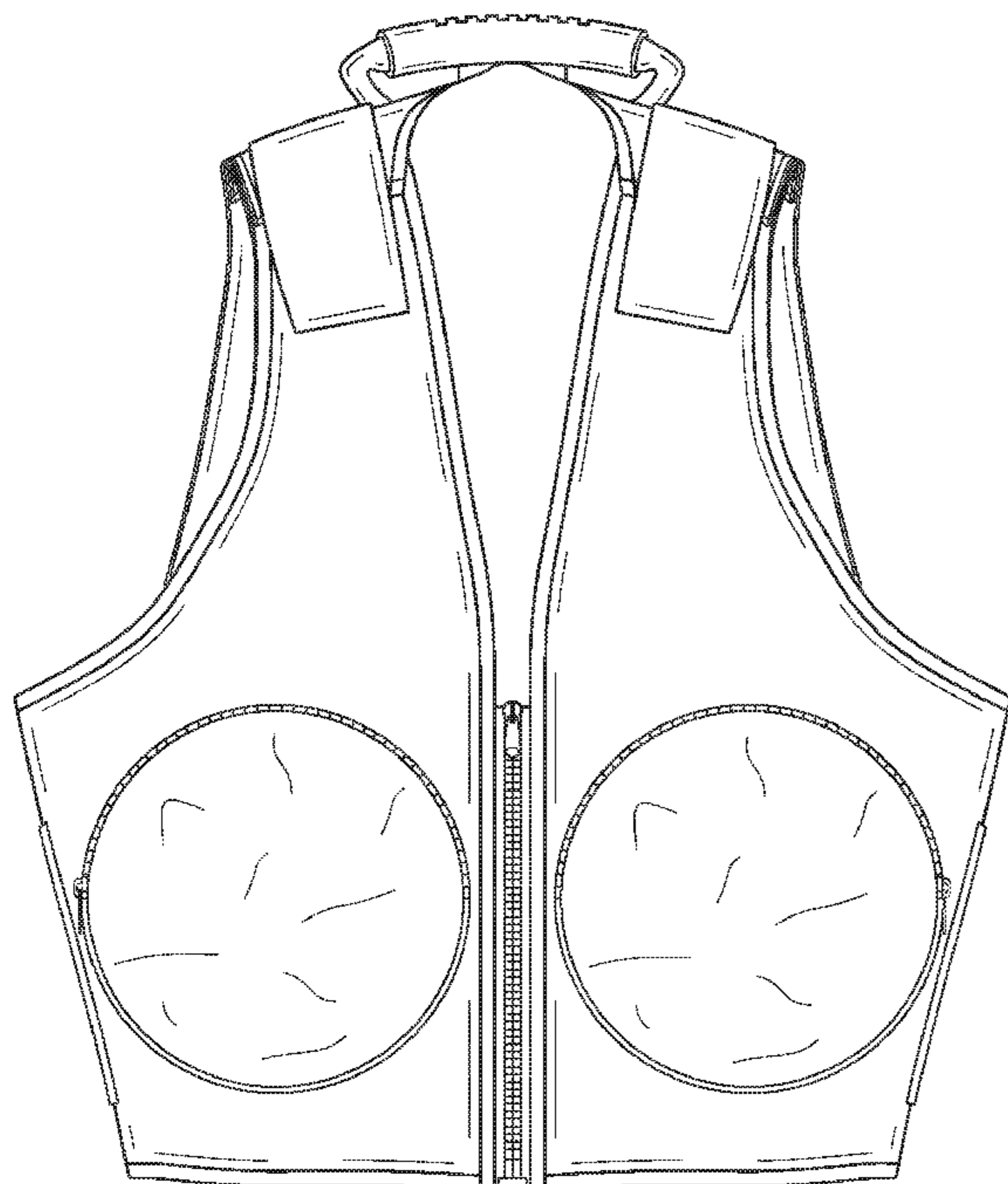
FIG. 2 is a rear view thereof;

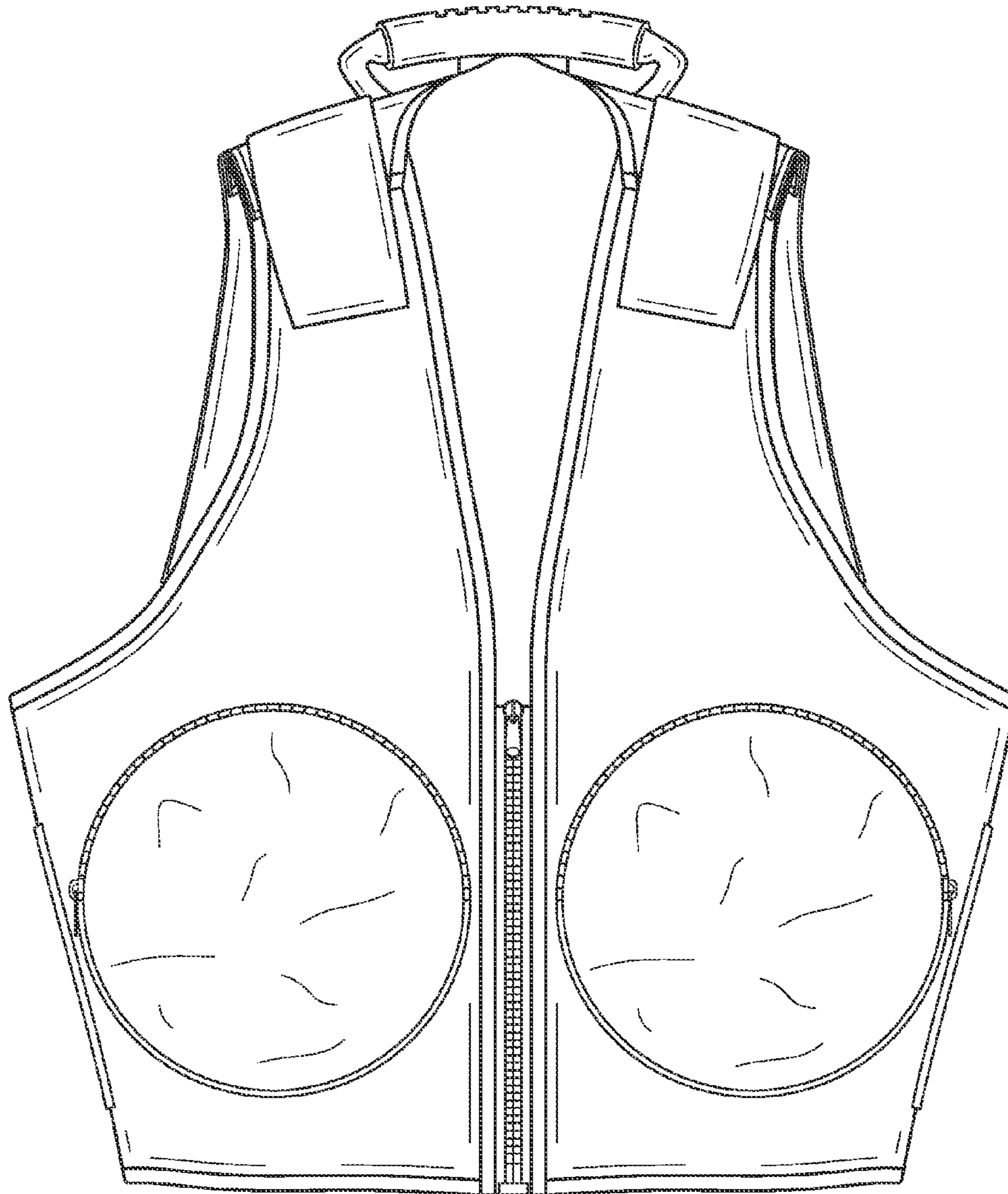

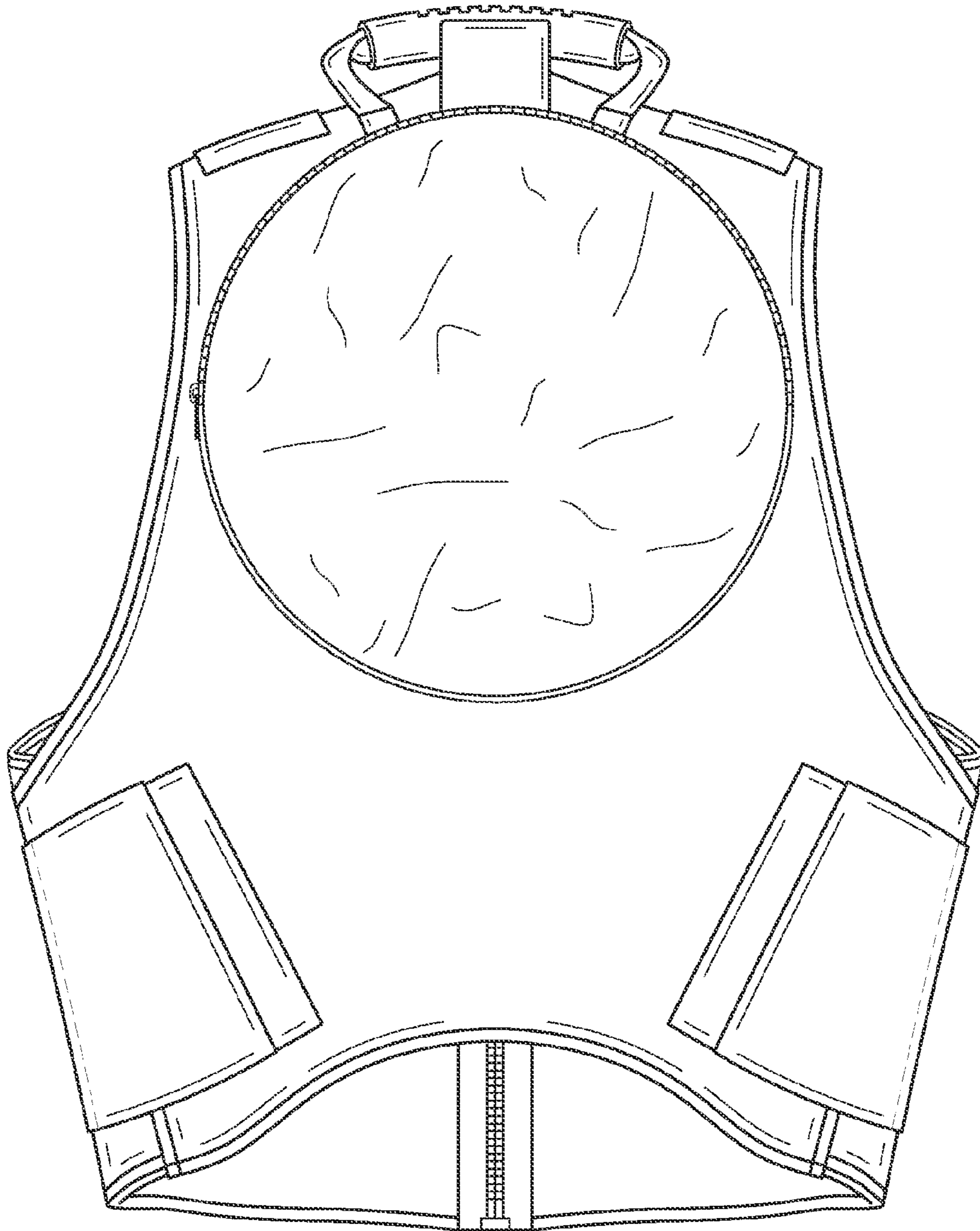

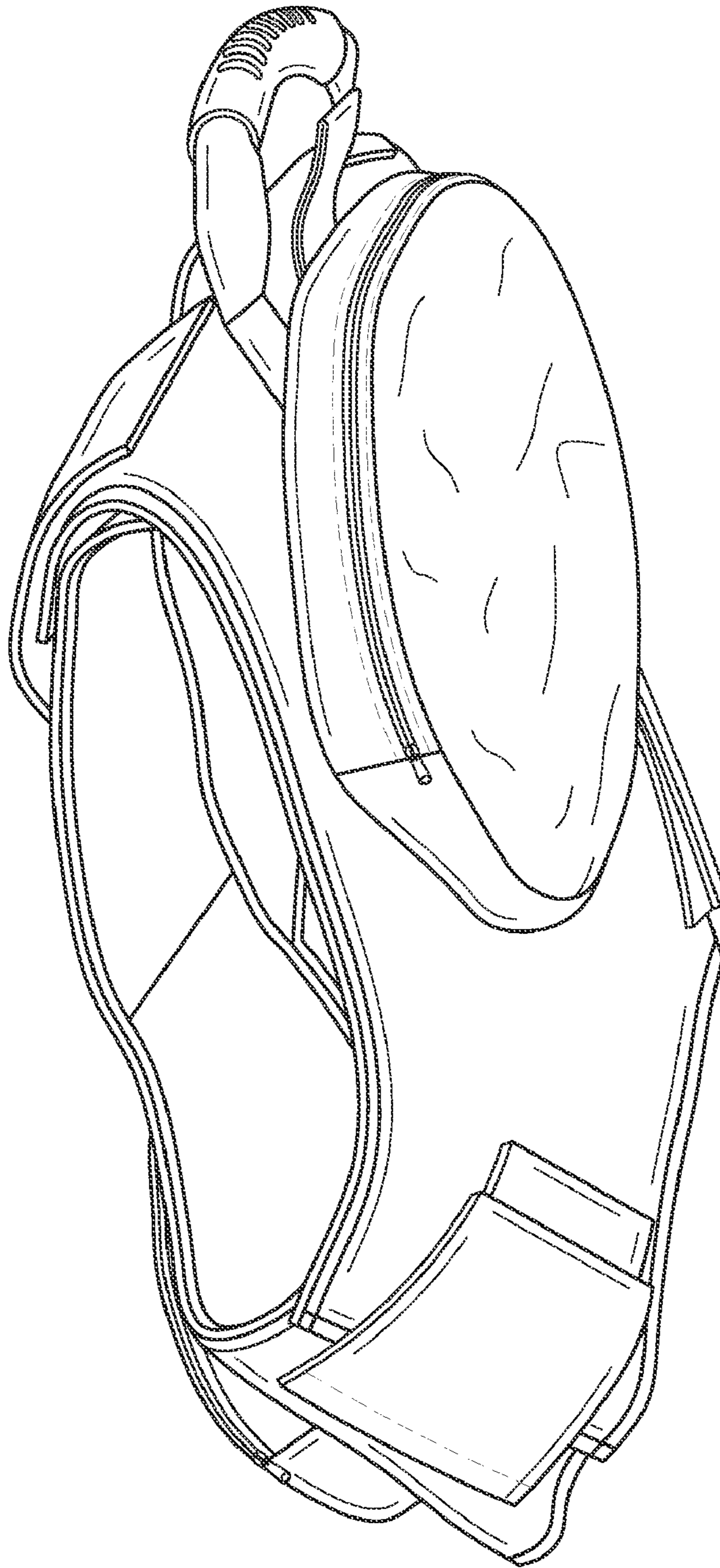

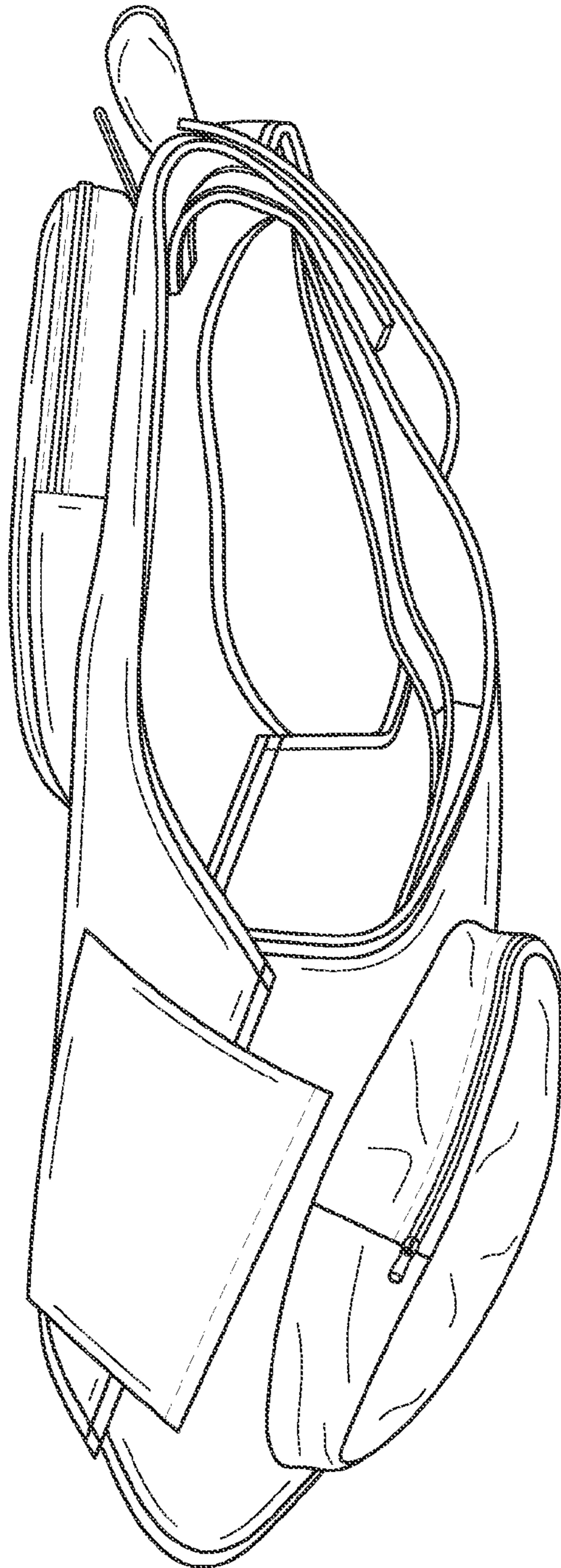
