FIG. 4 is an outer side view.

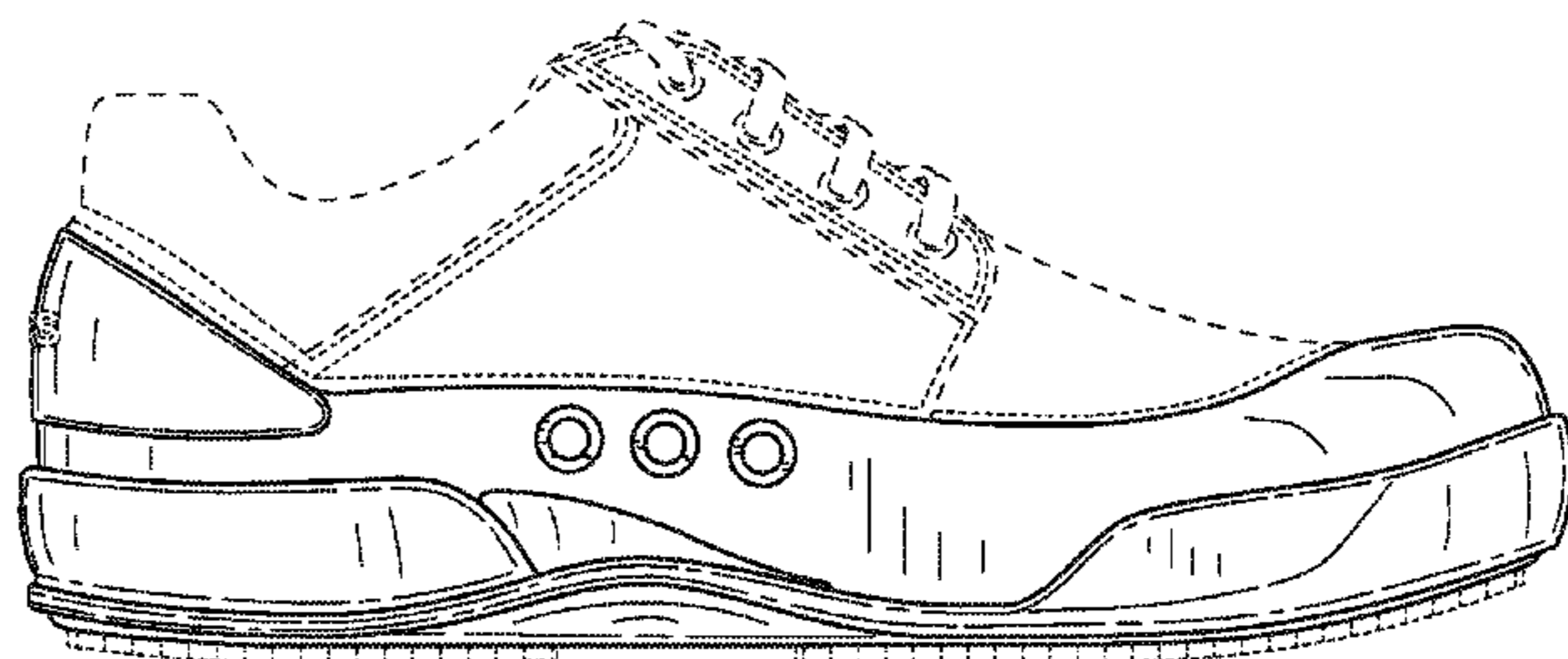
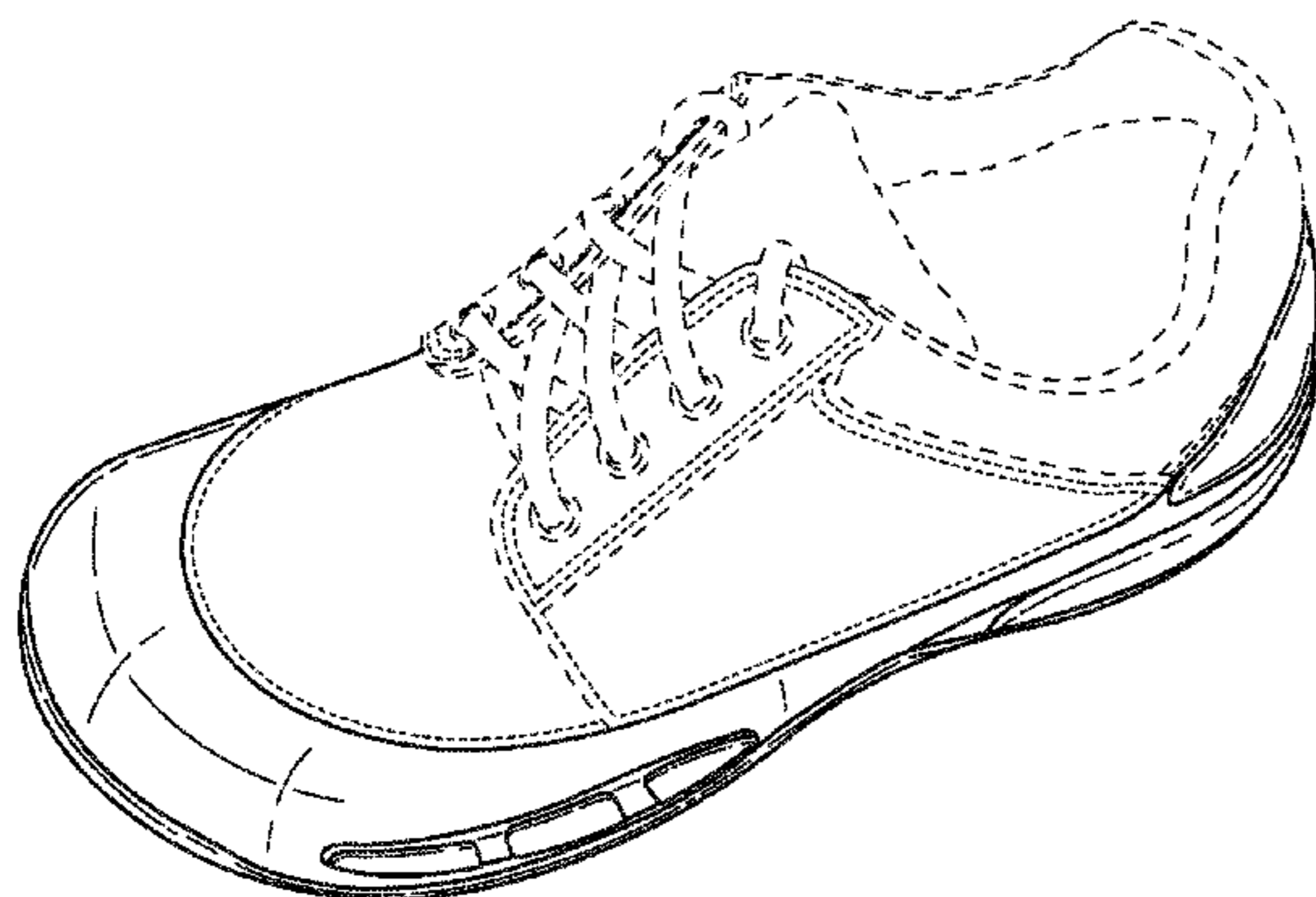
FIG. 5 is an inner side view.

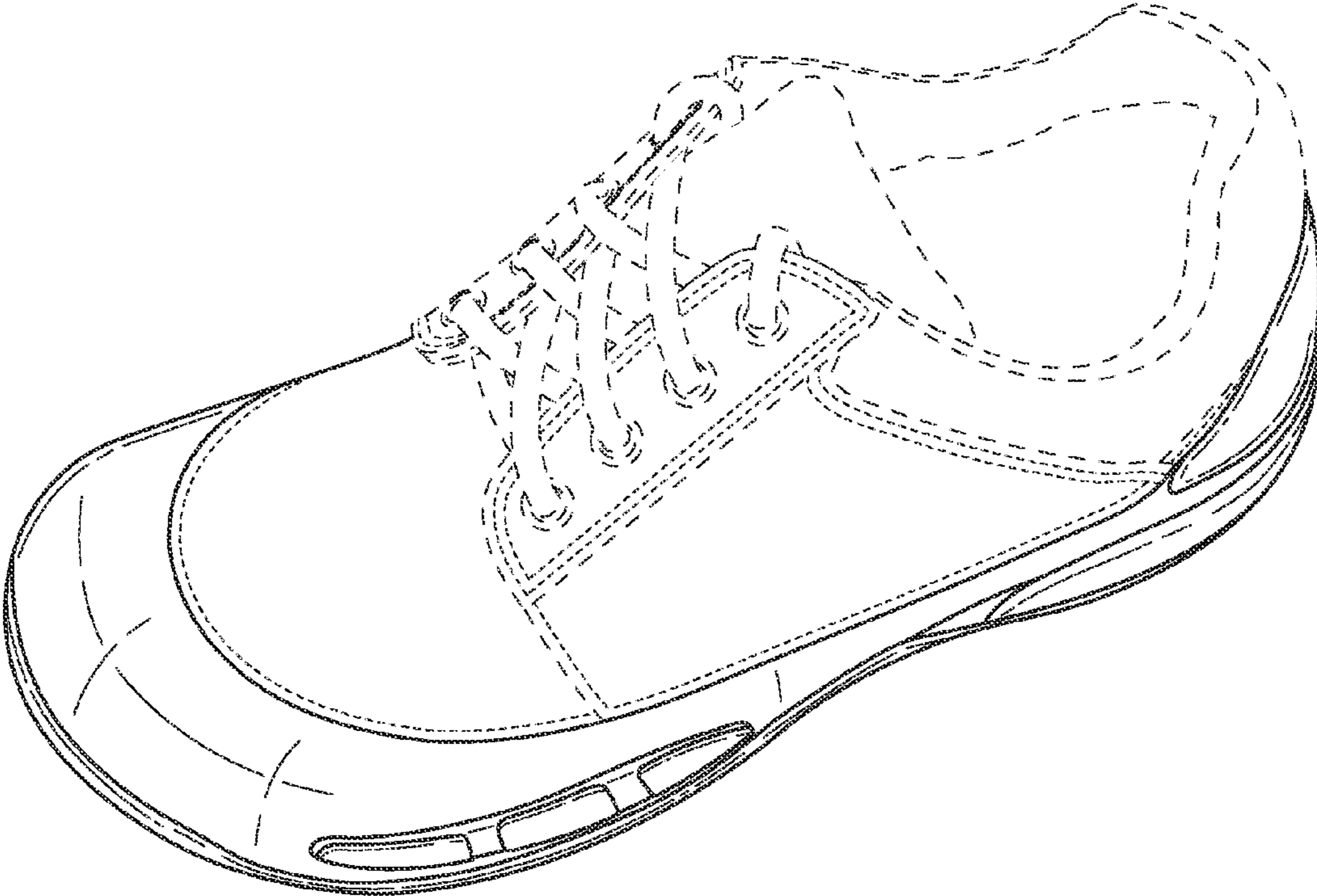

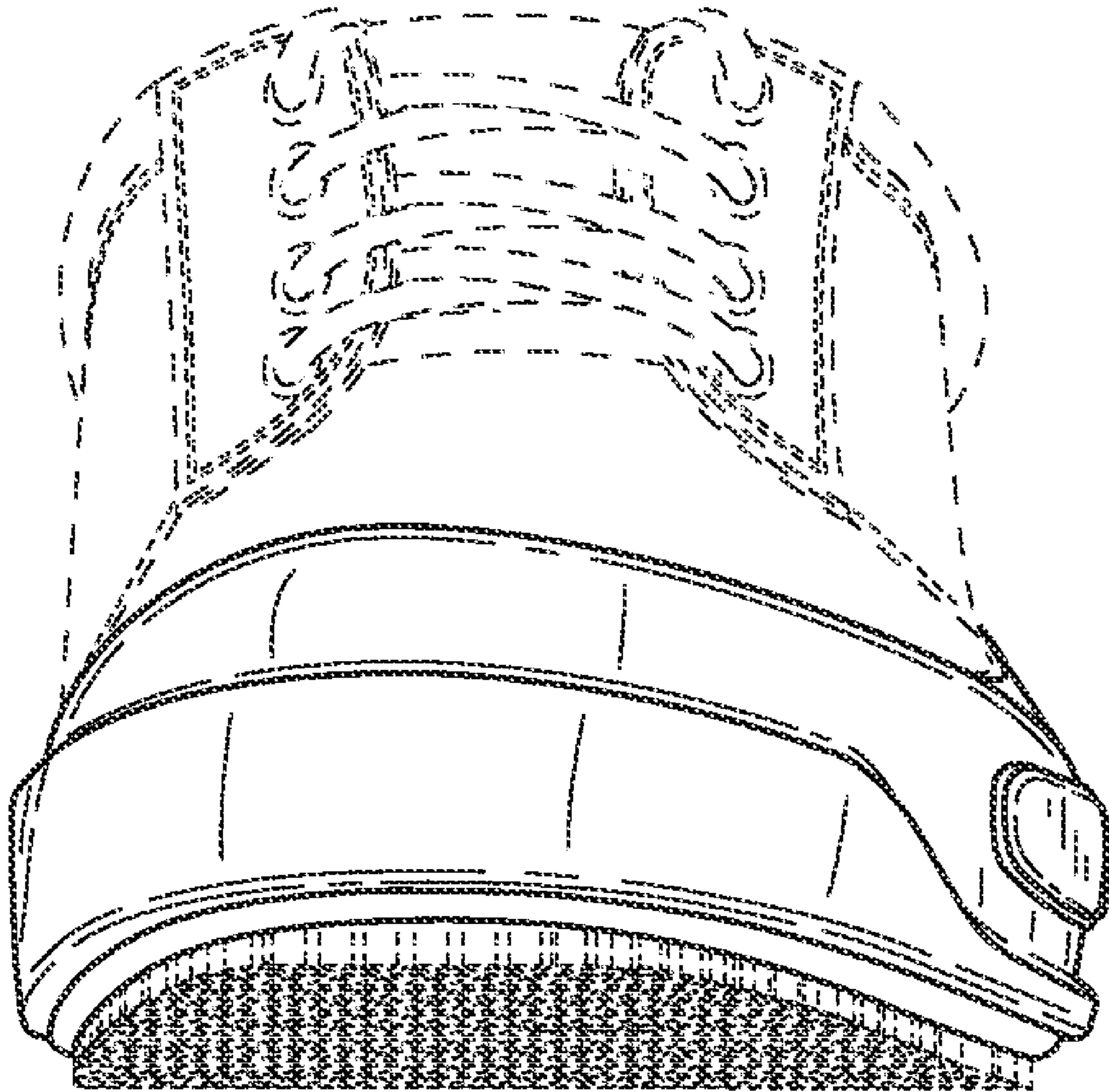

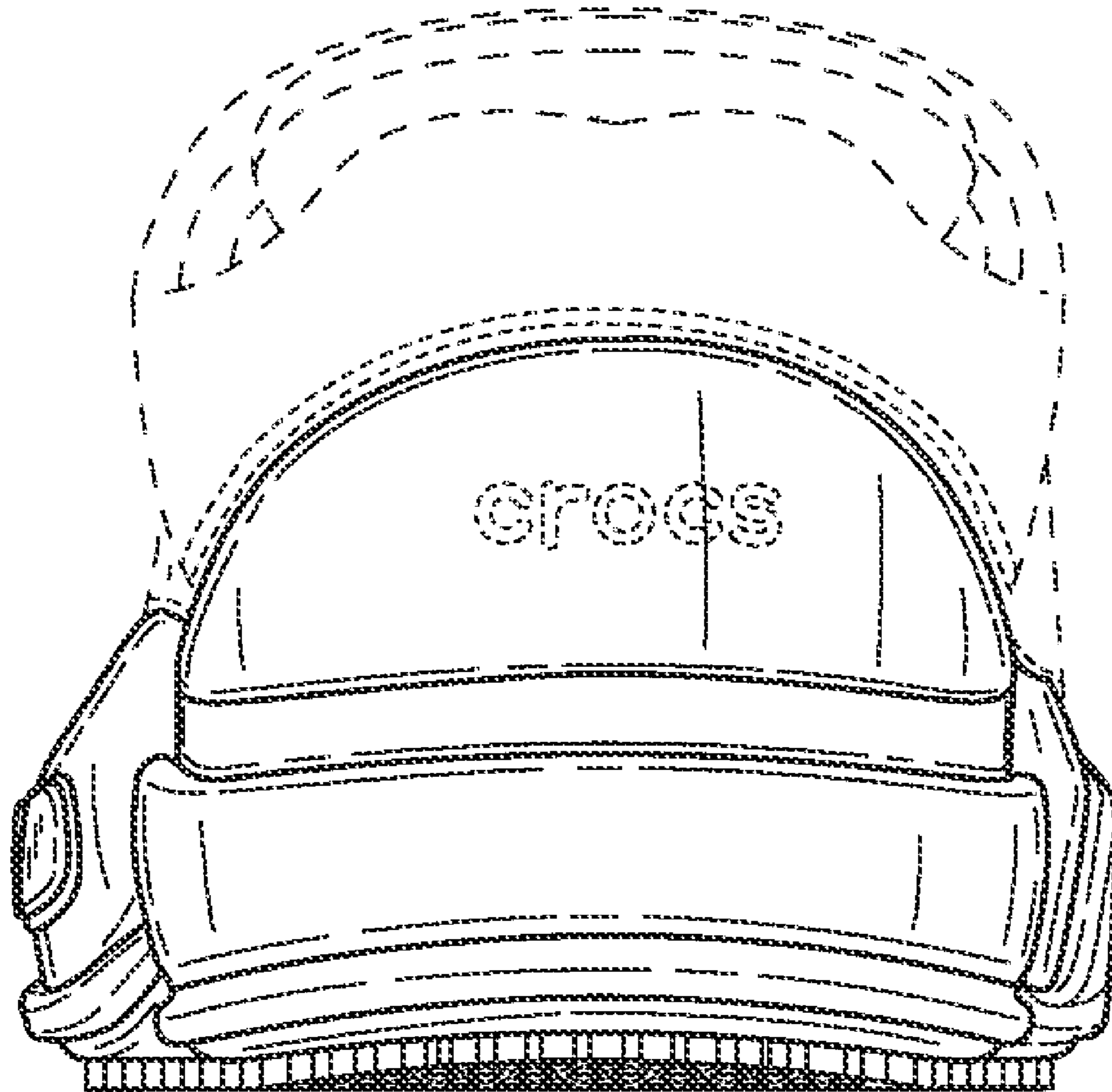

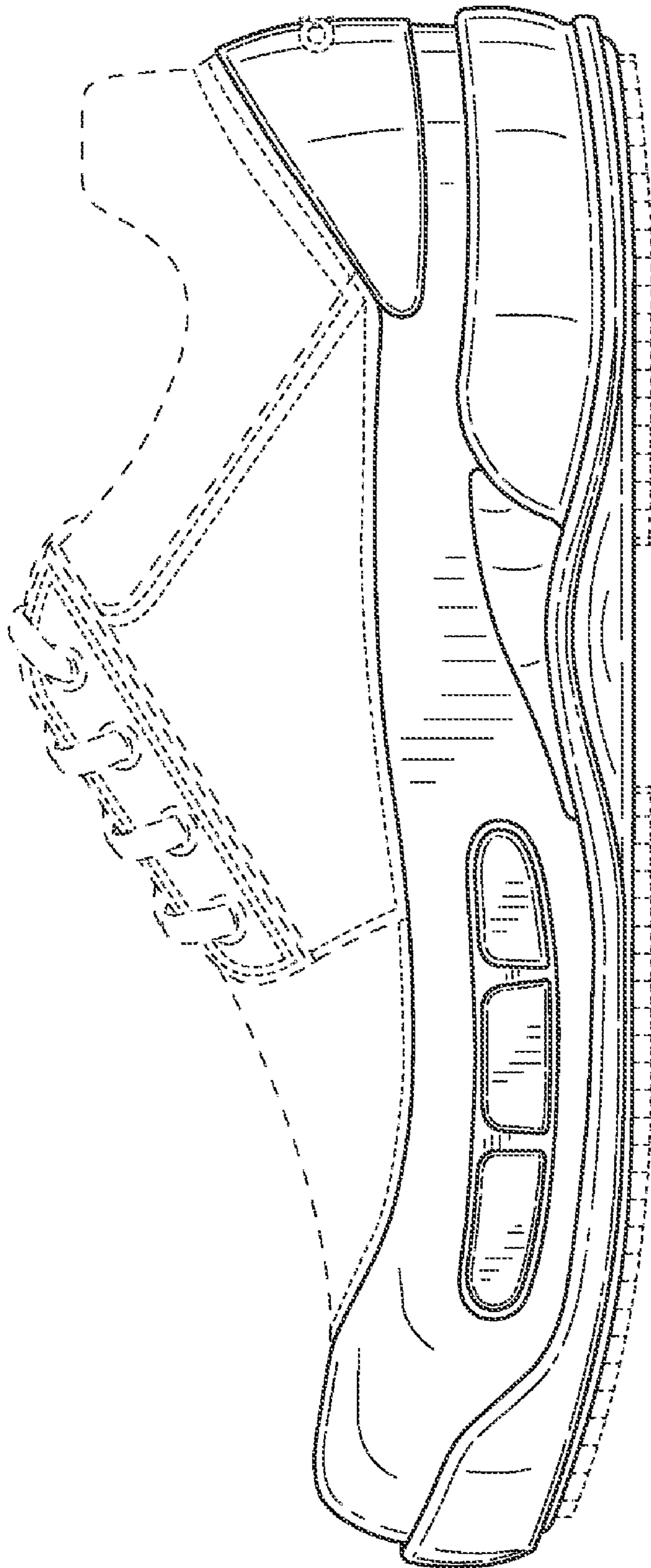

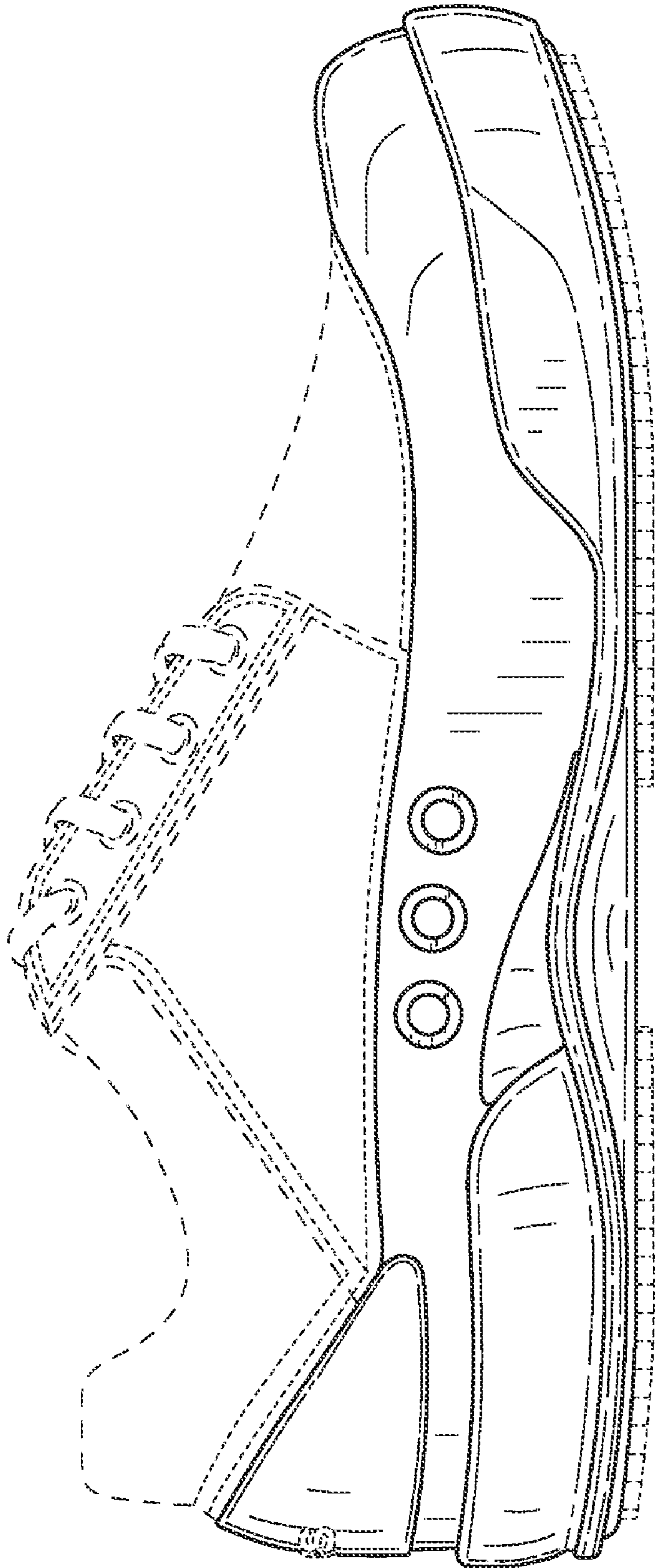

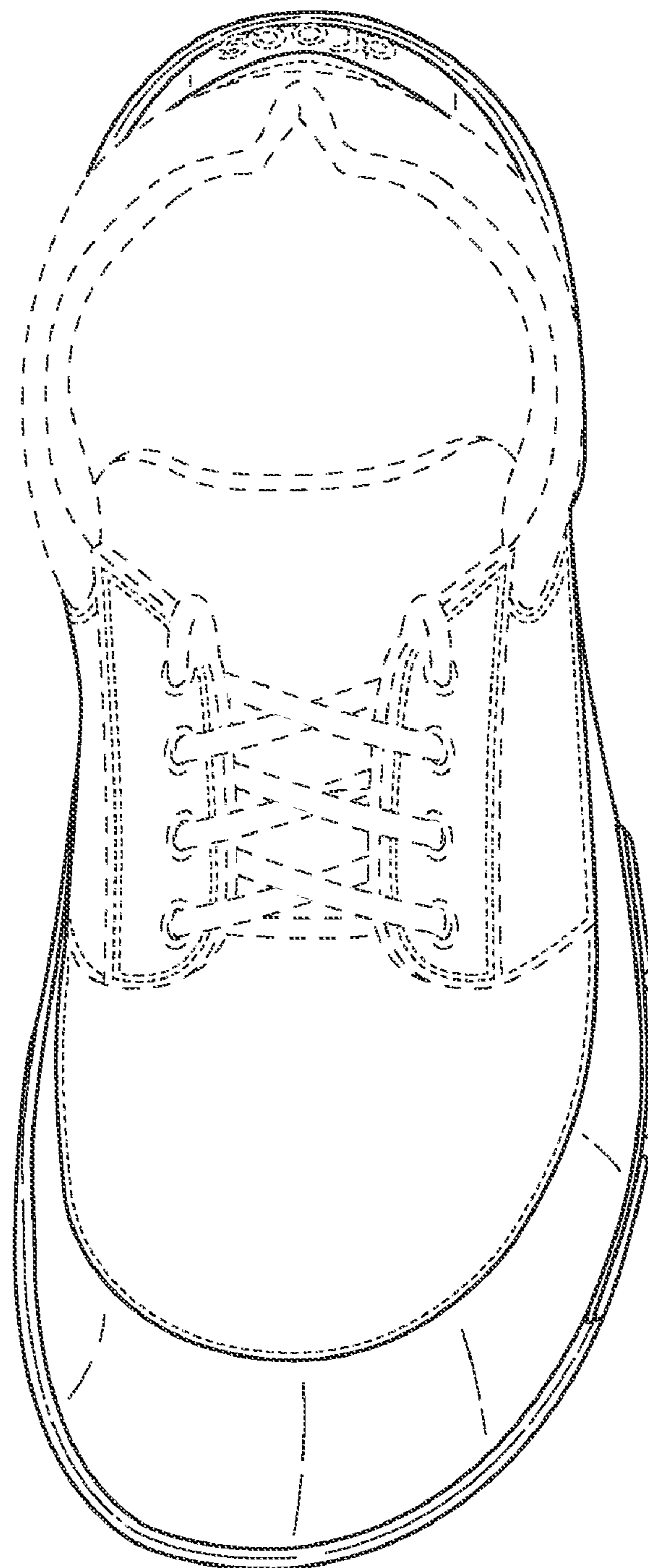

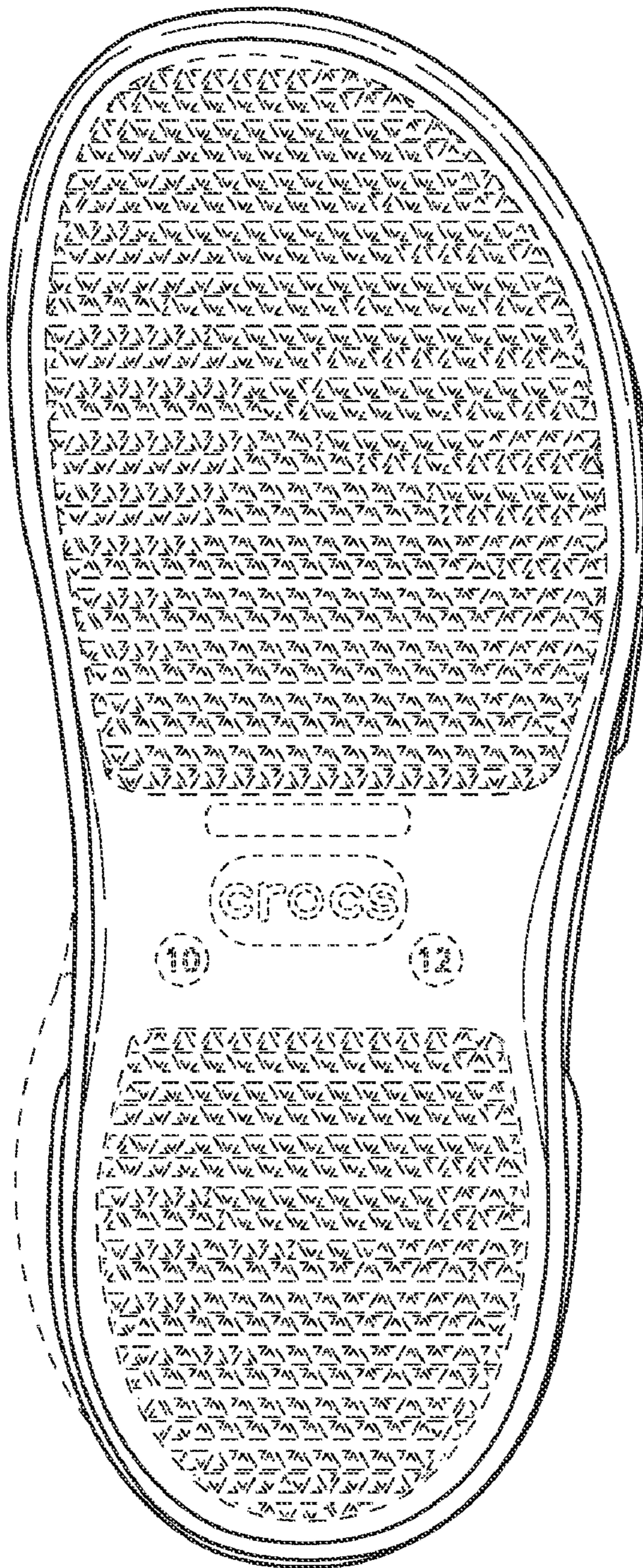
