(57) **CLAIM**

We claim the ornamental design for a door chest, as shown and described.

DESCRIPTION

FIG. 1 is a front corner perspective view of a door chest showing our new design. The view from the adjacent front corner being a mirror image thereof.

FIG. 2 is a front elevational view of a door chest thereof.

FIG. 3 is a side elevational view of a door chest thereof. The view from the opposite side being a mirror image thereof; and,

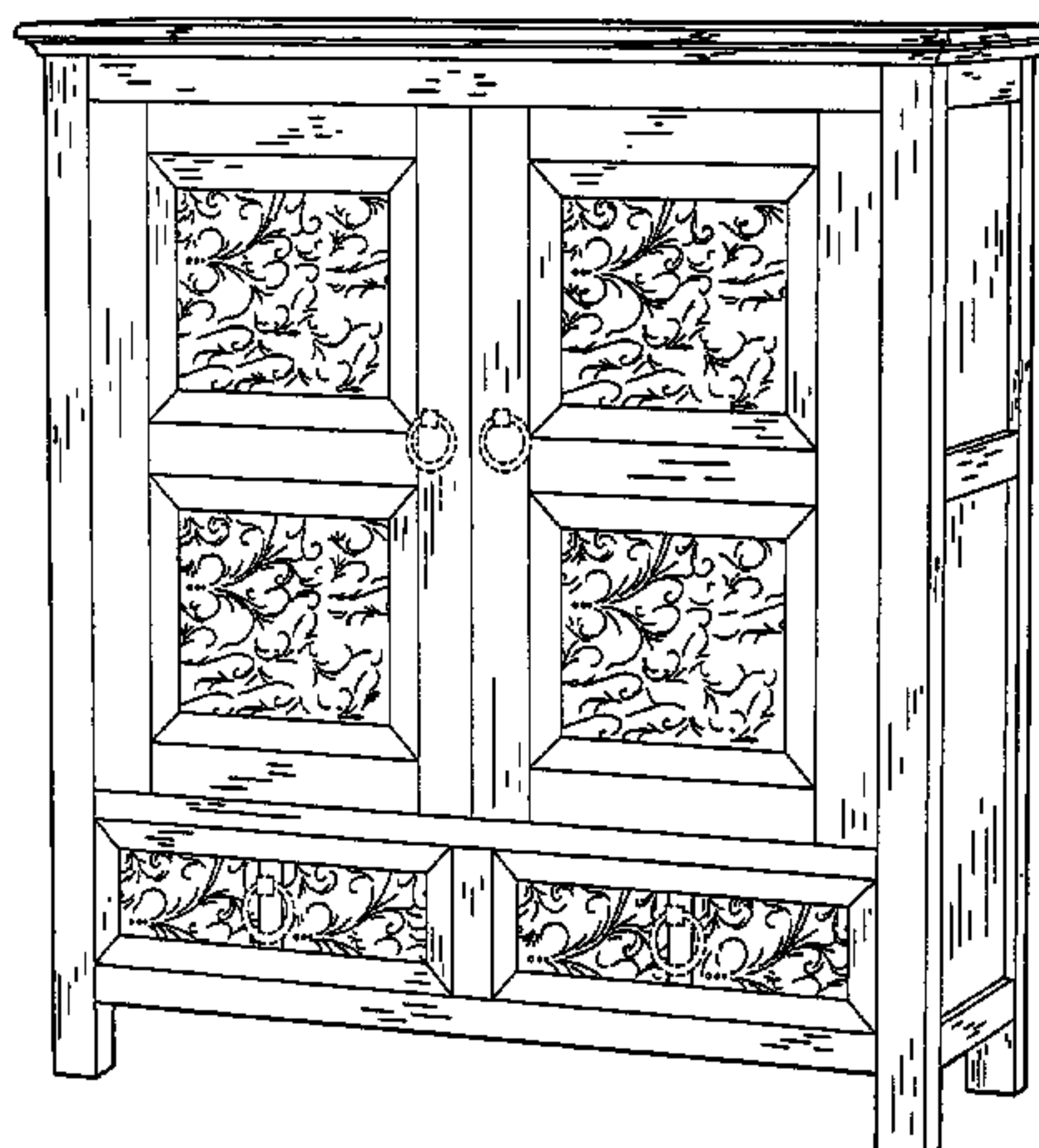
FIG. 4 is a top plan view of a door chest thereof.

The backside of the door chest is not shown and no part thereof is claimed as part of the invention.

The portions of the figures shown in dashed lines are for illustrative purposes only and form no part of the claimed invention.

The randomly organized symbols depicting stamped metal surfaces shown on the faces of the upper doors and lower drawers, illustrate a contrast in materials with respect to the surfaces without such randomly organized symbols.

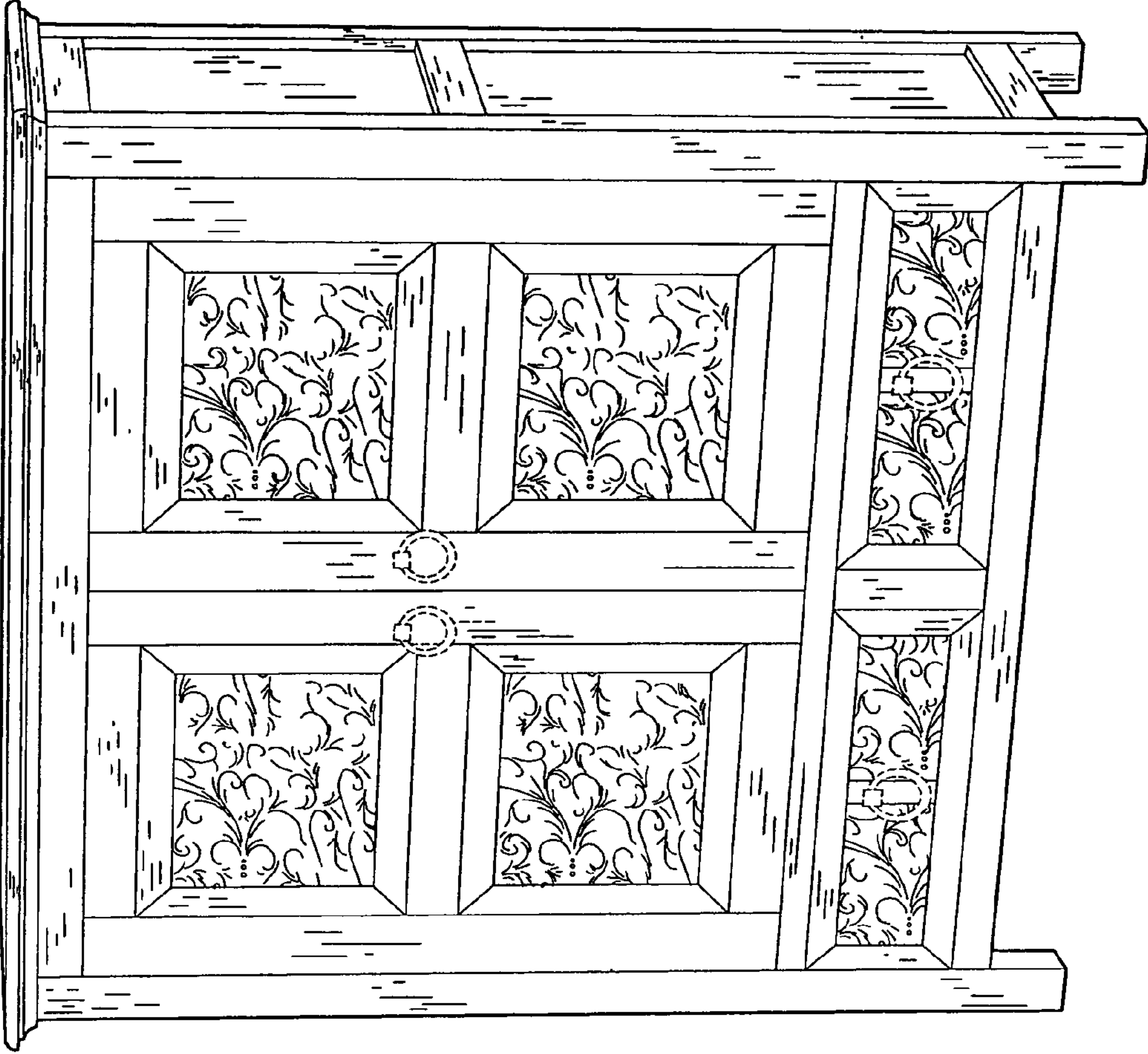

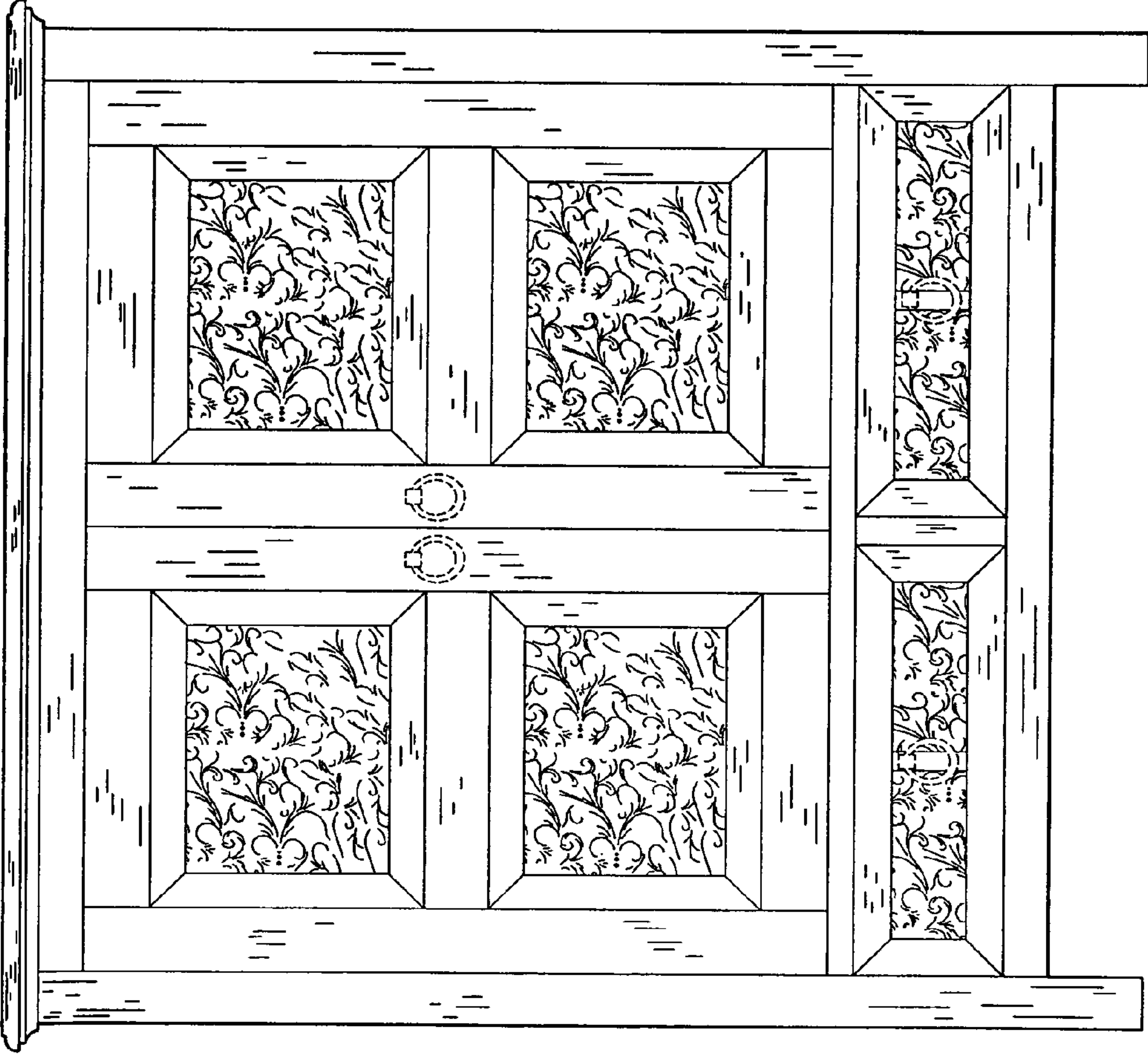

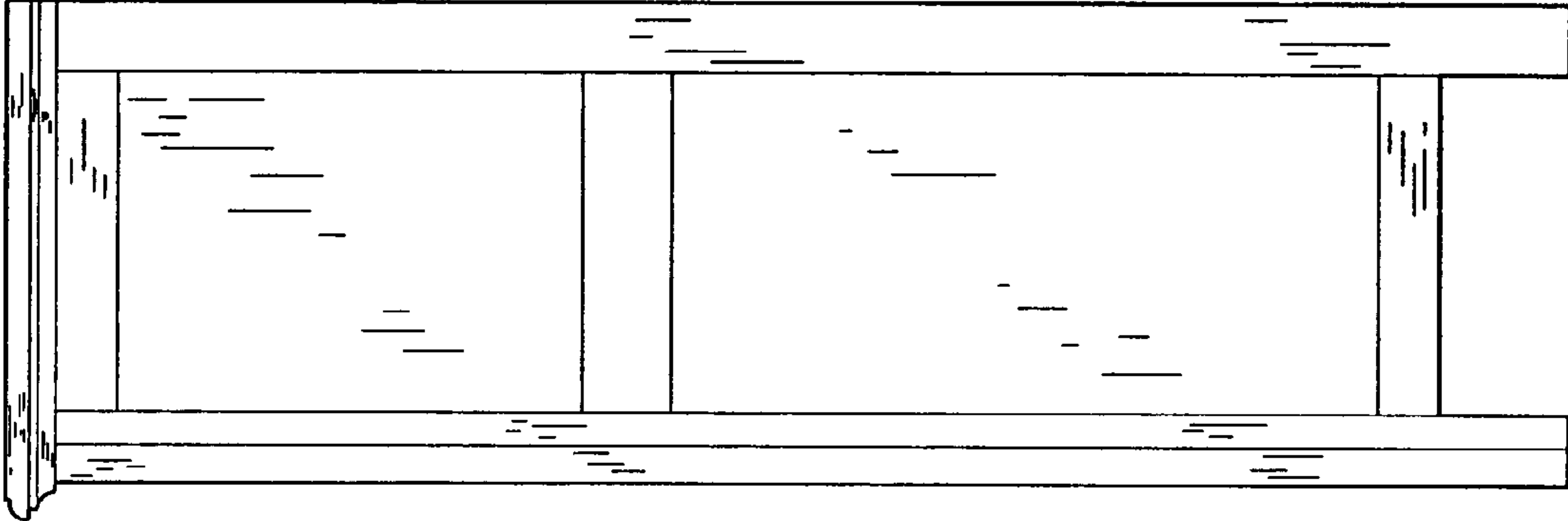

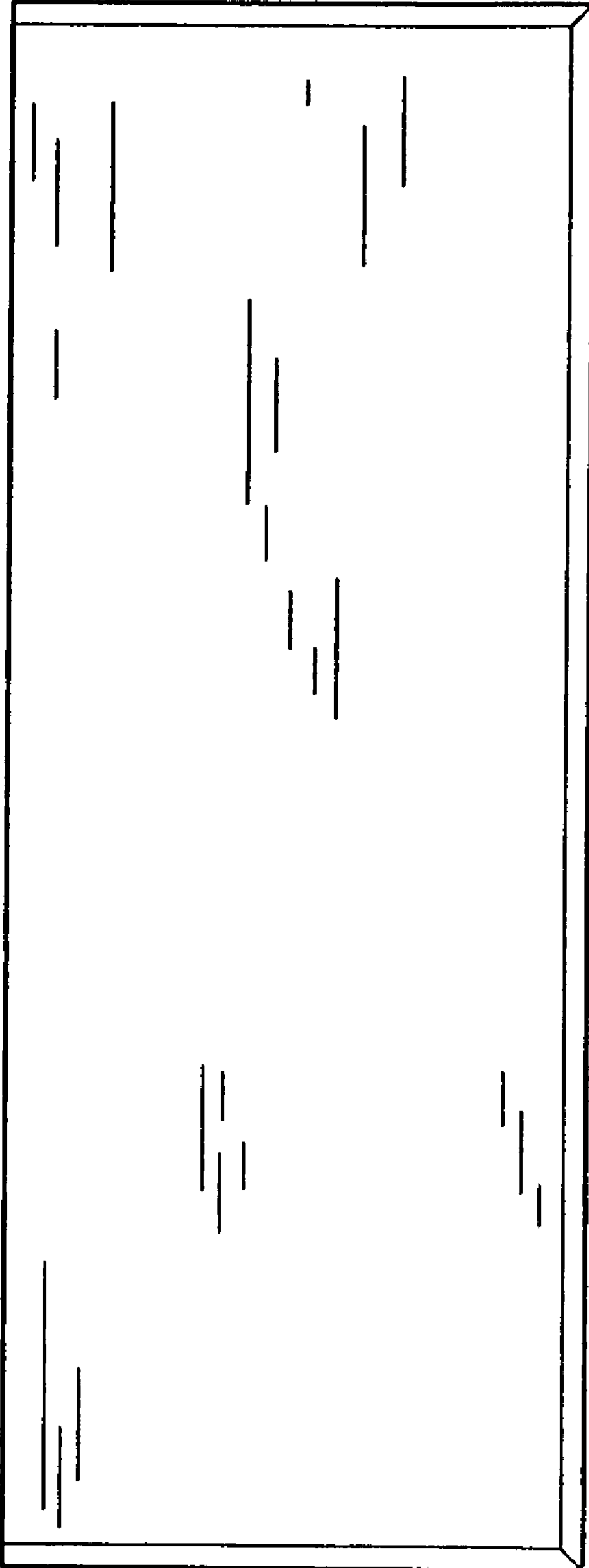
