The ornamental design for a handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment and a second embodiment of a handle of the new design;

FIG. 2 is a front elevational view of the first embodiment of the handle of FIG. 1;

FIG. 3 is a rear elevational view of the first embodiment of the handle of FIG. 1;

FIG. 4 is a left side elevational view of the first embodiment of the handle of FIG. 1;

FIG. 5 is a right side elevational view of the first embodiment of the handle of FIG. 1;

FIG. 6 is a top plan view of the first embodiment of the handle of FIG. 1;

FIG. 7 is a front elevational view of the second embodiment of the handle of FIG. 1;

FIG. 8 is a rear elevational view of the second embodiment of the handle of FIG. 1;

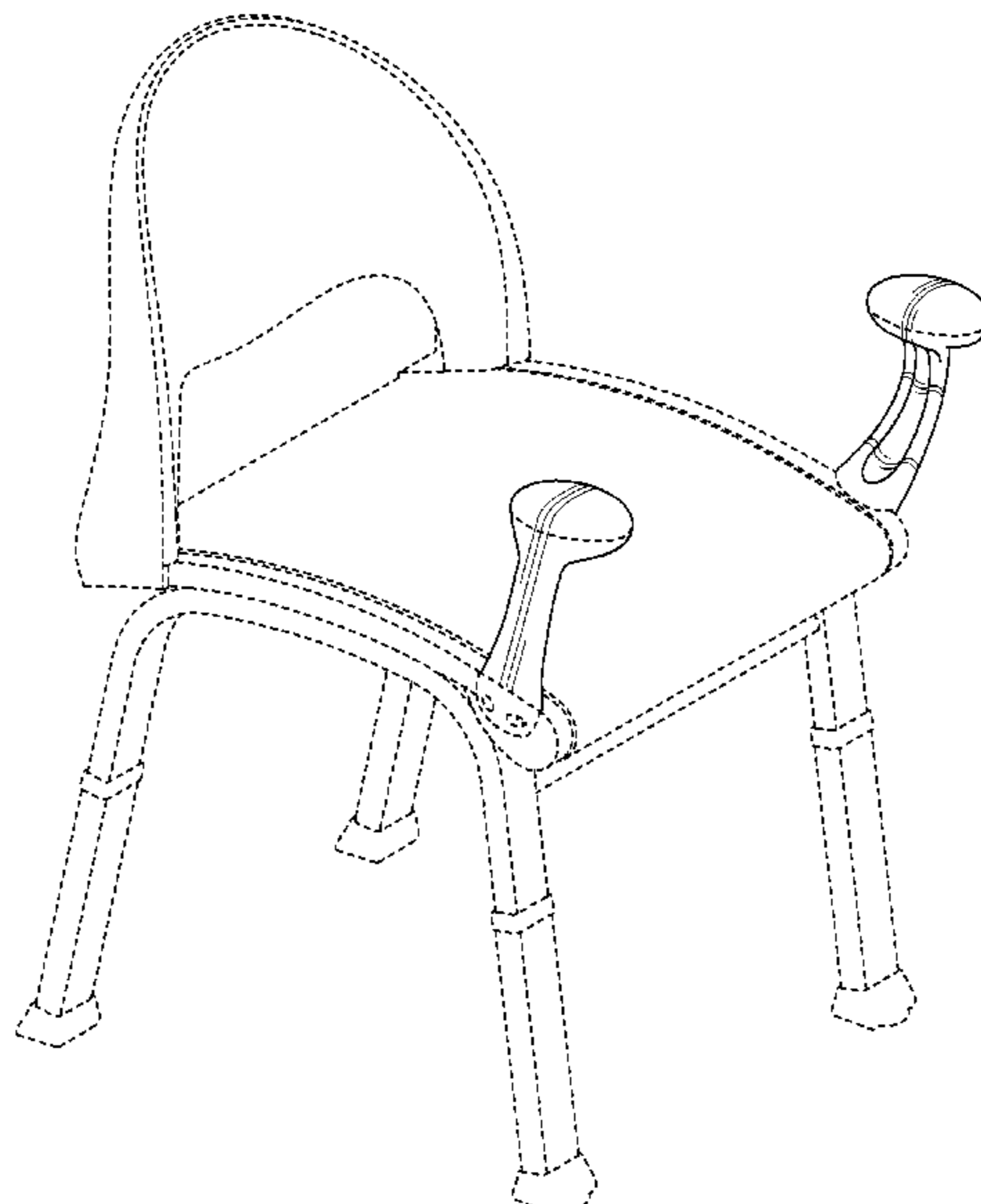
FIG. 9 is a left side elevational view of the second embodiment of the handle of FIG. 1;

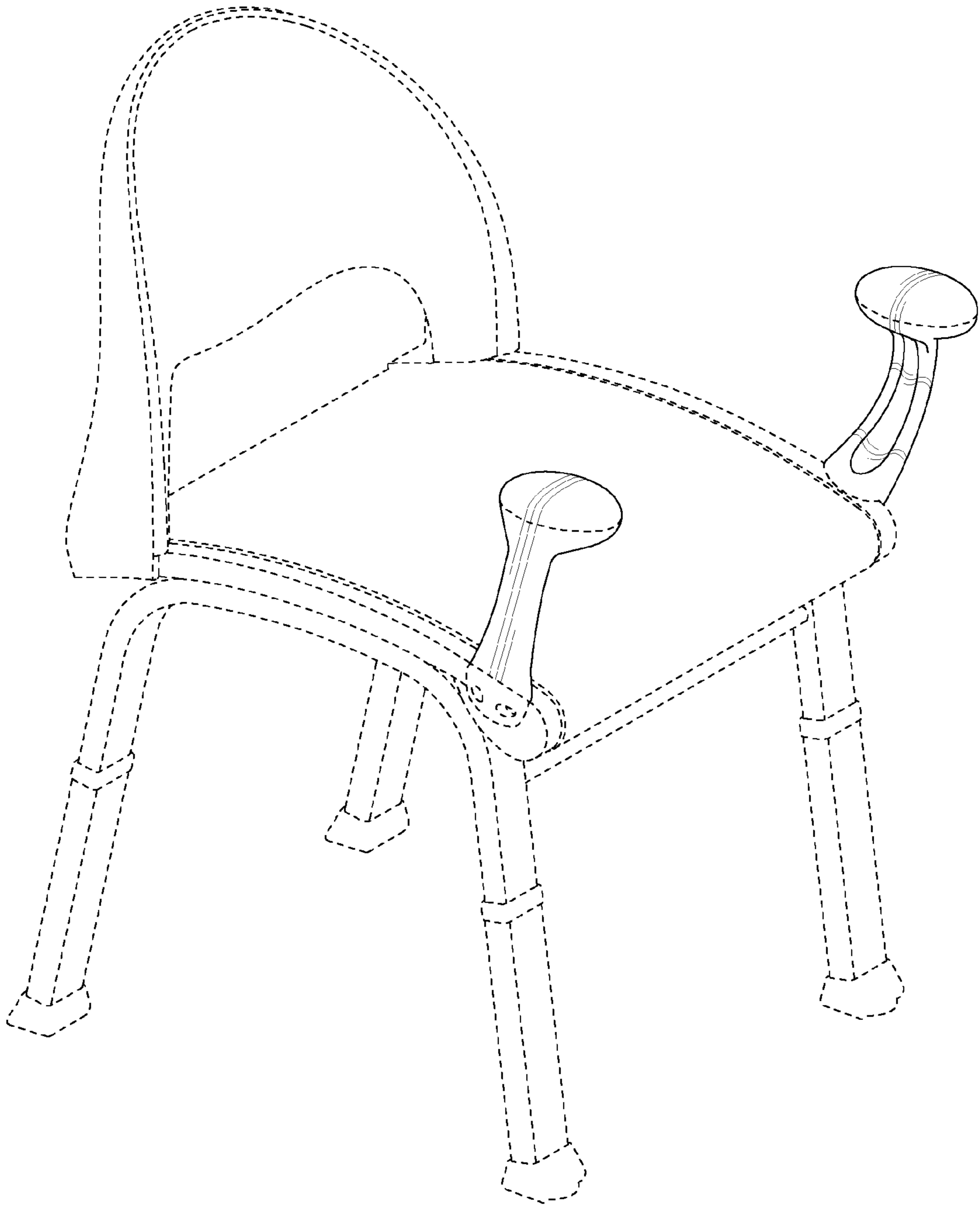

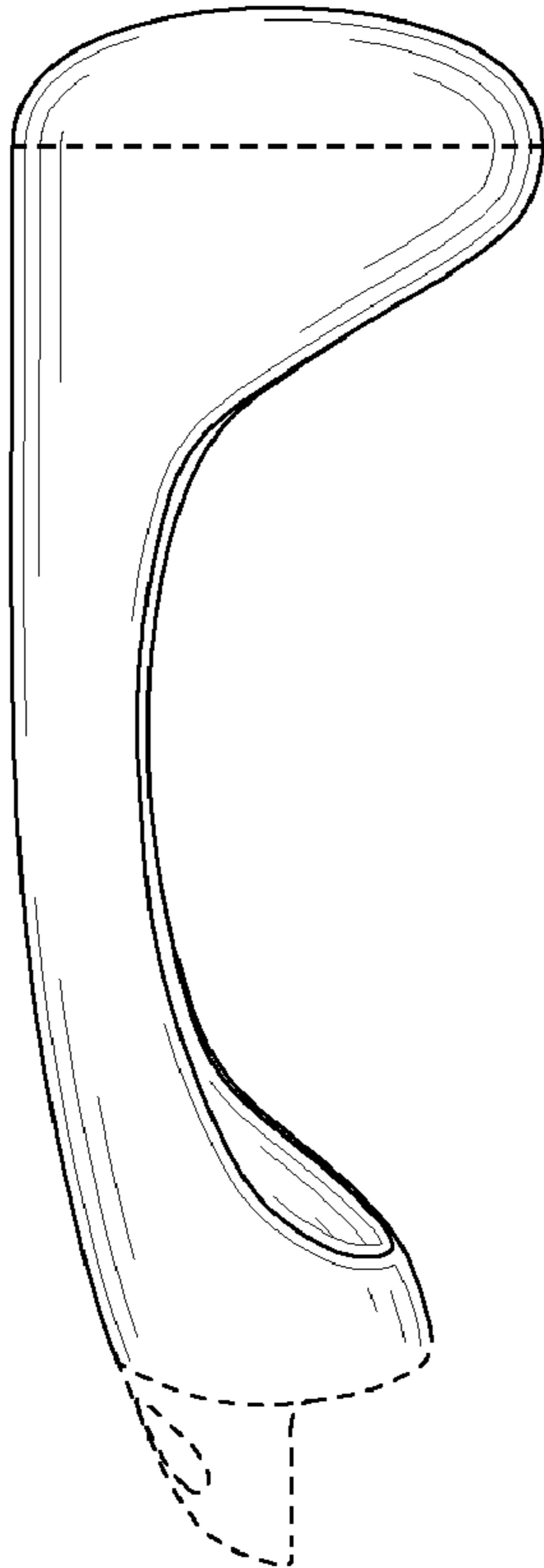

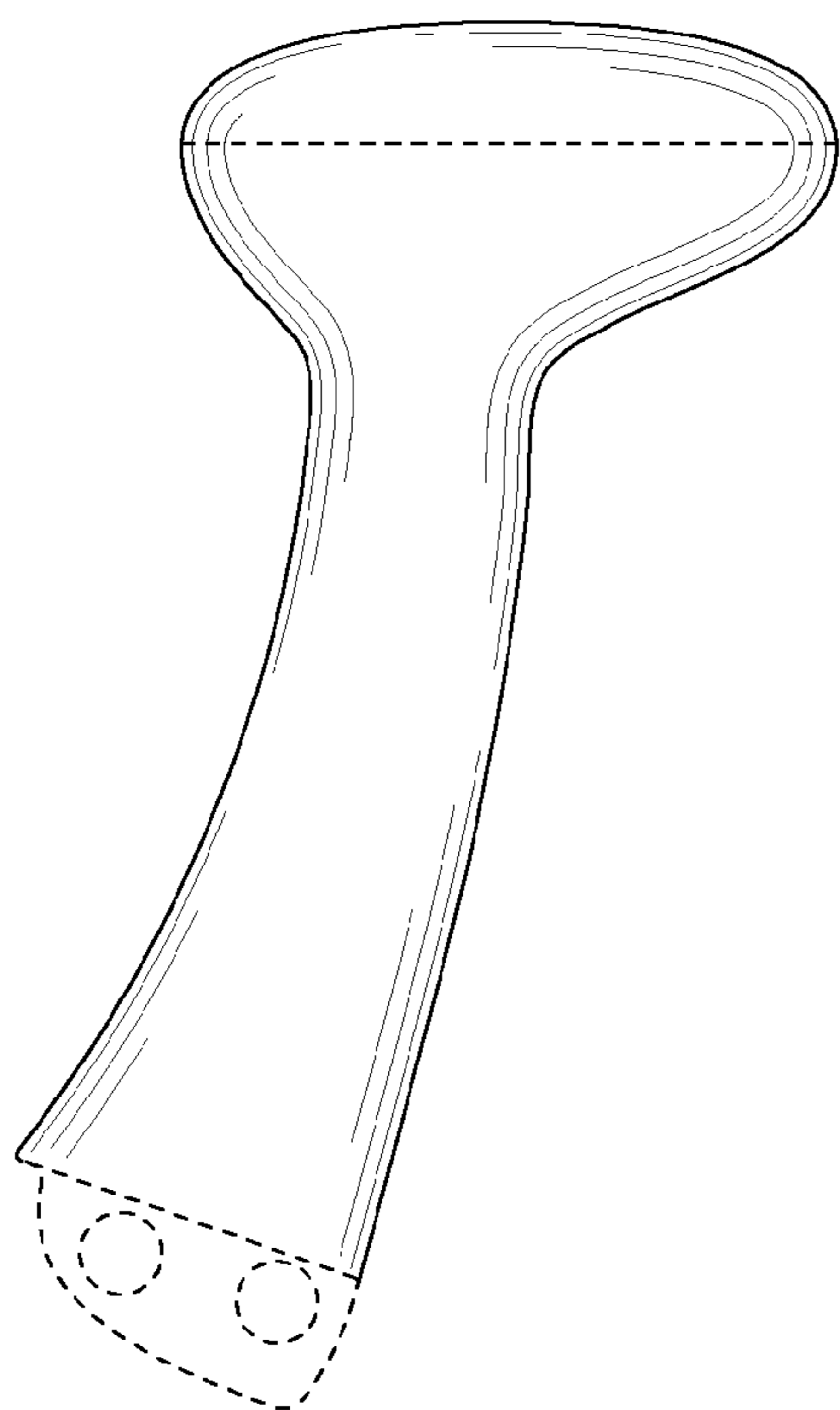

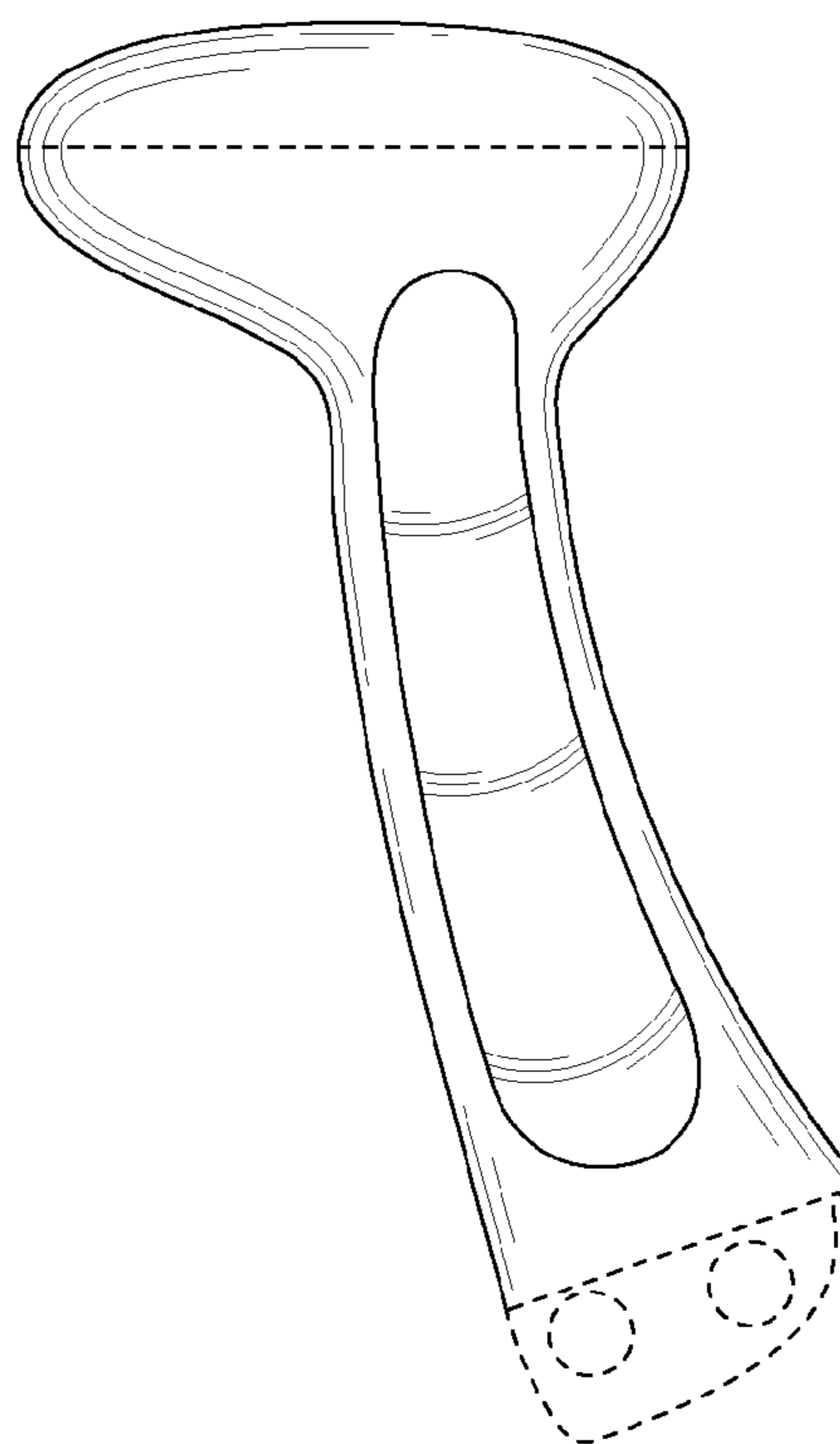

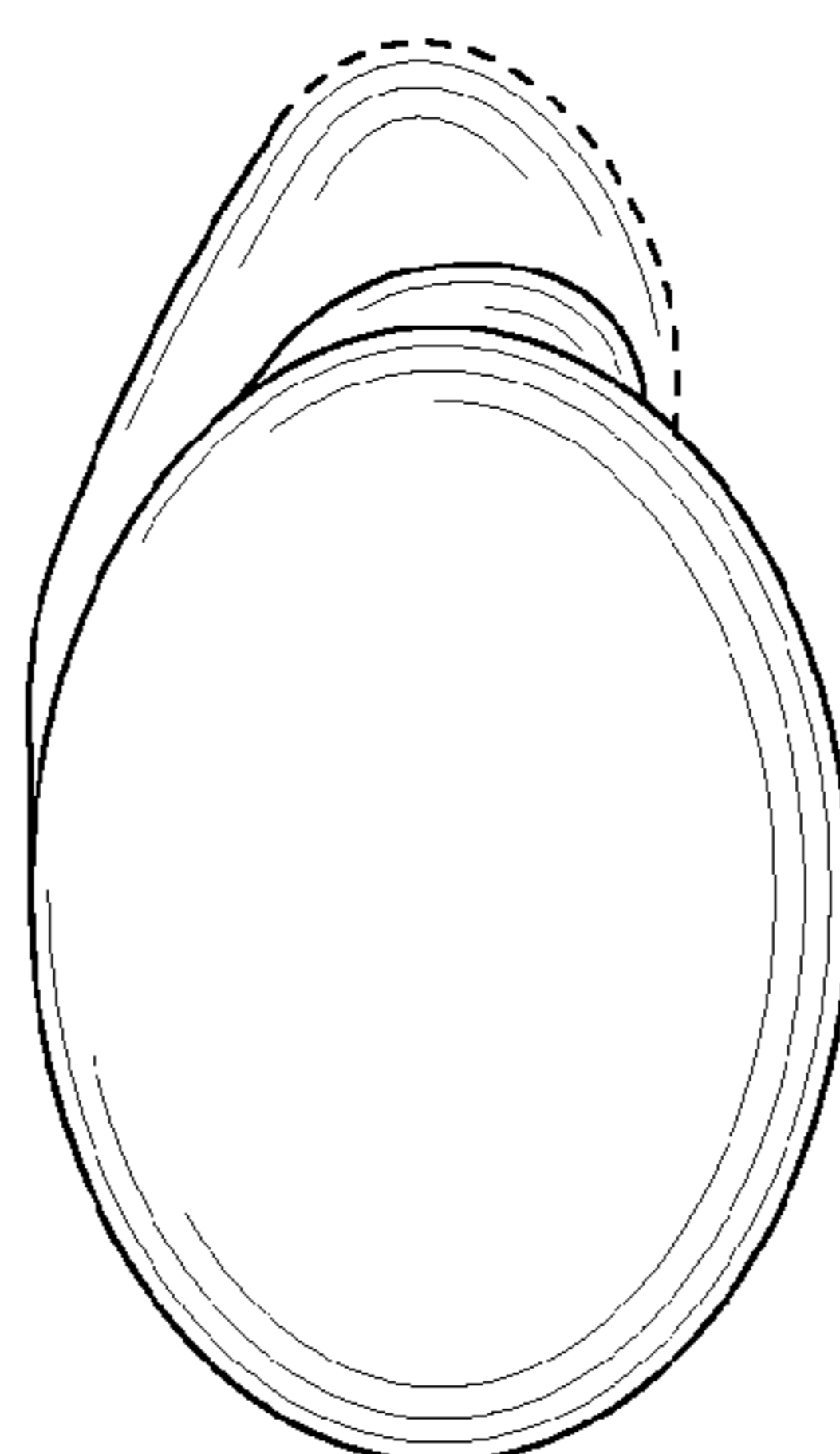

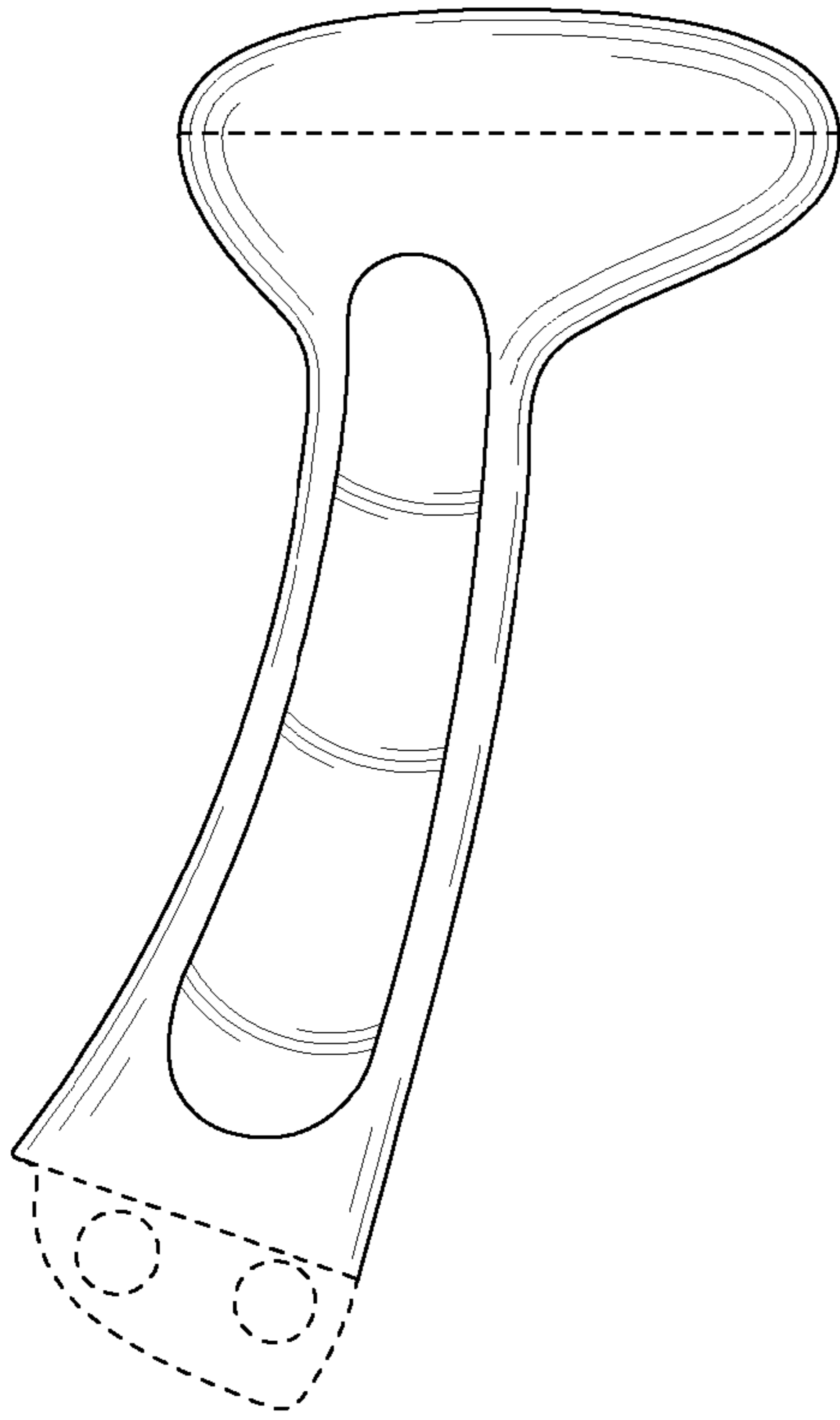

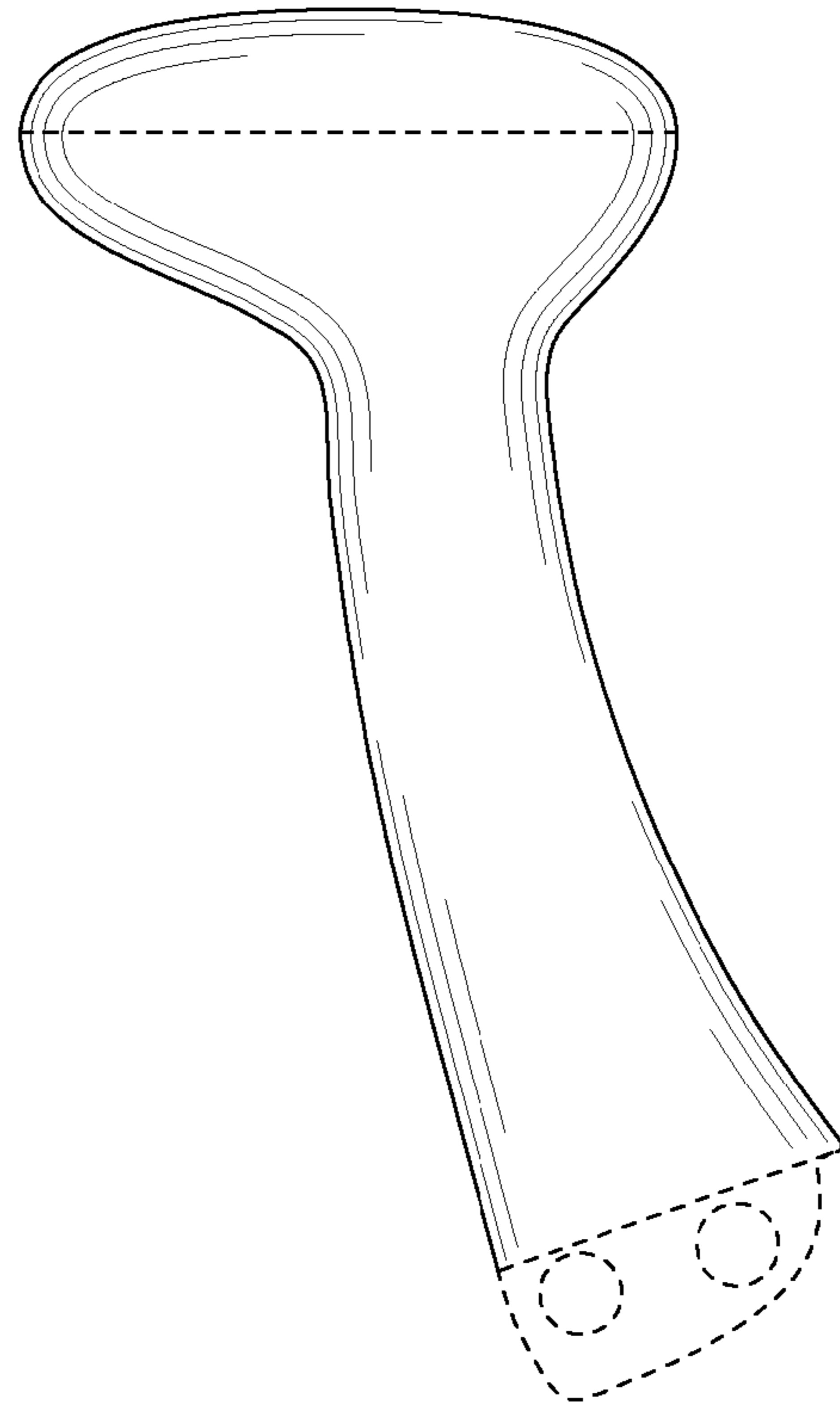

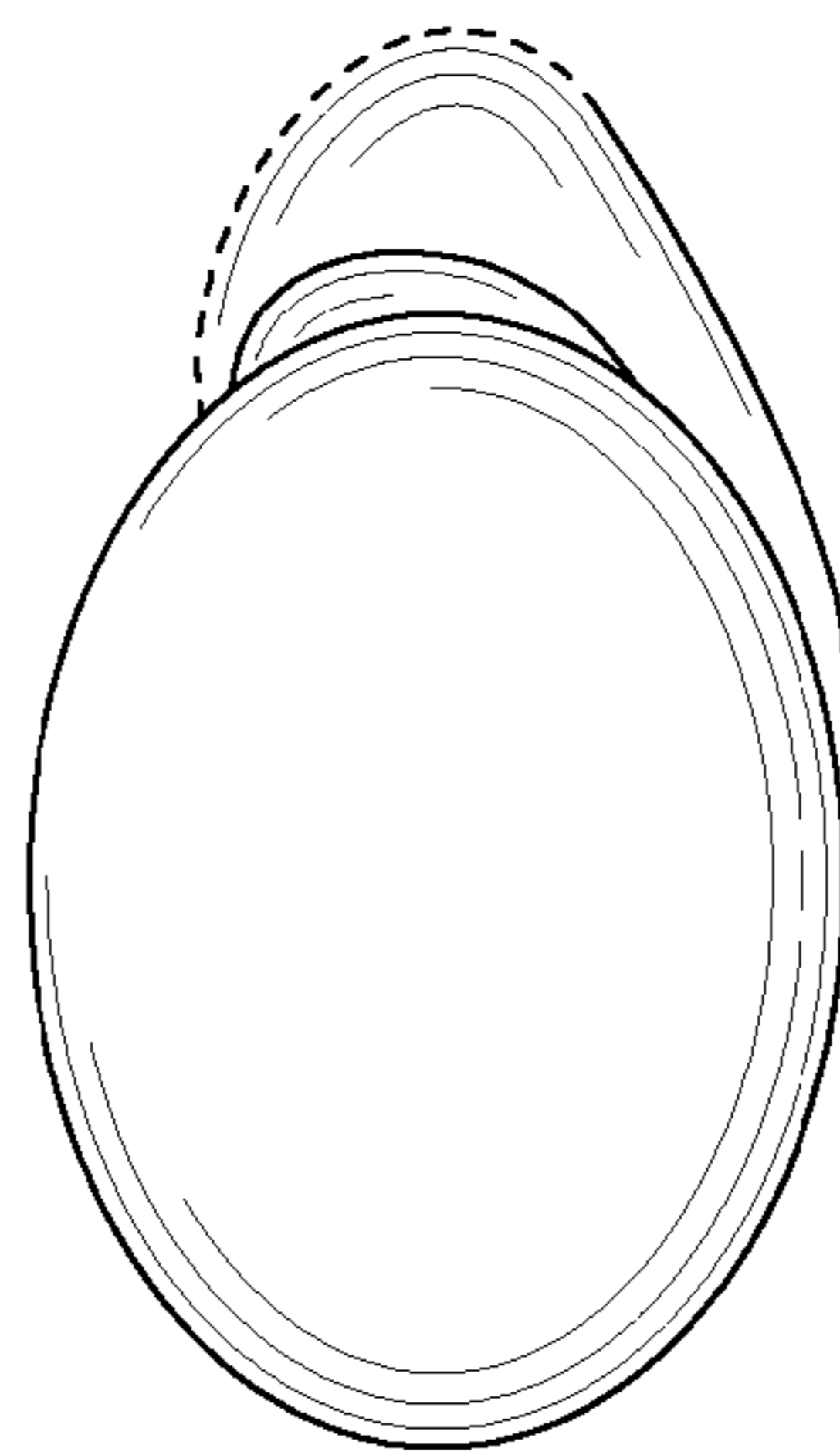
