FIG. 24 is a top plan view thereof;

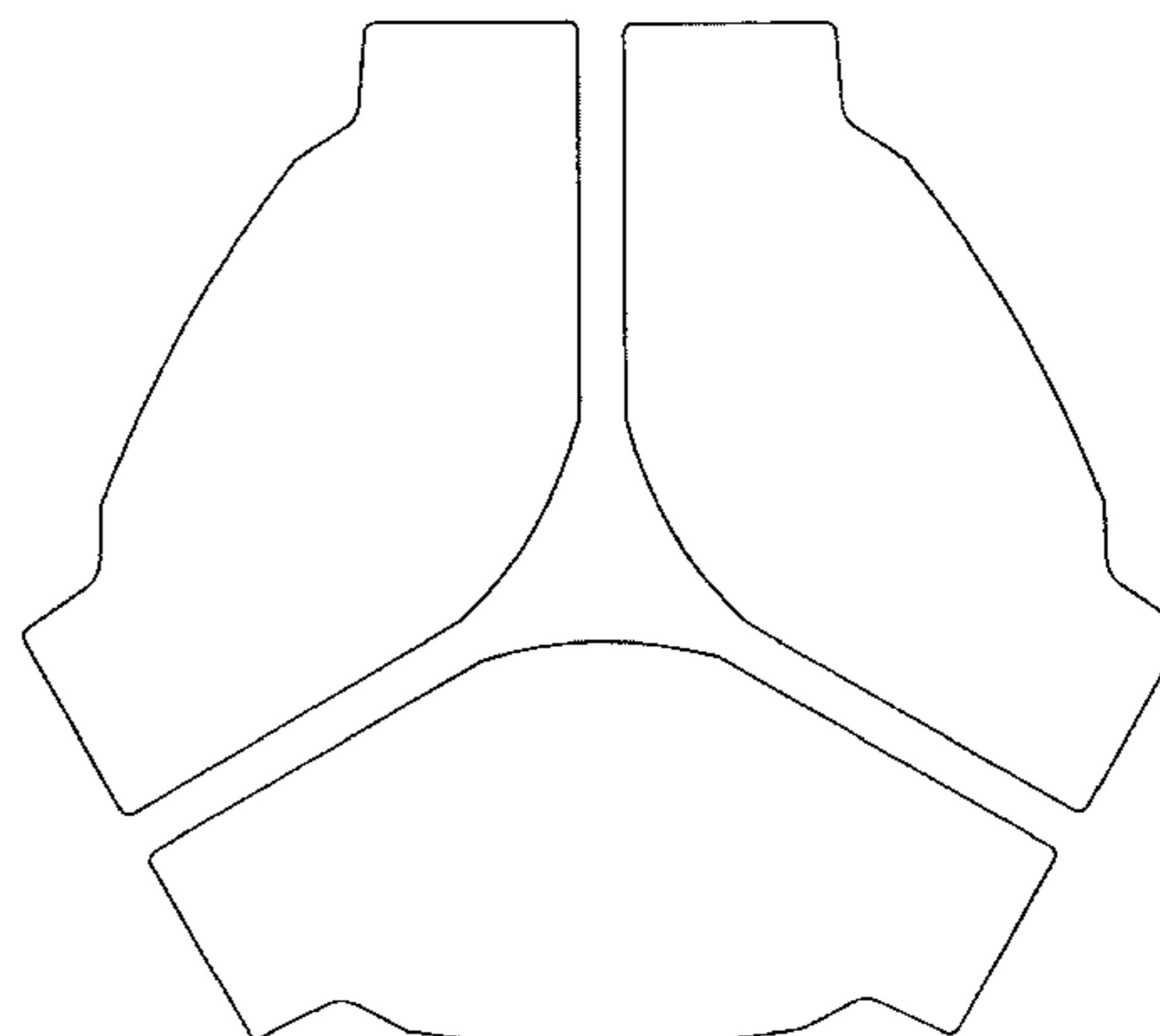
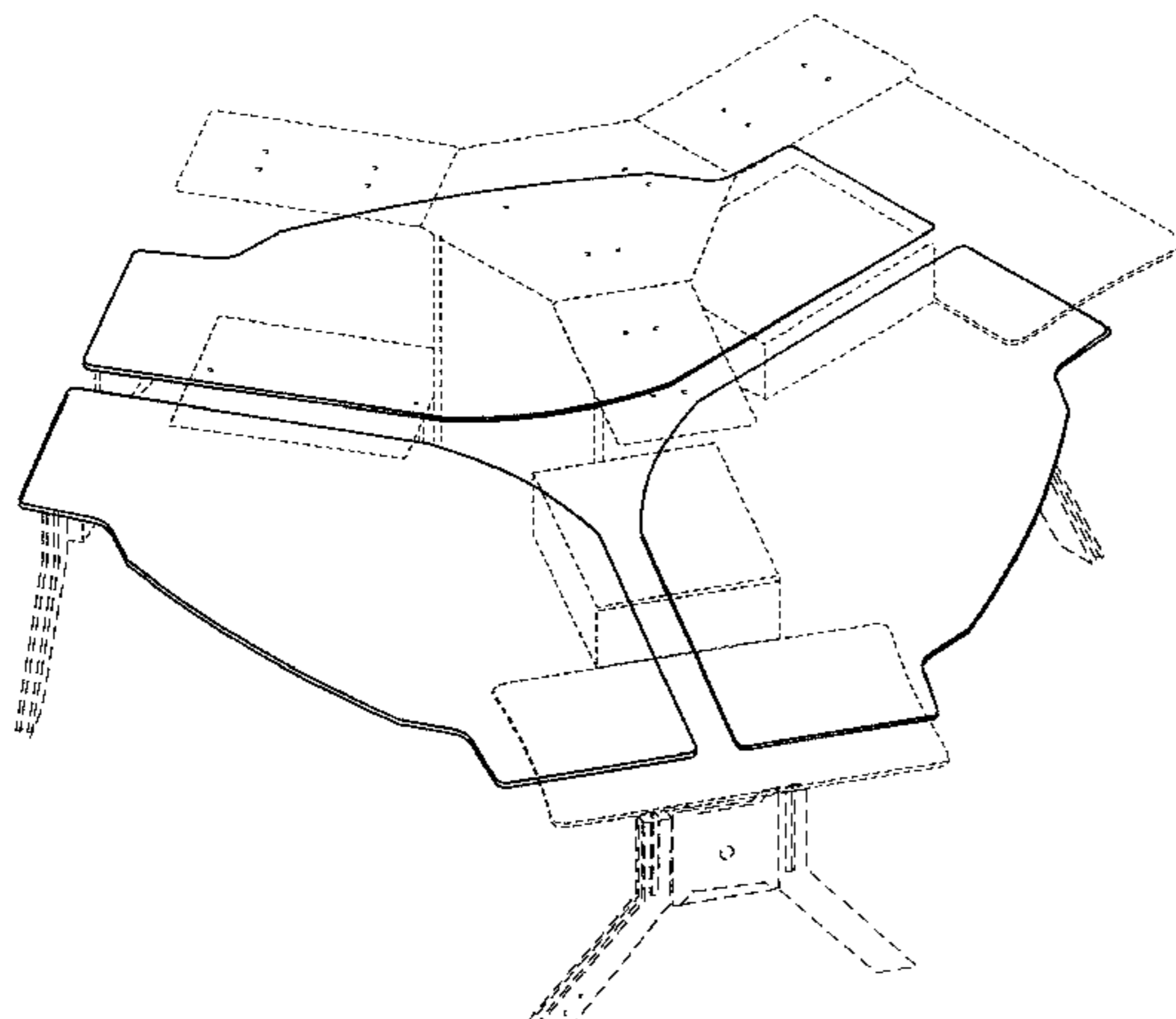
FIG. 25 is an elevational front view thereof;

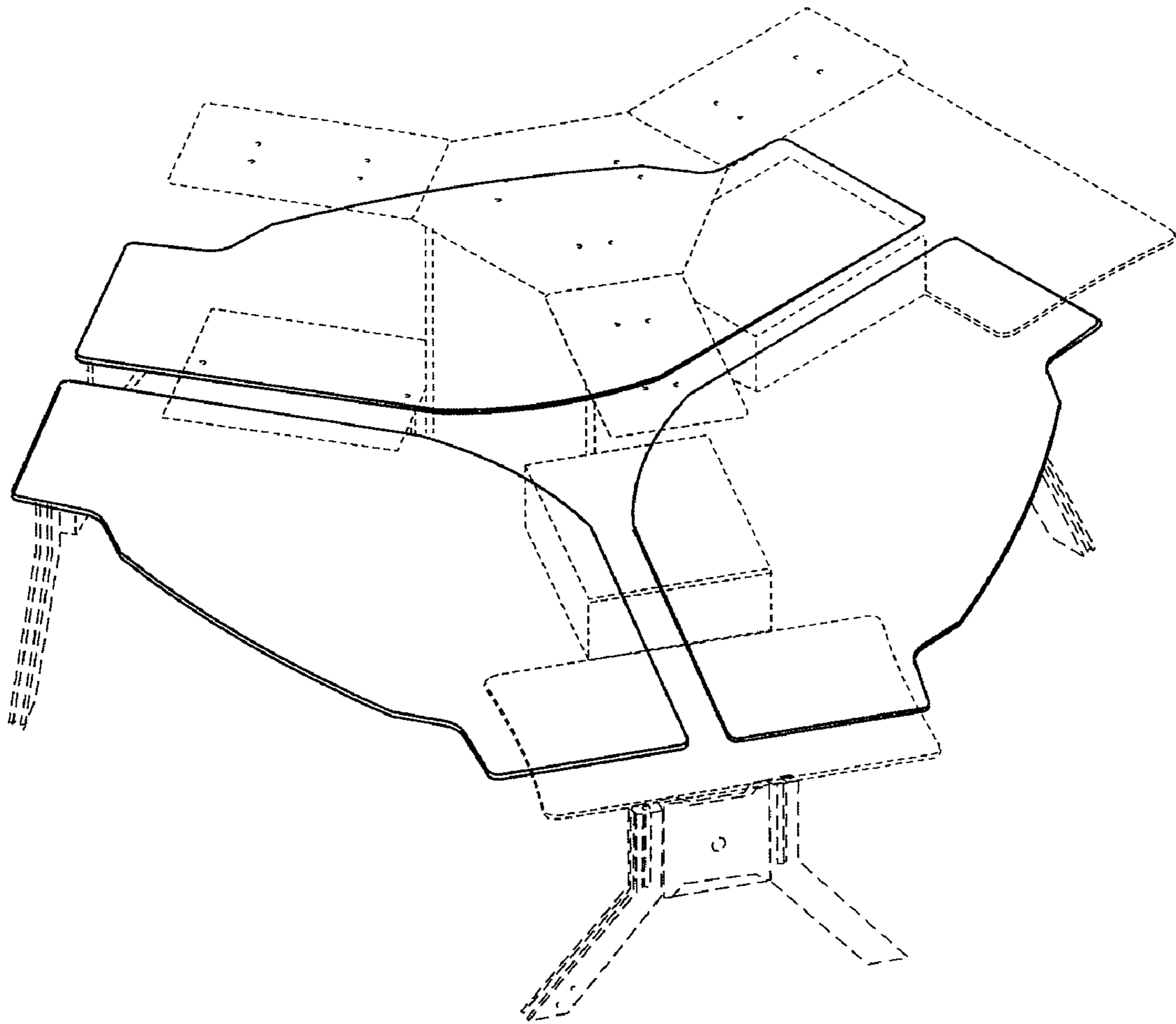

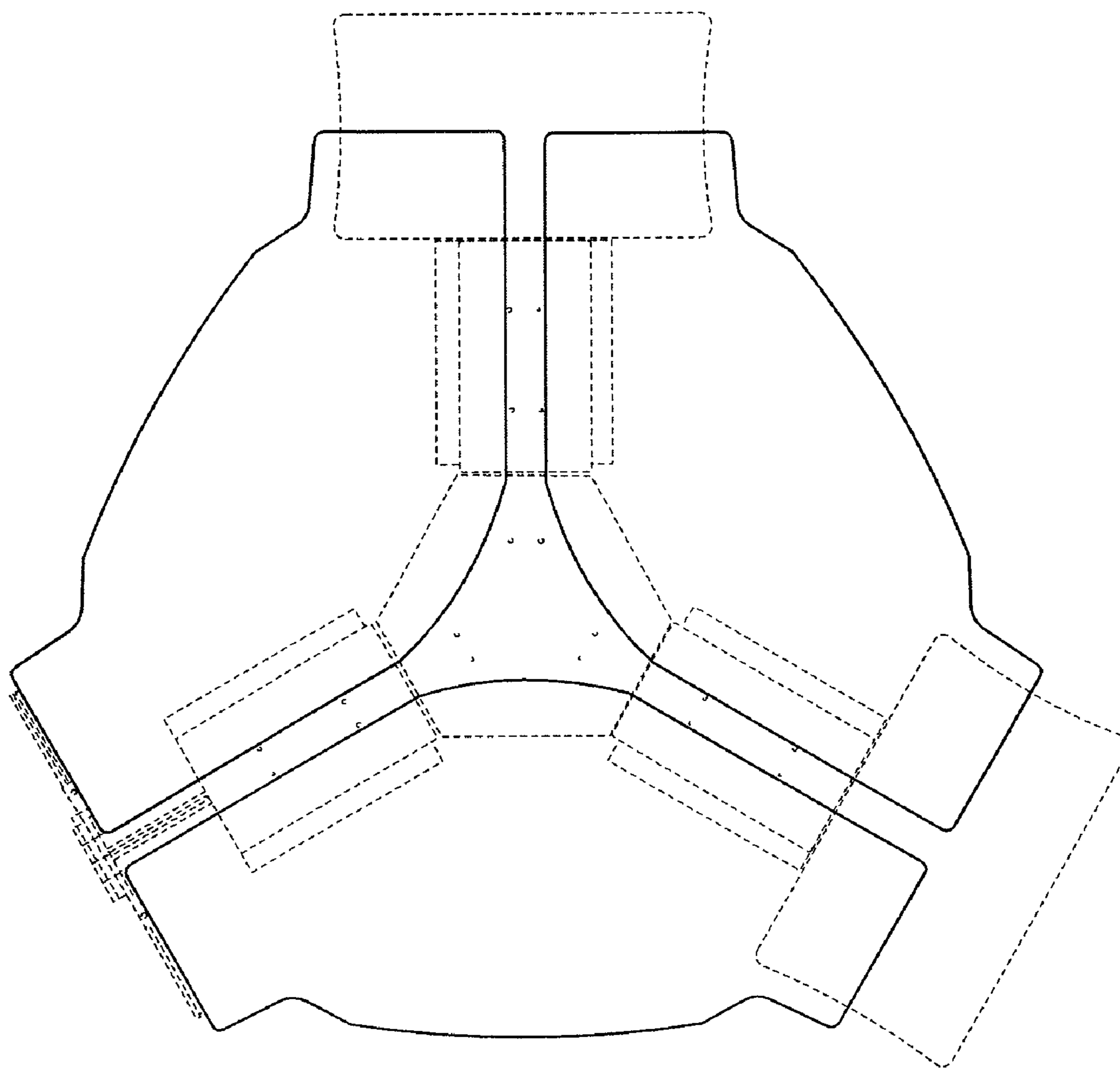

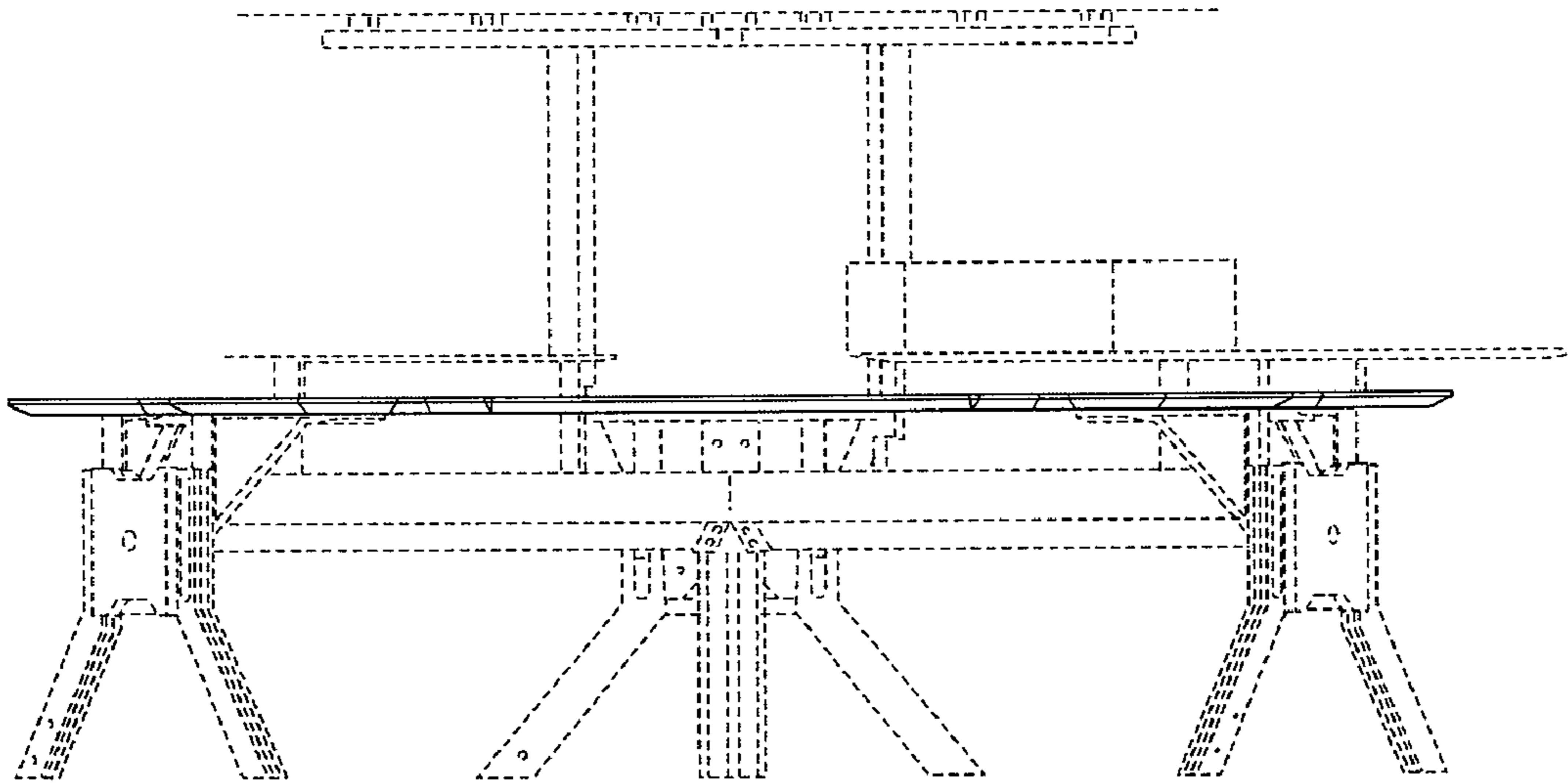

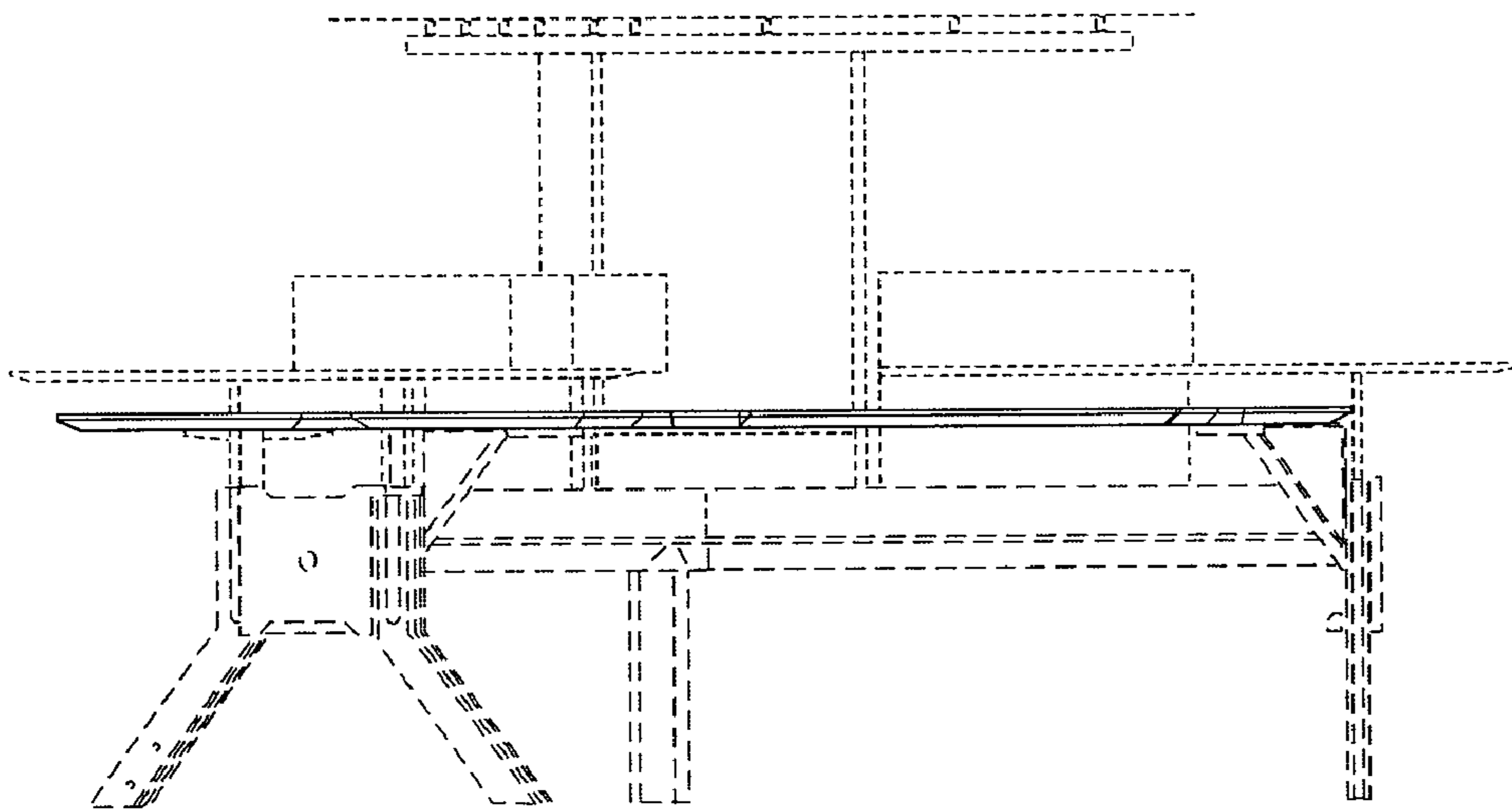

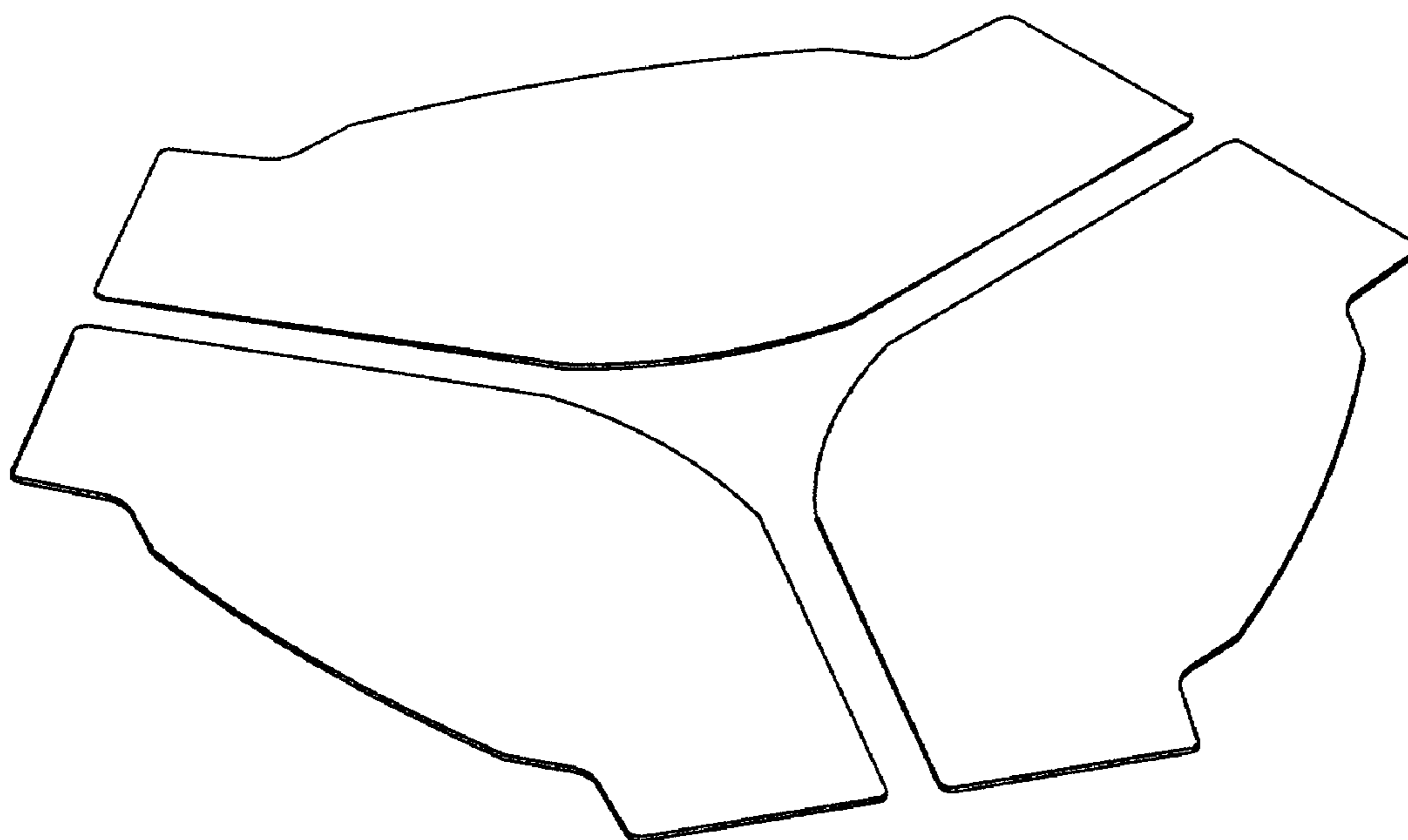

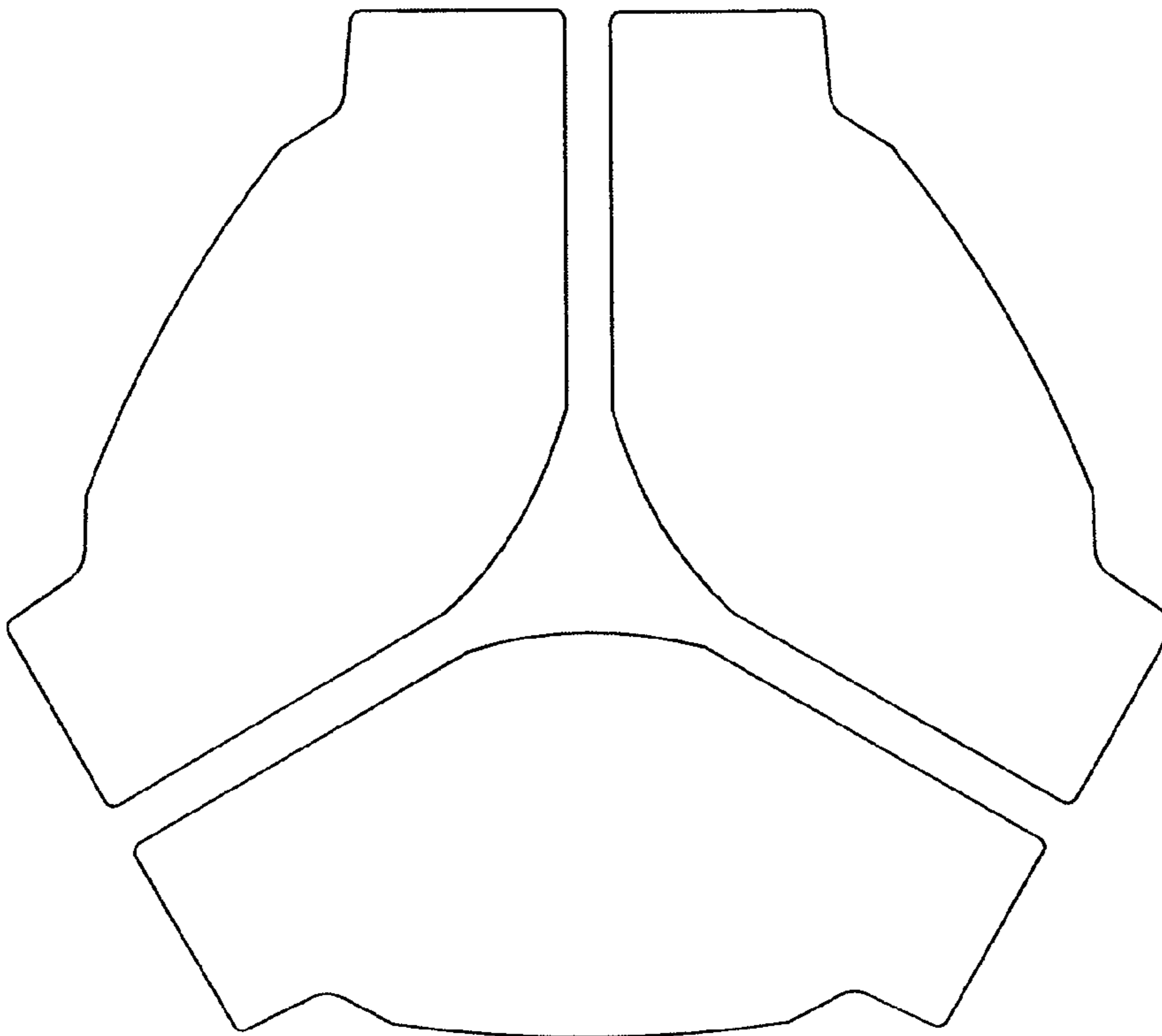

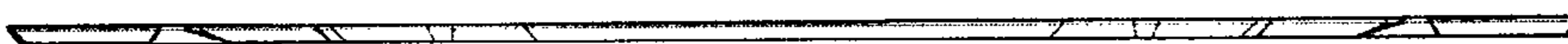

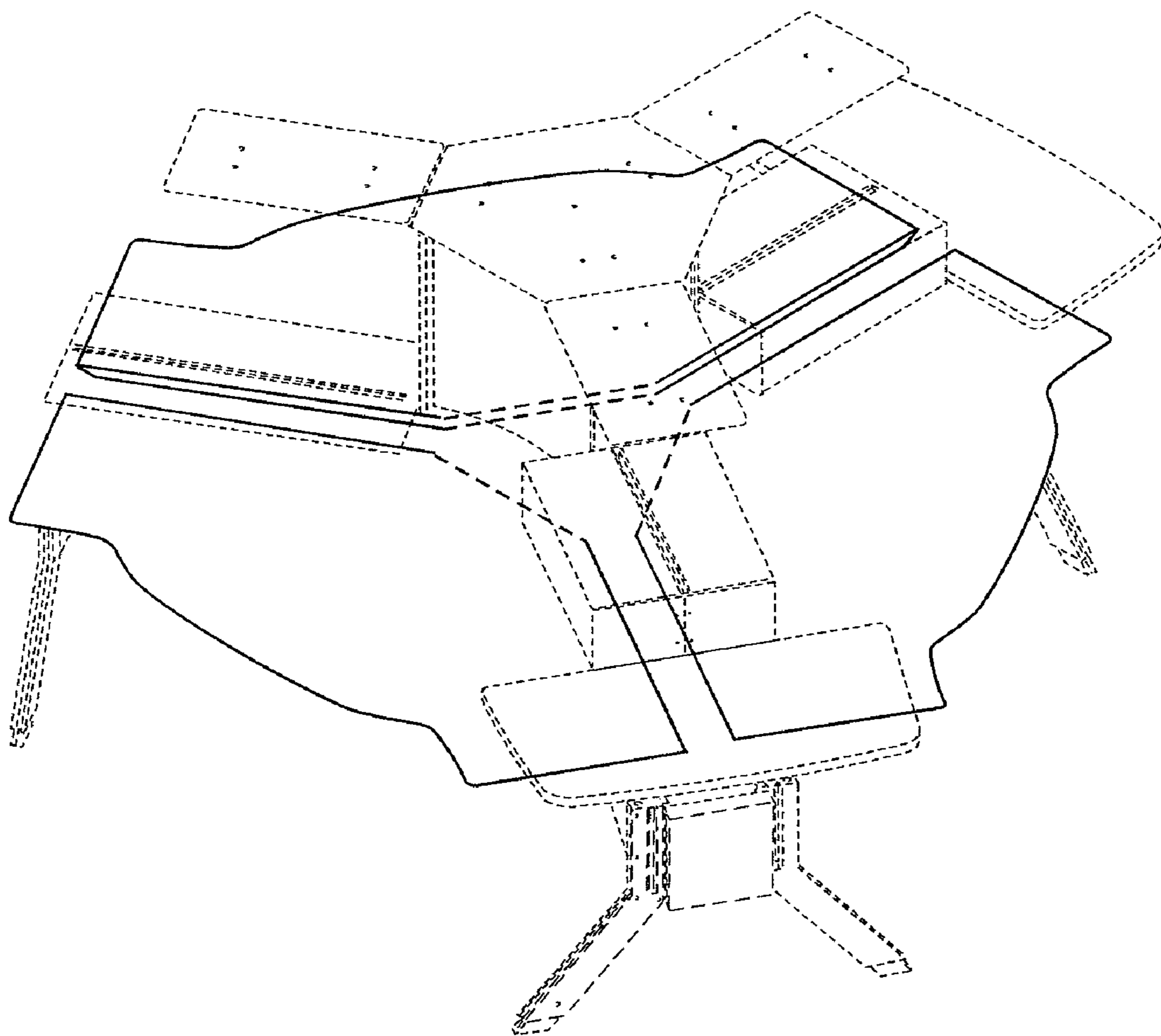

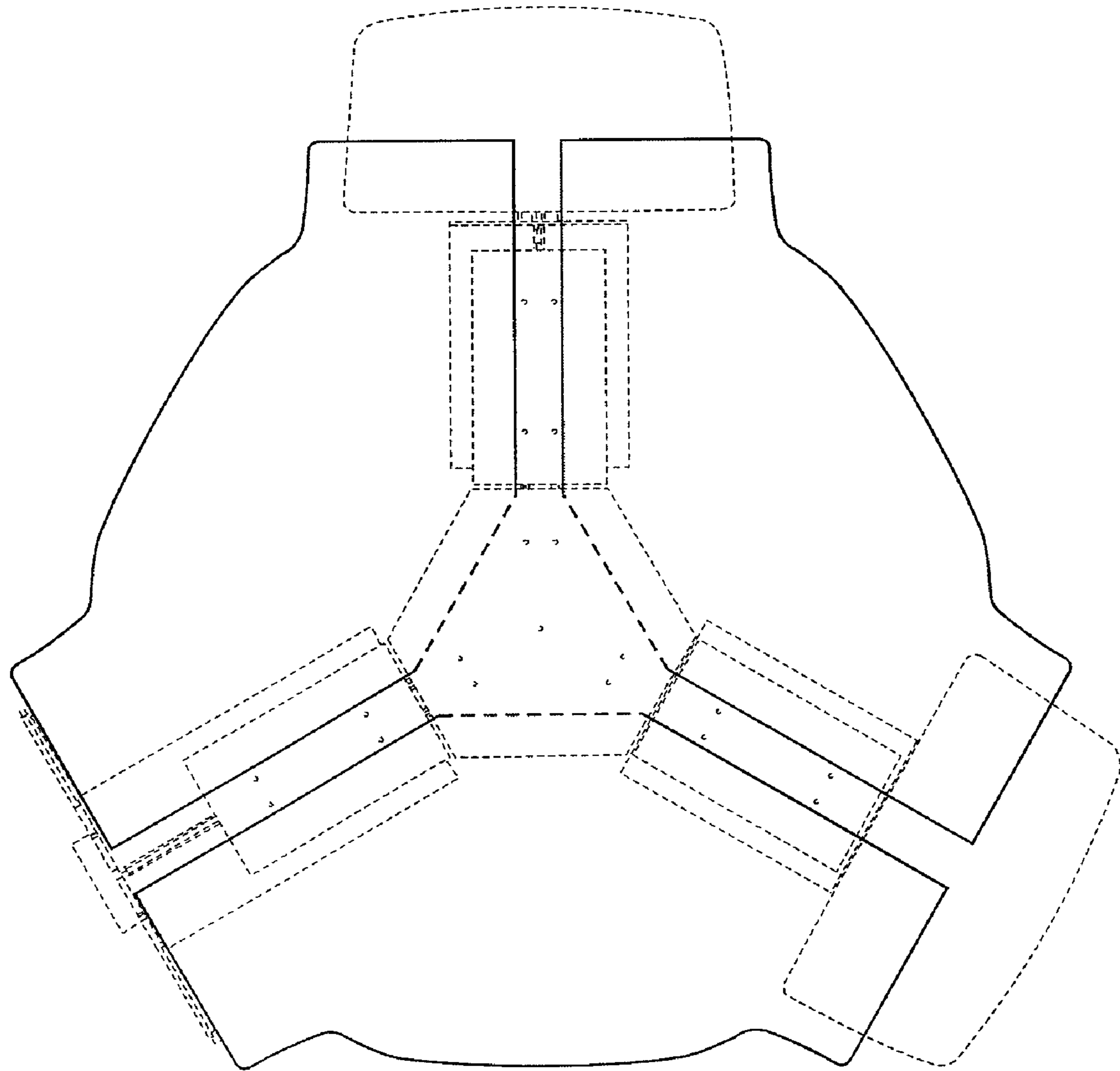

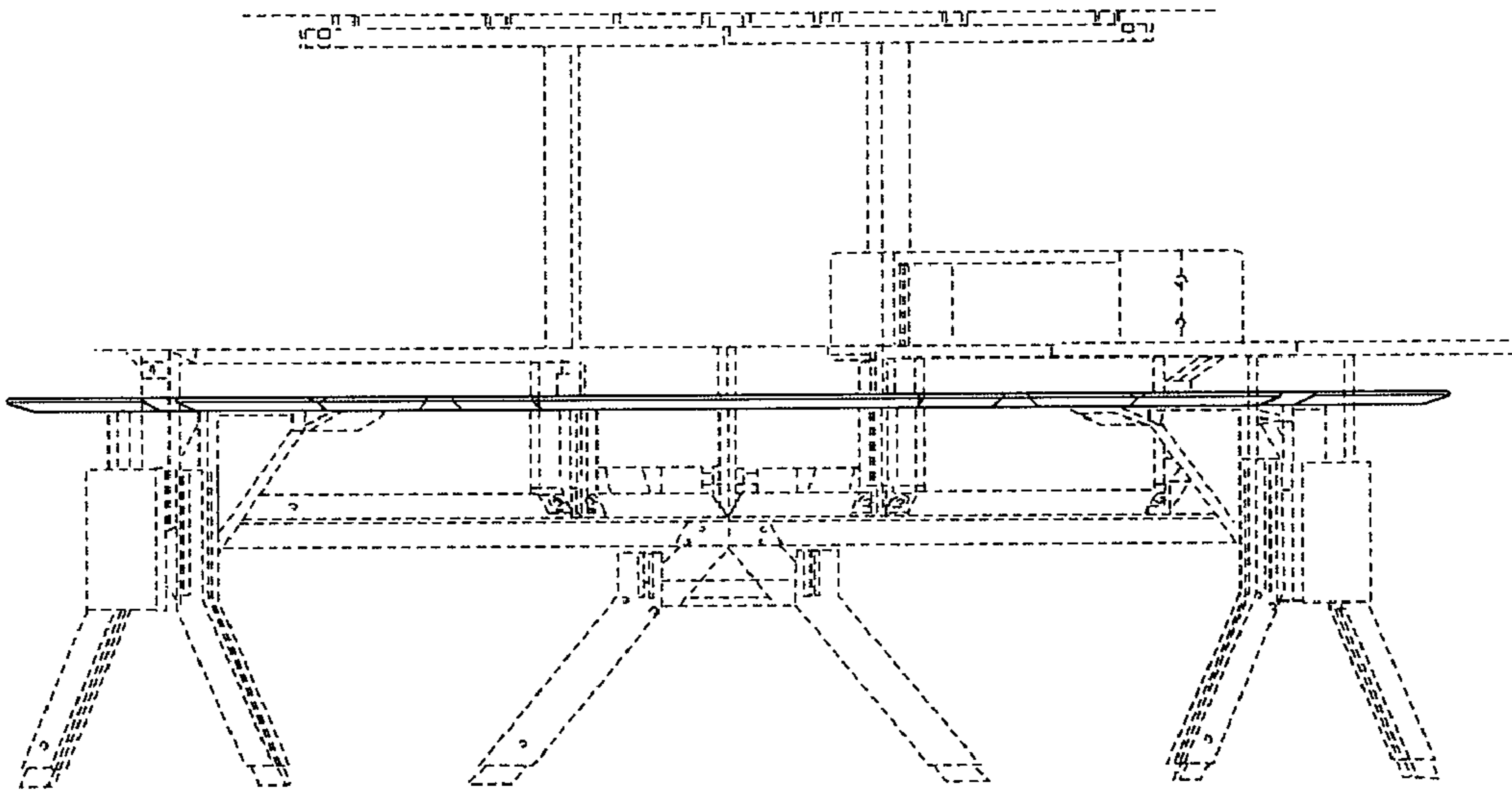

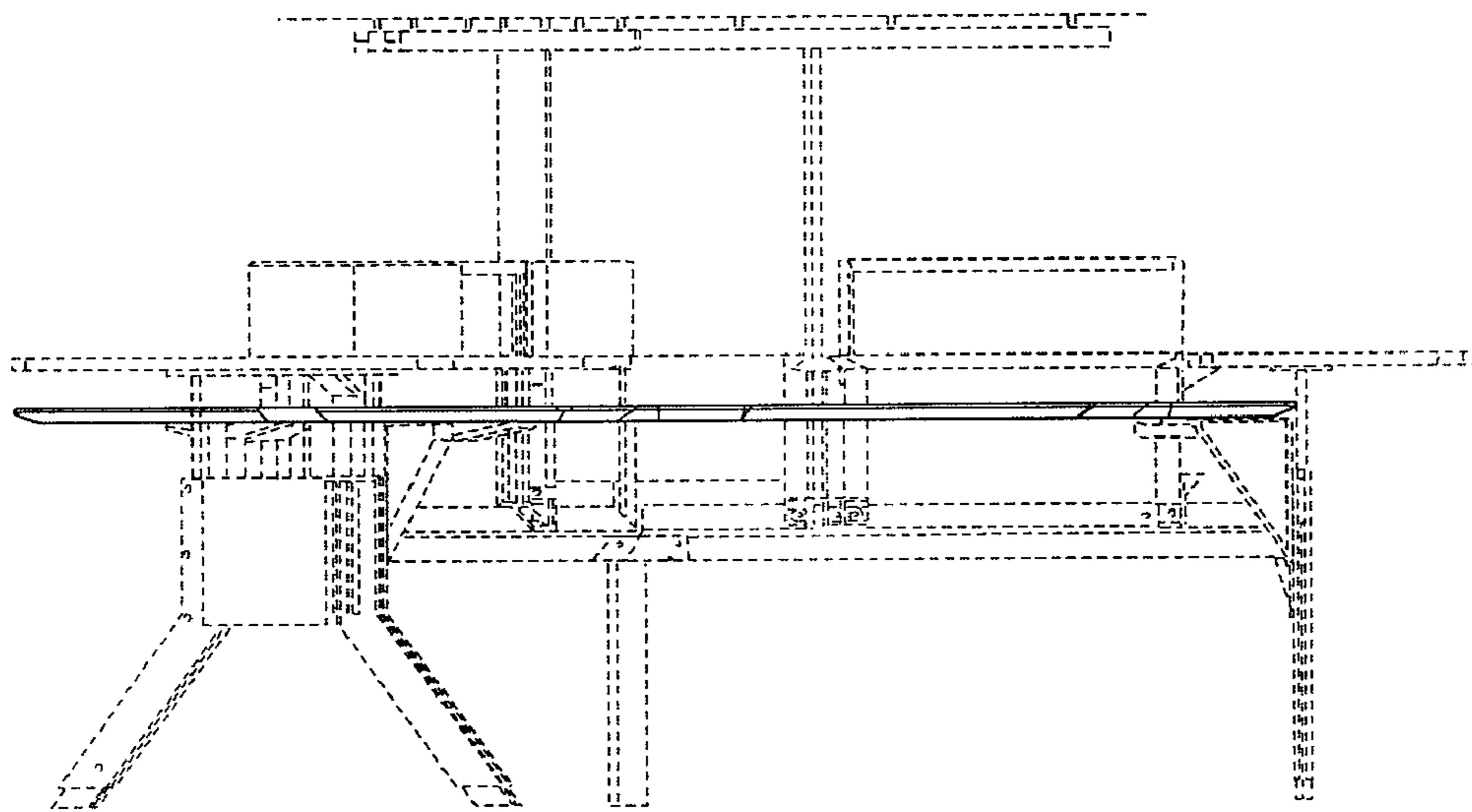

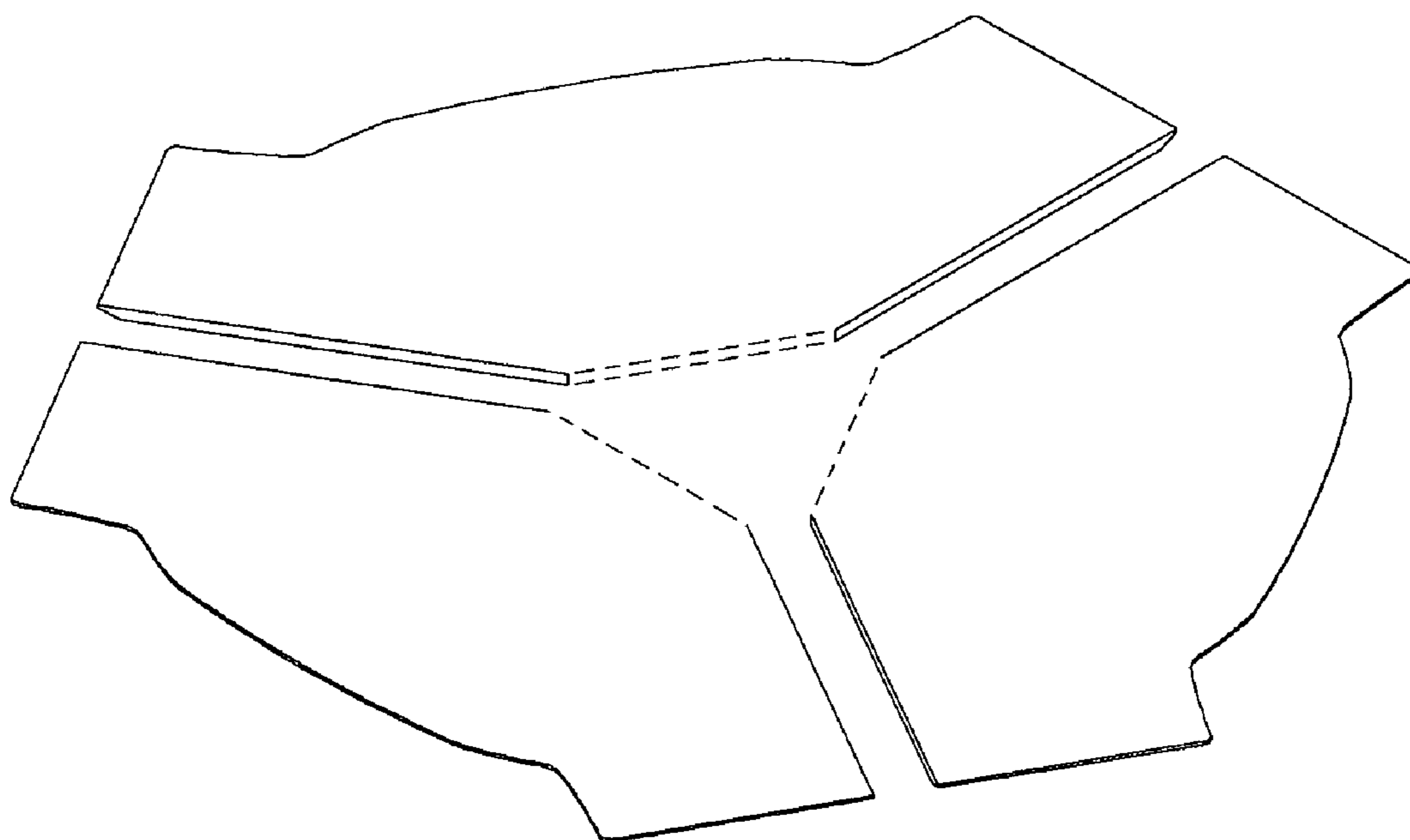

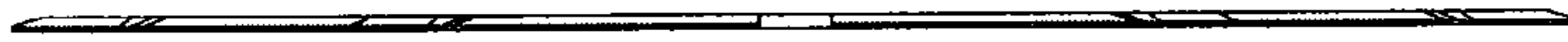

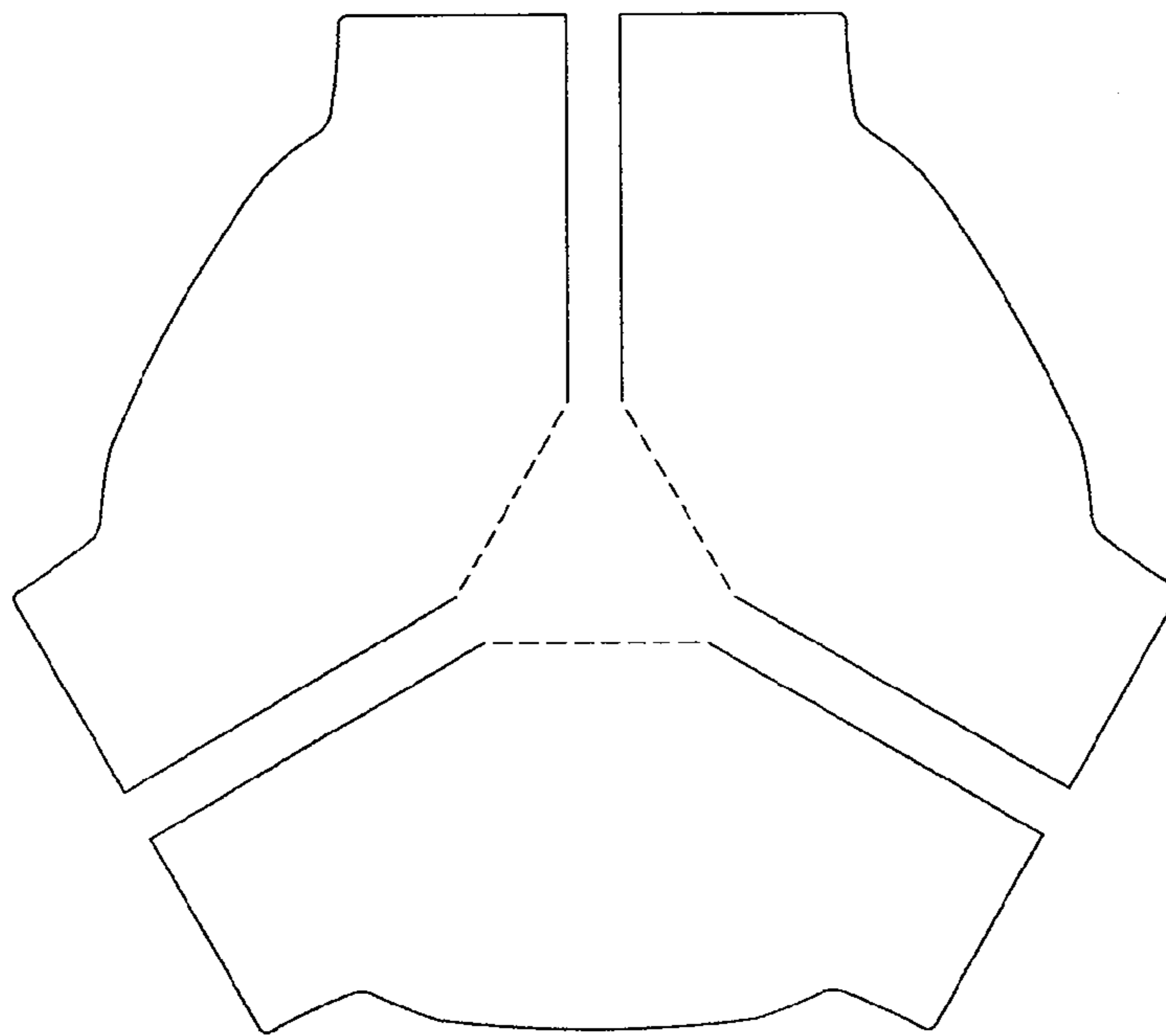

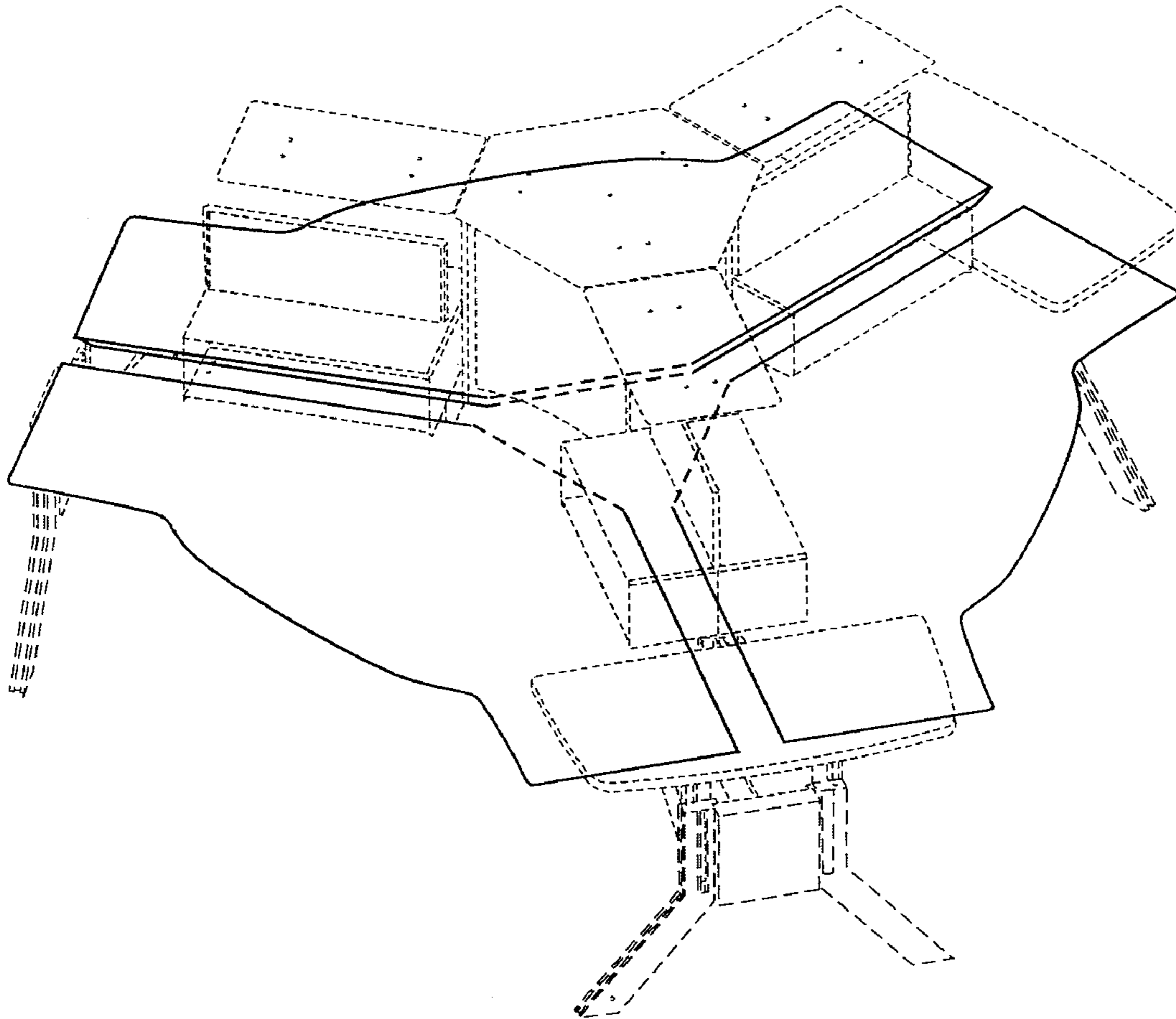

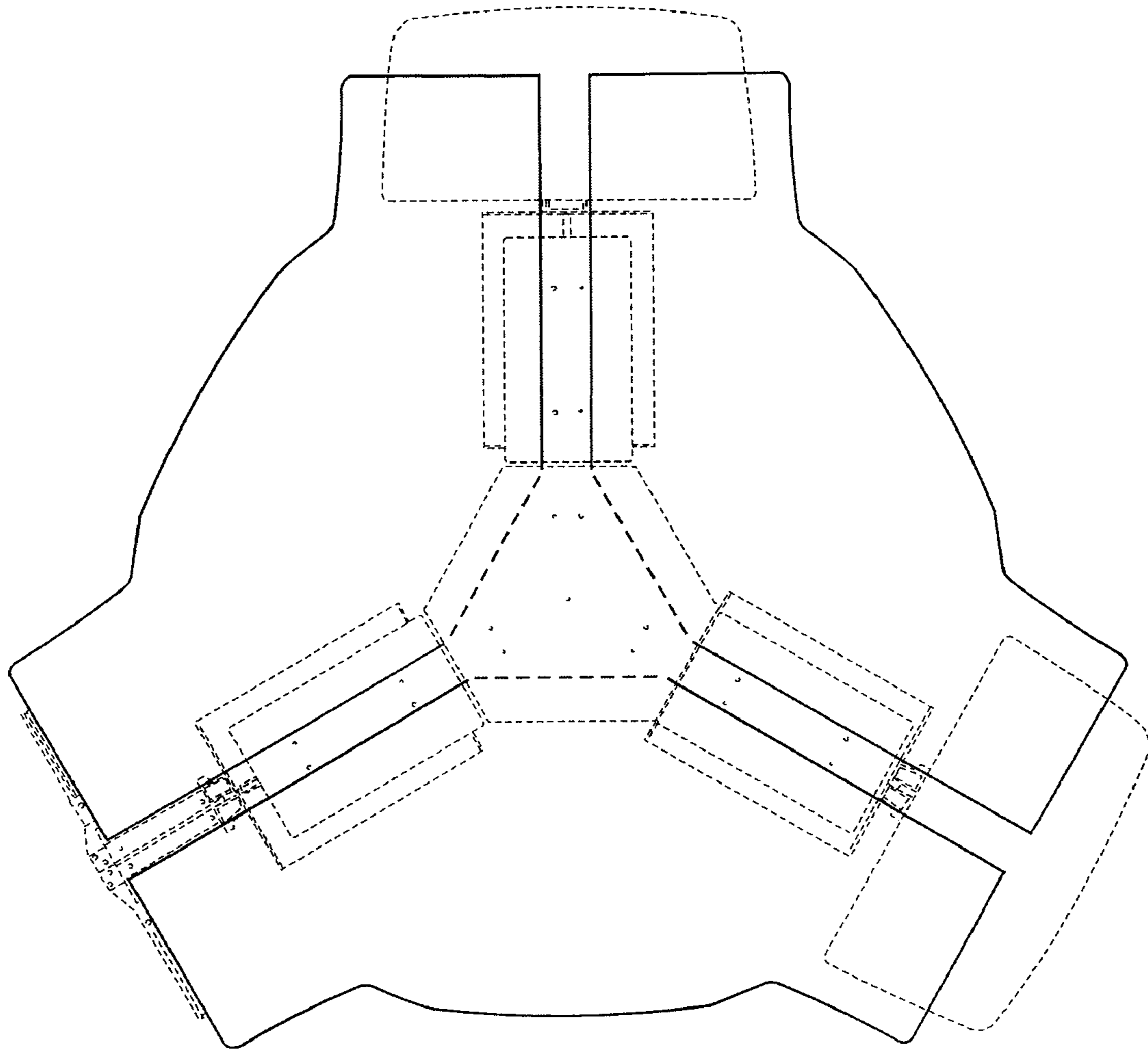

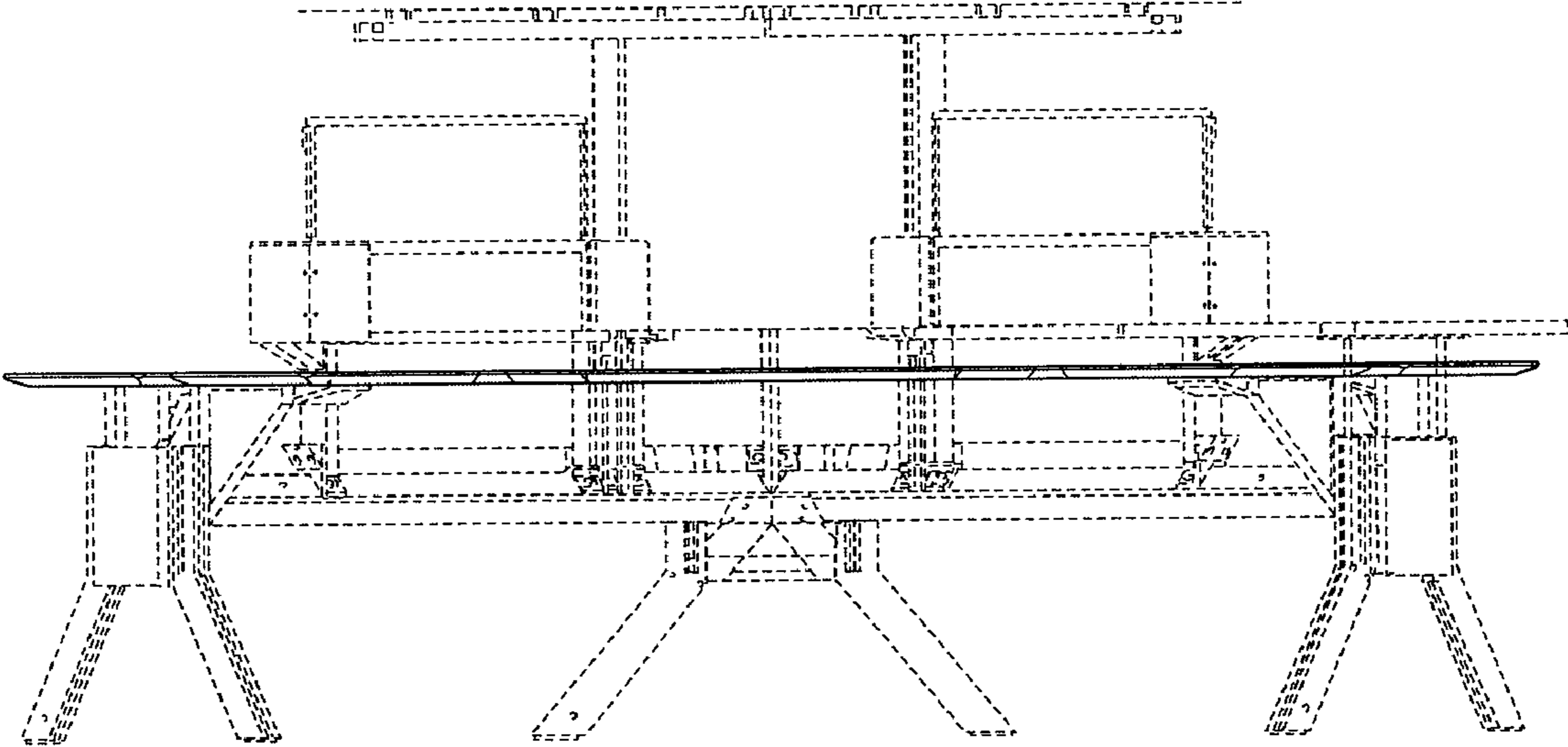

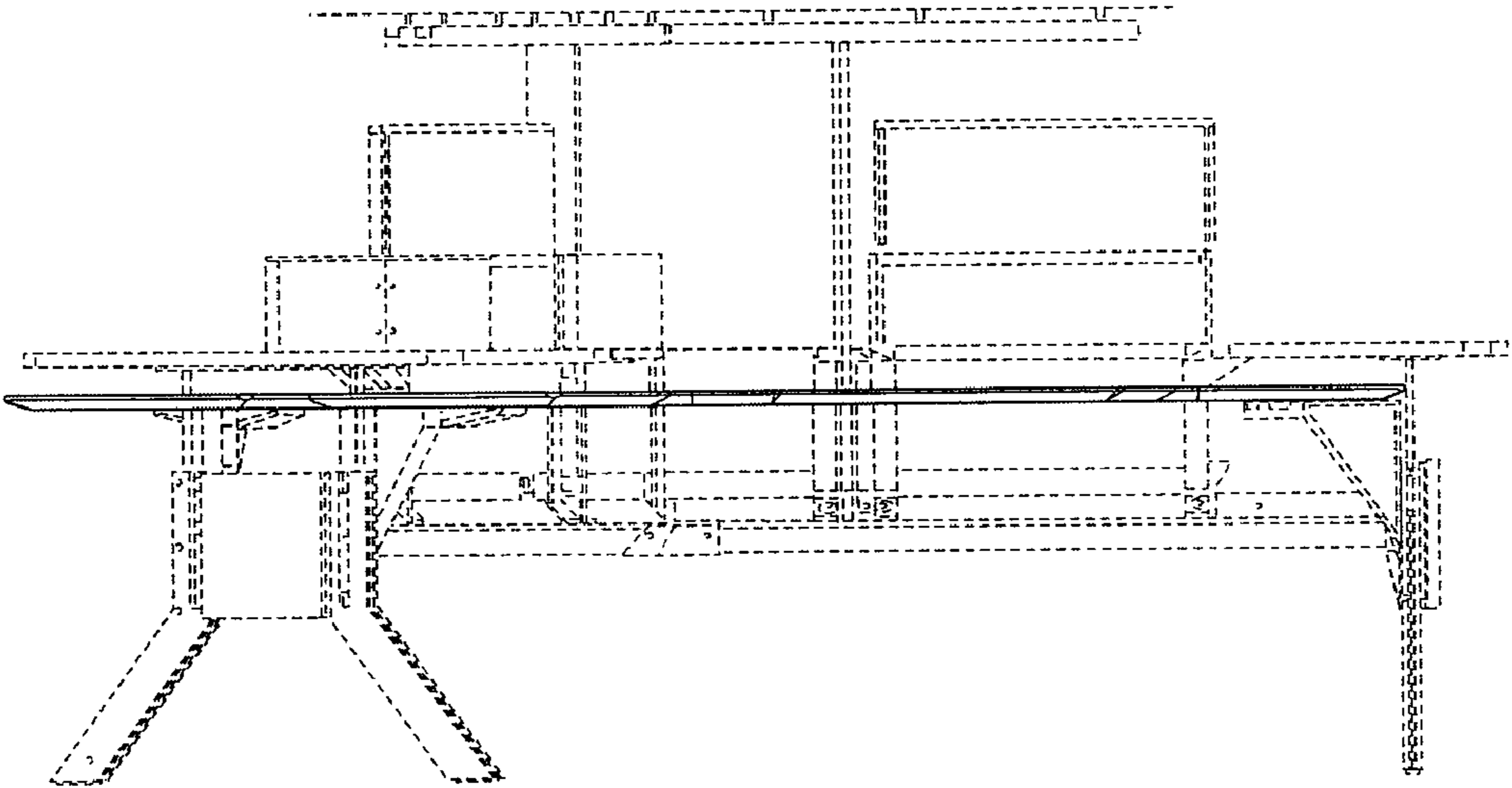

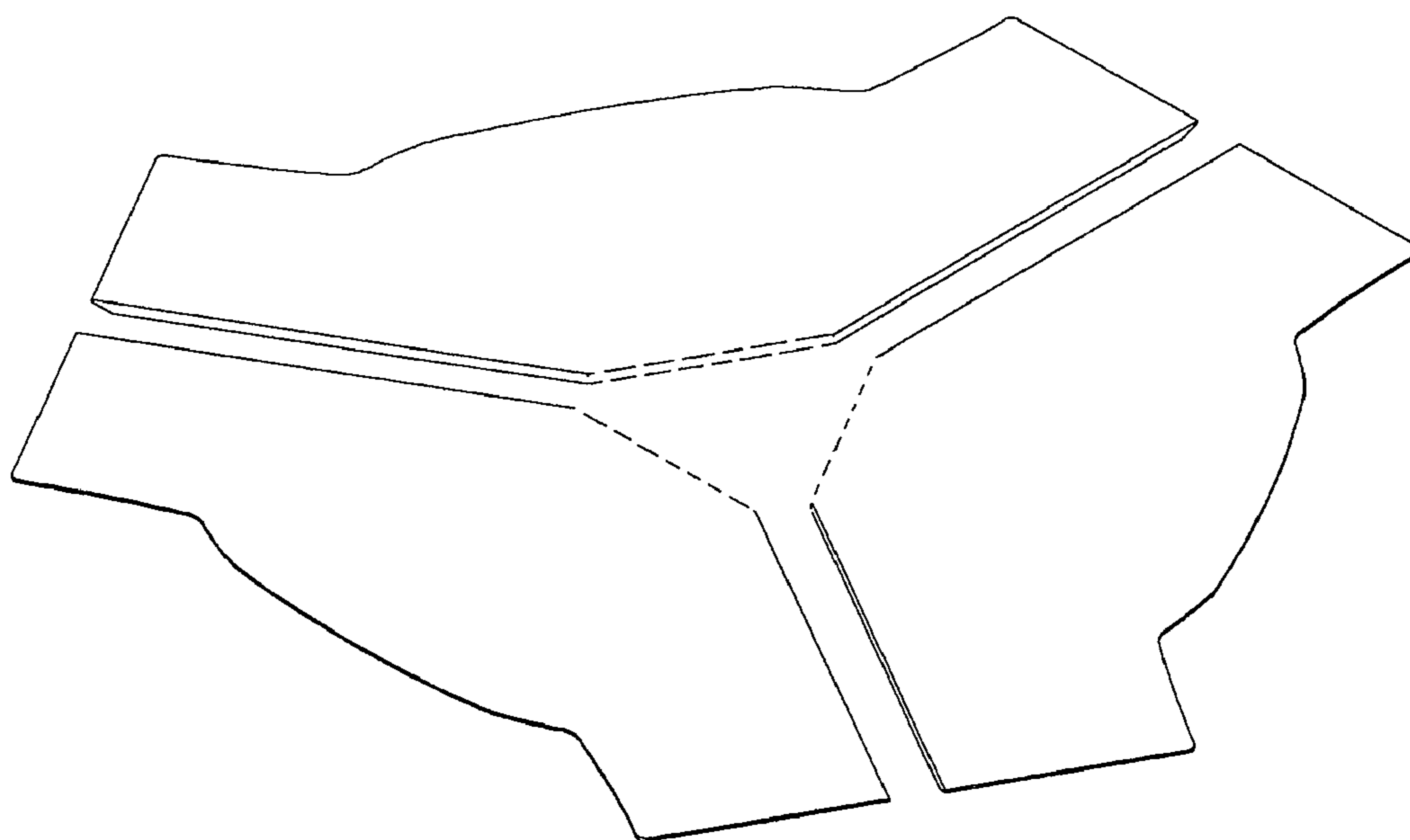

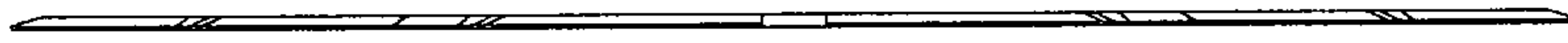

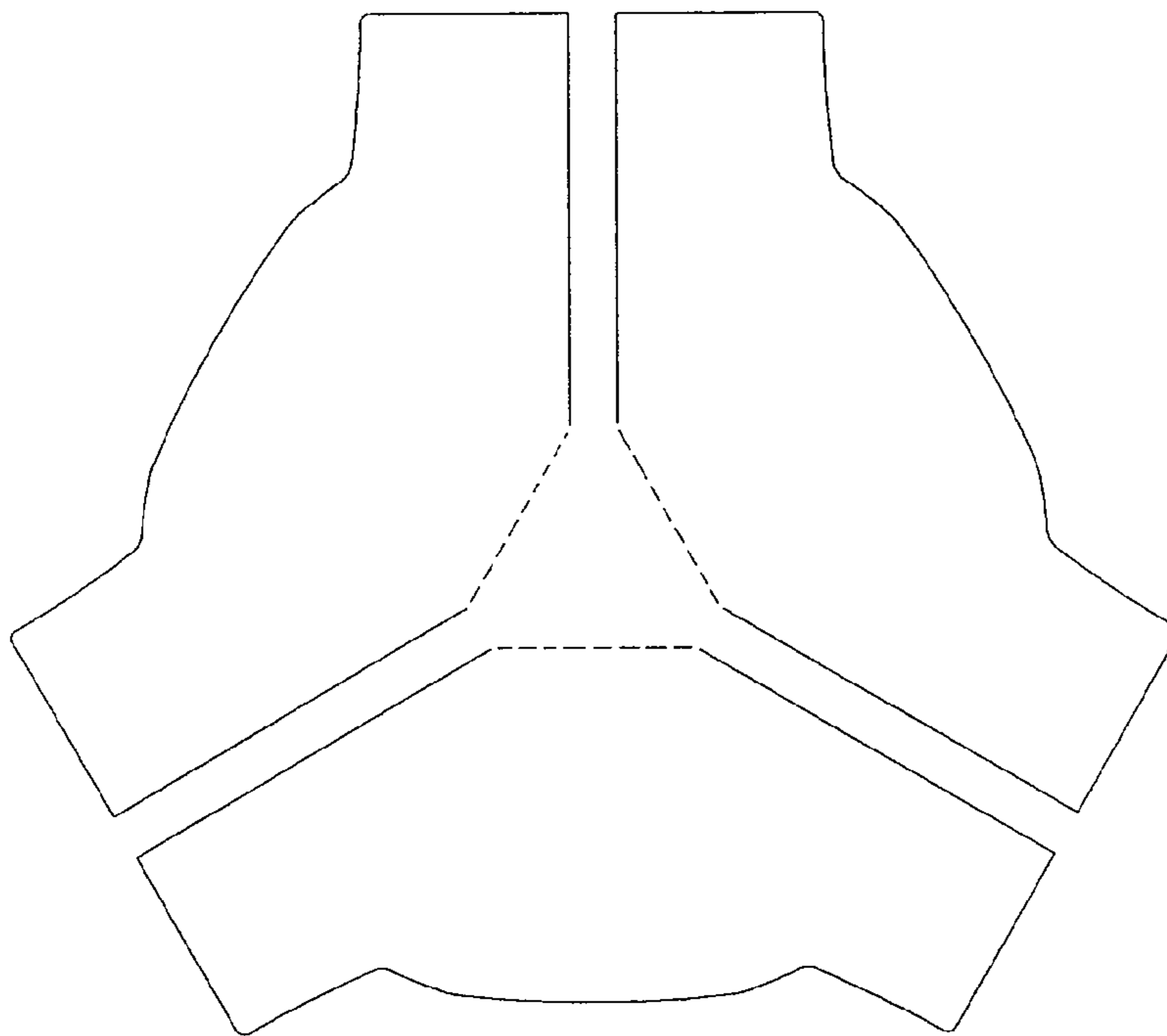

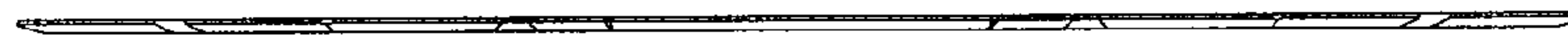
