(57) **CLAIM**

The ornamental design for a baby blanket, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the top side of an example embodiment of the present baby blanket design, with a baby positioned within the blanket.

FIG. 2 is a perspective view of the top side of the baby blanket illustrated in FIG. 1, without a baby positioned within the blanket.

FIG. 3 is a top view of the baby blanket illustrated in FIG. 2.

FIG. 4 is a bottom view of the baby blanket illustrated in FIG. 2.

FIG. 5 is a left side view of the baby blanket illustrated in FIG. 2.

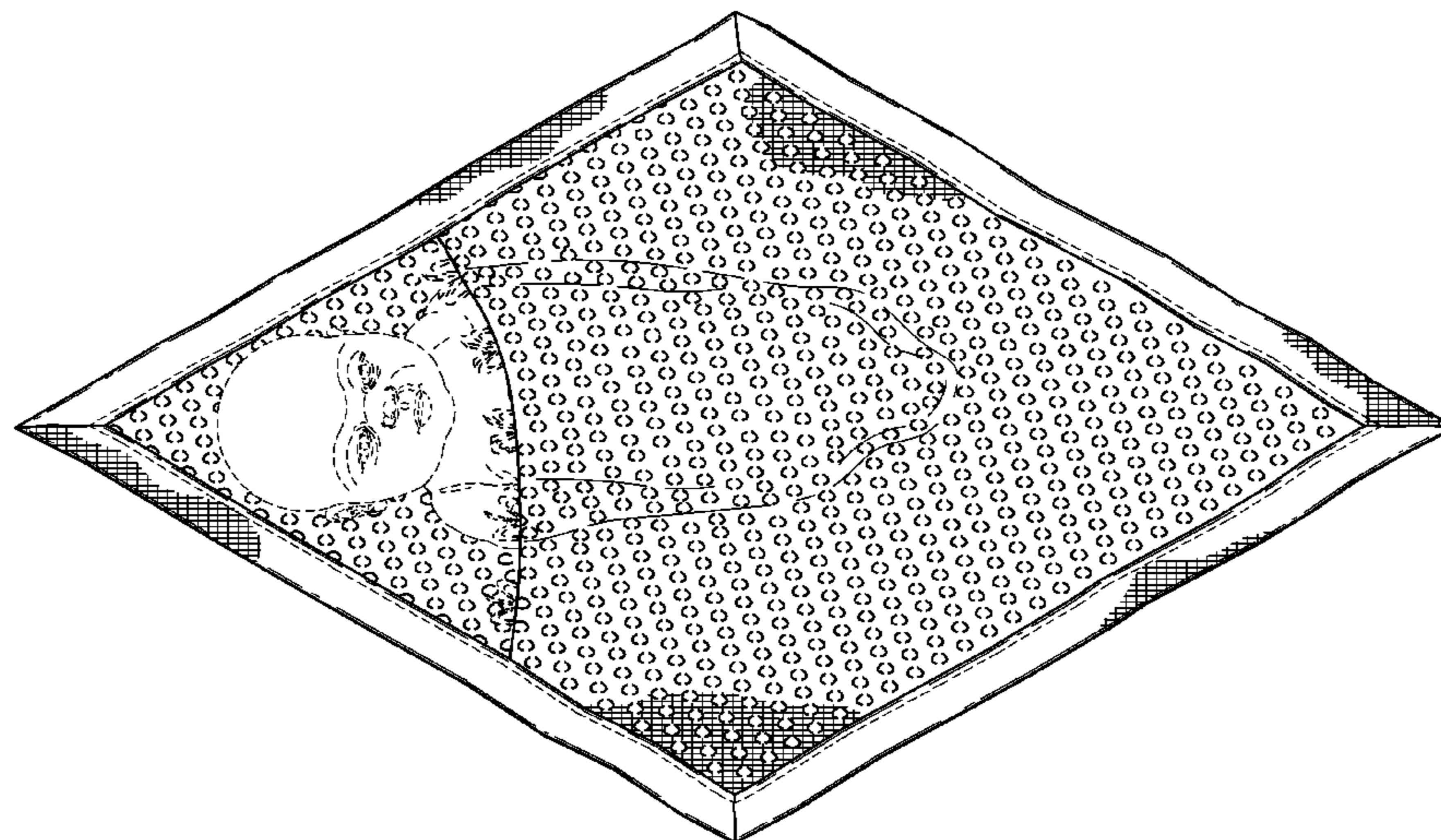
FIG. 6 is a right side view of the baby blanket illustrated in FIG. 2.

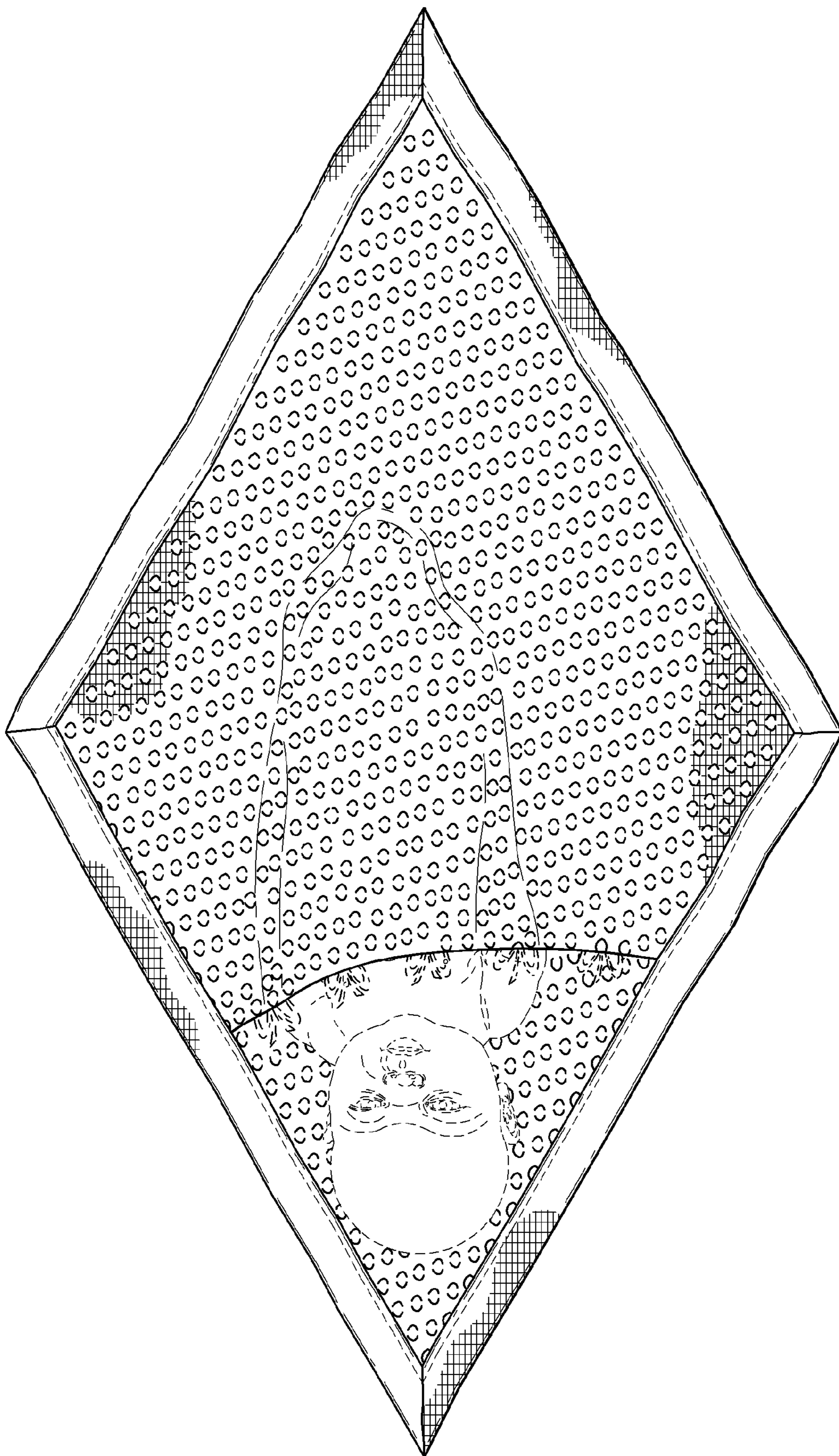

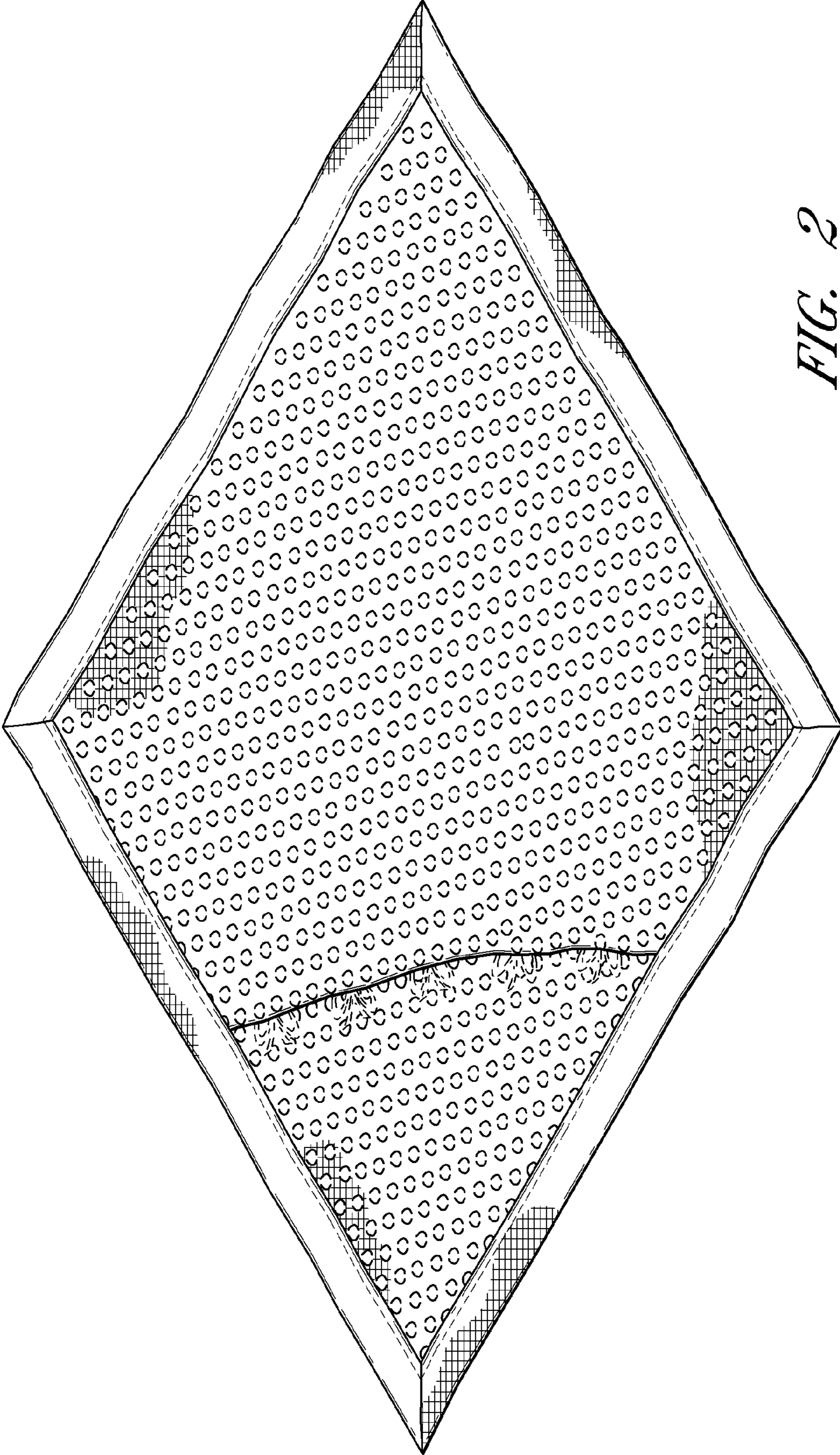

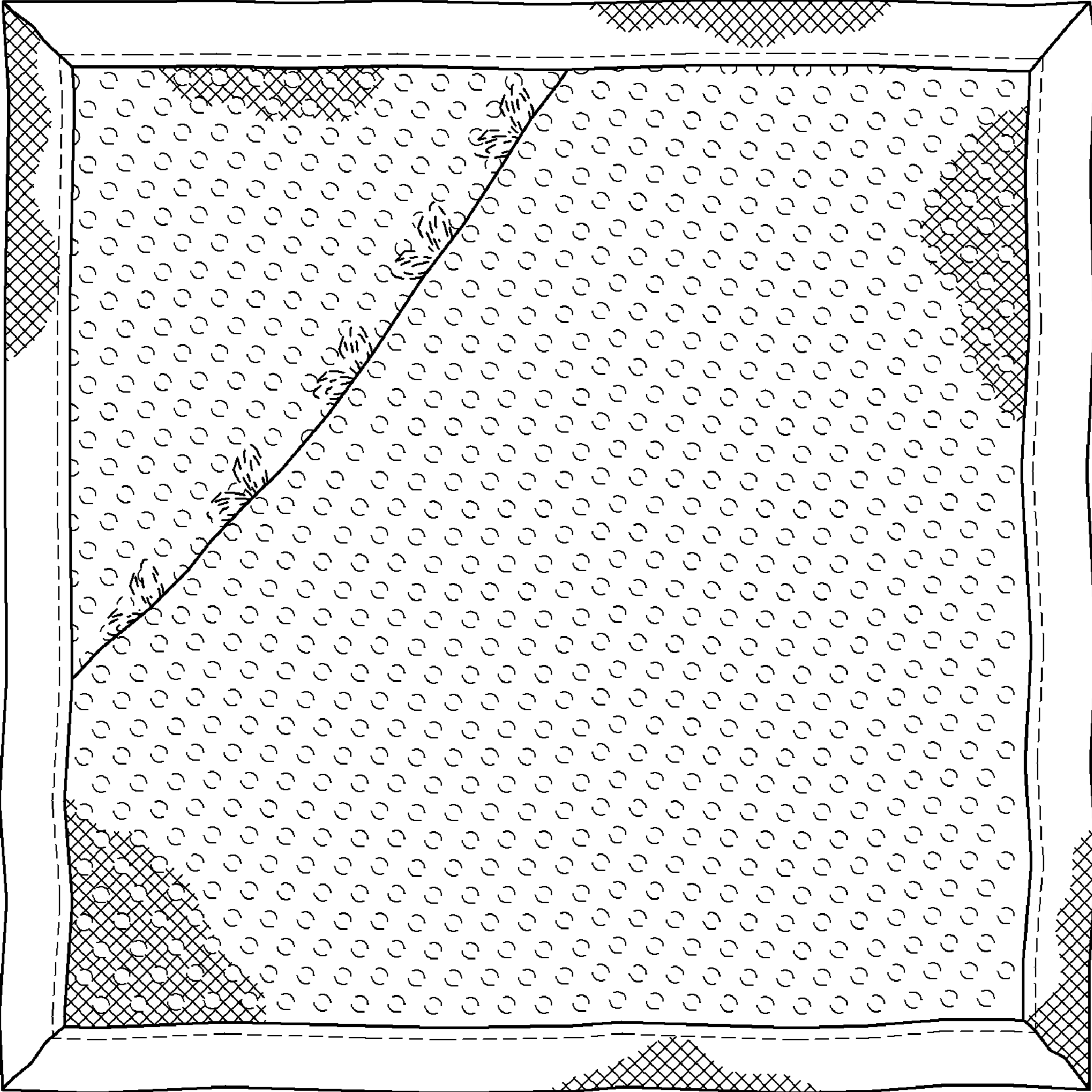

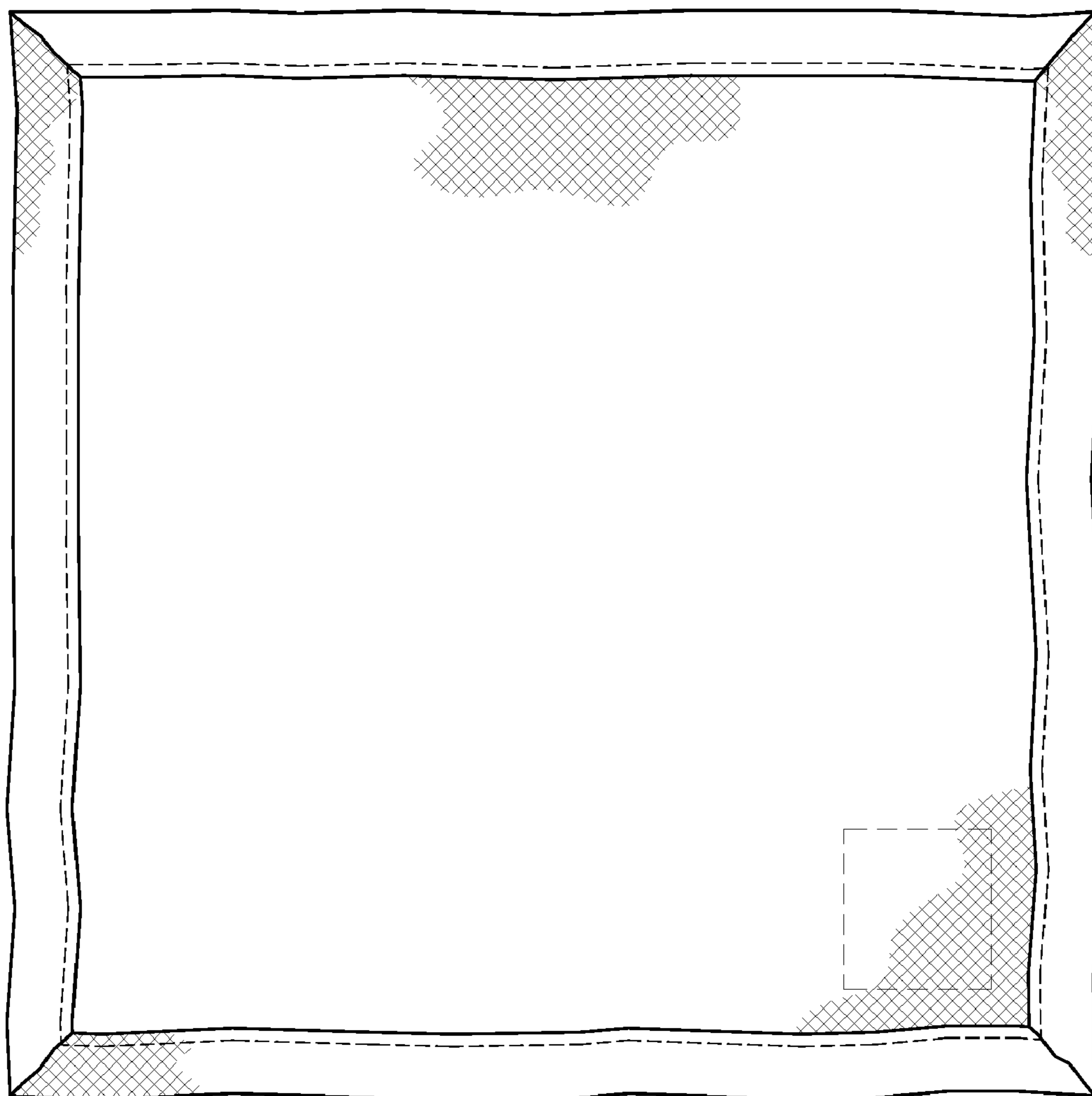

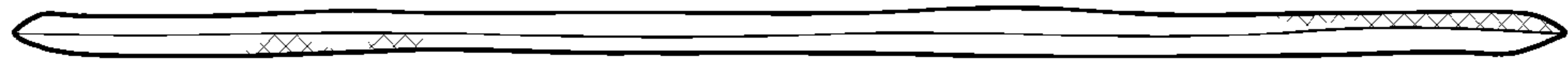

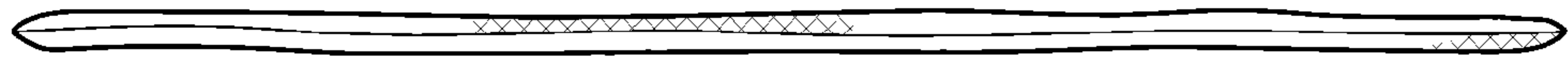

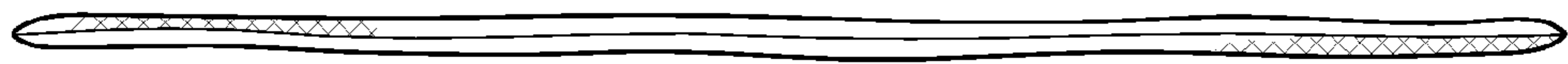

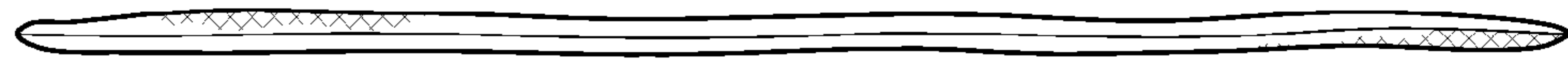
