(57) **CLAIM**

The ornamental design for a tennis ball shaped beverage container, as shown and described.

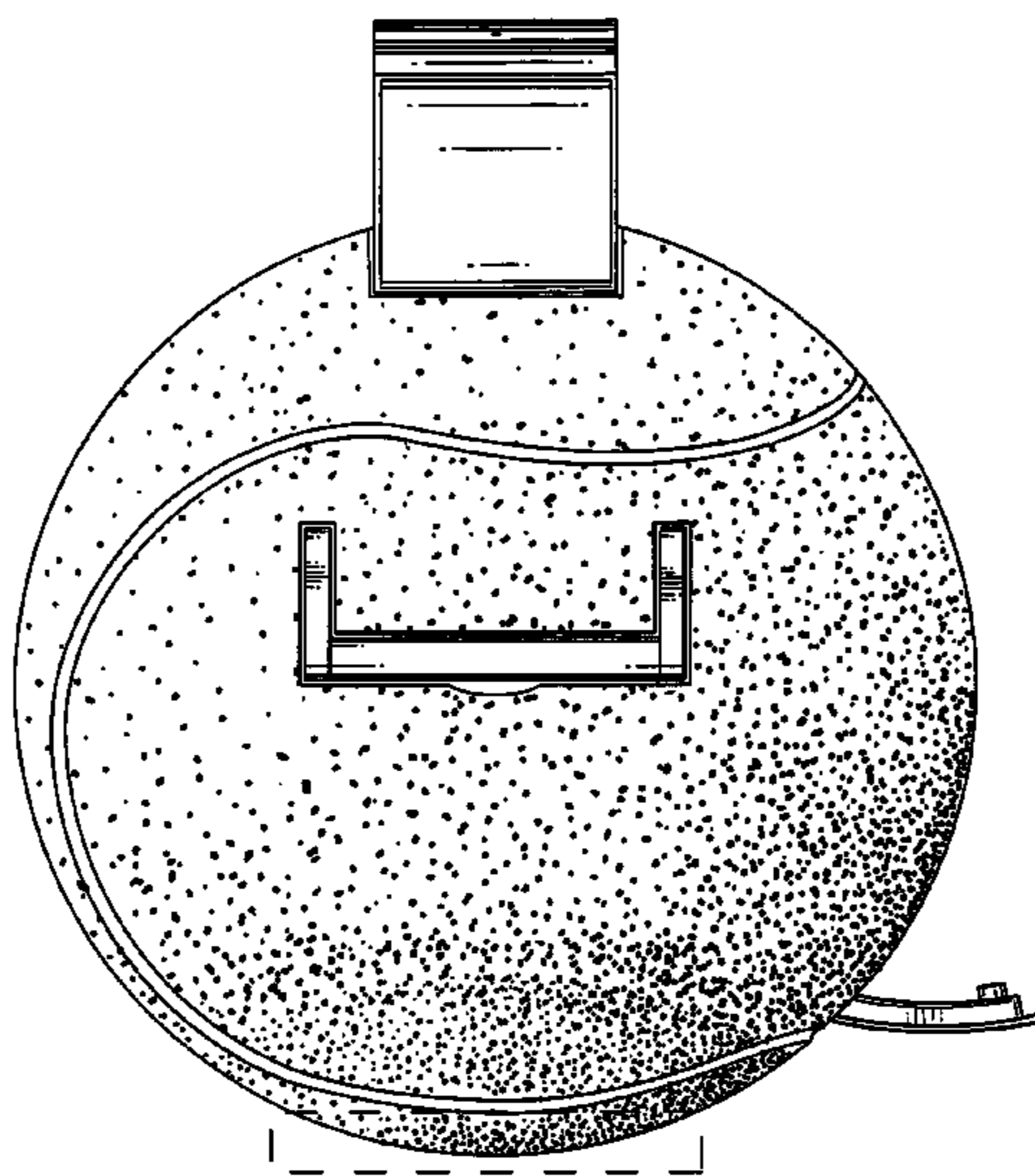
**DESCRIPTION**

FIG. 1 is a front view of a tennis ball shaped beverage container of the new design, in which the lid (top of the container) is shown in the open position, the two handles (sides of the container) are each shown in an extended position, and the spout opening (lower front) is shown in the open position; and,

FIG. 2 is a side view thereof.

The broken line showing a base for the tennis ball shaped beverage container is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

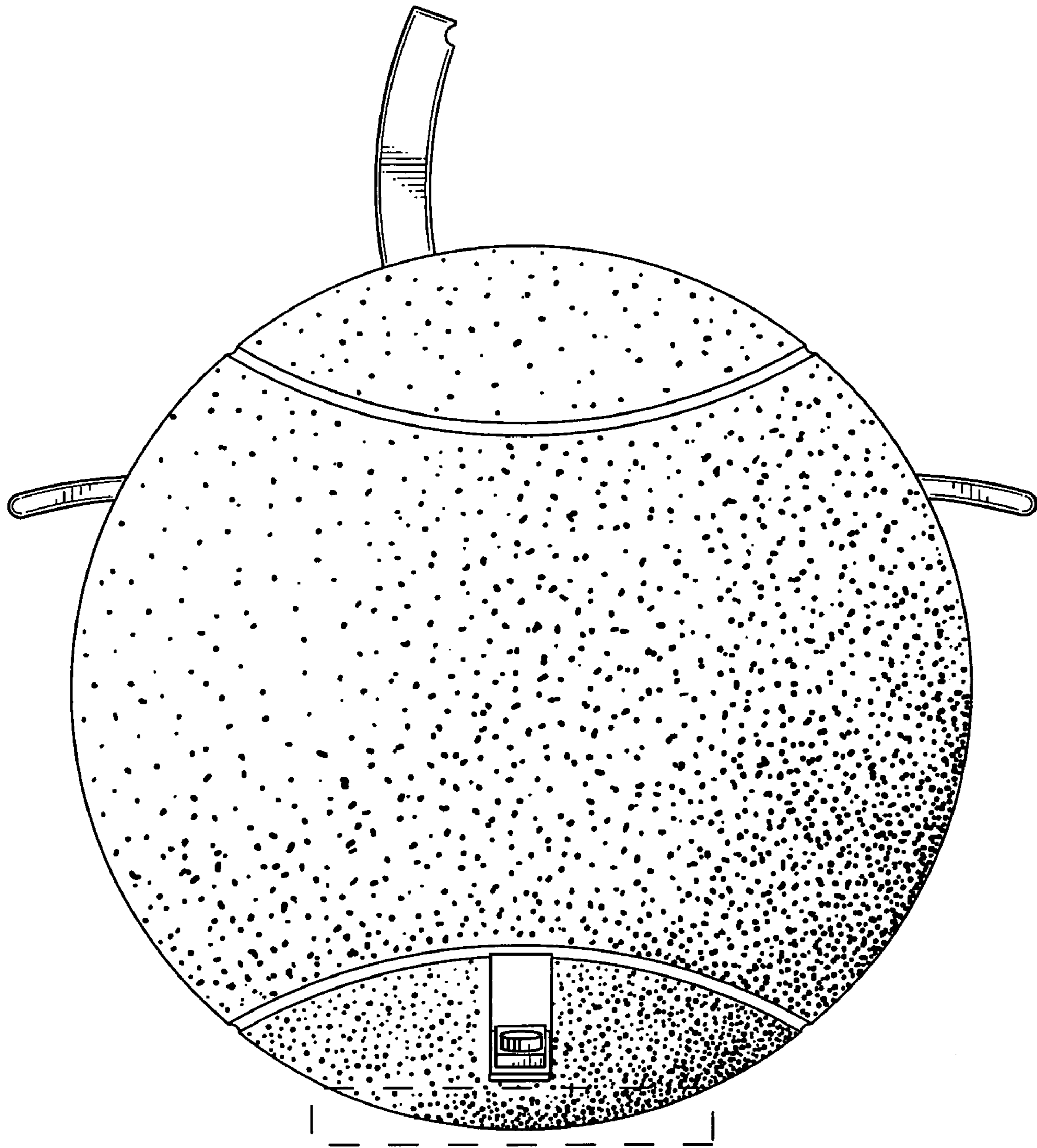

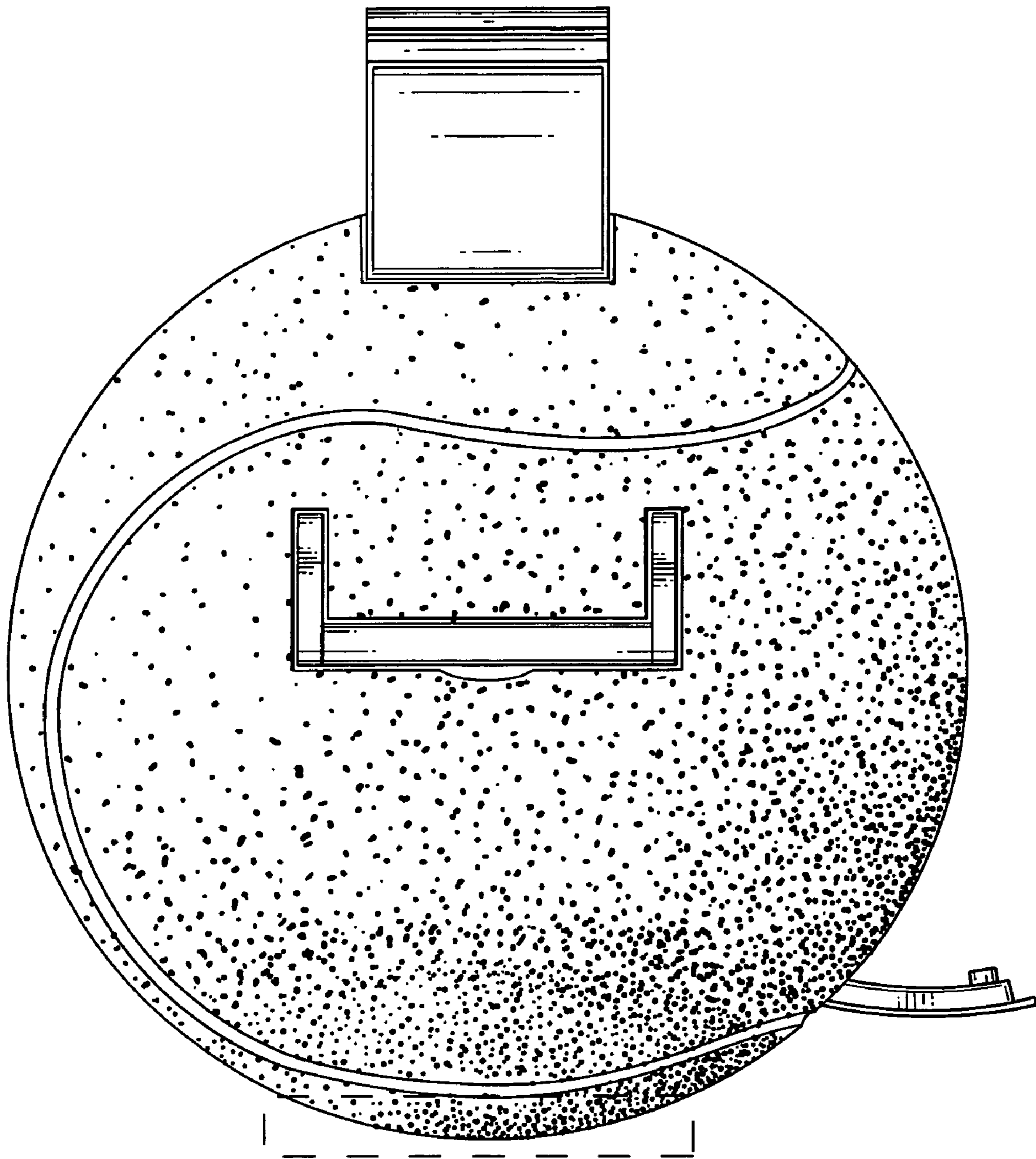
