(57) **CLAIM**

We claim the ornamental design for a protective sleeve, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a protective sleeve assembled with a cup.

FIG. 2 is a first side perspective view of the protective sleeve assembled with a cup.

FIG. 3 is a second side perspective view of the protective sleeve assembled with a cup.

FIG. 4 is a back perspective view of the protective sleeve assembled with a cup.

FIG. 5 is a front perspective view of the protective sleeve in flat-folded formation.

FIG. 6 is a front view of the protective sleeve in flat-folded formation.

FIG. 7 is a back view of the protective sleeve in flat-folded formation.

FIG. 8 is a top view of the protective sleeve in flat-folded formation.

FIG. 9 is a bottom view of the protective sleeve in flat-folded formation.

FIG. 10 is a right view of the protective sleeve in flat-folded formation.

FIG. 11 is a left view of the protective sleeve in flat-folded formation.

FIG. 12 is a front perspective view of the unfolded protective sleeve.

FIG. 13 is a front view of the unfolded protective sleeve.

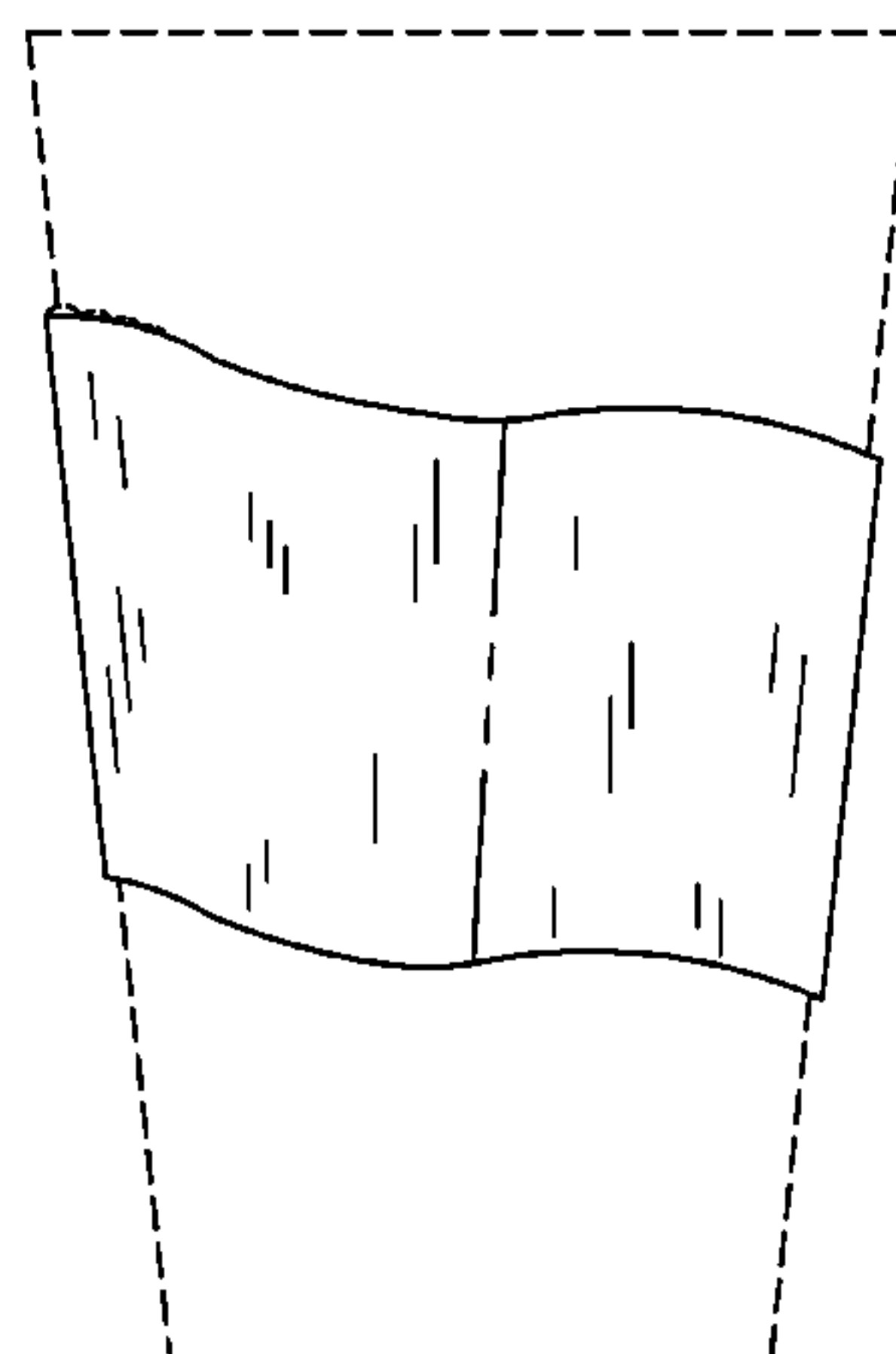
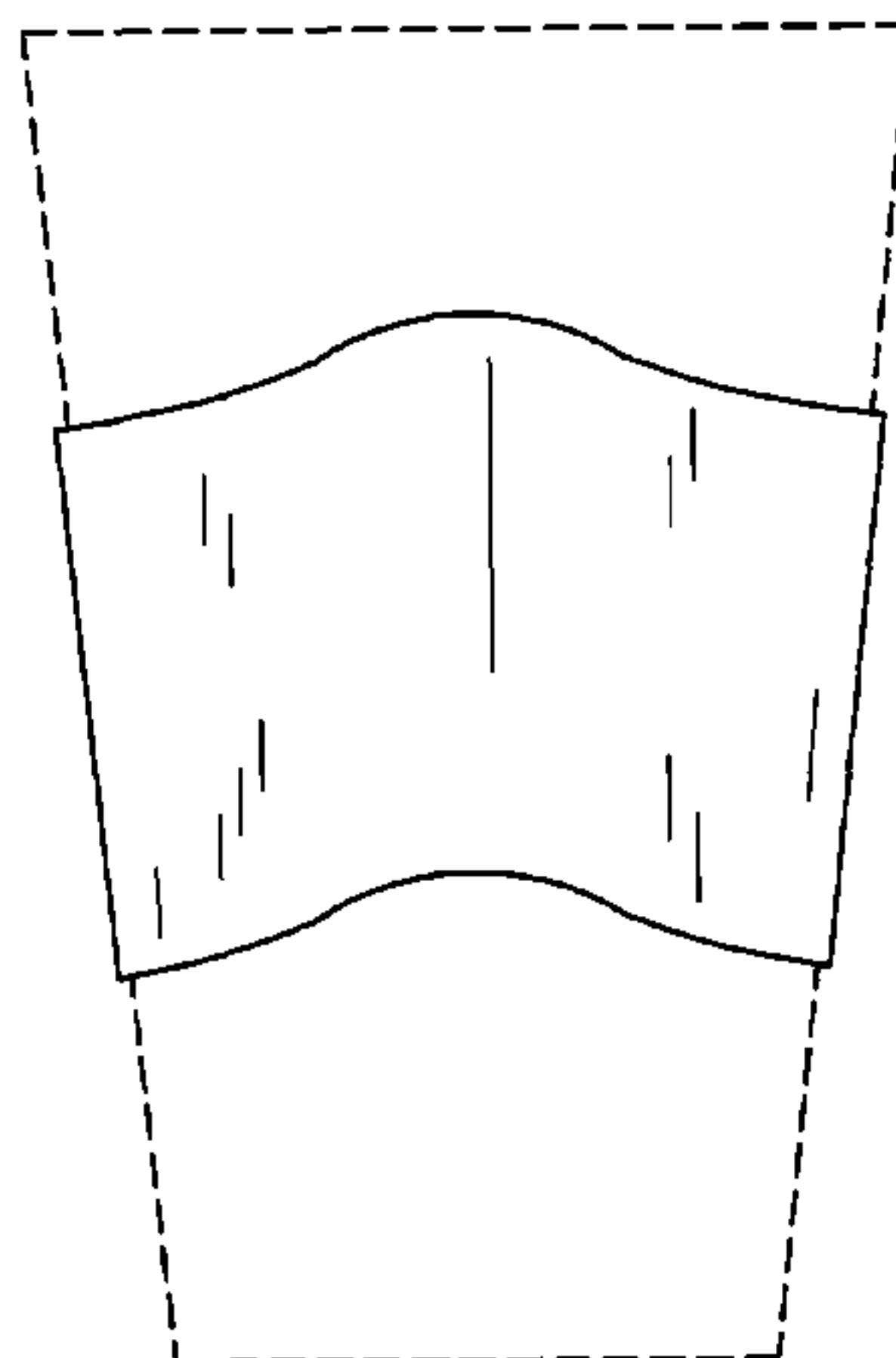
FIG. 14 is a back view of the unfolded protective sleeve.

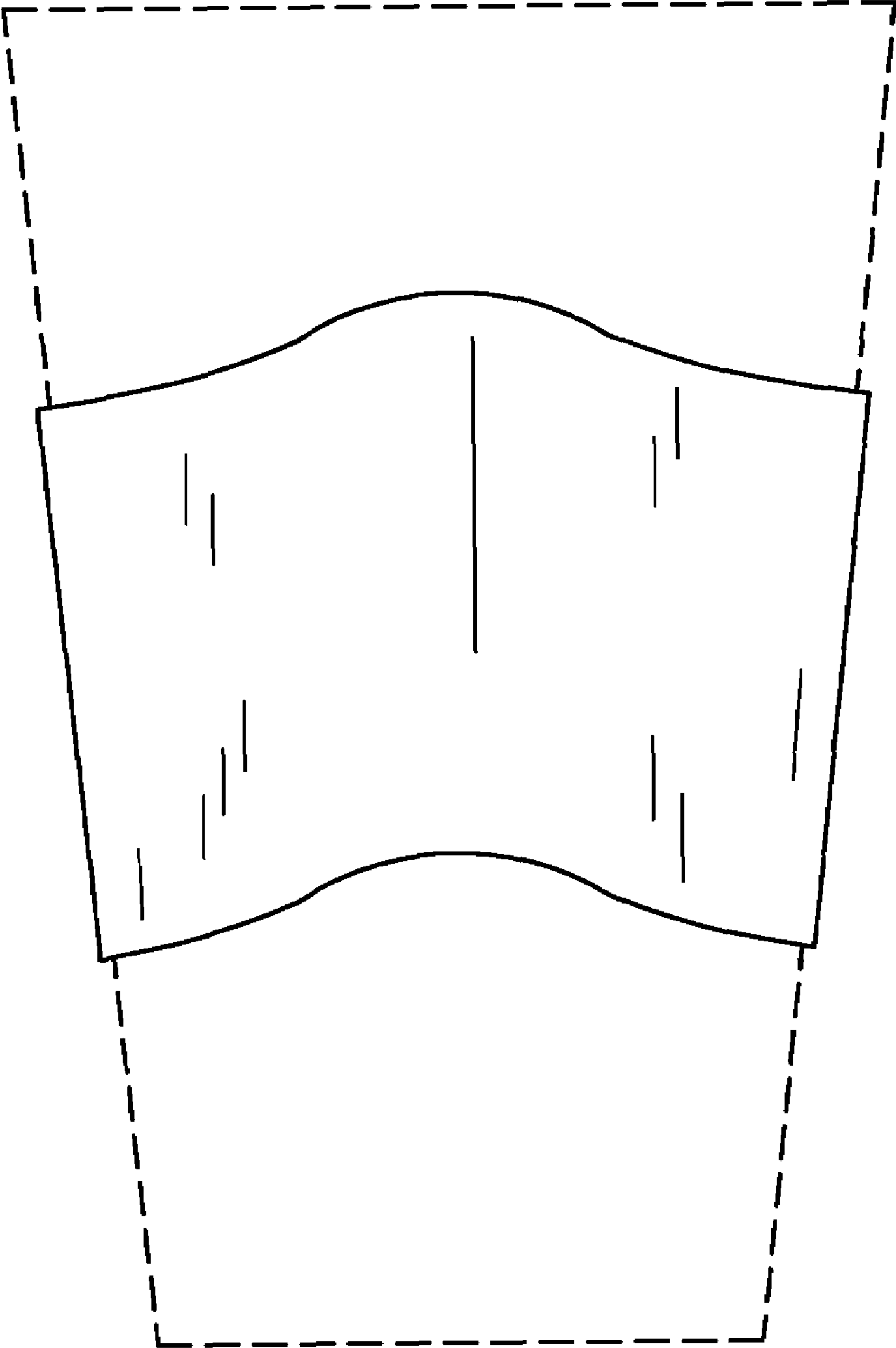

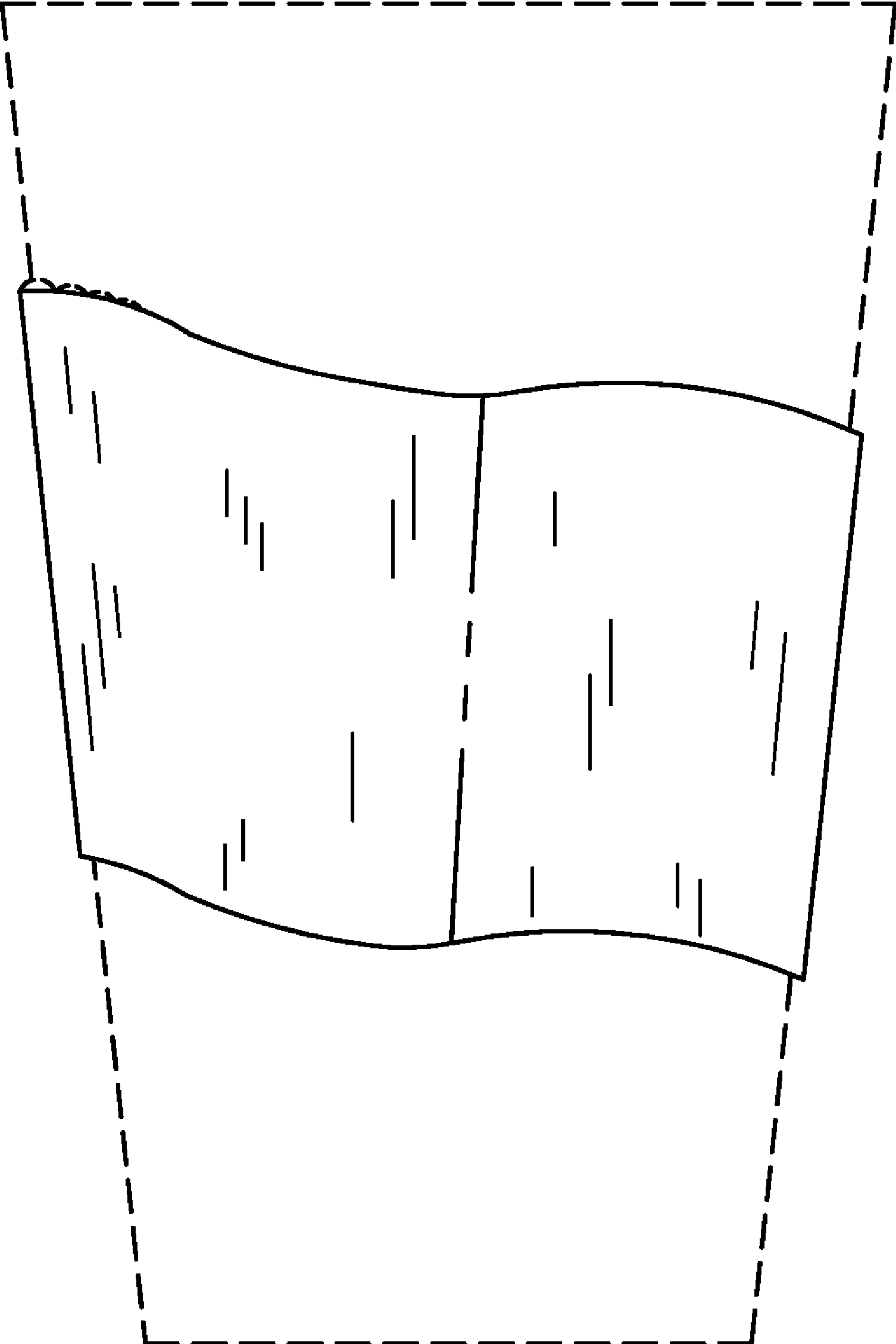

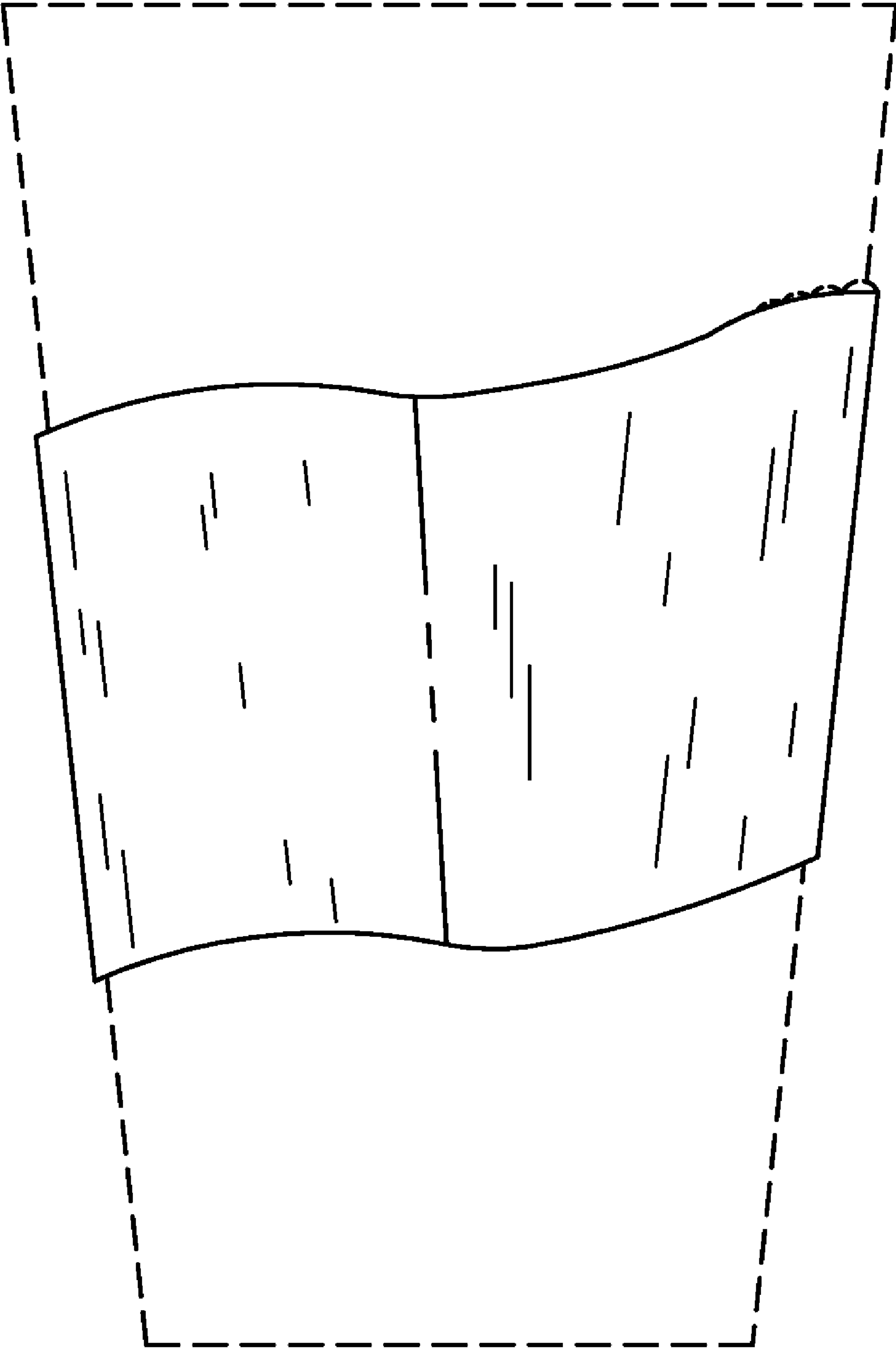

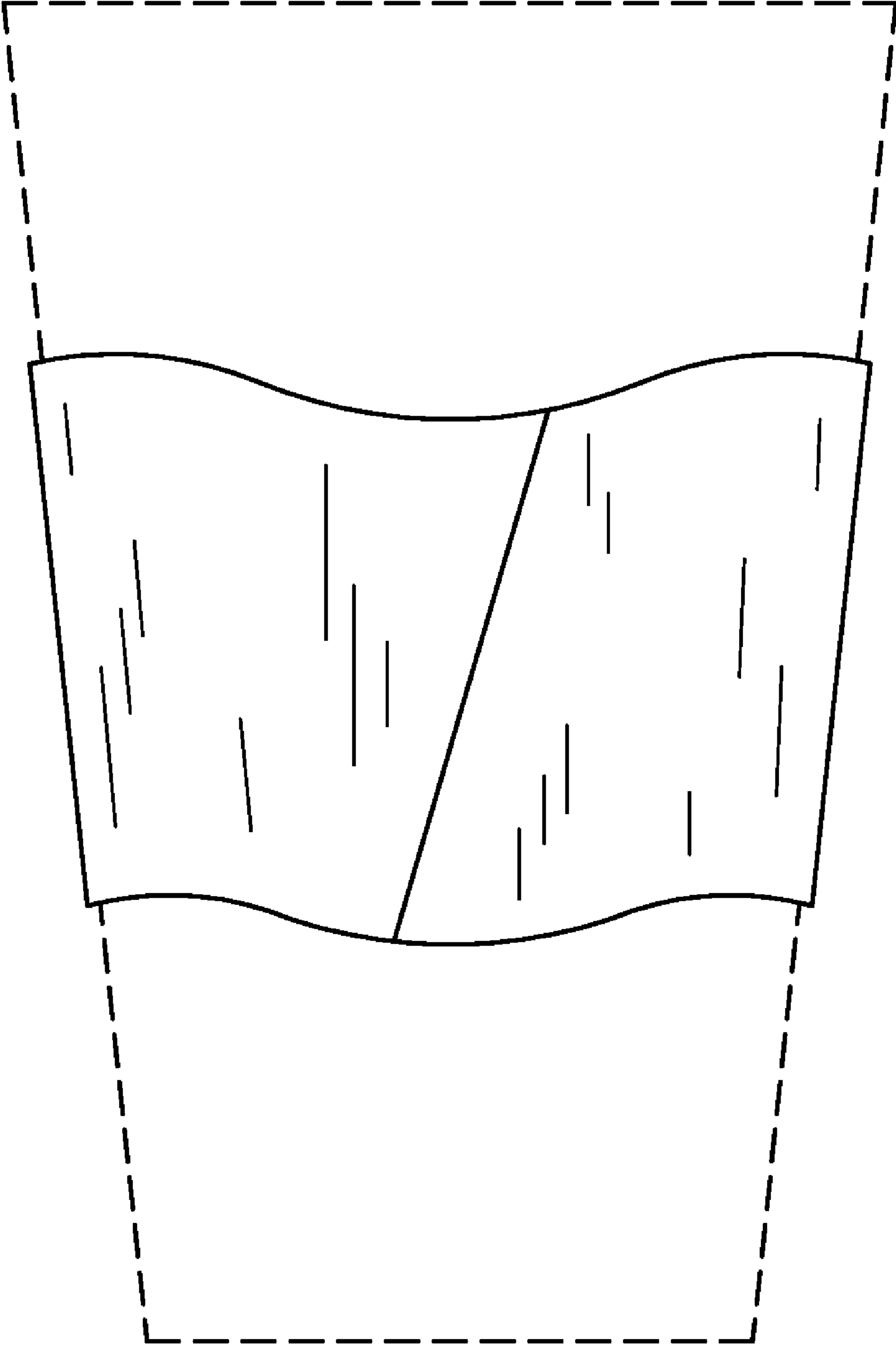

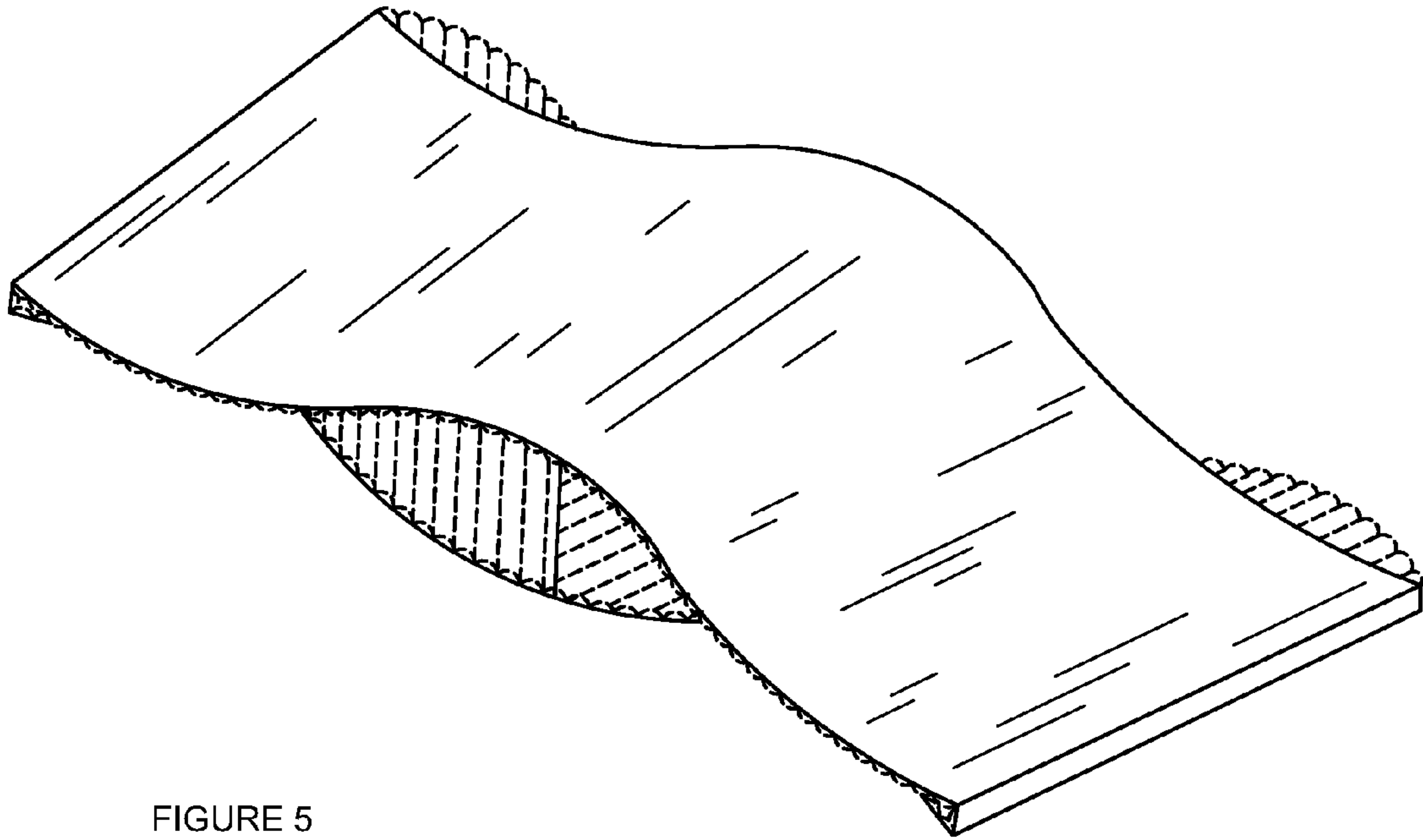

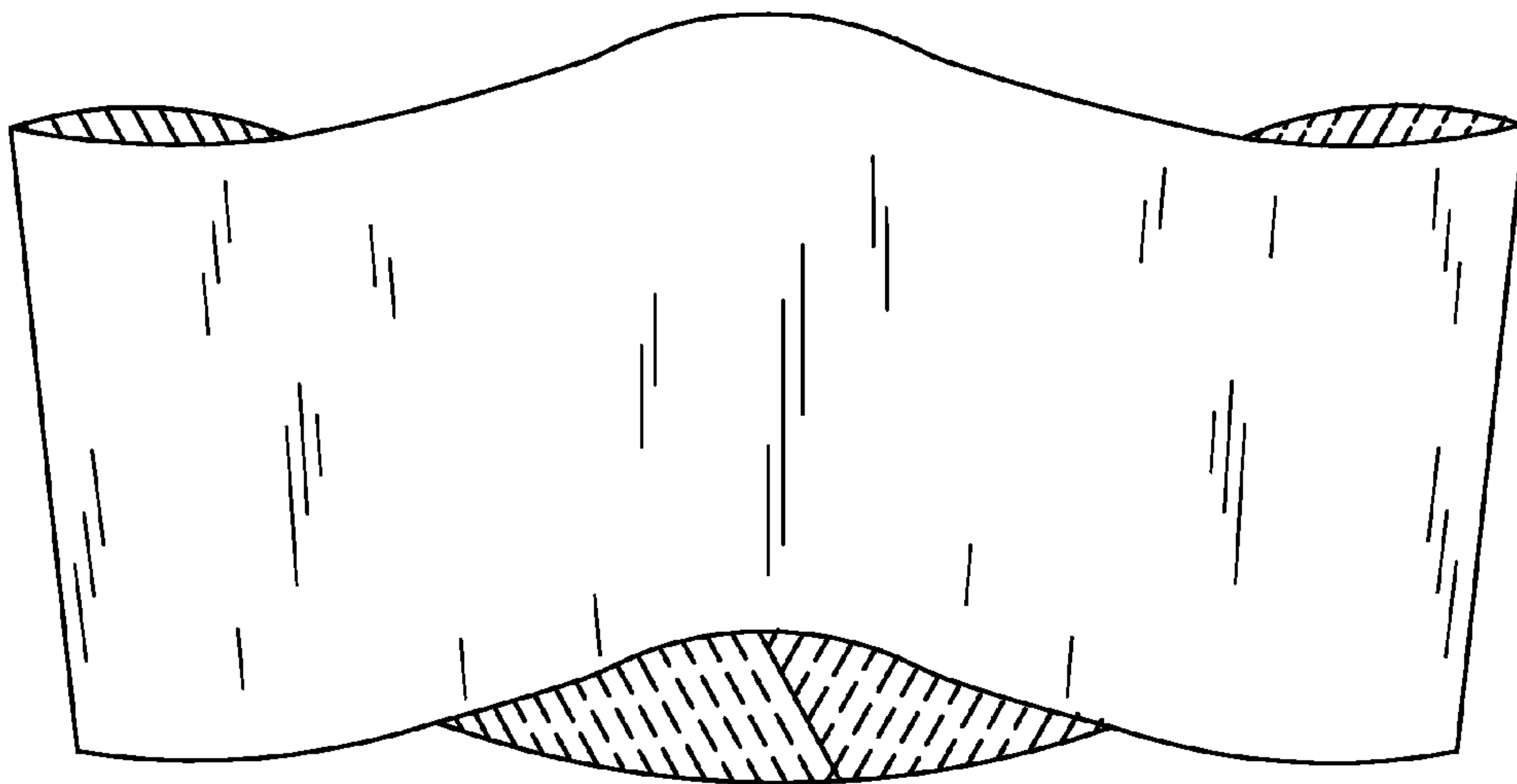

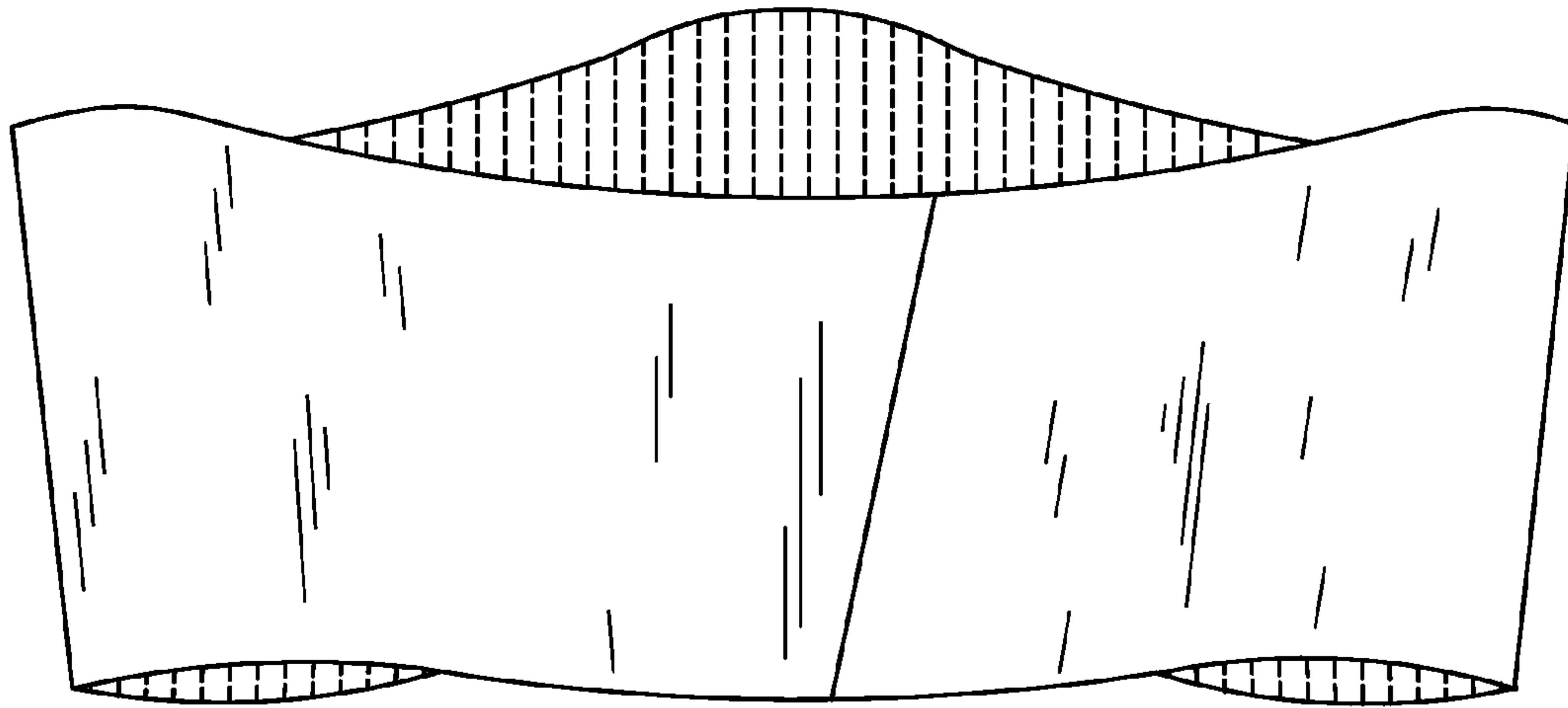

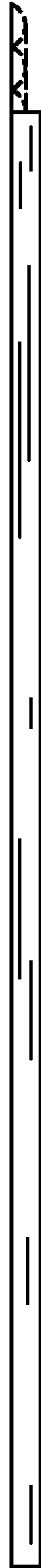

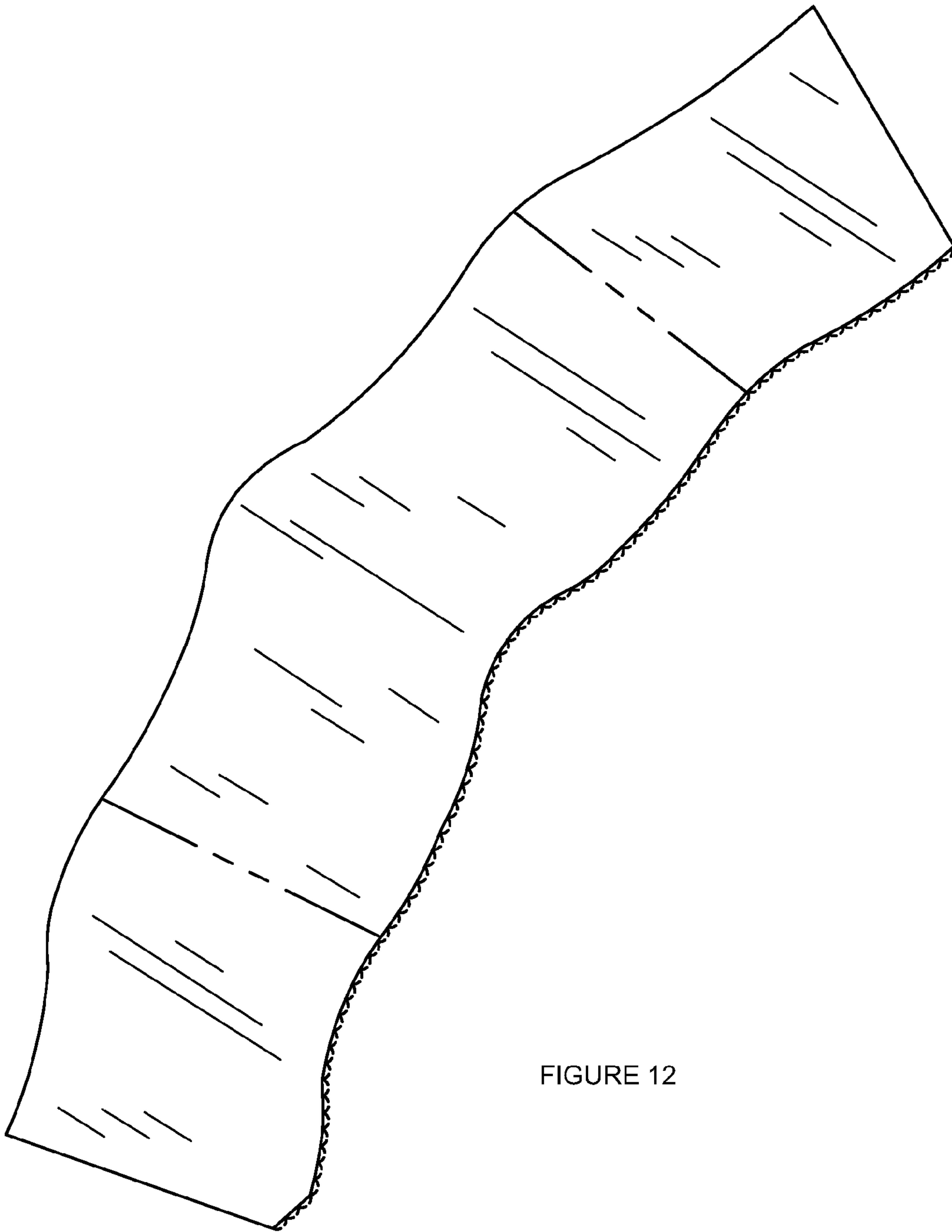

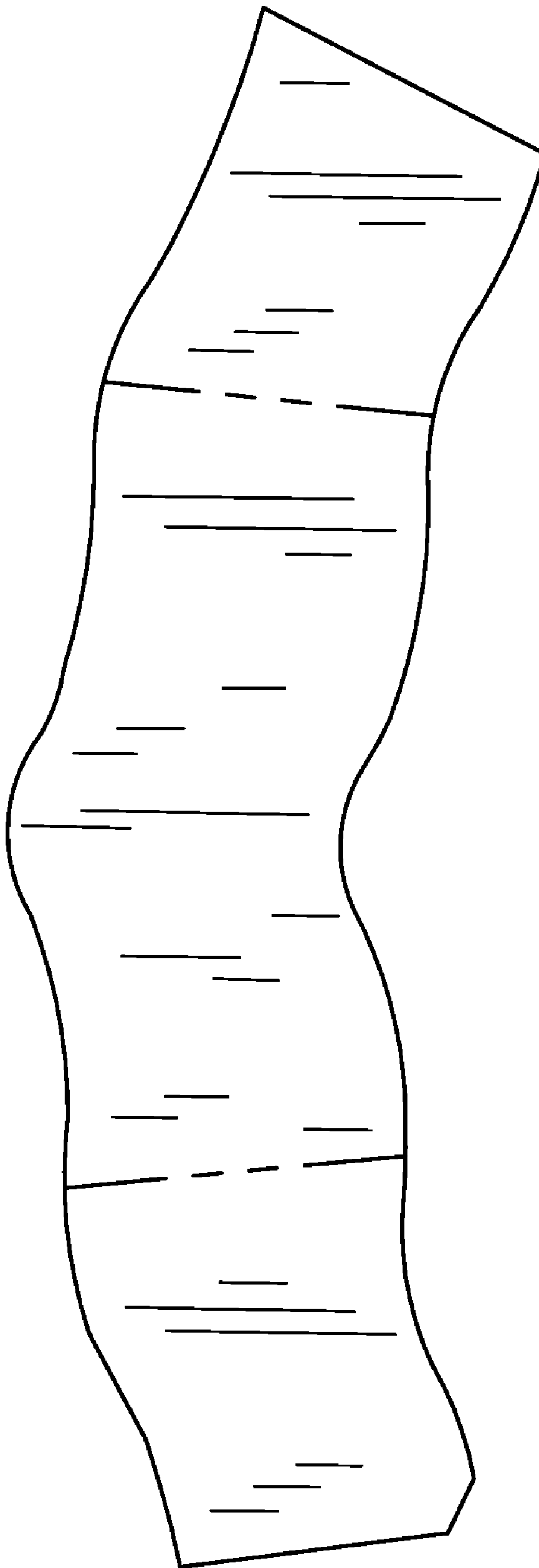

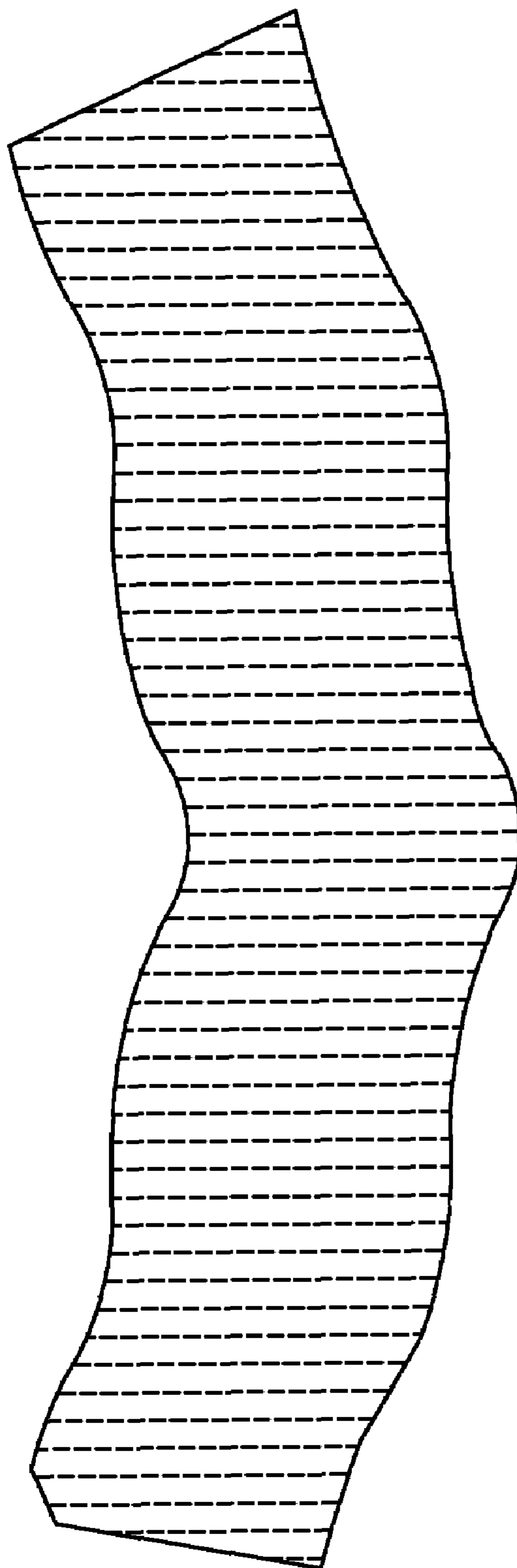
