(57) **CLAIM**

The ornamental design for a window for a package, as shown and described.

FIG. 1 is a perspective view of a first embodiment of a window for a package showing my new design;

FIG. 2 is a front side view of the window for a package as shown in FIG. 1;

FIG. 3 is a back side view of the window for a package as shown in FIG. 1;

FIG. 4 is a right side view of the window for a package as shown in FIG. 1;

FIG. 5 is a left side view of the window for a package as shown in FIG. 1;

FIG. 6 is a top view of the window for a package as shown in FIG. 1;

FIG. 7 is a bottom view of the window for a package as shown in FIG. 1;

FIG. 8 is perspective view of a second embodiment of a window for a package showing my new design;

FIG. 9 is a front side view of the window for a package as shown in FIG. 8;

FIG. 10 is a back side view of the window for a package as shown in FIG. 8;

FIG. 11 is a right side view of the window for a package as shown in FIG. 8;

FIG. 12 is a left side view of the window for a package as shown in FIG. 8;

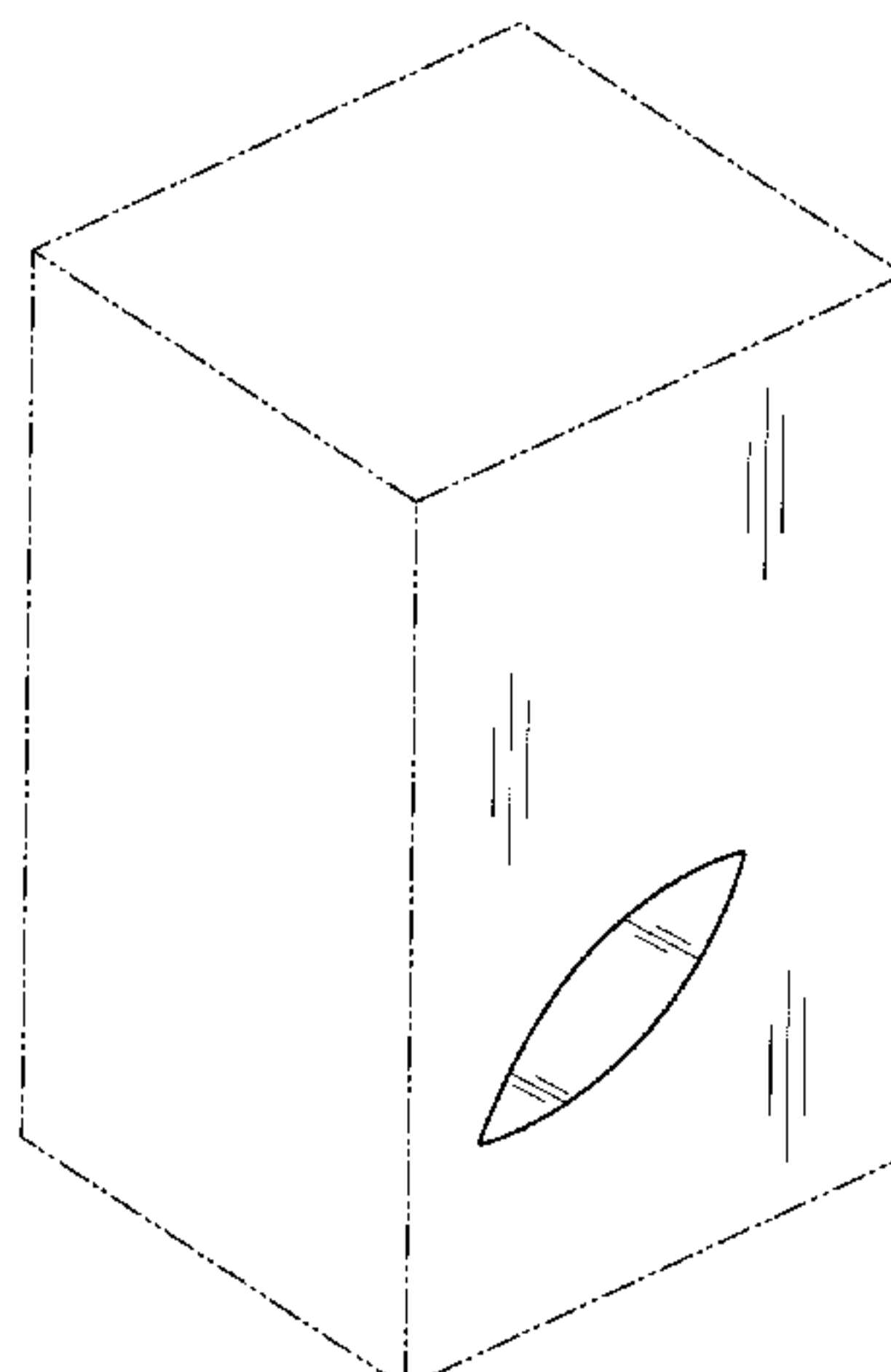
FIG. 13 is a top view of the window for a package as shown in FIG. 8; and,

FIG. 14 is a bottom view of the window for a package as shown in FIG. 8.

The broken lines showing the rear, top, bottom and sides of the package illustrate environmental structure and form no part of the claimed design.

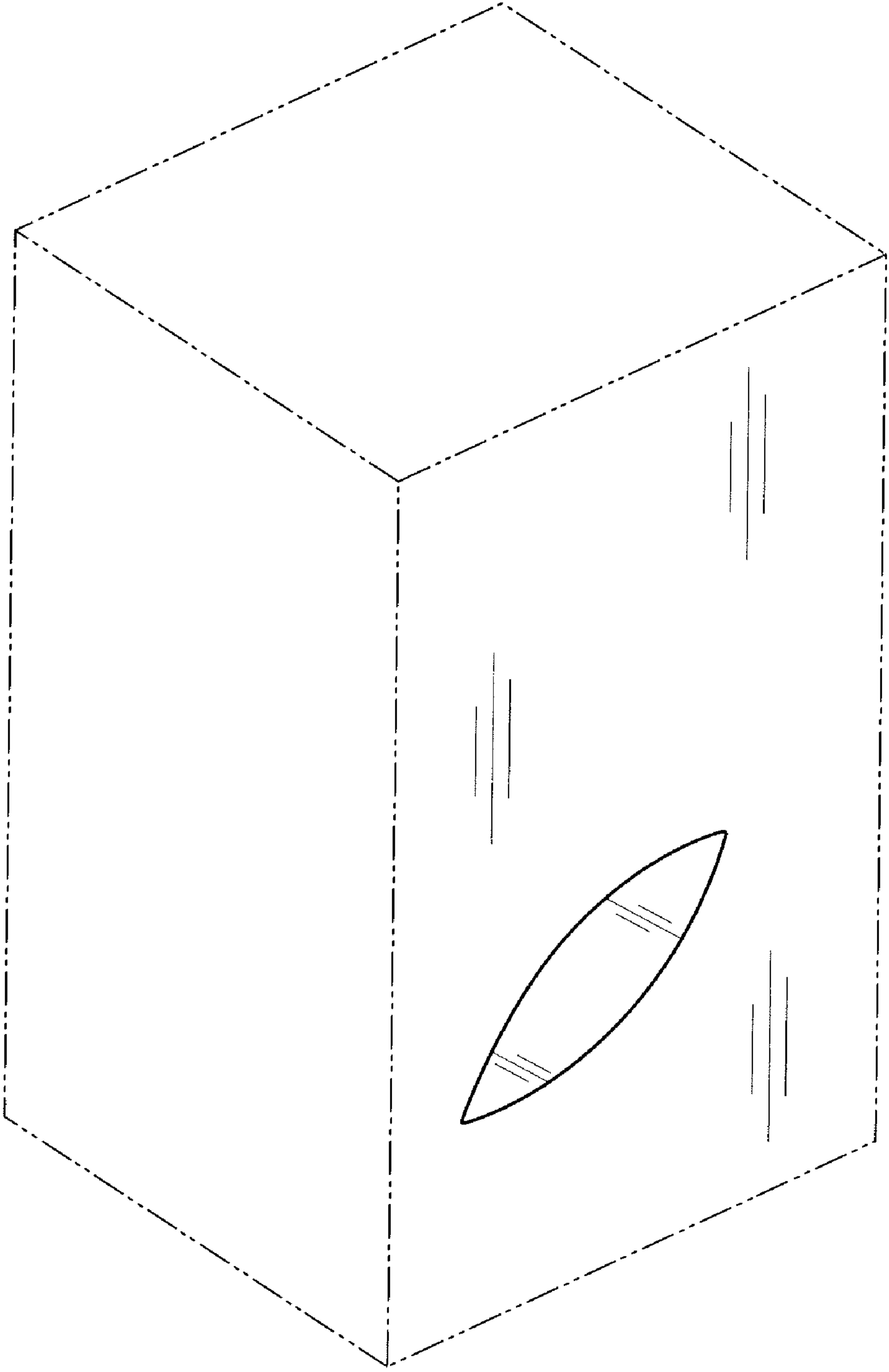

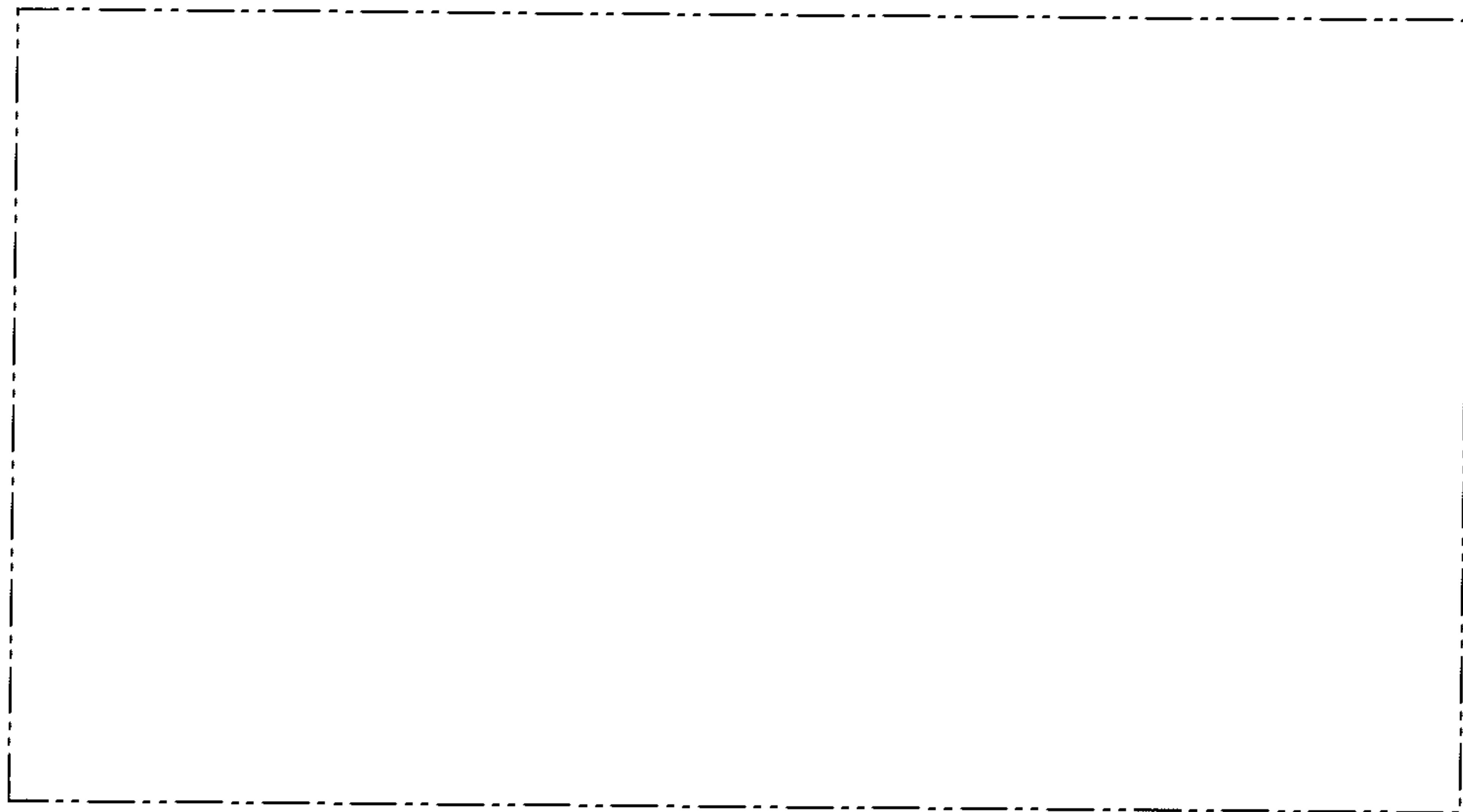

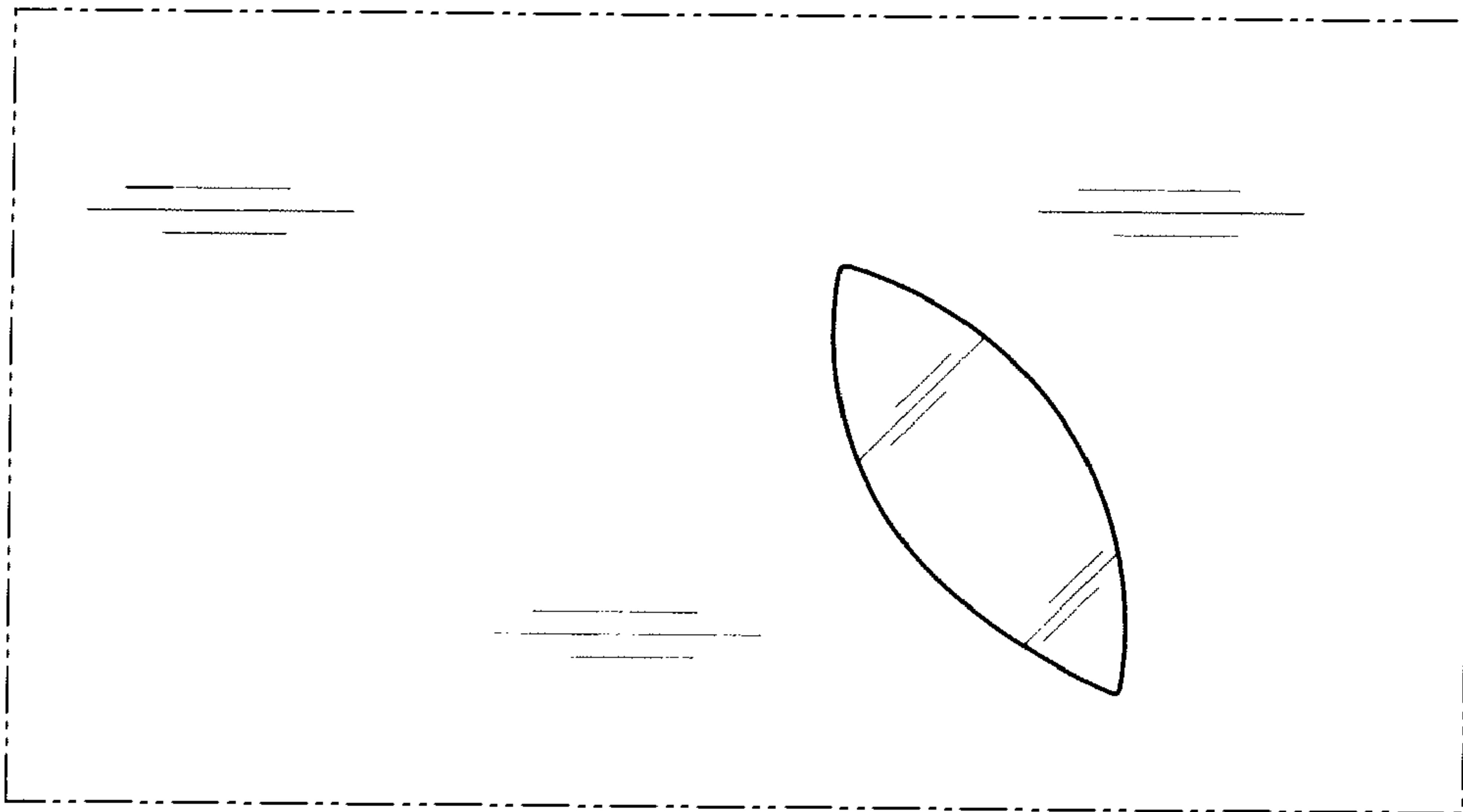
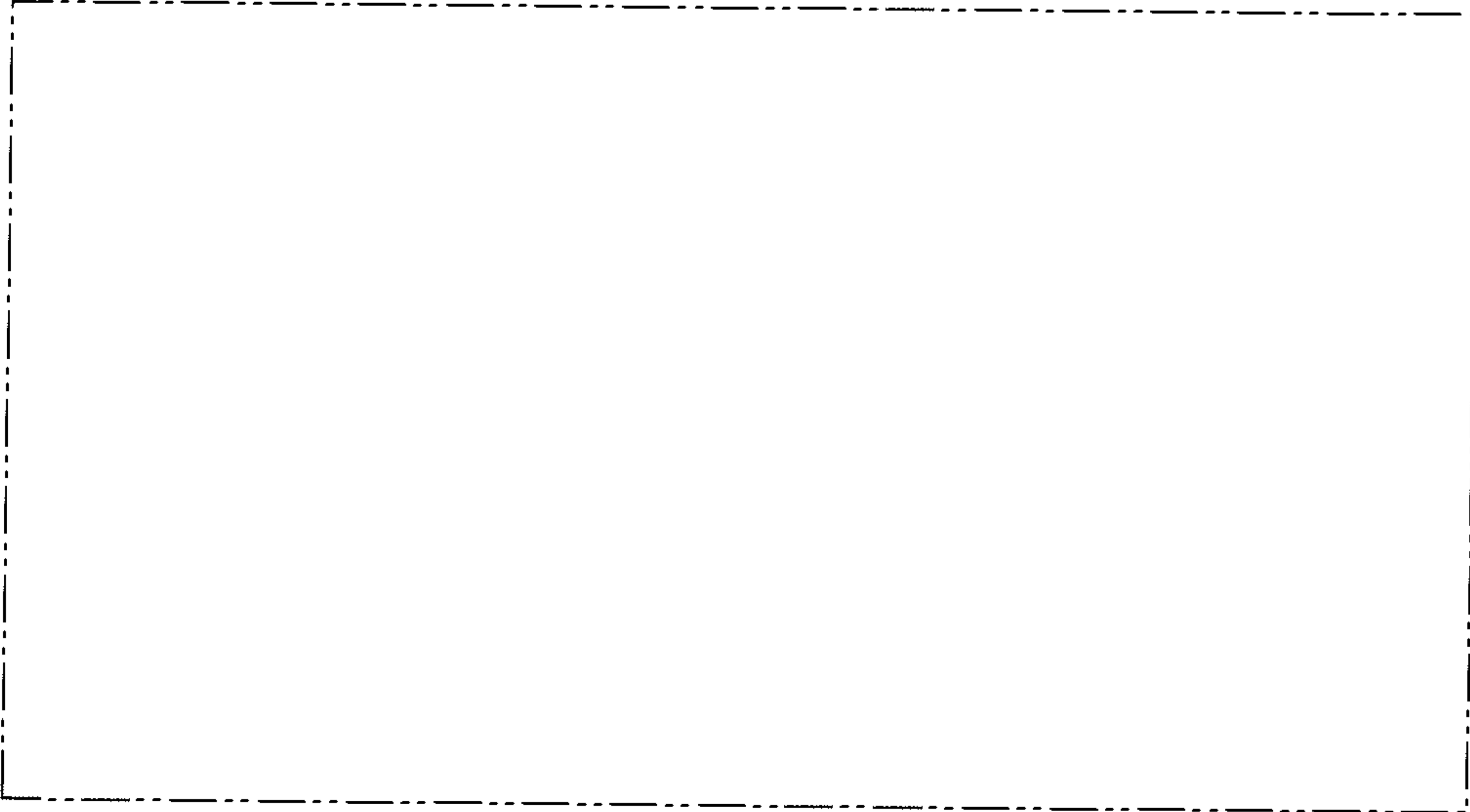


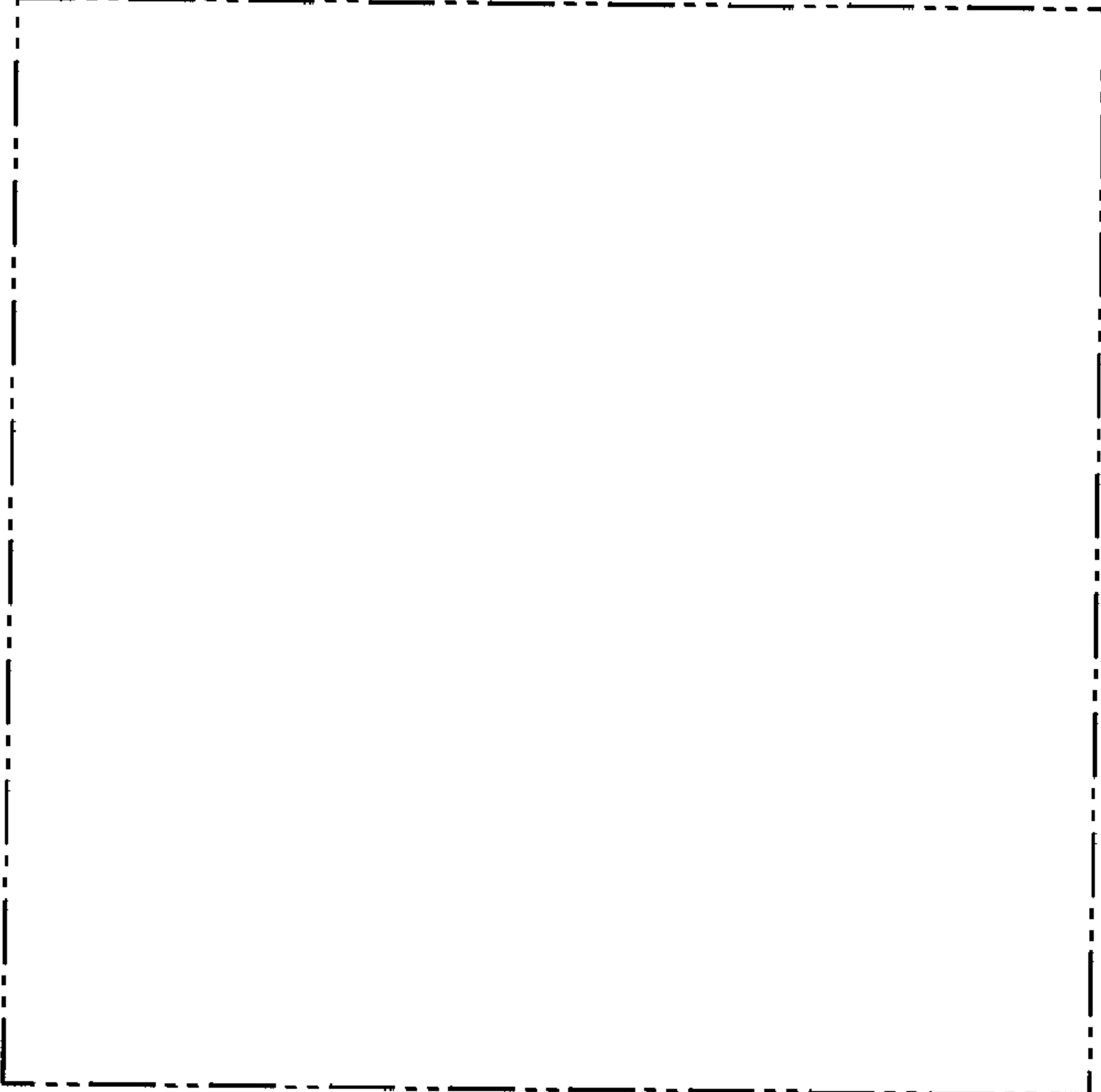

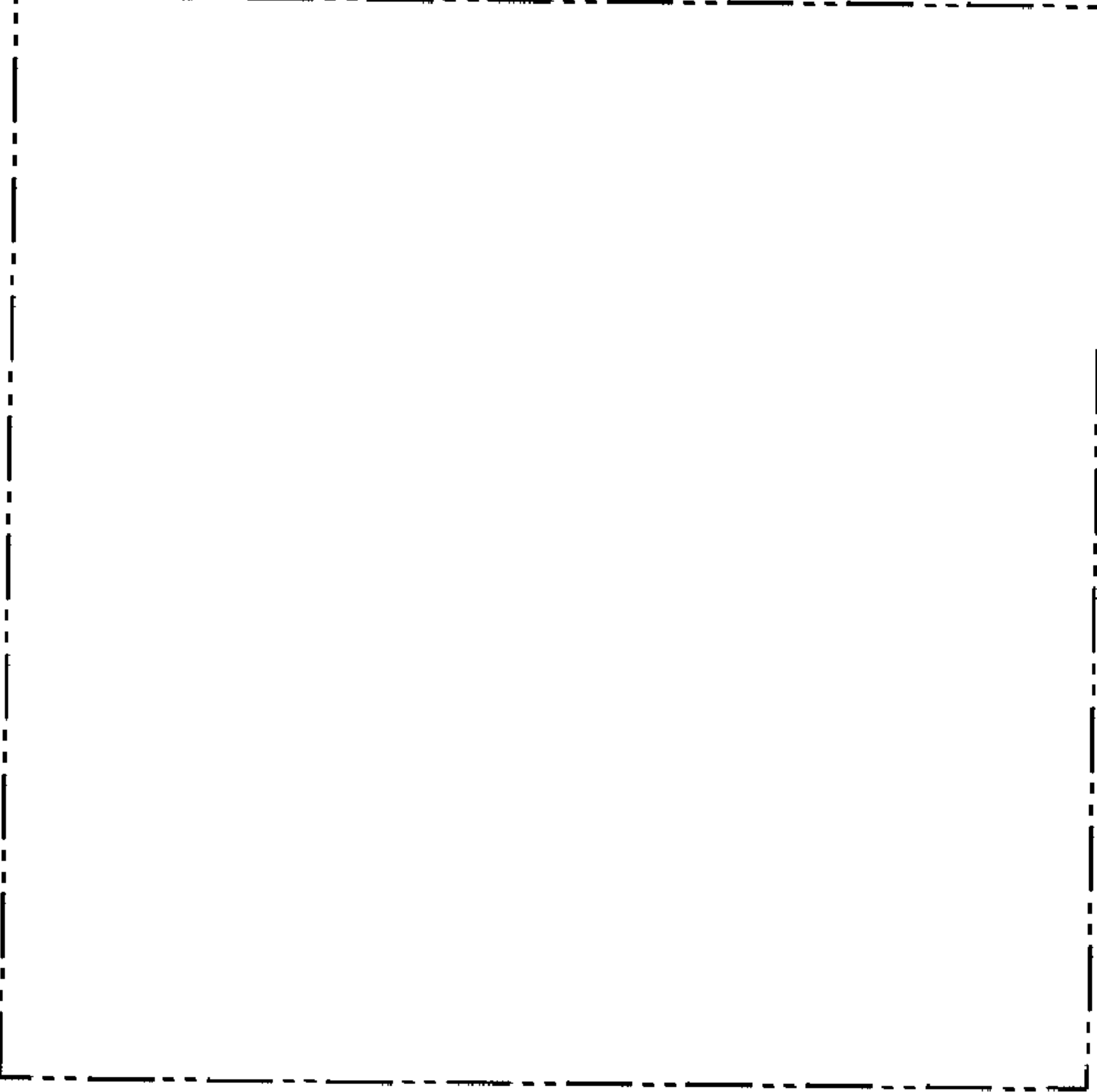

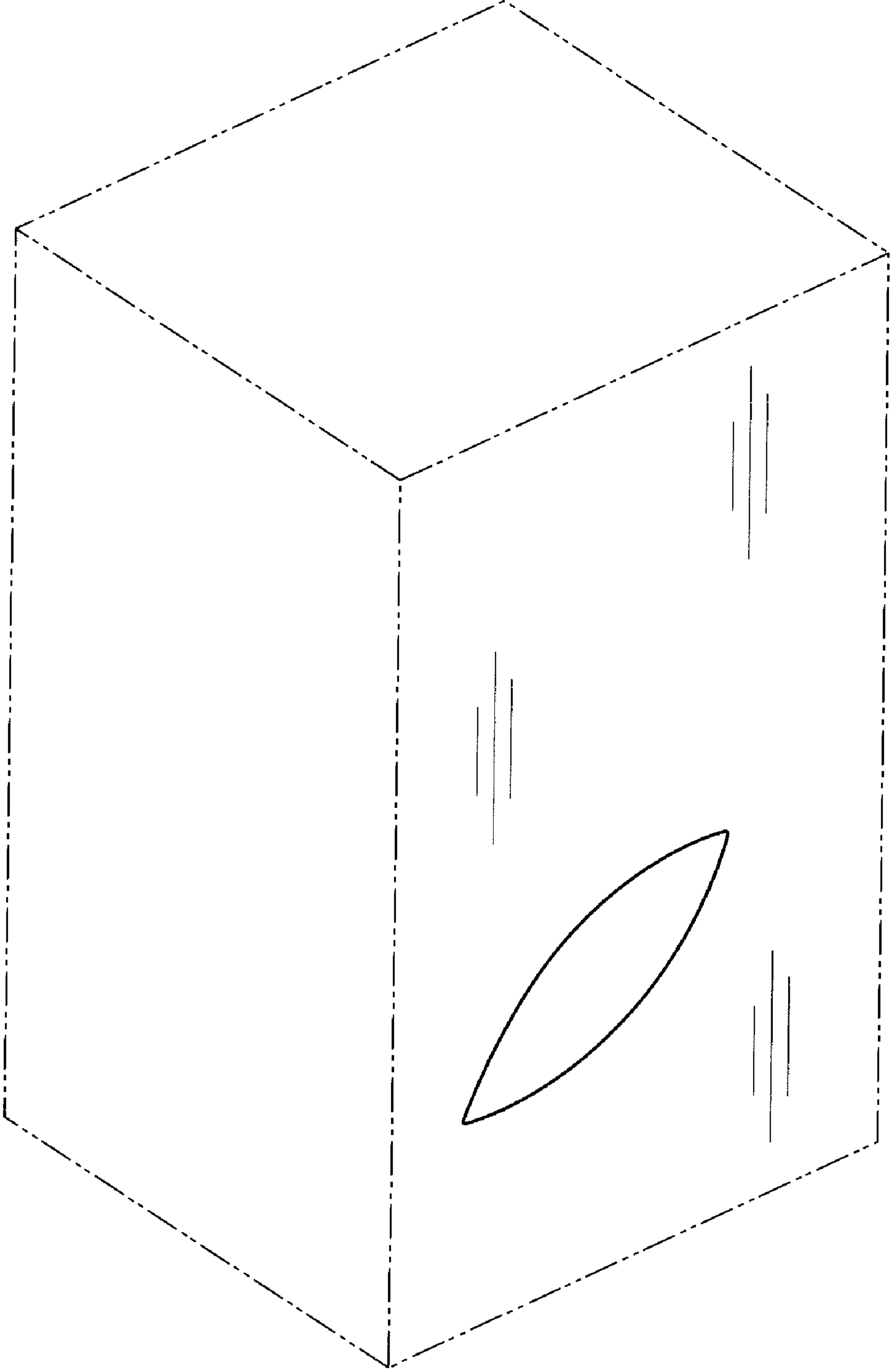

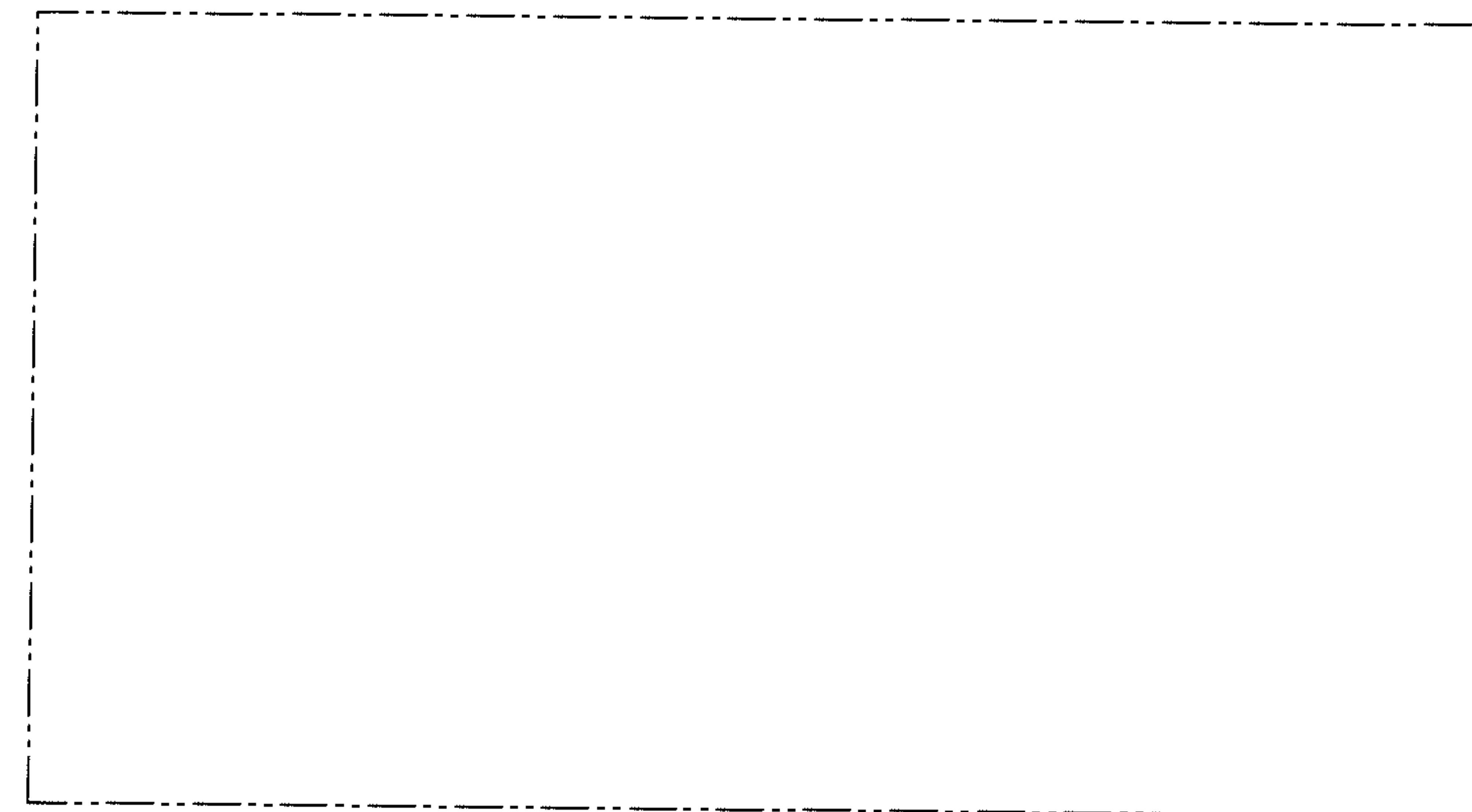

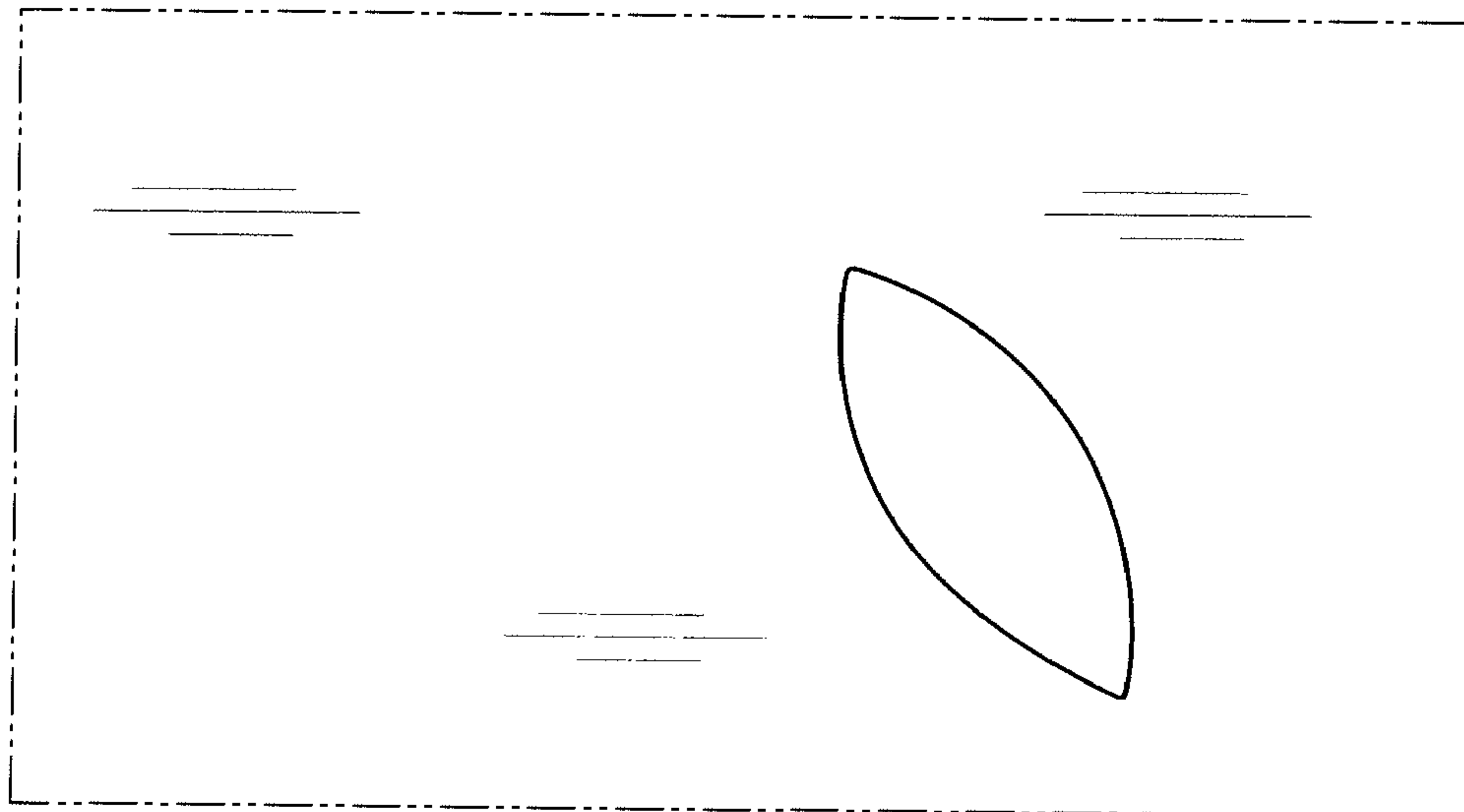
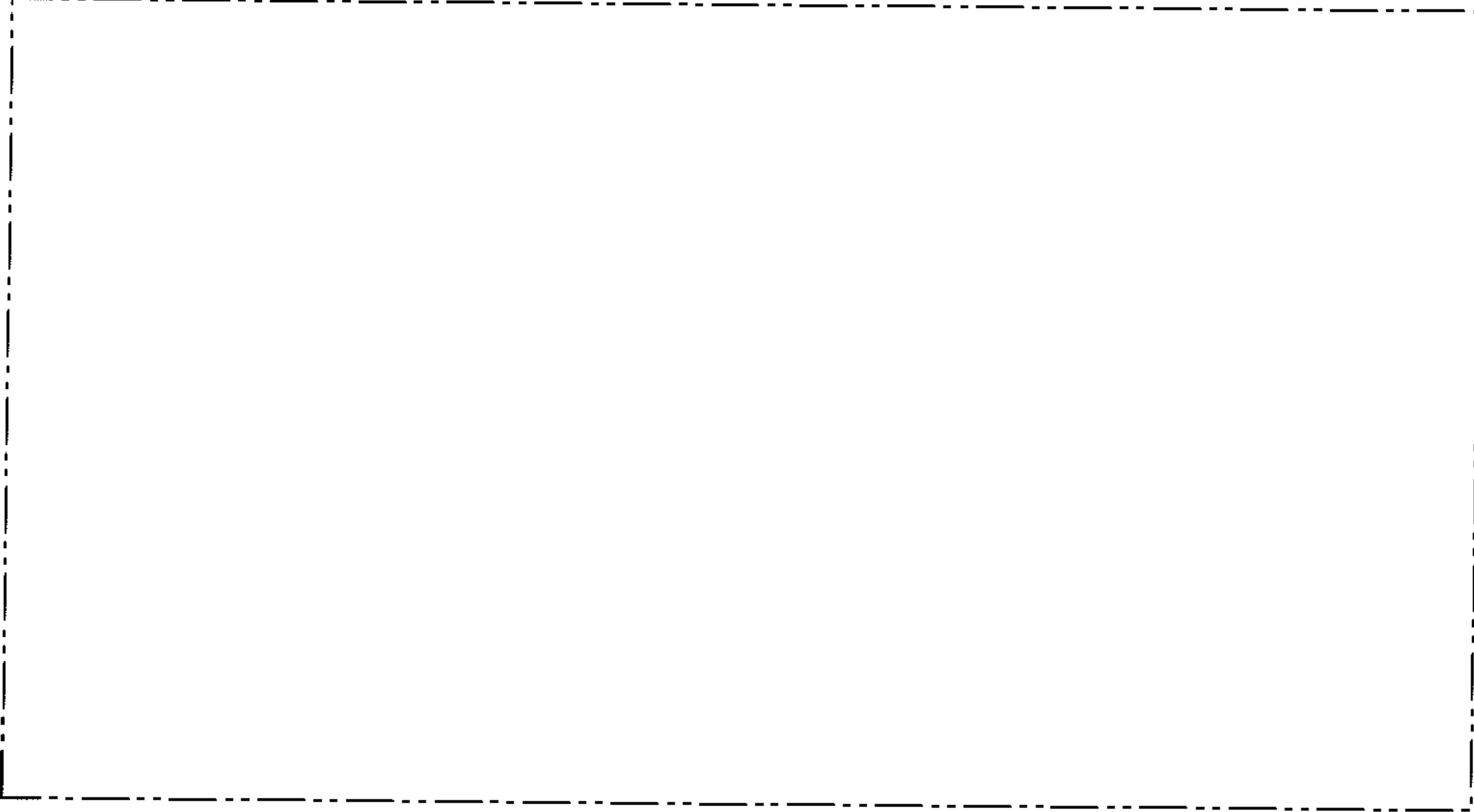

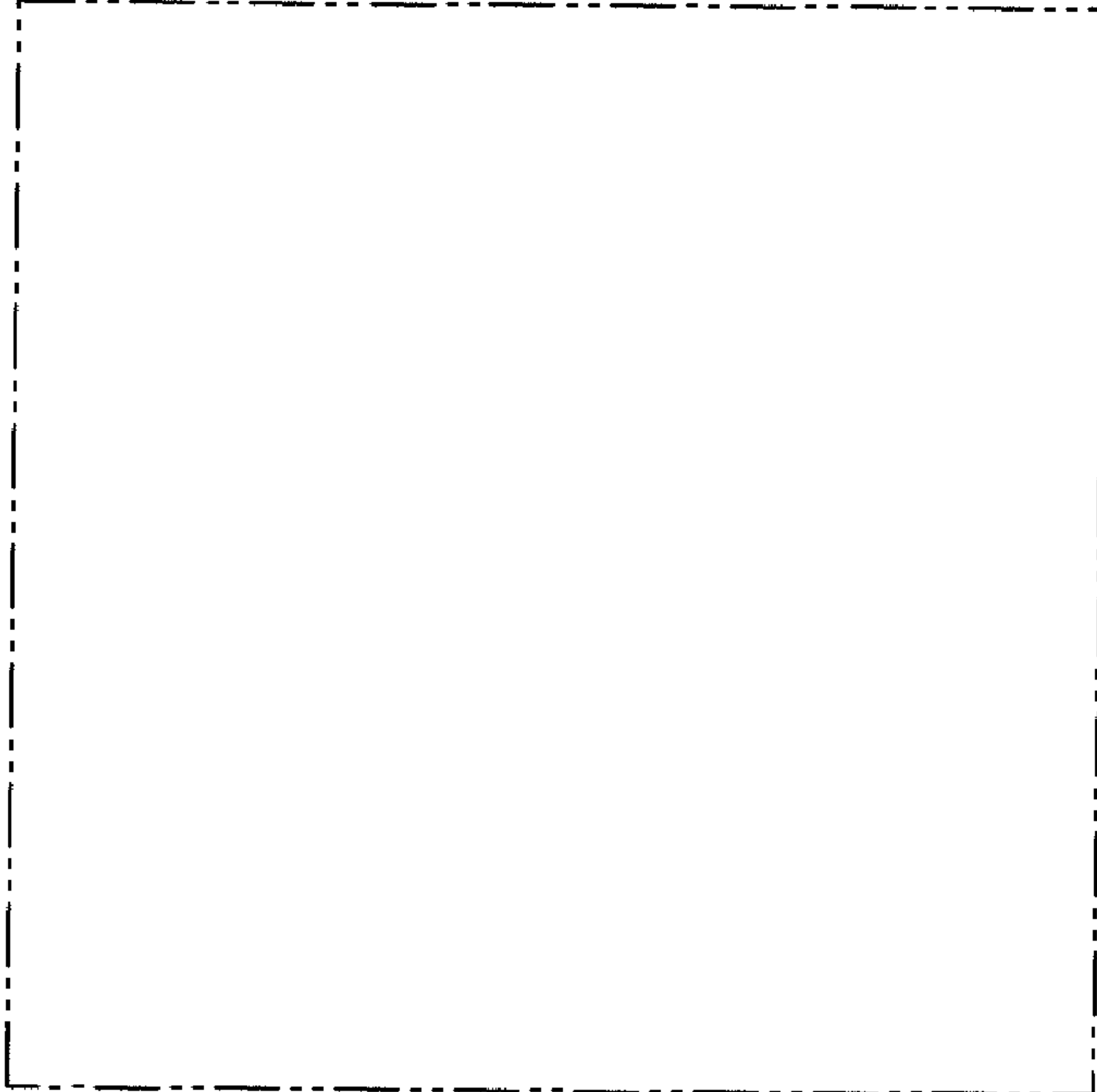




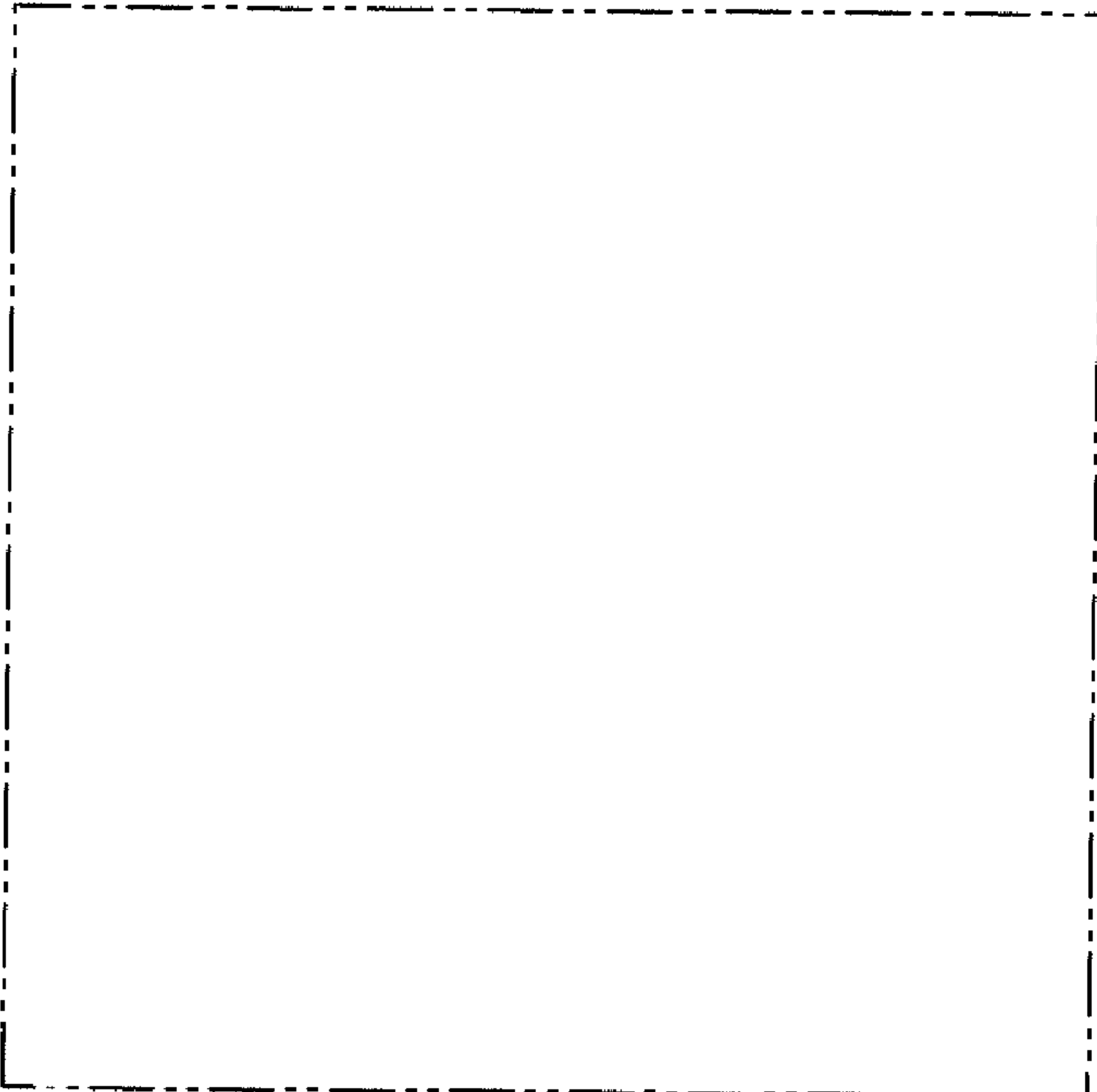
