DESCRIPTION

FIG. 1 is a top plan view of a precision level according to the invention;

FIG. 2 is a front elevational view of the invention;

FIG. 3 is a bottom plan view of the invention;

FIG. 4 is a rear elevational view of the invention;

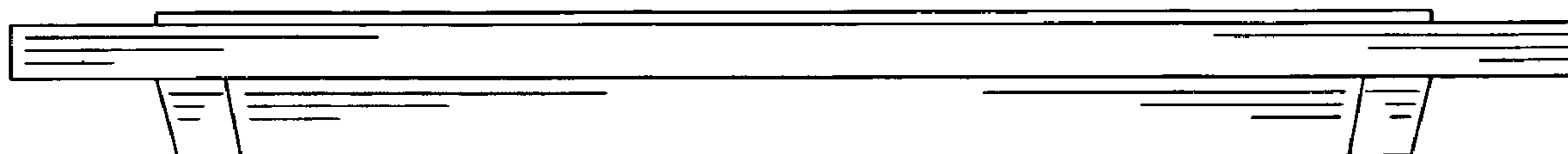
FIG. 5 is a right elevational view of the invention, the left elevational view being a mirror image;

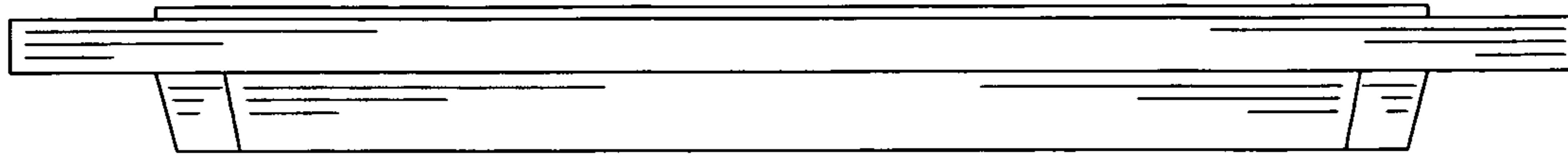

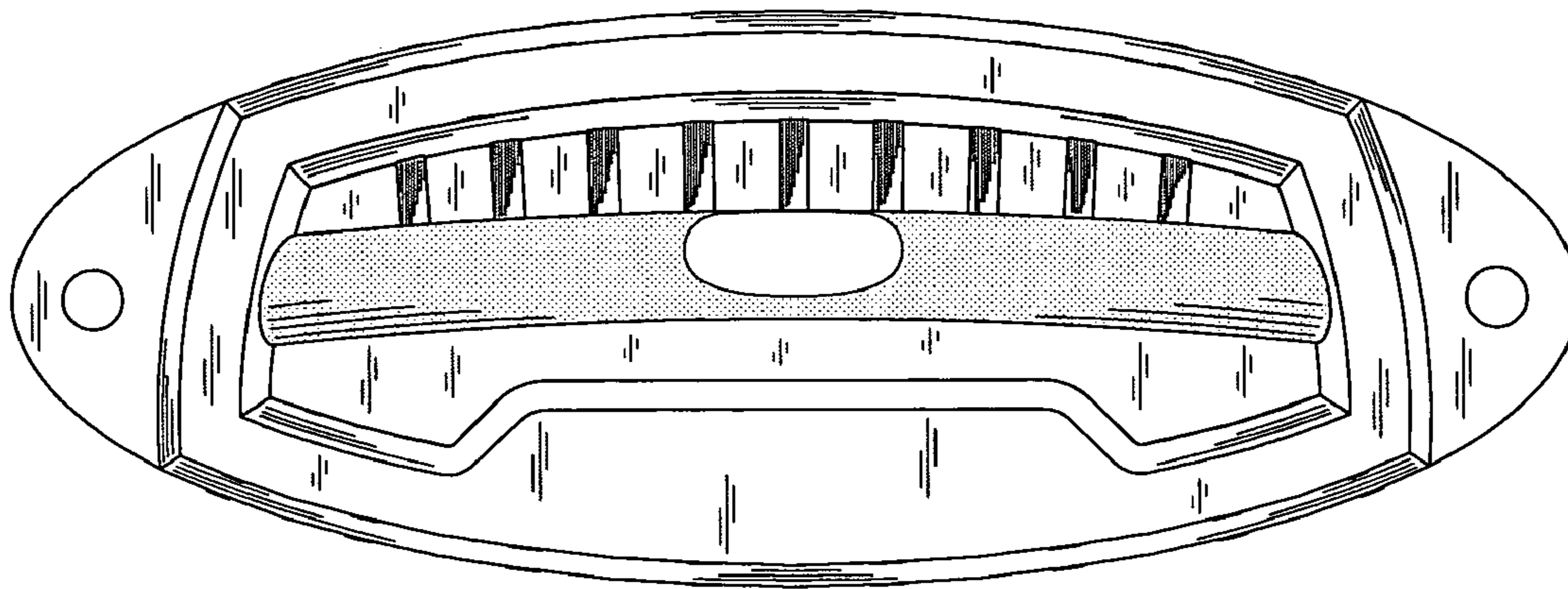

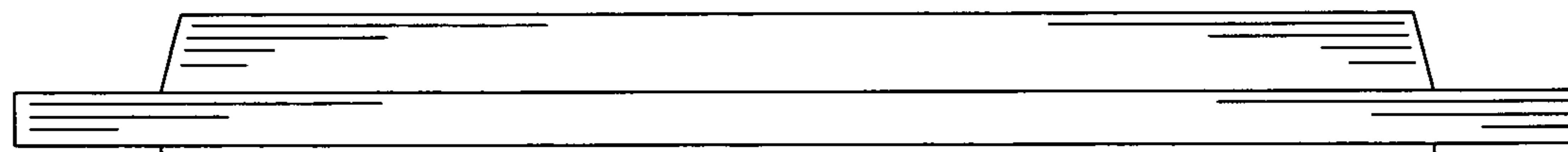

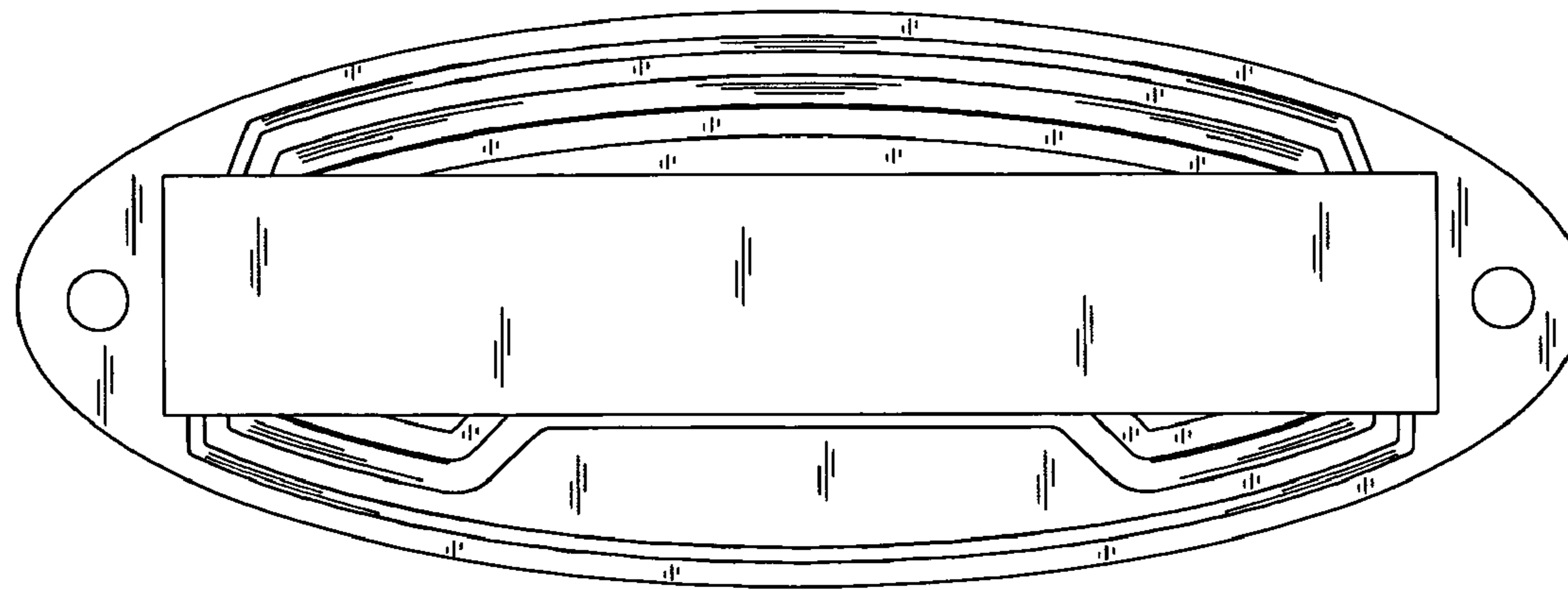

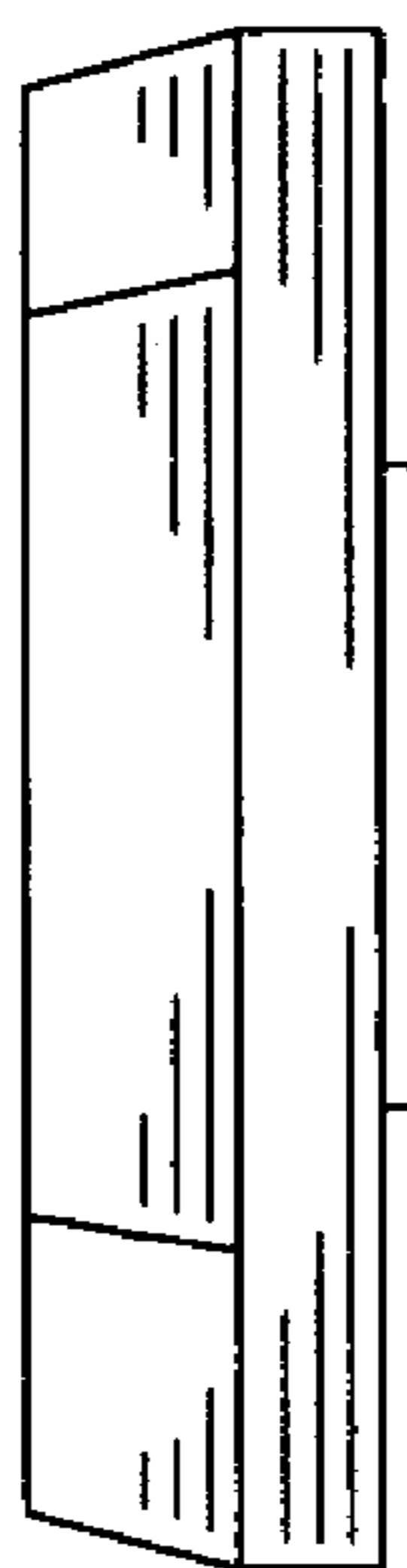

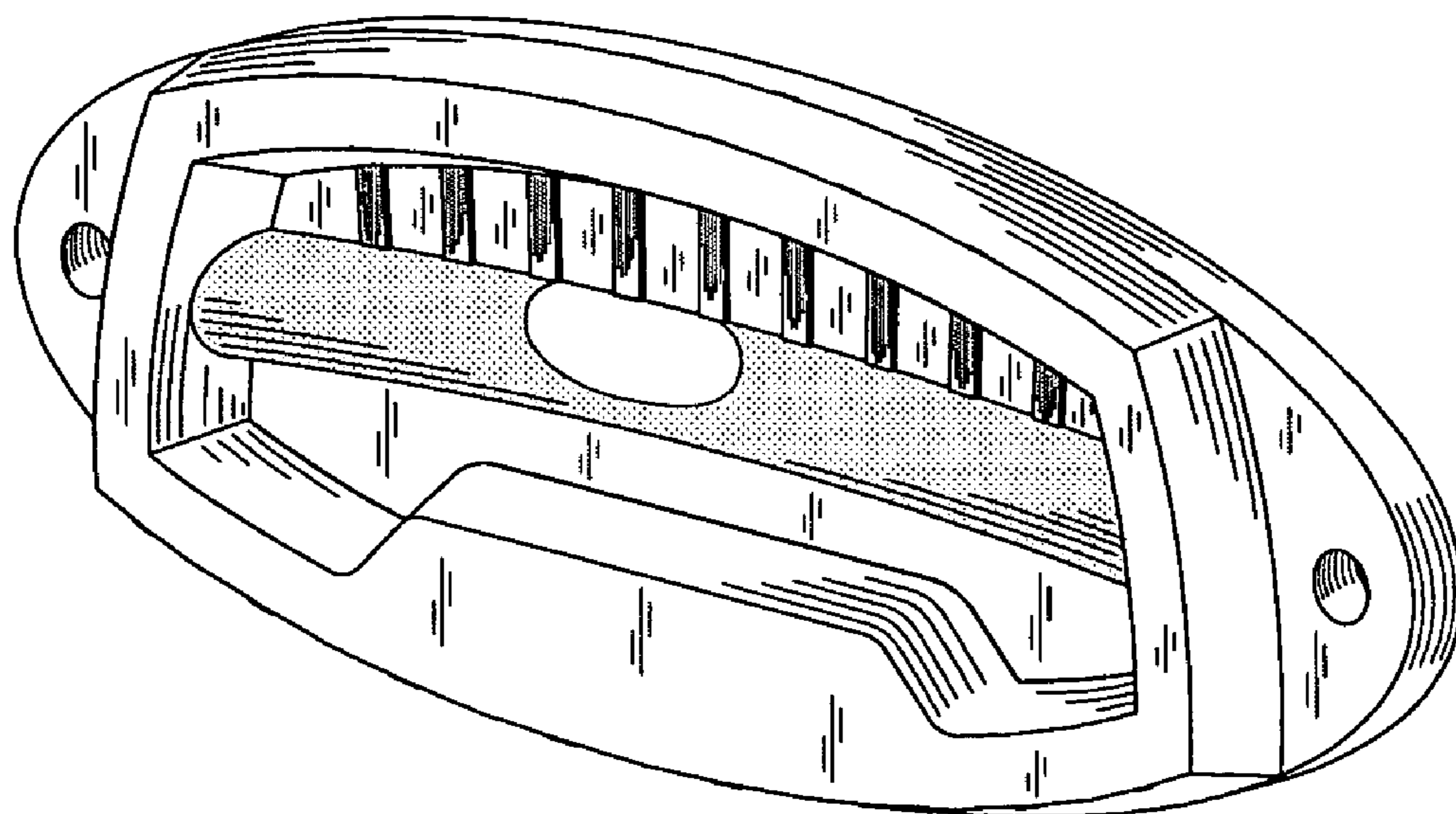

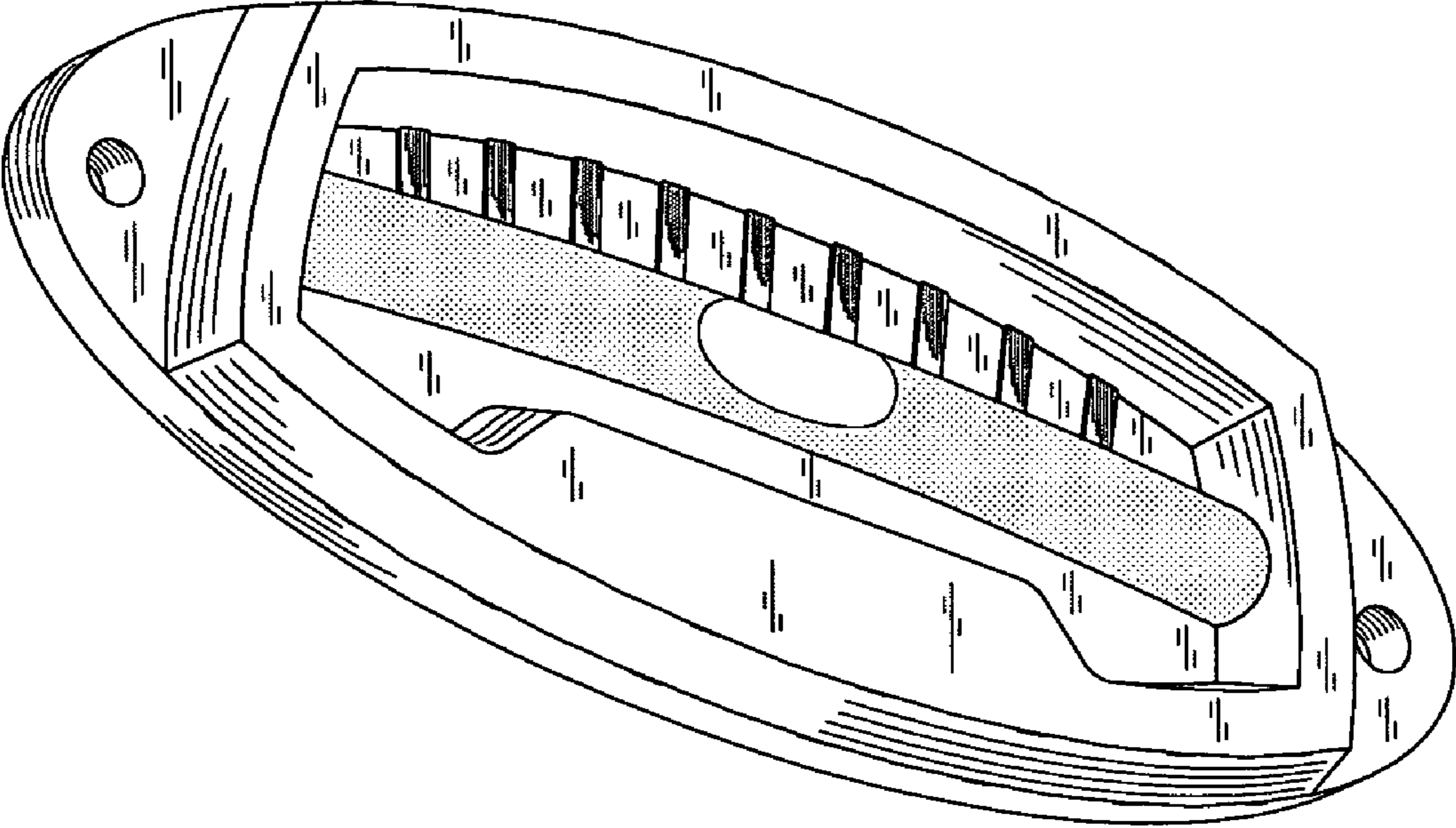

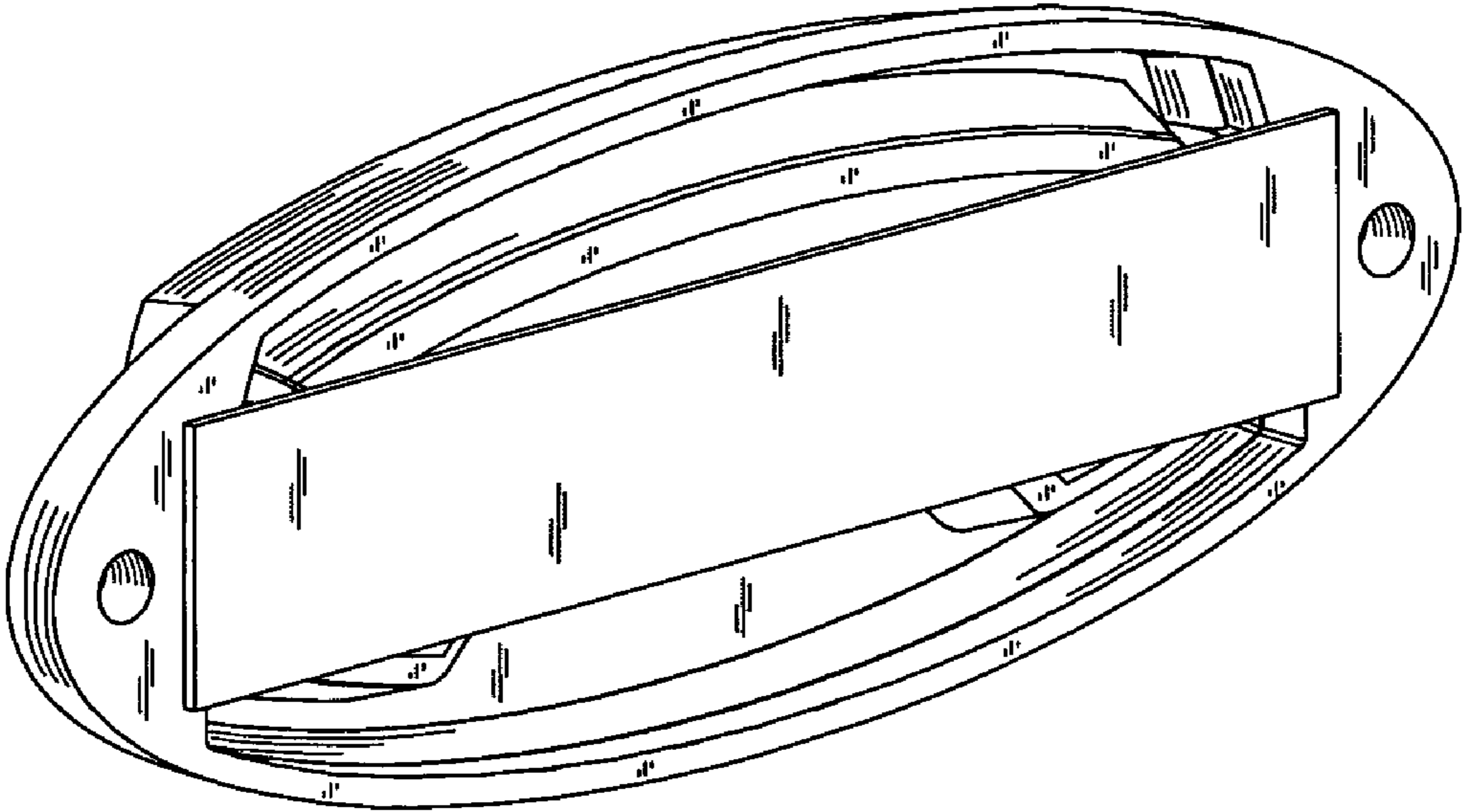
