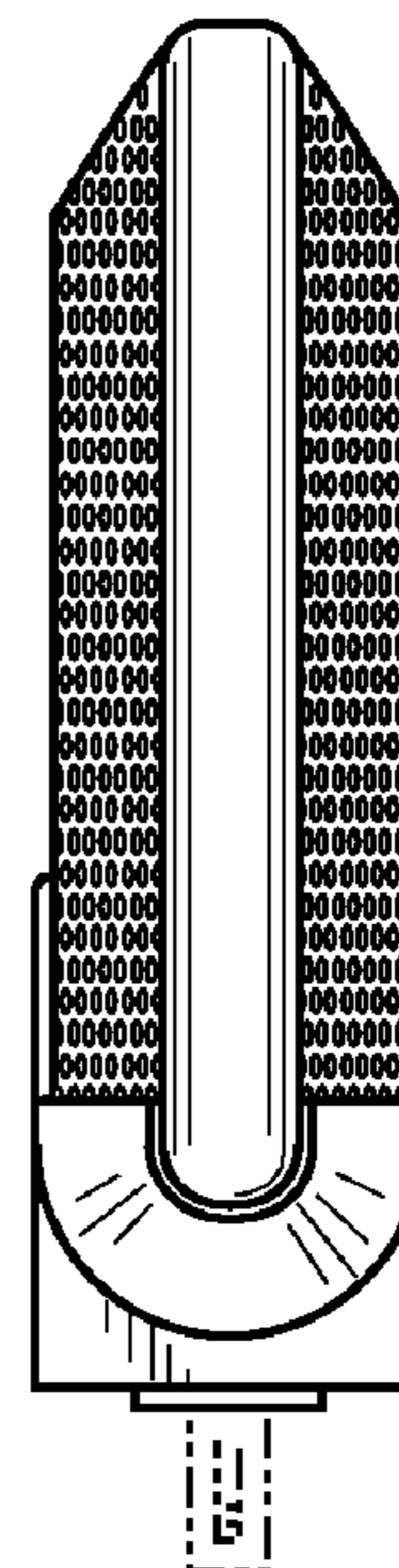
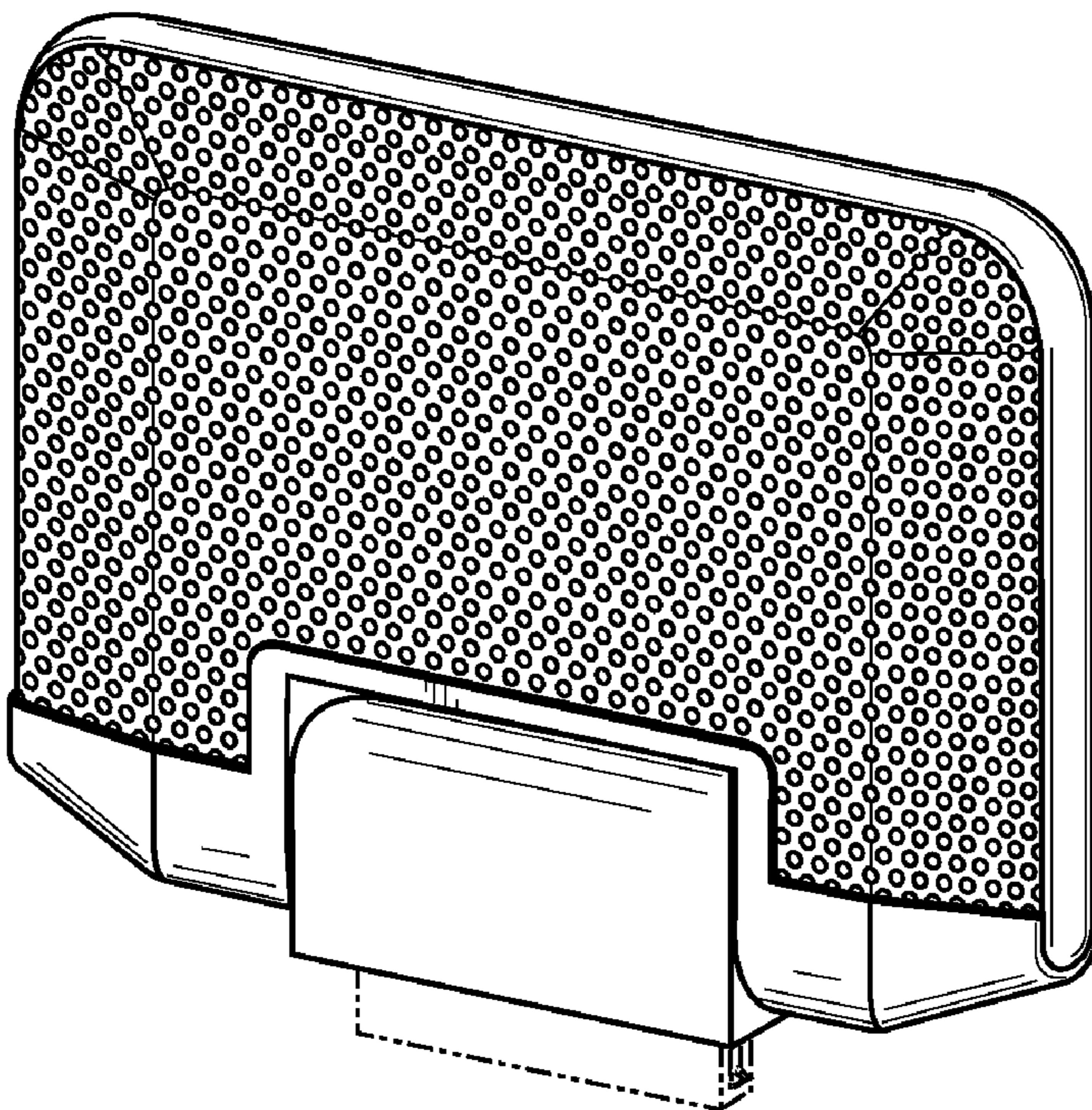
We claim the ornamental design for a microphone, as shown and described.

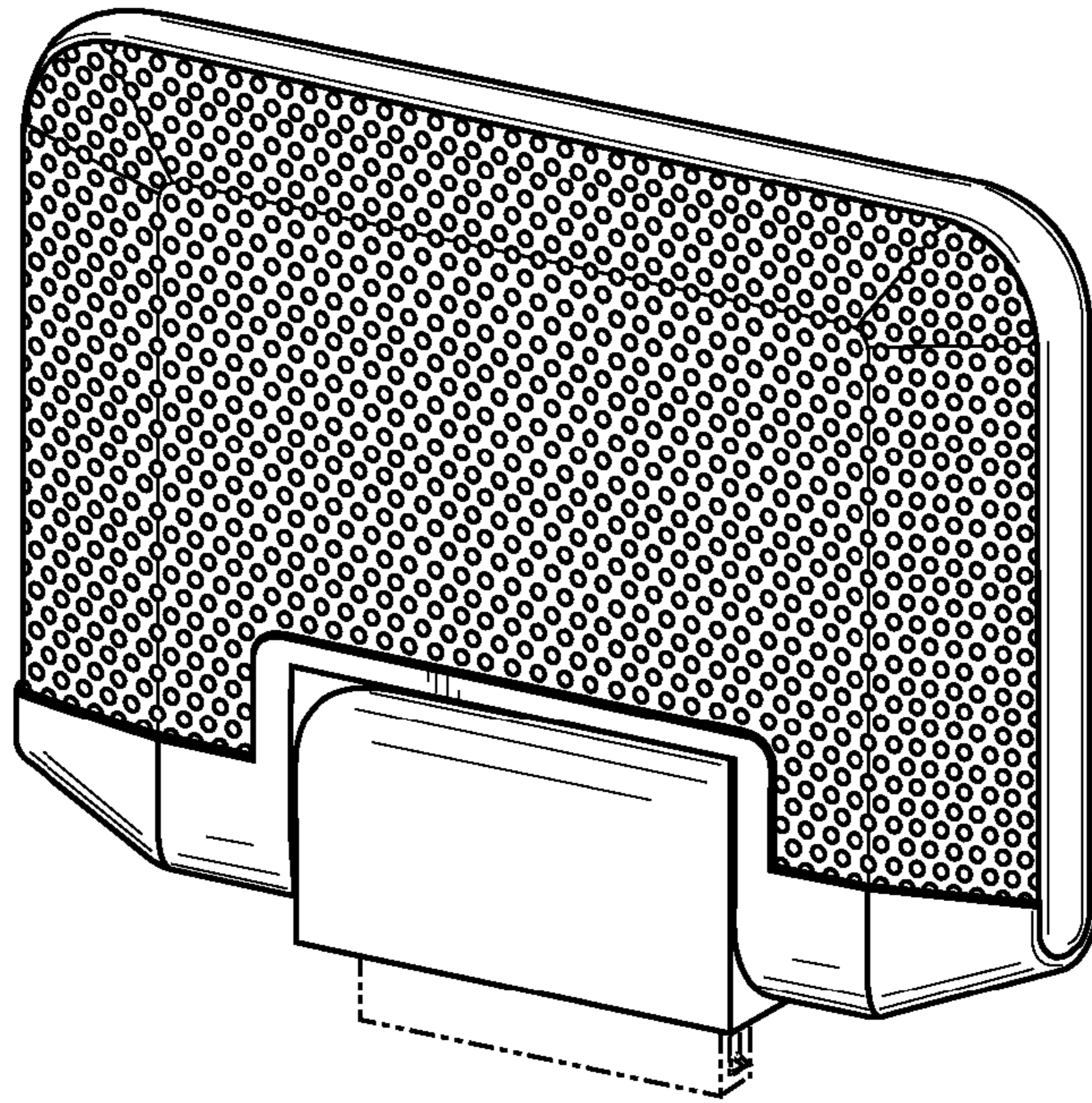
**DESCRIPTION**

FIG. 7 is a bottom view thereof.

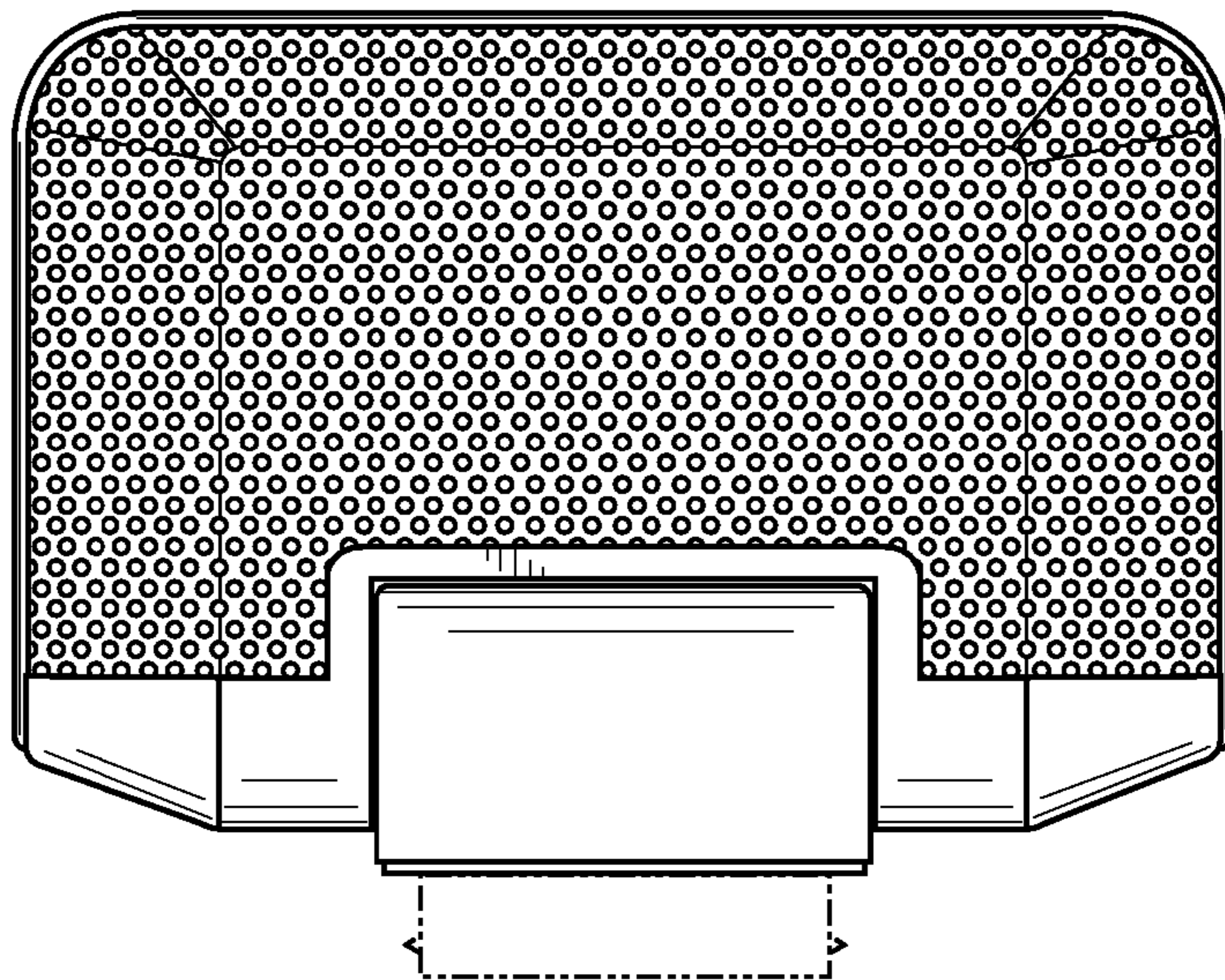

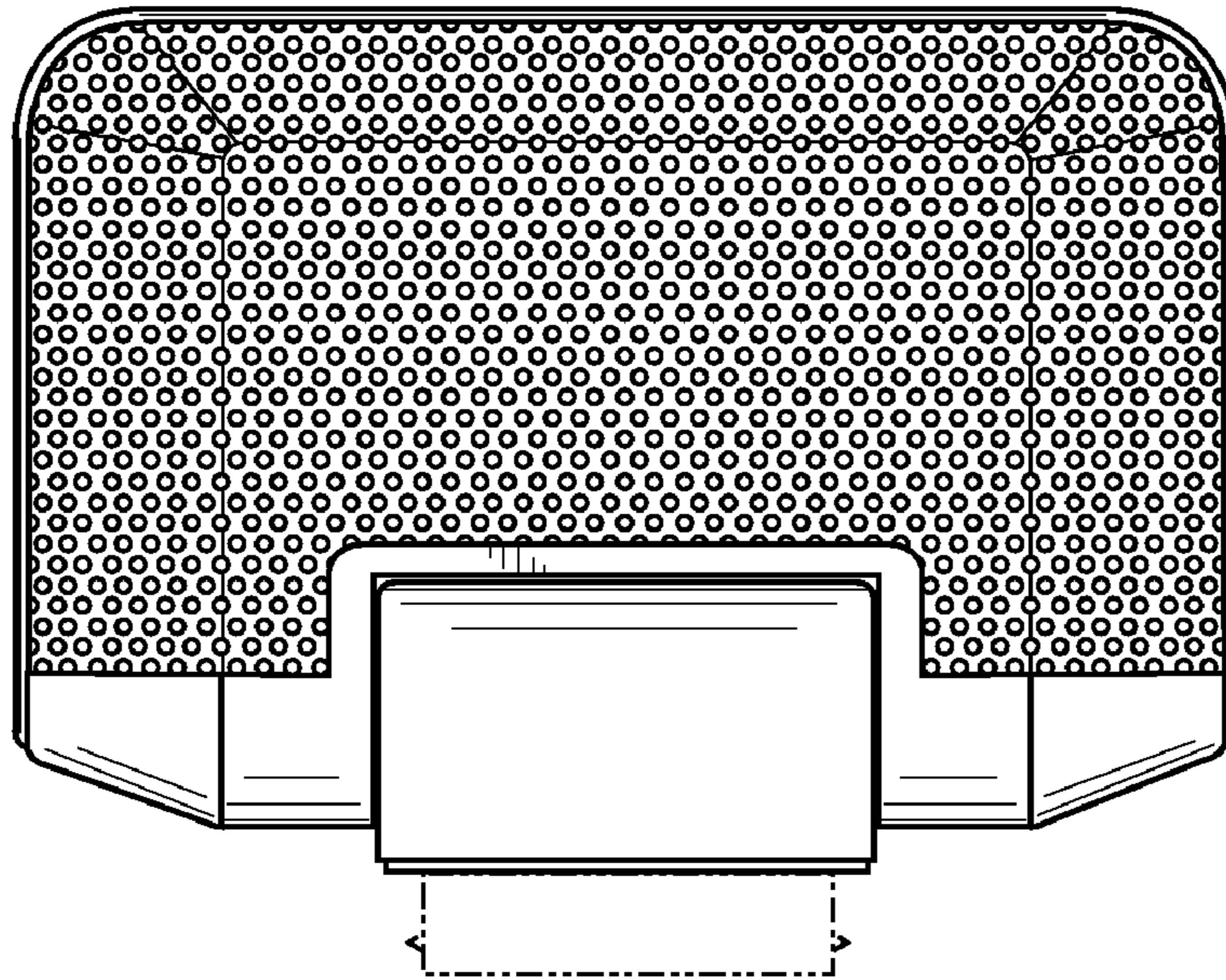

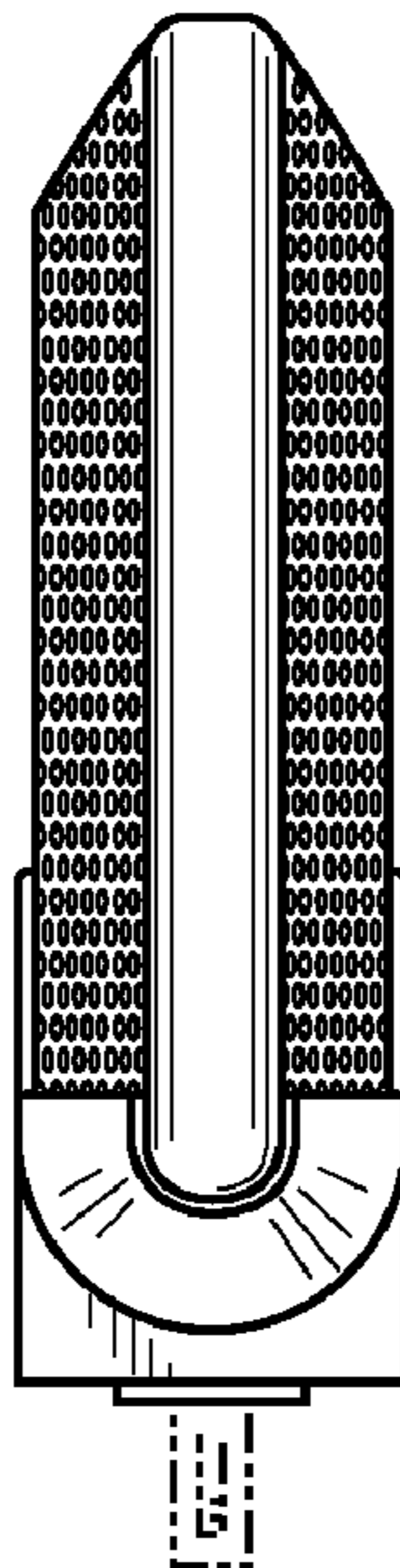

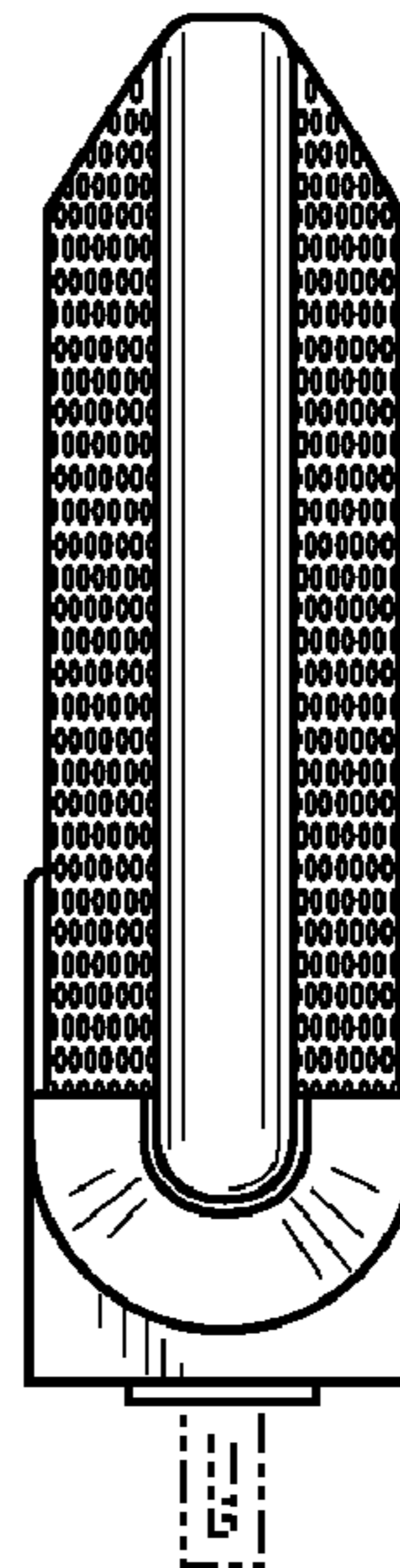




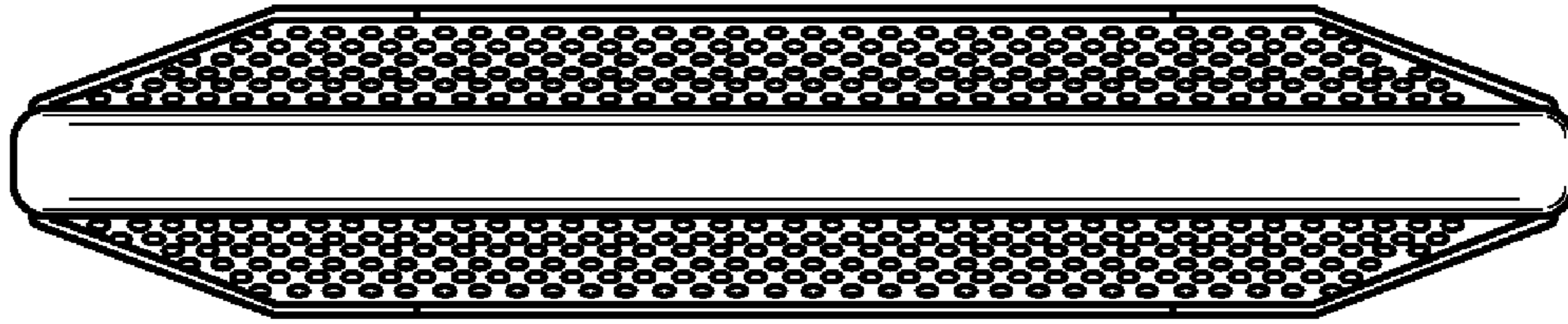

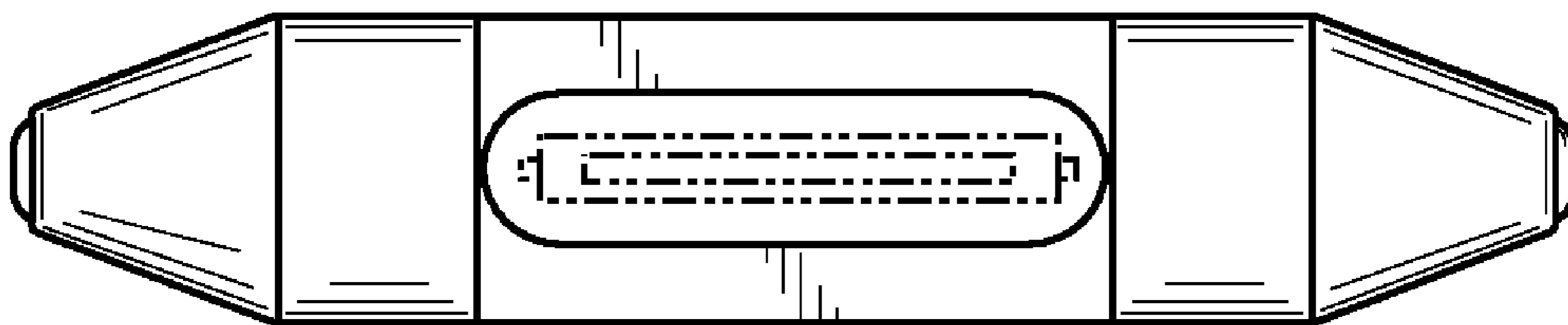
