(57) **CLAIM**

I claim the ornamental design for a correction tape, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of the correction tape showing my new design, the hash marks appearing in the drawings indicating transparent sections of the design;

FIG. 2 is a right side view thereof;

FIG. 3 is a bottom view thereof;

FIG. 4 is a left side view thereof;

FIG. 5 is a front view thereof;

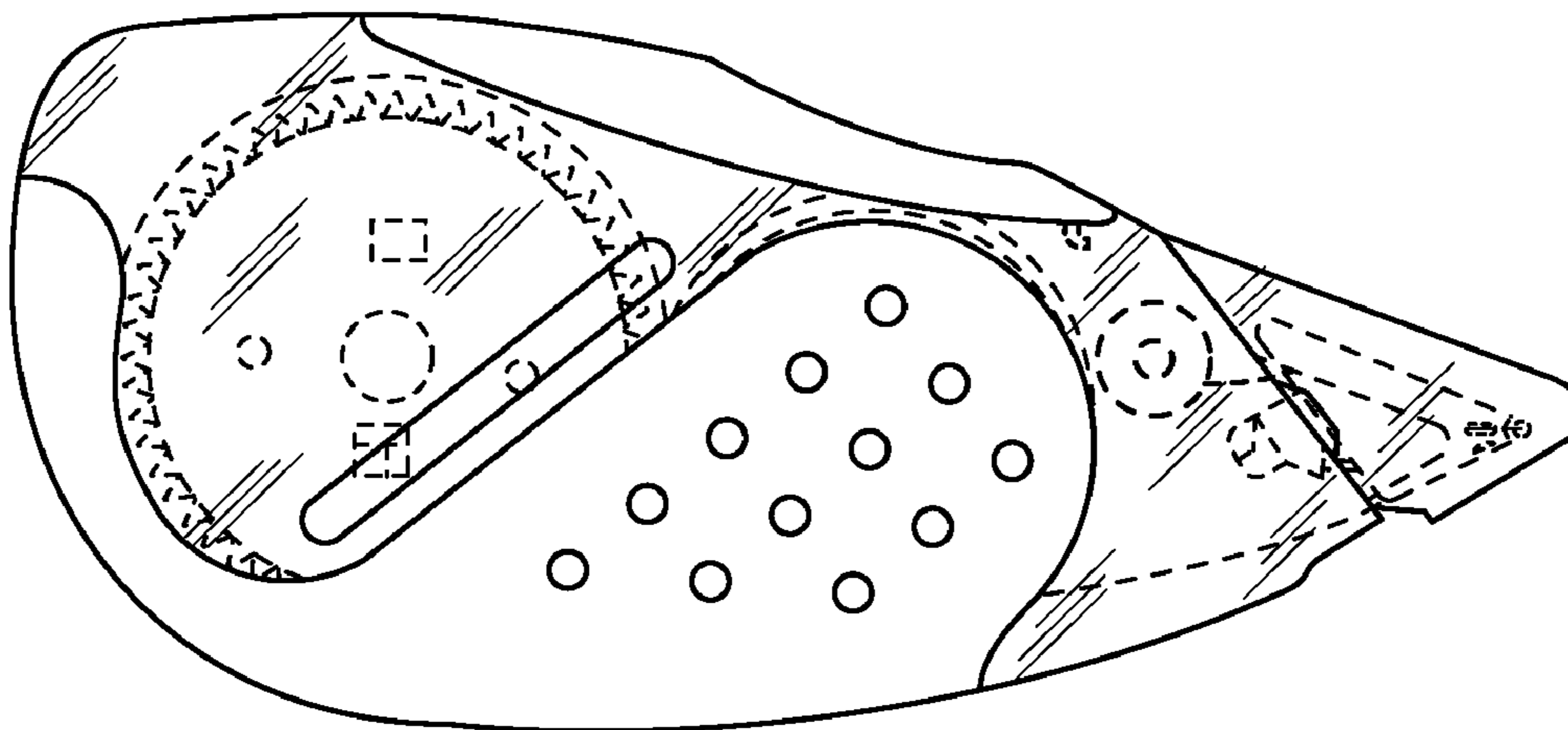
FIG. 6 is a rear view thereof;

FIG. 7 is a perspective view thereof; and,

FIG. 8 is a perspective view thereof with a cover for exposing the tape dispensing nozzle removed.

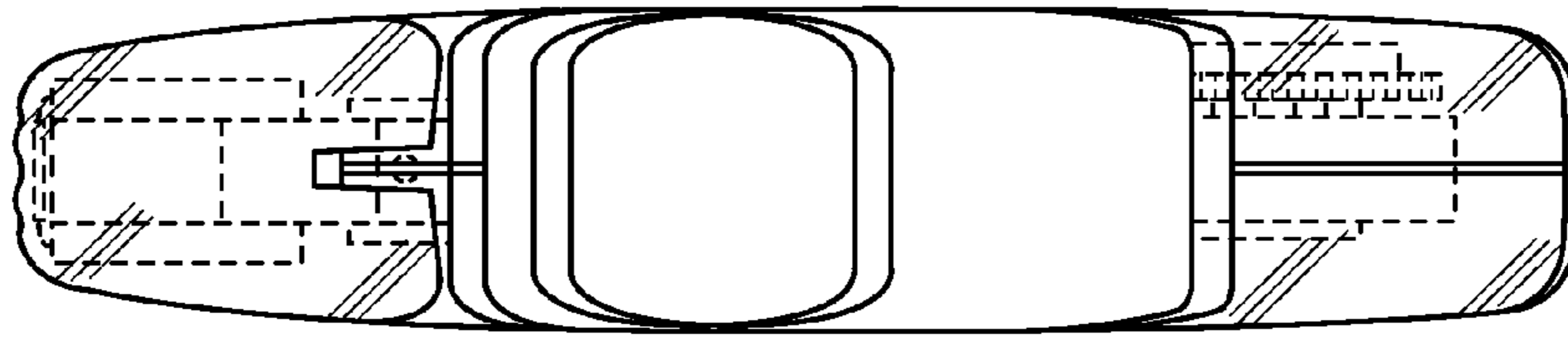

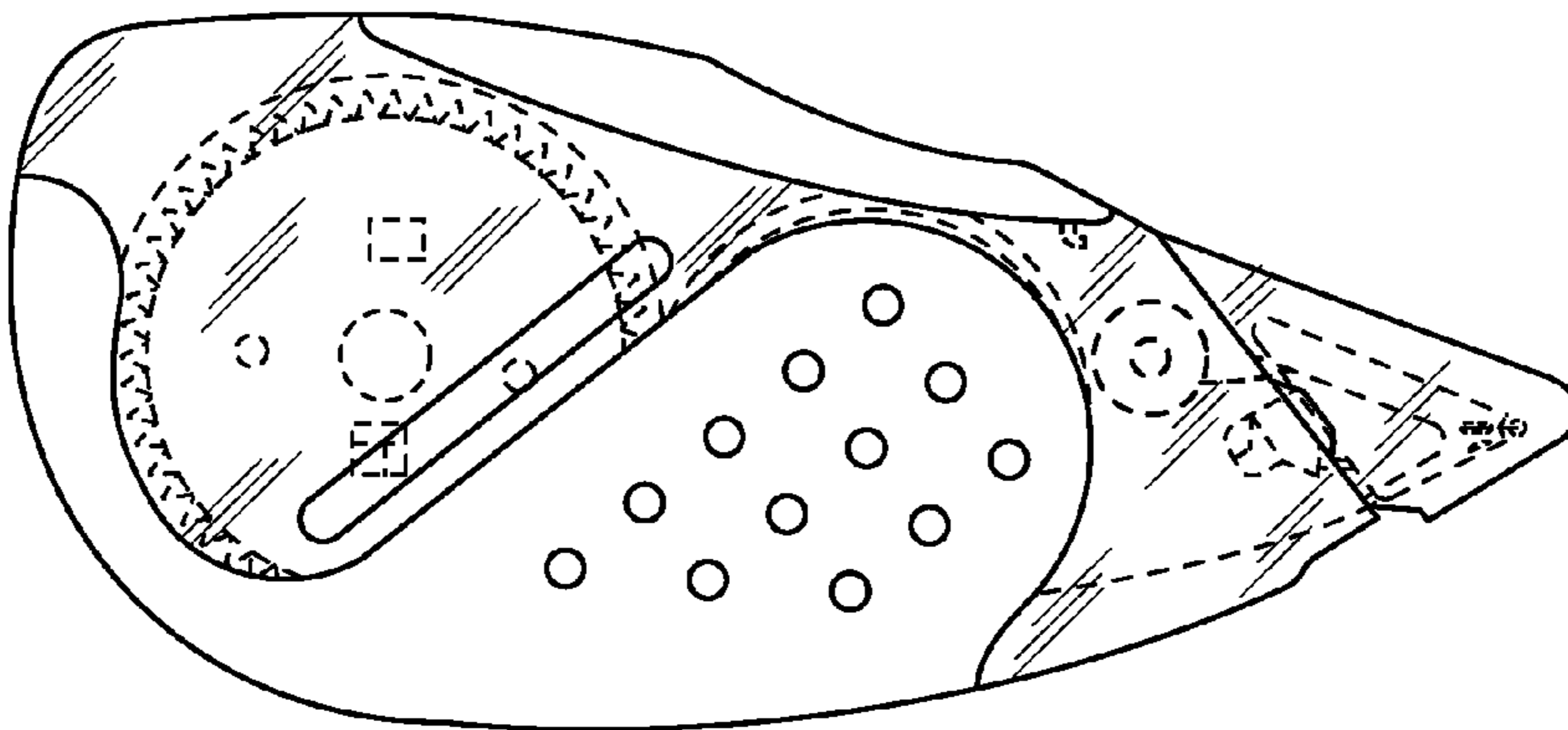

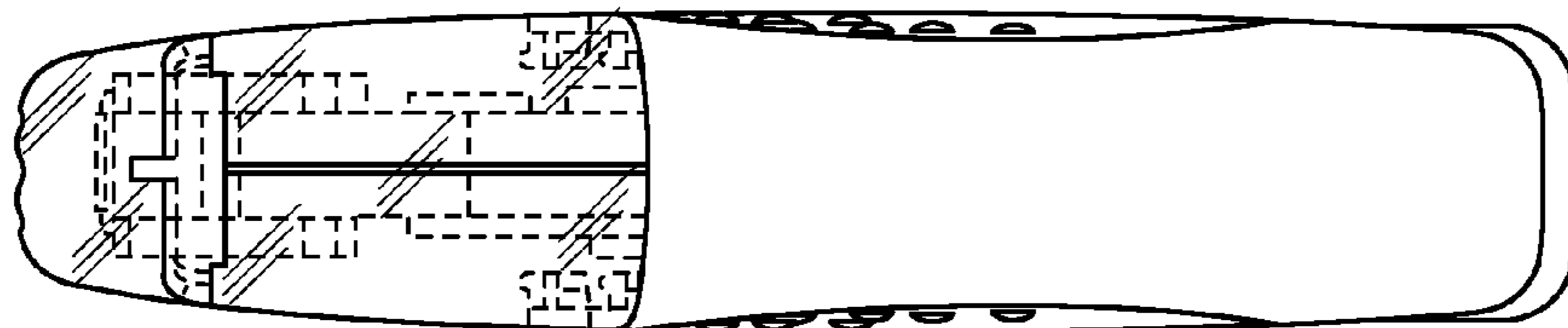

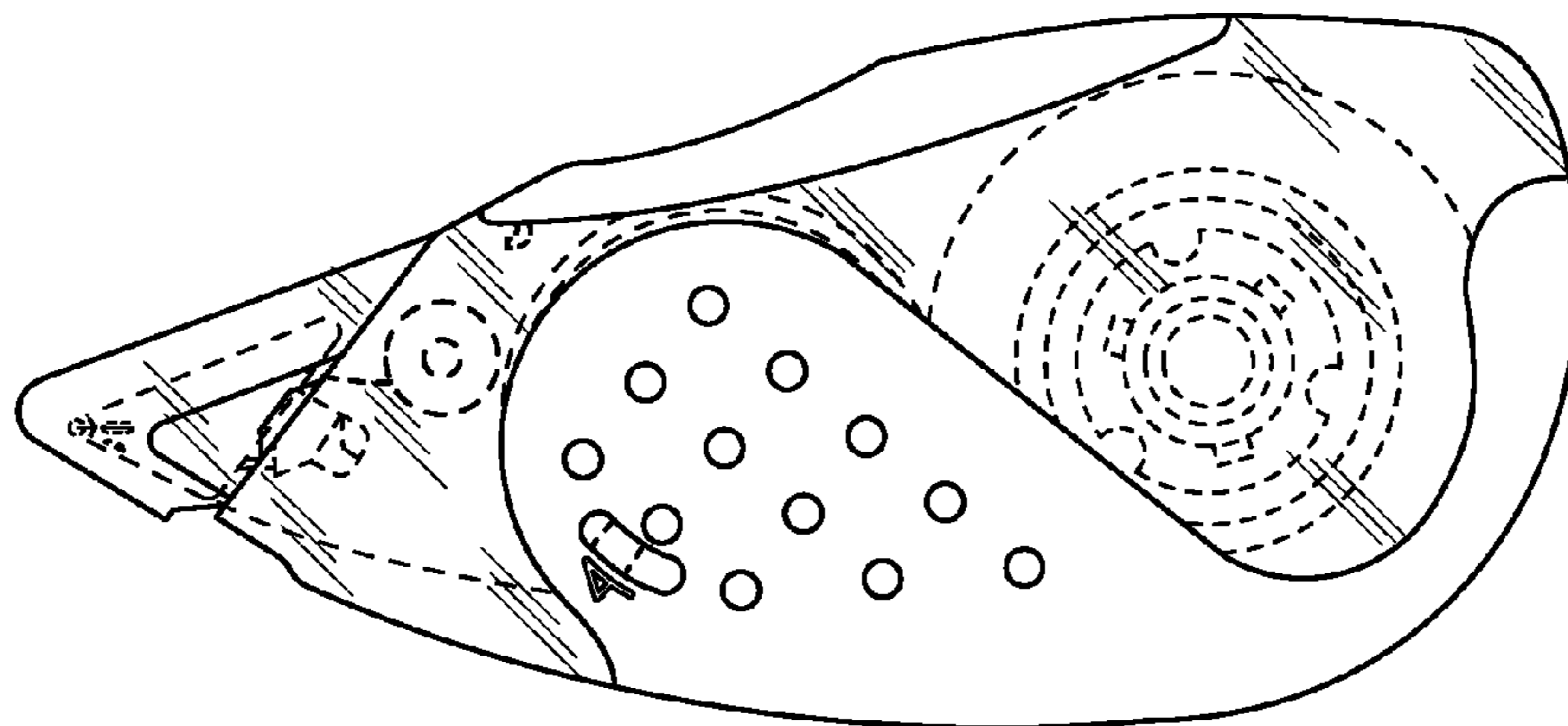

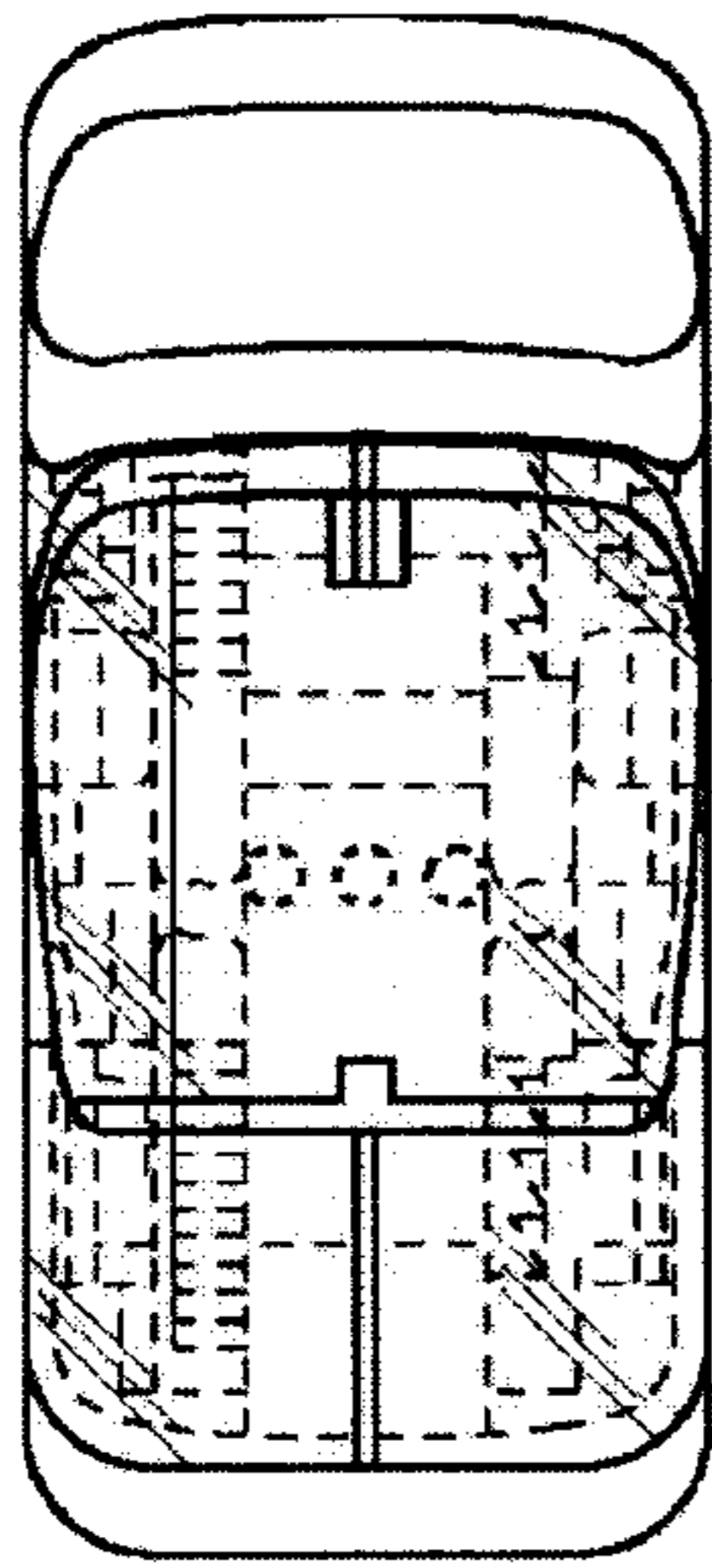

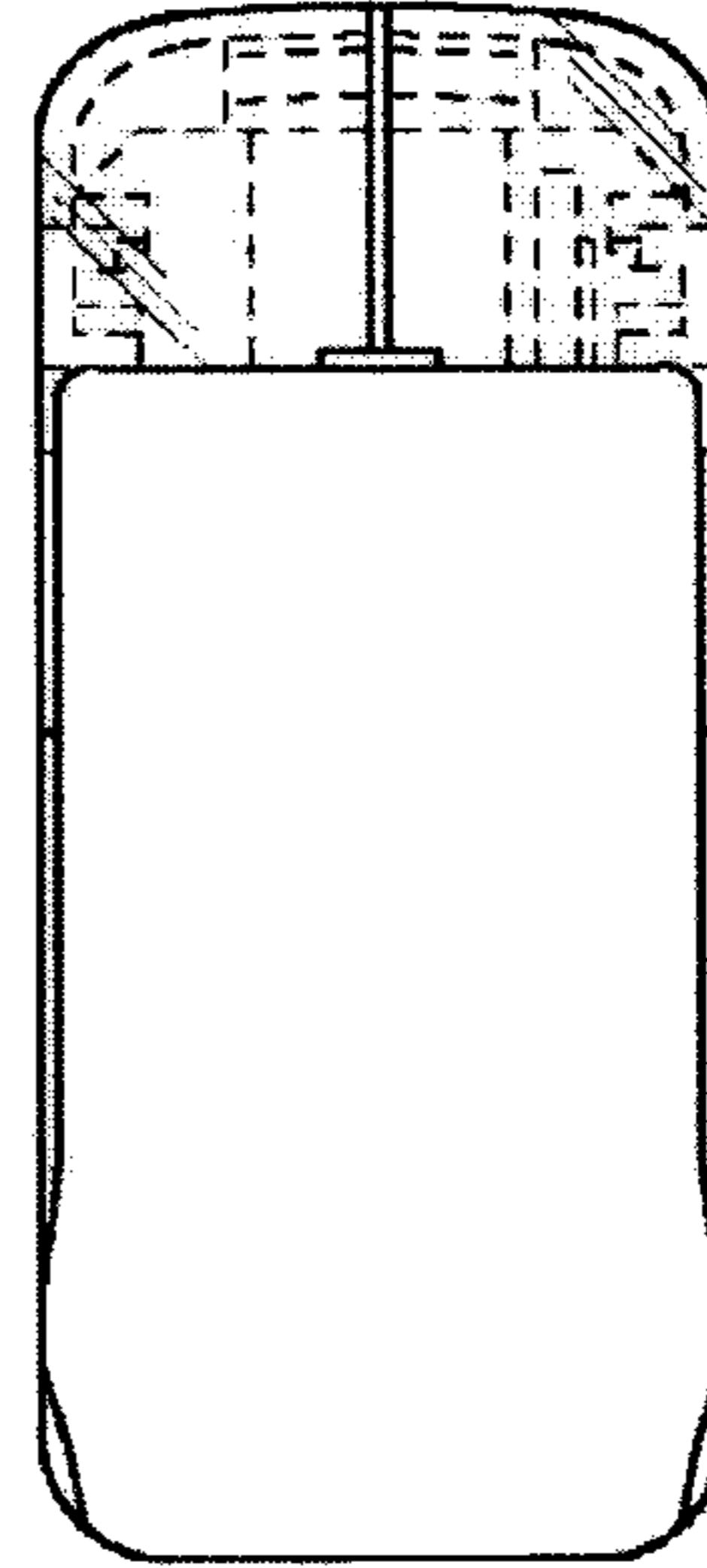

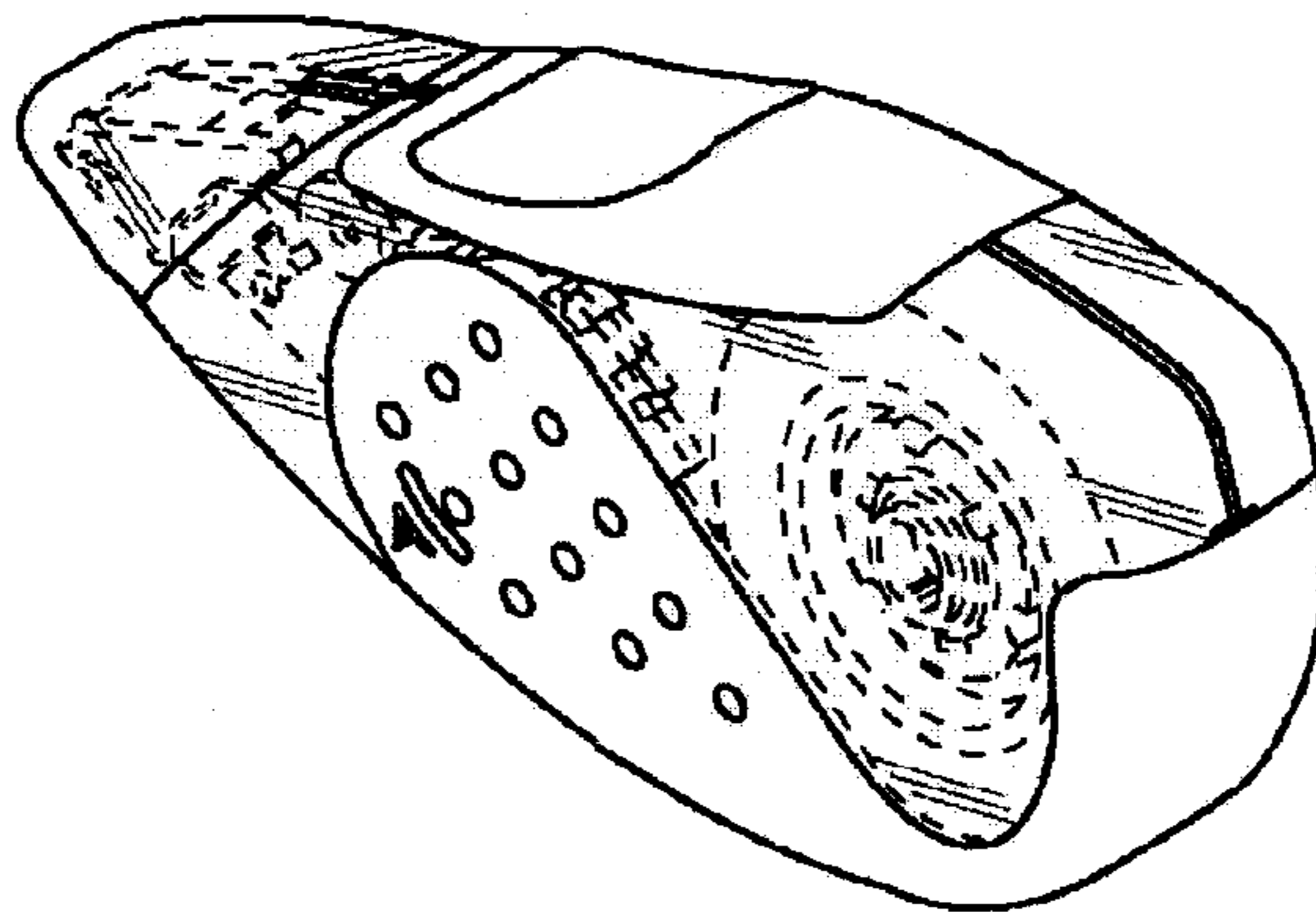

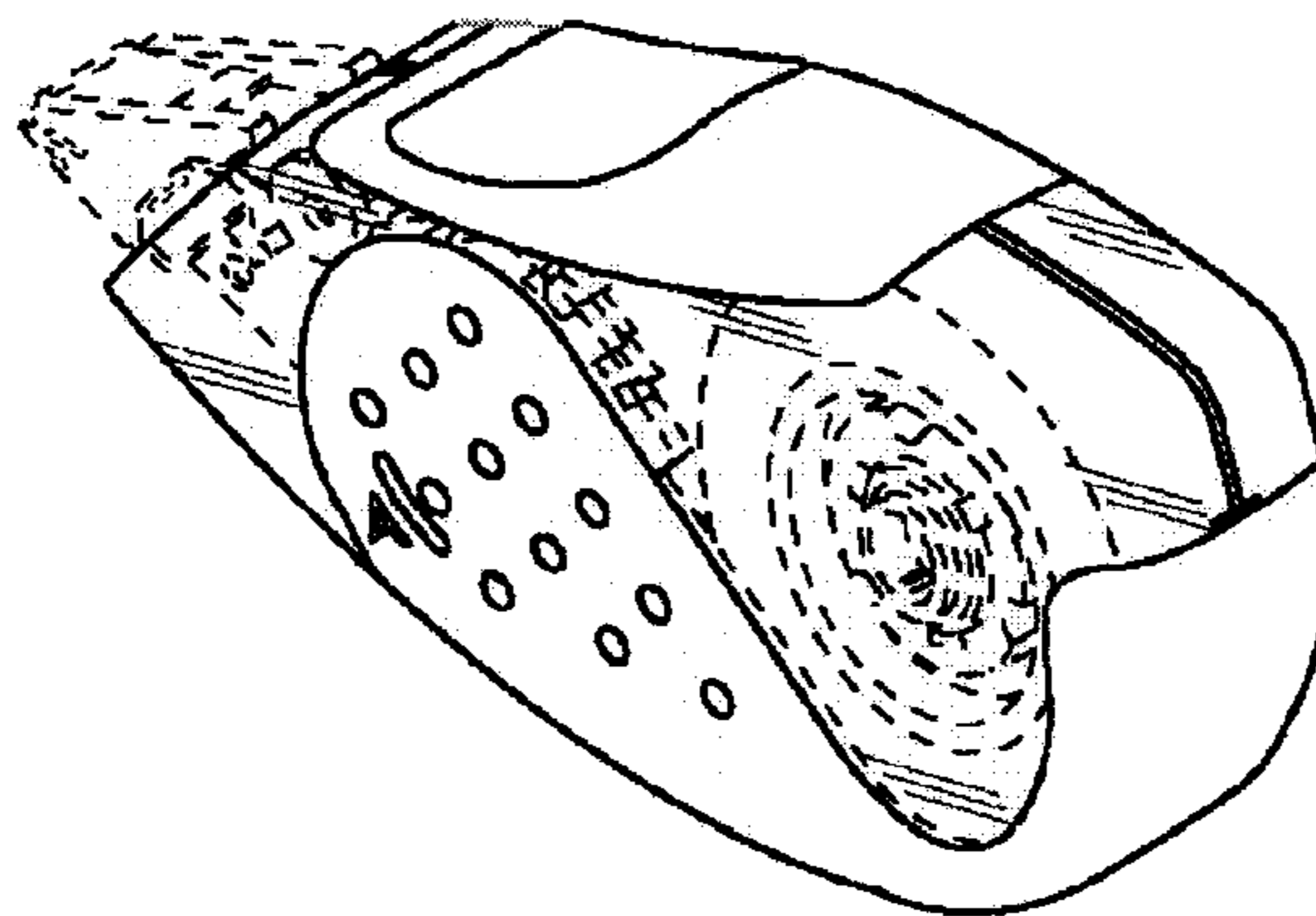
