(57) **CLAIM**

The ornamental design for a golf tee remover/divot fixer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a golf tee remover/divot fixer showing my new design;

FIG. 8 is a front elevational view thereof;

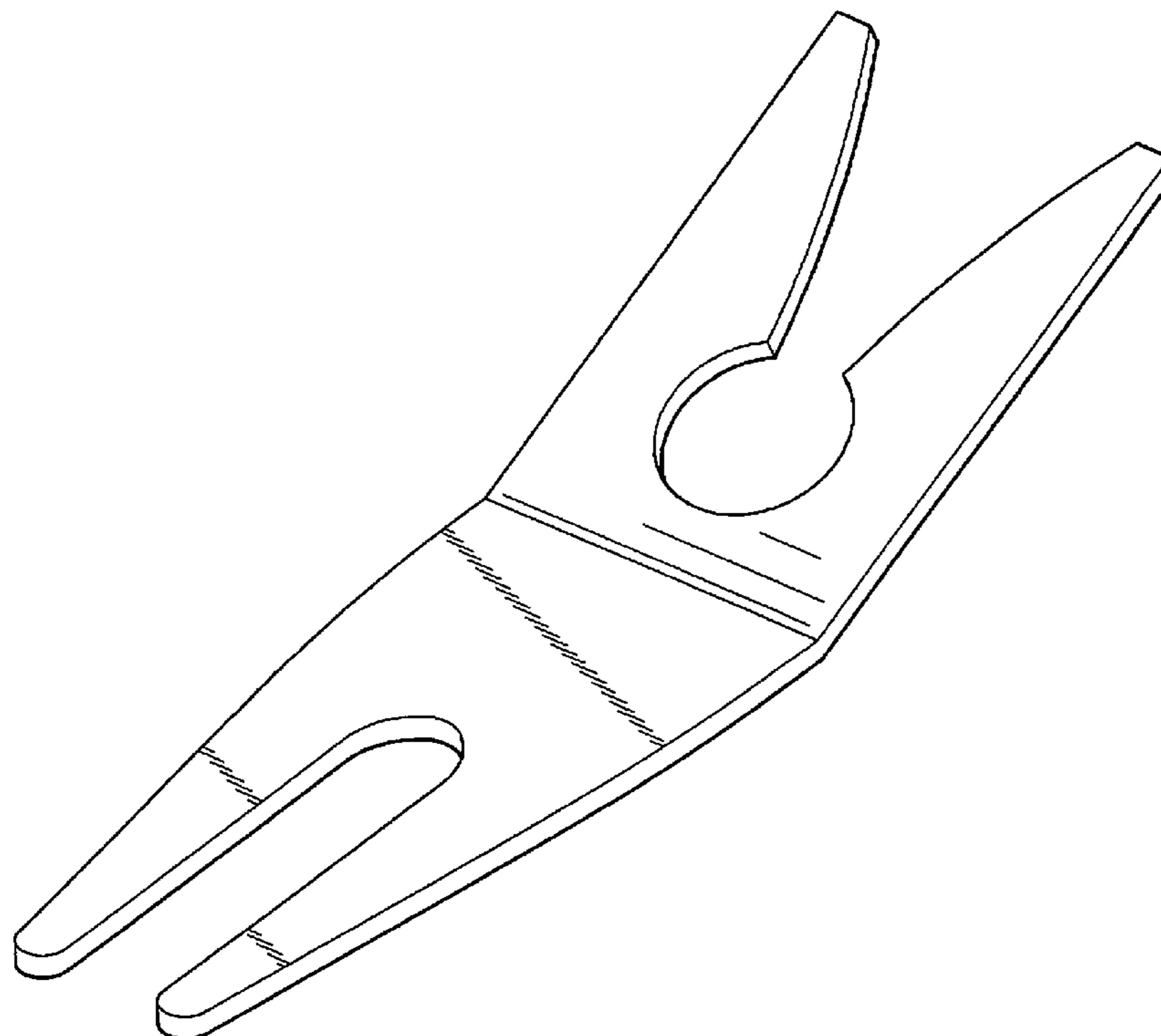
FIG. 9 is a rear elevational view thereof;

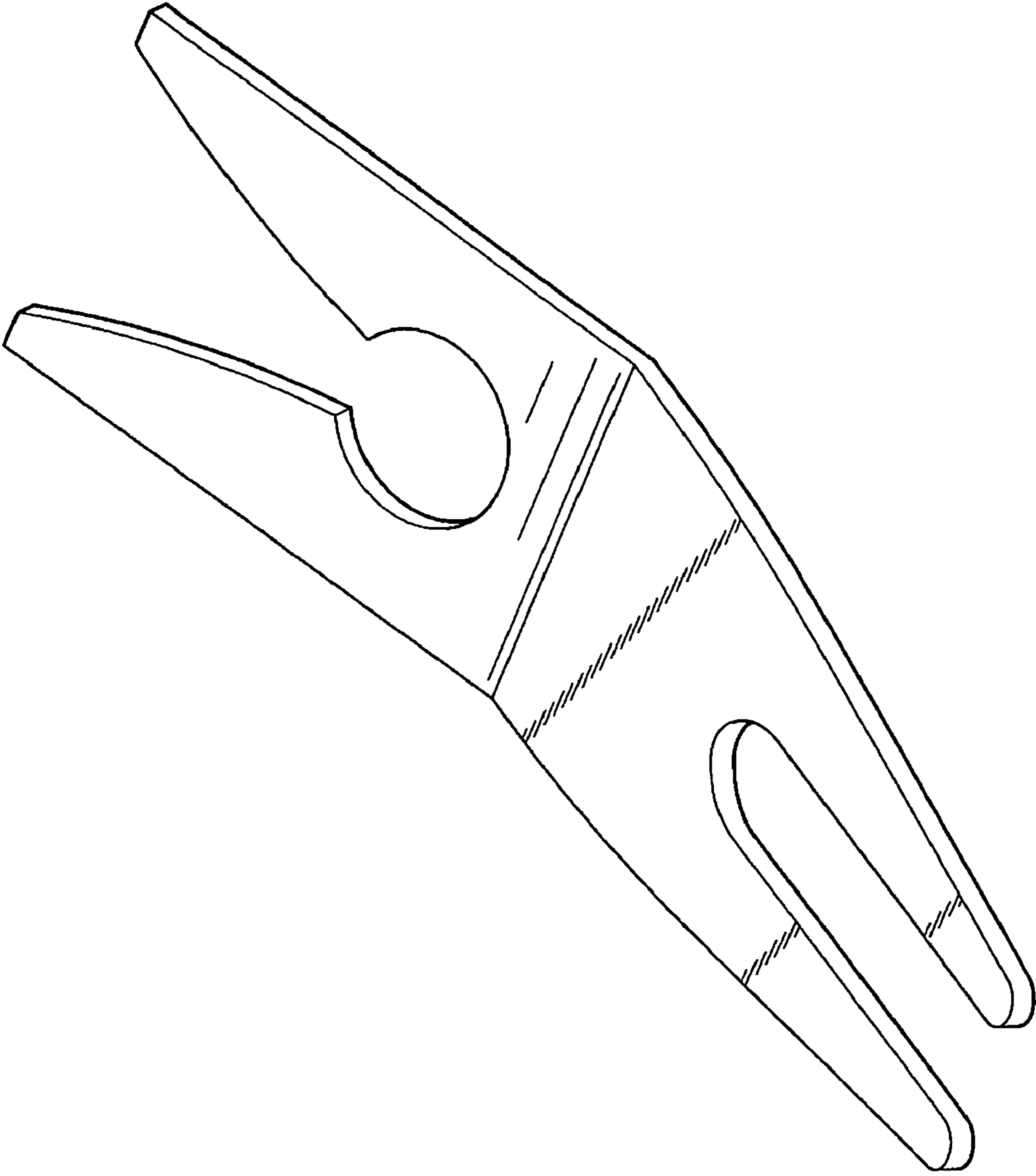

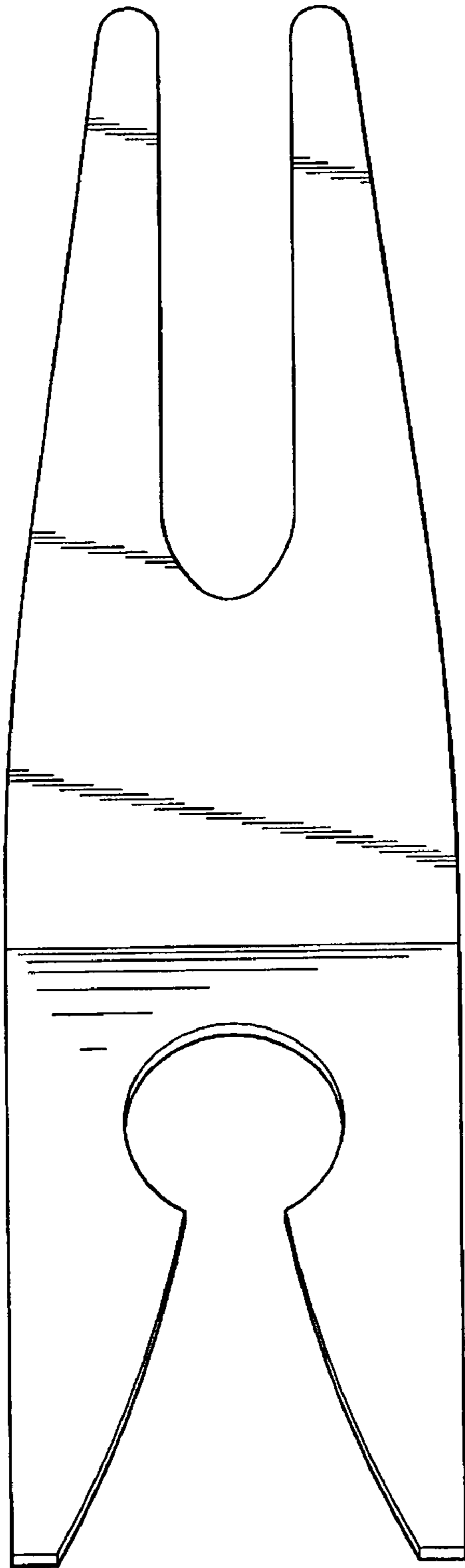

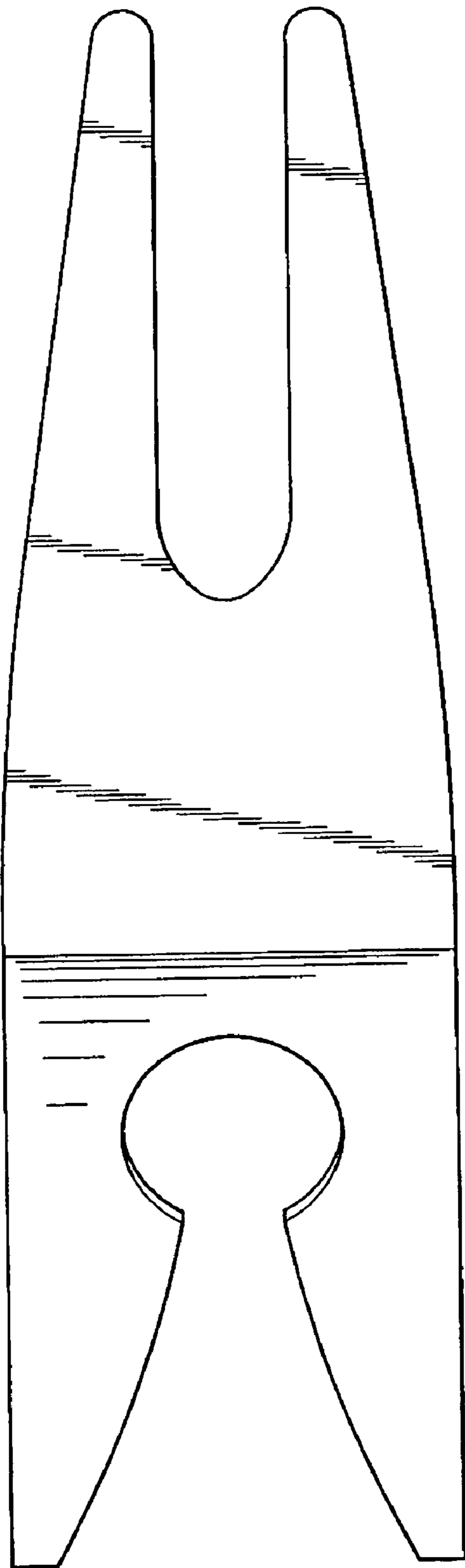

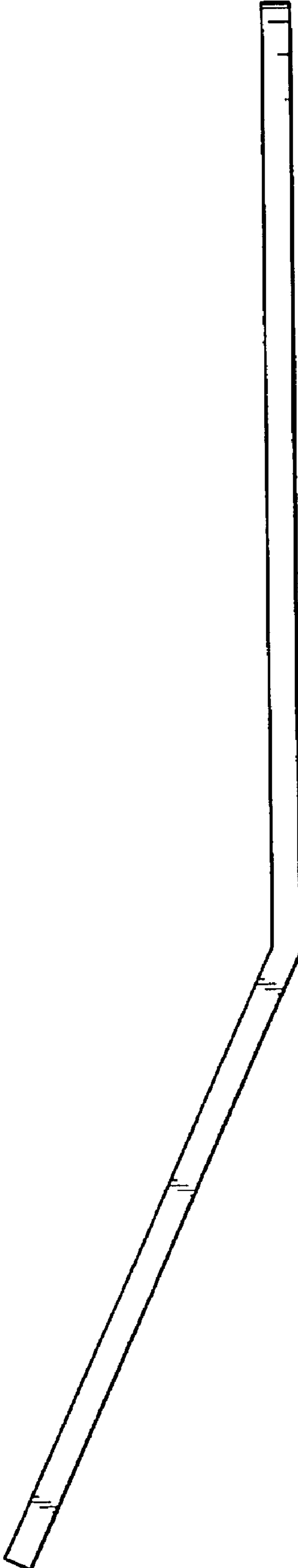

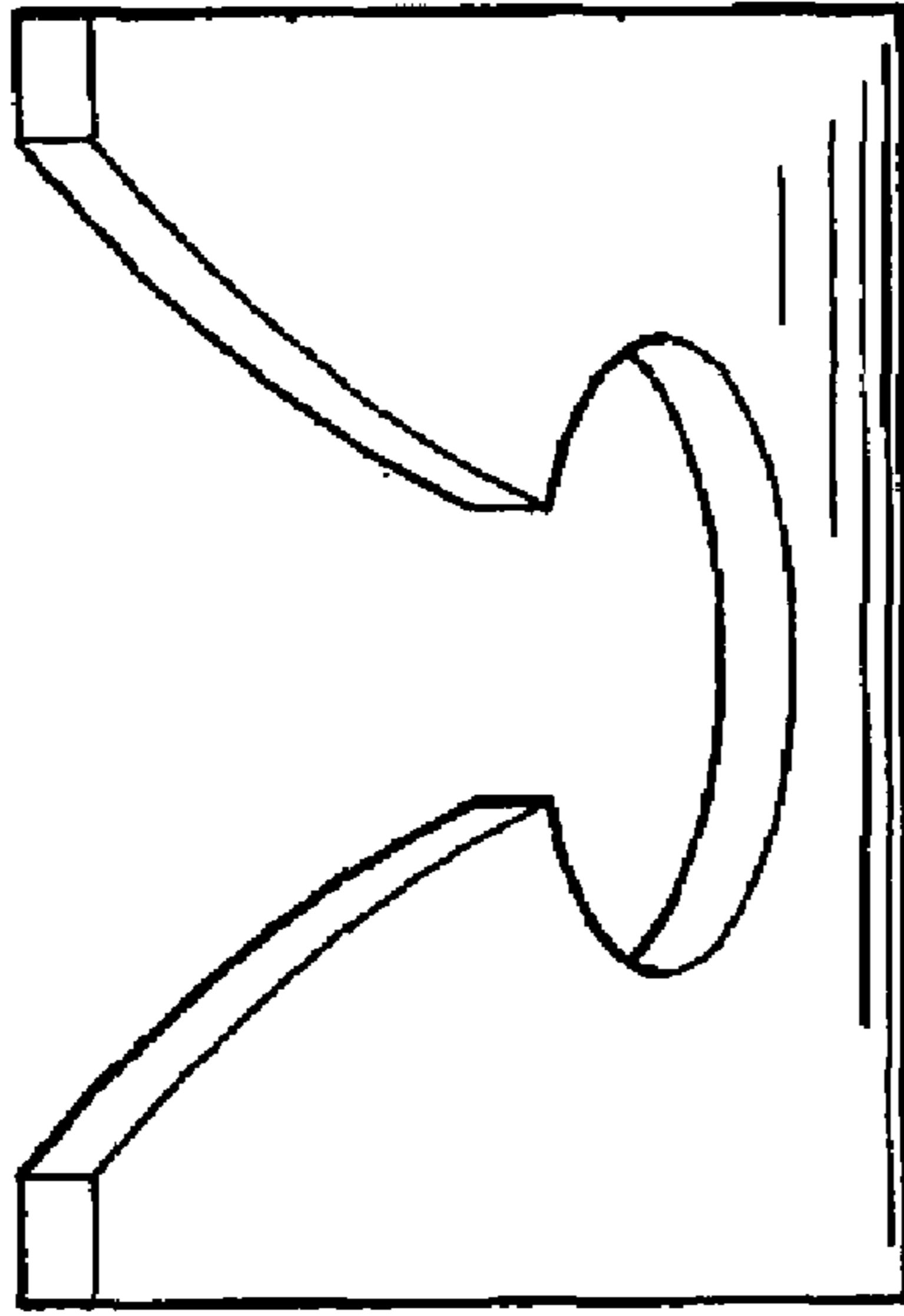

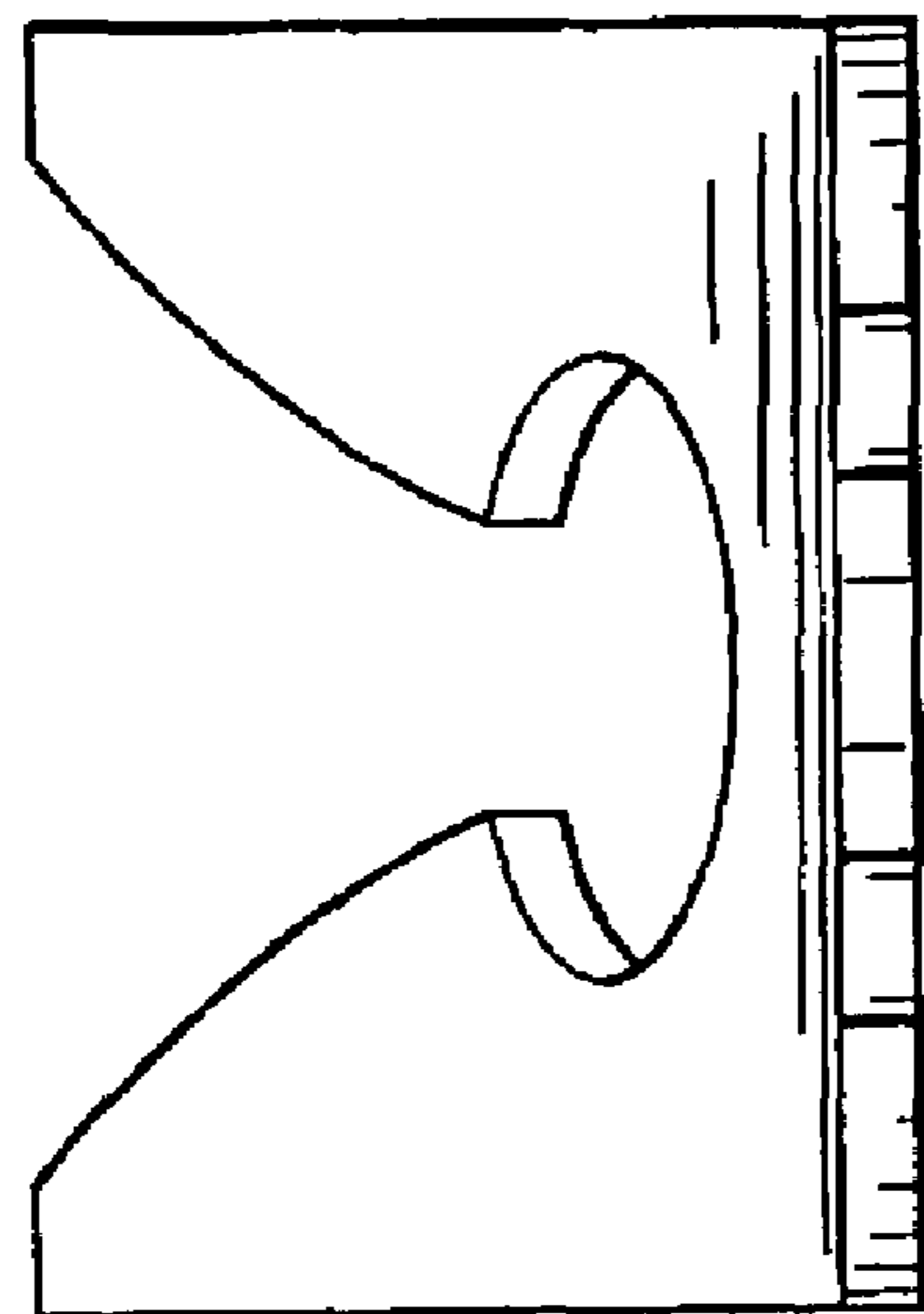

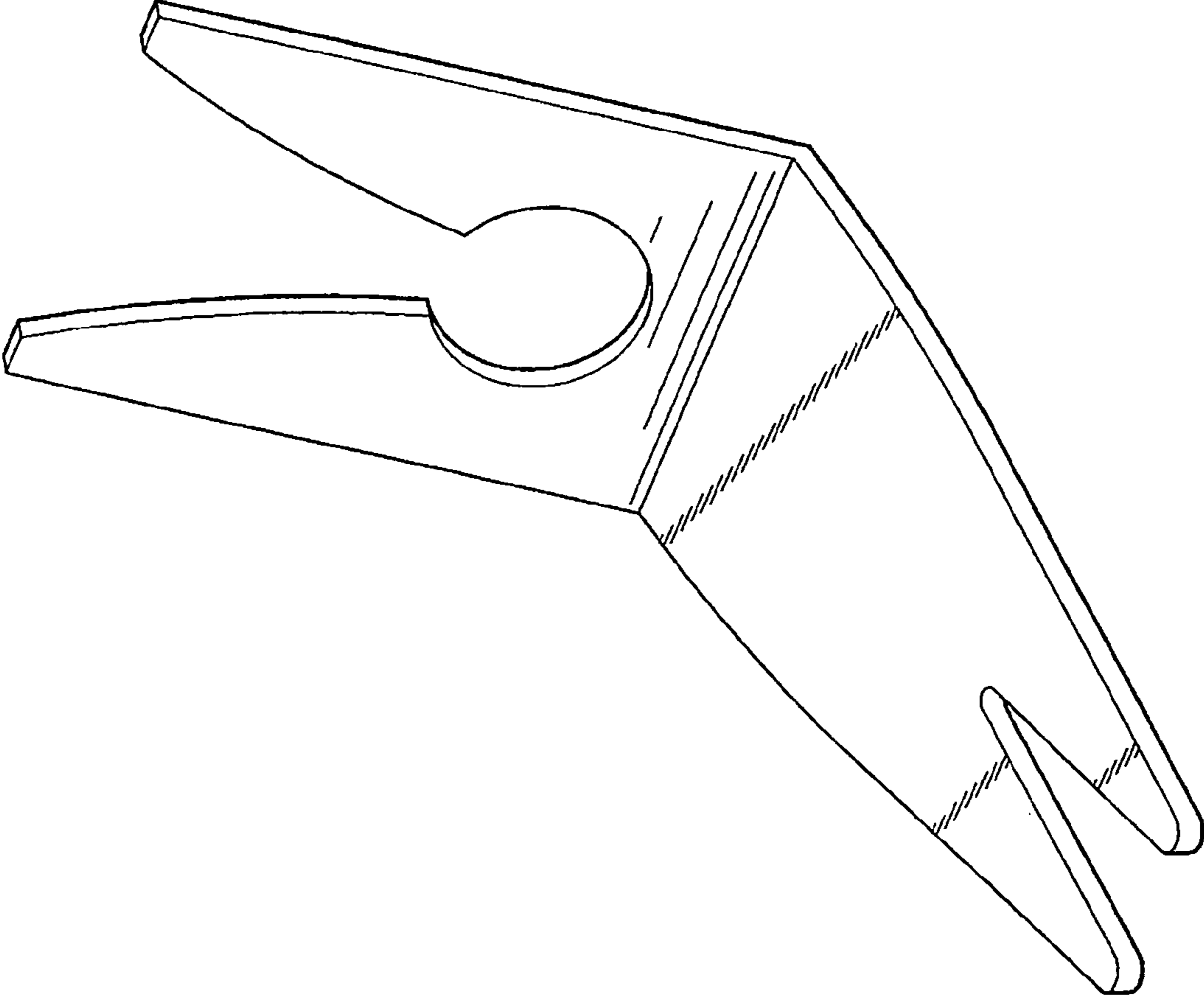

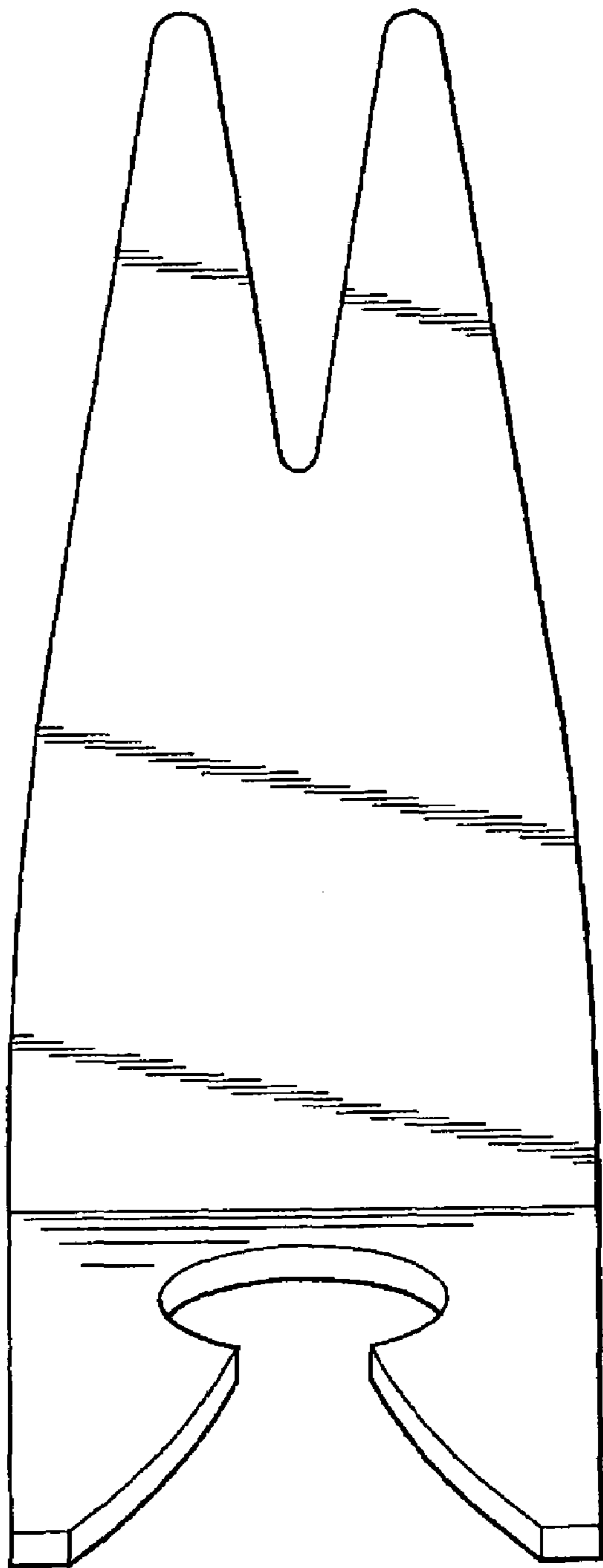

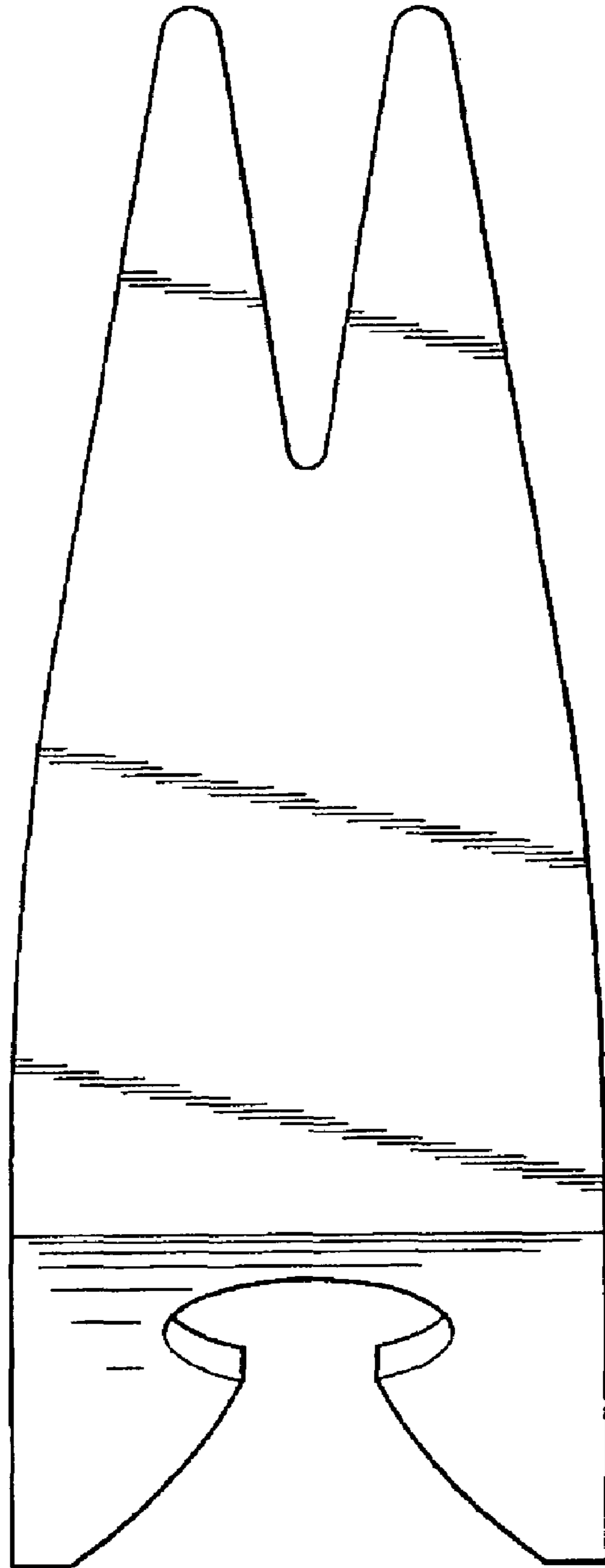

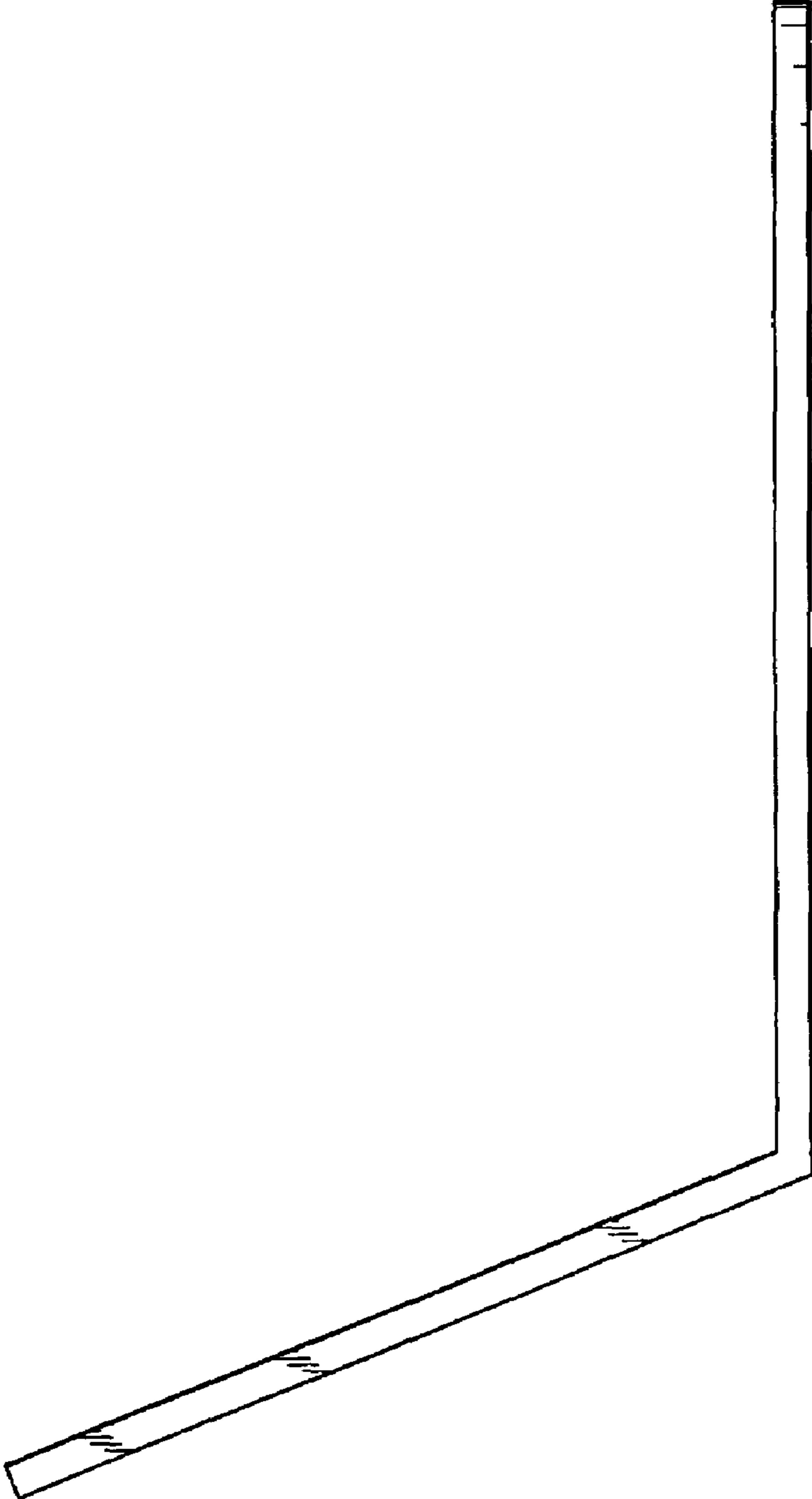

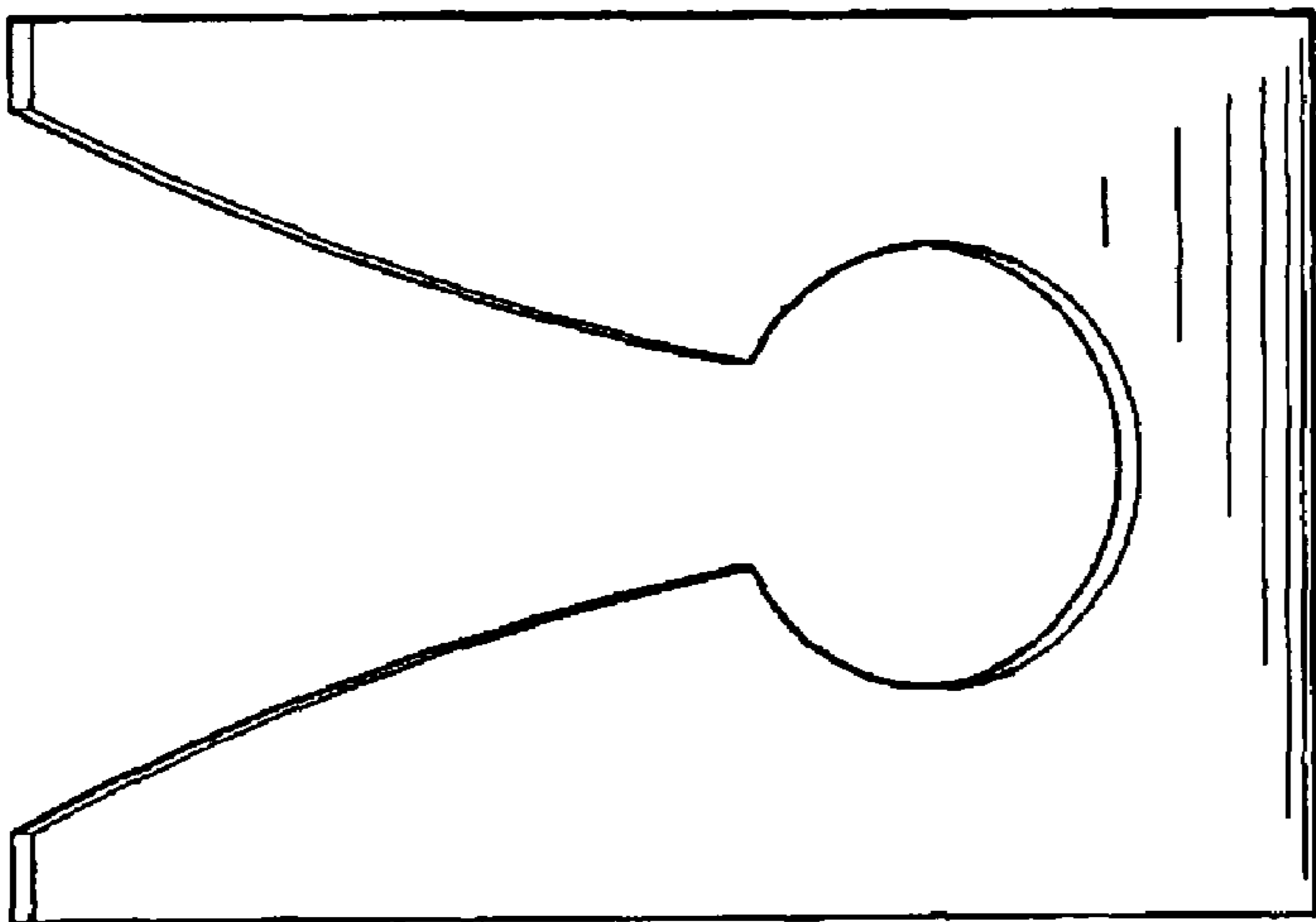

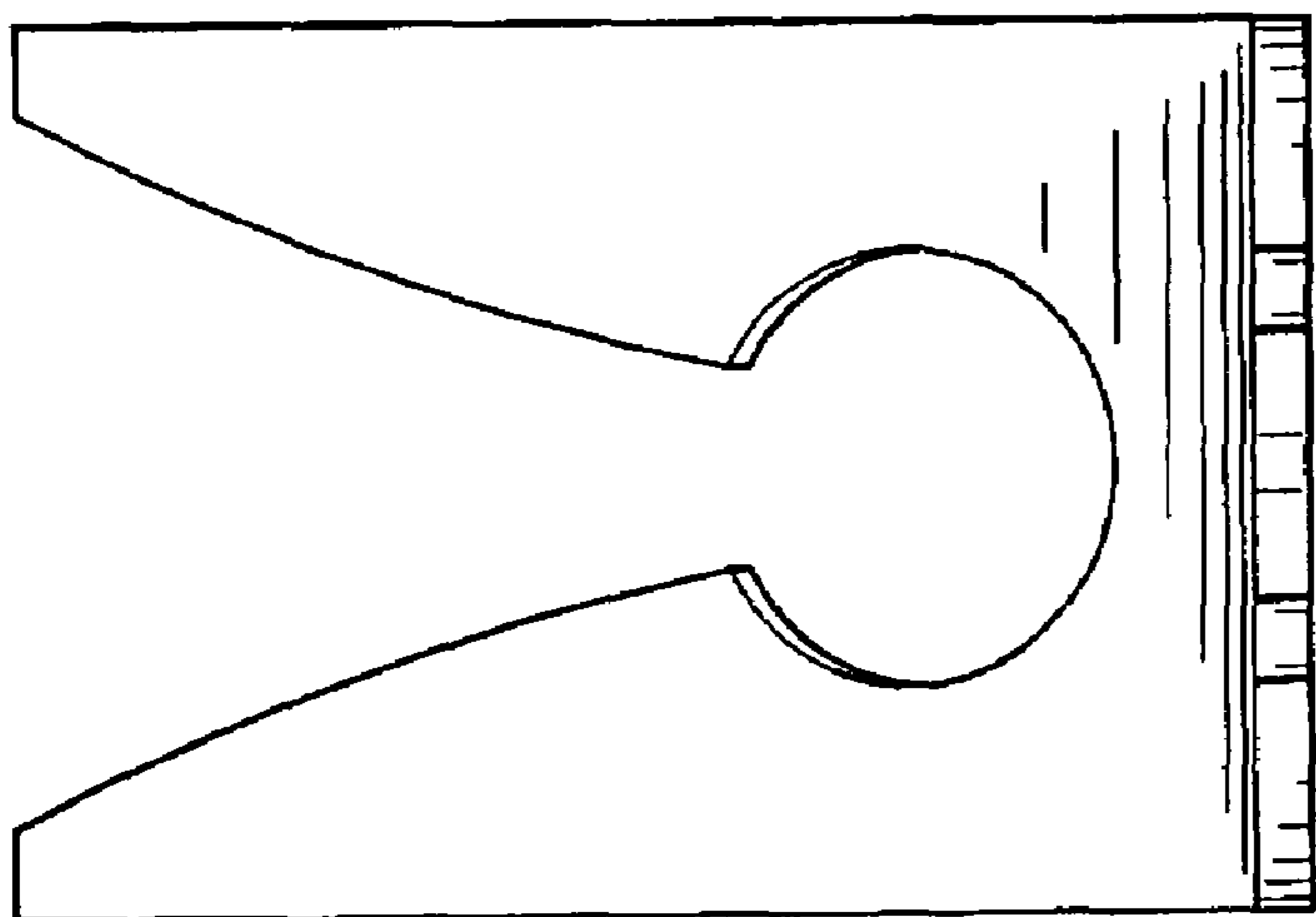
