FIG. 3 is a bottom view of the breast pad of FIG. 1.

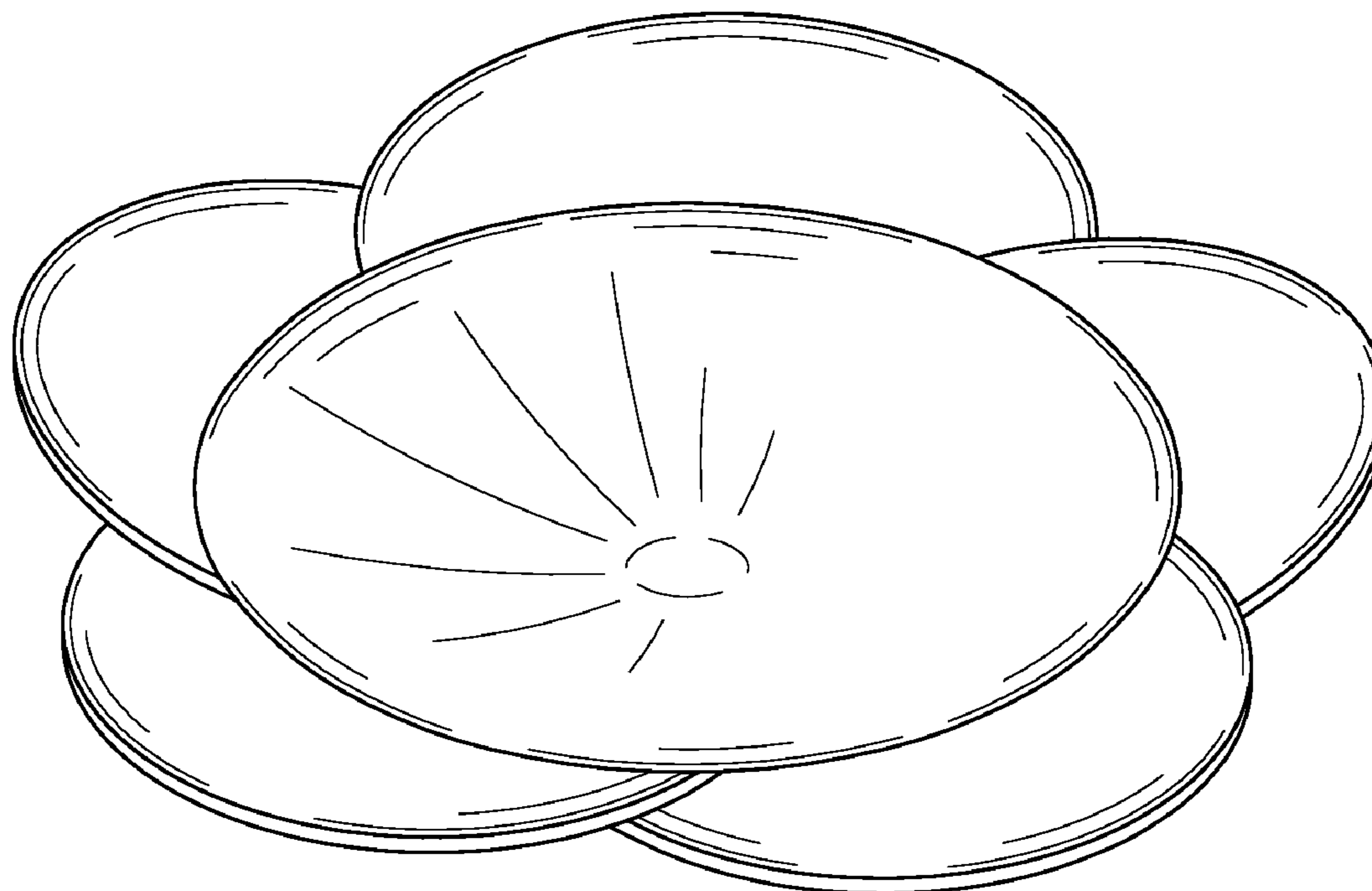
FIG. 4 is a front view of the breast pad of FIG. 1.

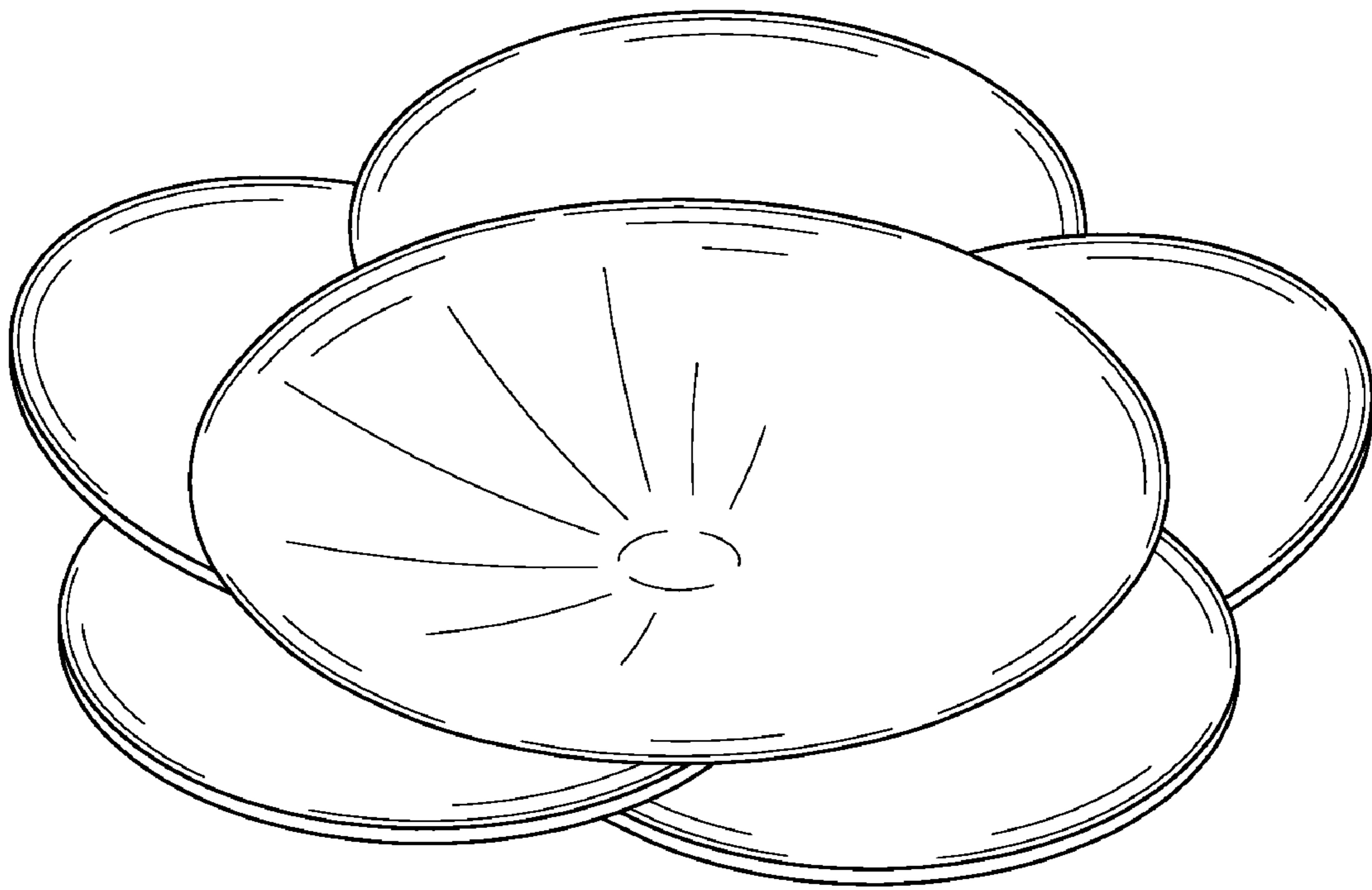

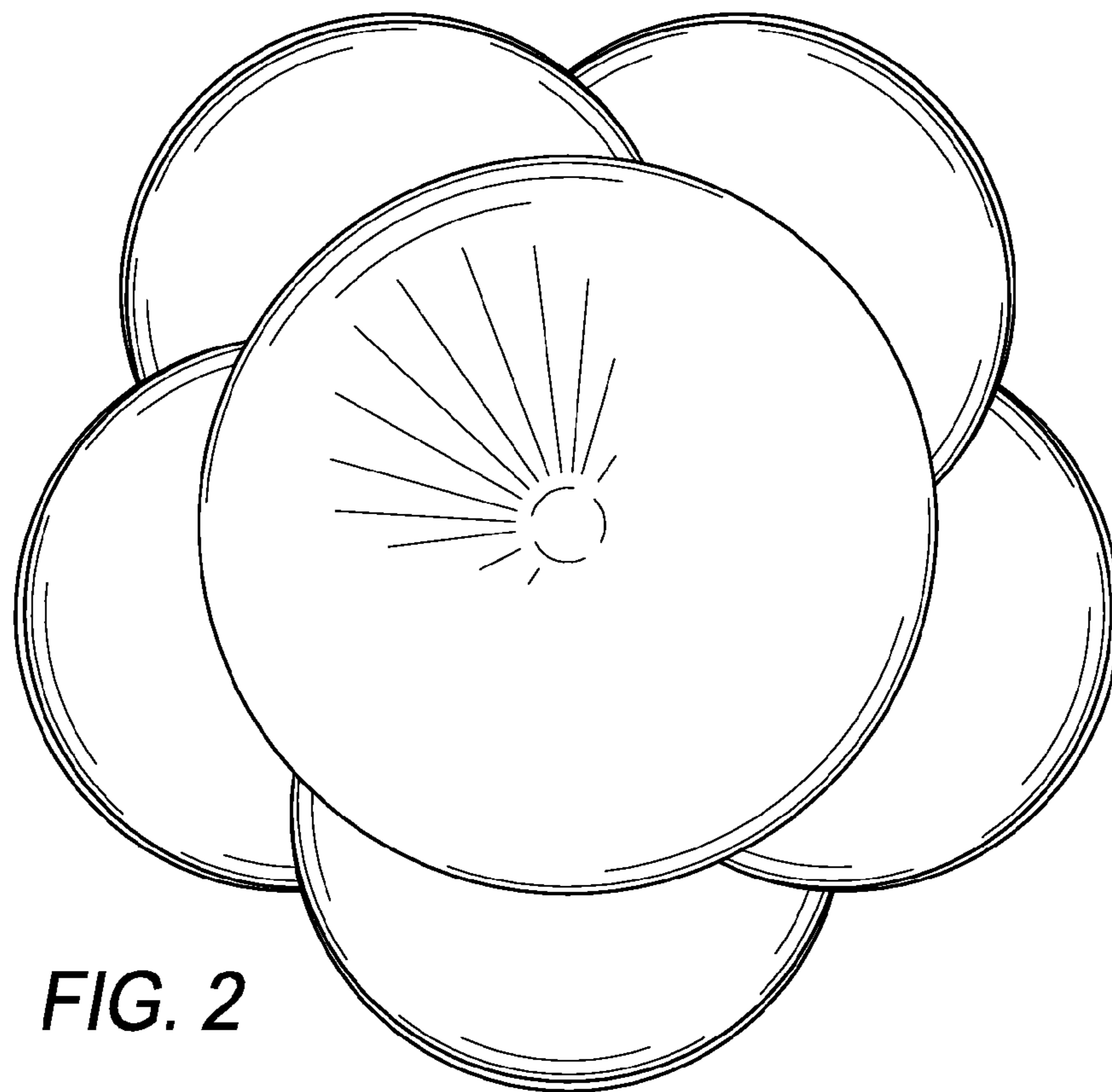

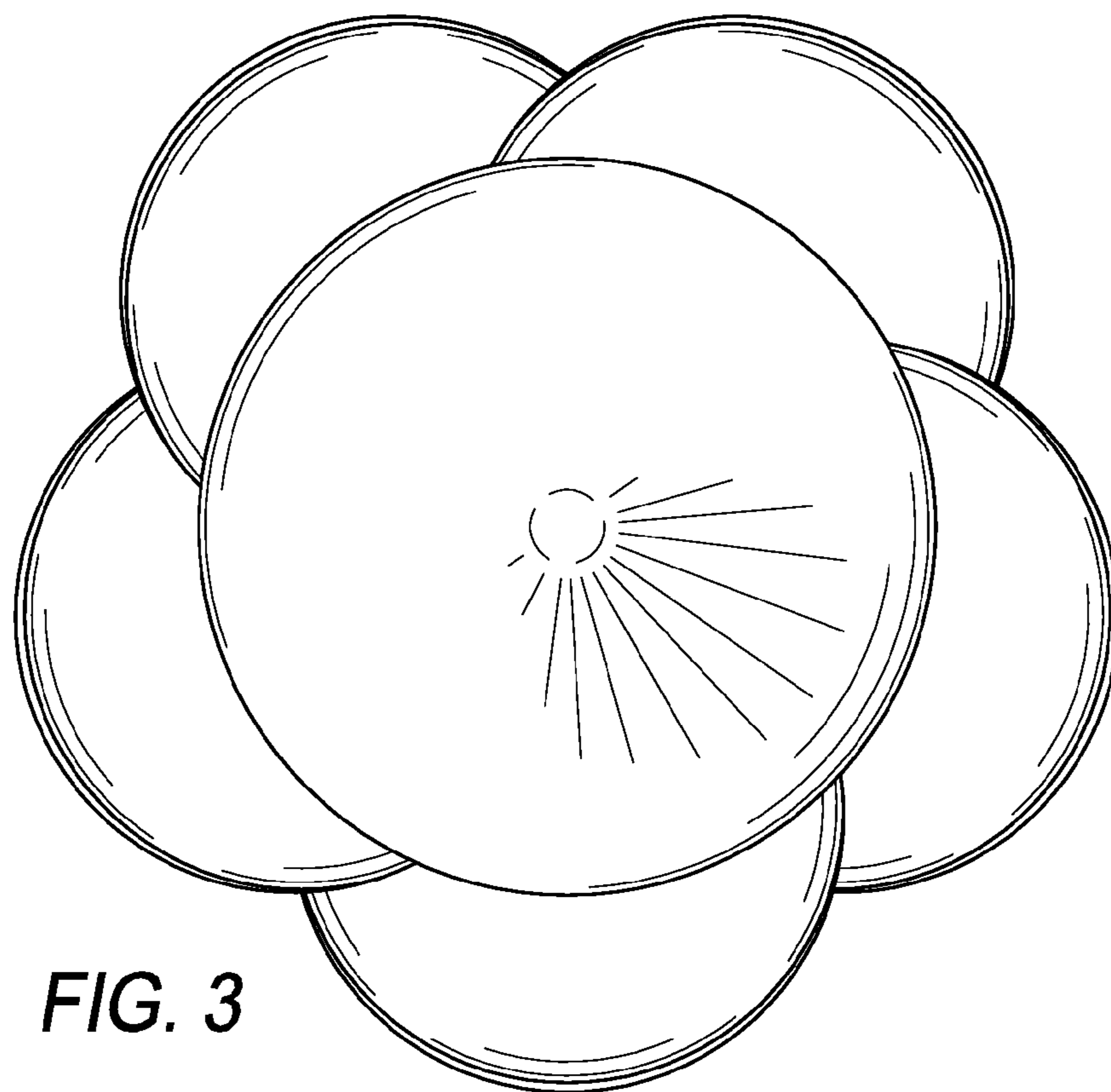

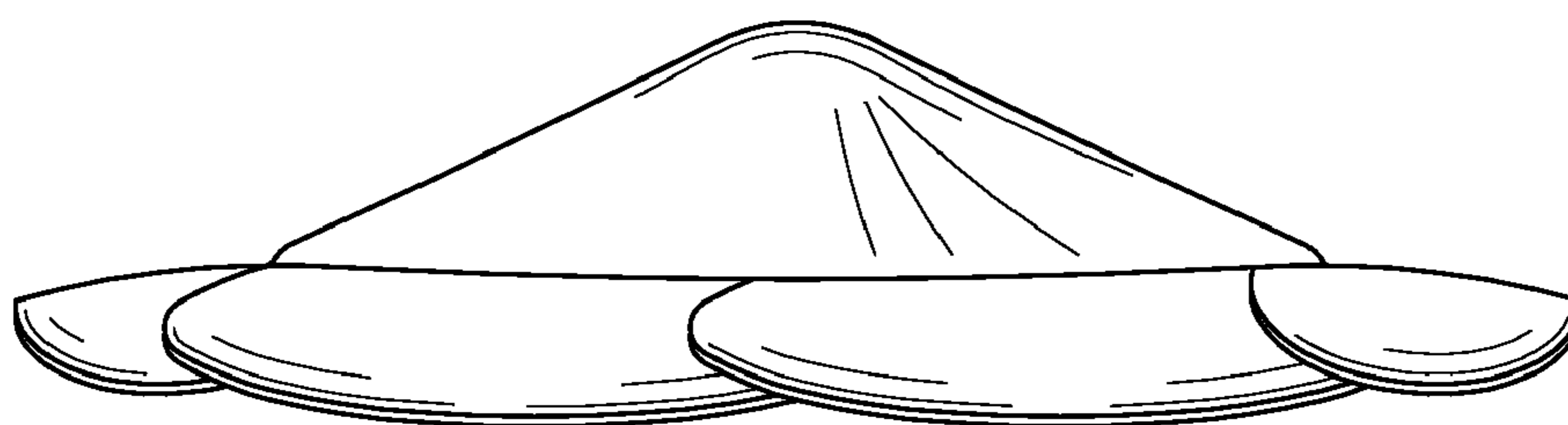

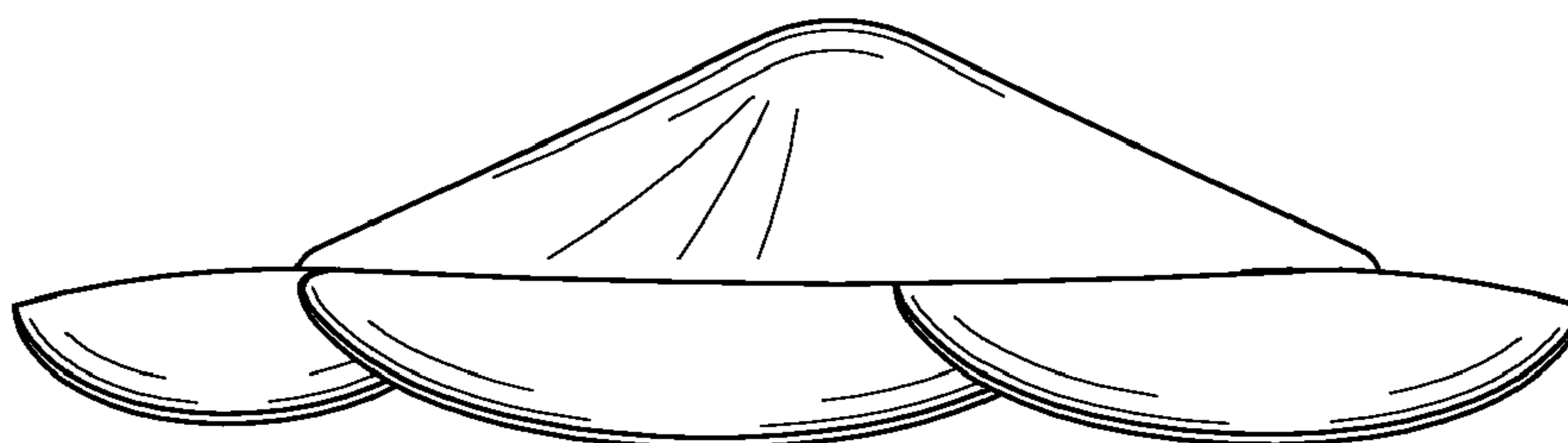

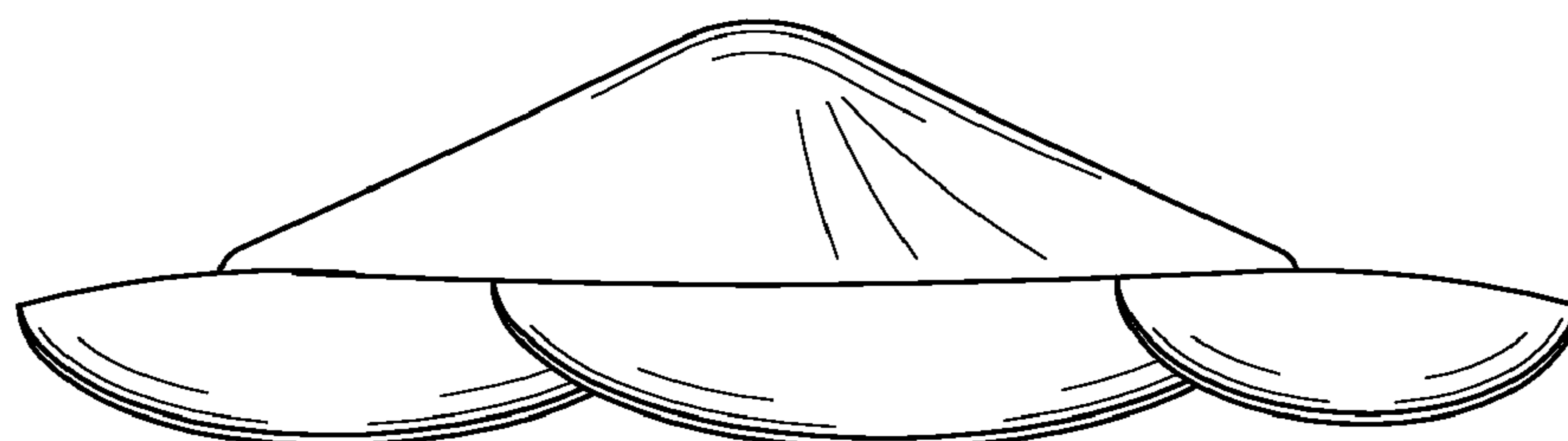

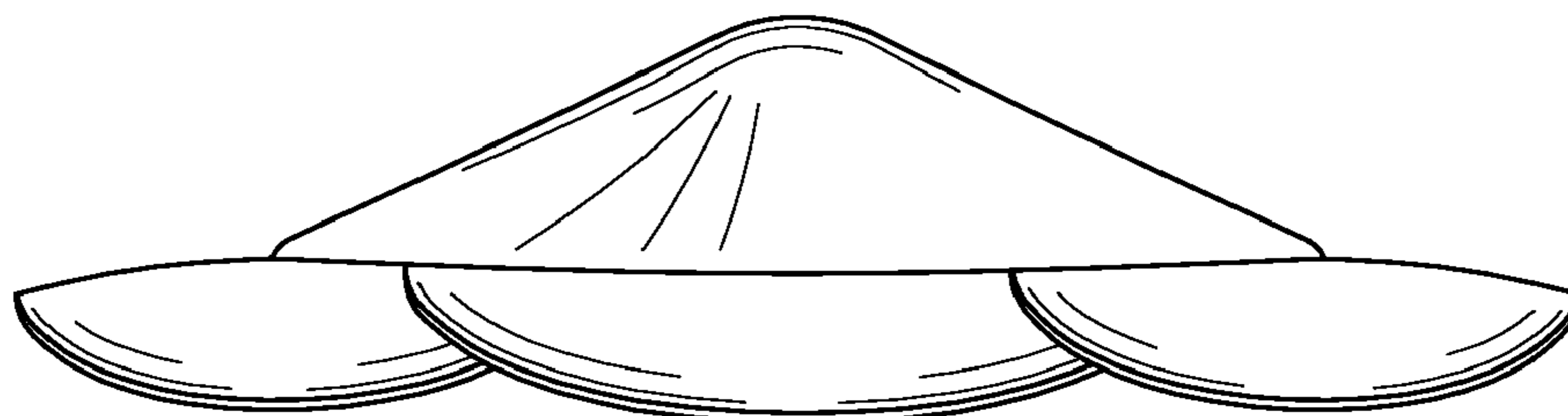
