I claim the ornamental design for a head protector, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a head protector showing my new design;

FIG. 2 is a front and right side perspective view thereof;

FIG. 3 is a top view thereof;

FIG. 4 is a rear view thereof;

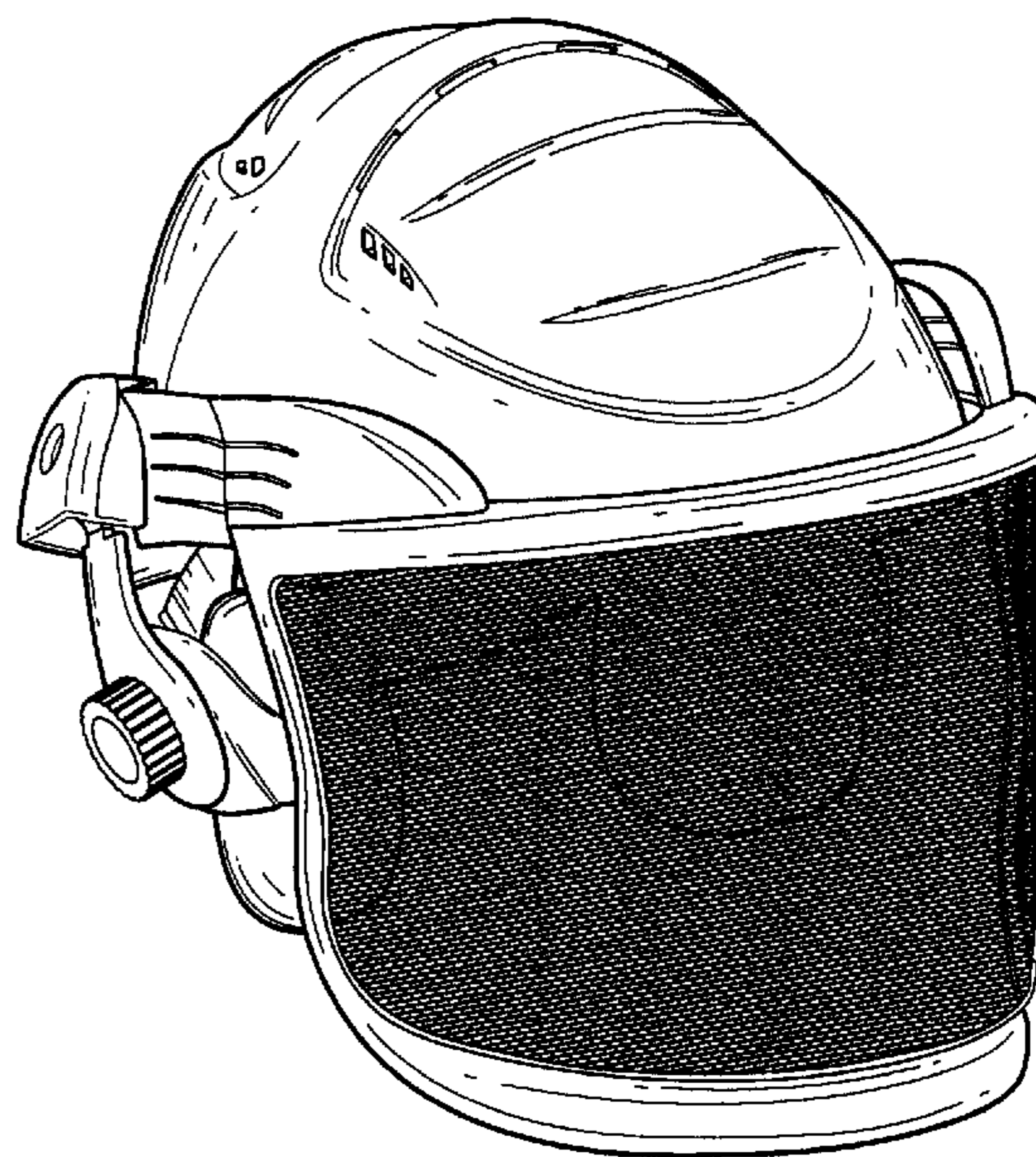
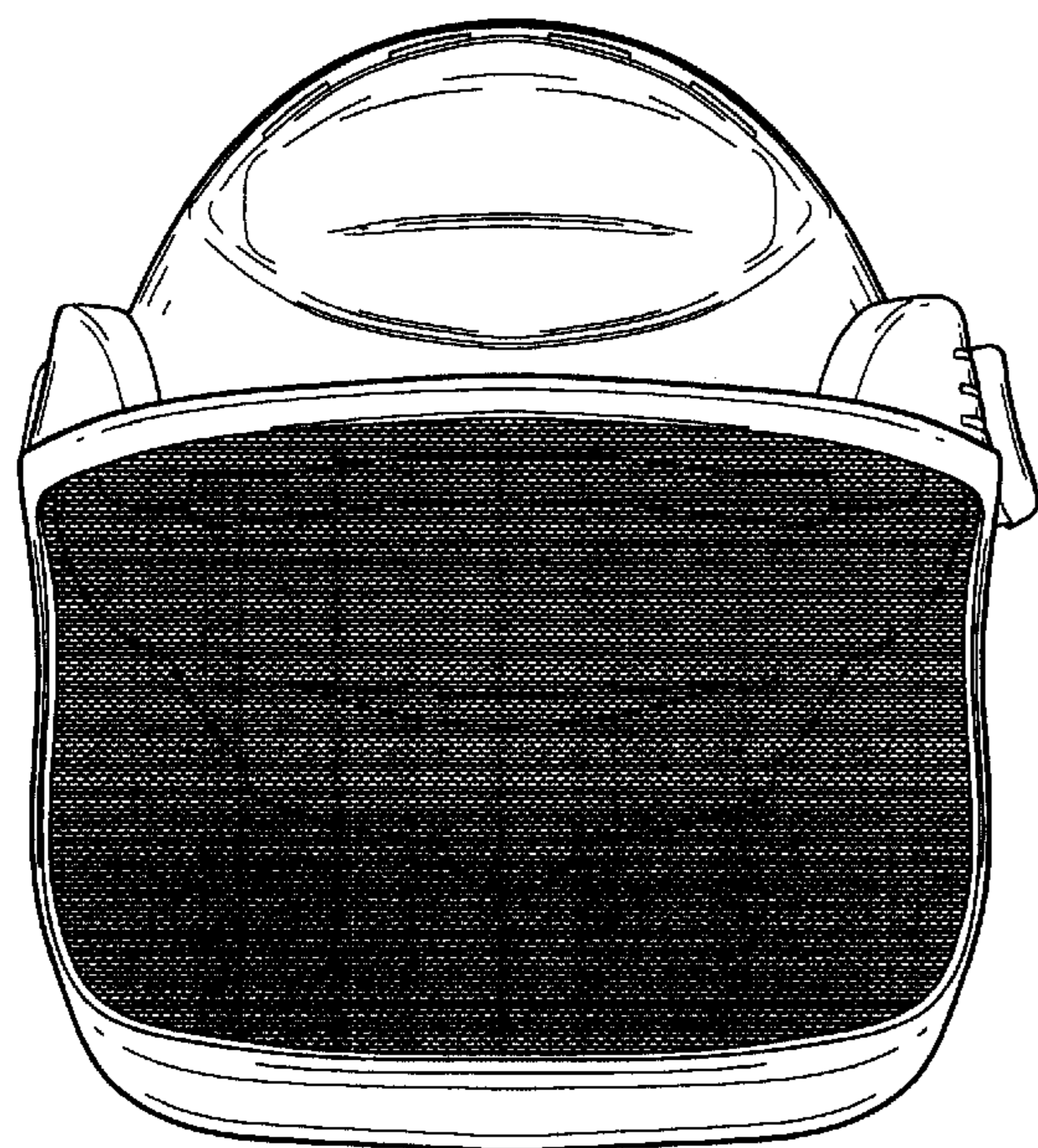
FIG. 5 is a right side view thereof, with the ear protection raised;

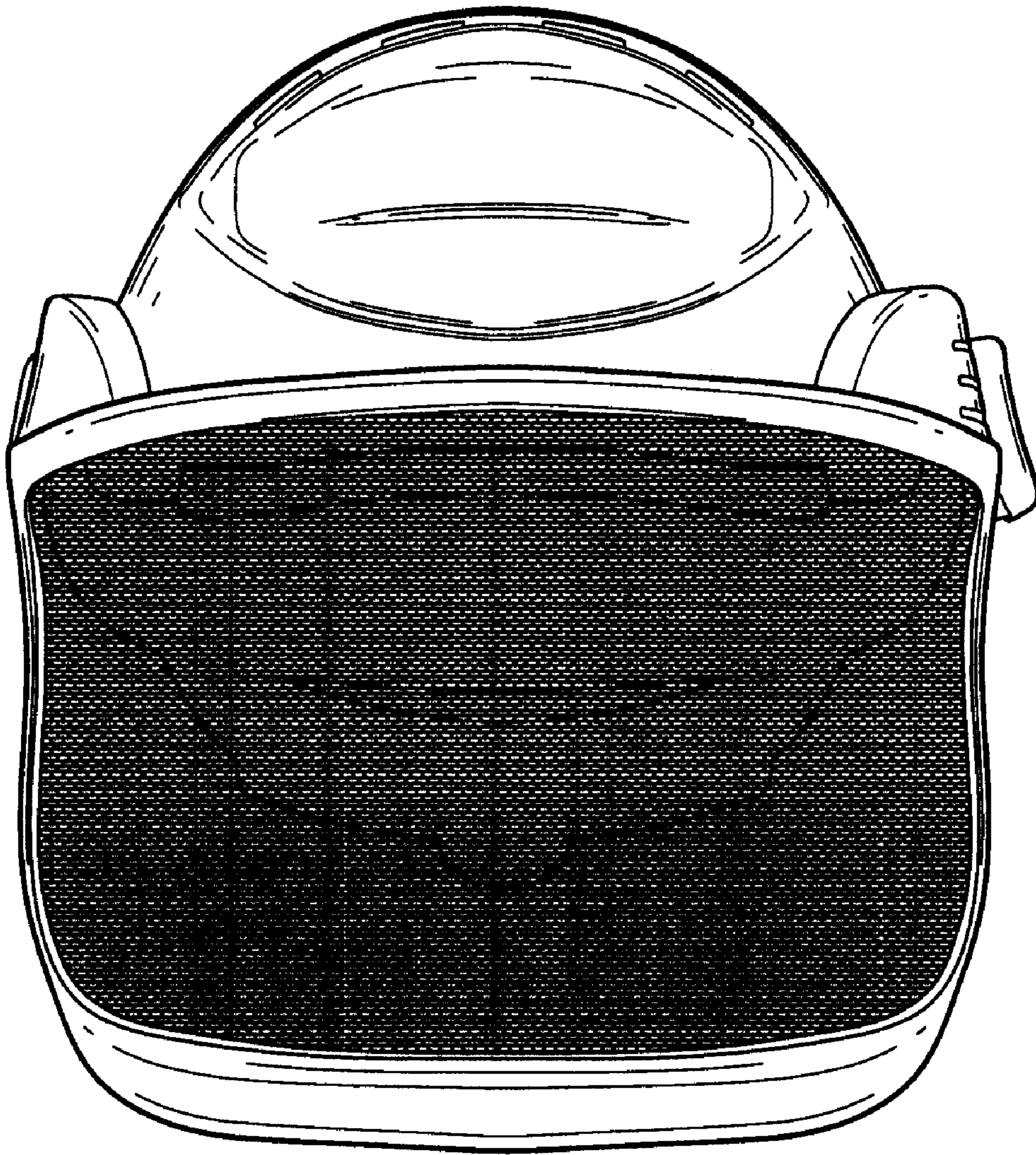

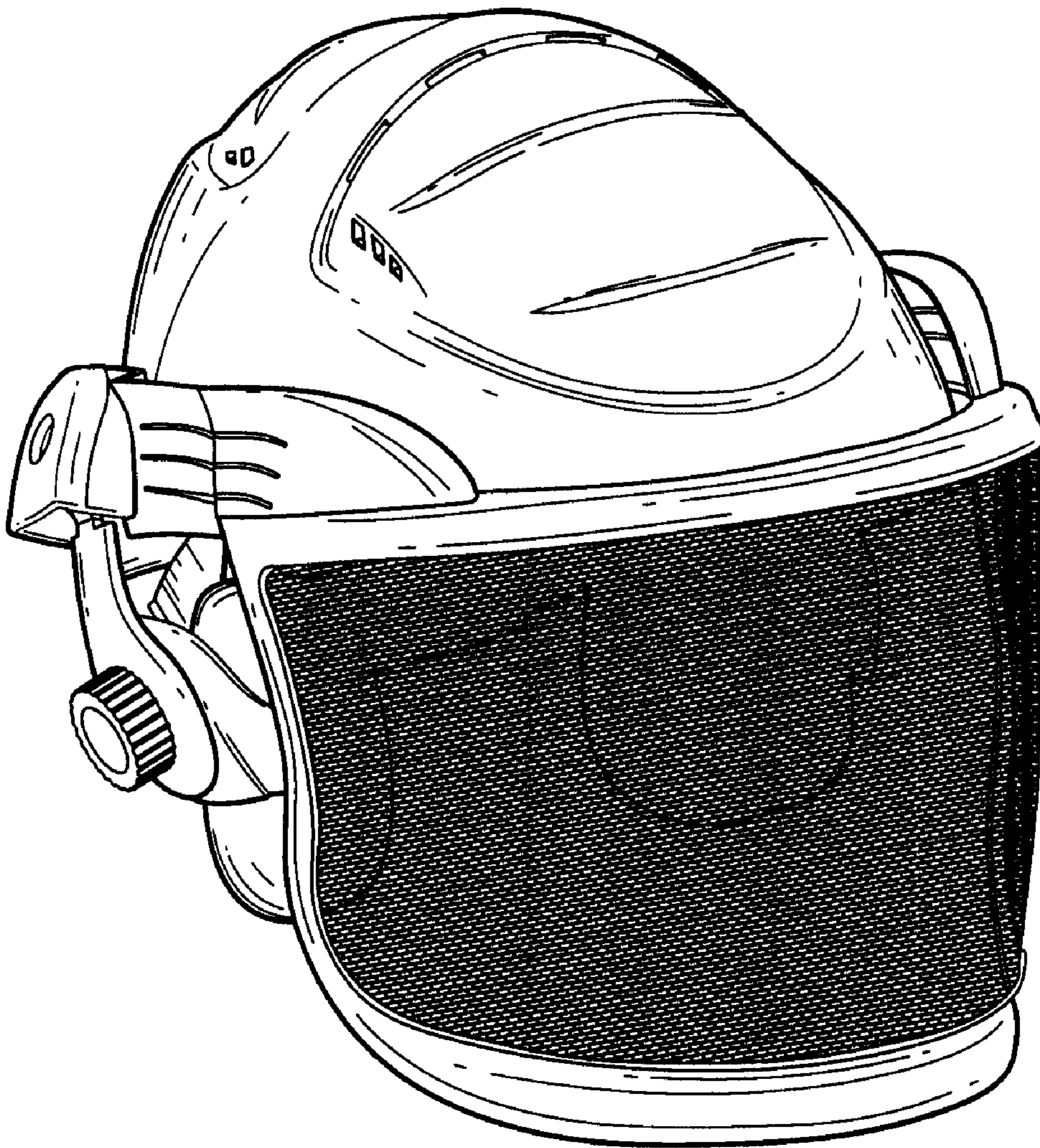

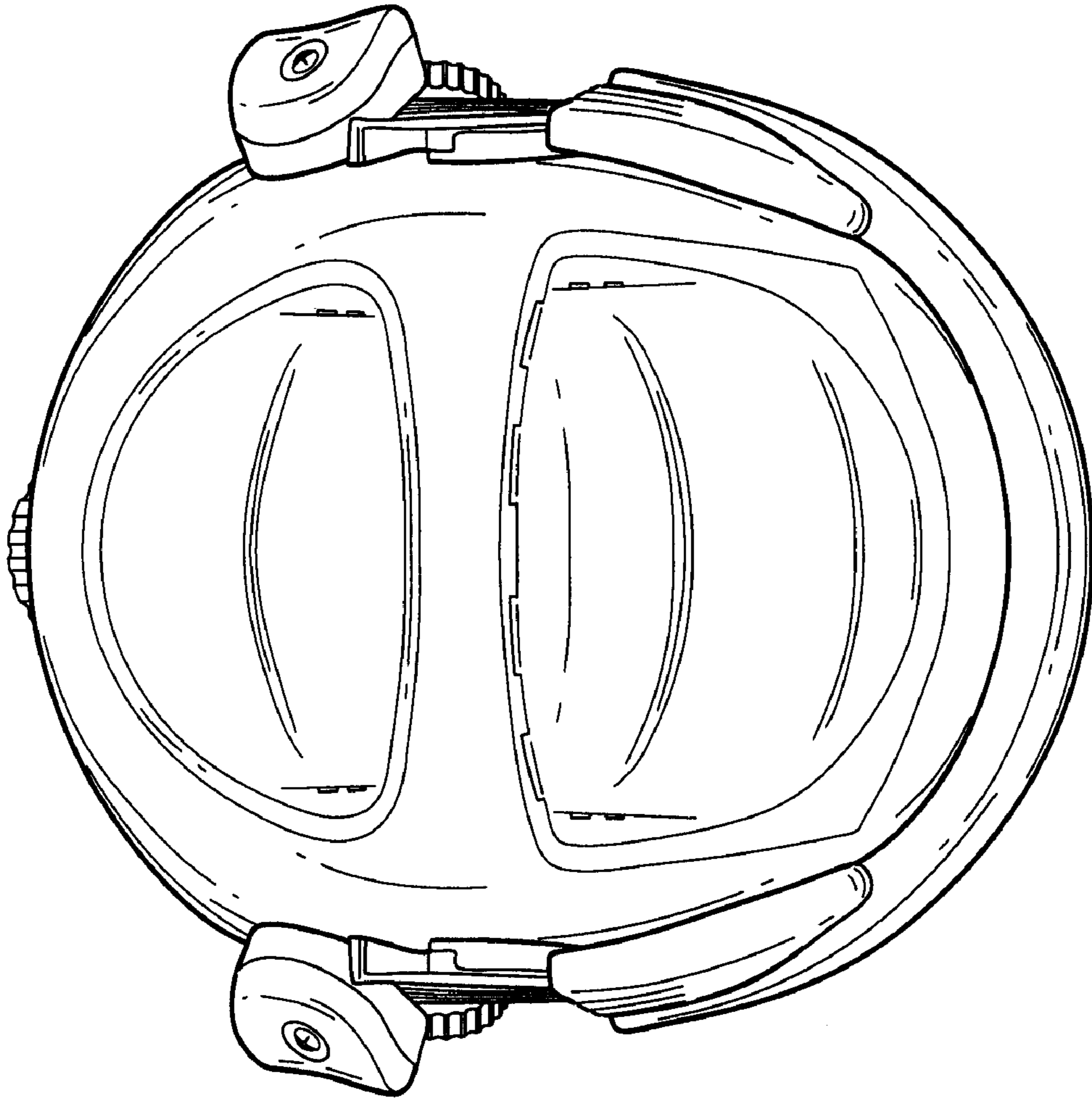

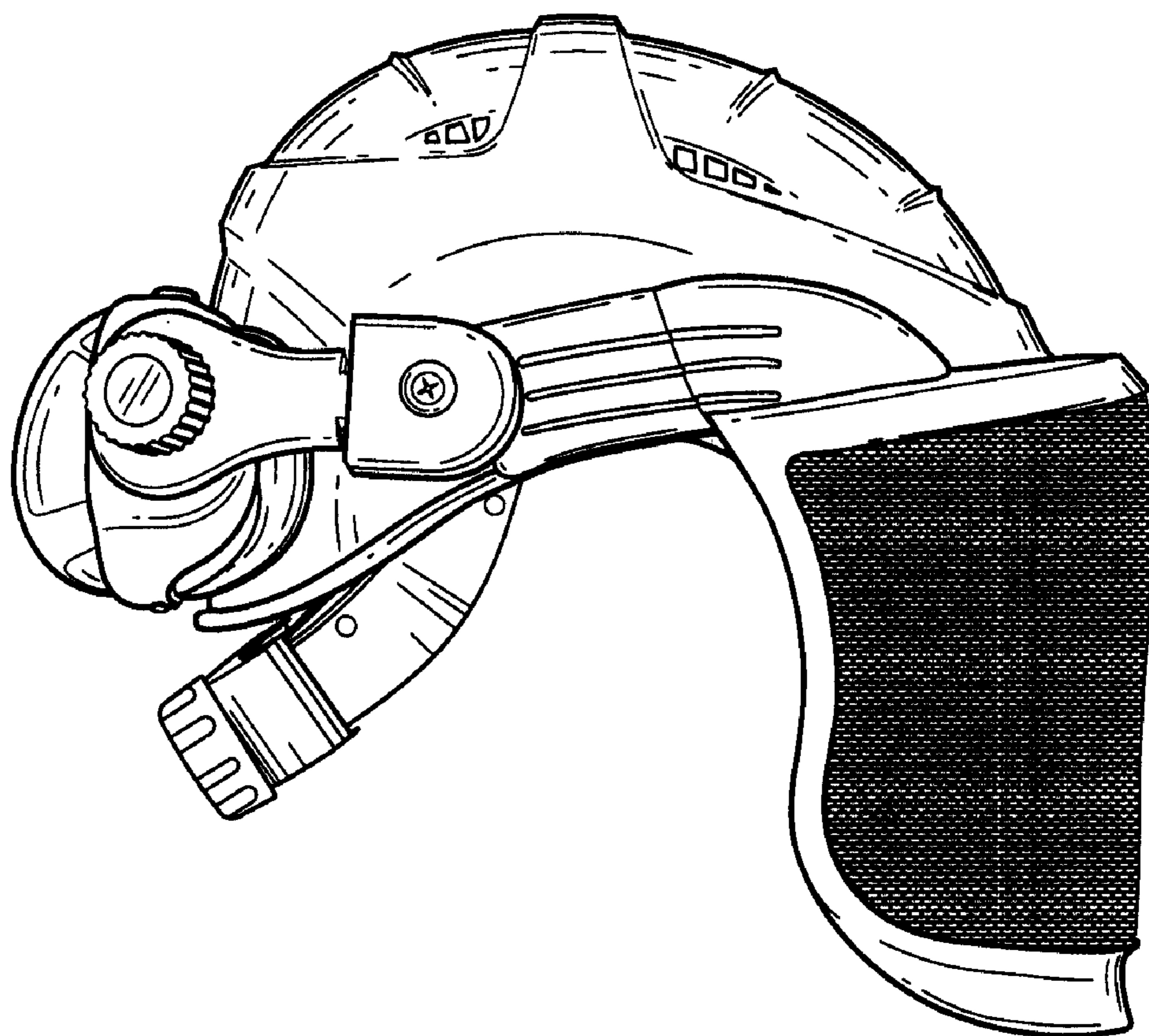

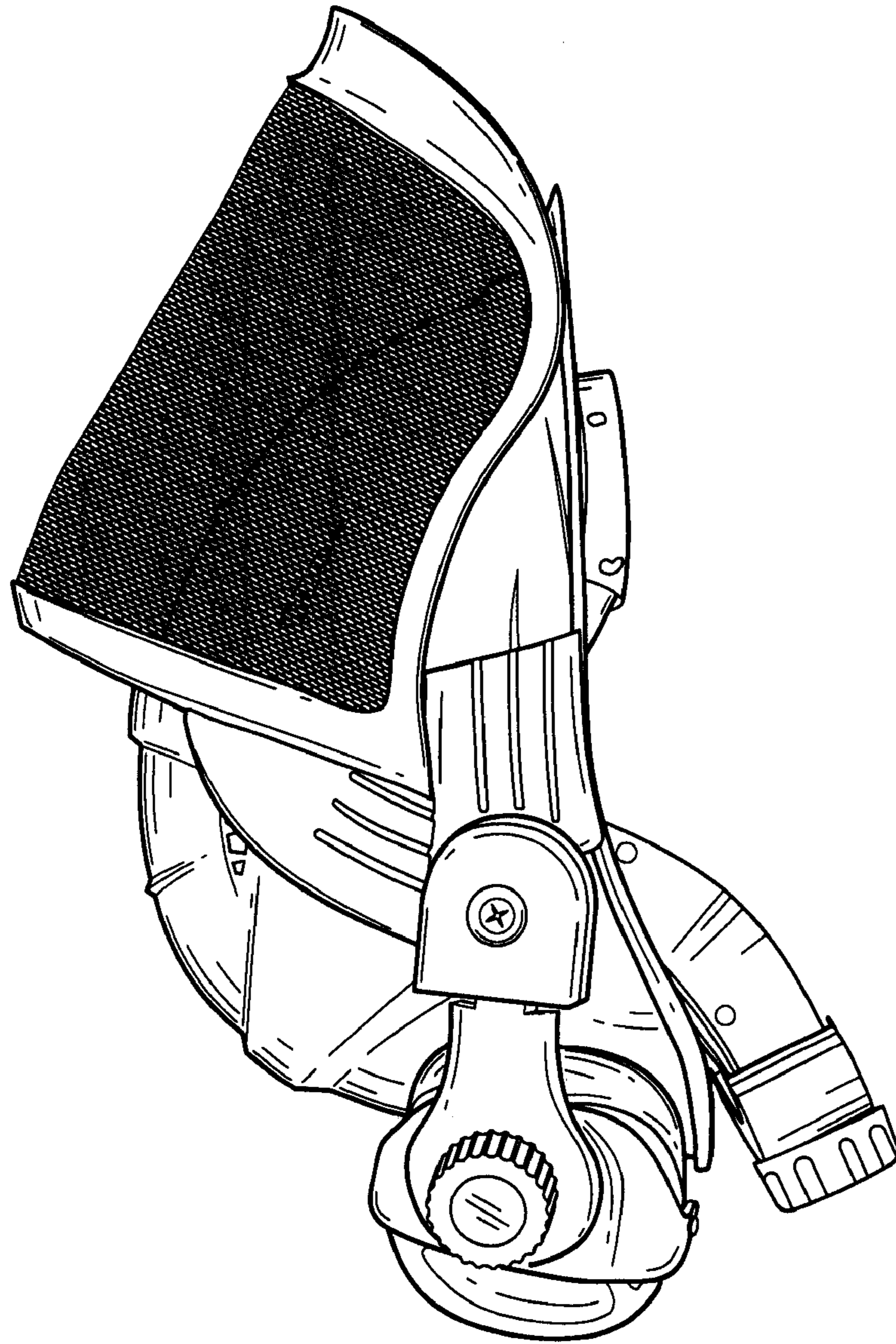

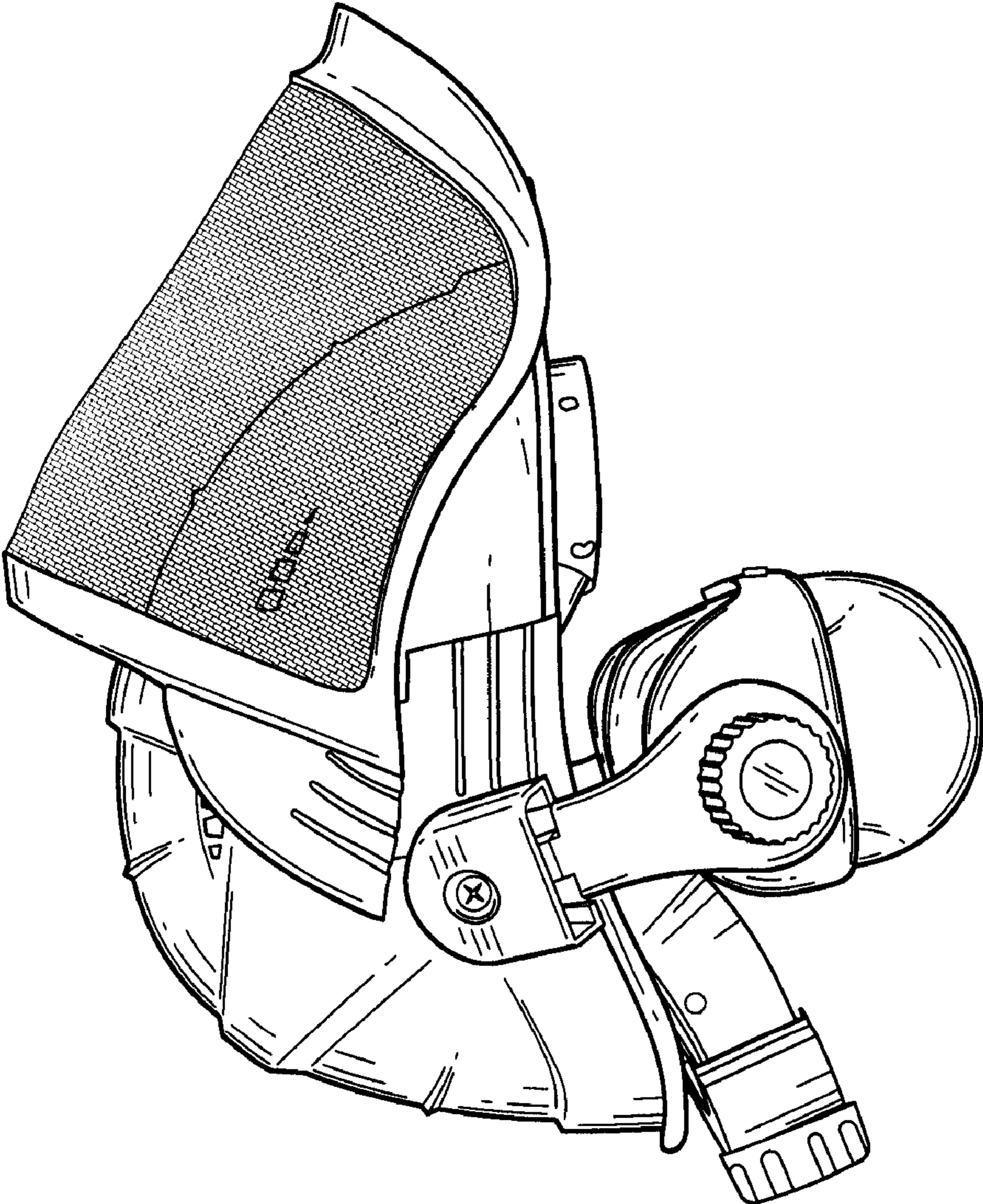
