FIG. 1 is a perspective view of my new and novel design of a baby garment in a snapped position;

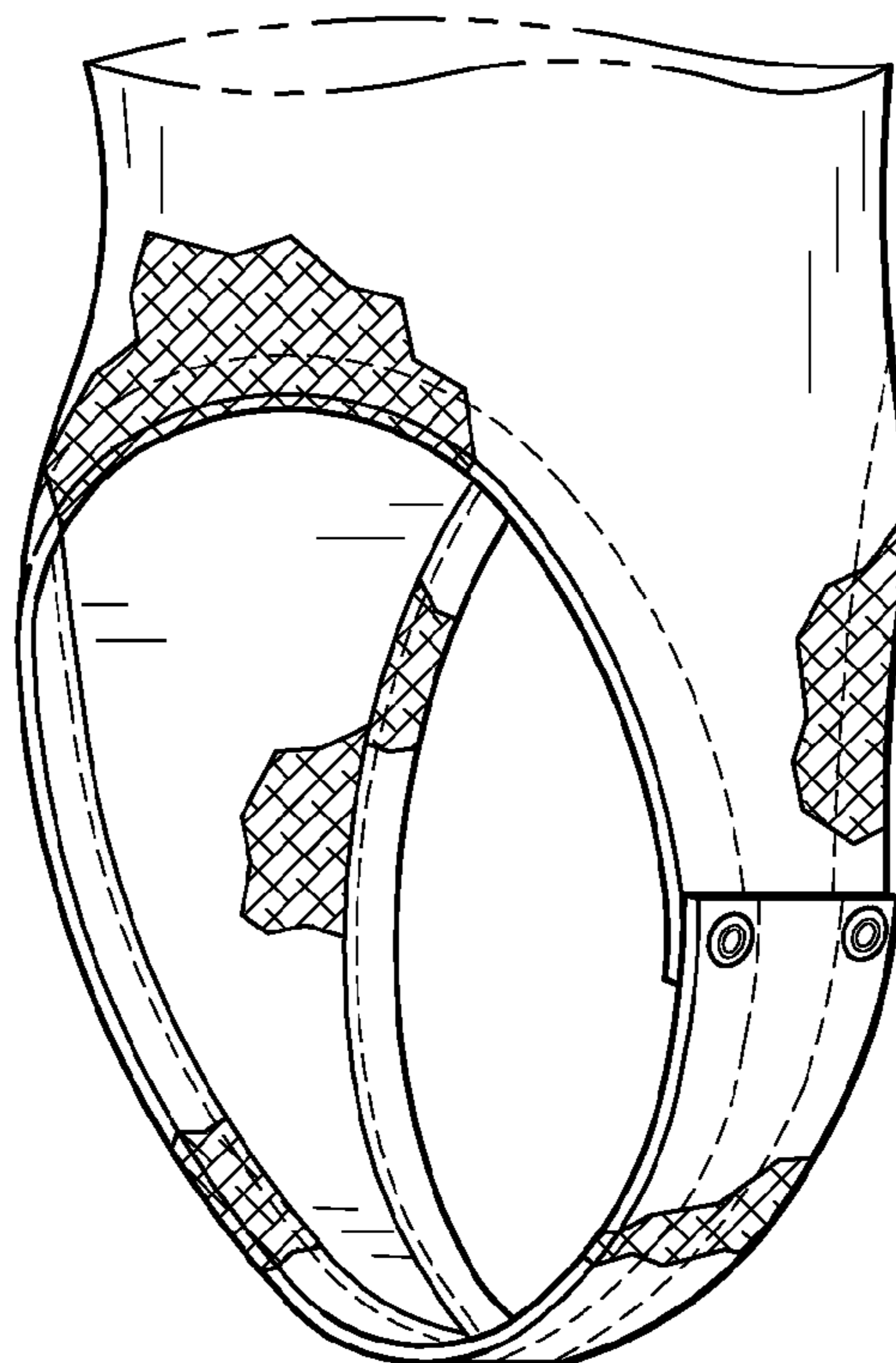
FIG. 2 is a front view of my new and novel design of a baby garment in an un-snapped position; and,

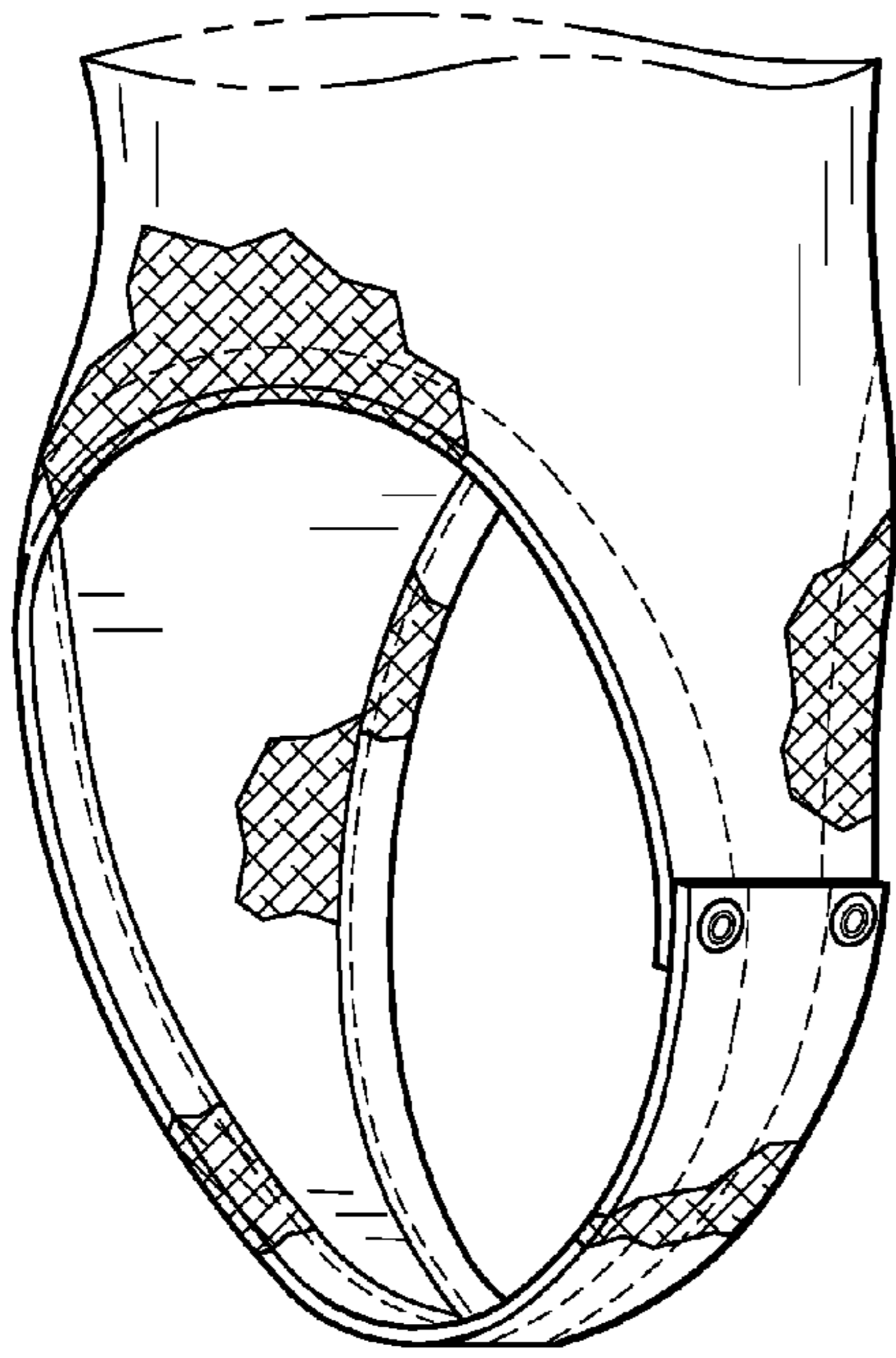

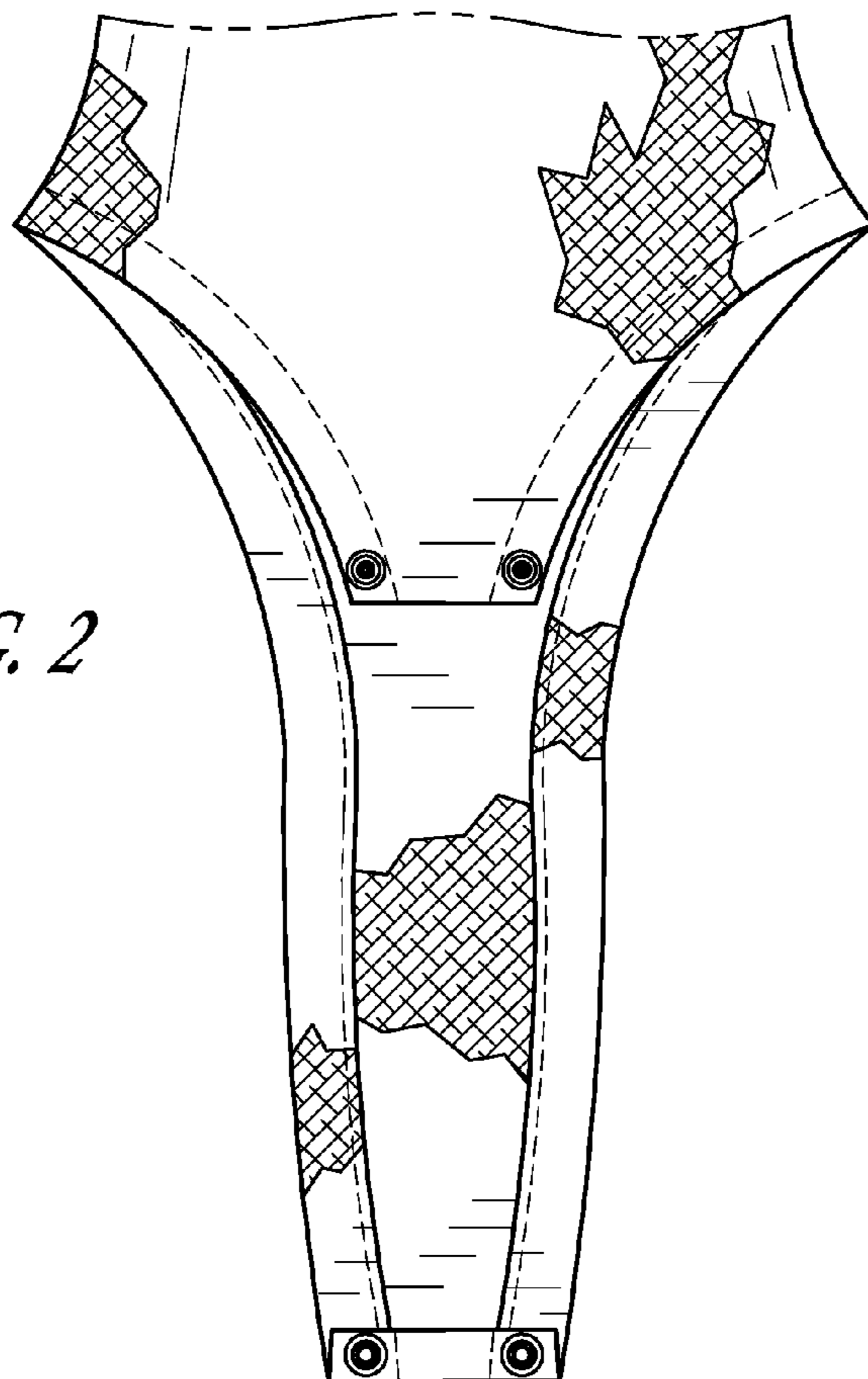

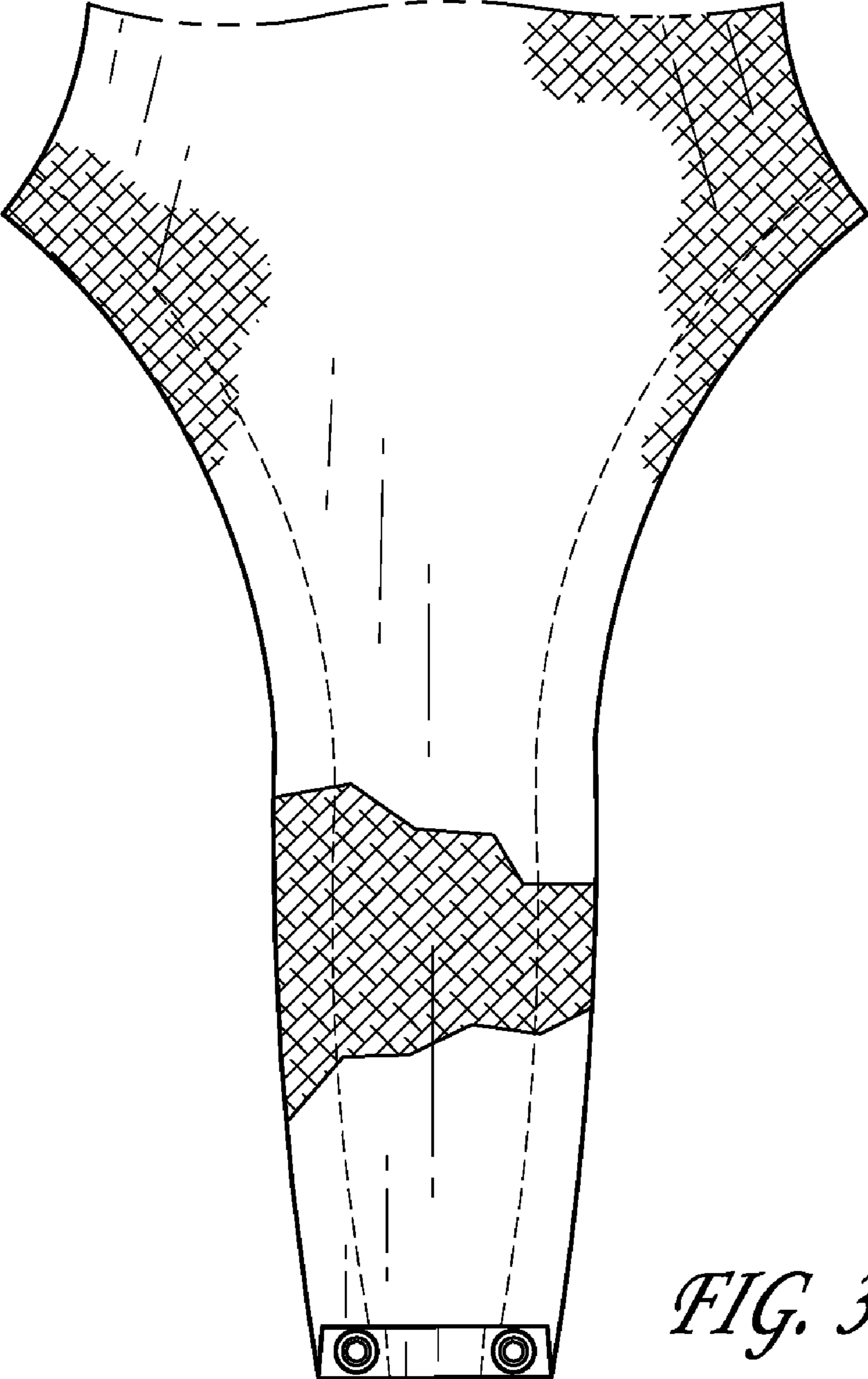
