(57) **CLAIM**

The ornamental design for a china cabinet, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a first embodiment of my new design of a china cabinet.

FIG. 2 is a right side elevational view thereof, with the left side elevational view being a mirror image thereof.

FIG. 3 is a cross-sectional view along line 3—3 of FIG. 1 thereof.

FIG. 4 is a rear elevational view thereof.

FIG. 5 is a top plan view thereof.

FIG. 6 is a cross-sectional view along line 6—6 of FIG. 1.

FIG. 7 is a cross-sectional view along line 7—7 of FIG. 1.

FIG. 8 is a cross-sectional view along line 8—8 of FIG. 1.

FIG. 9 is a bottom plan view thereof.

FIG. 10 is a front elevational view of the second embodiment of my new design of a china cabinet.

FIG. 11 is a right side elevational view thereof, the left side elevational view being a mirror image thereof.

FIG. 12 is a cross-sectional view along line 12—12 of FIG. 10.

FIG. 13 is a rear elevational view thereof.

FIG. 14 is a top plan view thereof.

FIG. 15 is a cross-sectional view along line 15—15 of FIG. 10.

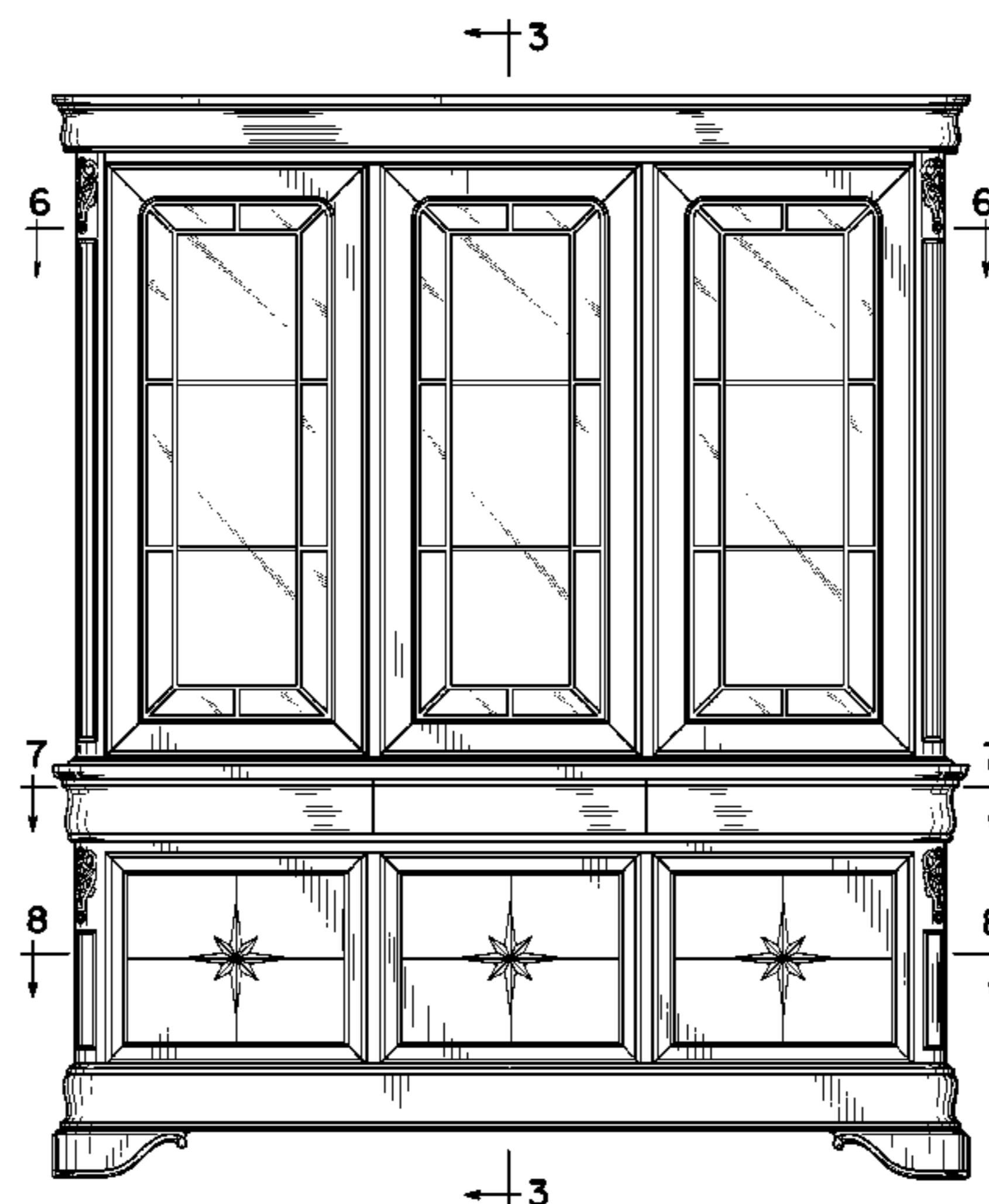
FIG. 16 is a cross-sectional view along line 16—16 of FIG. 10.

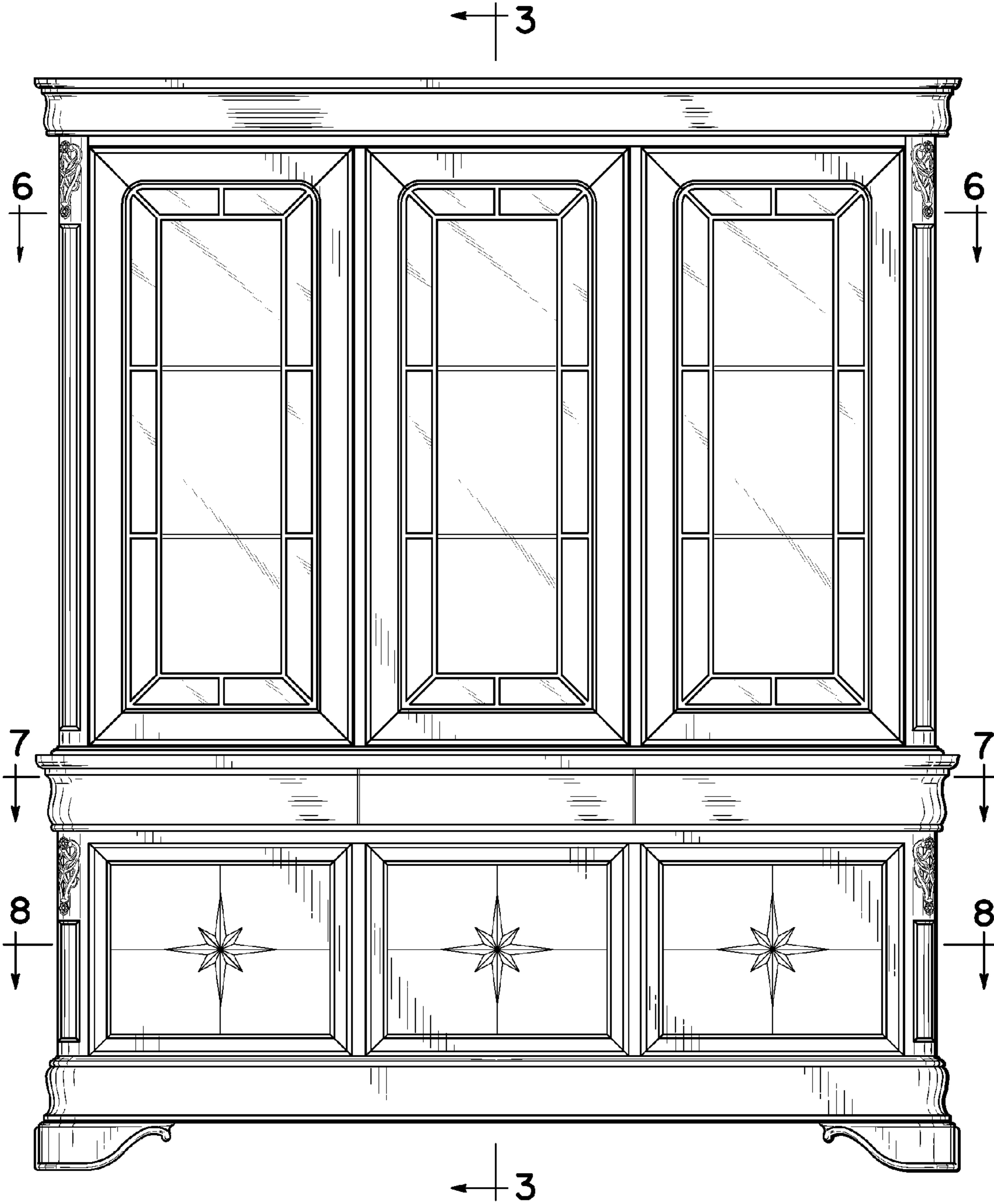

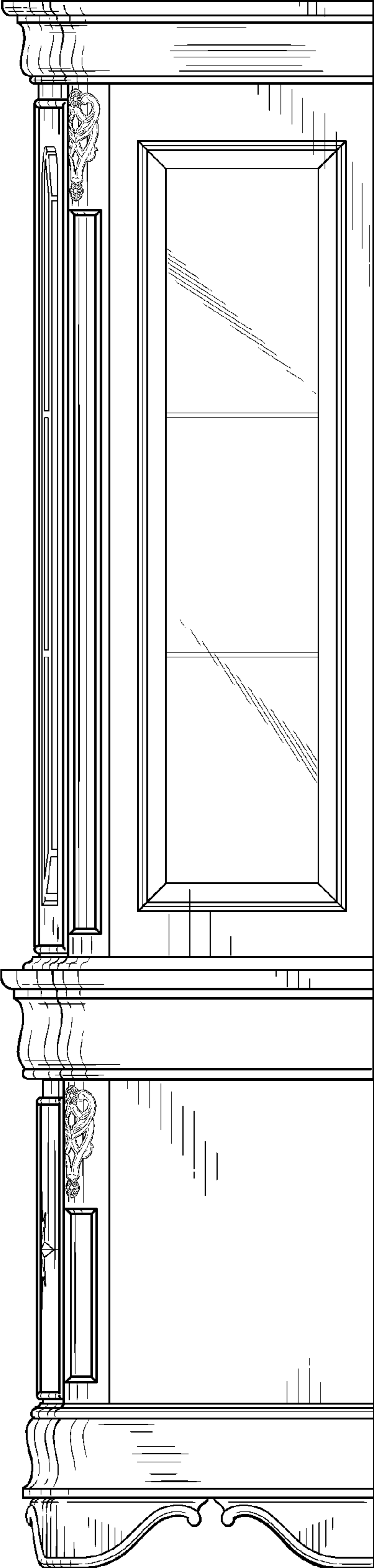

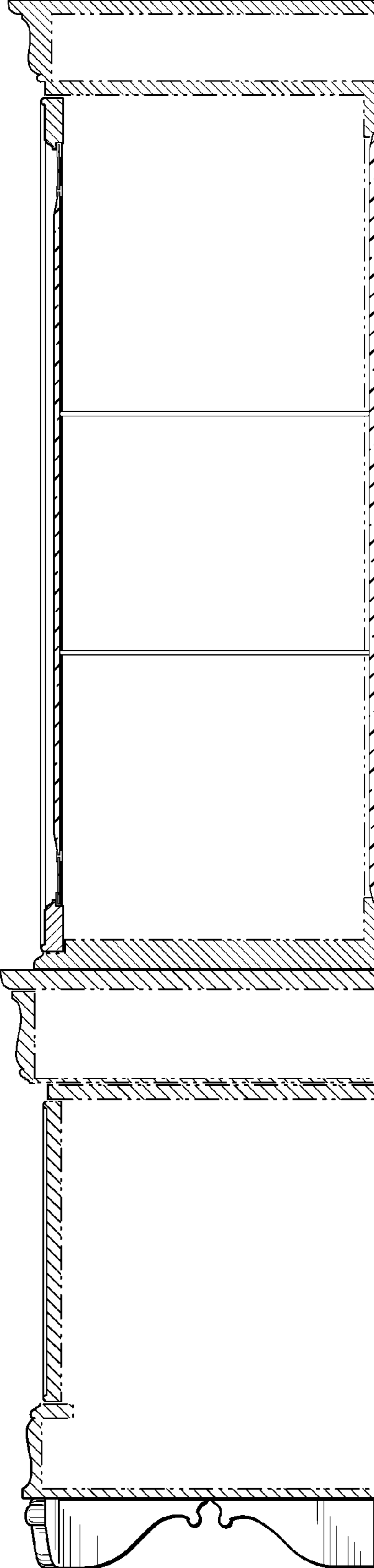

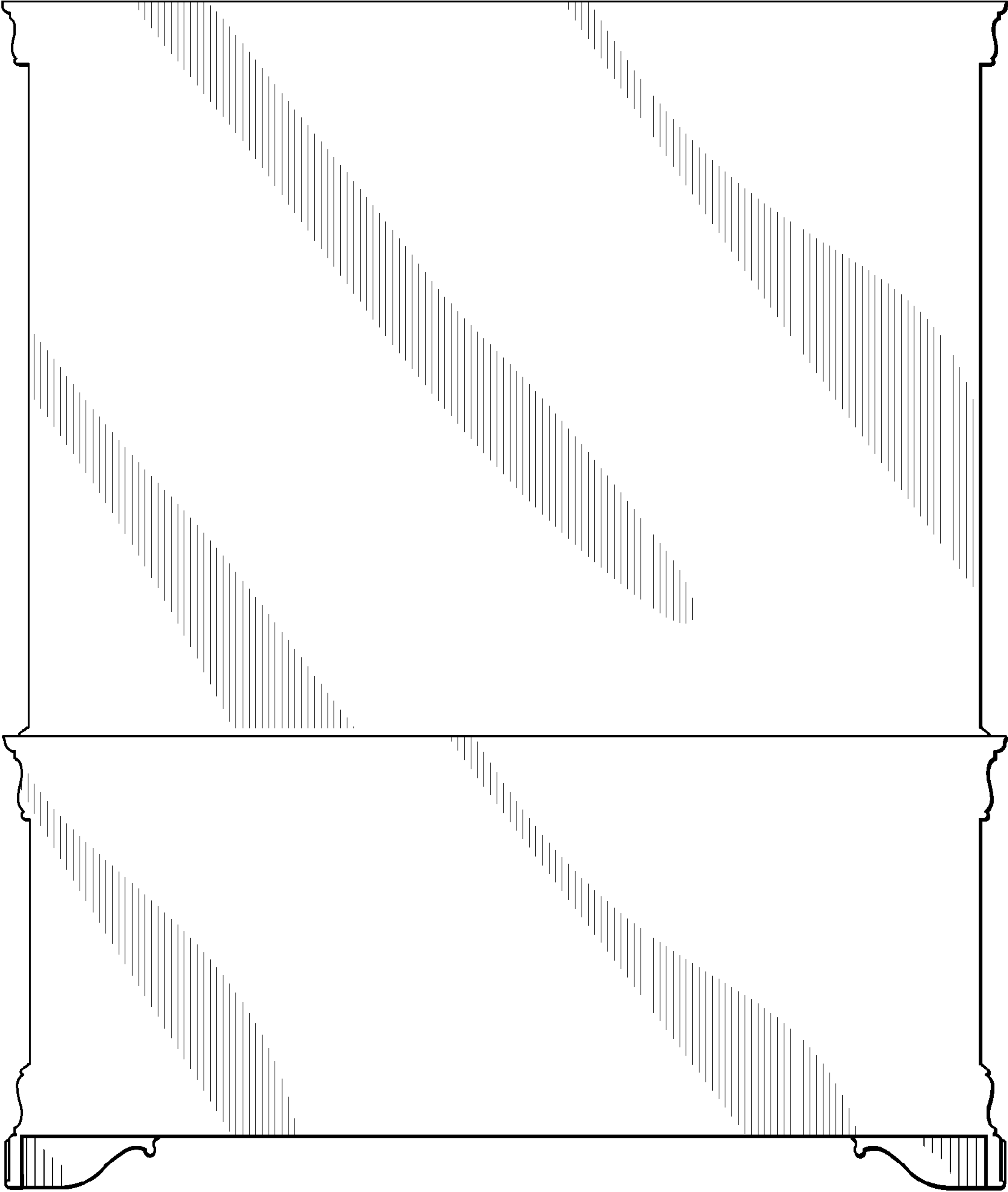

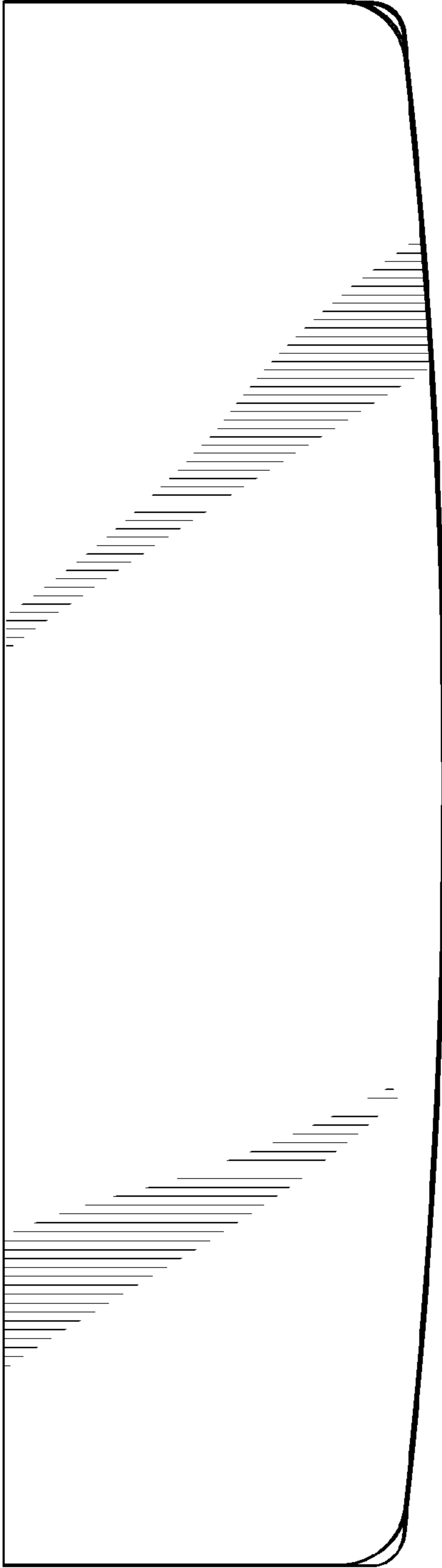

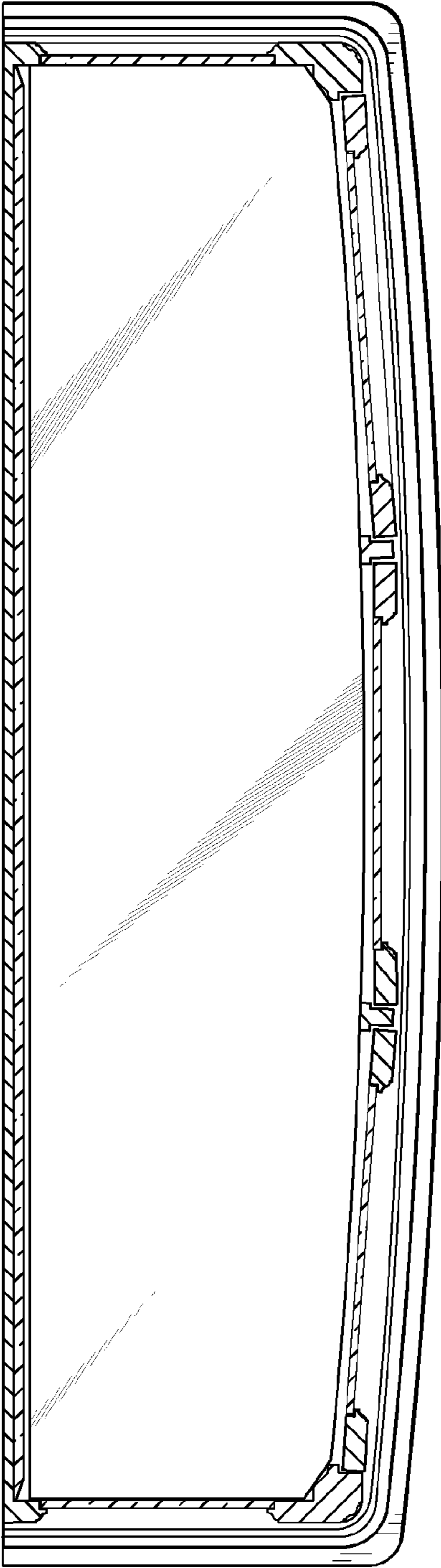

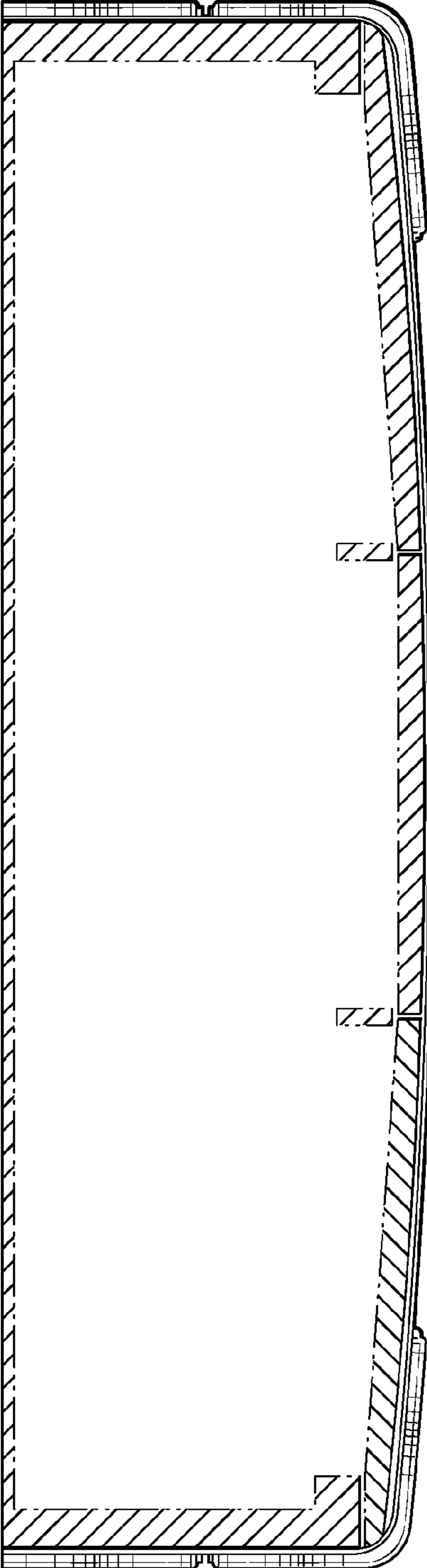

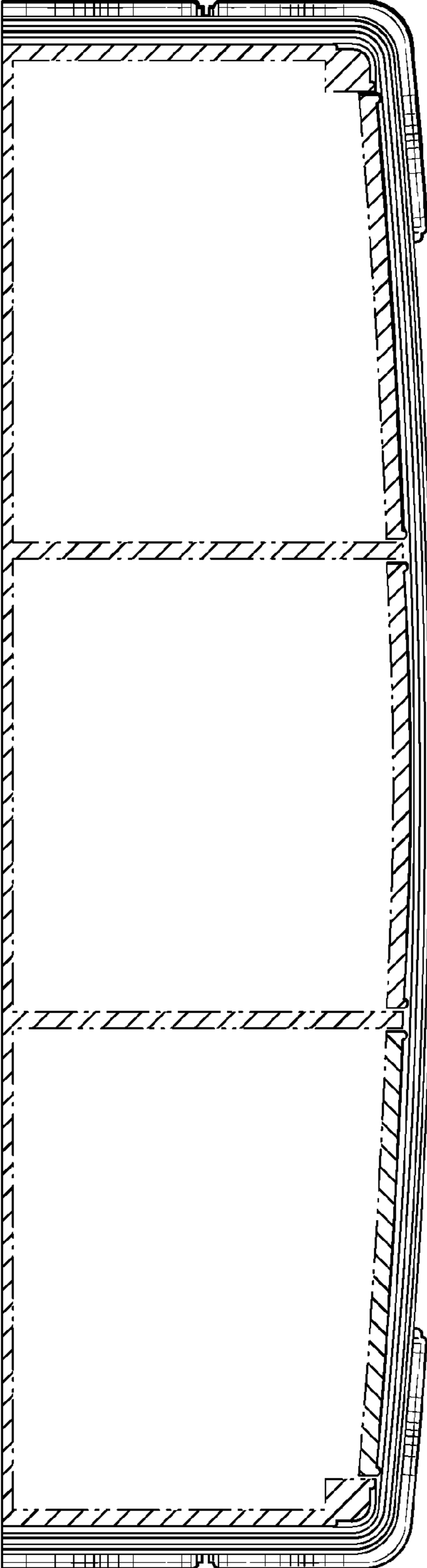

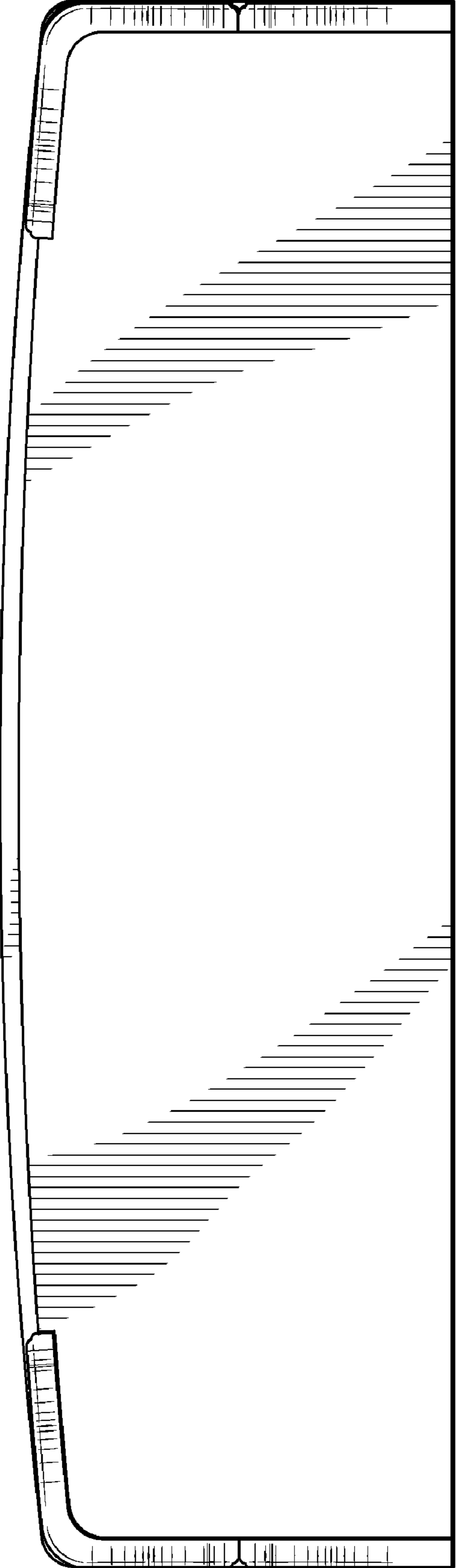

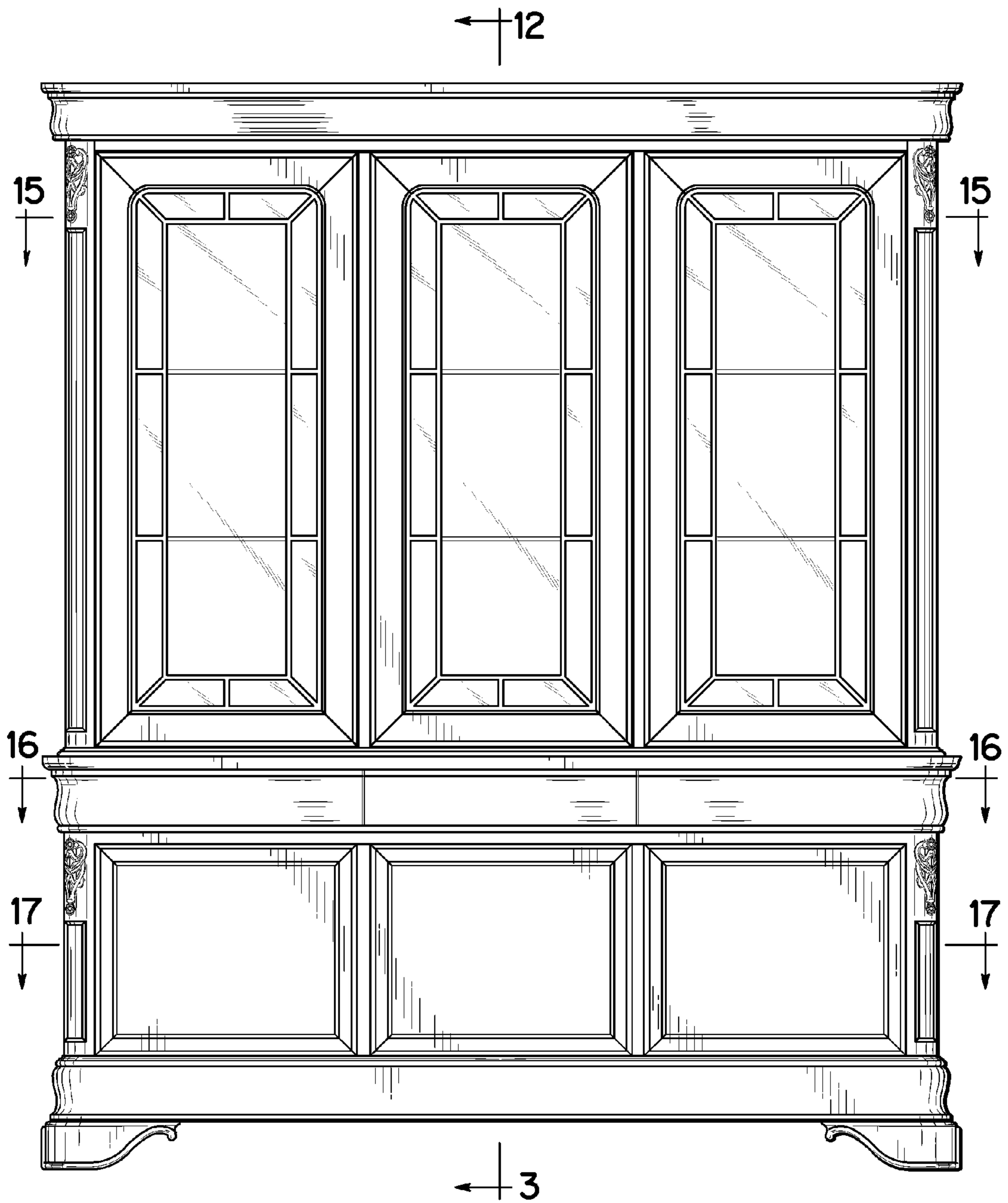

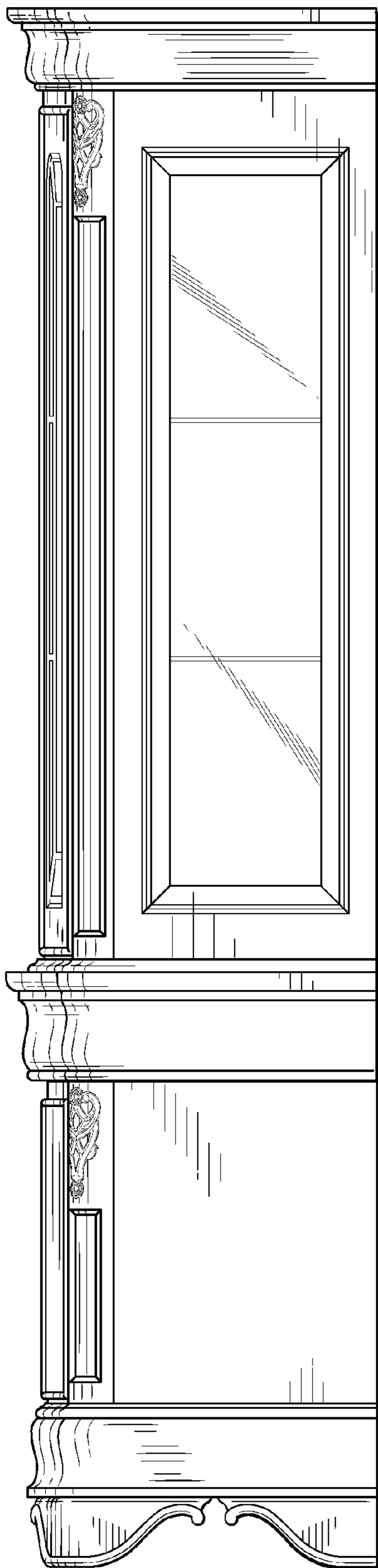

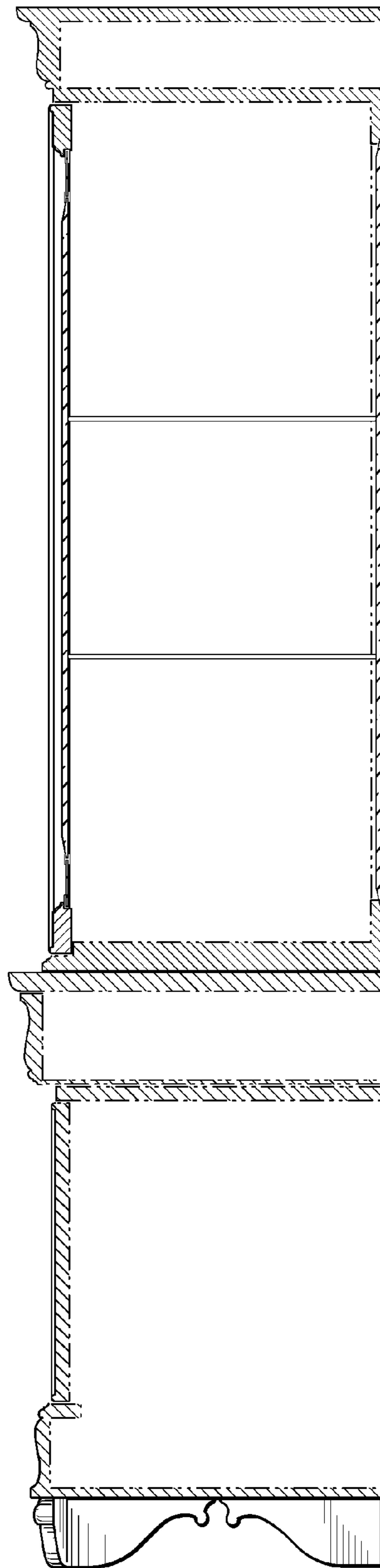

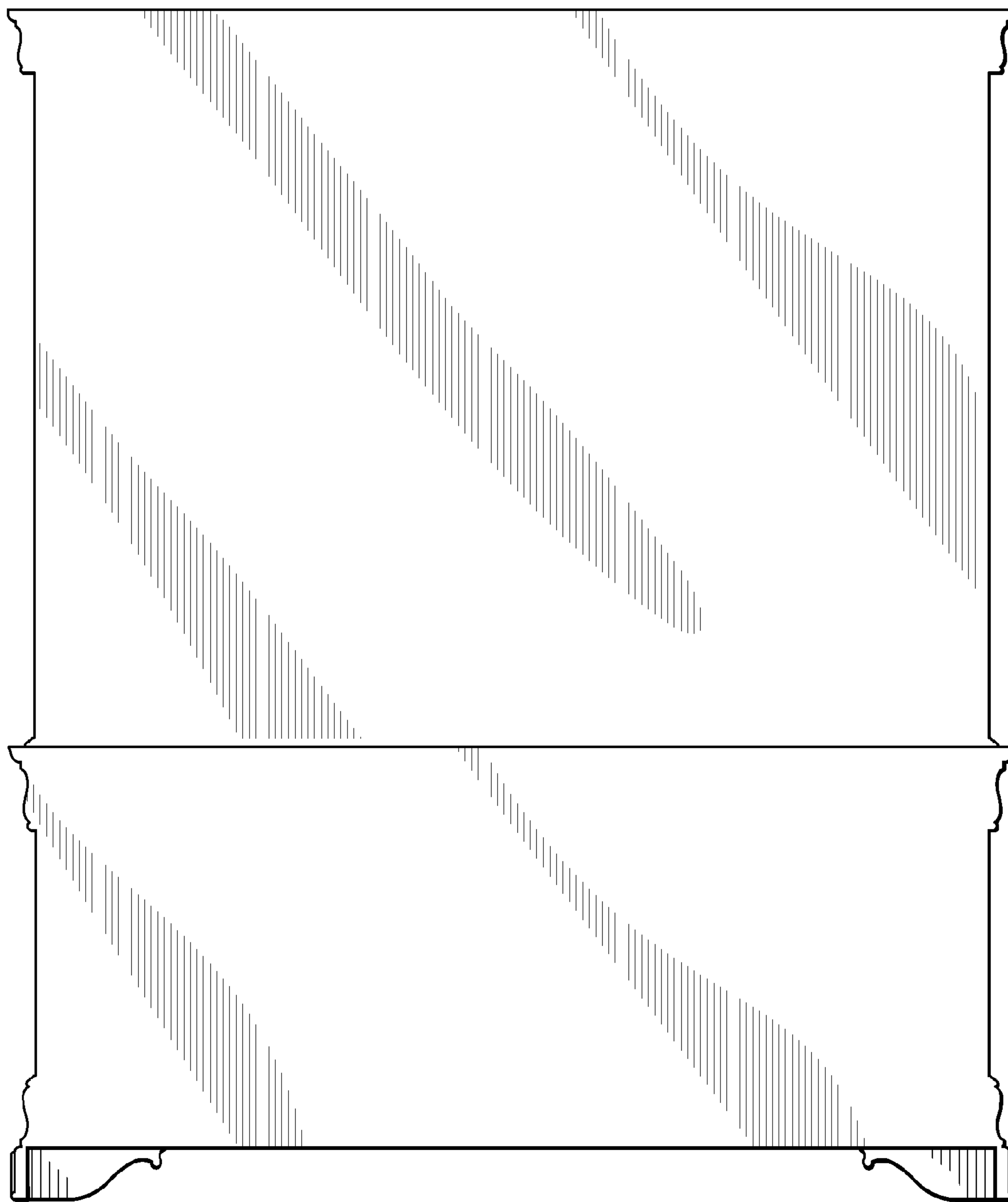

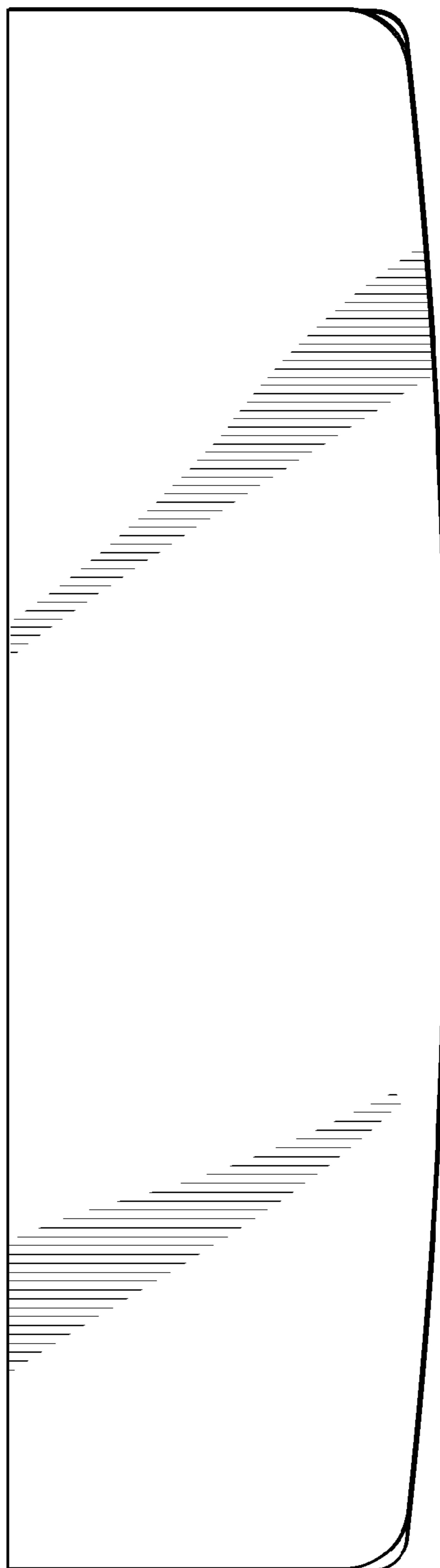

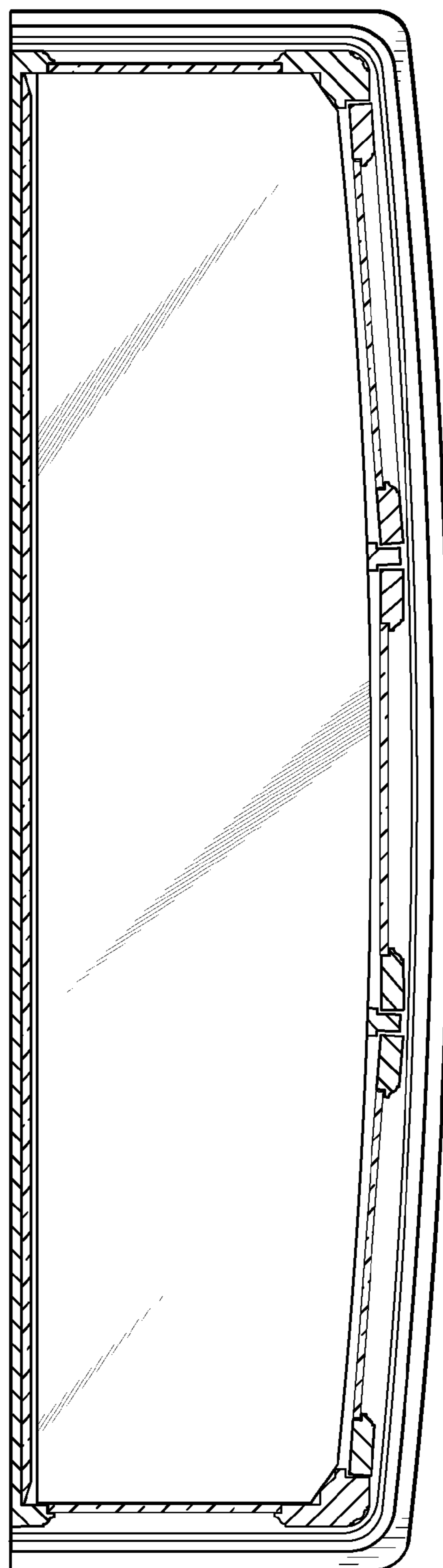

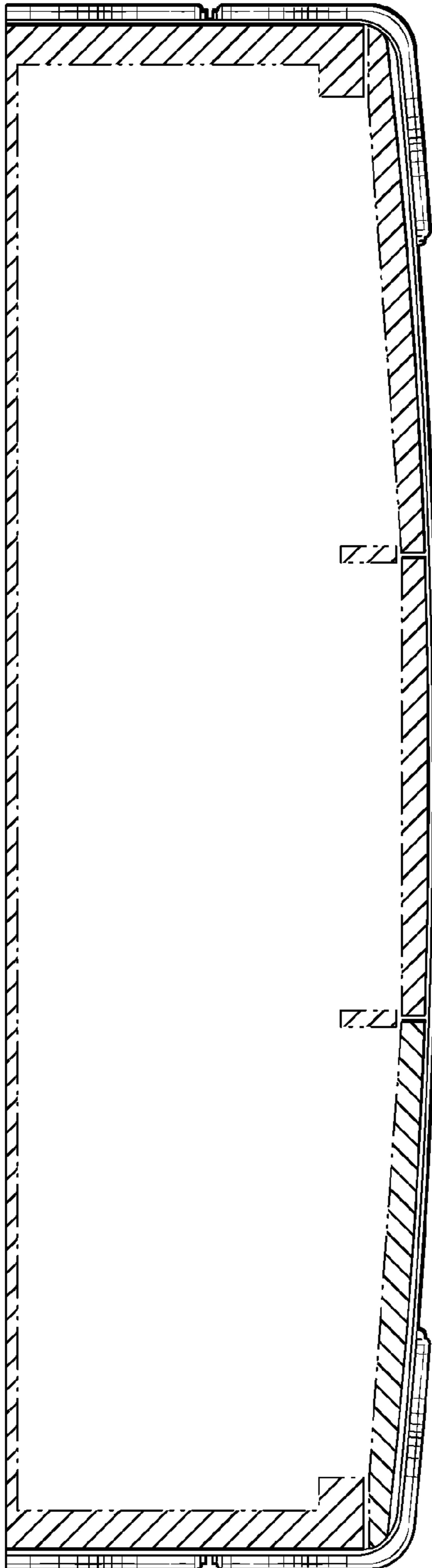

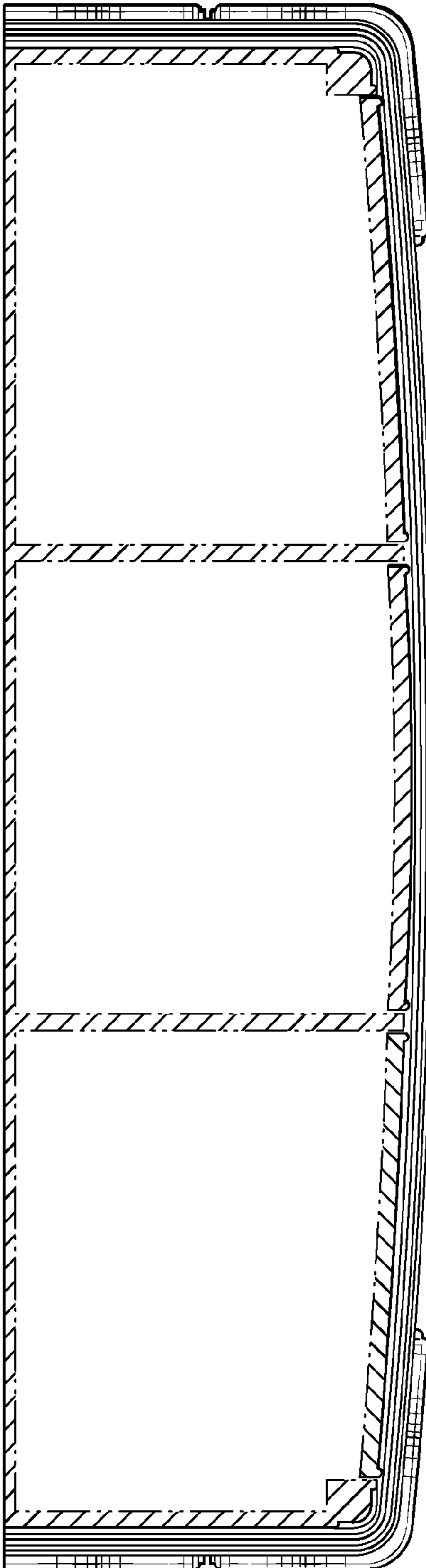

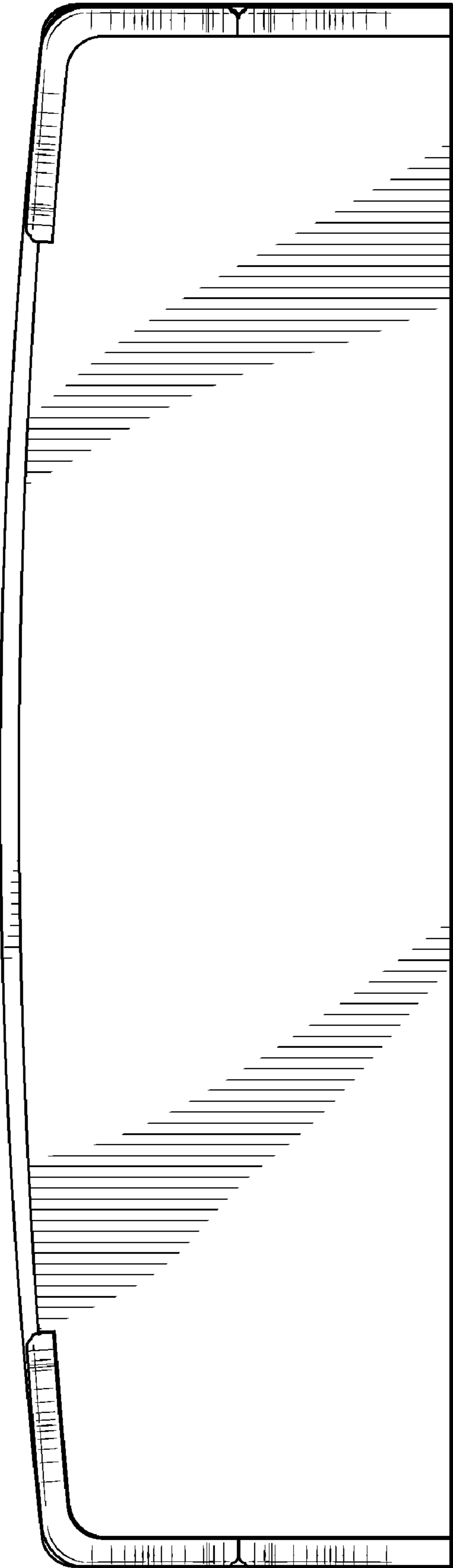
