(57) **CLAIM**

The ornamental design for an armoire, as shown and described.

FIG. 1 is a front elevational view of a first embodiment of an armoire showing my new design.

FIG. 2 is right side elevational view thereof, the left side elevational view being a mirror image thereof.

FIG. 3 is a cross-sectional view taken along line 3—3 of FIG. 1 thereof,

FIG. 4 is a rear elevational view thereof.

FIG. 5 is a top plan view thereof.

FIG. 6 is a cross-sectional view taken along line 6—6 of FIG. 1 thereof.

FIG. 7 is a cross-sectional view taken along line 7—7 of FIG. 1 thereof.

FIG. 8 is a cross-sectional view taken along line 8—8 of FIG. 1 thereof.

FIG. 9 bottom plan view thereof.

FIG. 10 is a front elevational view if a second embodiment of an armoire showing my new design.

FIG. 11 is right side elevational view thereof, the left side elevational view being a mirror image thereof.

FIG. 12 is a cross-sectional view taken along line 12—12 of FIG. 10 thereof,

FIG. 13 is a rear elevational view thereof.

FIG. 14 is a top plan view thereof.

FIG. 15 is a cross-sectional view taken along line 15—15 of FIG. 10 thereof.

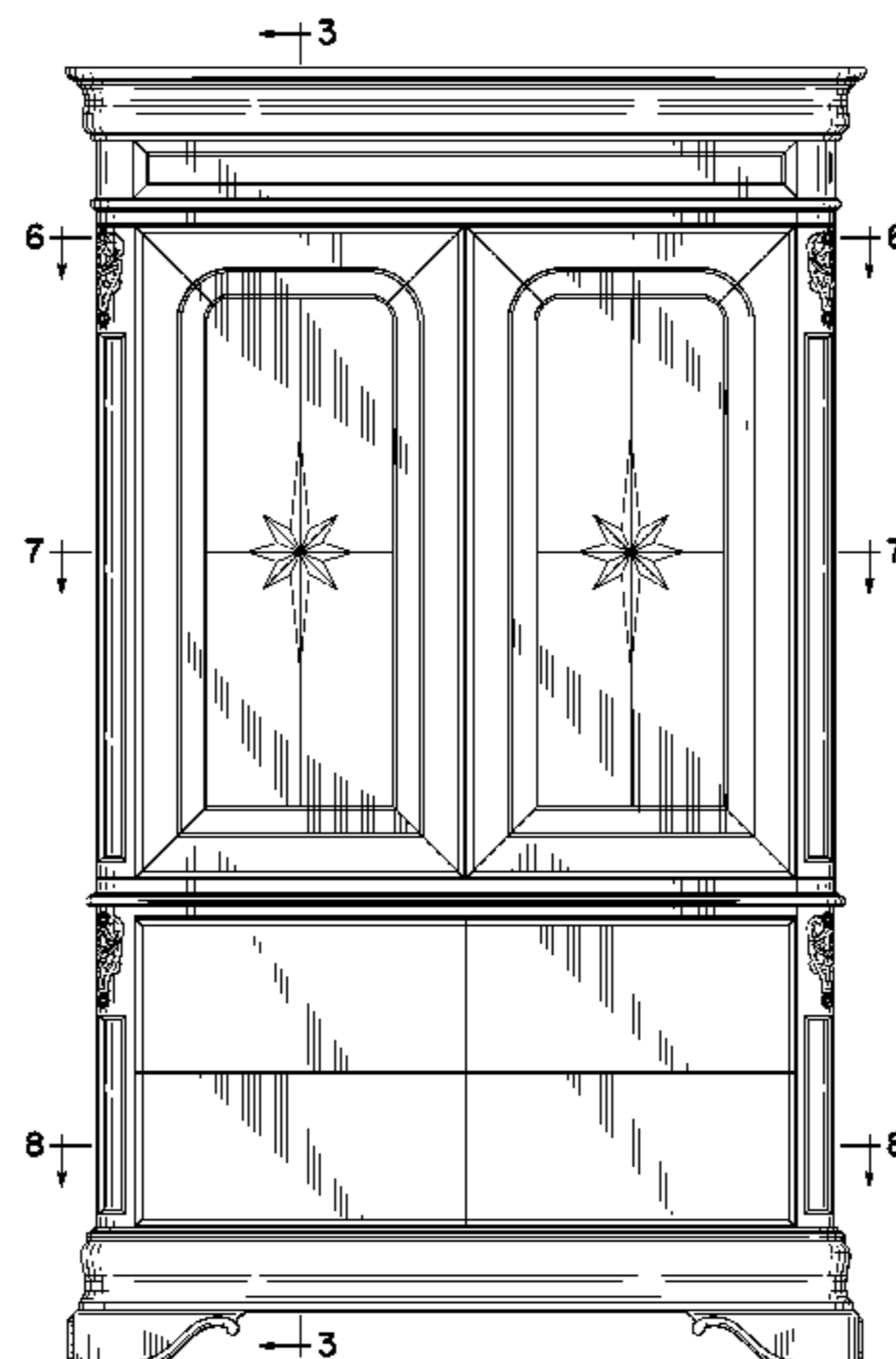
FIG. 16 is a cross-sectional view taken along line 16—16 of FIG. 10 thereof.

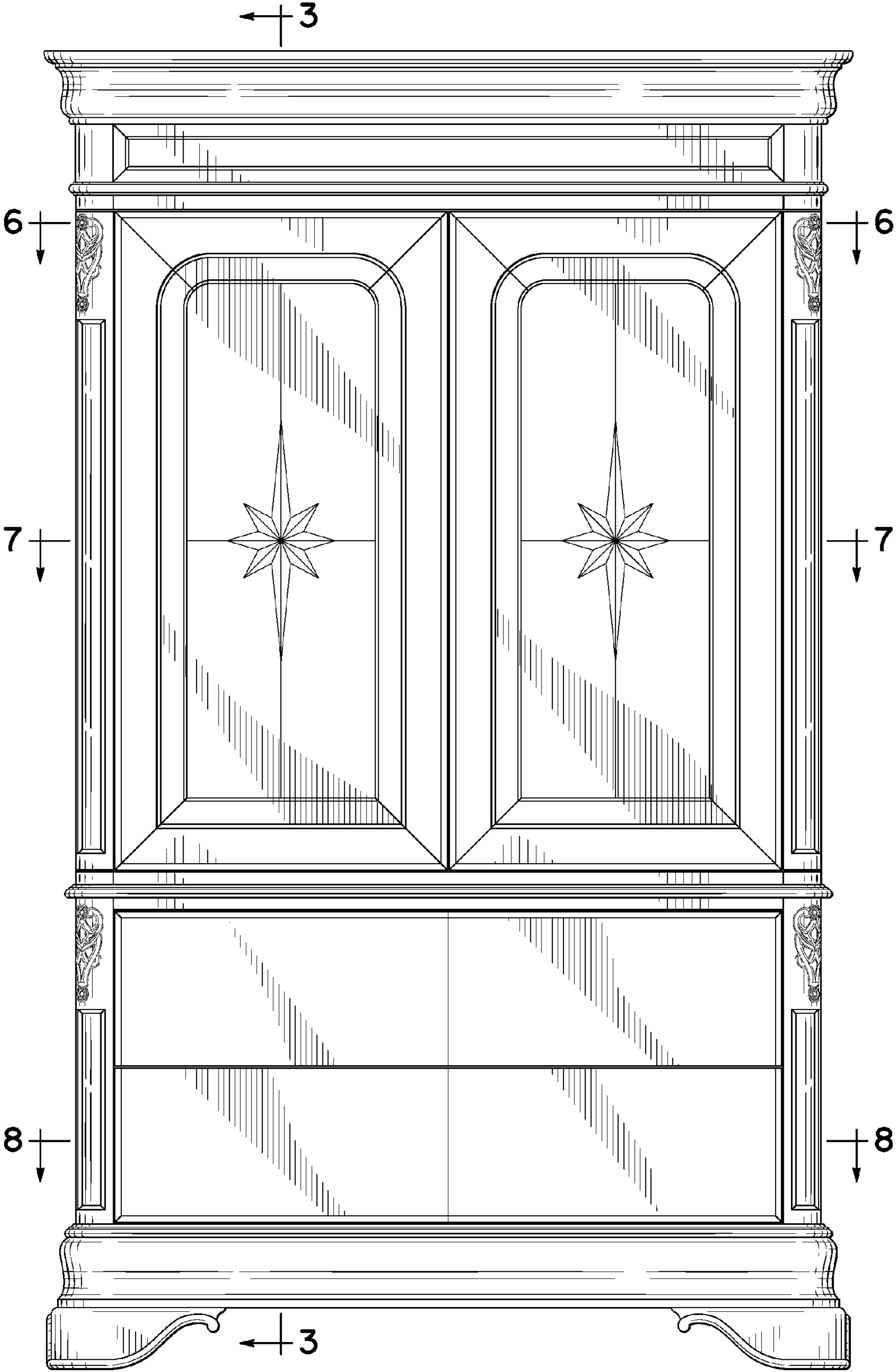

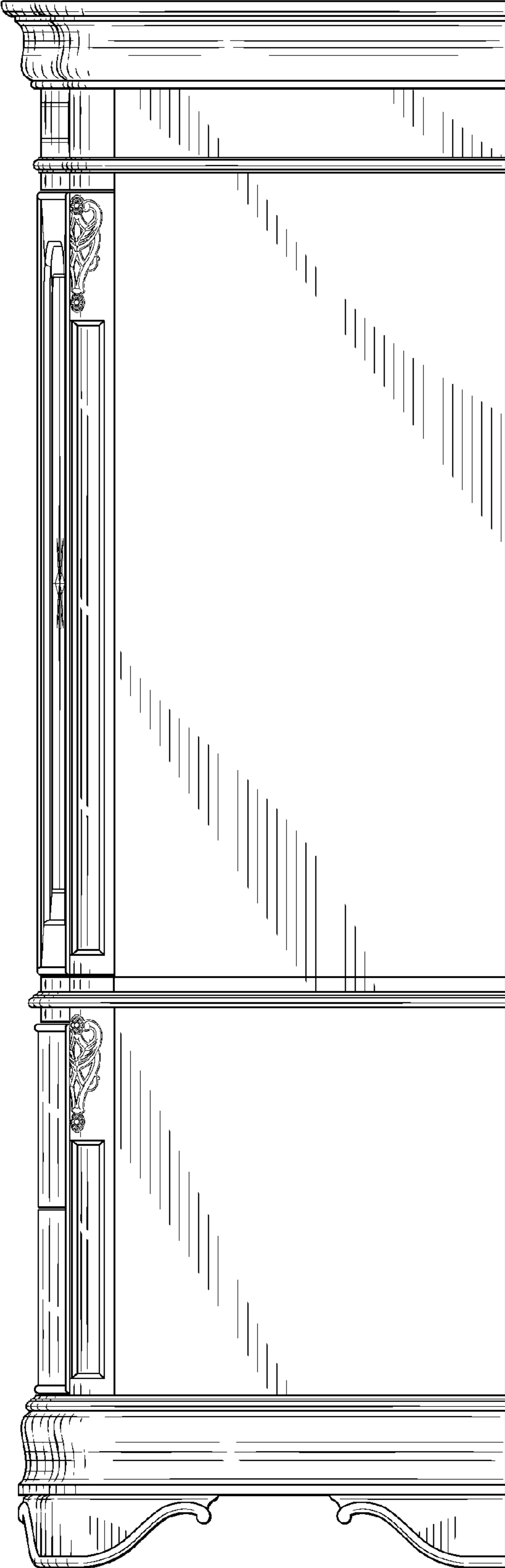

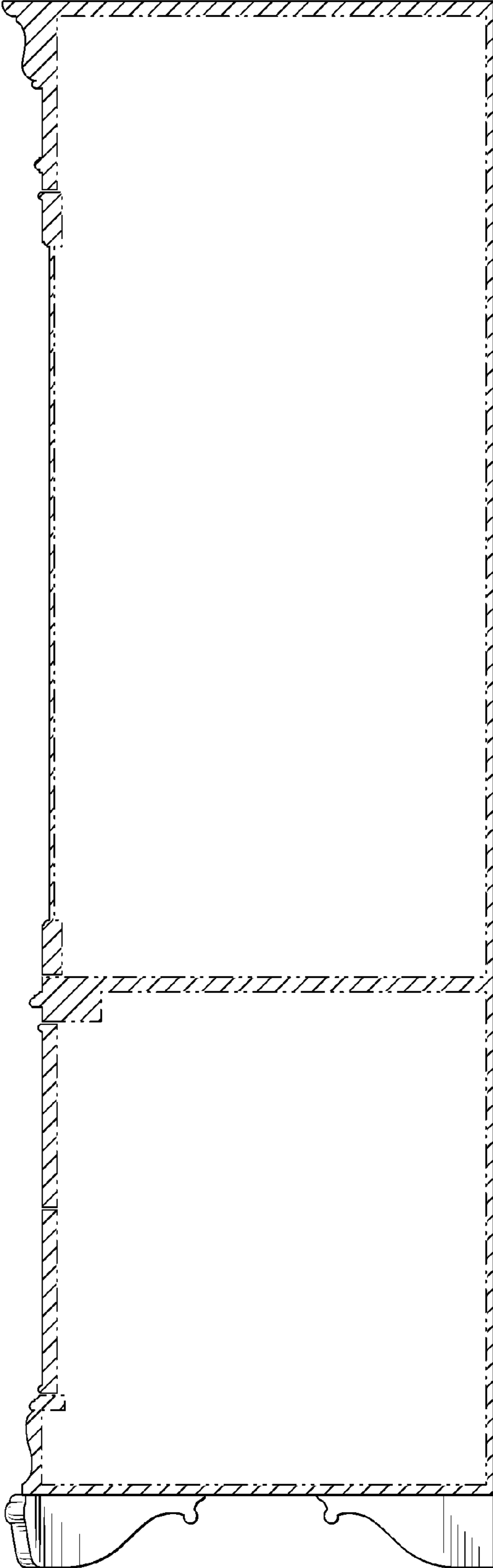

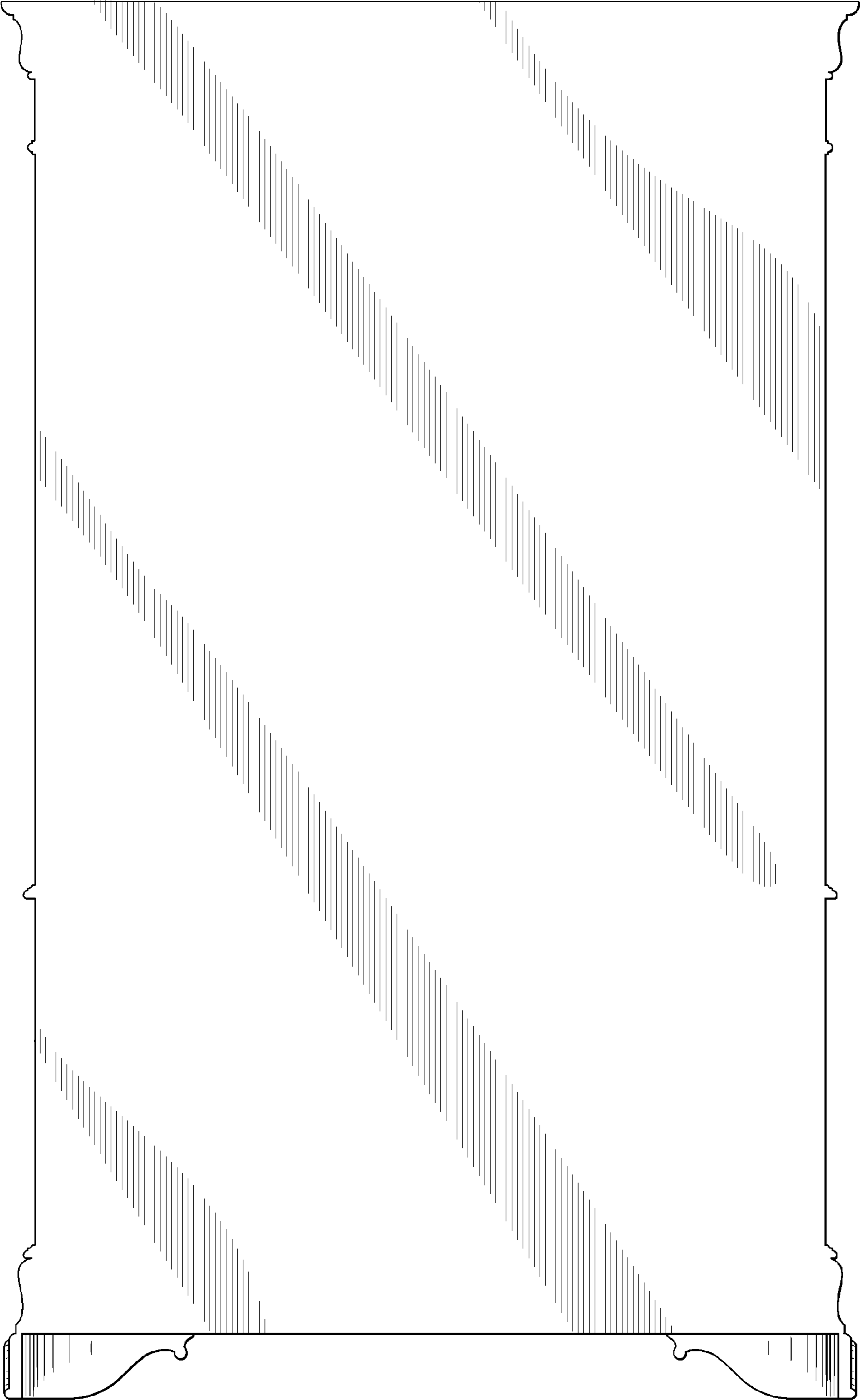

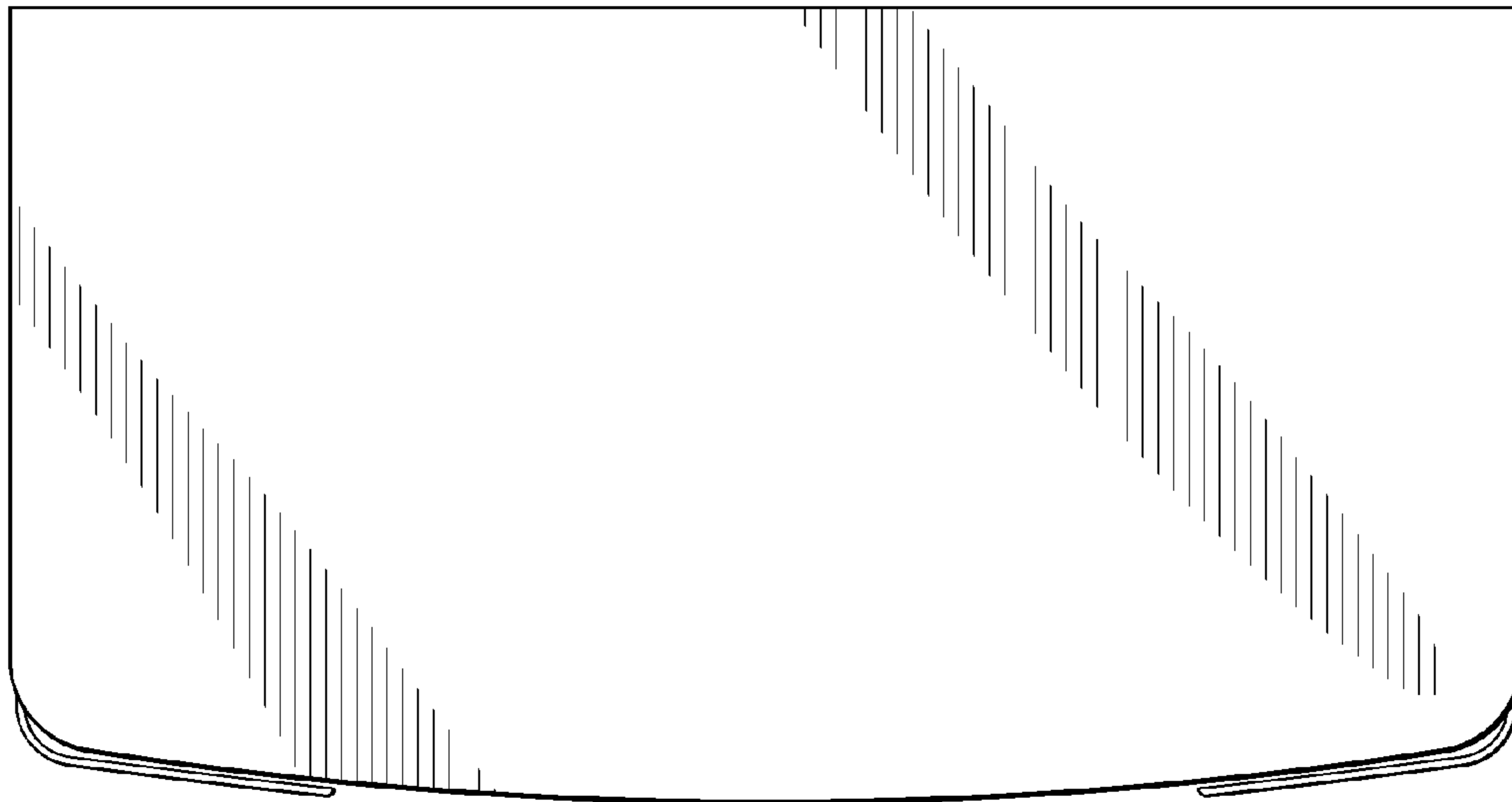

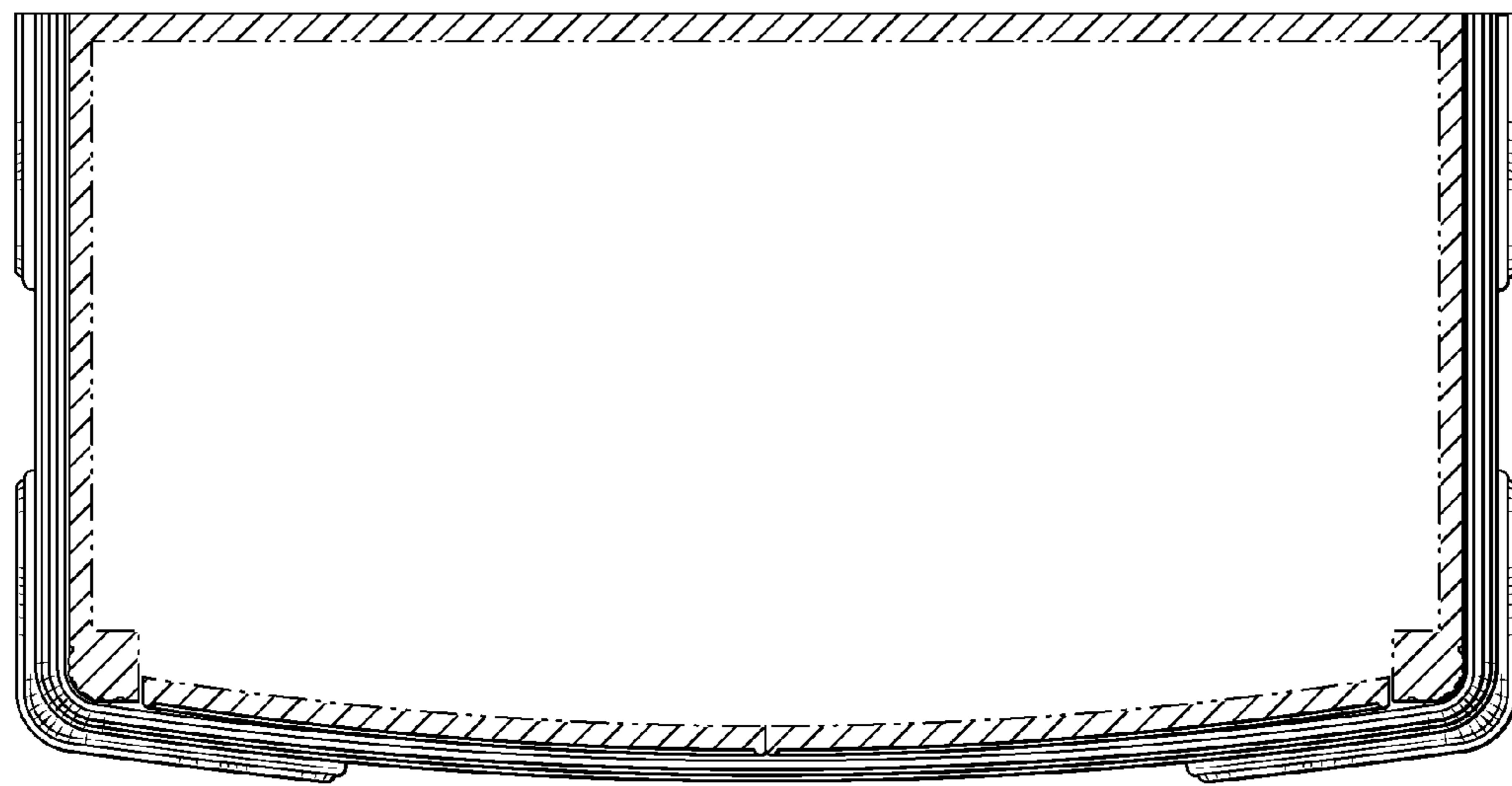

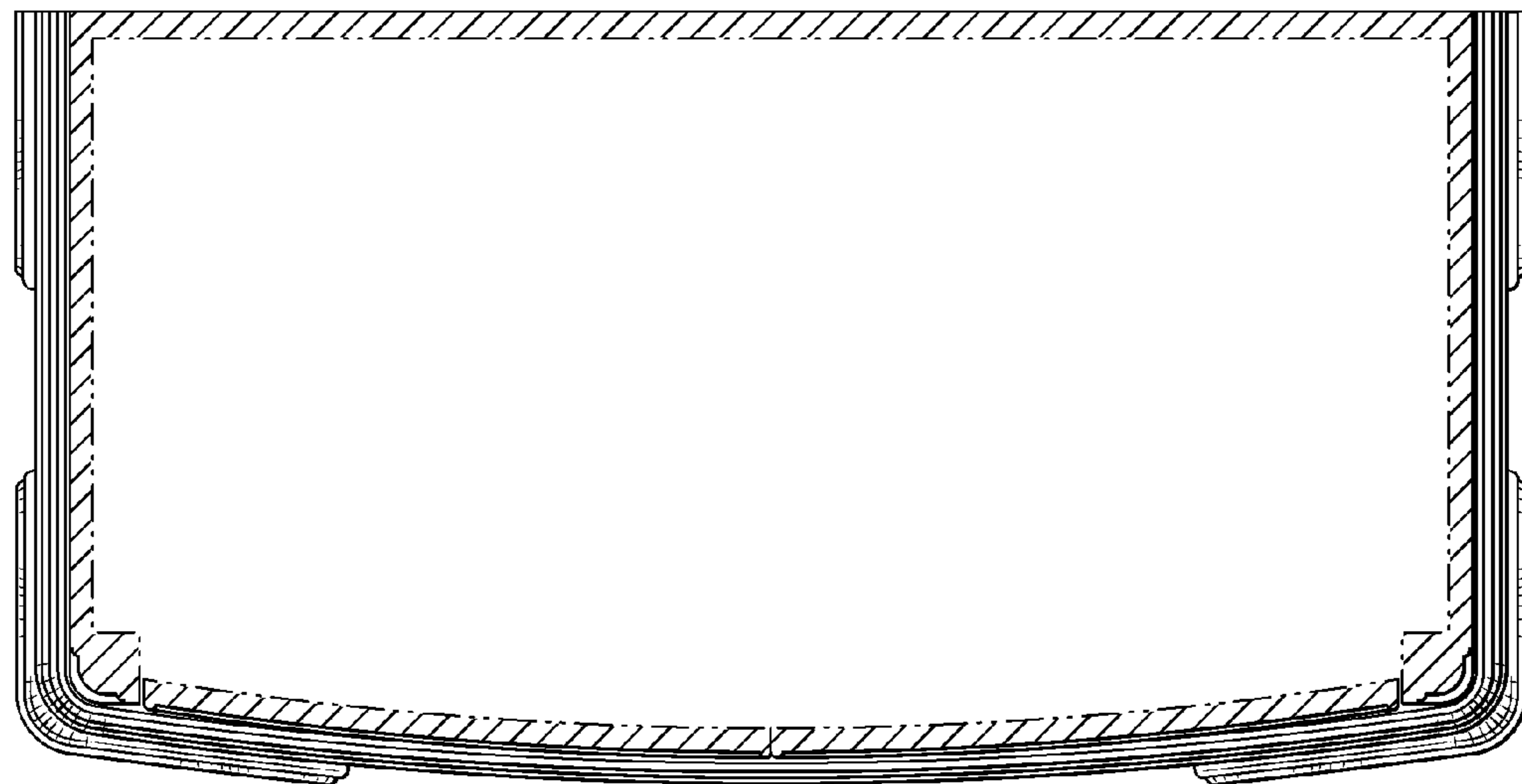

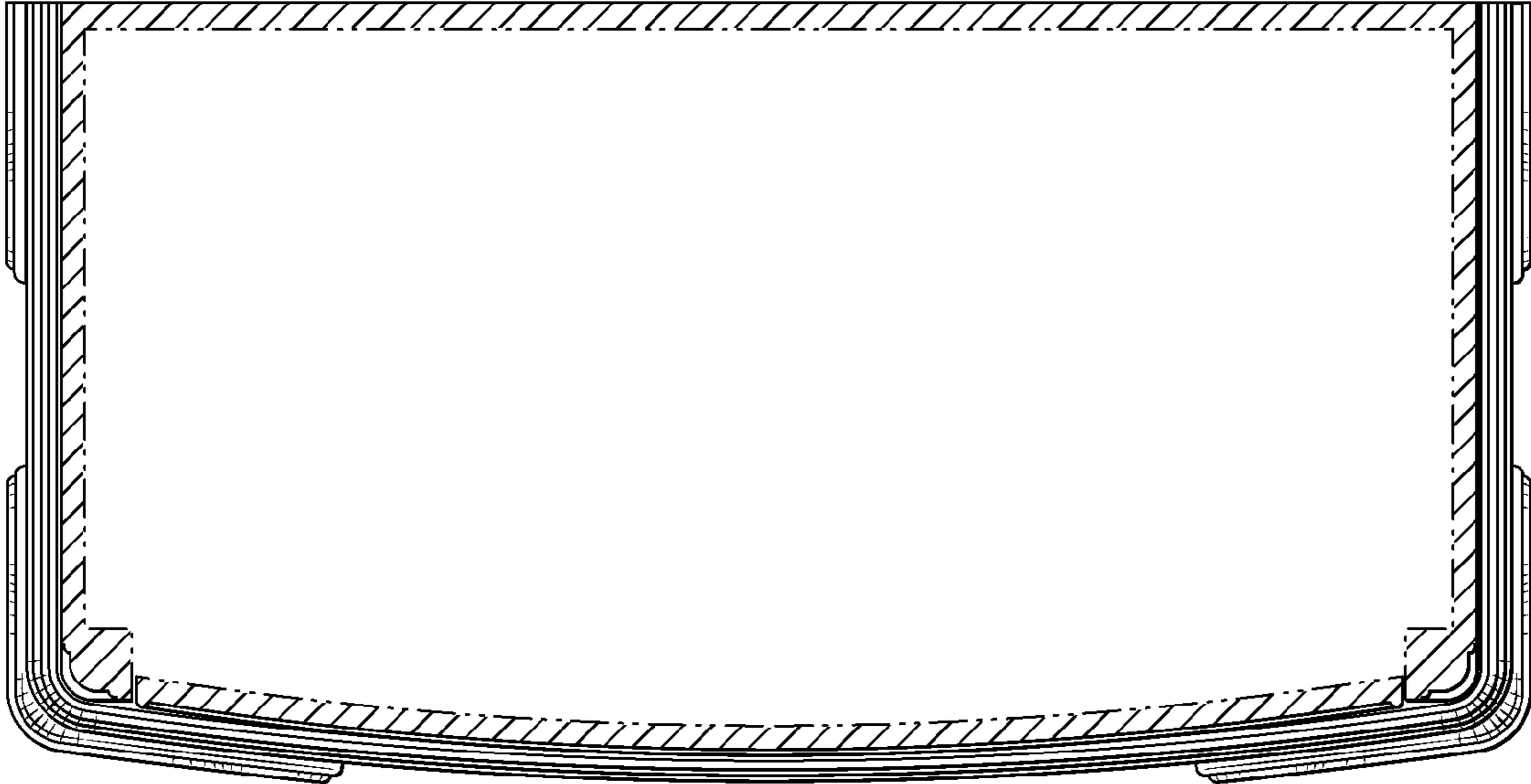

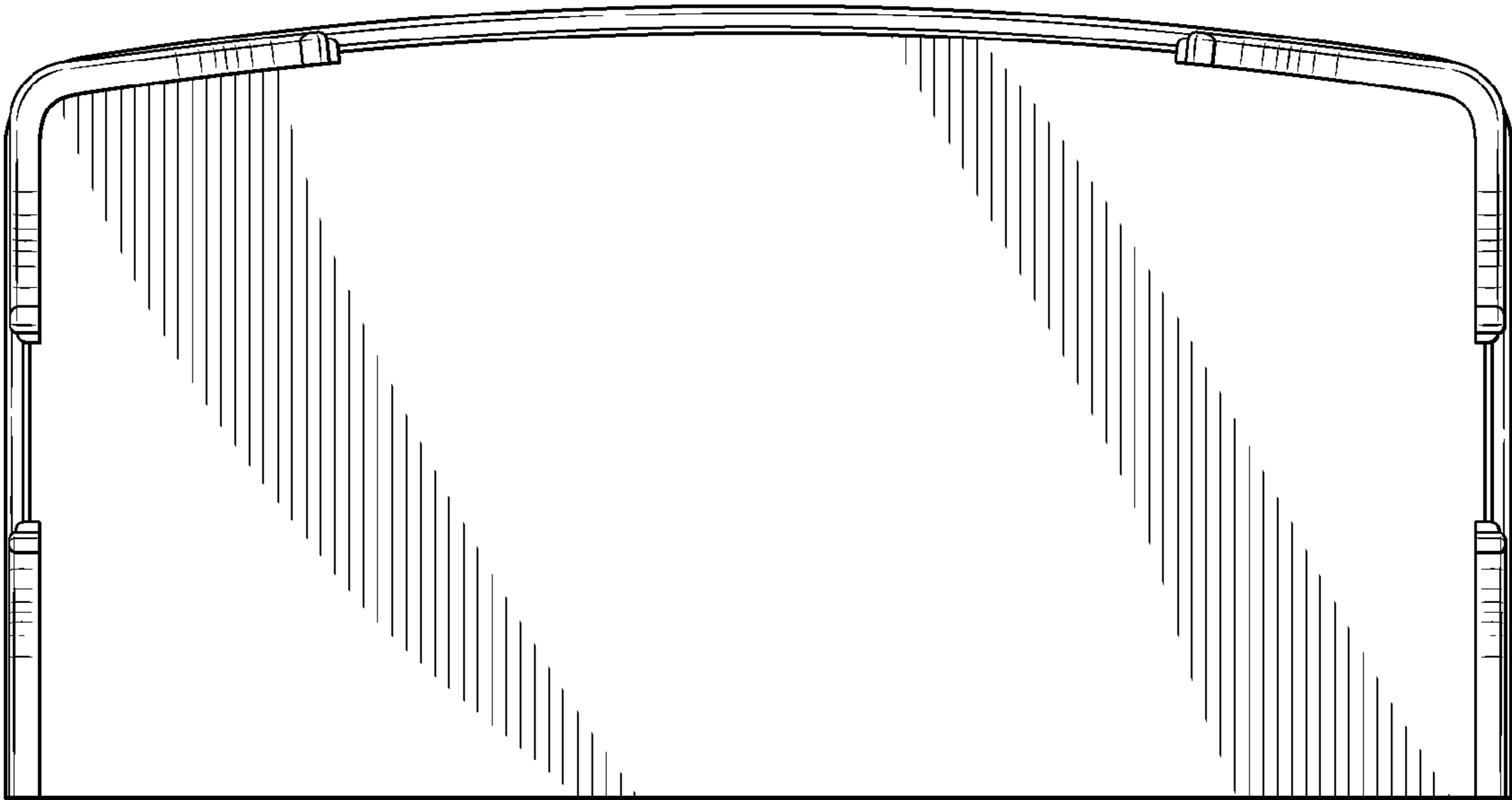

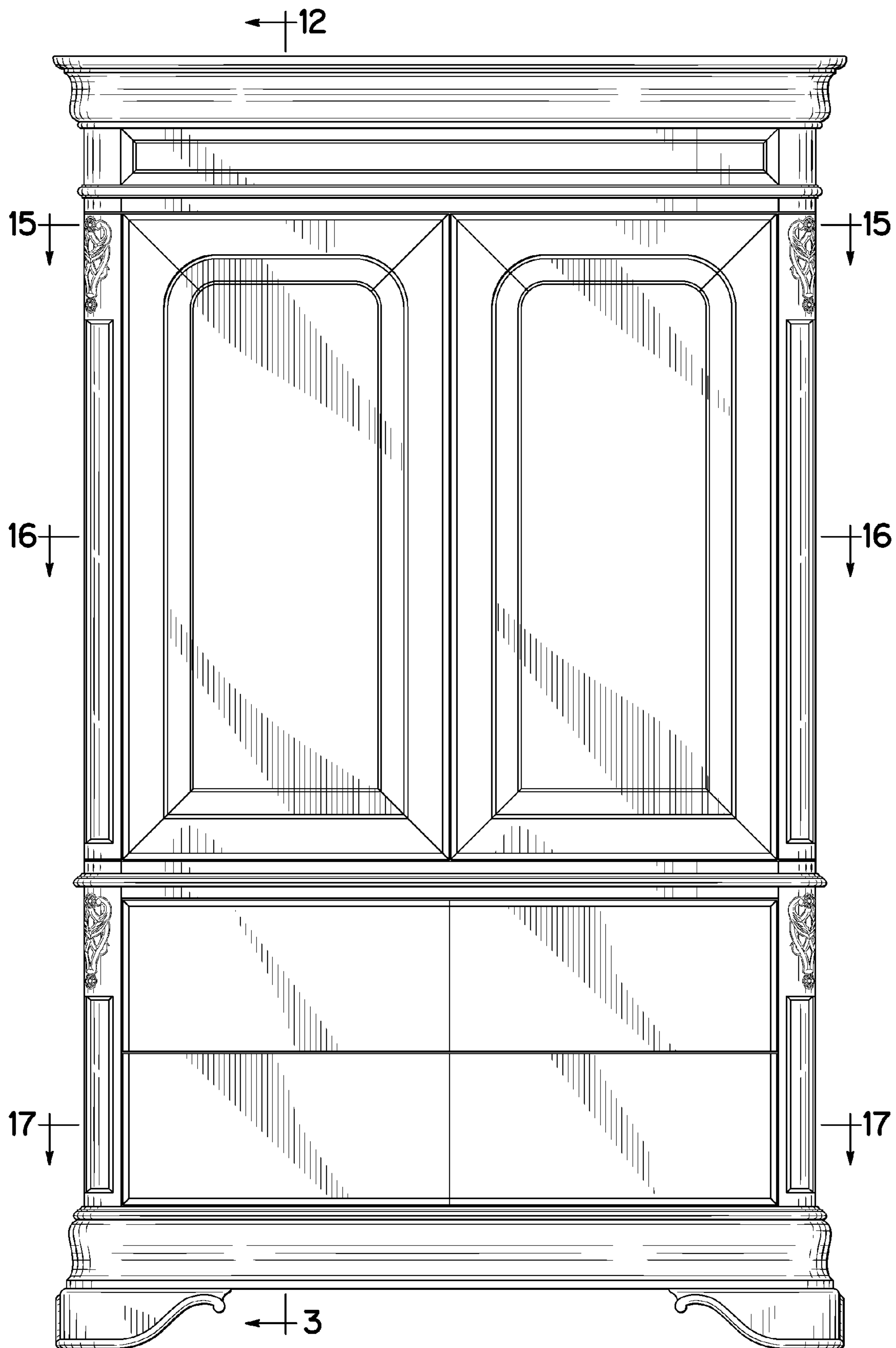

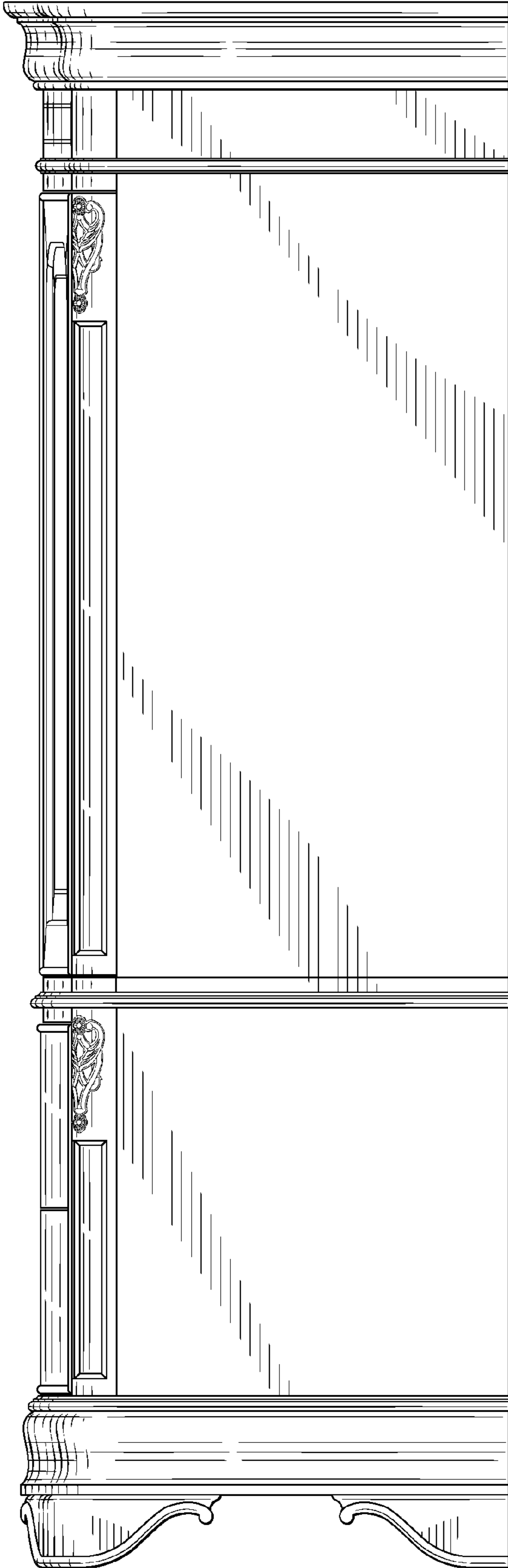

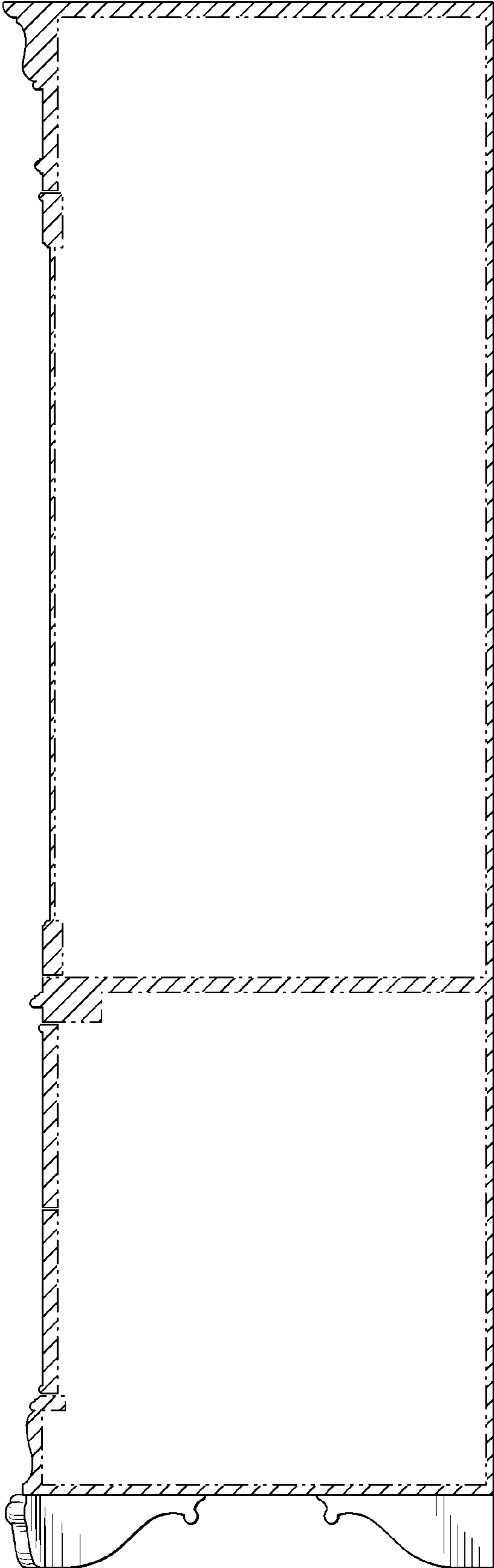

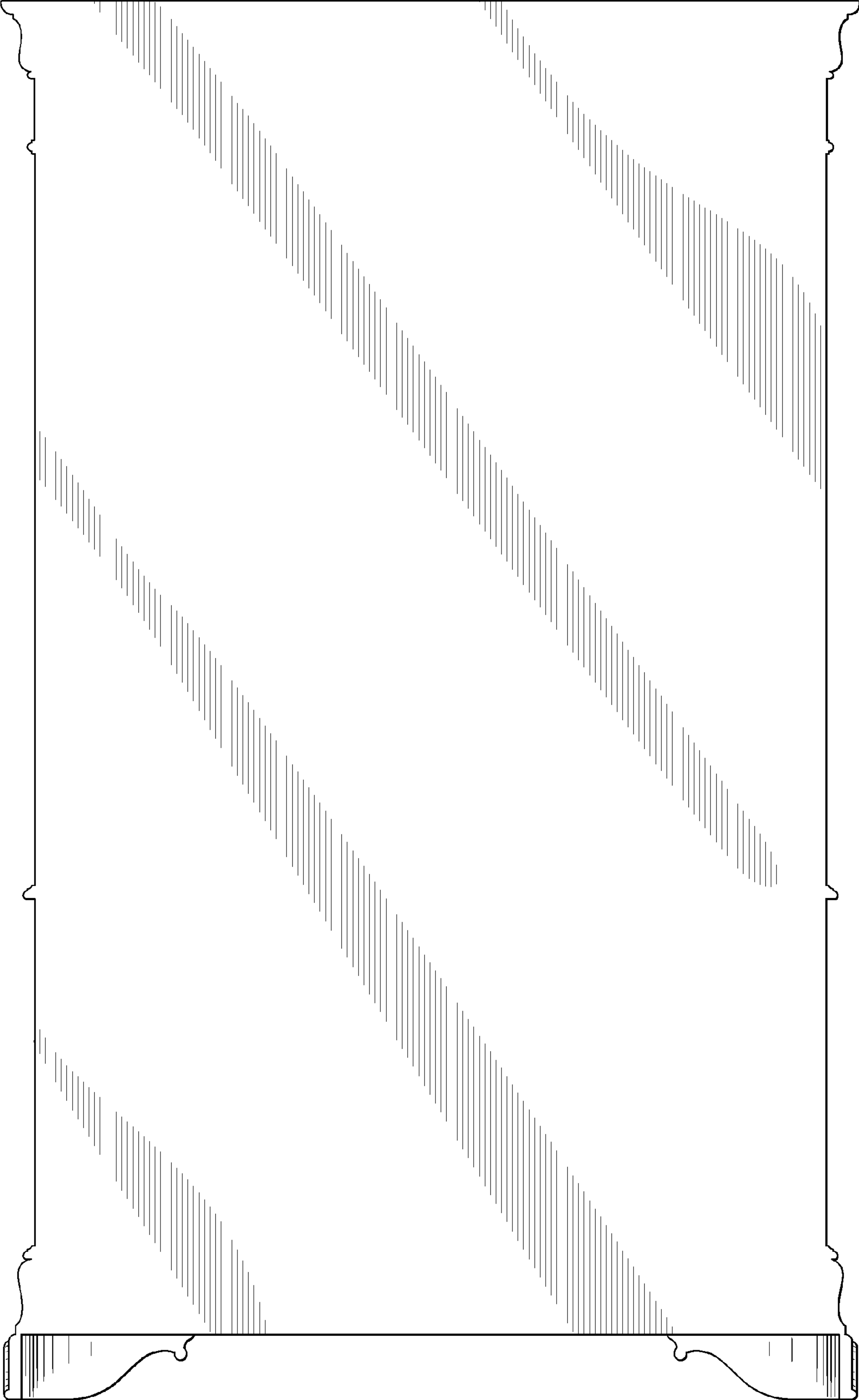

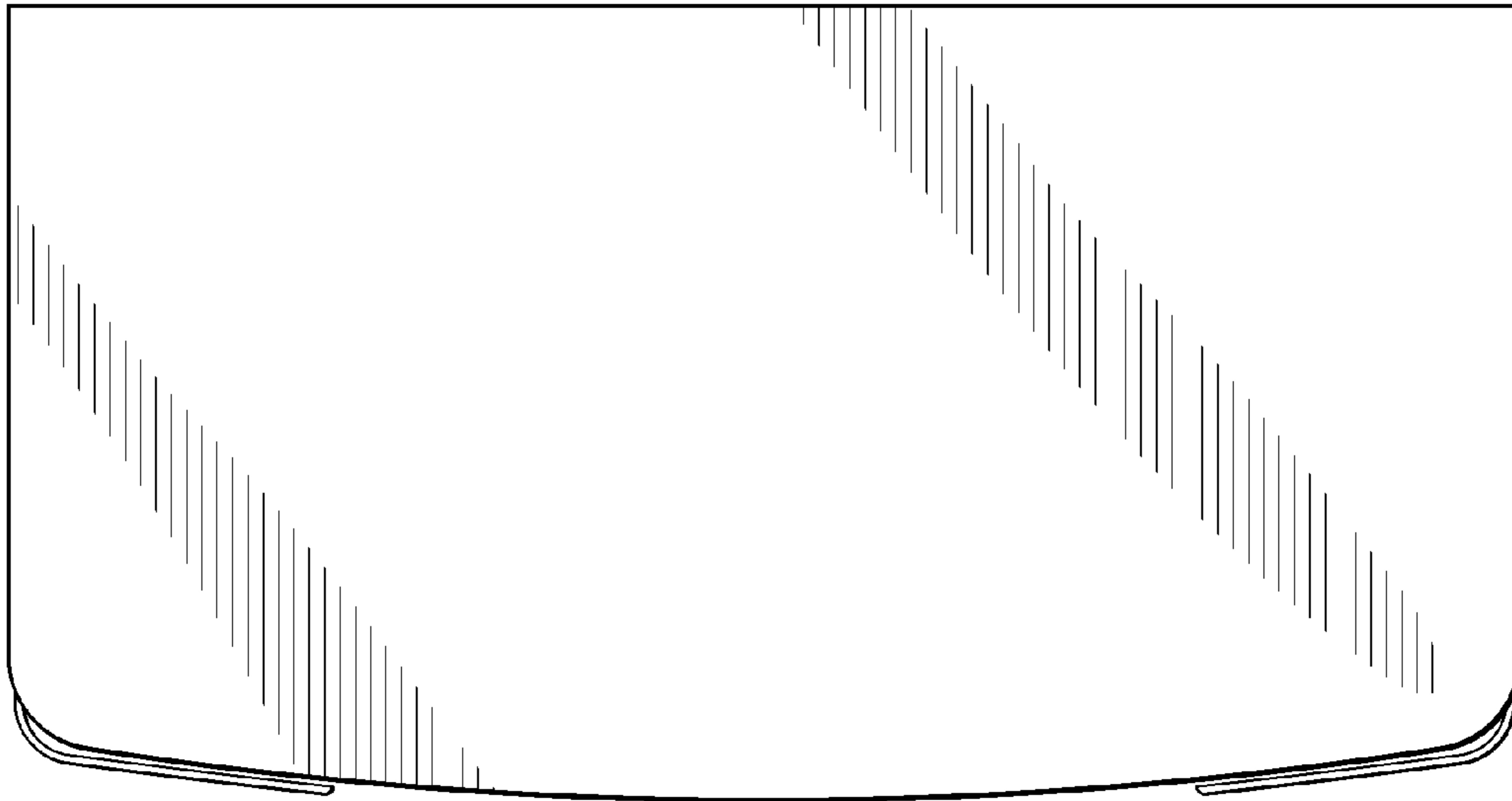

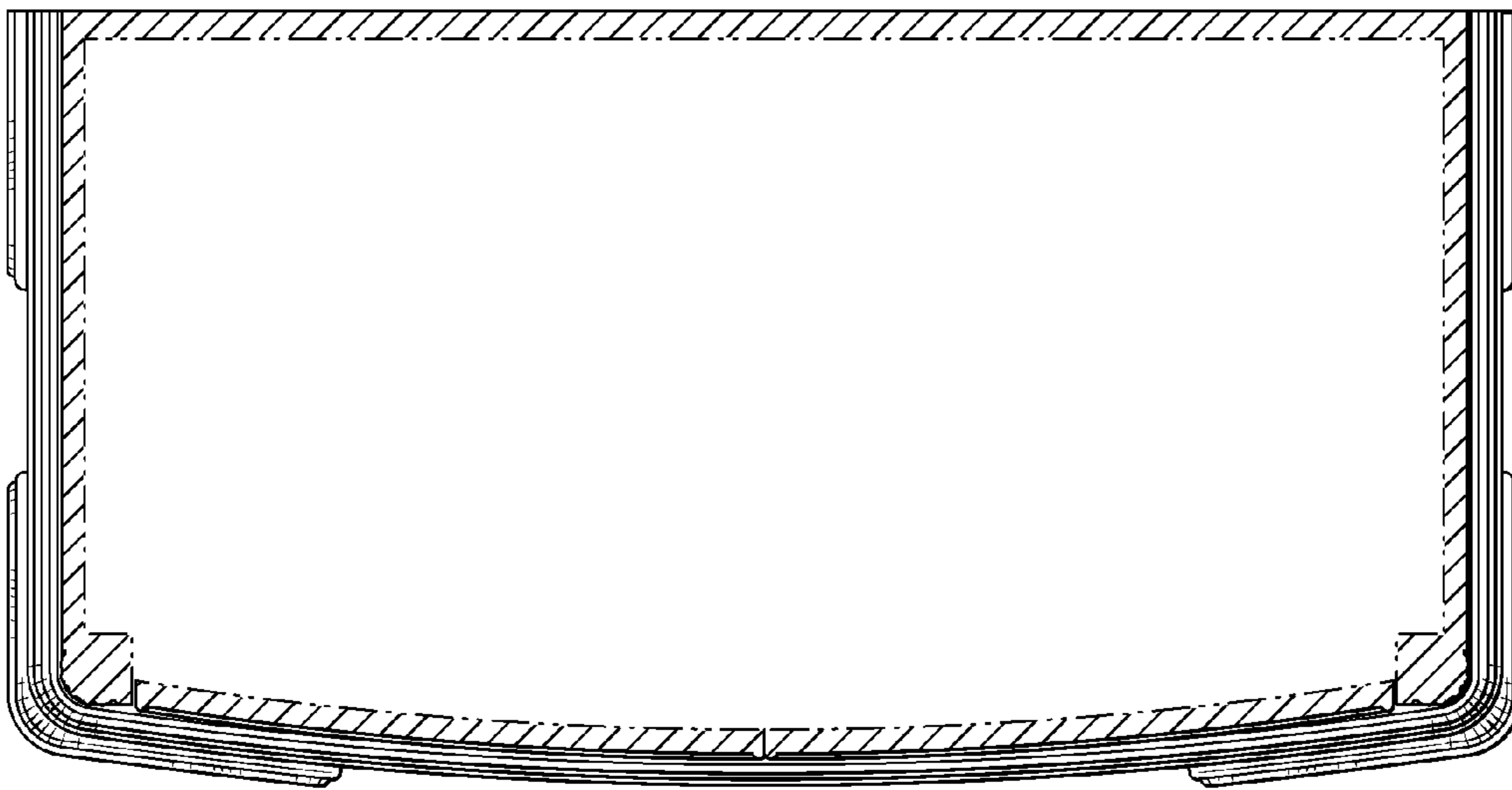

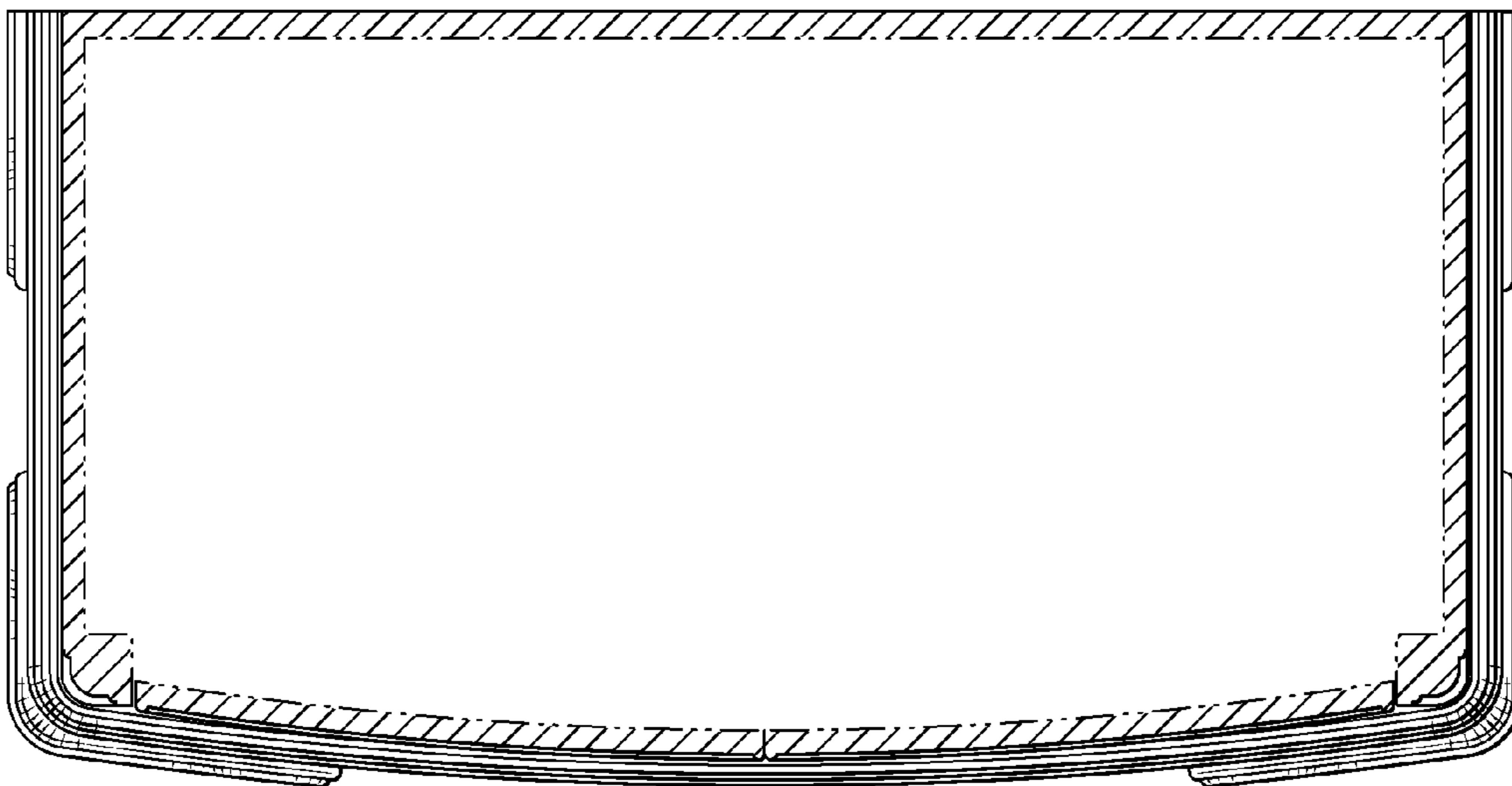

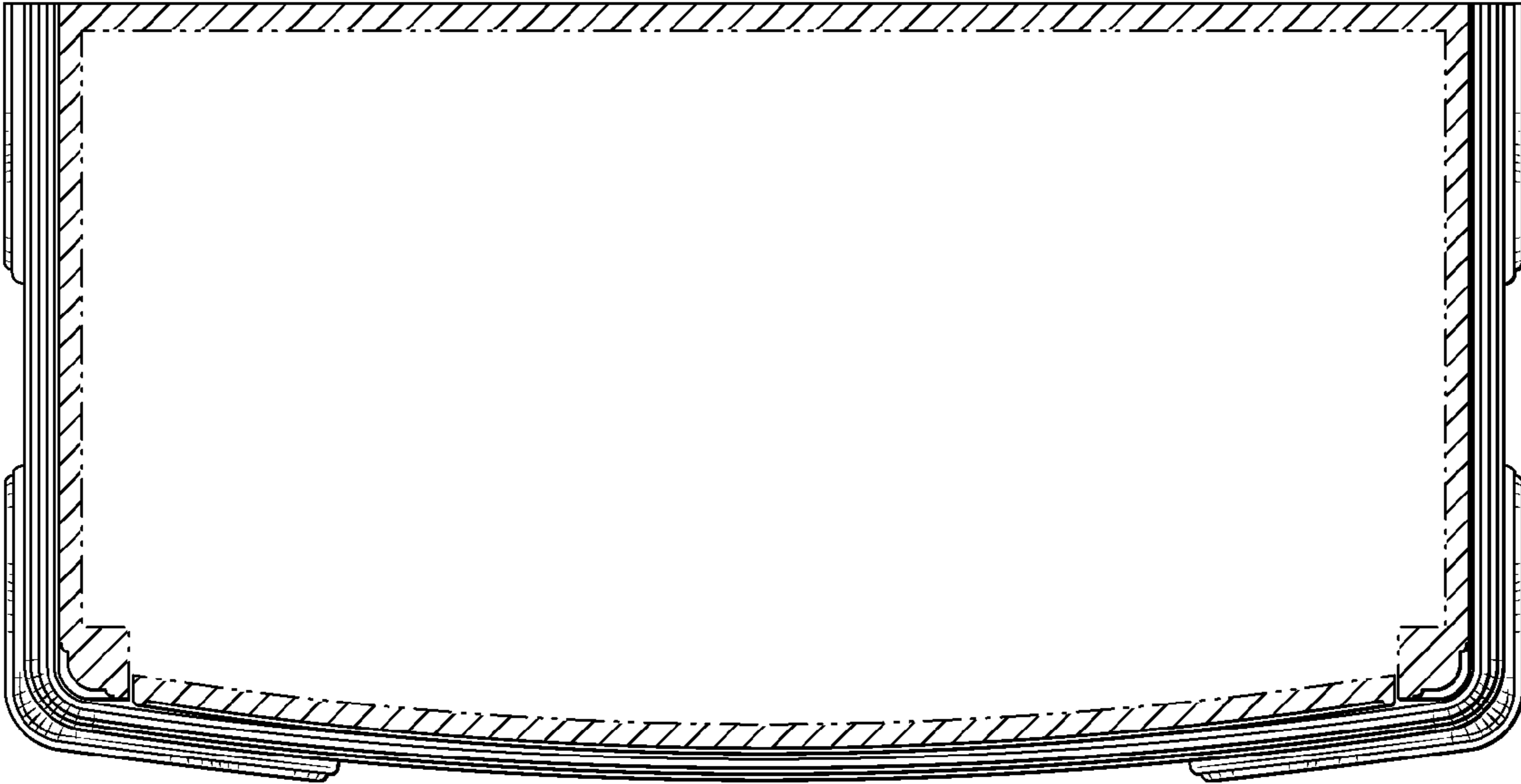

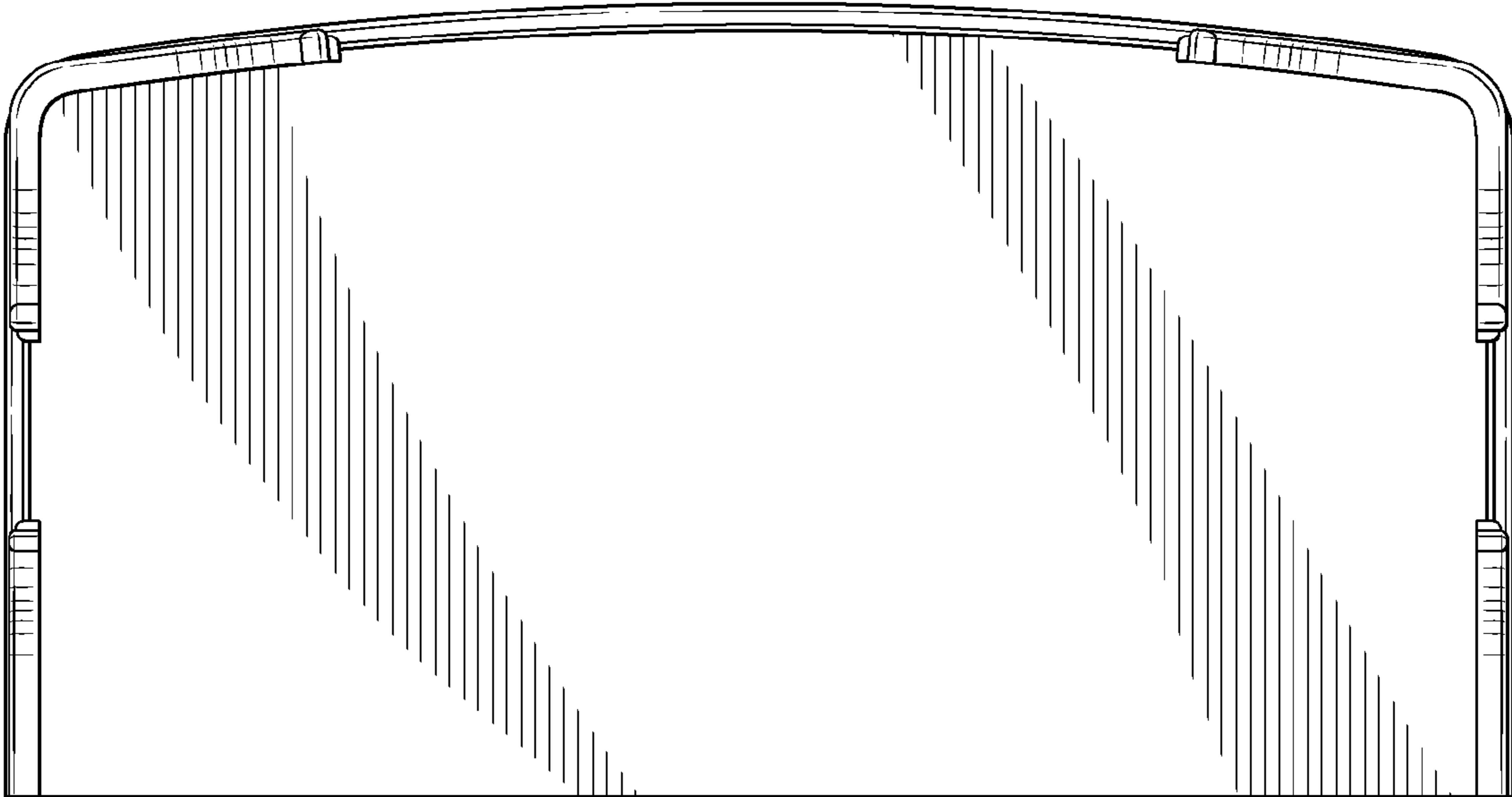
