FIG. 14 is a bottom plan view thereof.

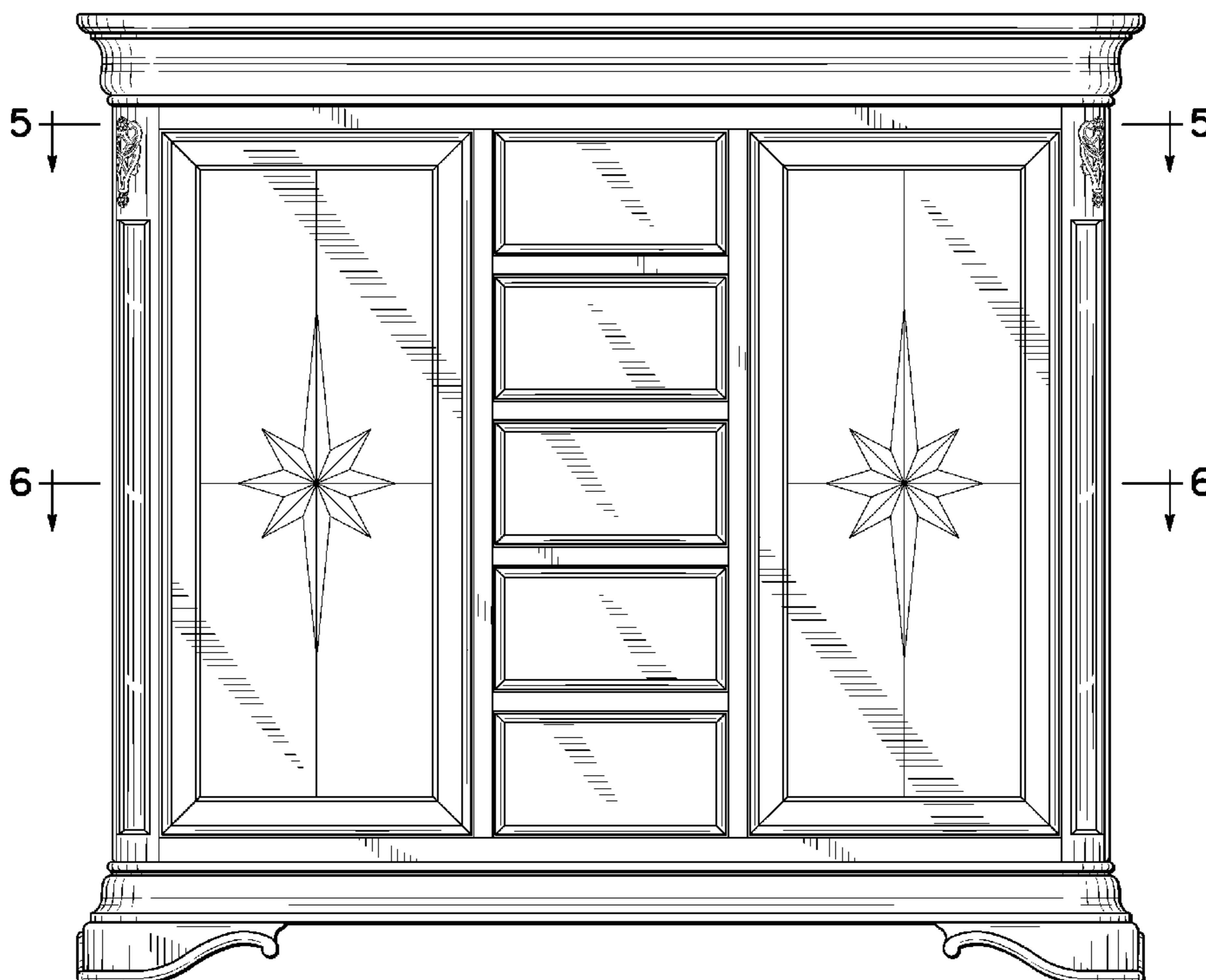

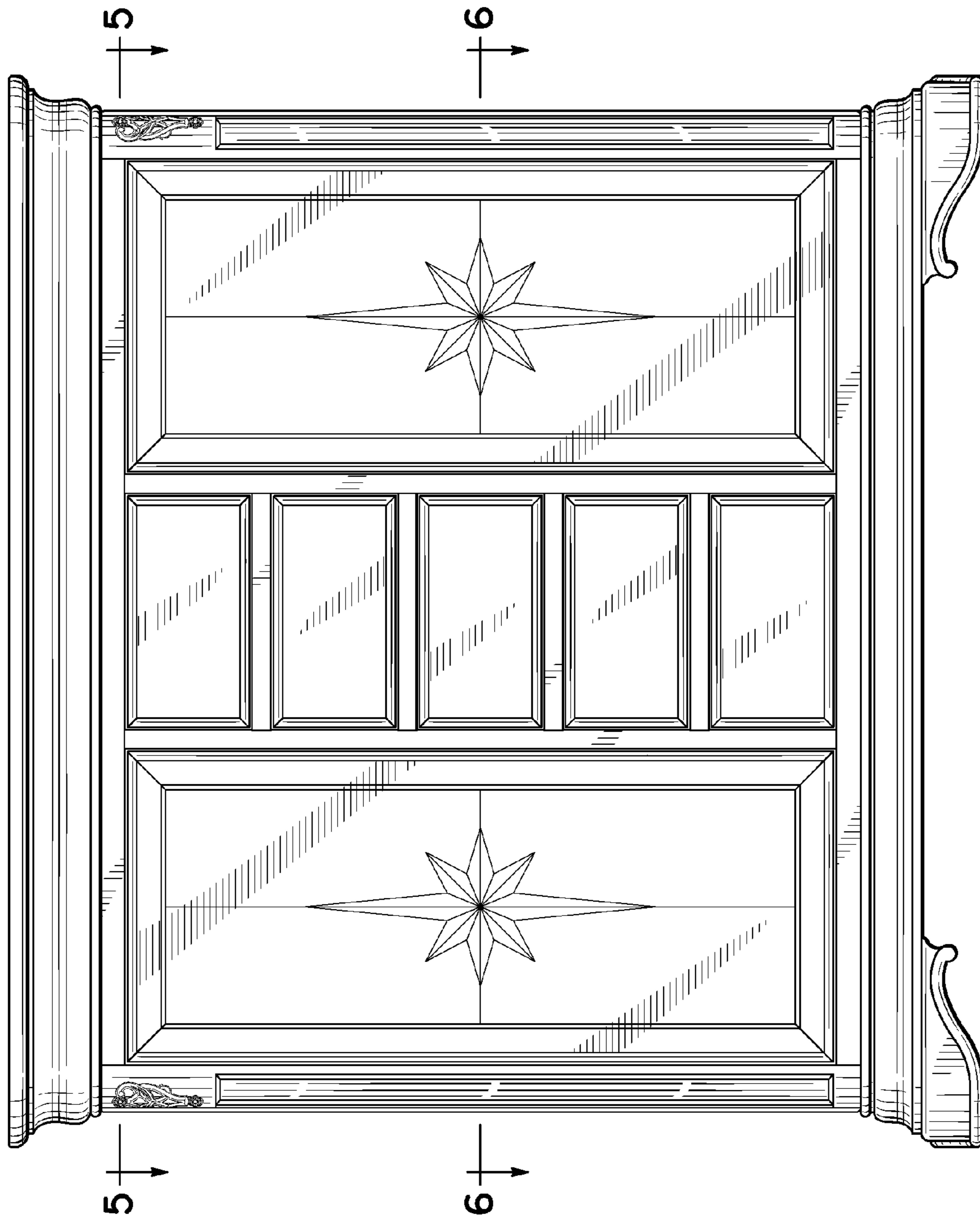

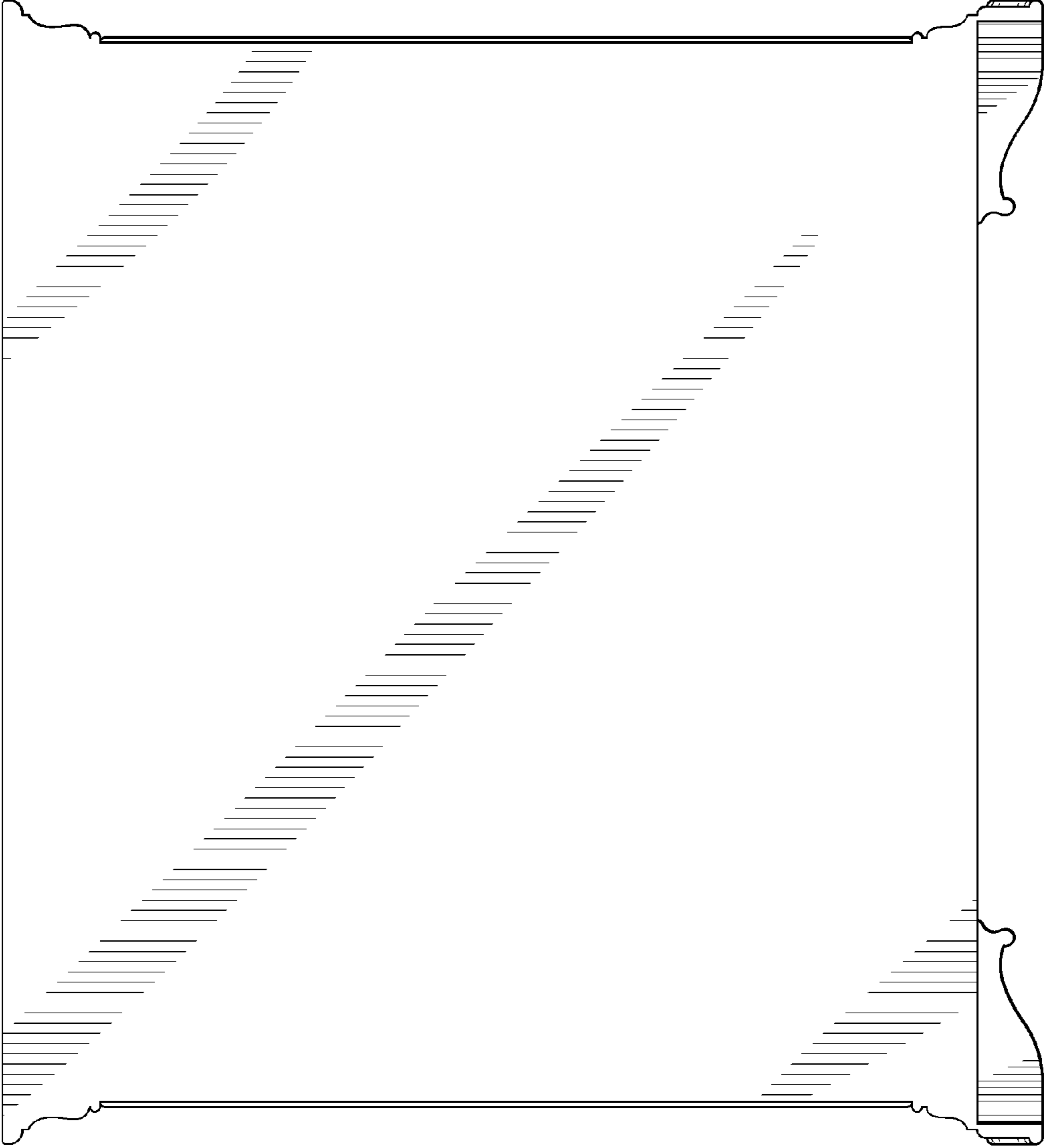

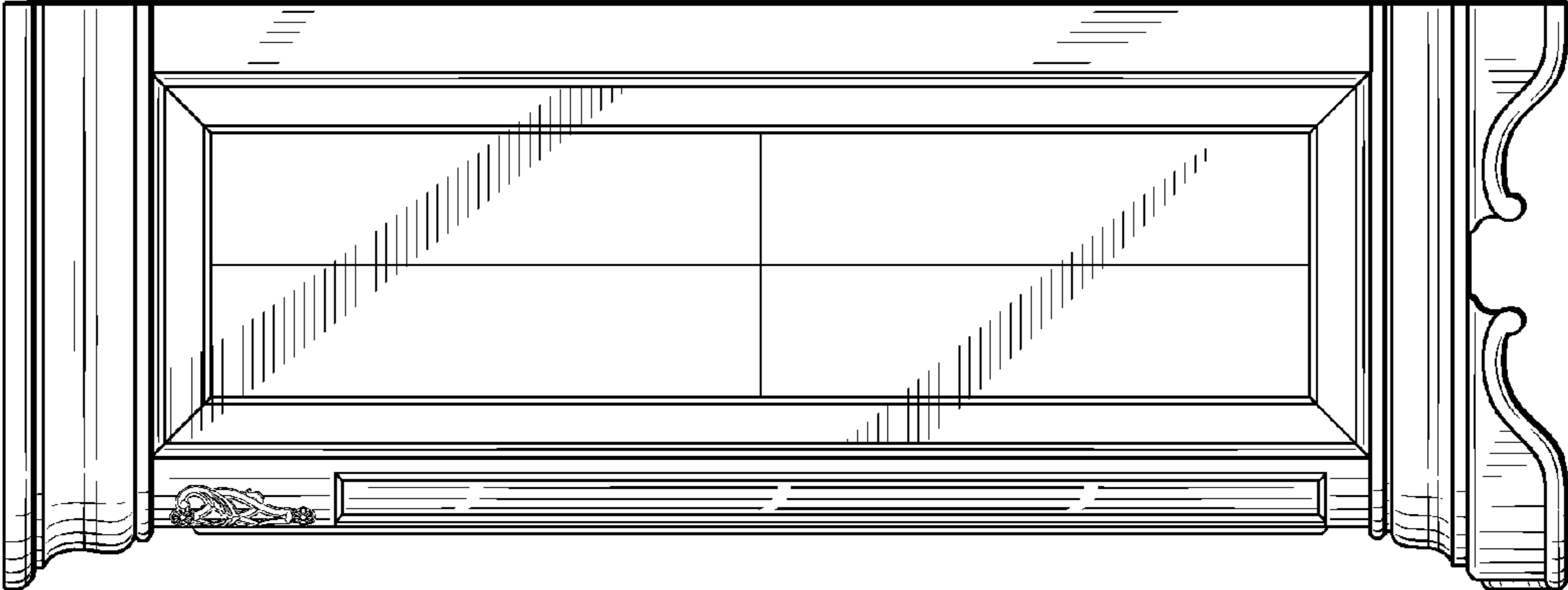

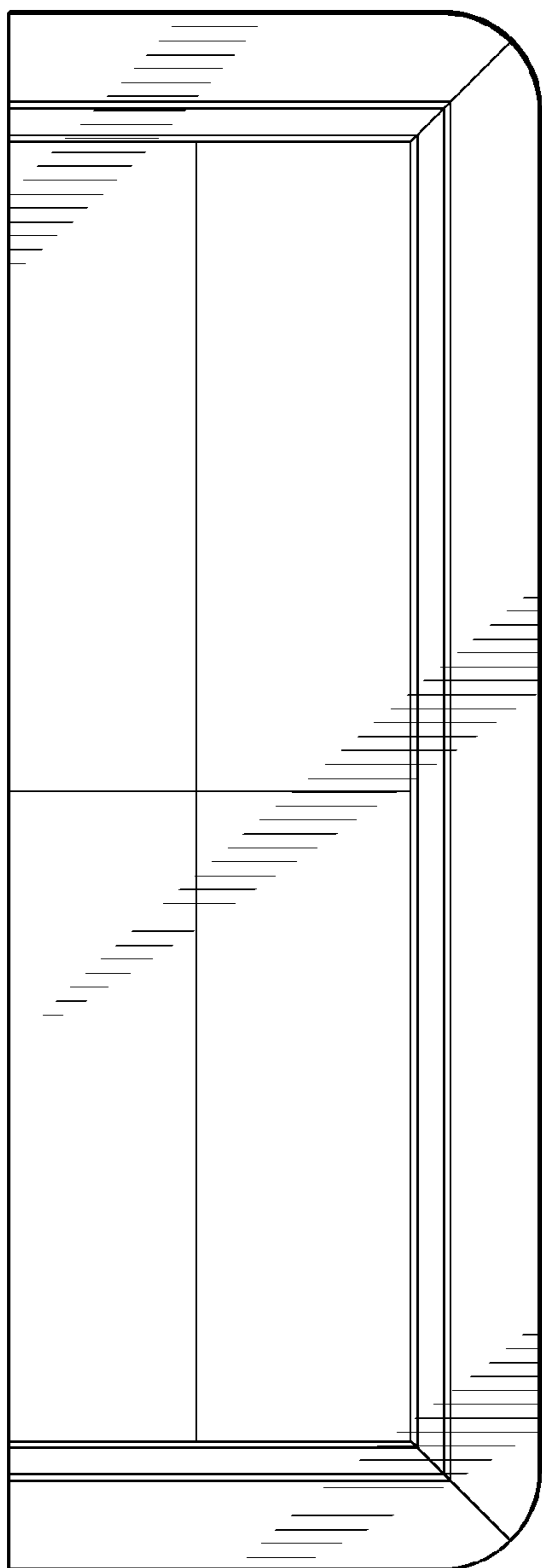

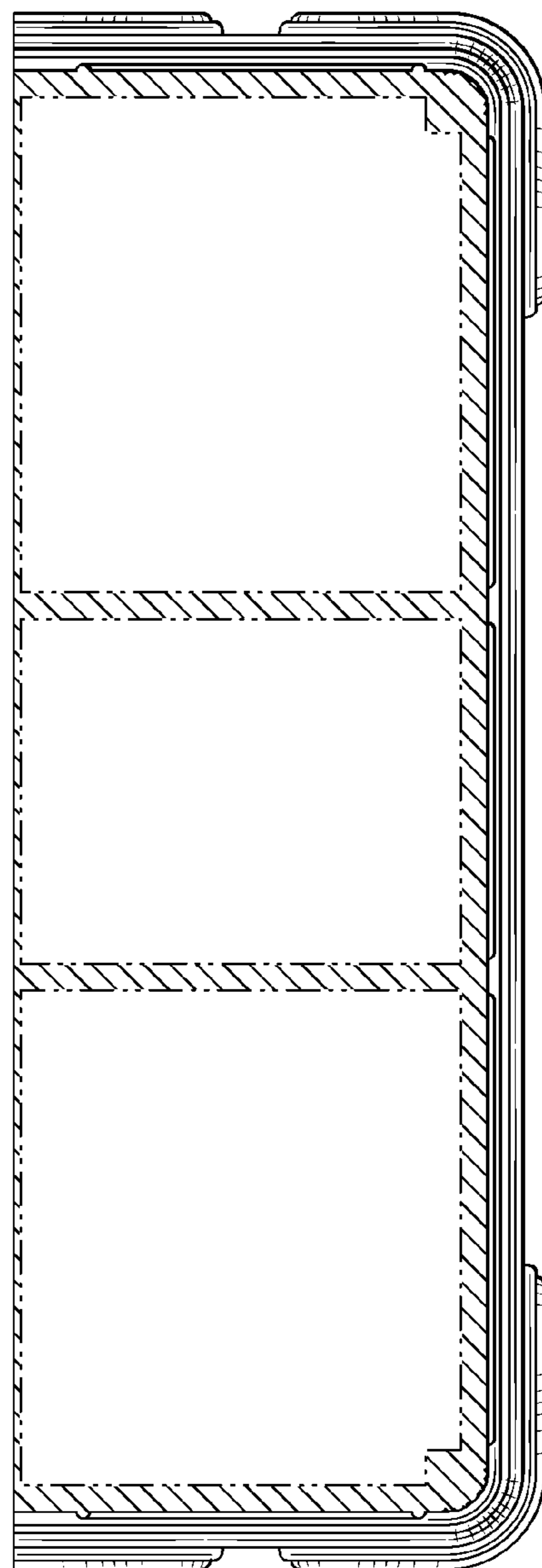

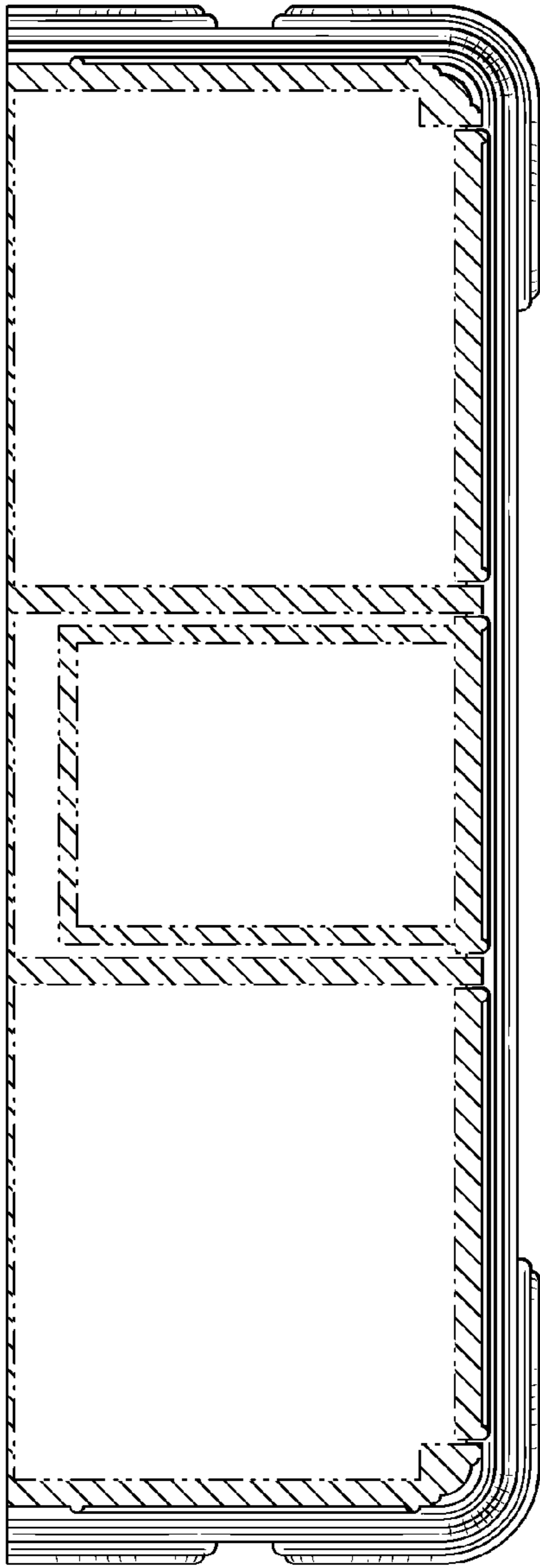

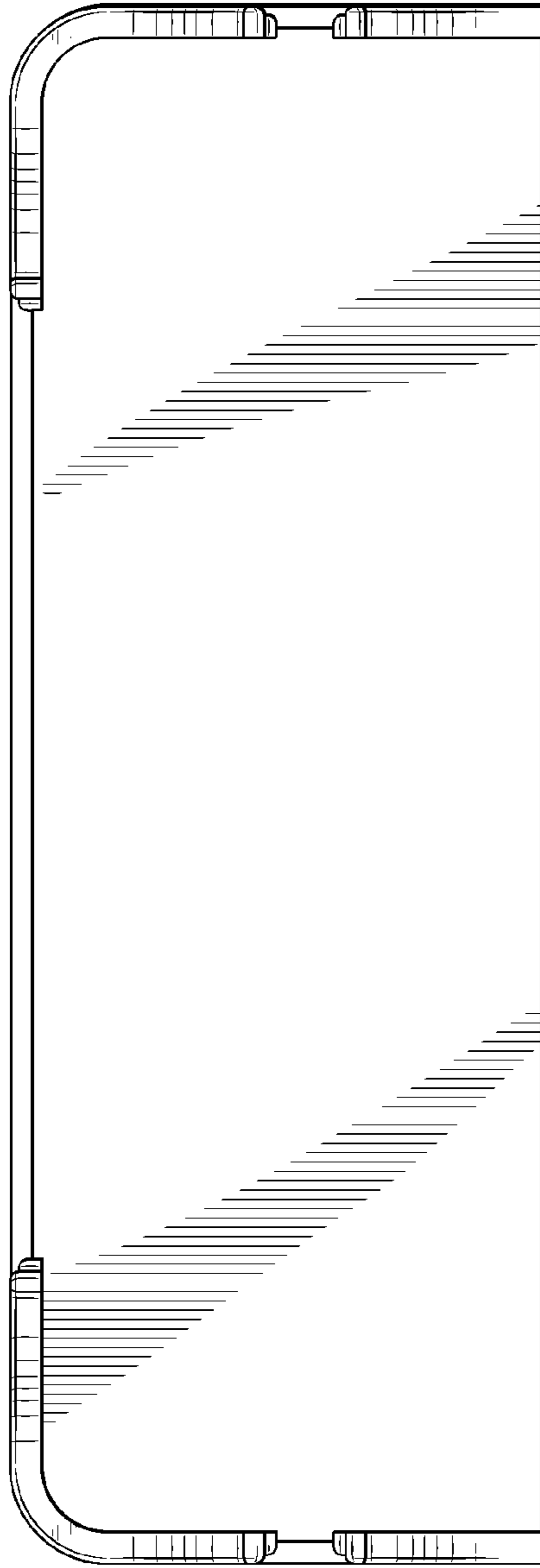

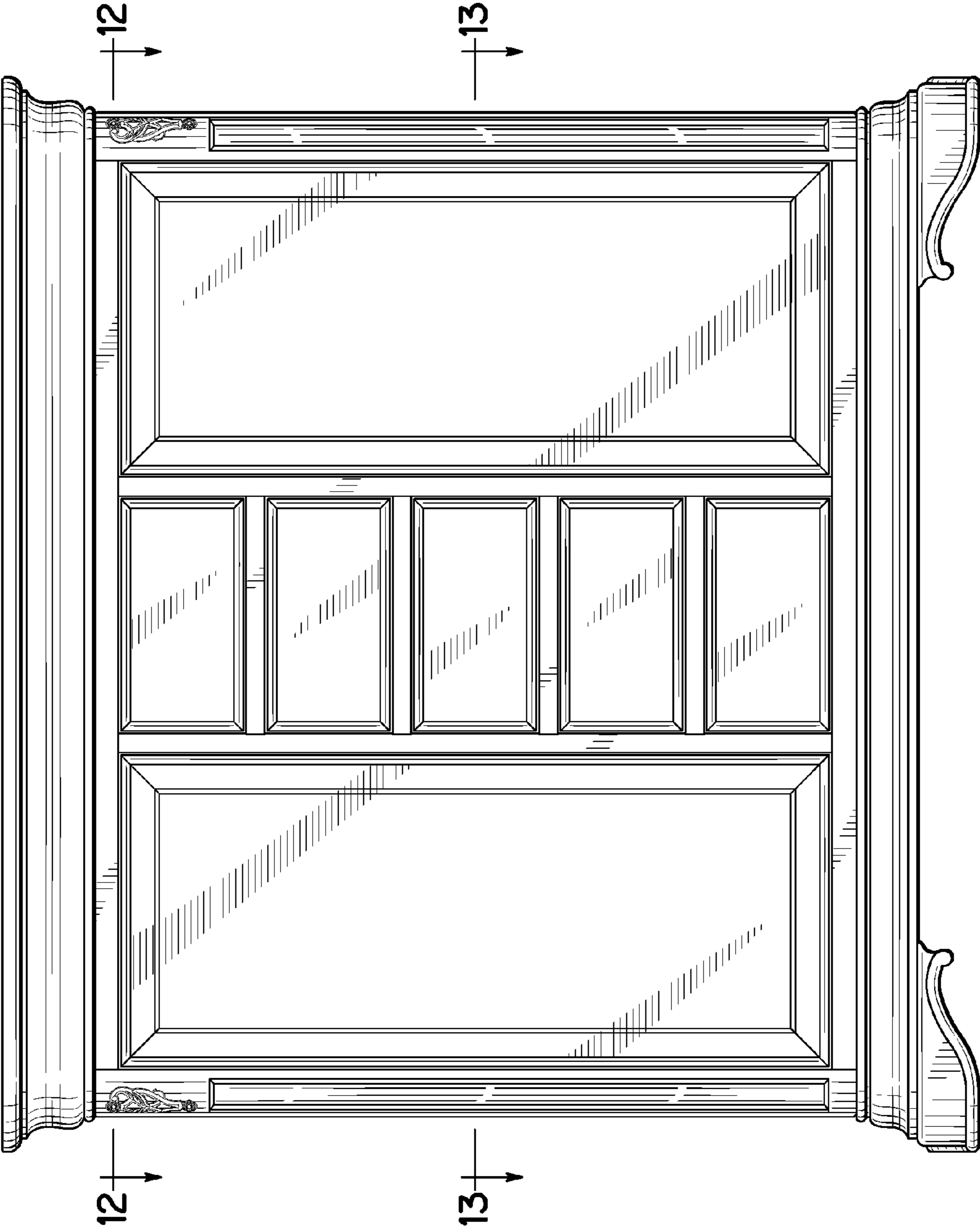

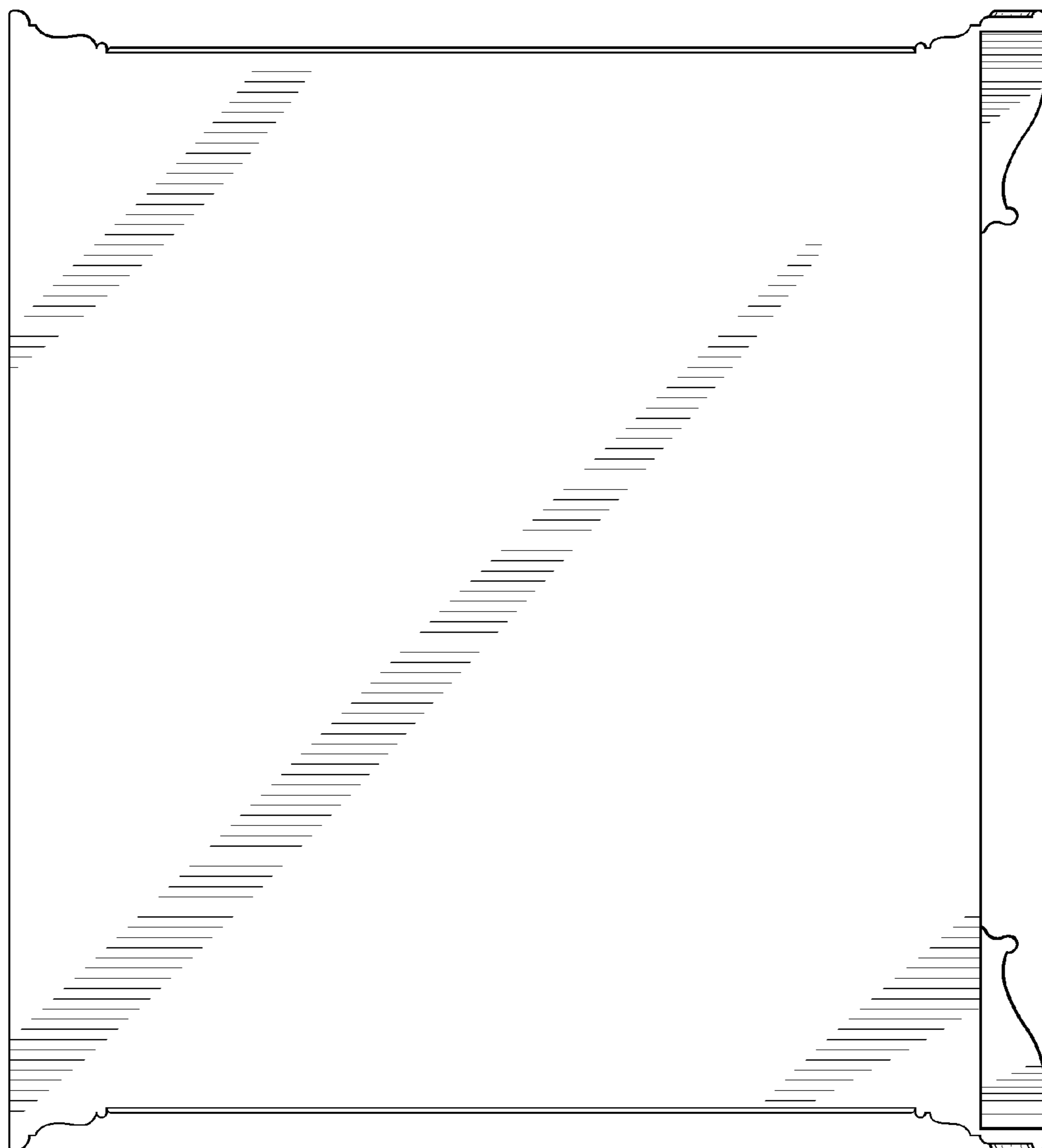

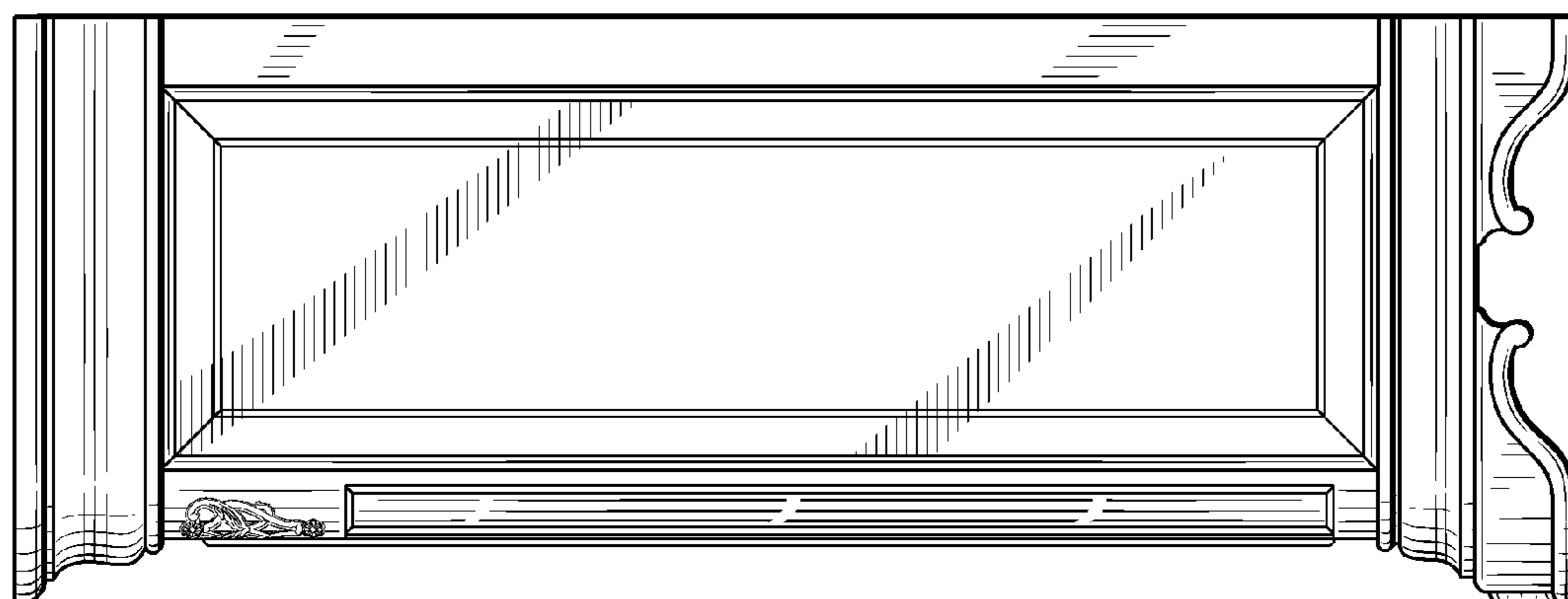

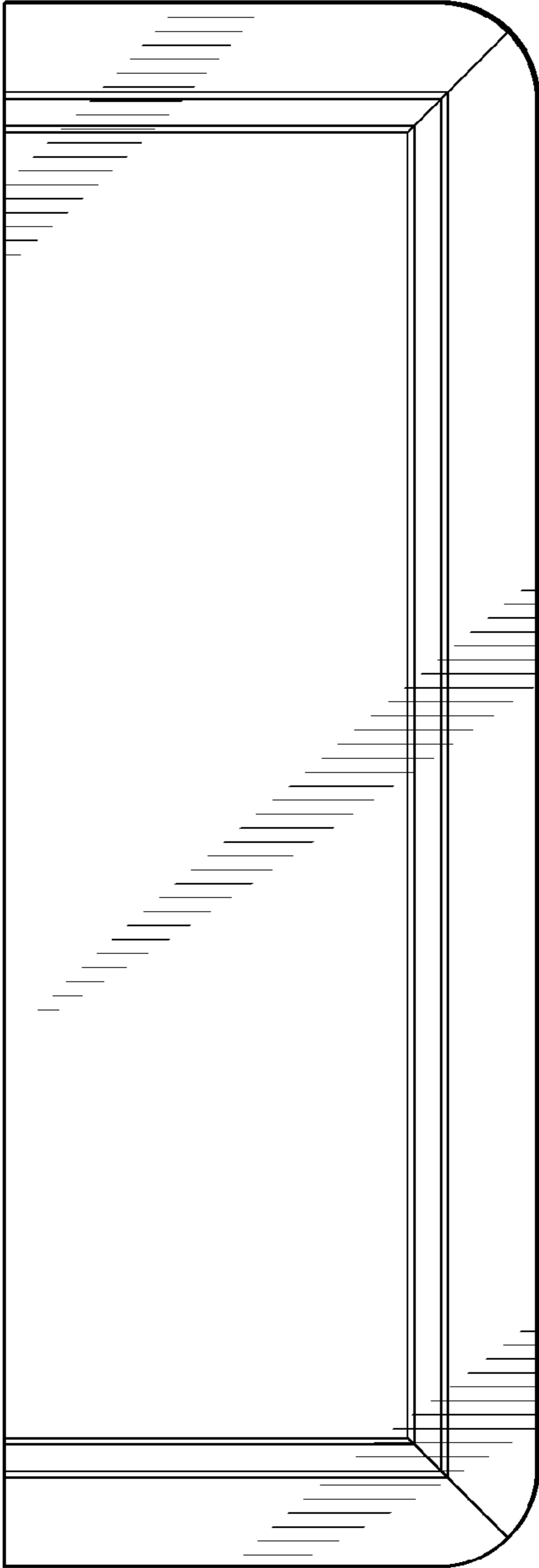

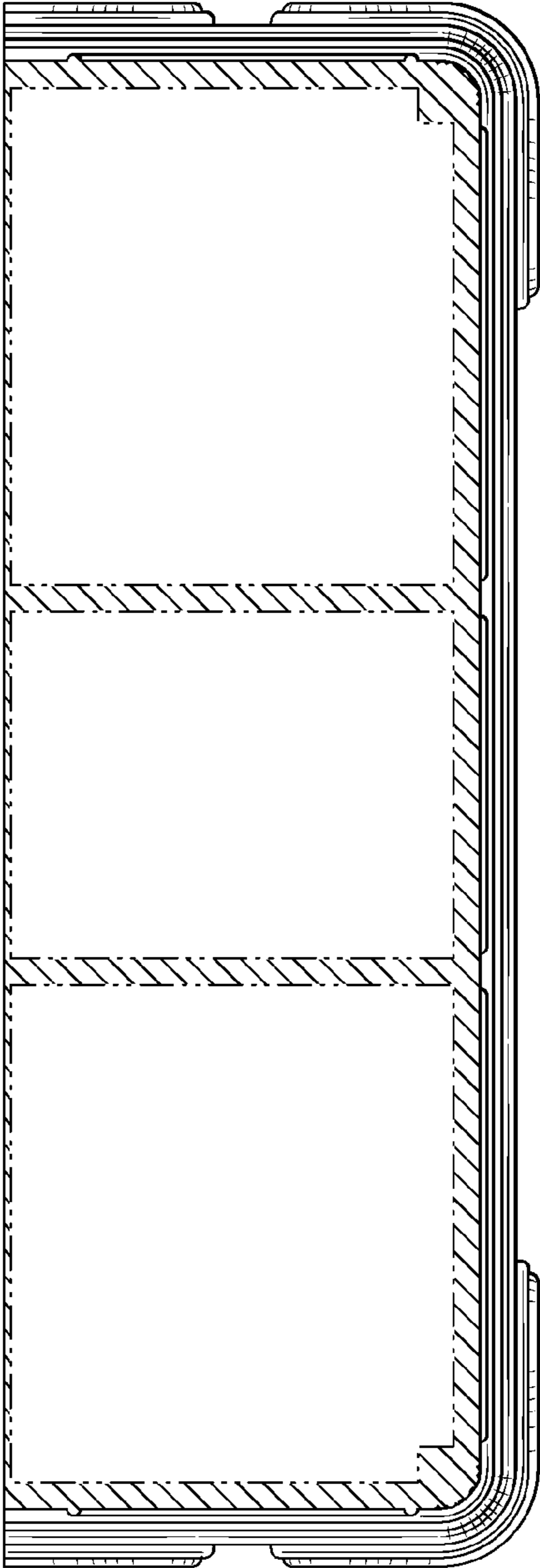

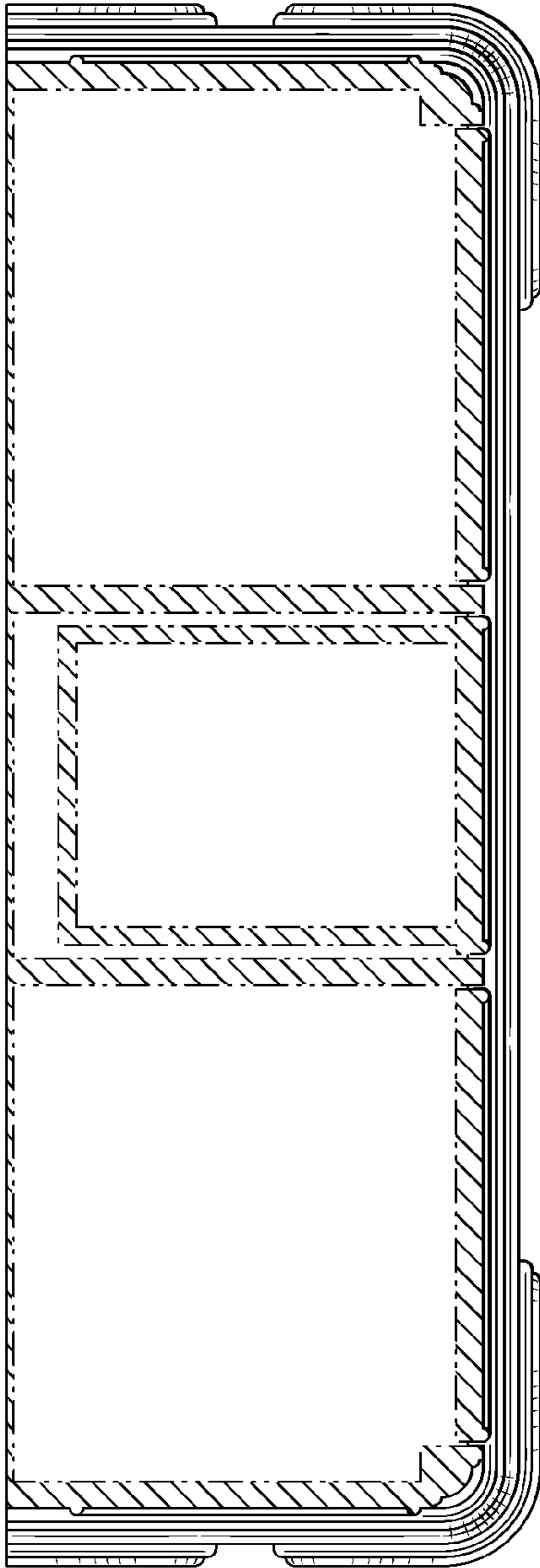
