(57) **CLAIM**

The ornamental design for a decorative piece, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a decorative piece showing my new design;

FIG. 2 is a front view of the decorative piece shown in FIG. 1;

FIG. 3 is a rear view of the decorative piece shown in FIG. 1;

FIG. 4 is a right side view of the decorative piece shown in FIG. 1;

FIG. 5 is a left side view of the decorative piece shown in FIG. 1;

FIG. 6 is a top view of the decorative piece shown in FIG. 1;

FIG. 7 is a bottom view of the decorative piece shown in FIG. 1; and,

FIG. 8 is a front perspective view of the decorative piece shown in FIG. 1, shown in the environment of a handbag;

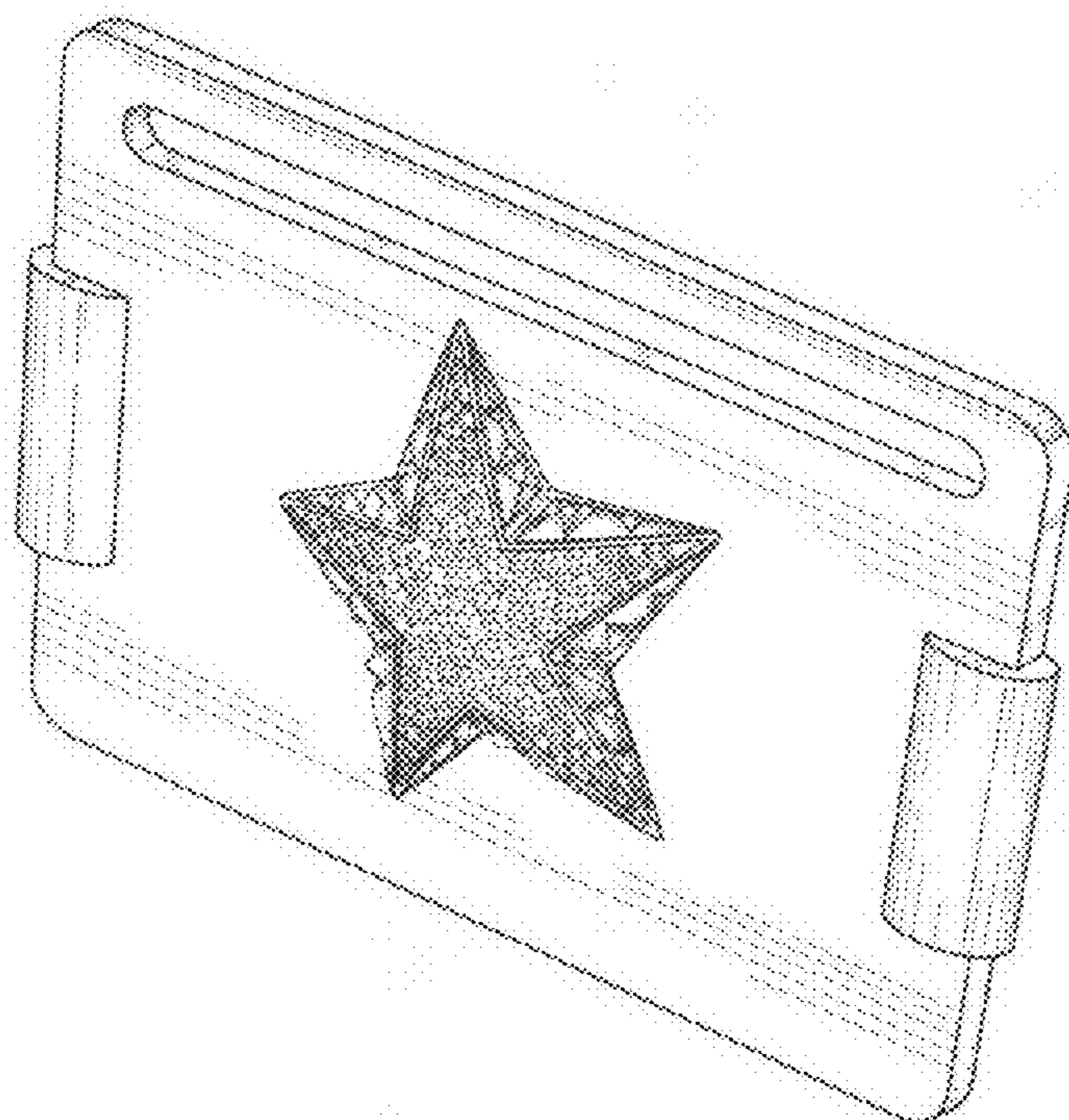

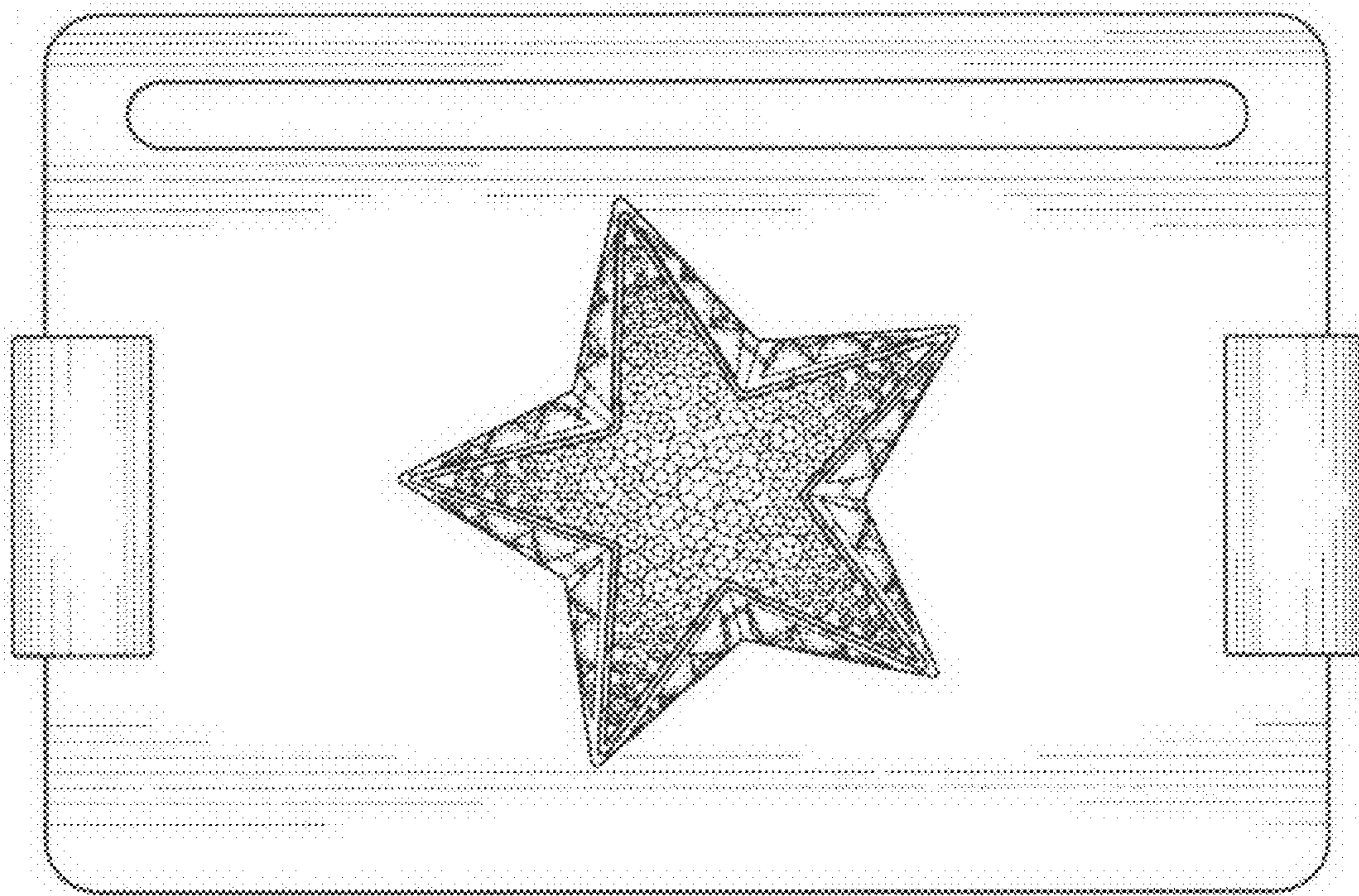

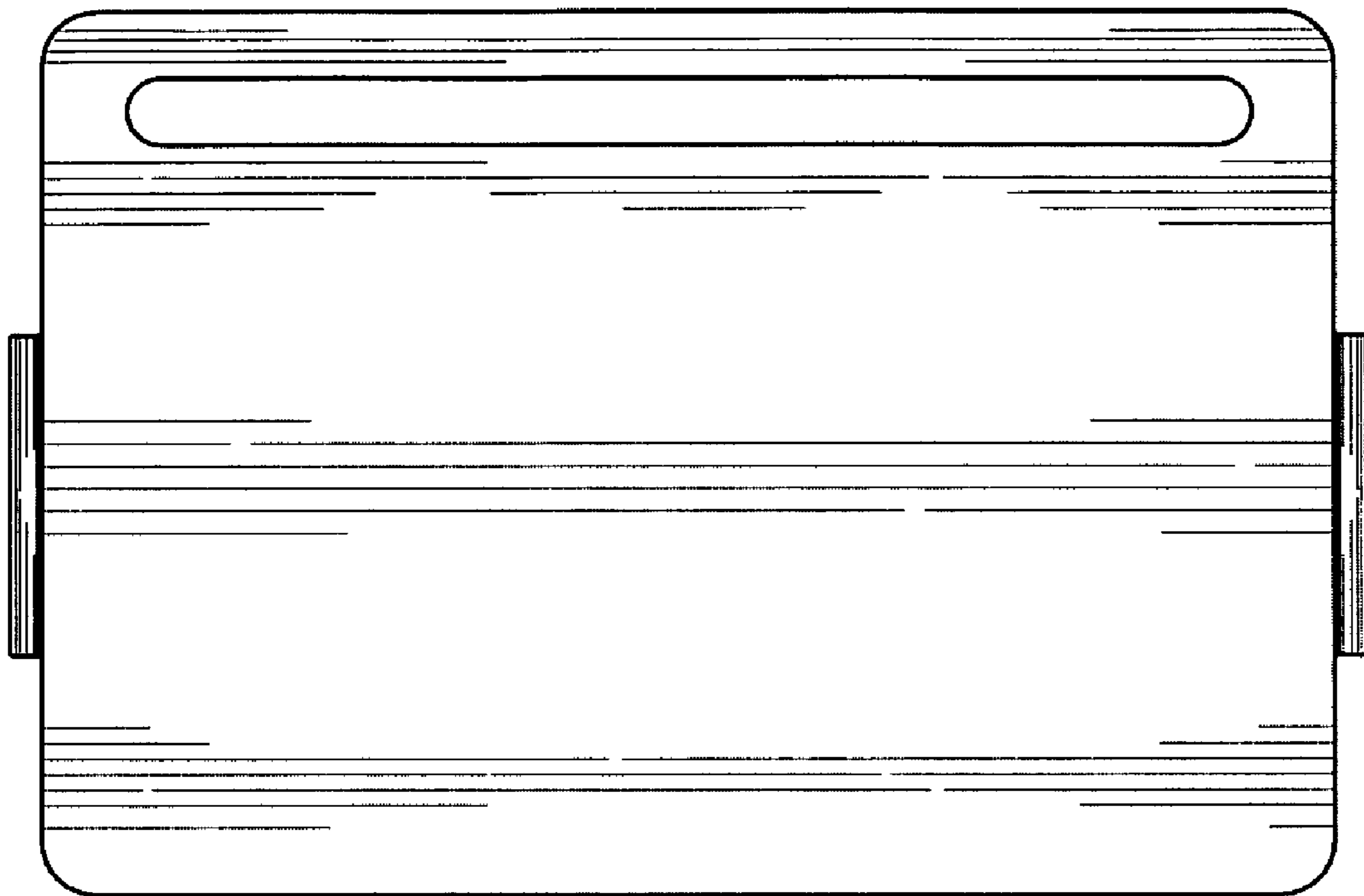

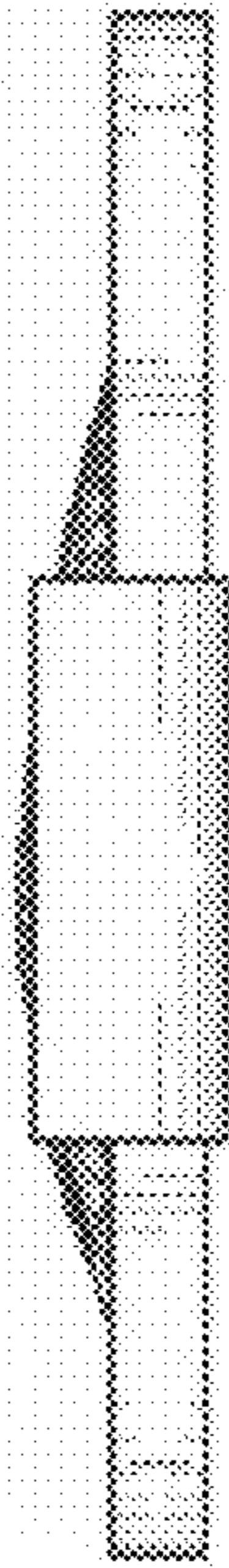

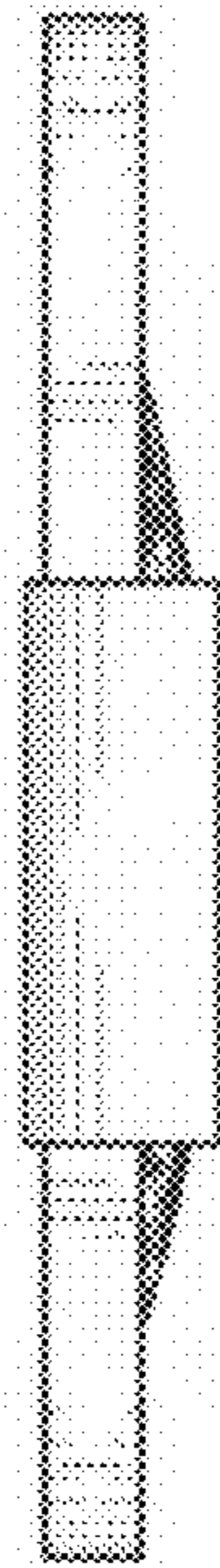
