**DESCRIPTION**

FIG. 1 is a perspective view of a flask showing my new design;

FIG. 2 is a front elevational view, with the rear elevational view being identical thereto;

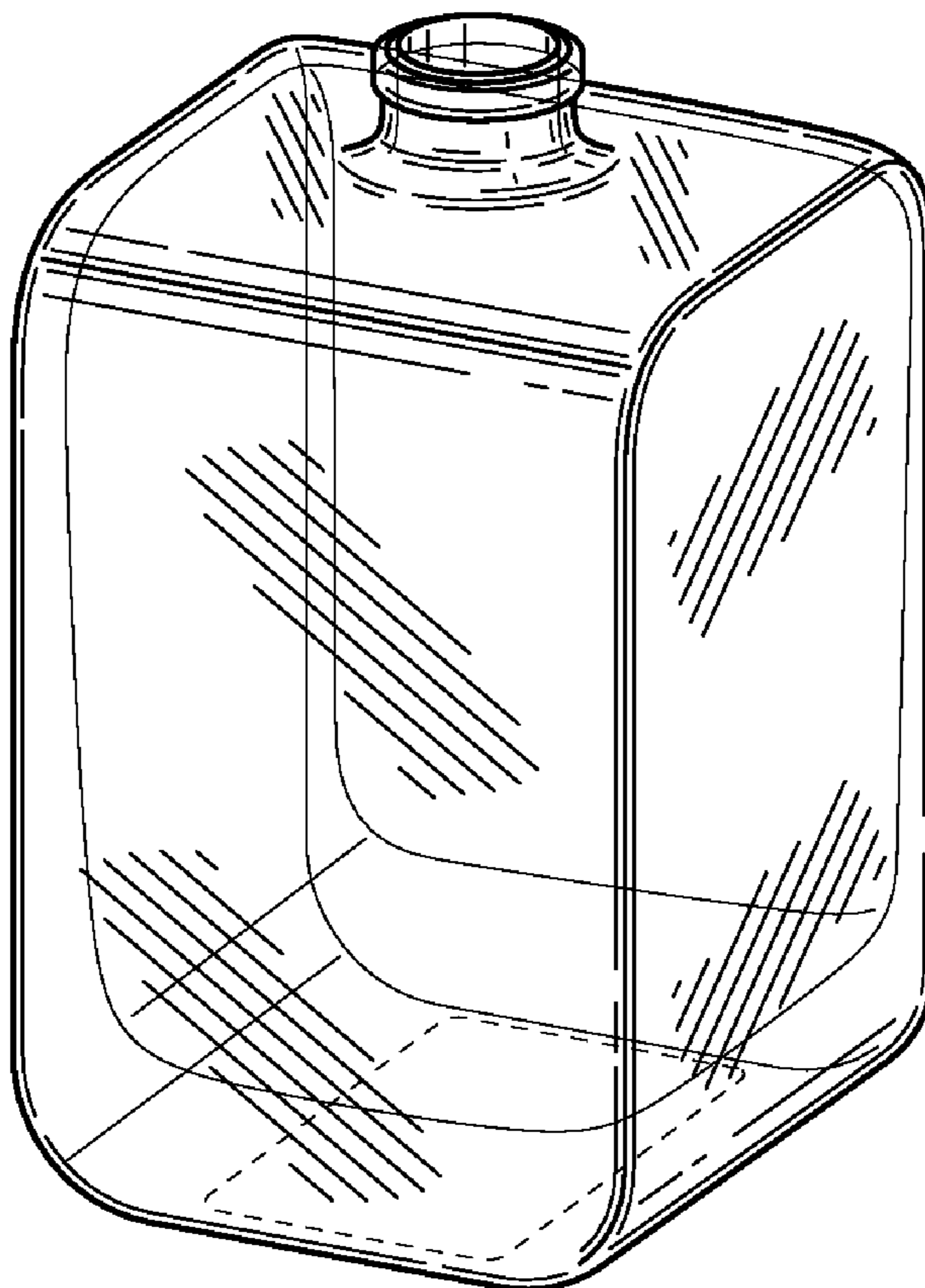
FIG. 3 is a side elevational view with the side opposite thereto being identical thereto;

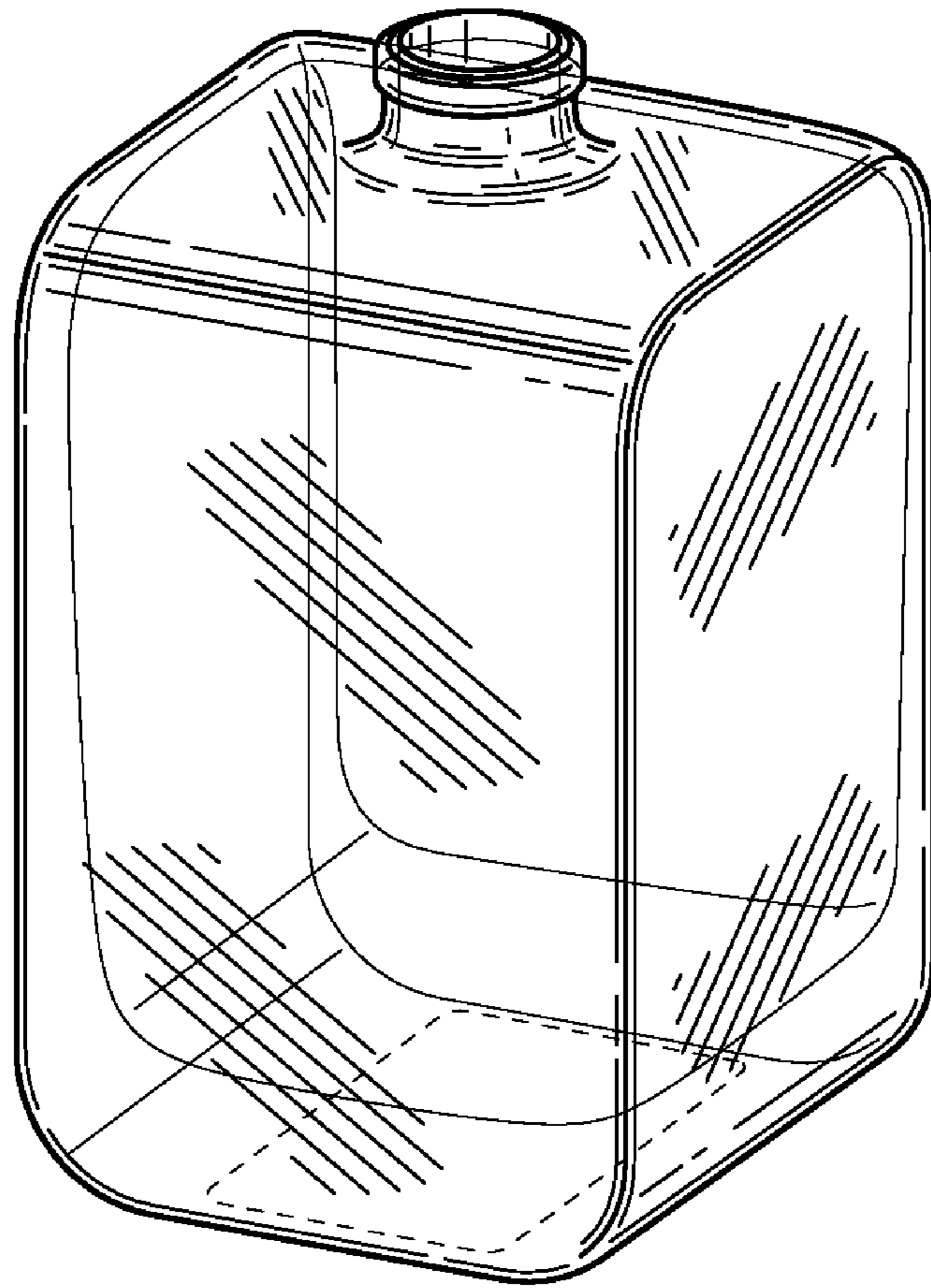

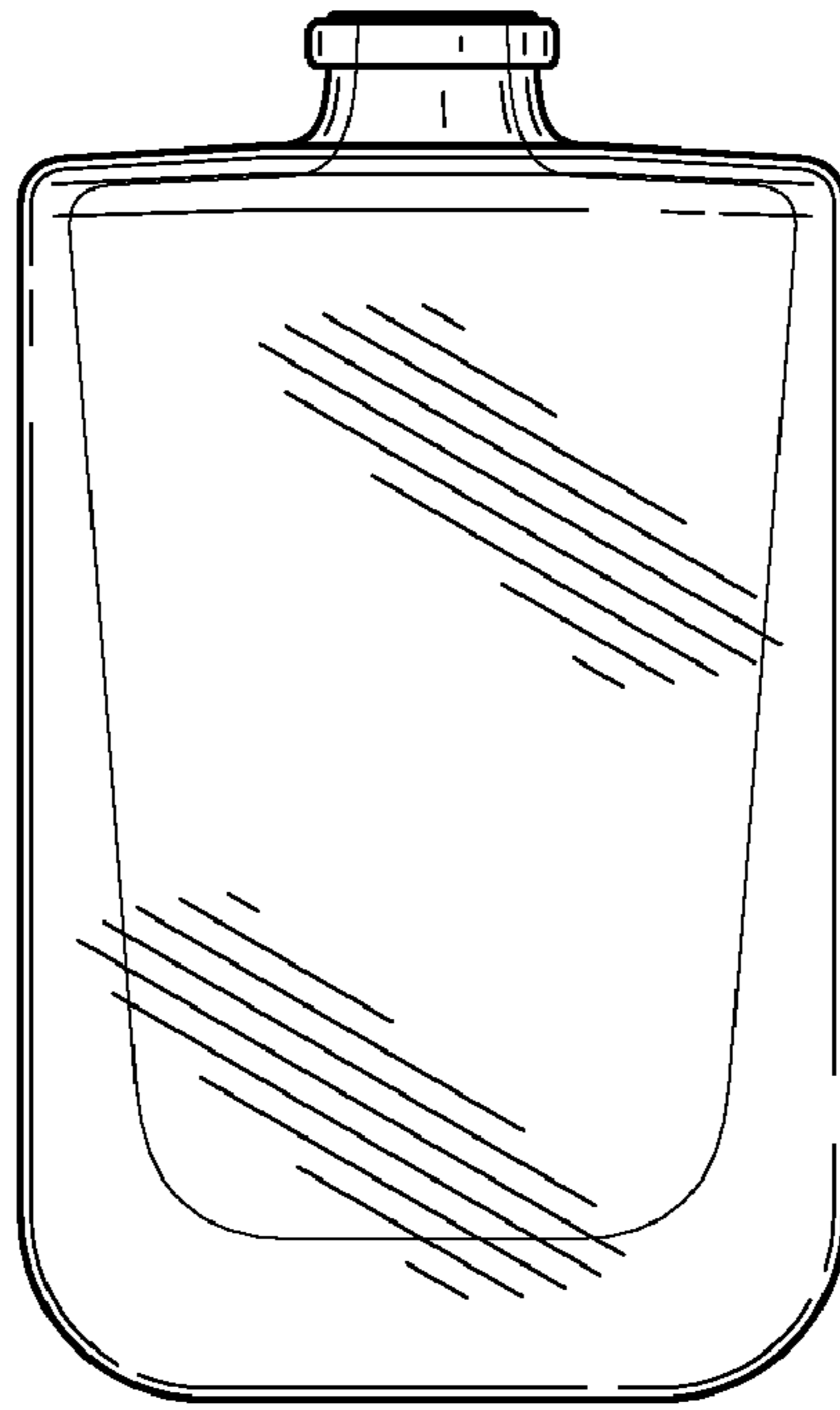

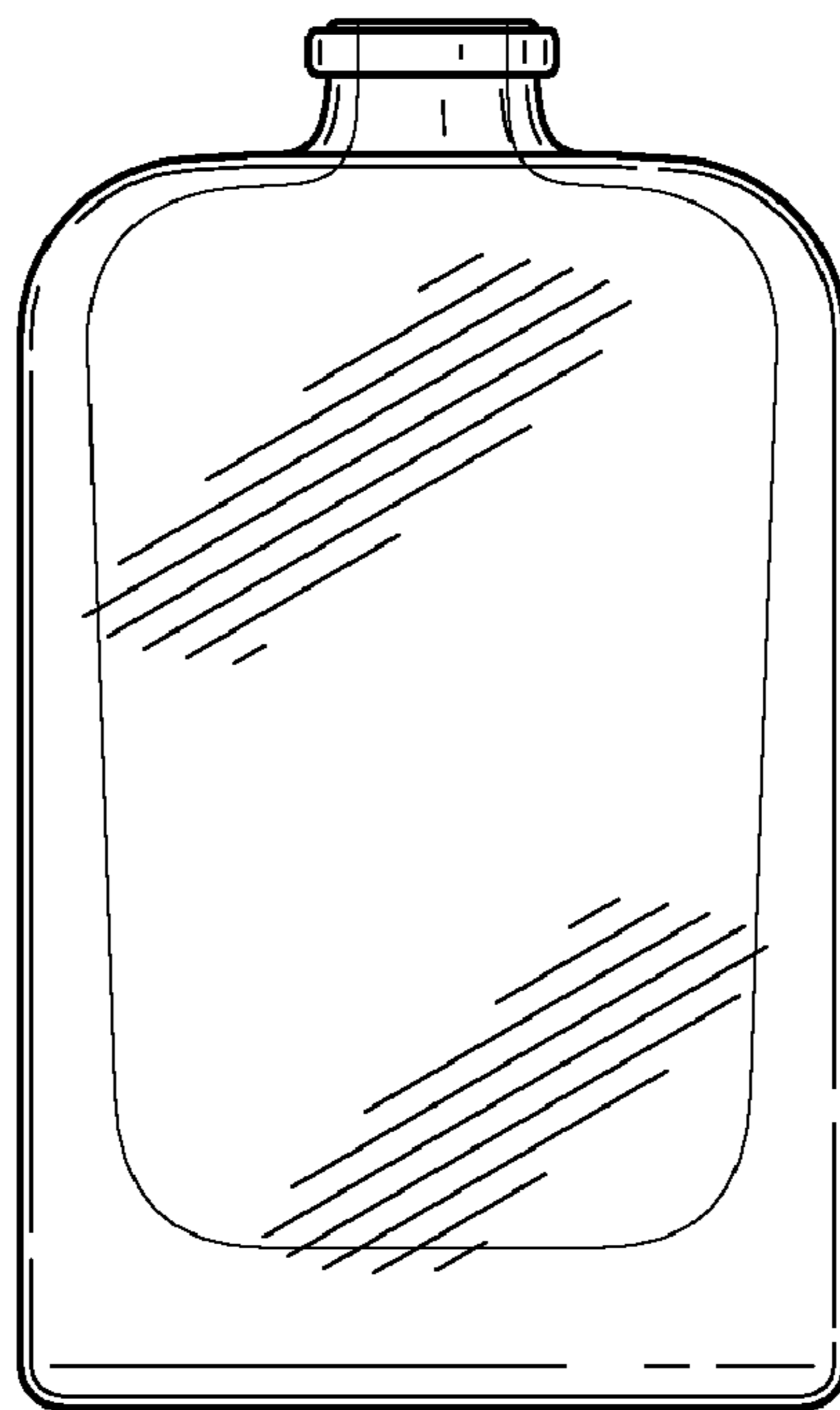

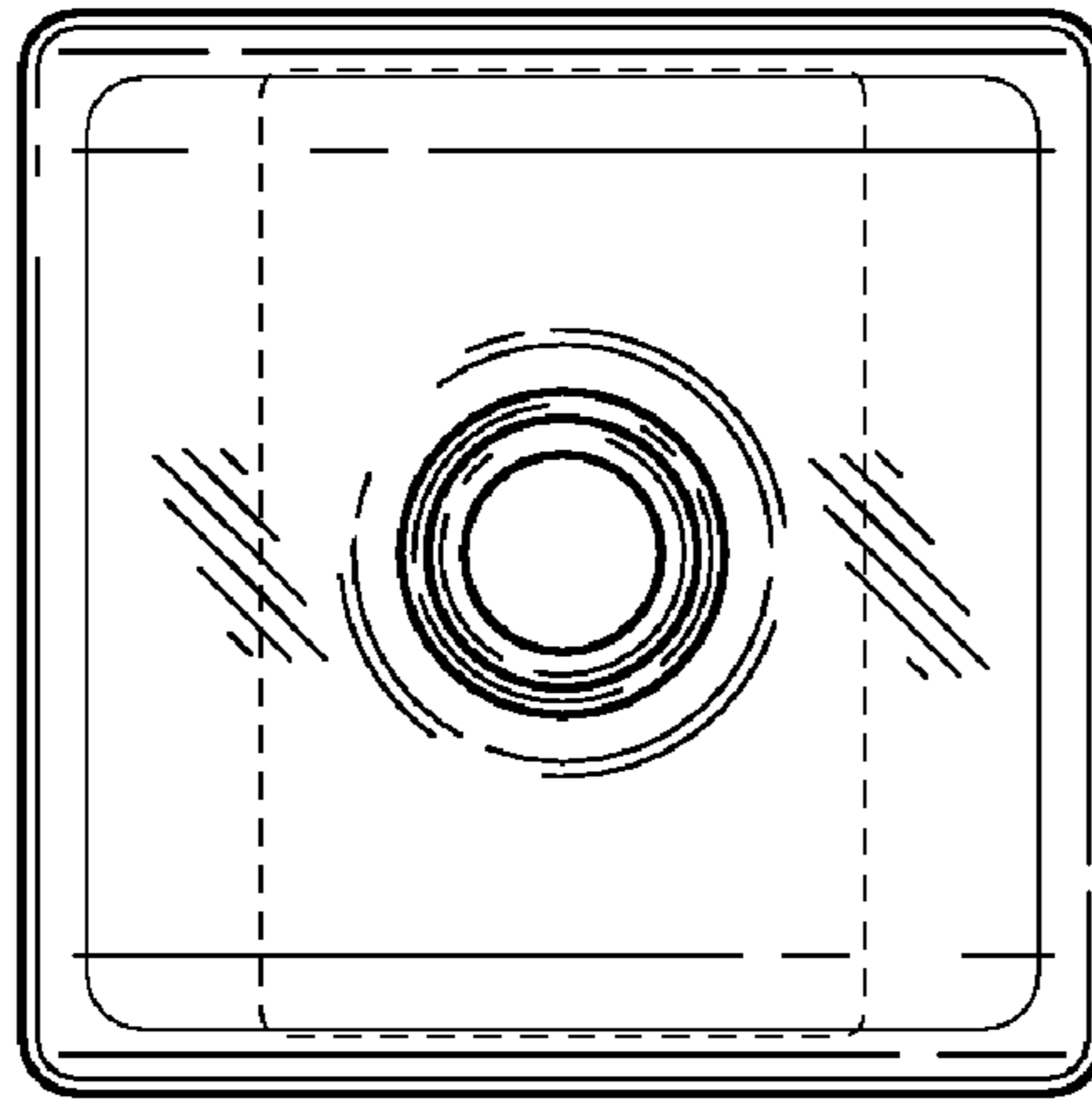

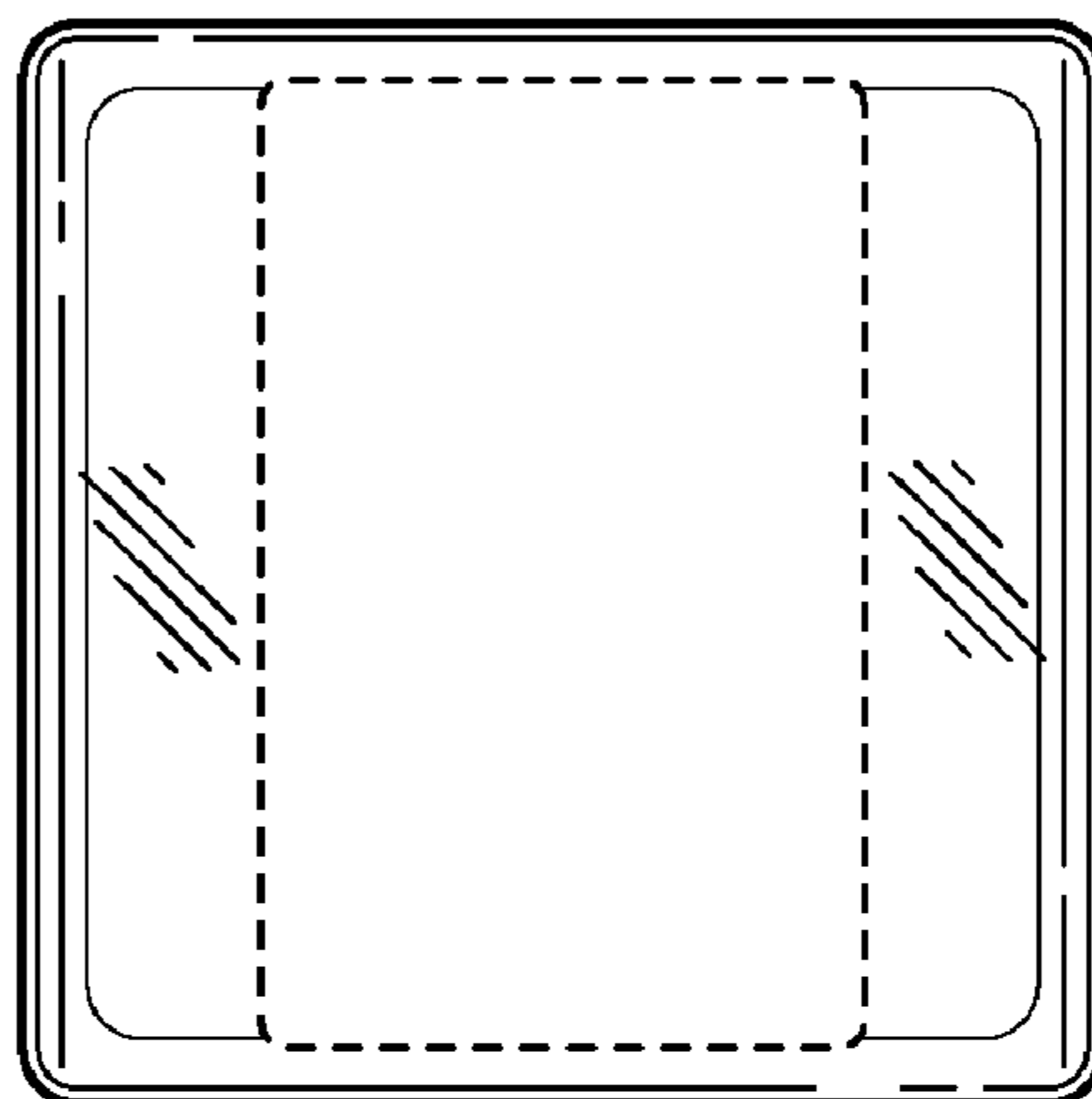
