We claim the ornamental design for an M-shaped boat hull, as shown and described.

**DESCRIPTION**

FIG. 4 is a top plan view;

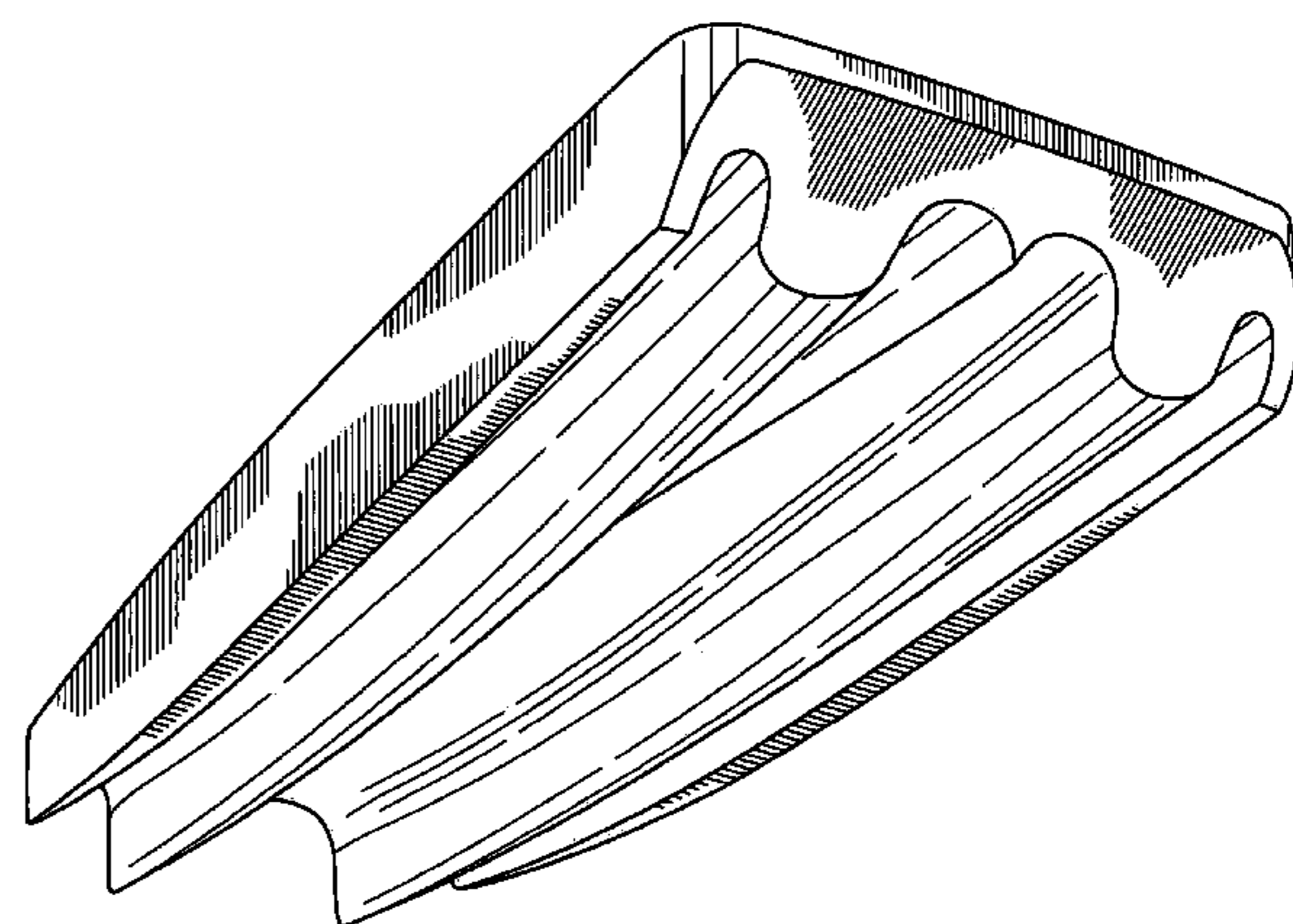
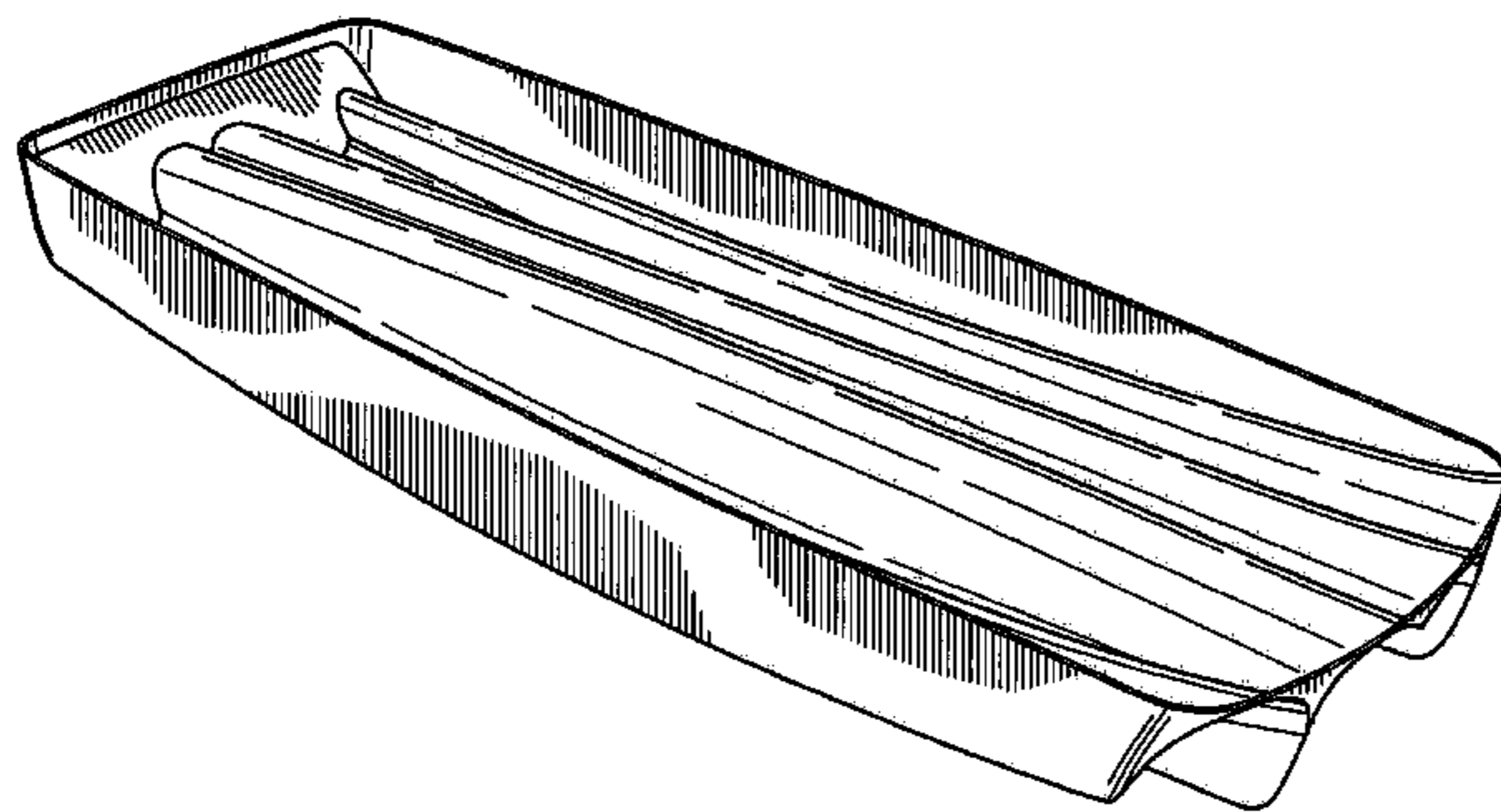
FIG. 5 is a left side elevation view;

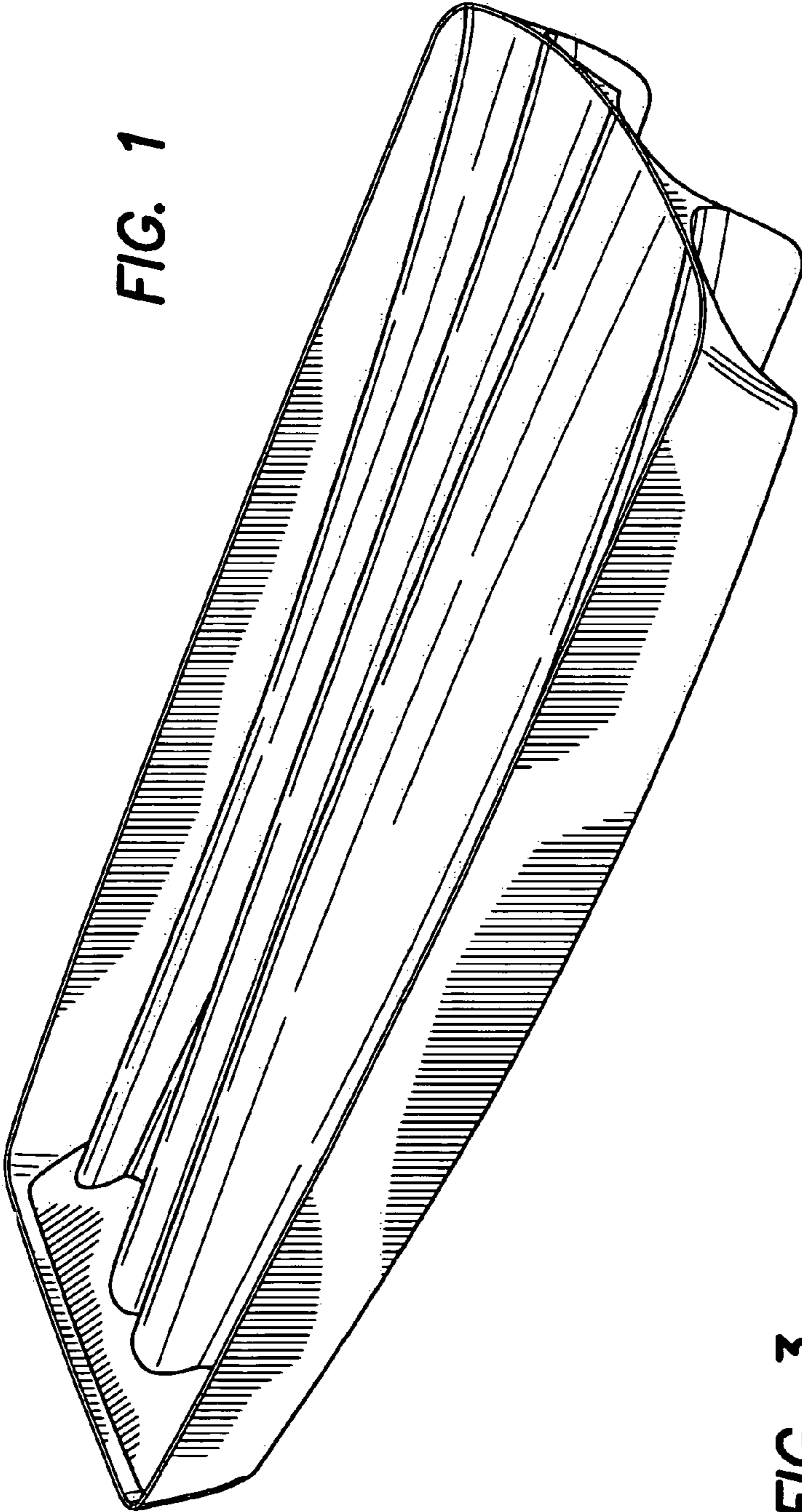

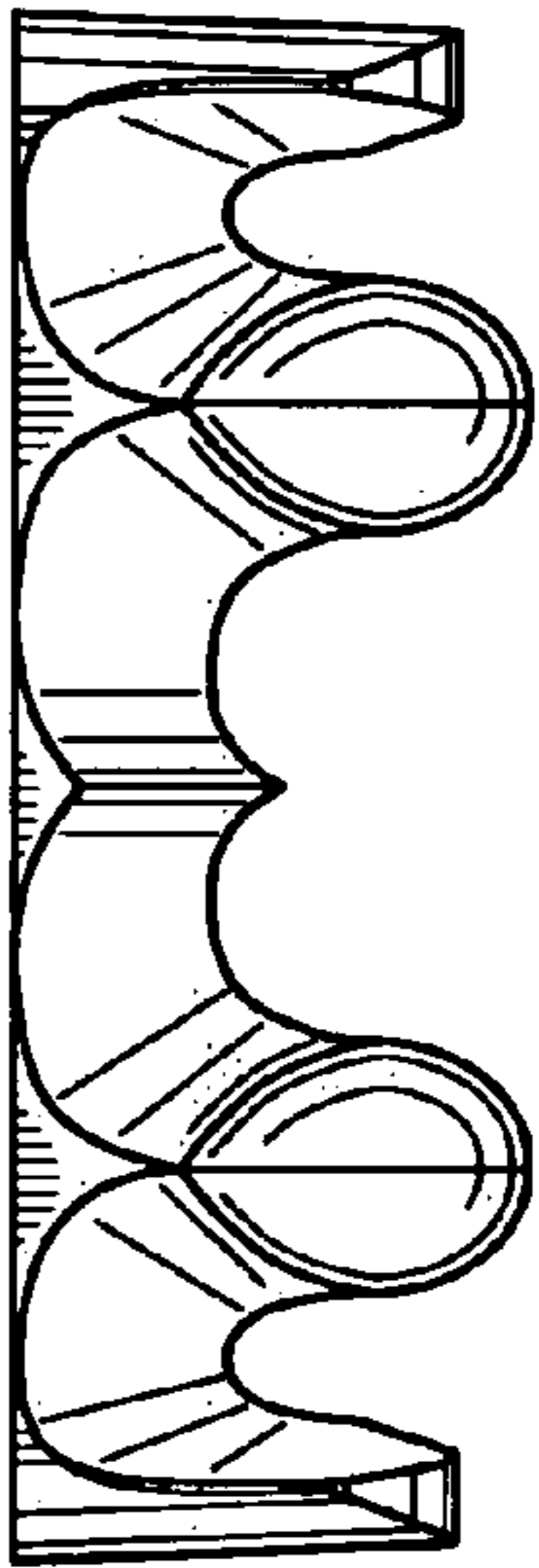

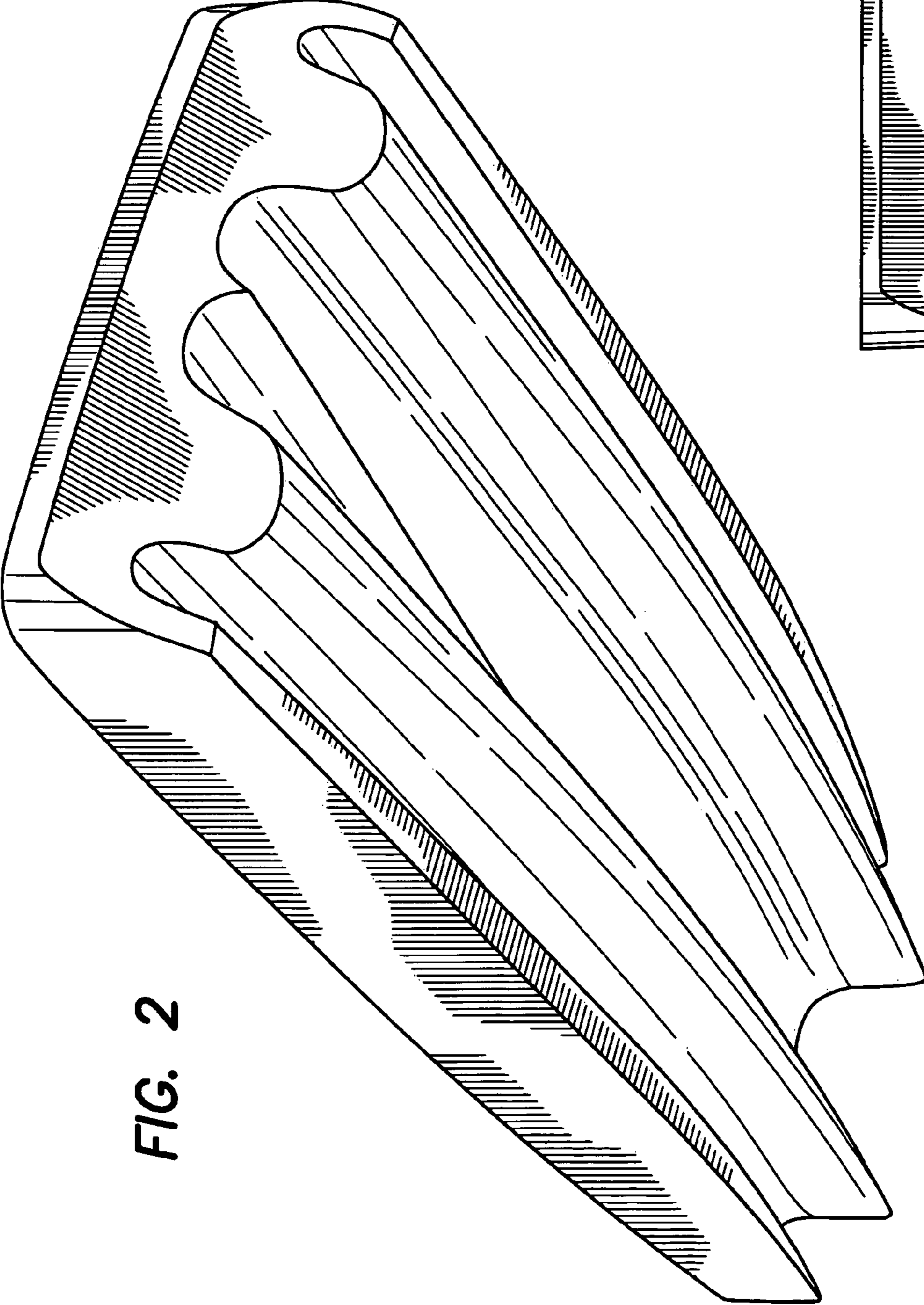
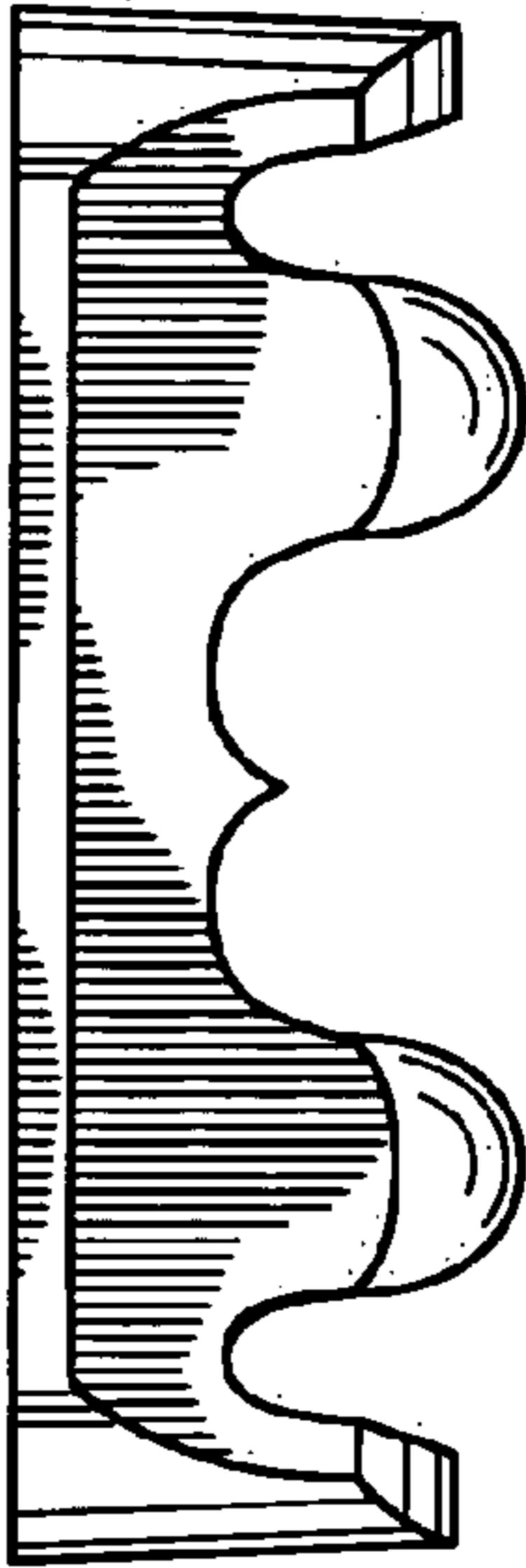
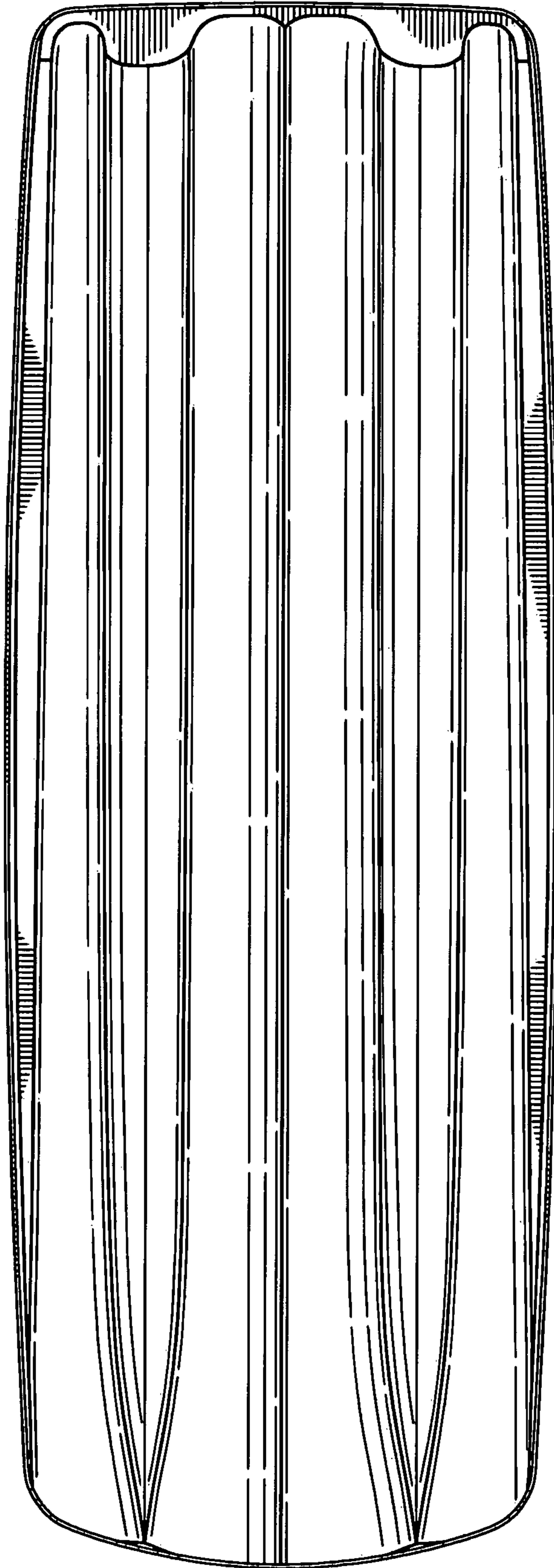


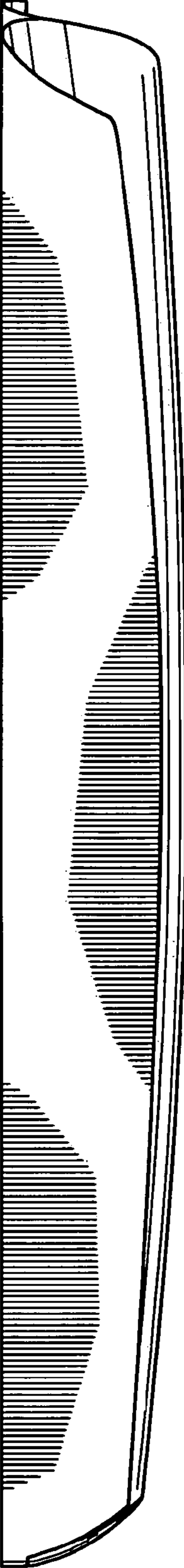

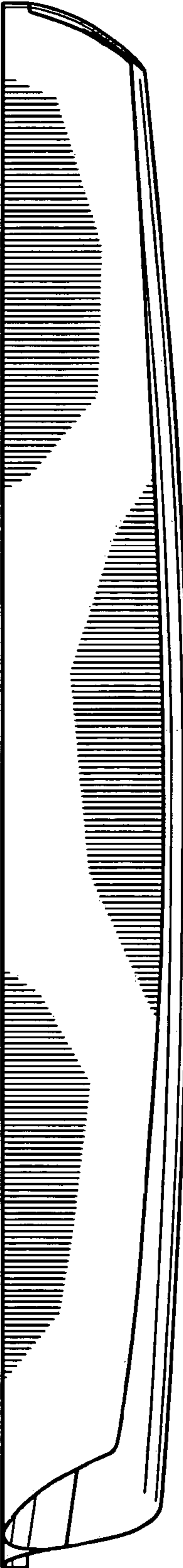




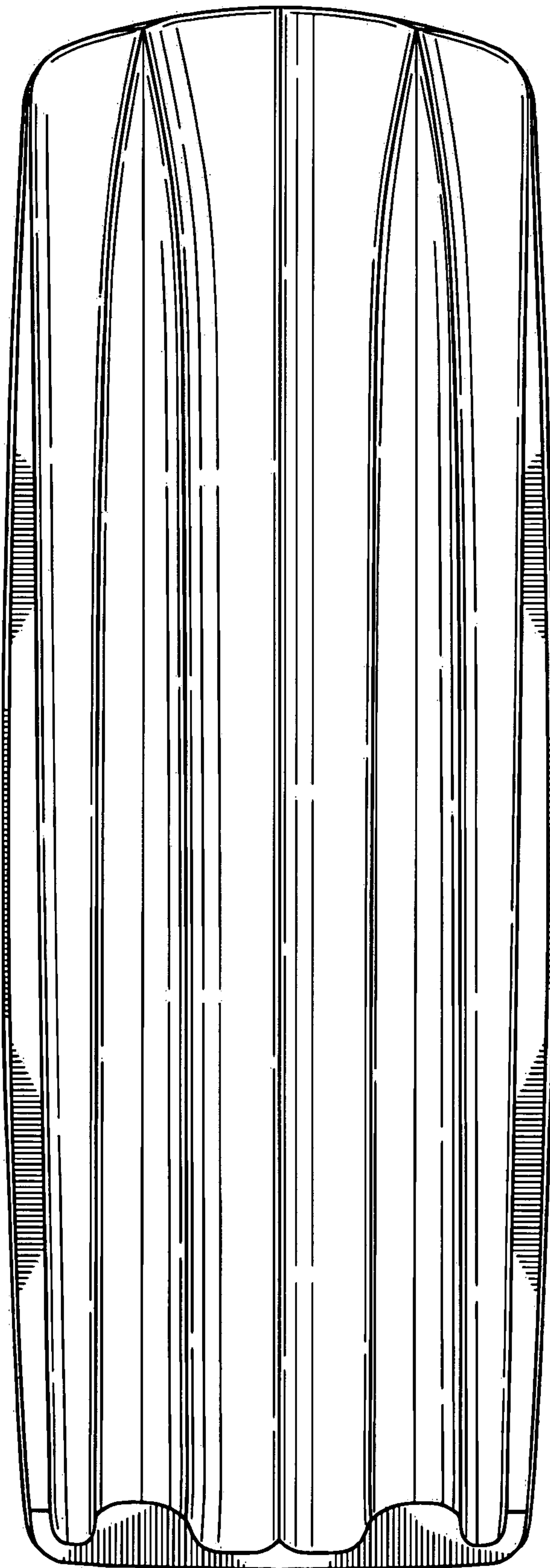
